DESCRIPTION

FIG. 1 is a front elevational view of a sewing machine showing my design;

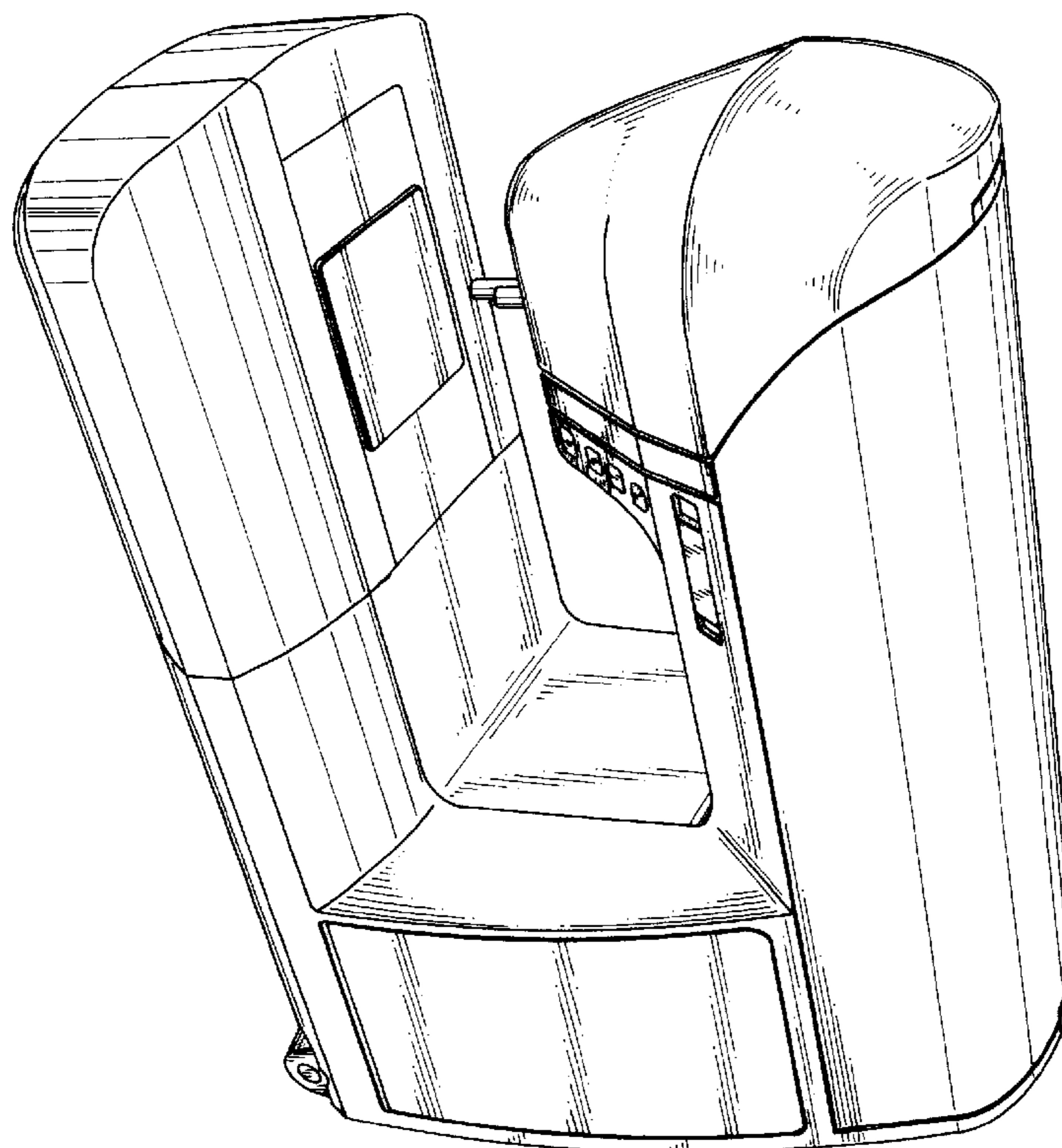

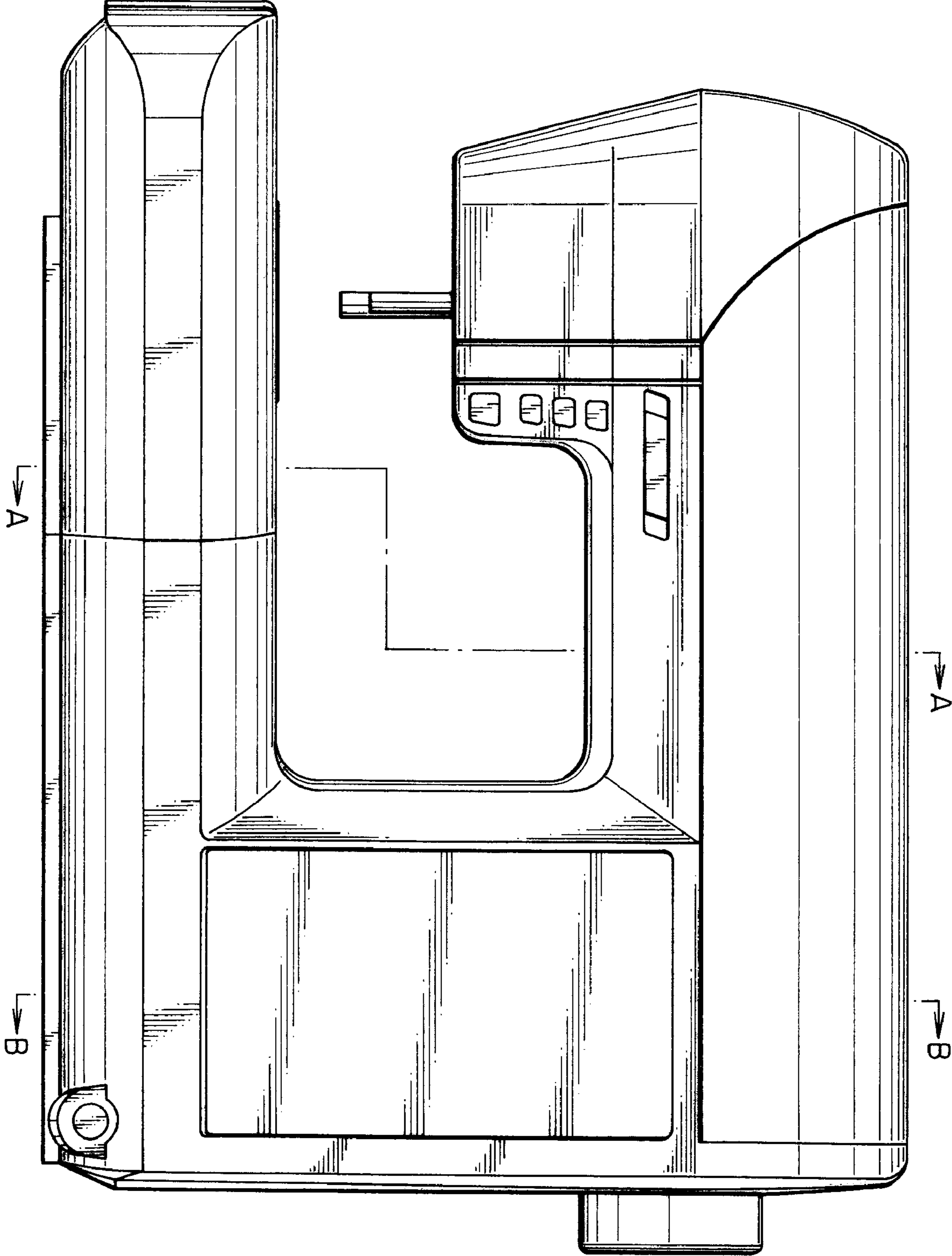

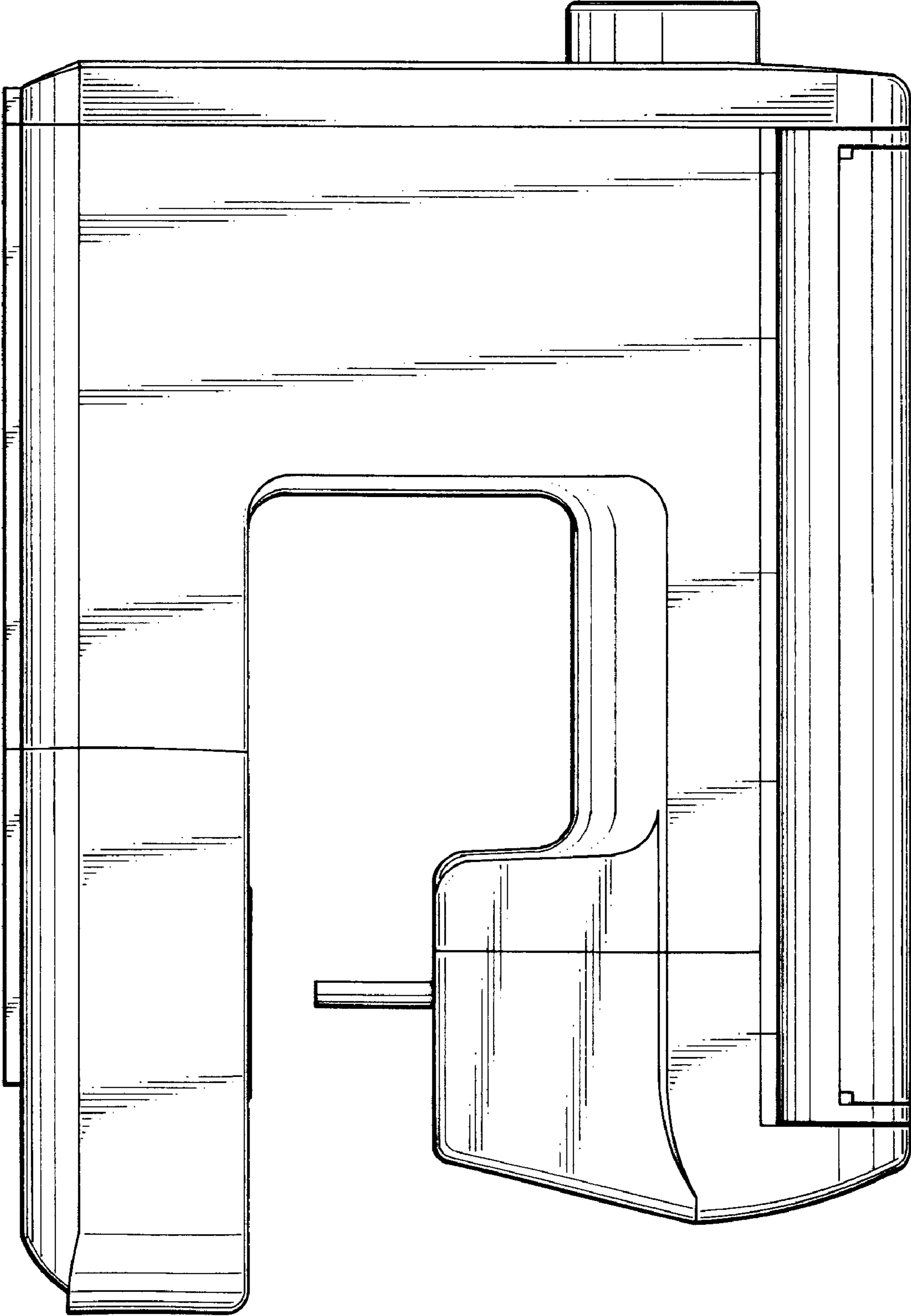

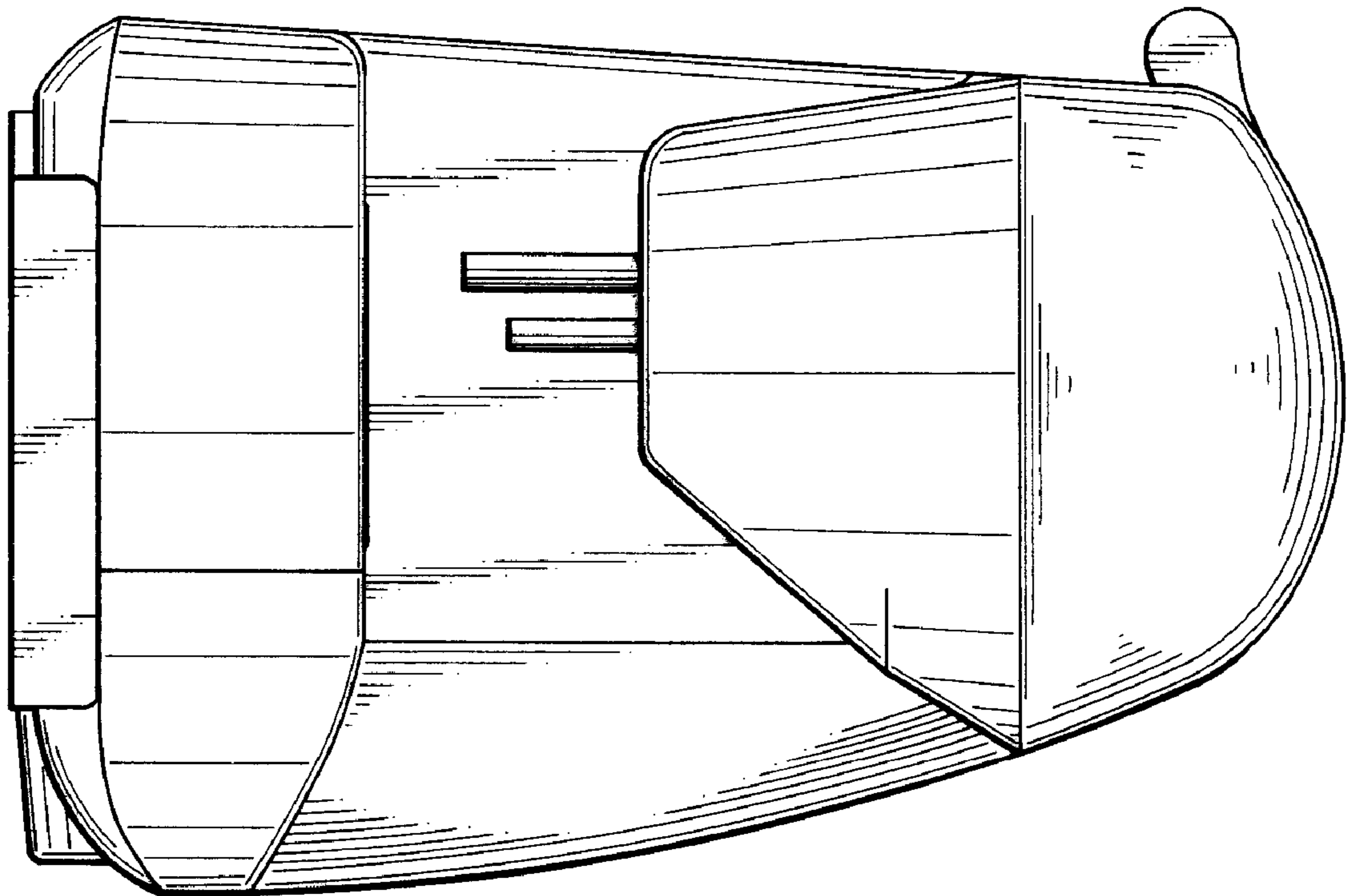

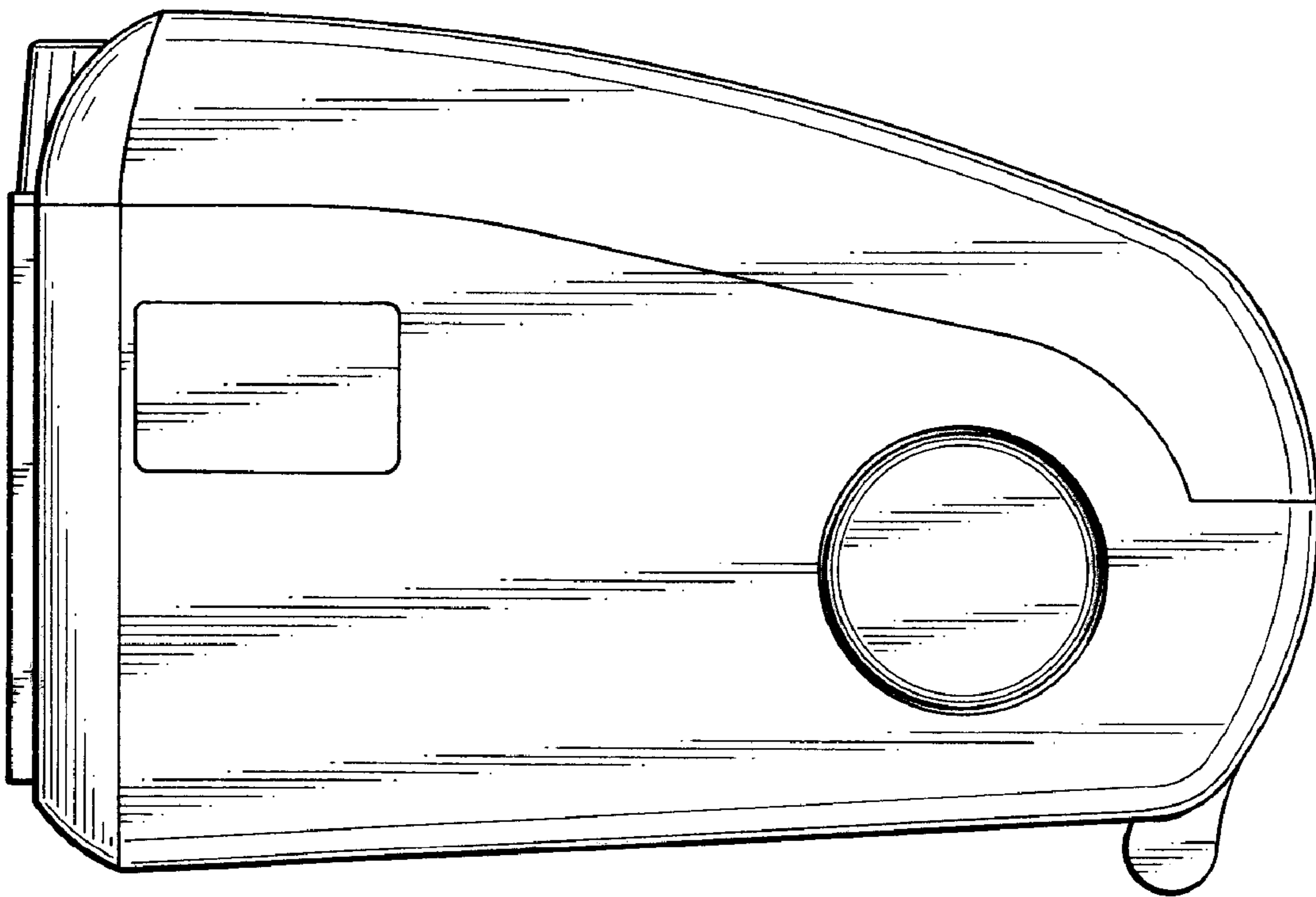

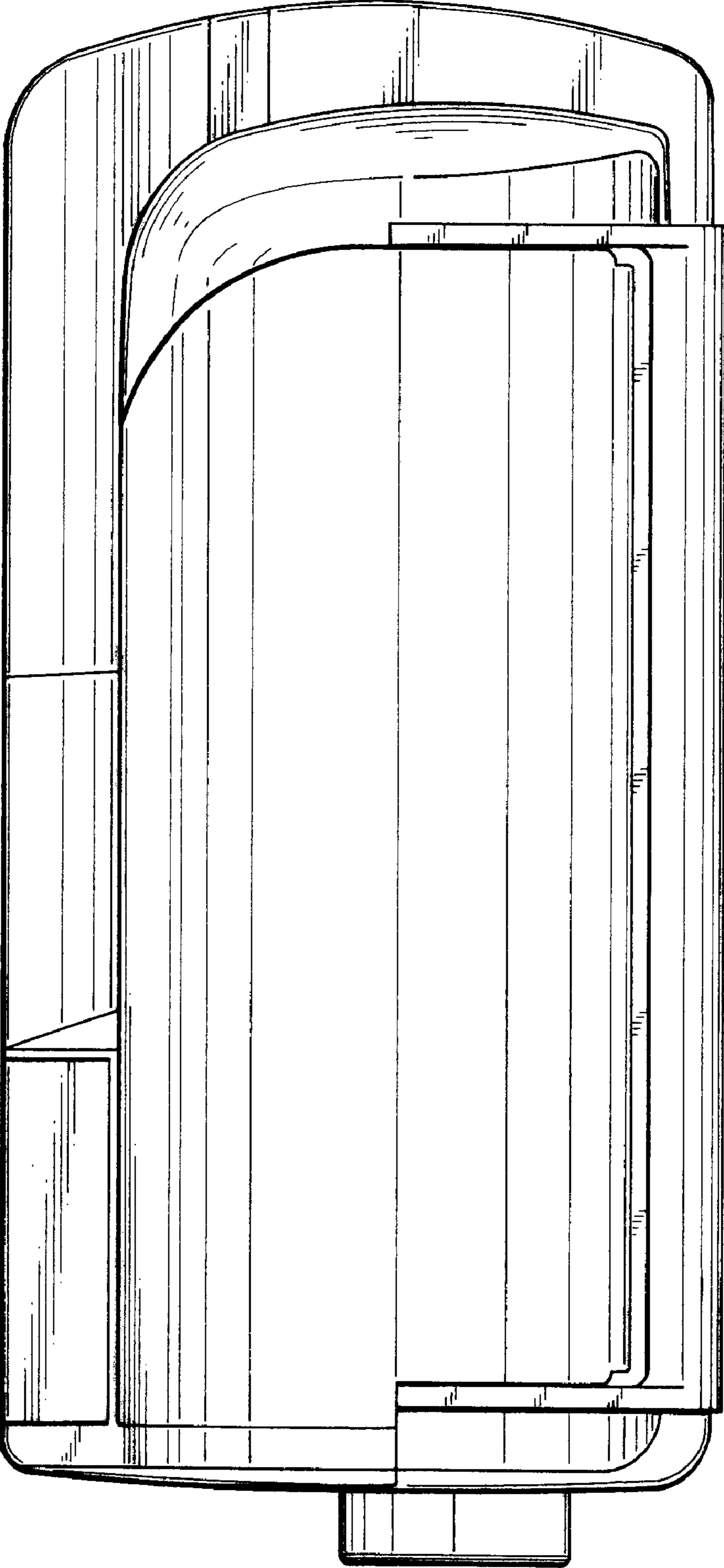

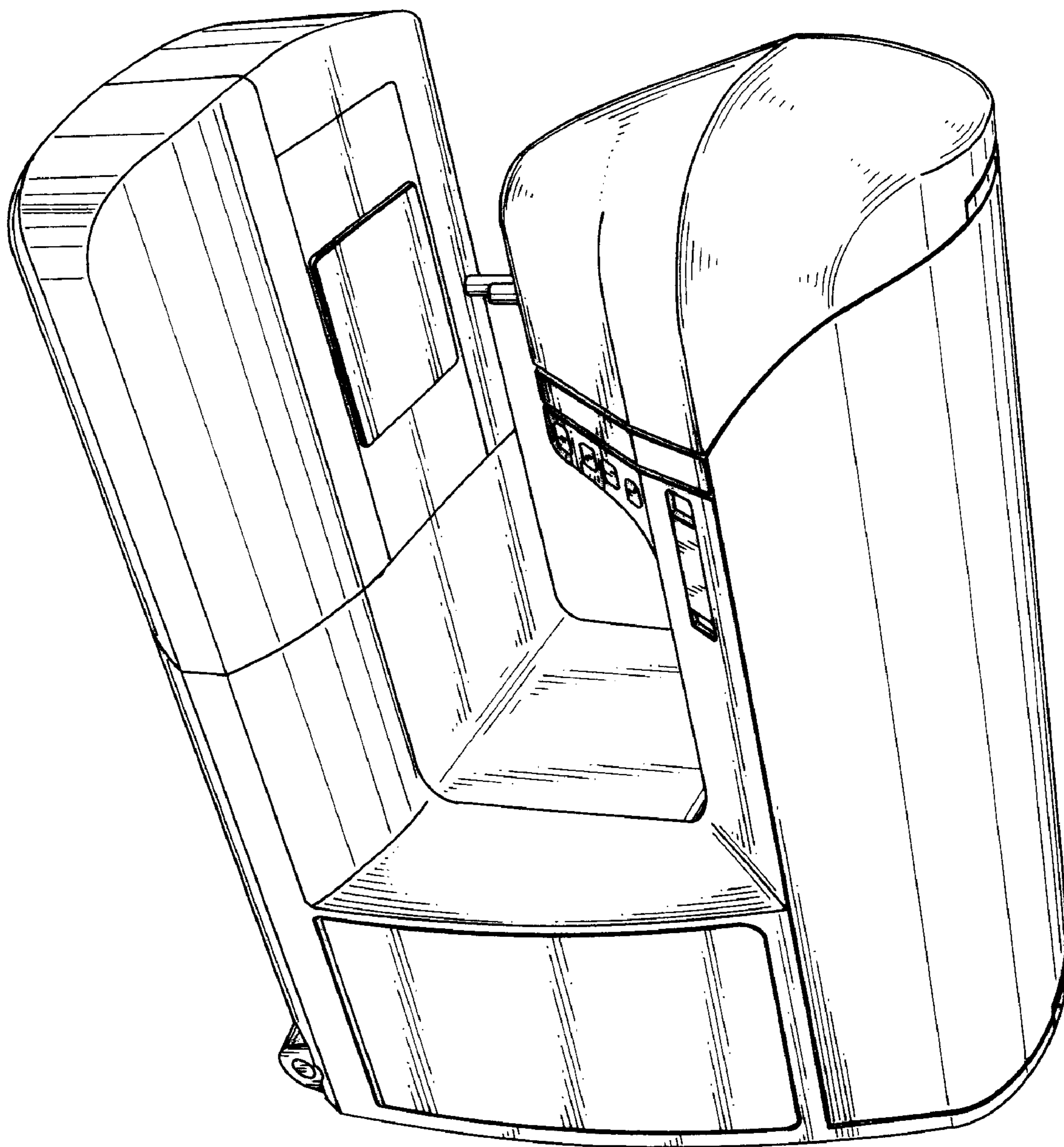

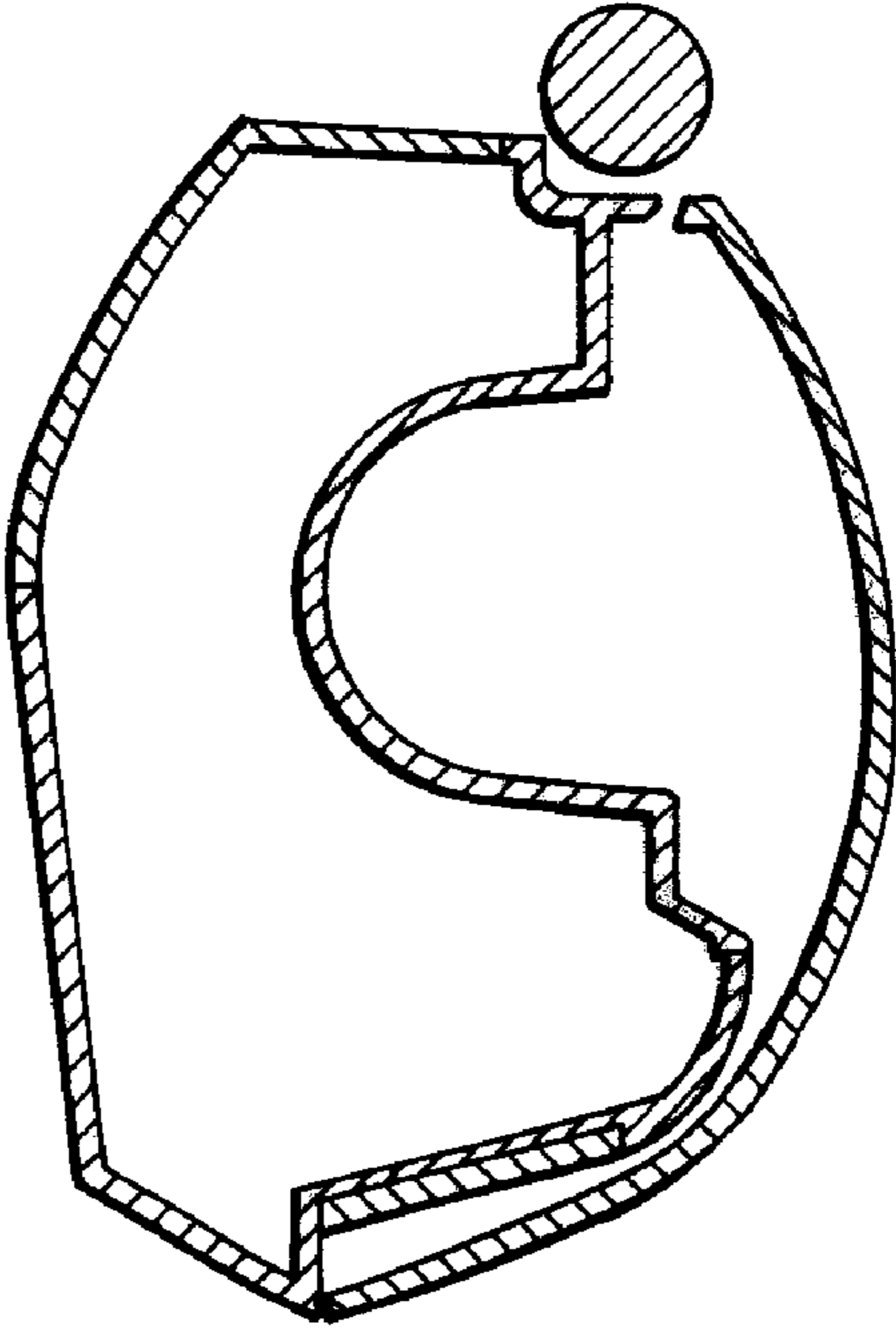
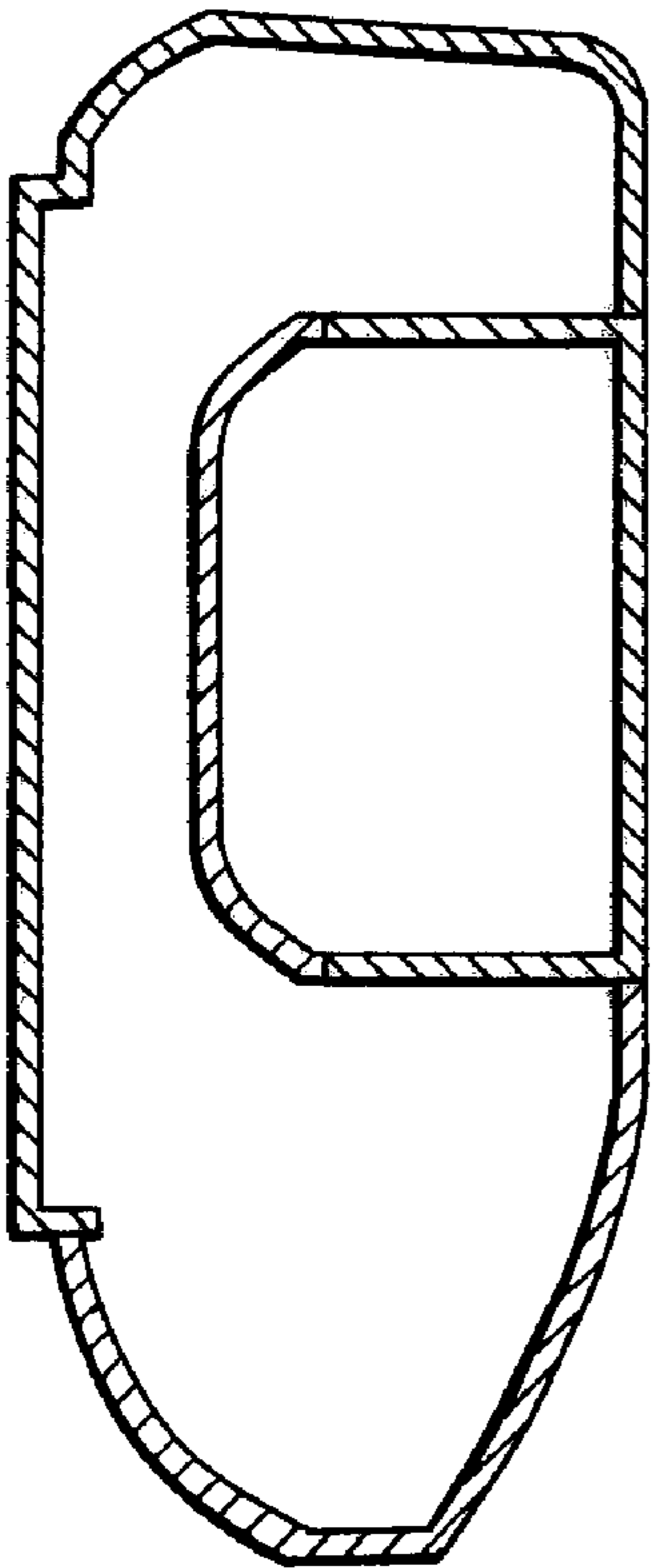
