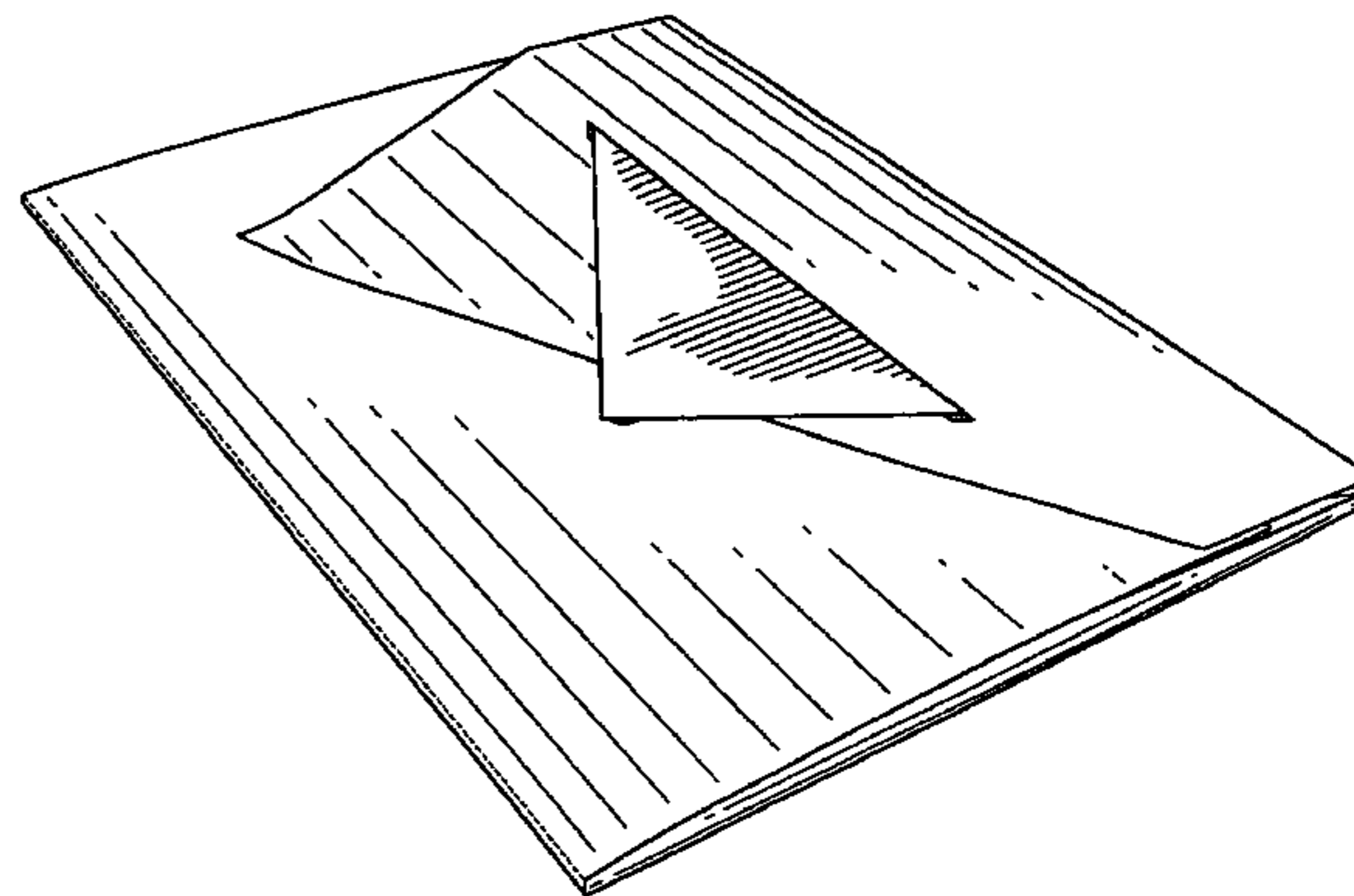
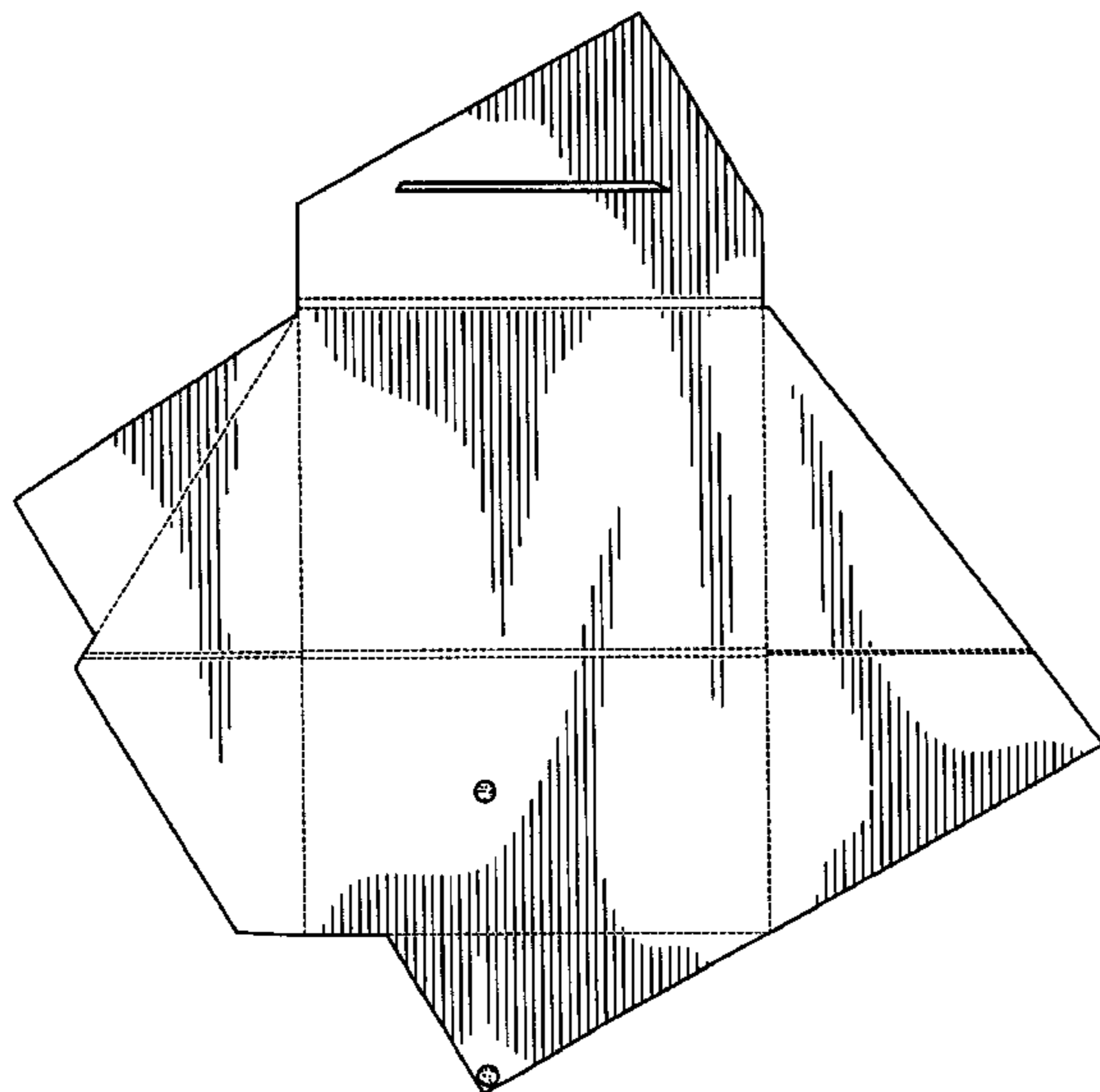
The ornamental design for an angular folder, as shown and described.

**DESCRIPTION**

FIG. 1 is top plan view of the angular folder in unfolded condition showing my new design;  
FIG. 2 is a top plan view in a folded condition;  
FIG. 3 is a bottom plan view;  
FIG. 4 is a front elevation view;  
FIG. 5 is a rear elevation view;  
FIG. 6 is a left side elevation view;  
FIG. 7 is a right side elevation view; and,

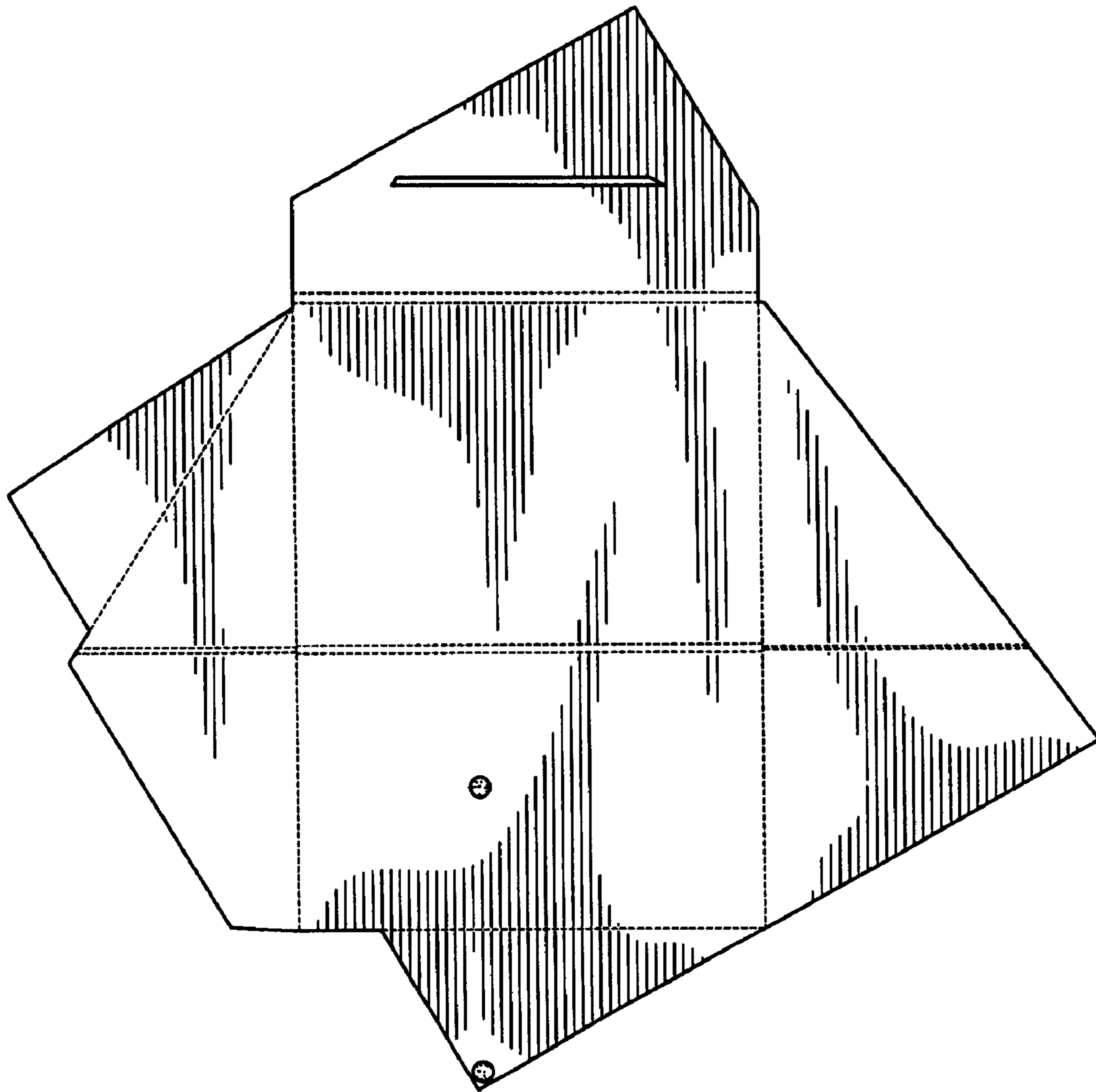

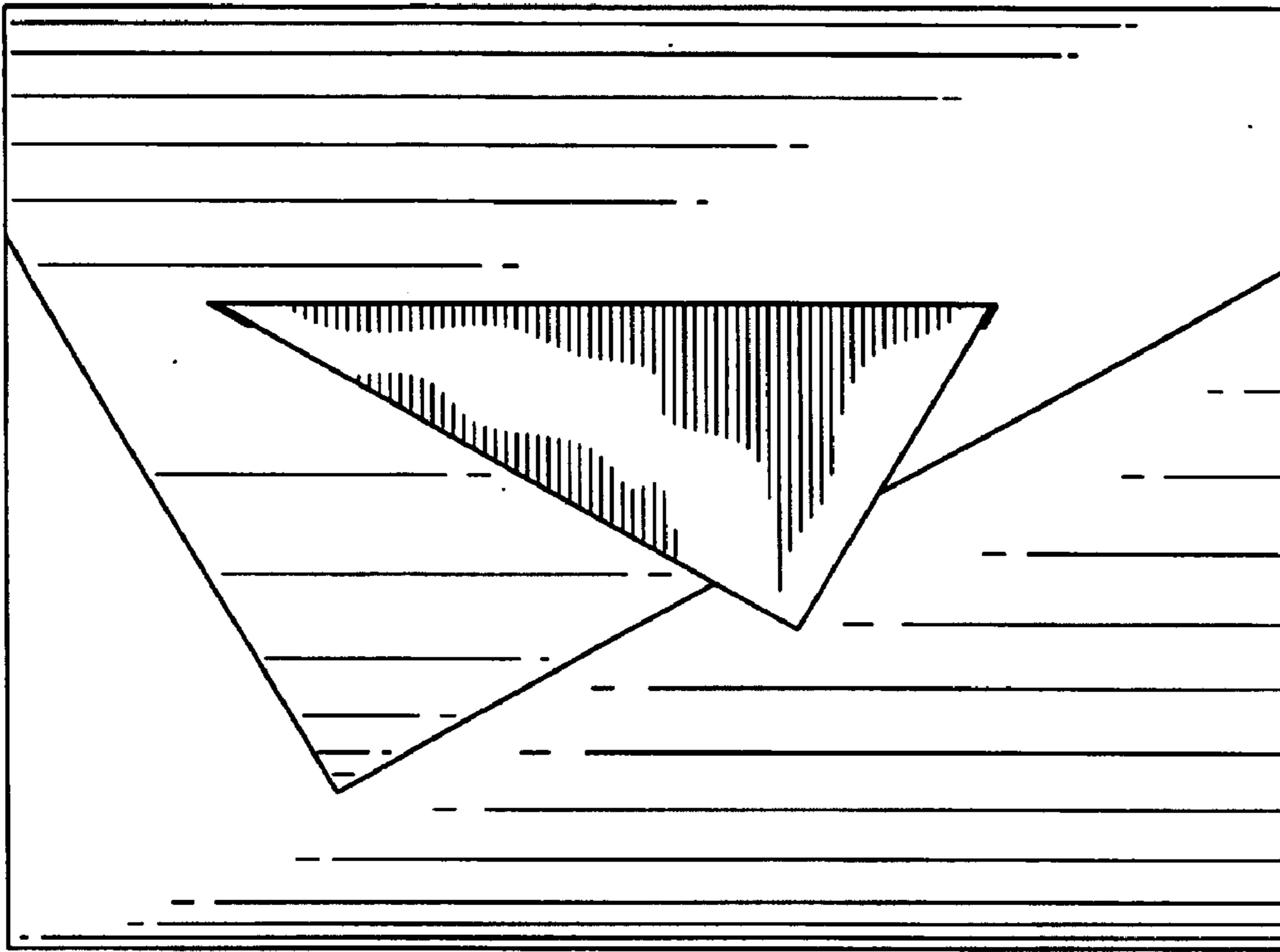

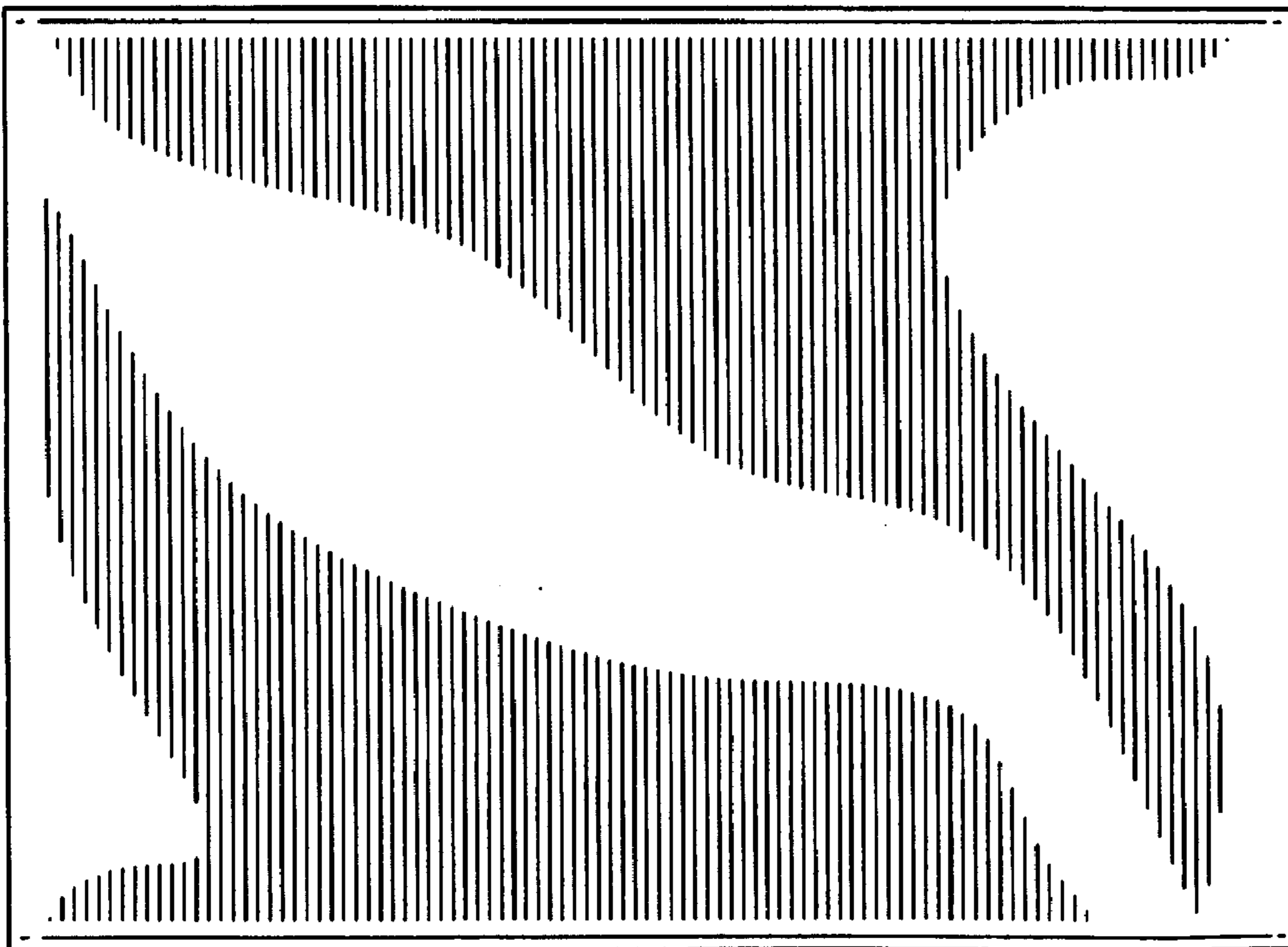

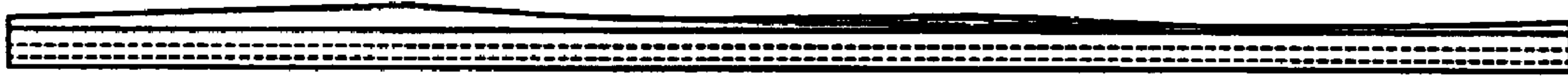

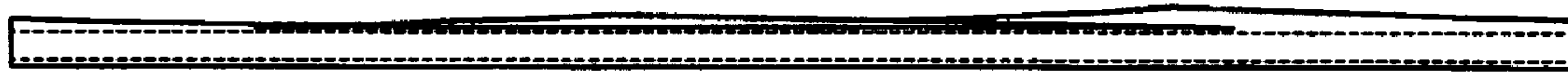

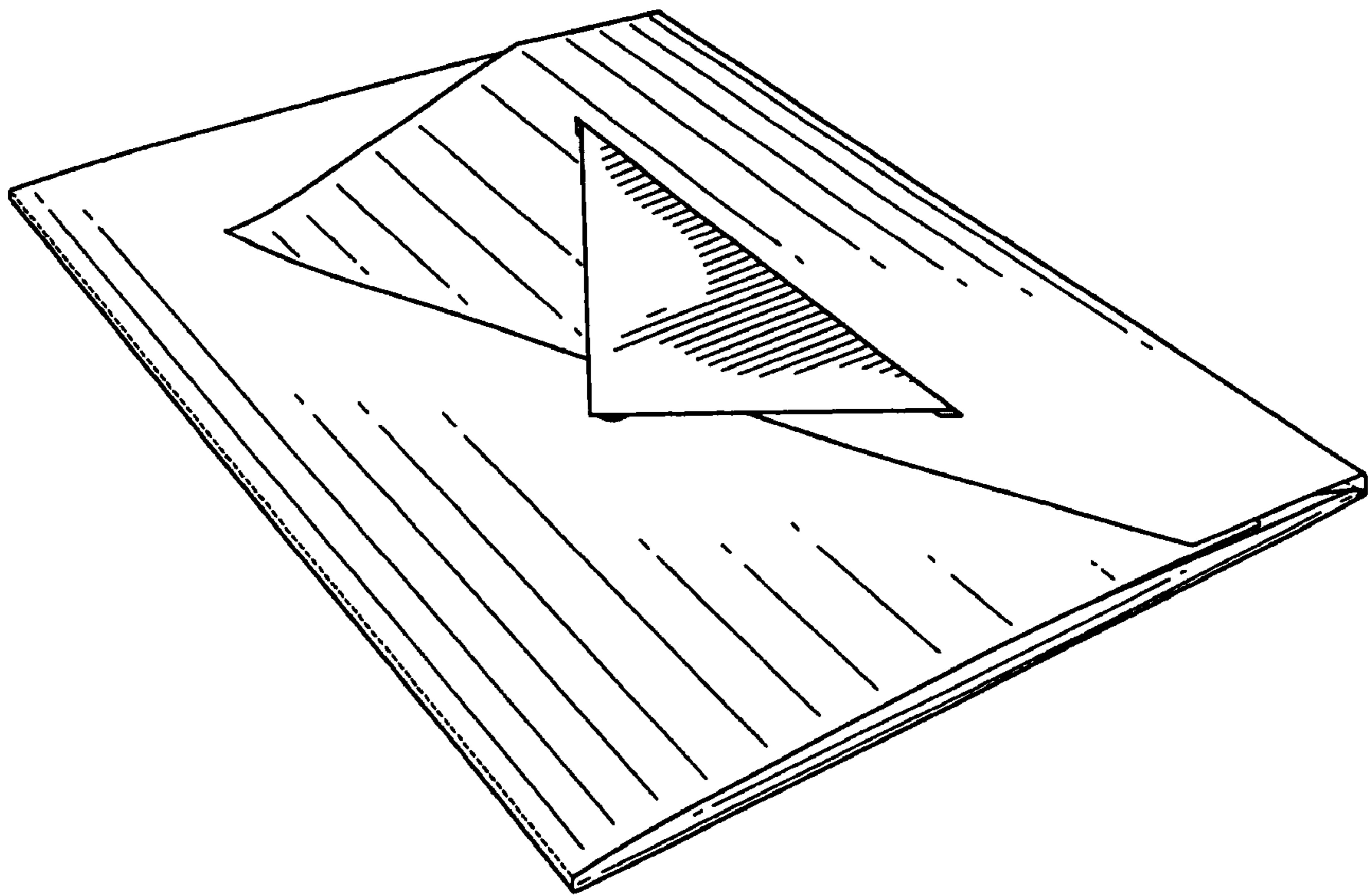
