FIG. 3 is a back view of the vending machine;

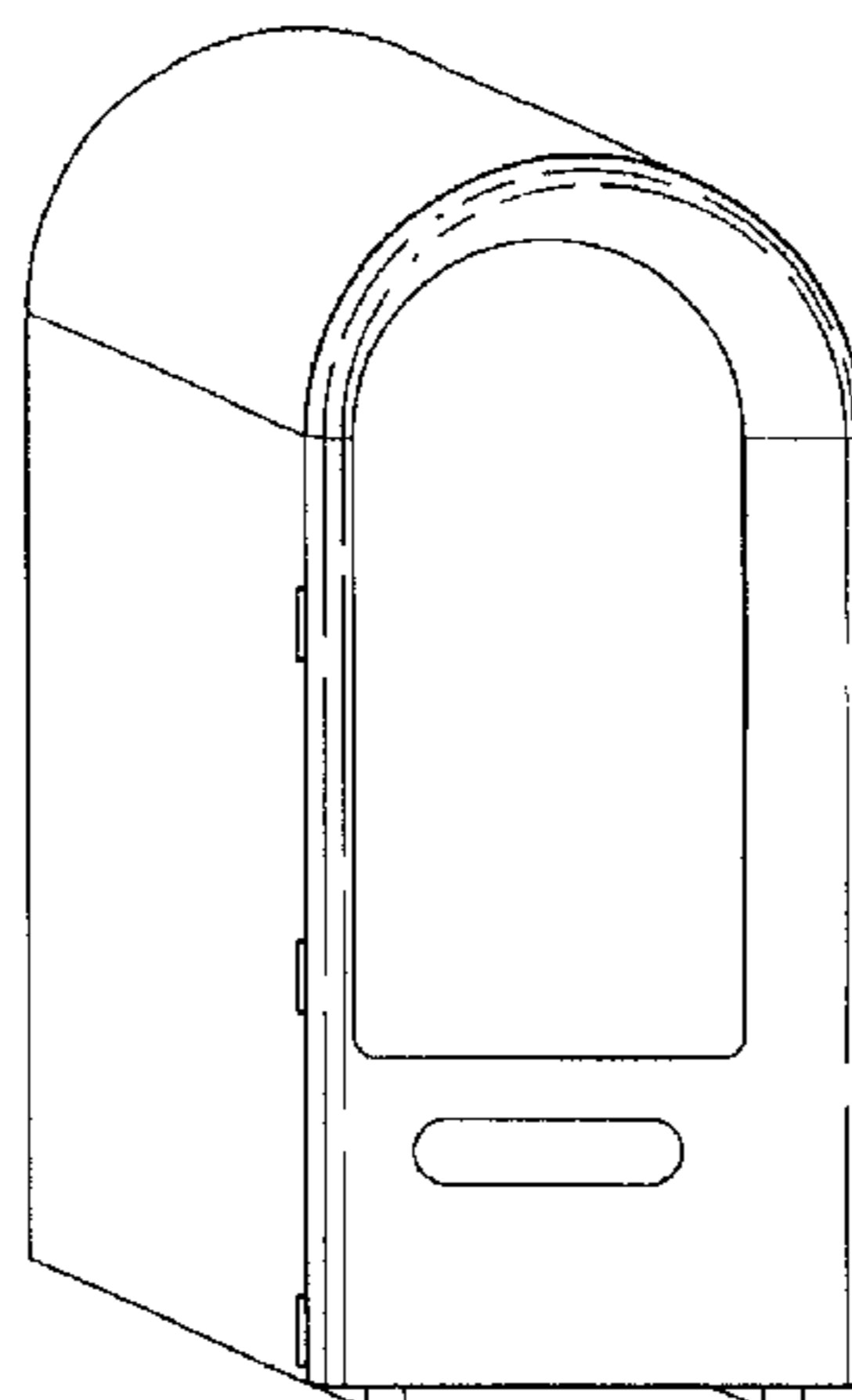
FIG. 4 is a view from a first side of the vending machine;

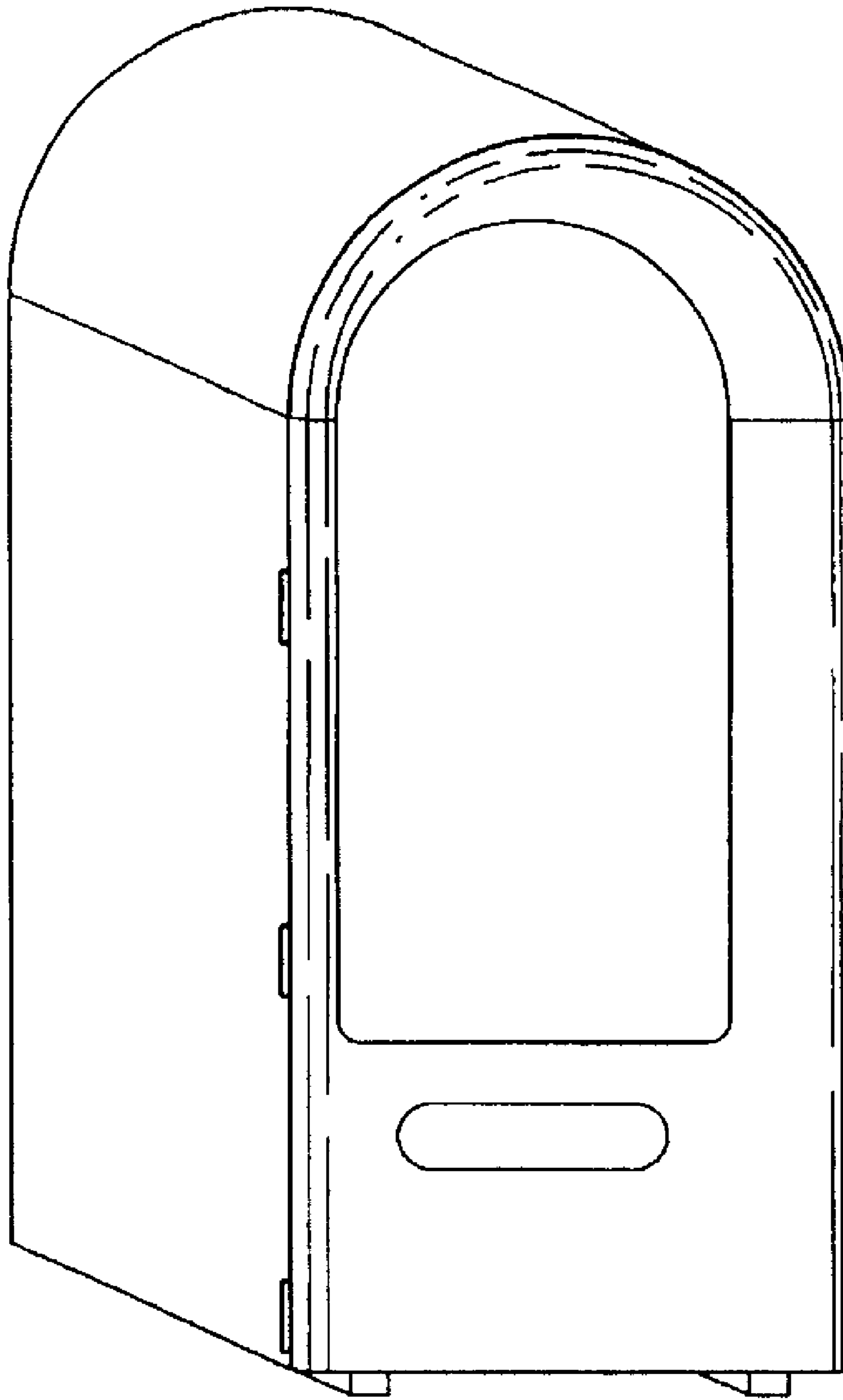

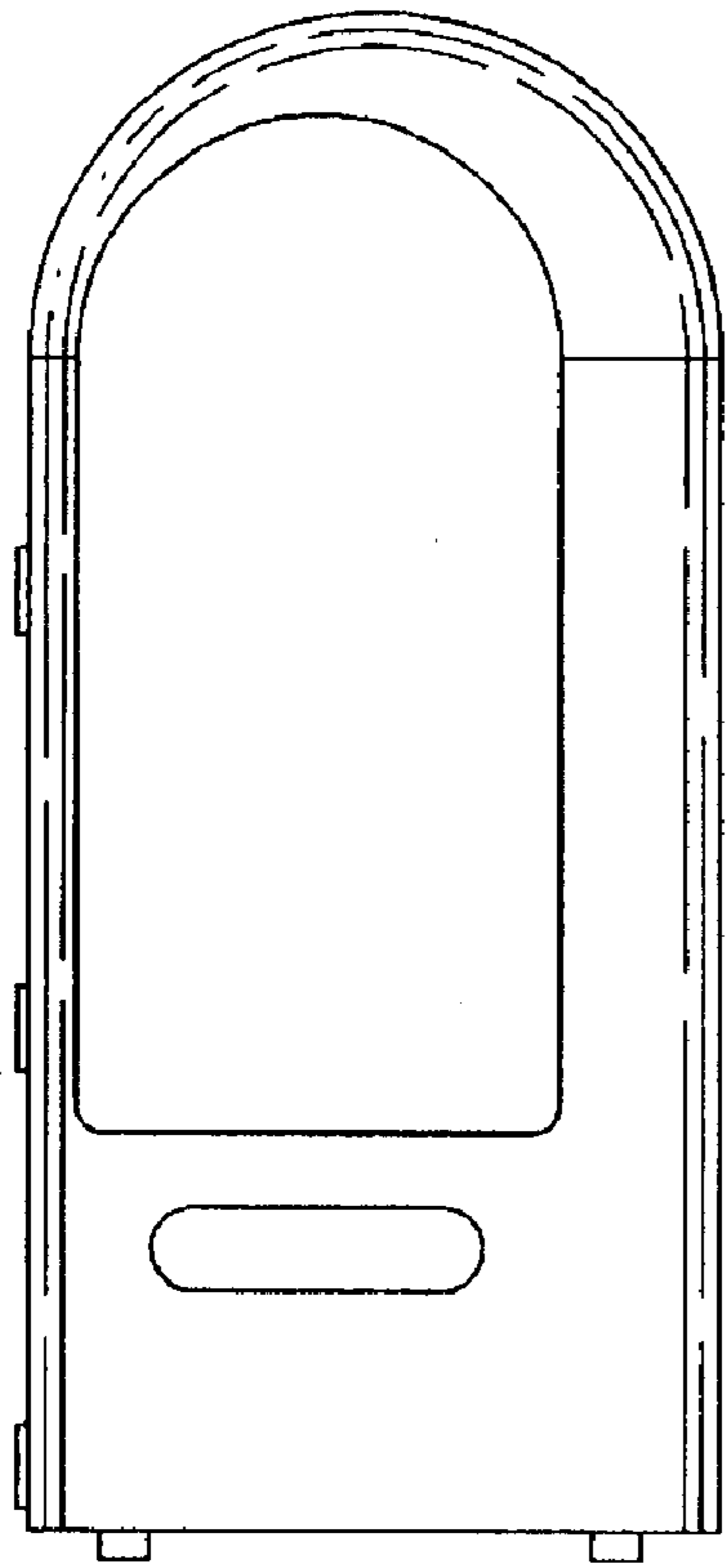

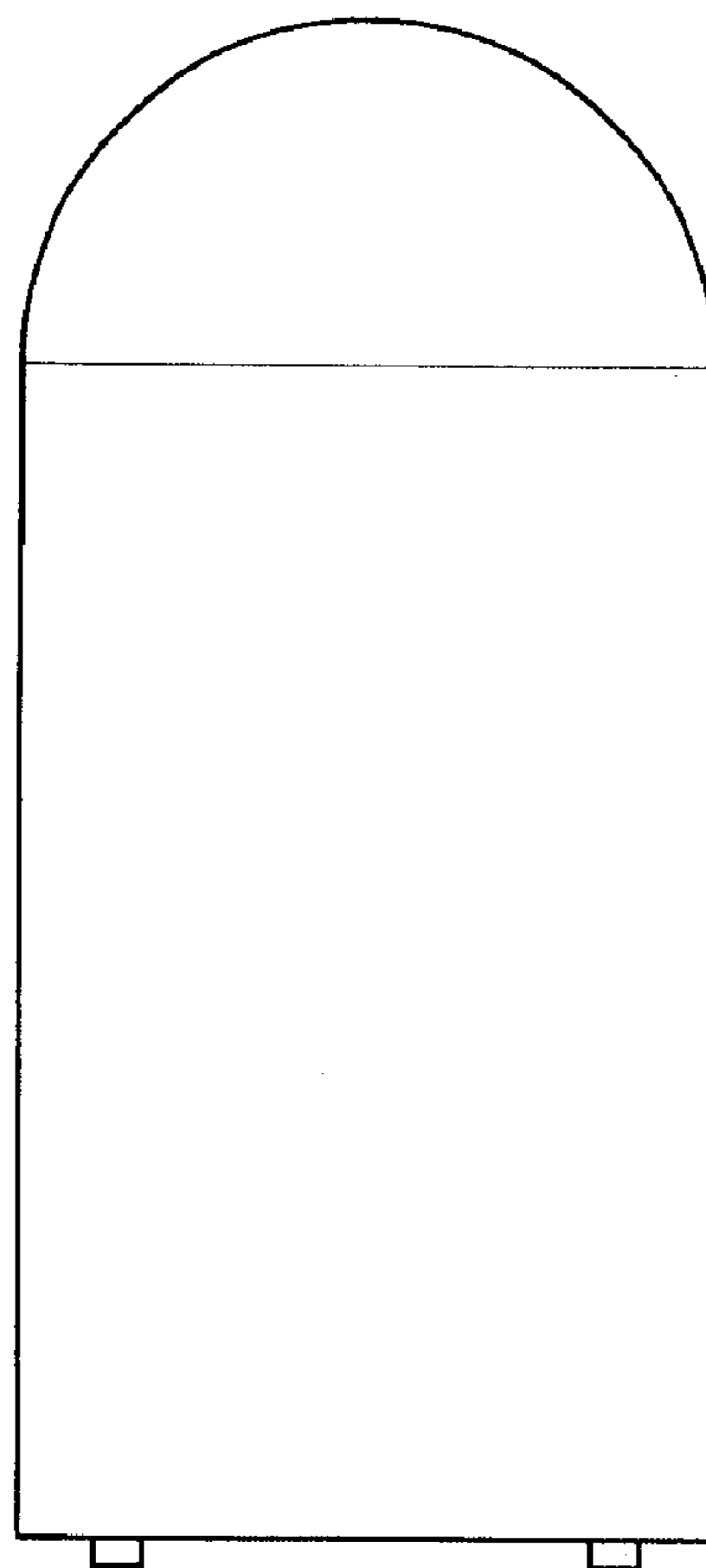

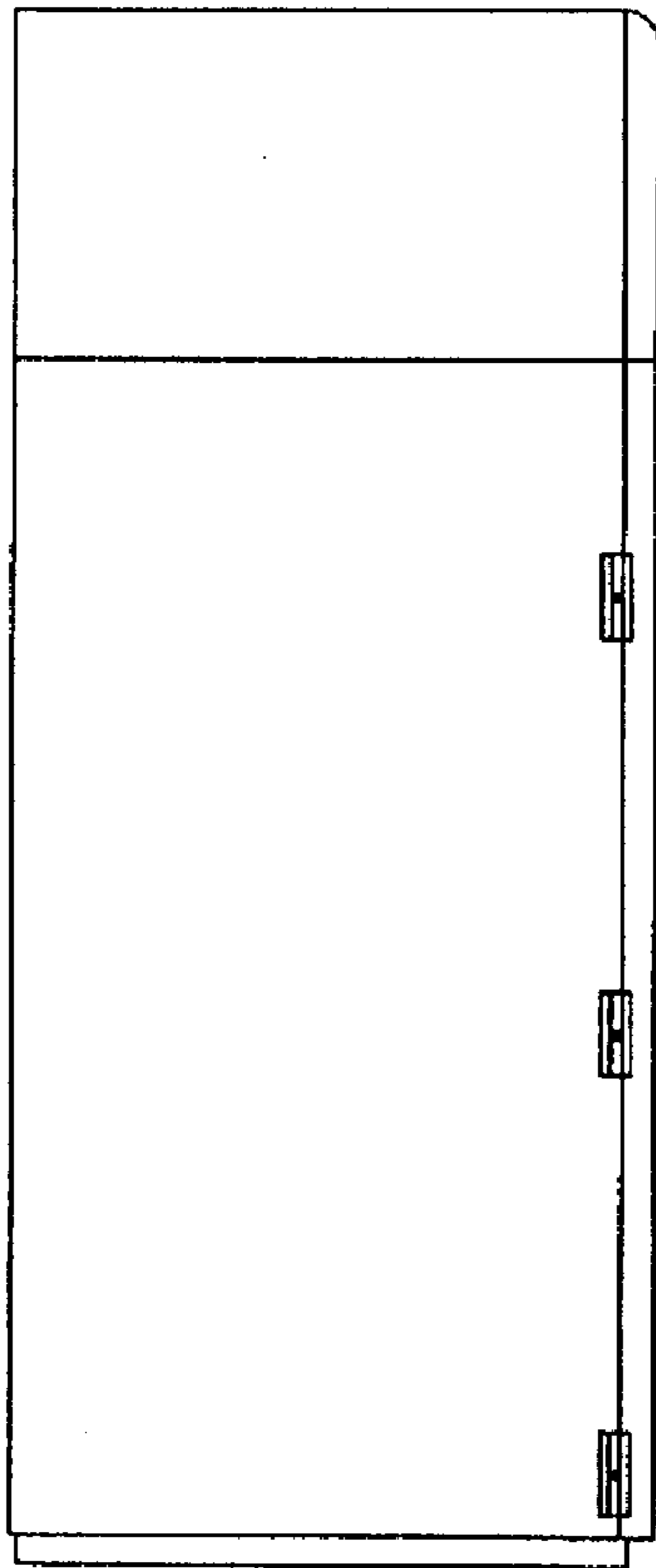

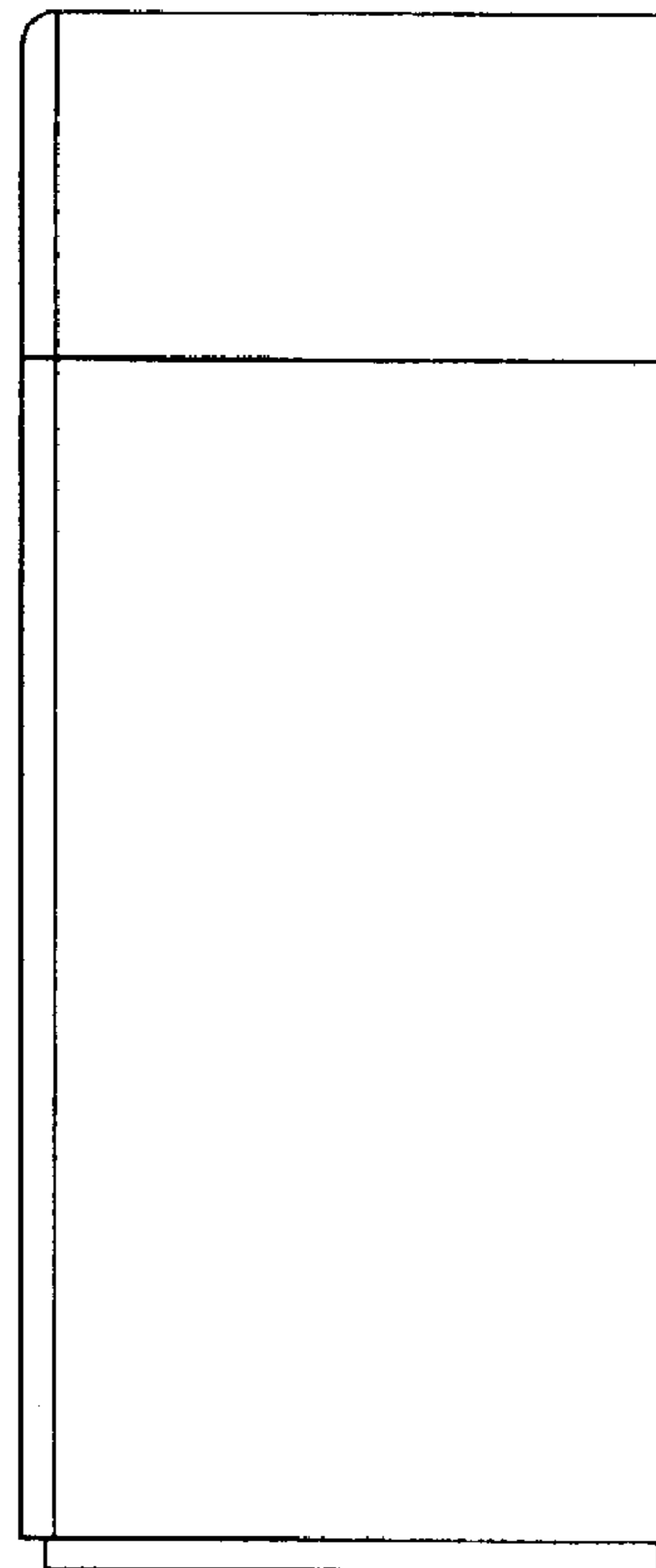

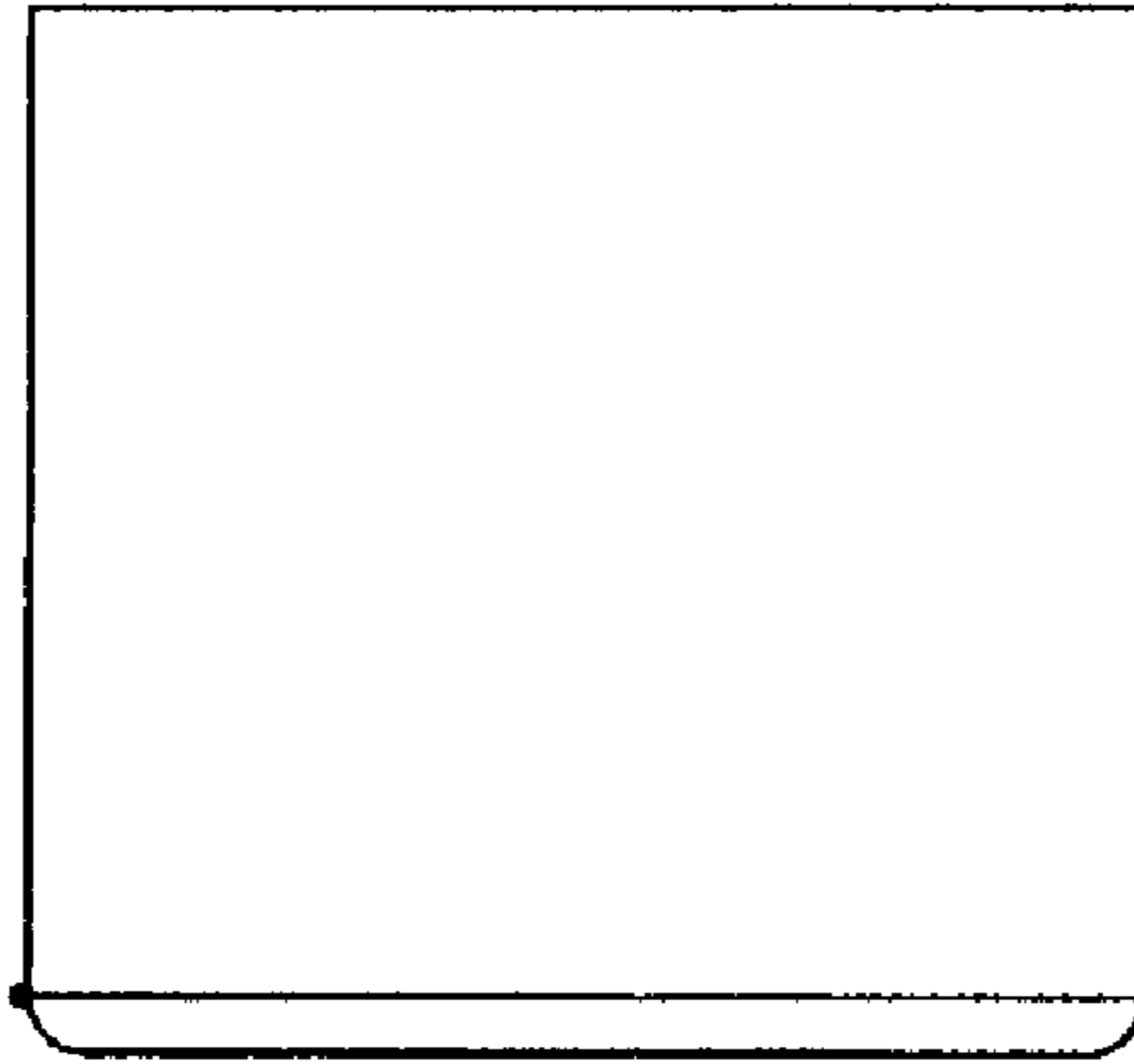

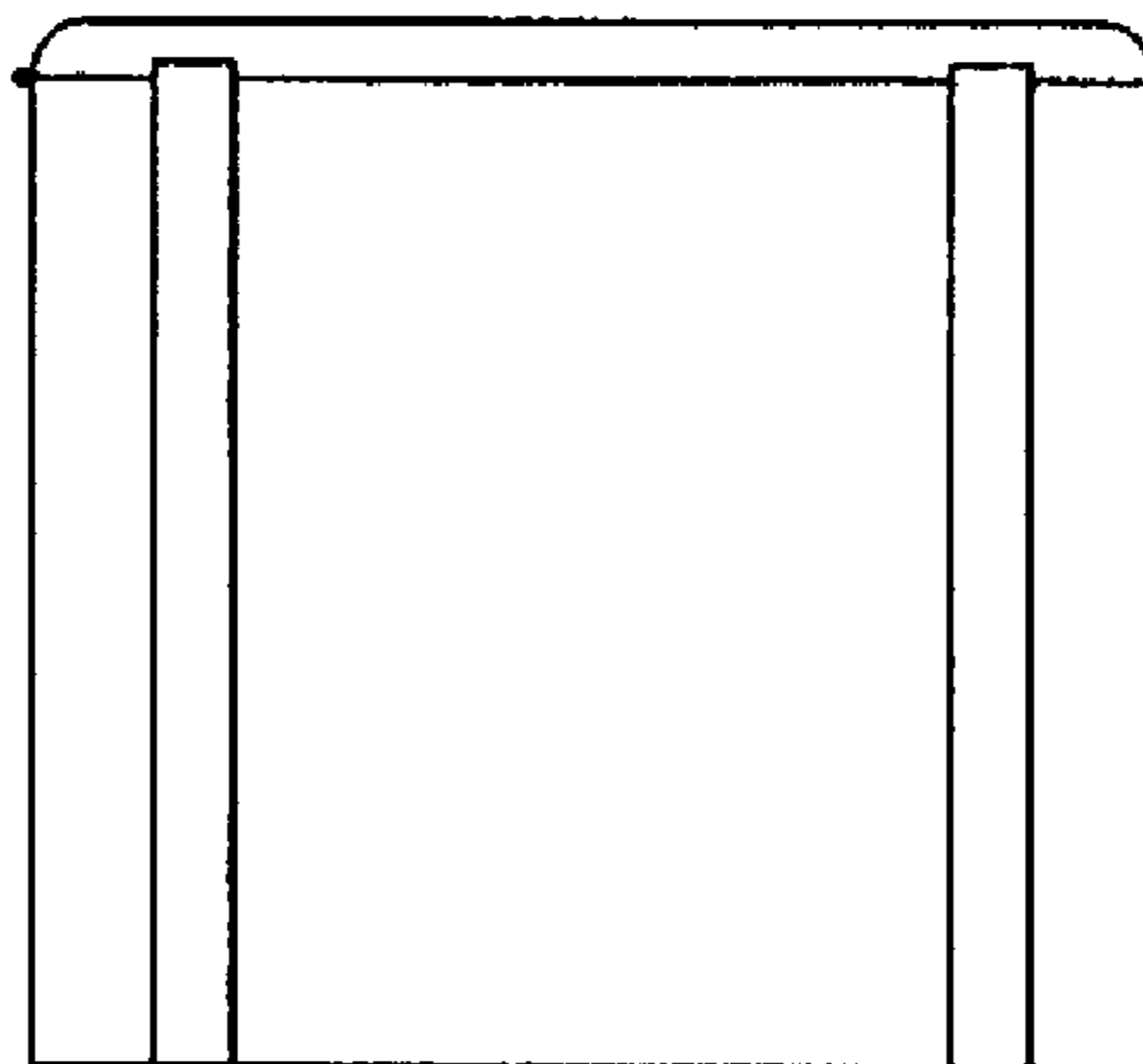
