**DESCRIPTION**

FIG. 2 is substantially a front elevational view of the gaming device display shown in FIG. 1.

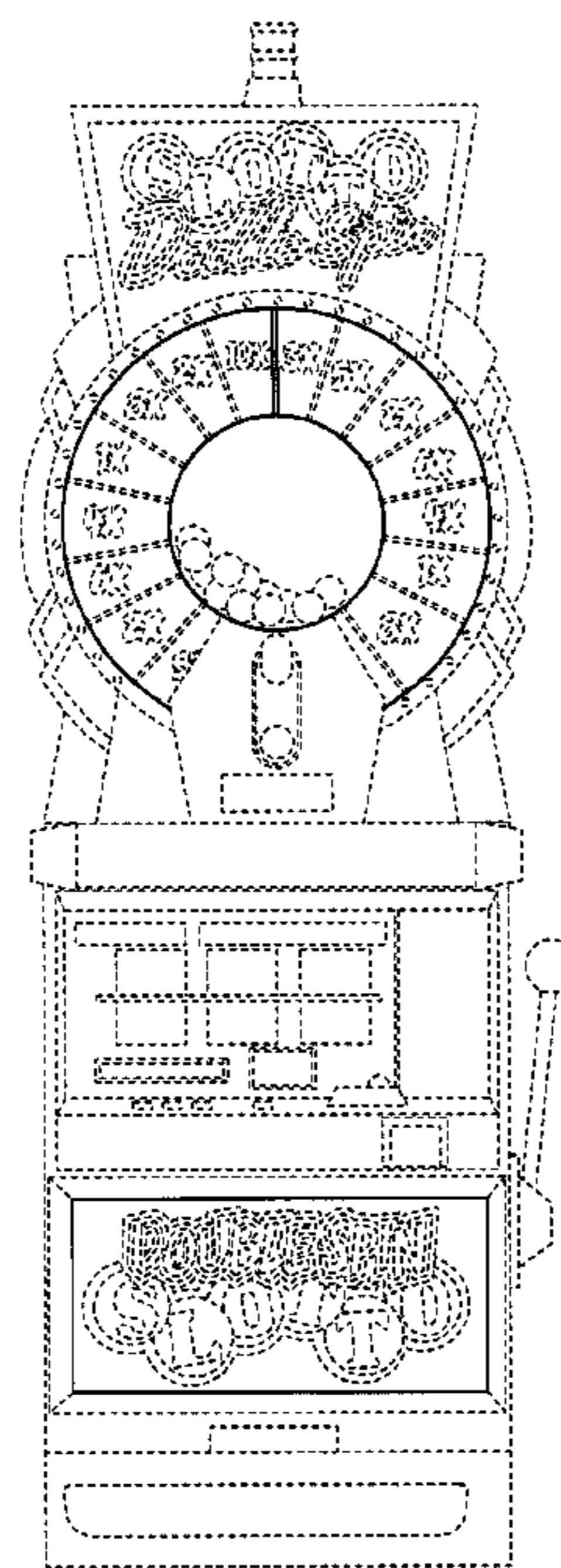
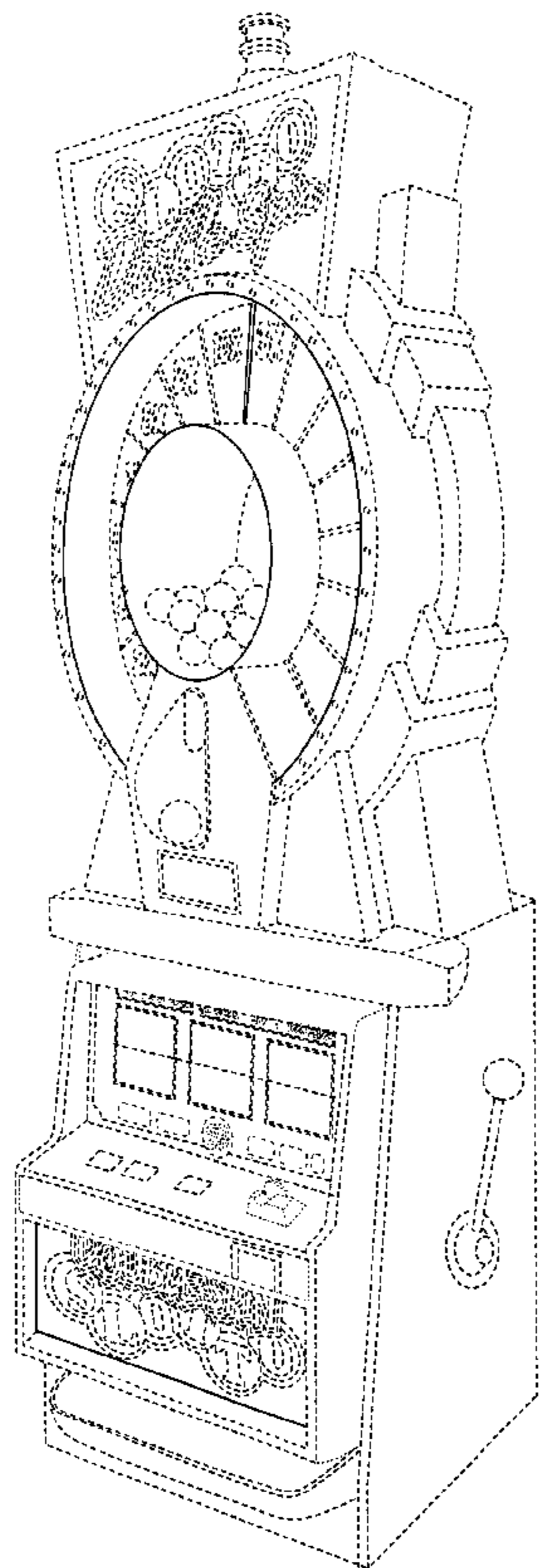
FIG. 3 is substantially a right side elevational view of the gaming device display shown in FIG. 1.

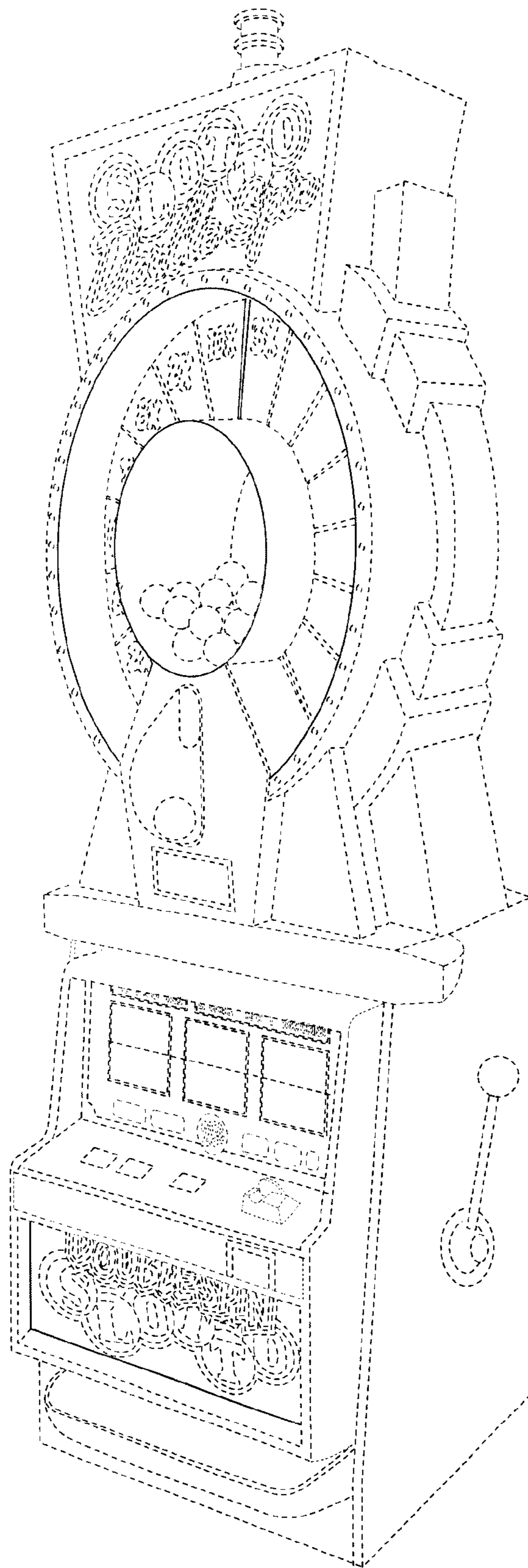

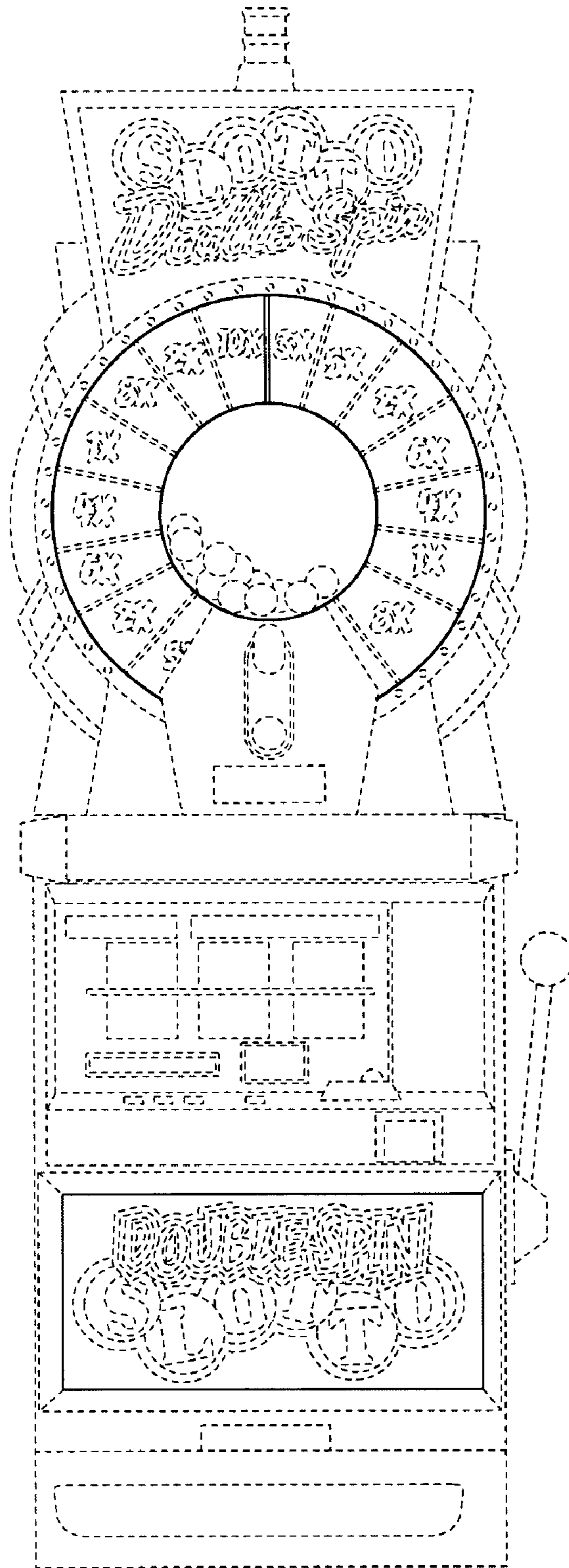
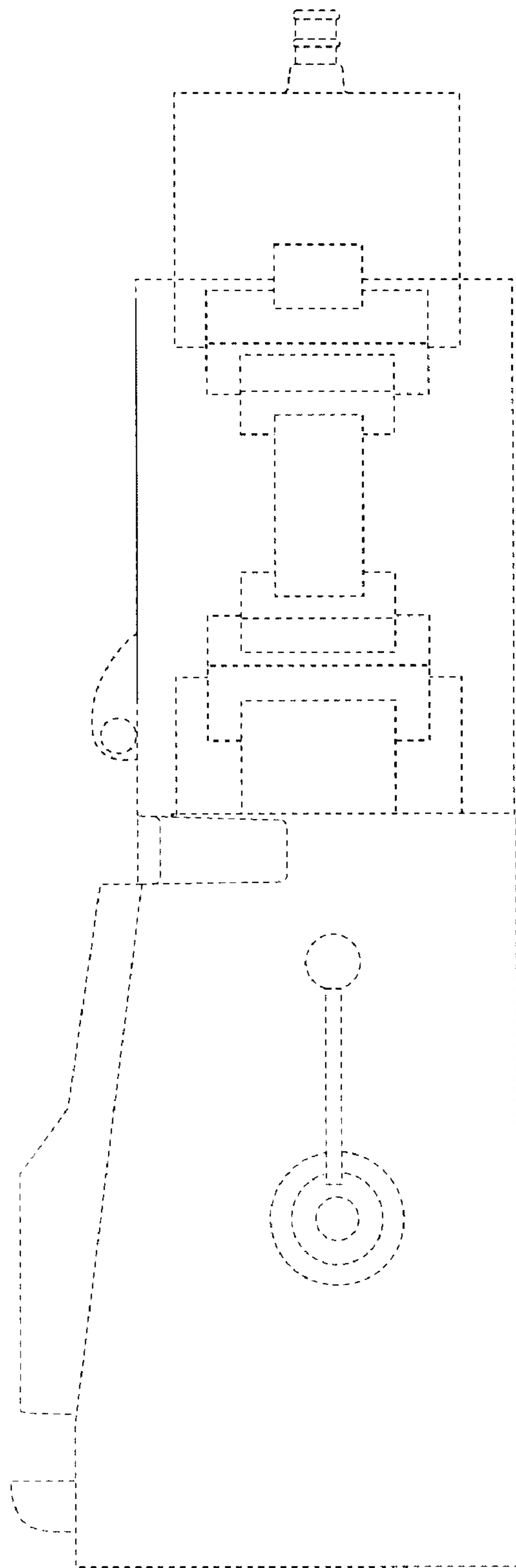
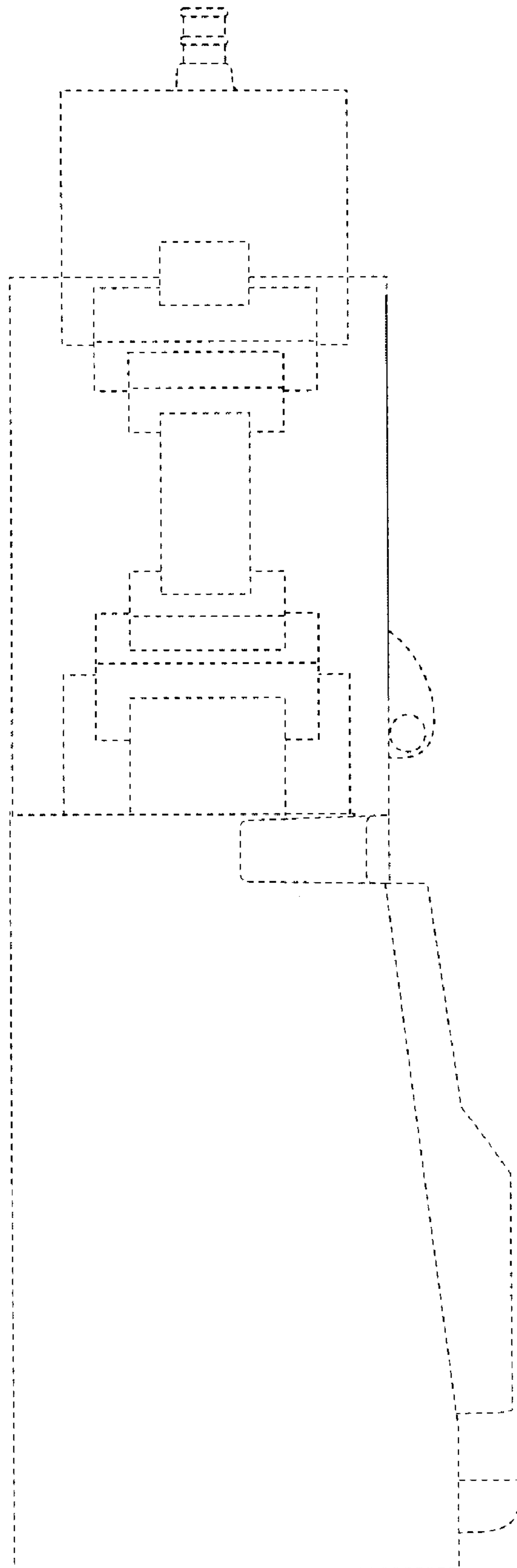

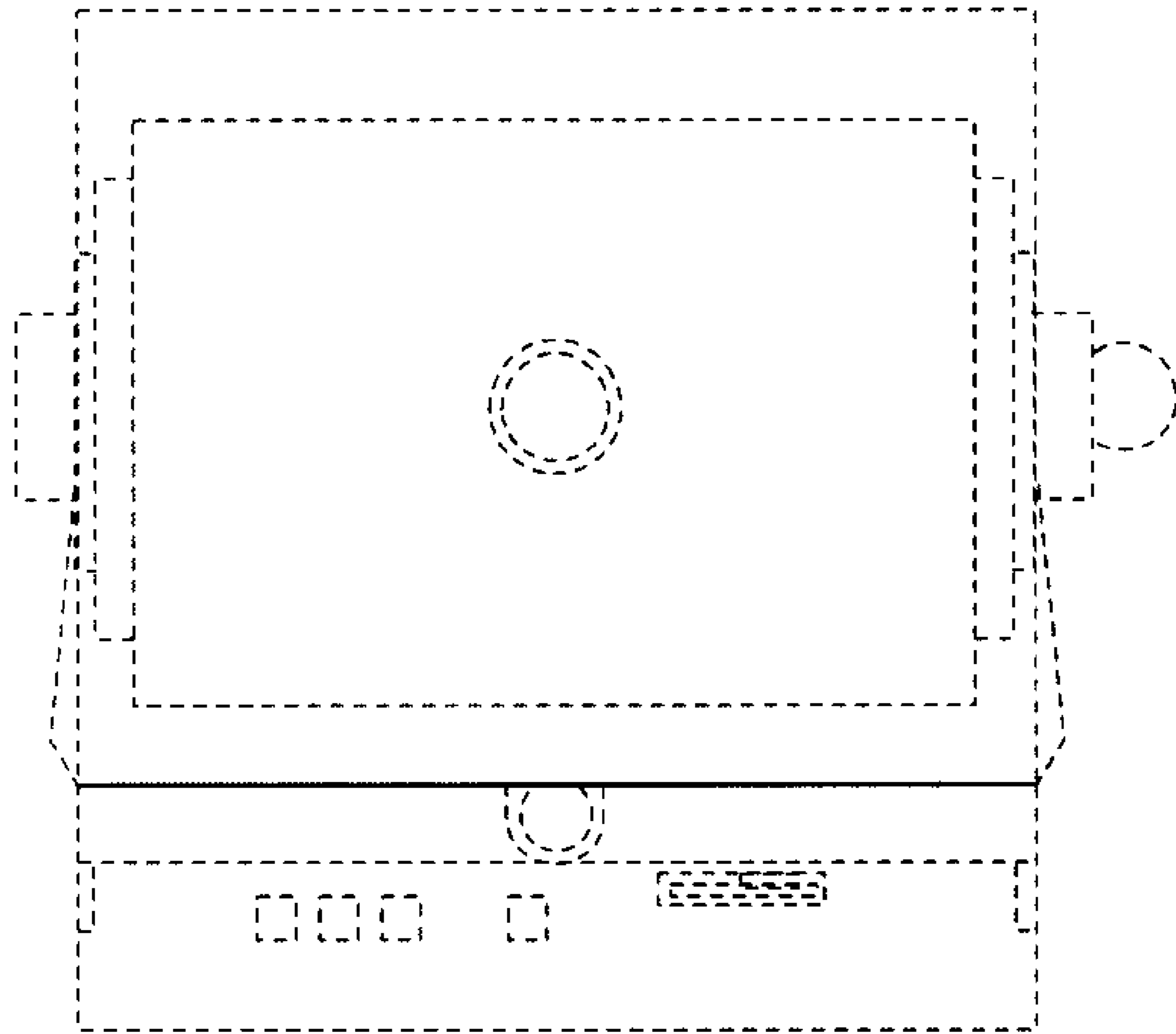
