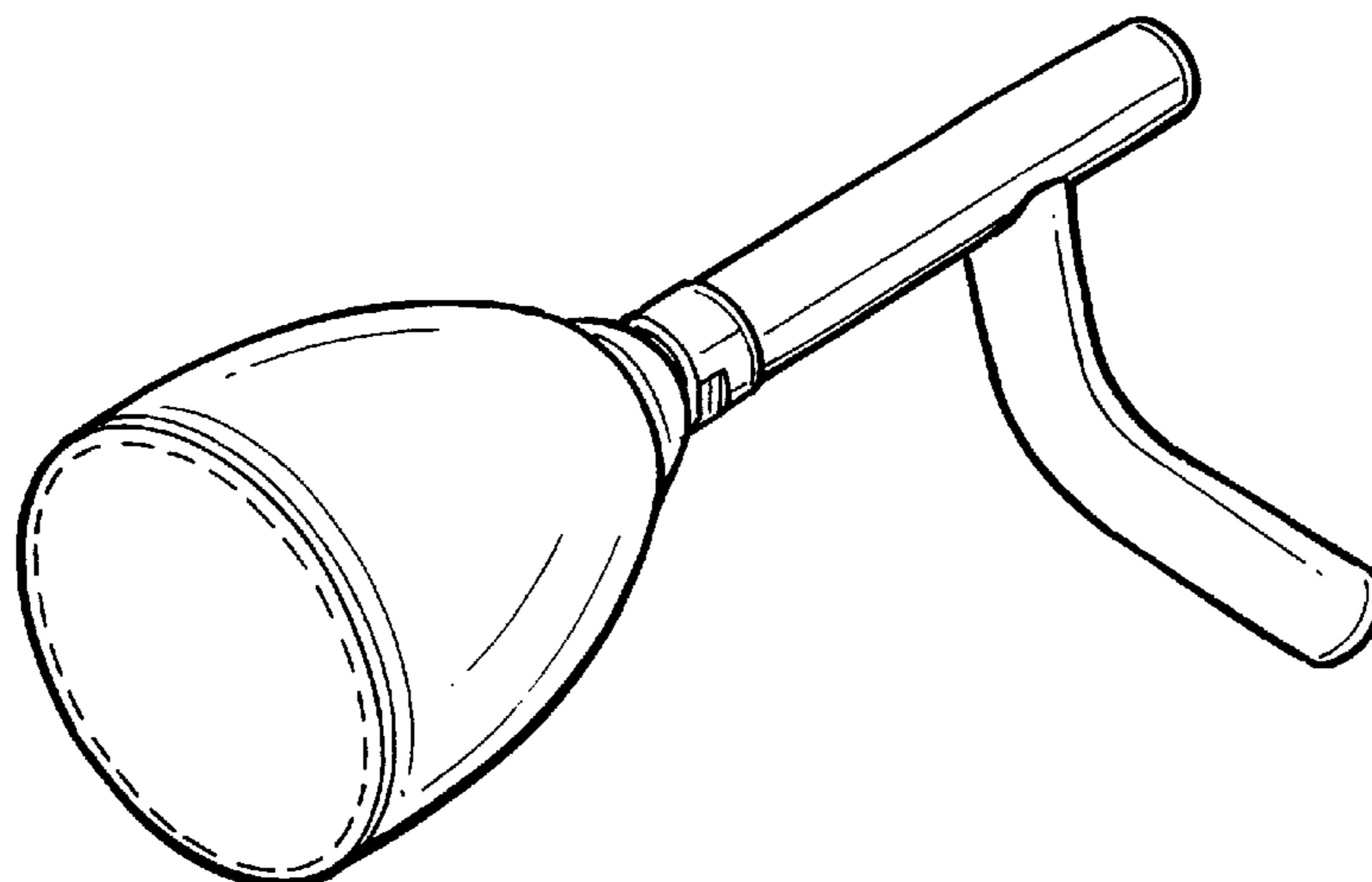
(57) **CLAIM**

The ornamental design for a showerhead with arm, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the new design for a showerhead with arm;  
 FIG. 2 is a left elevational view of the new design for a showerhead with arm, the right elevational view being a mirror image;  
 FIG. 3 is a top plan view of the new design for a showerhead with arm;  
 FIG. 4 is a bottom plan view of the new design for a showerhead with arm;  
 FIG. 5 is a front elevational view of the new design for a showerhead with arm; and,  
 FIG. 6 is a rear elevational view of the new design for a showerhead with arm.  
 The broken lines in the Figures are for illustrative purposes only and form no part of the claimed design.

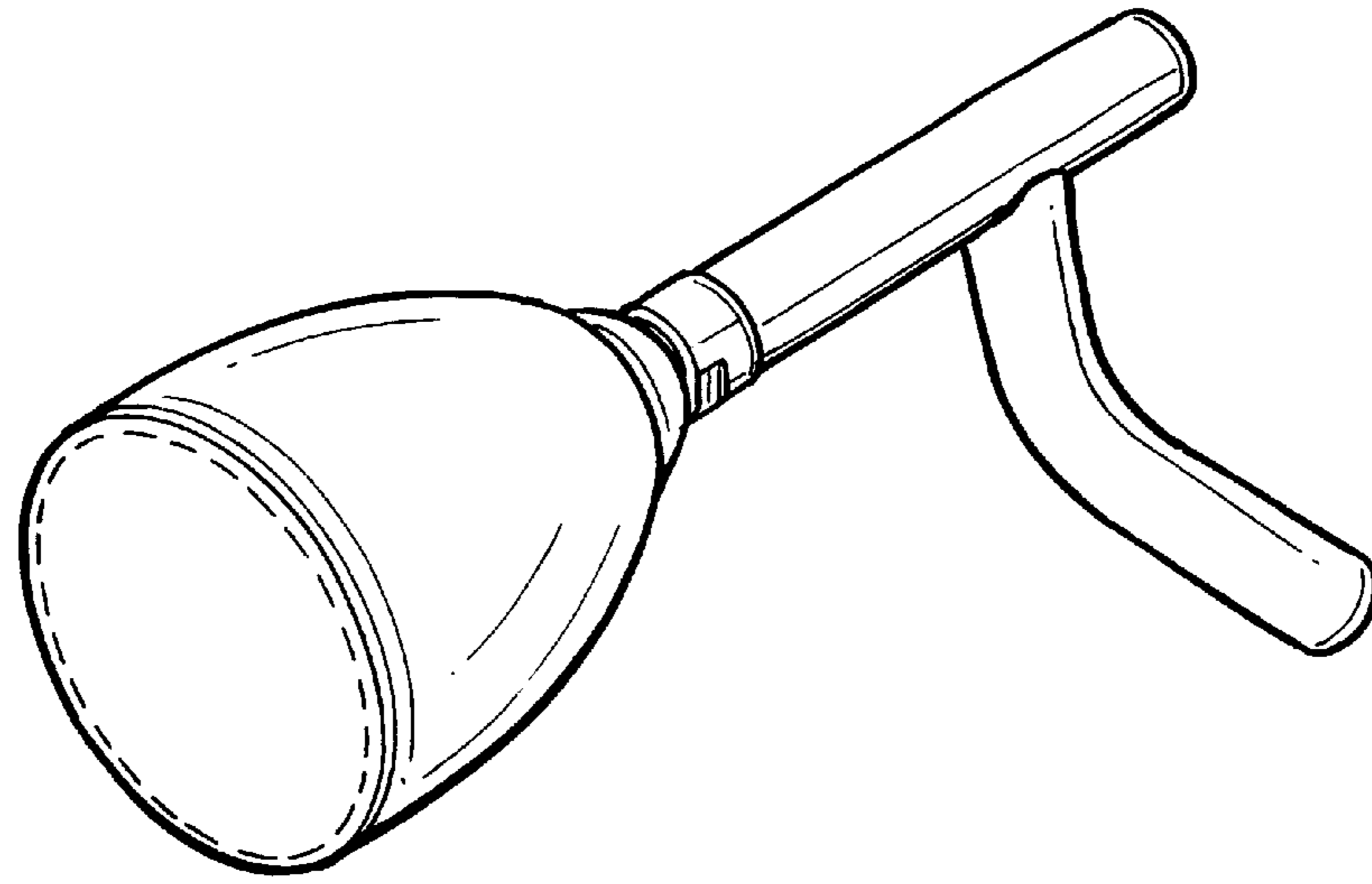

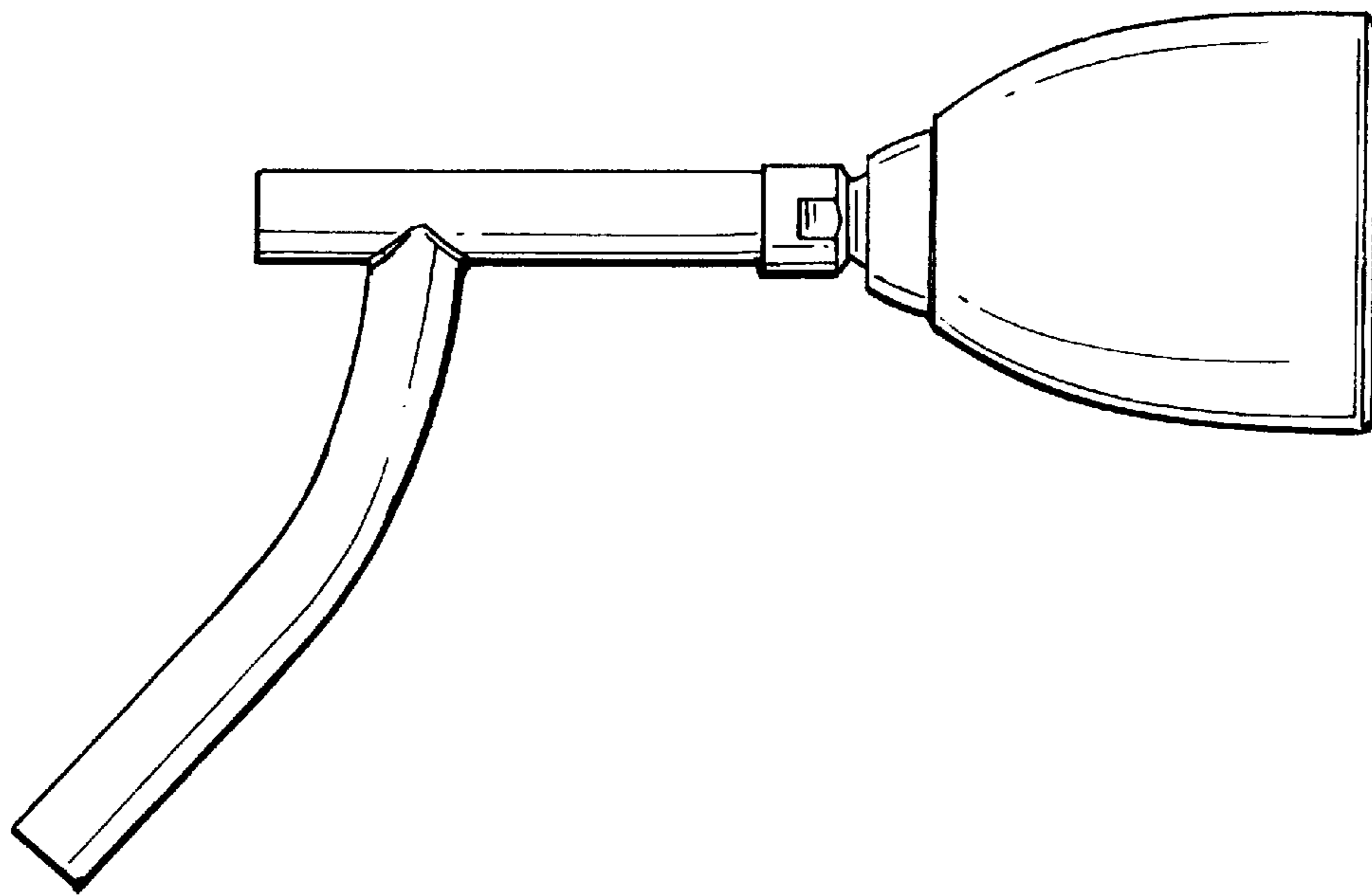

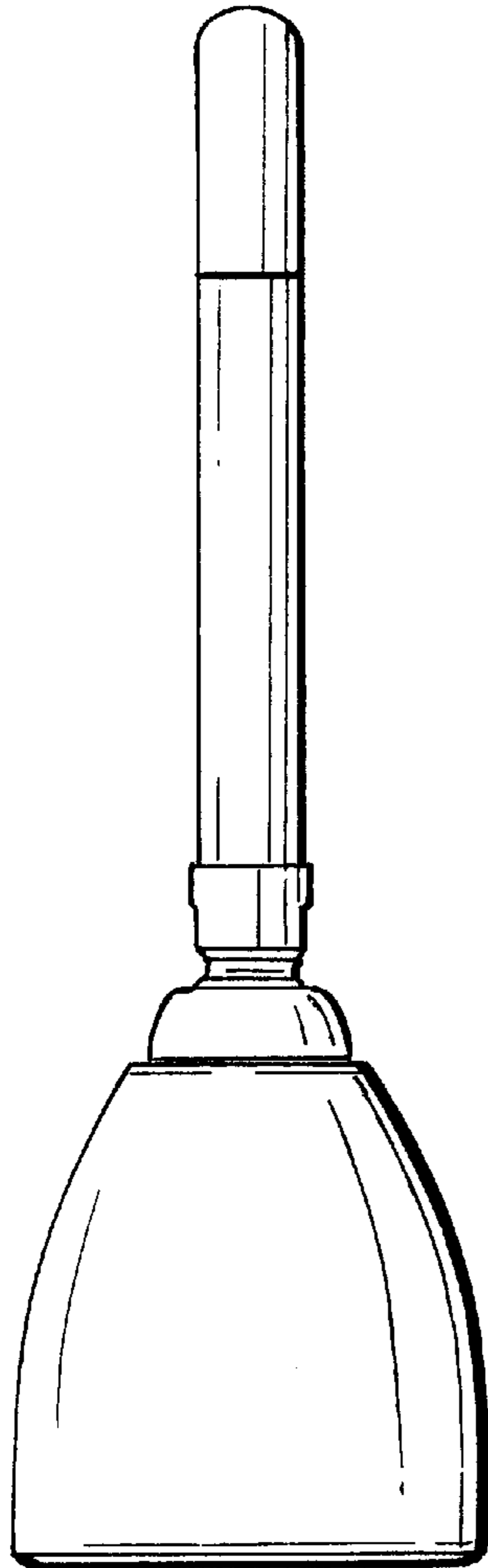

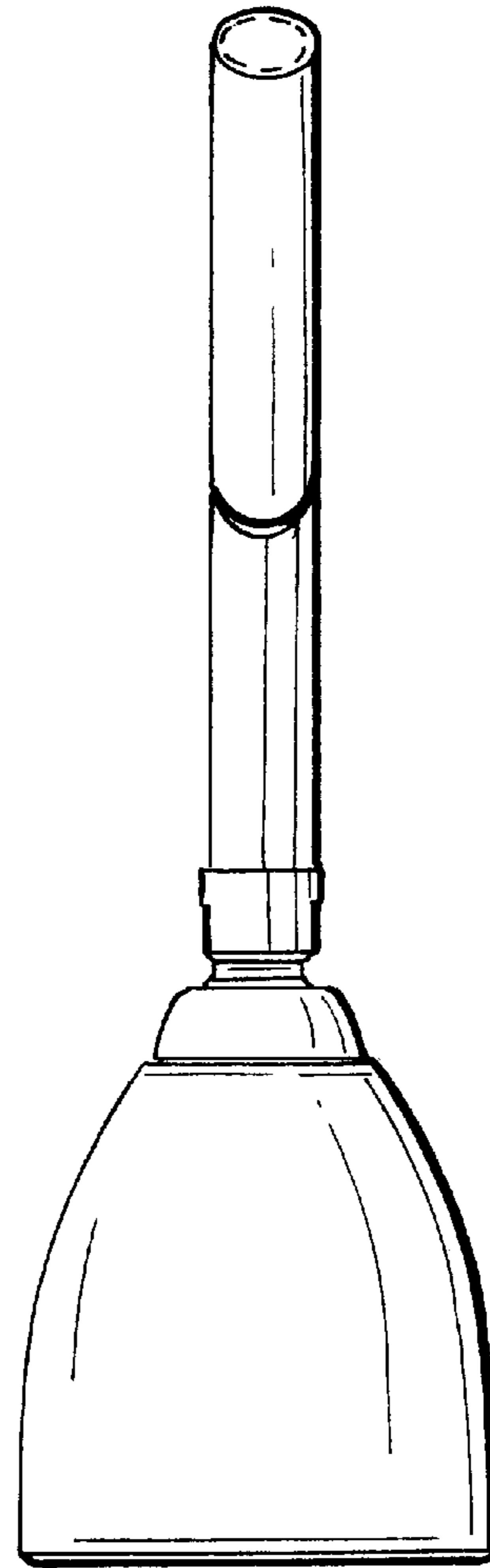

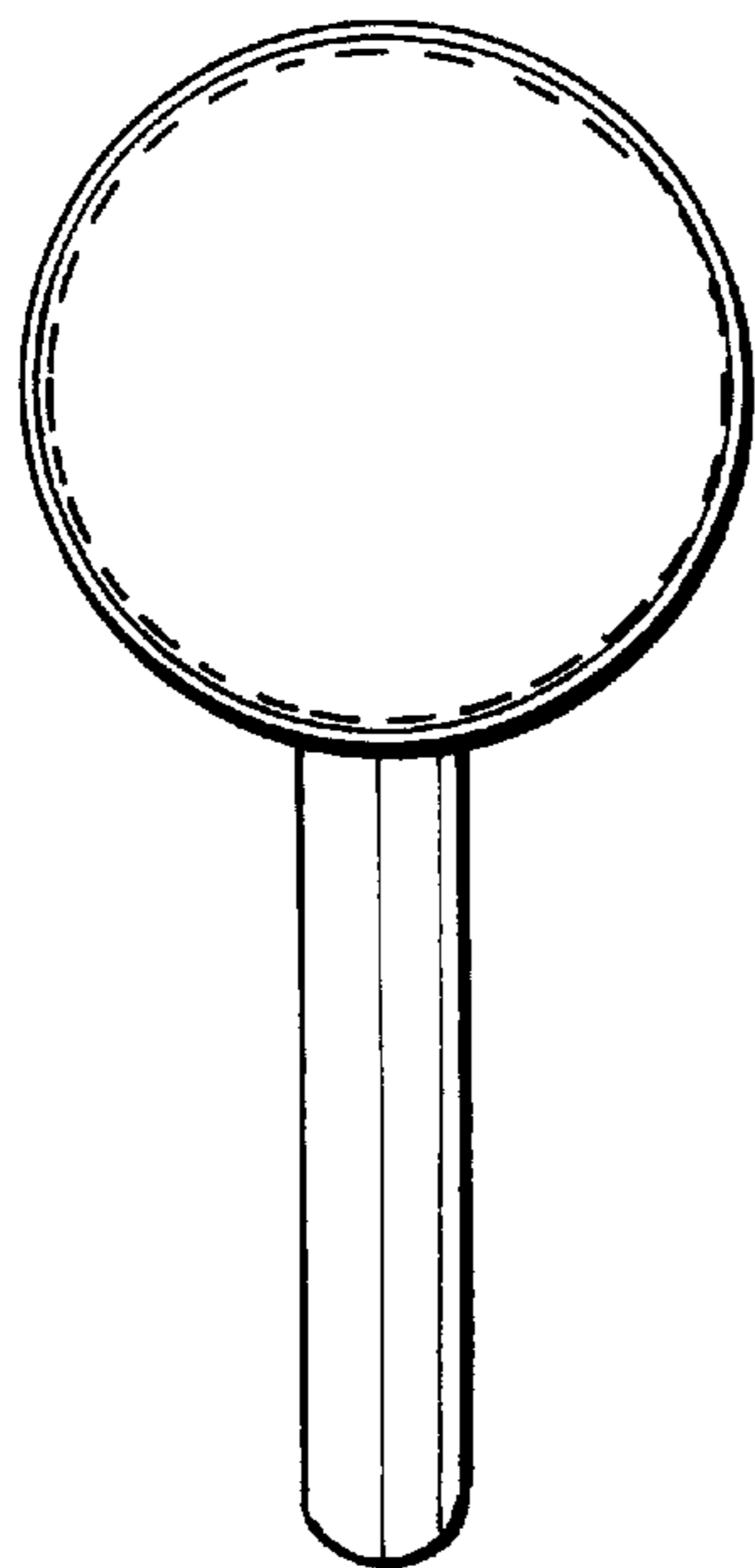

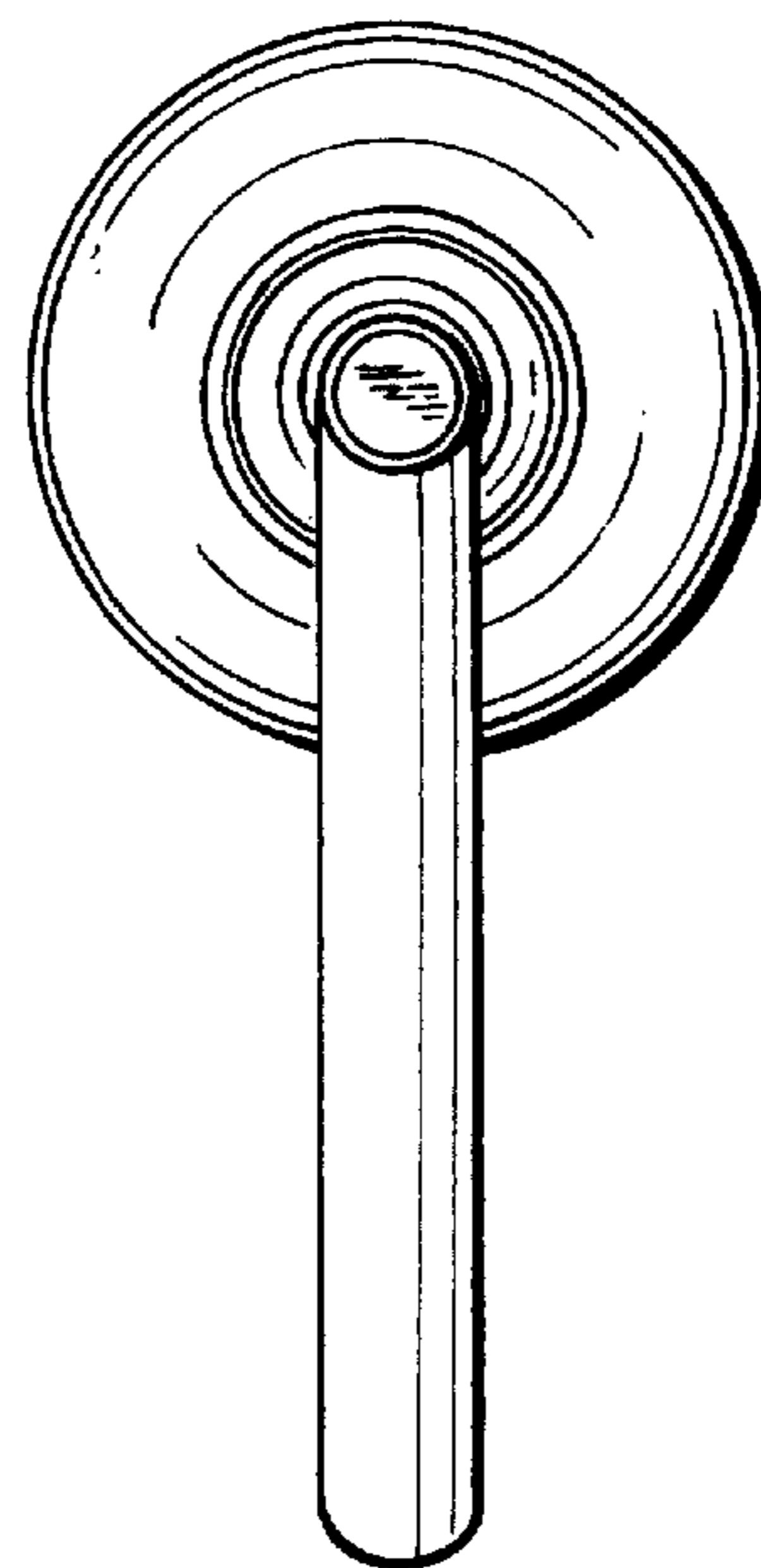
