(57) **CLAIM**

The ornamental design for a combination ceiling fan and light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of a combination ceiling fan and light fixture in accordance with my design; FIG. 2 is a greatly reduced bottom plan view of the combination ceiling fan and light fixture in accordance with my design;

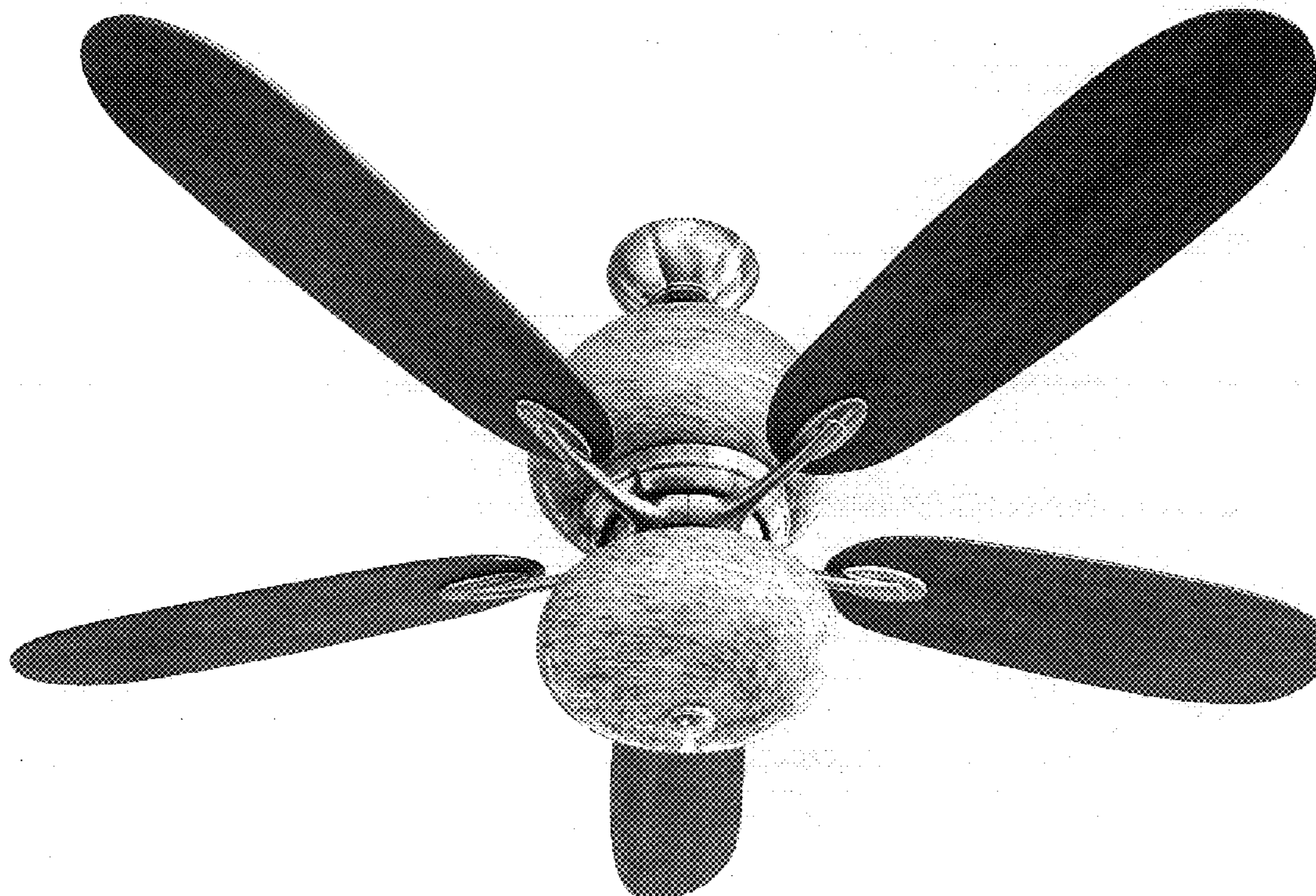
FIG. 3 is a greatly reduced top plan view of the combination ceiling fan and light fixture in accordance with my design; and

FIG. 4 is a reduced front elevation view of the combination ceiling fan and light fixture in accordance with my design; and,

FIG. 5 is a side elevation view of the combination ceiling fan and light fixture in accordance with my design.

FIGS. 4 and 5 are identical except for the positioning of the fan blades.

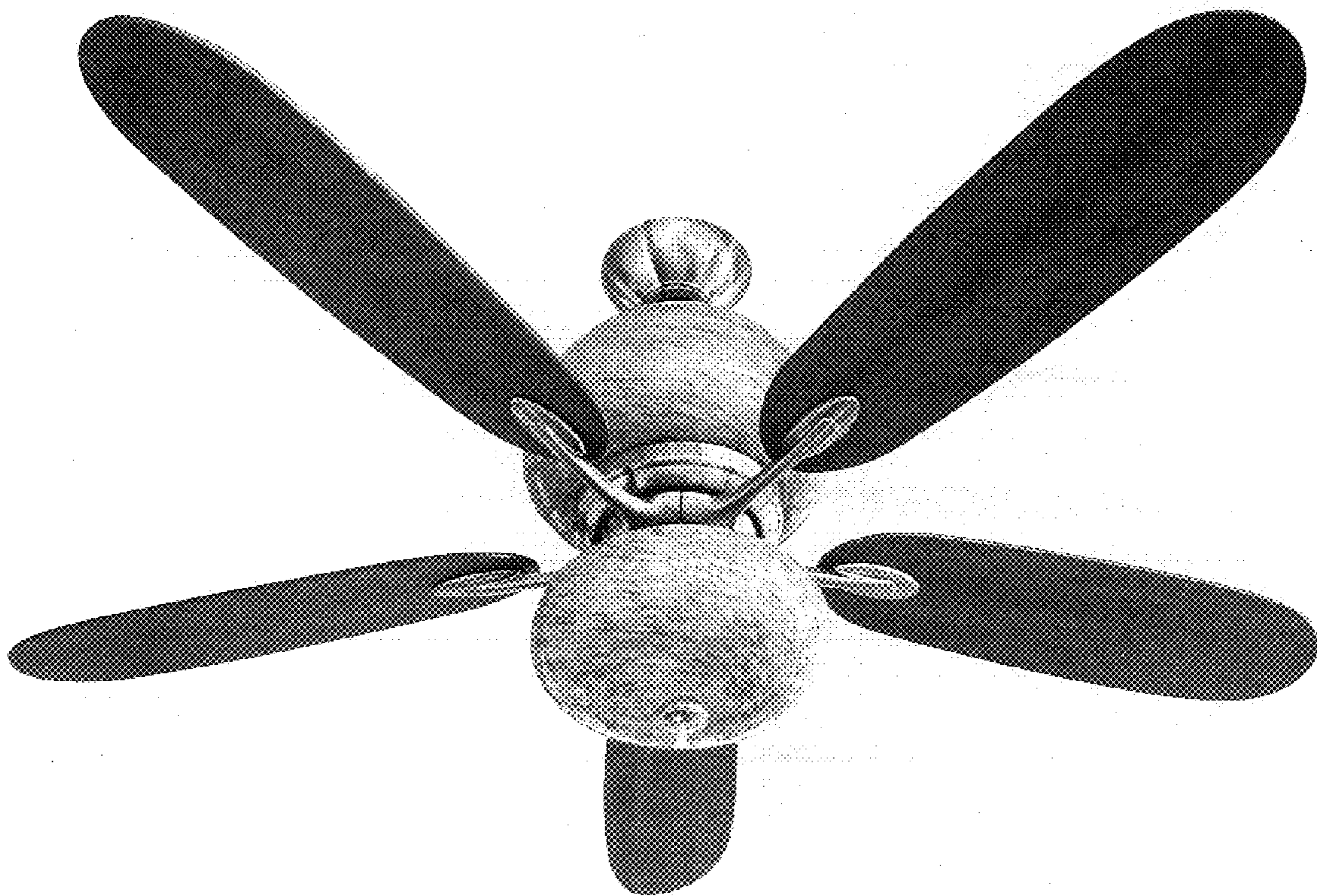

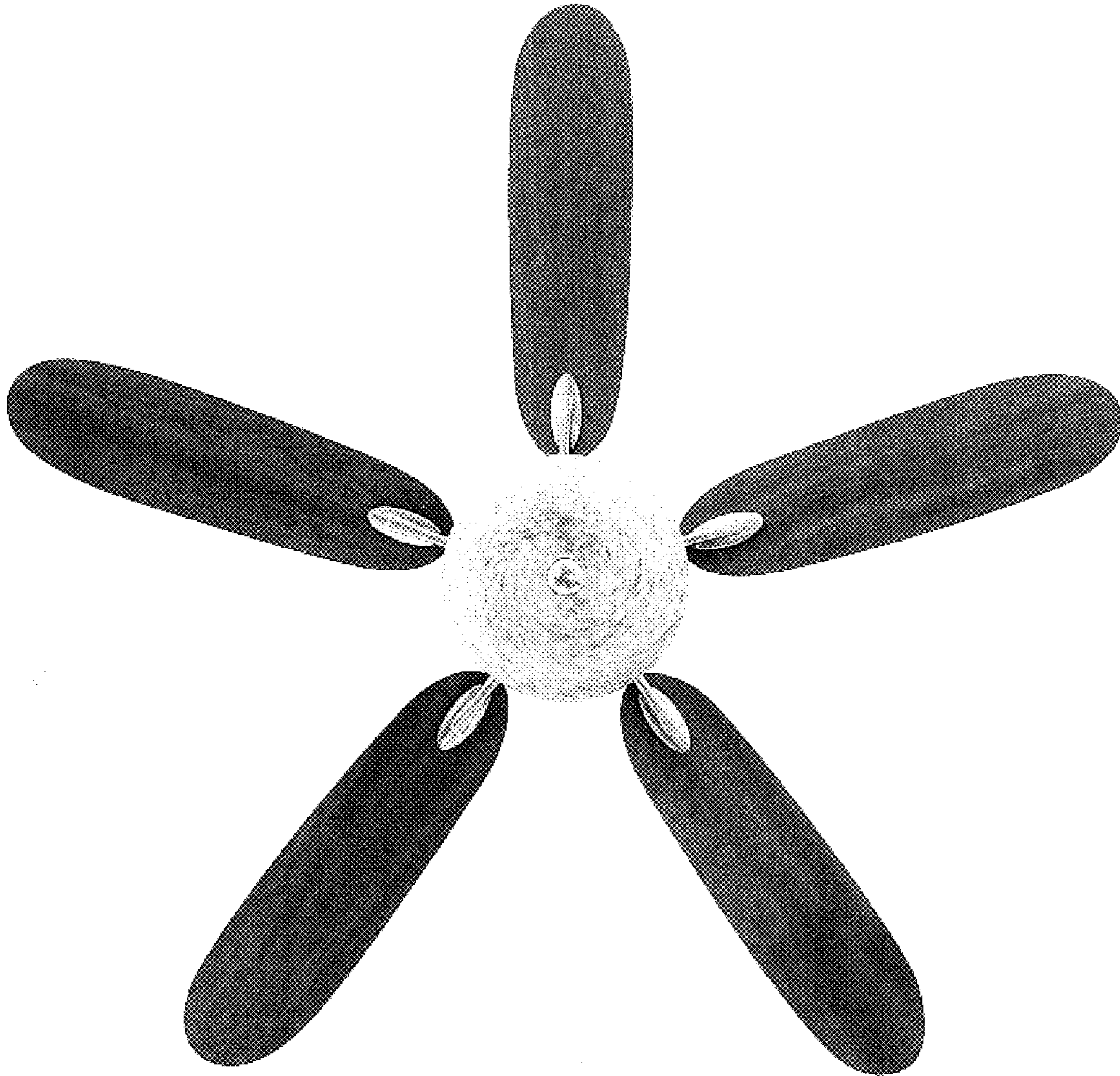

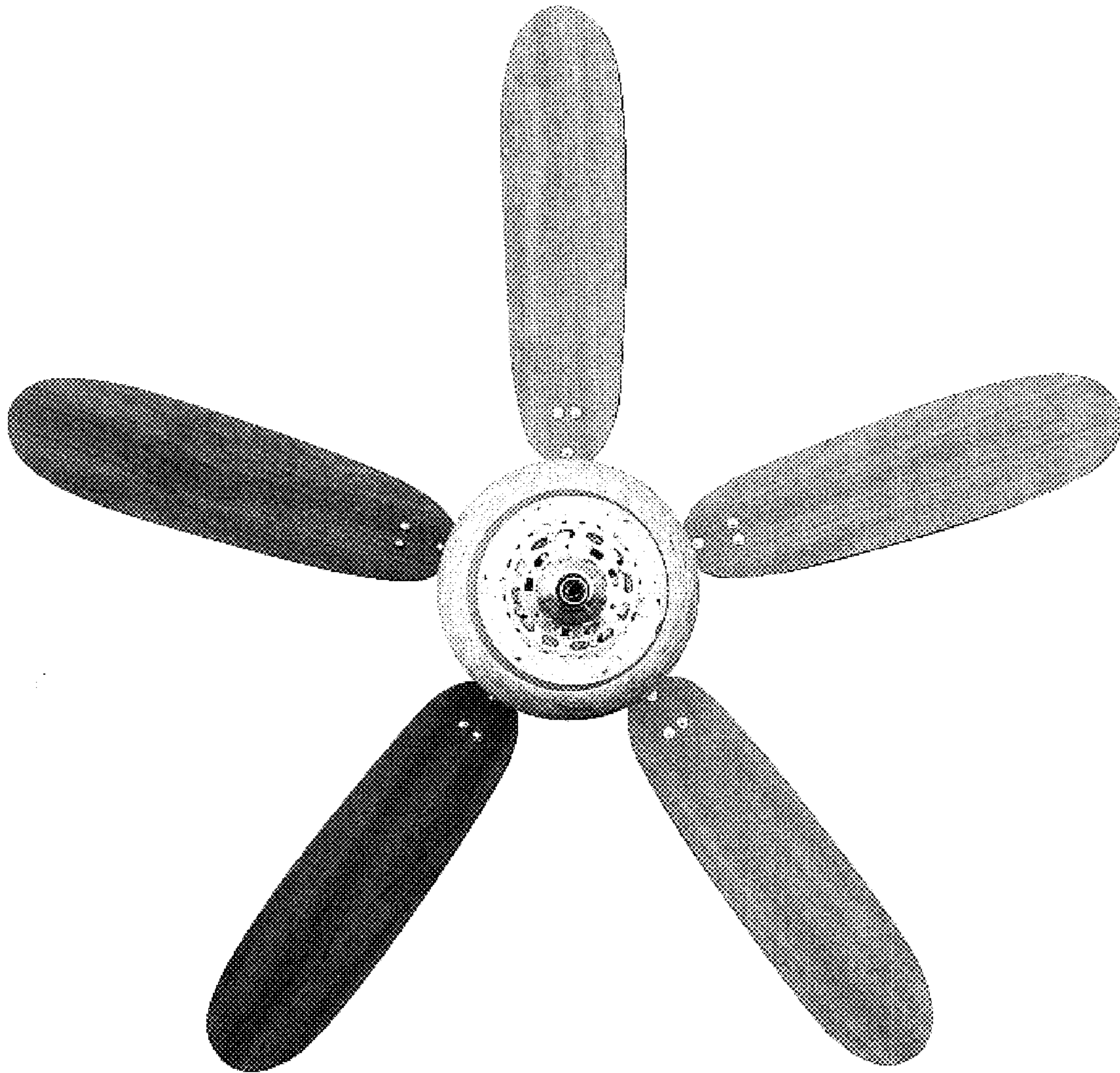

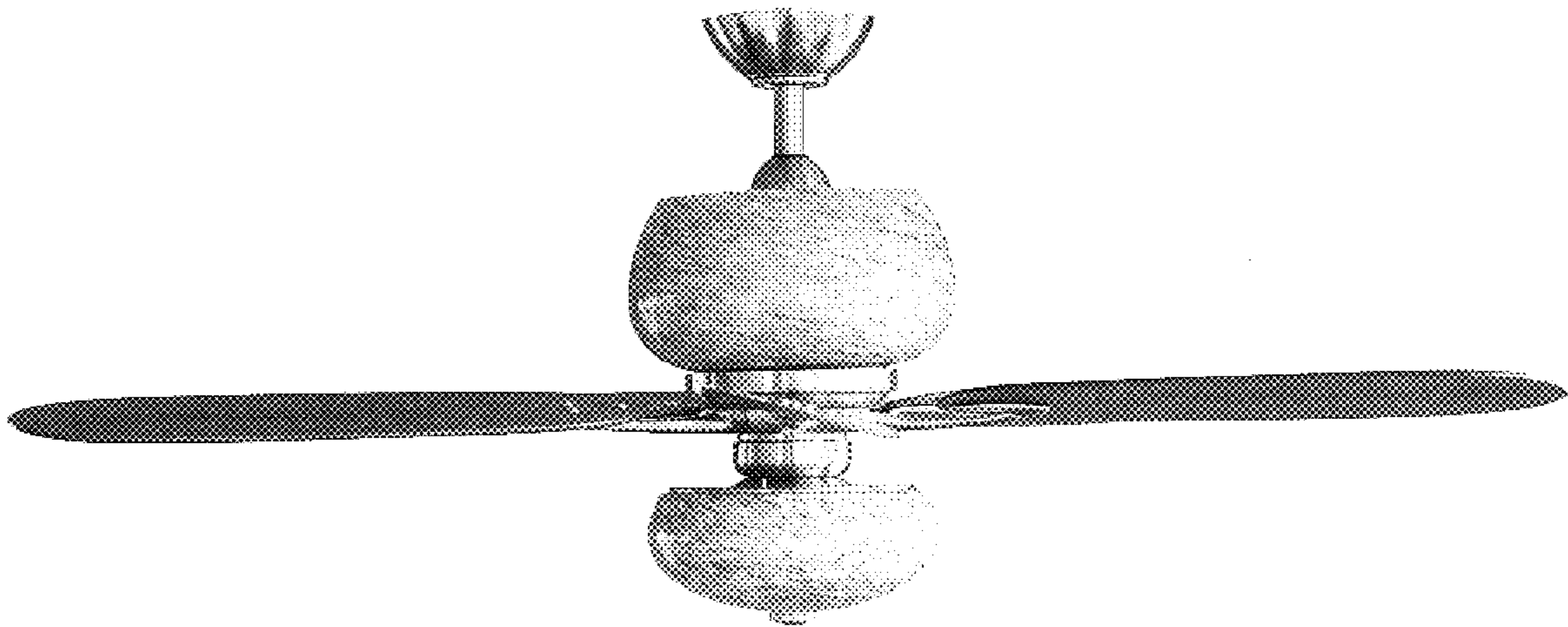

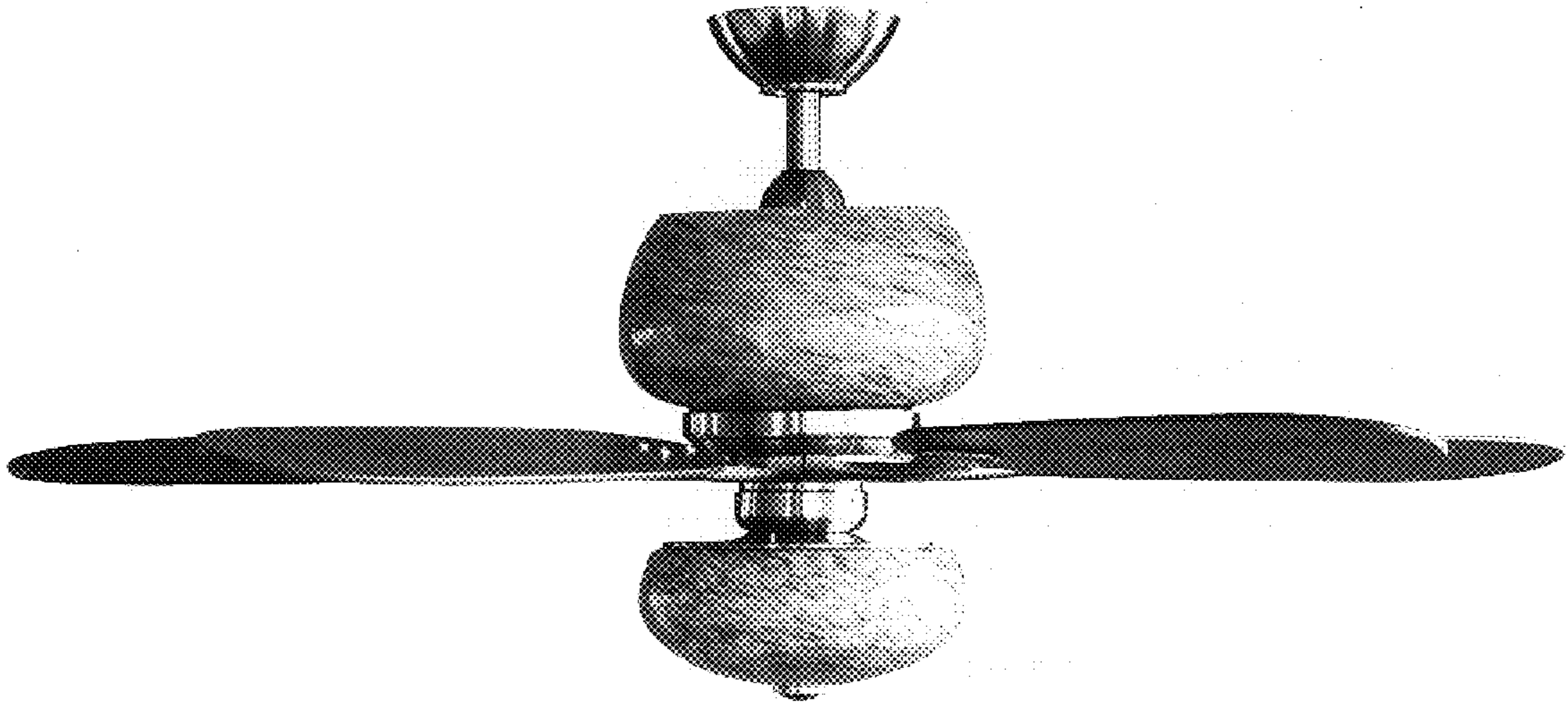
