DESCRIPTION

FIG. 1 is a perspective view of the design of the present invention for a nosepiece;

FIG. 2 is a left side elevational view of the nosepiece of FIG. 1;

FIG. 3 is a right side elevational view of the nosepiece of FIG. 1;

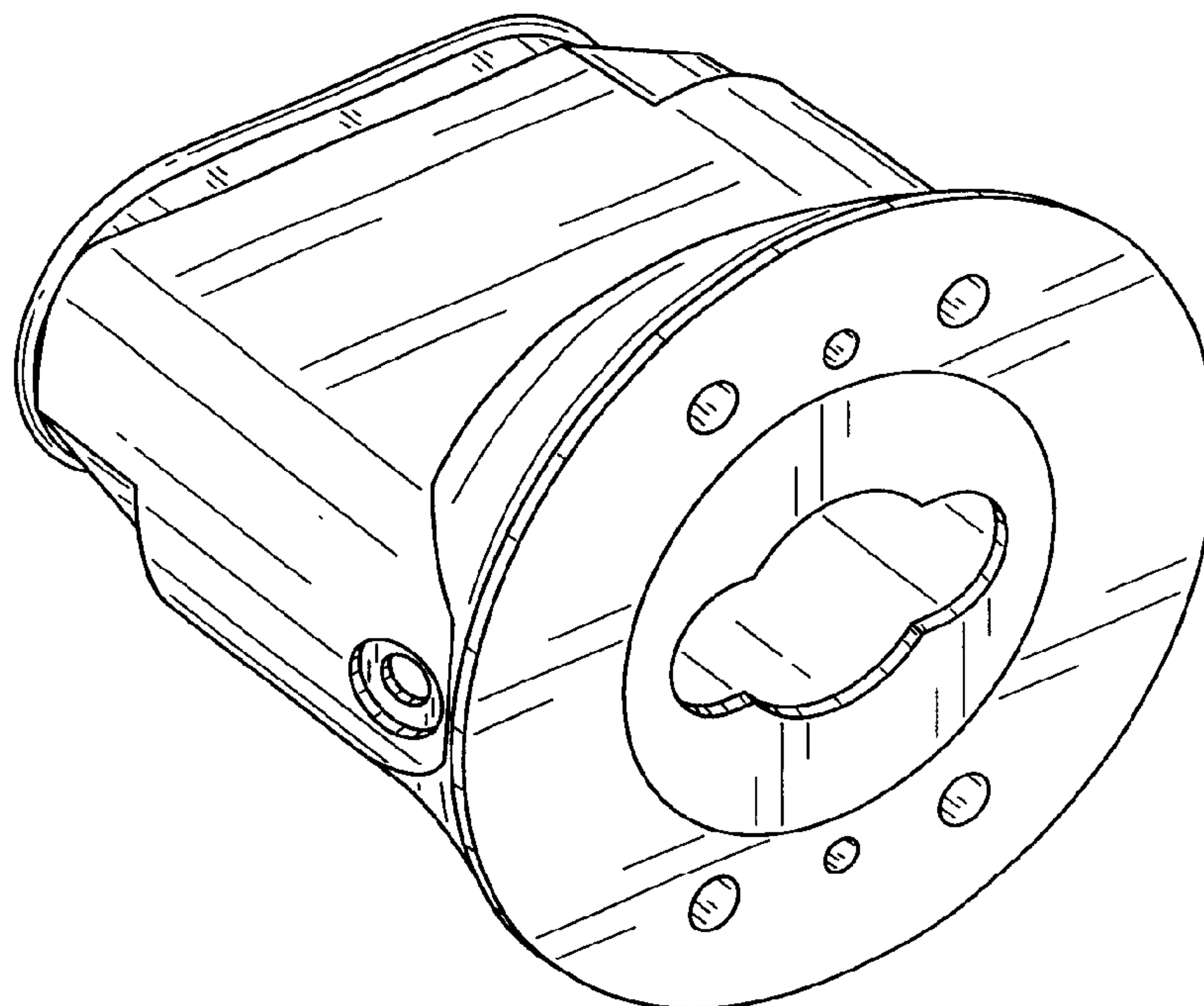
FIG. 4 is a top plan view of the nosepiece of FIG. 1;

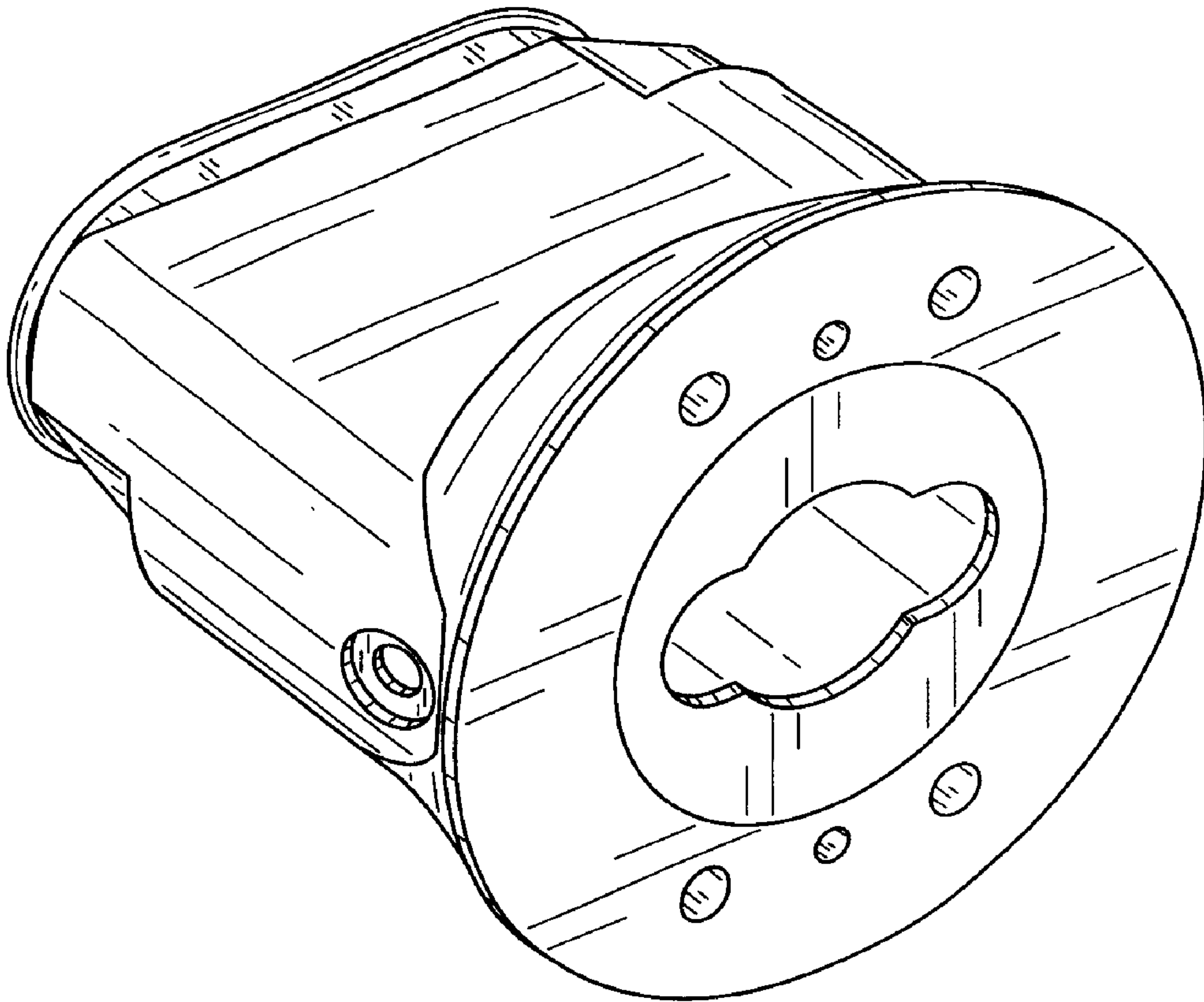

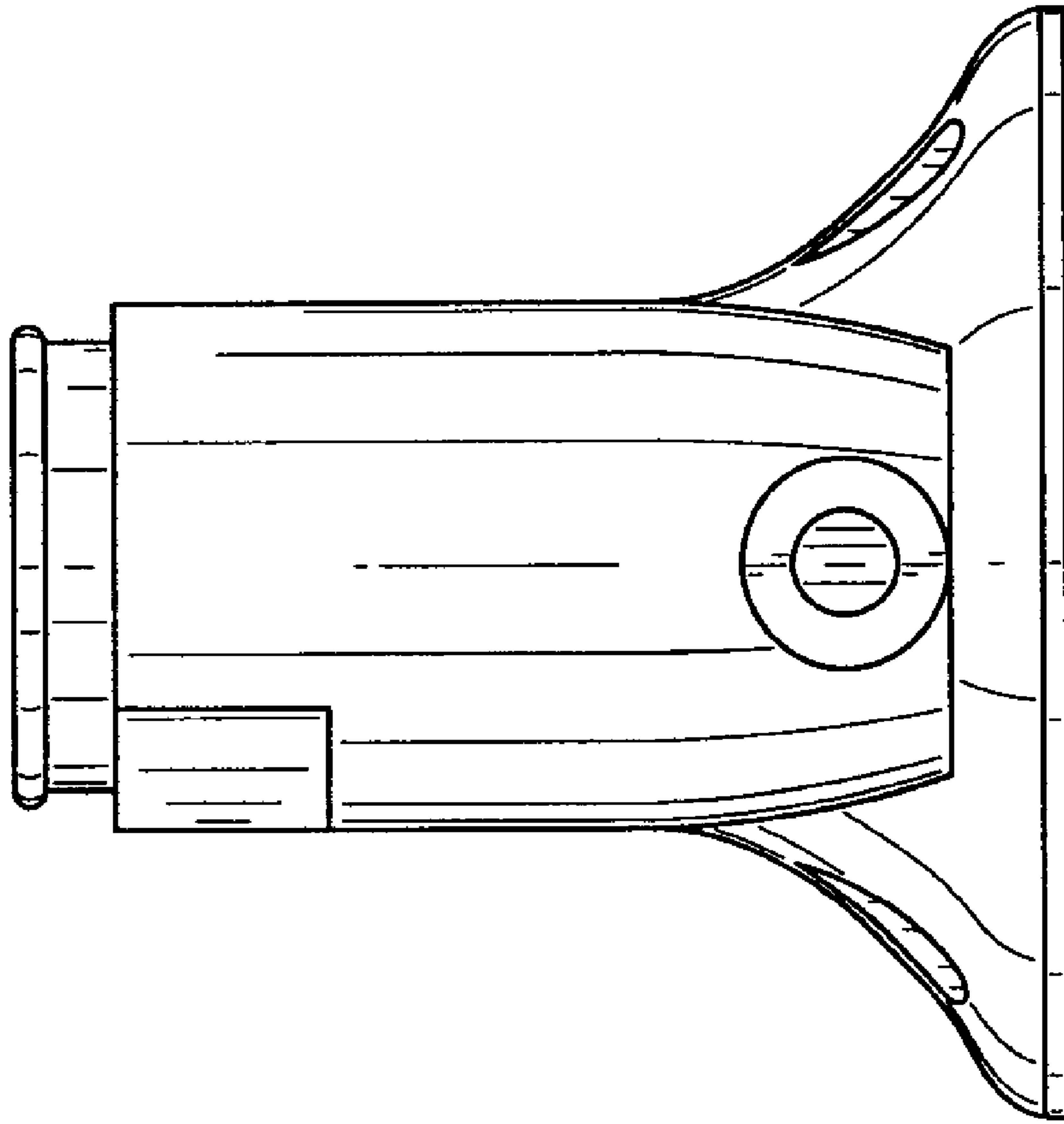

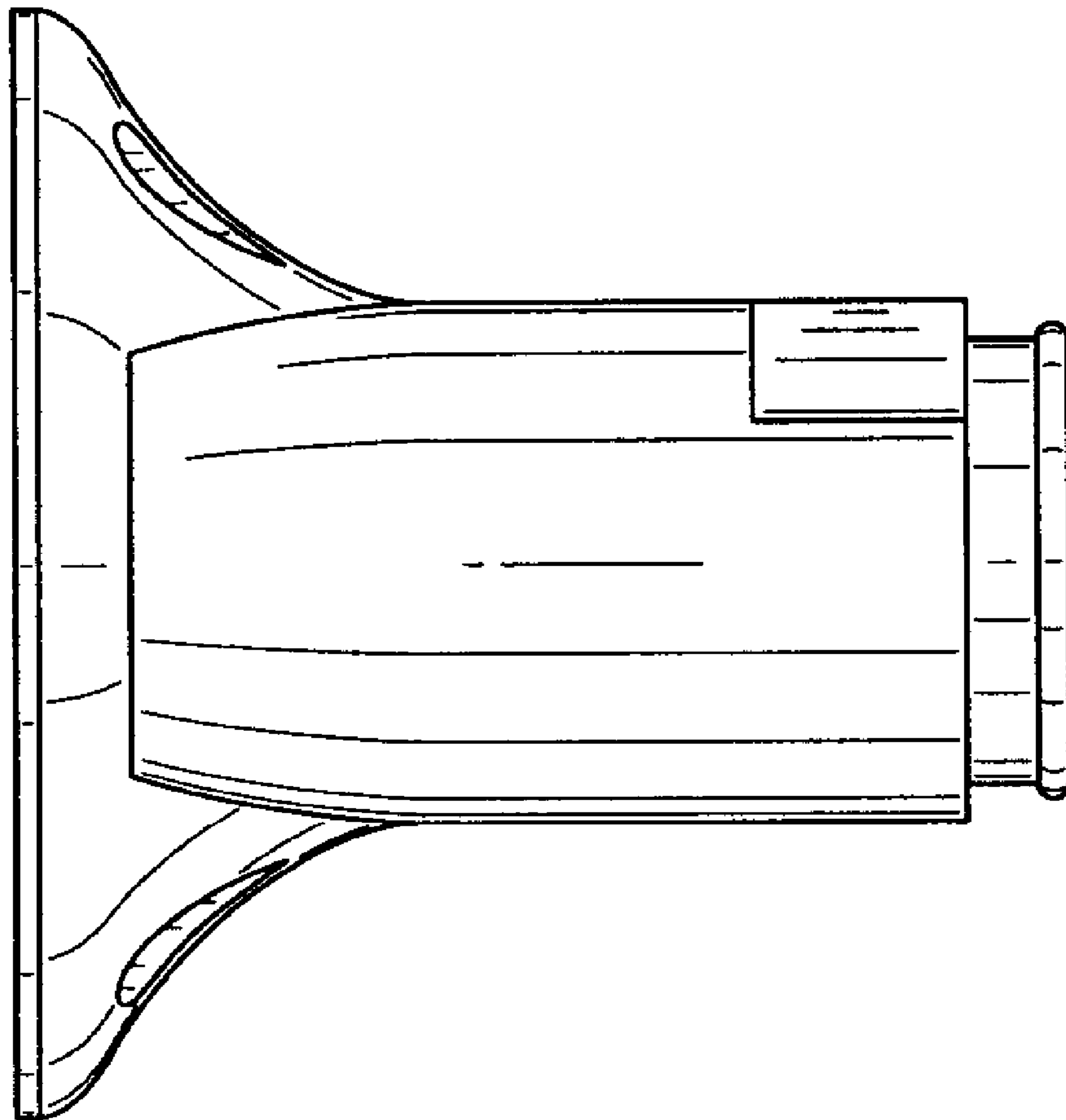

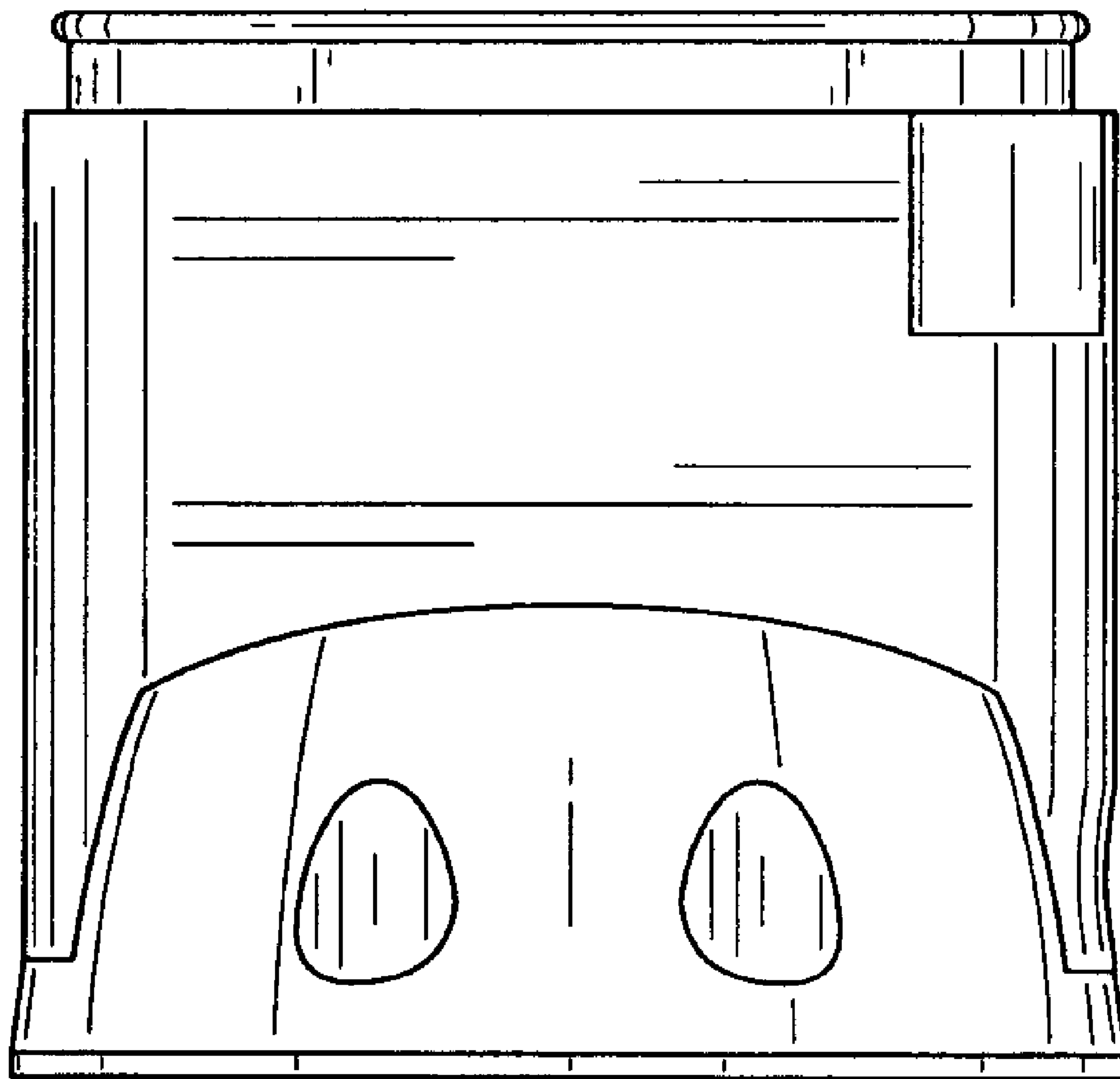

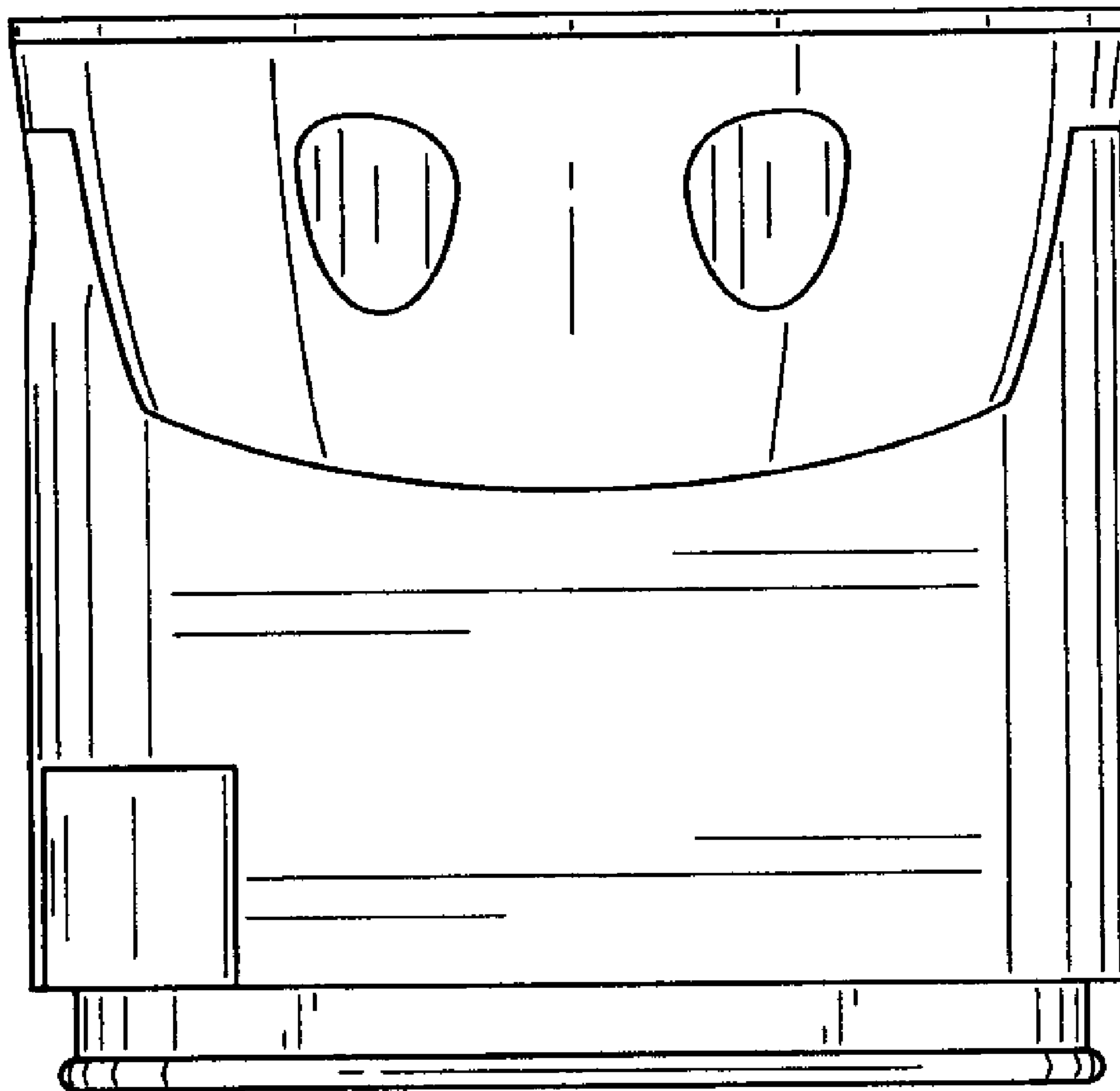

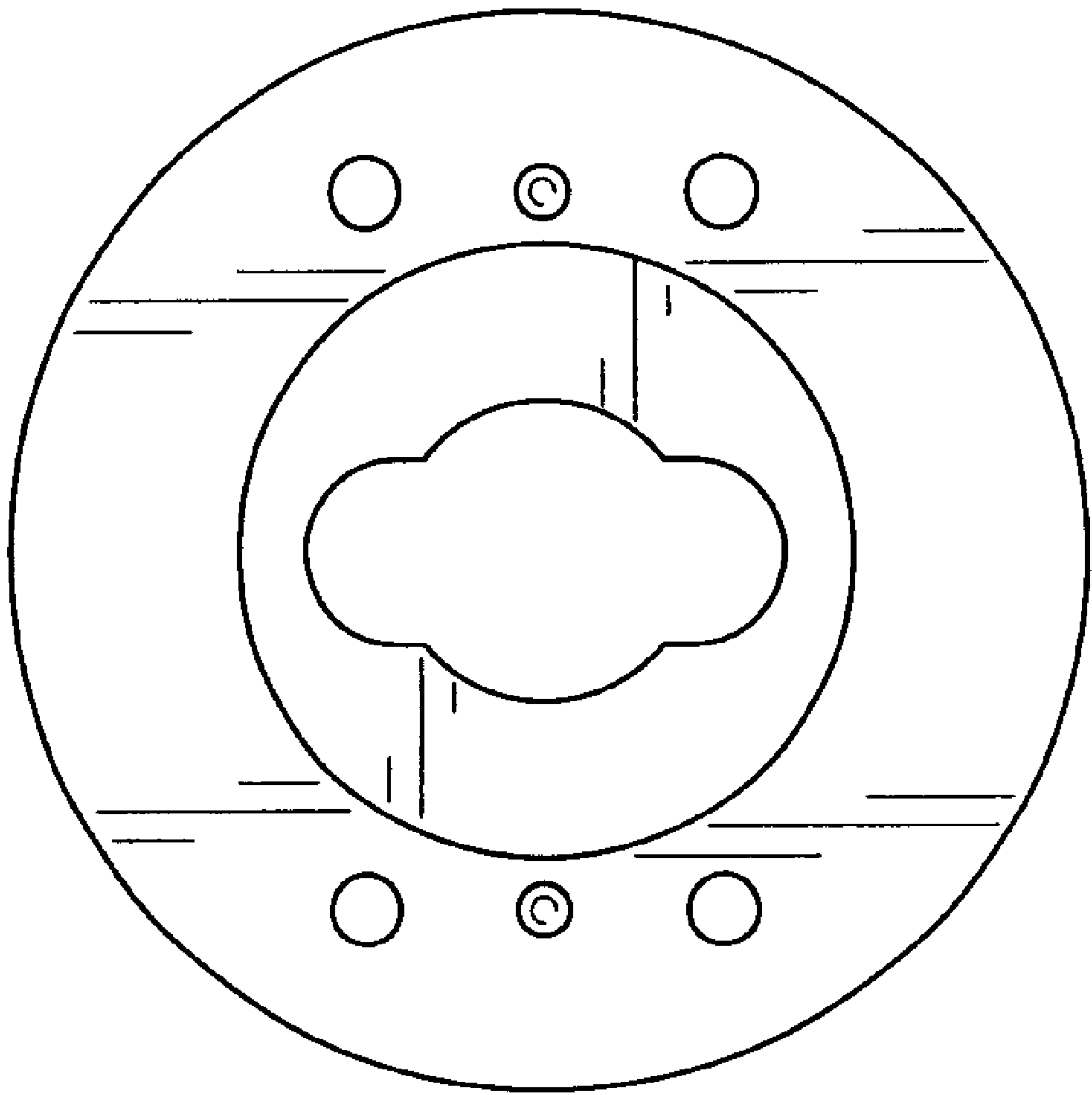

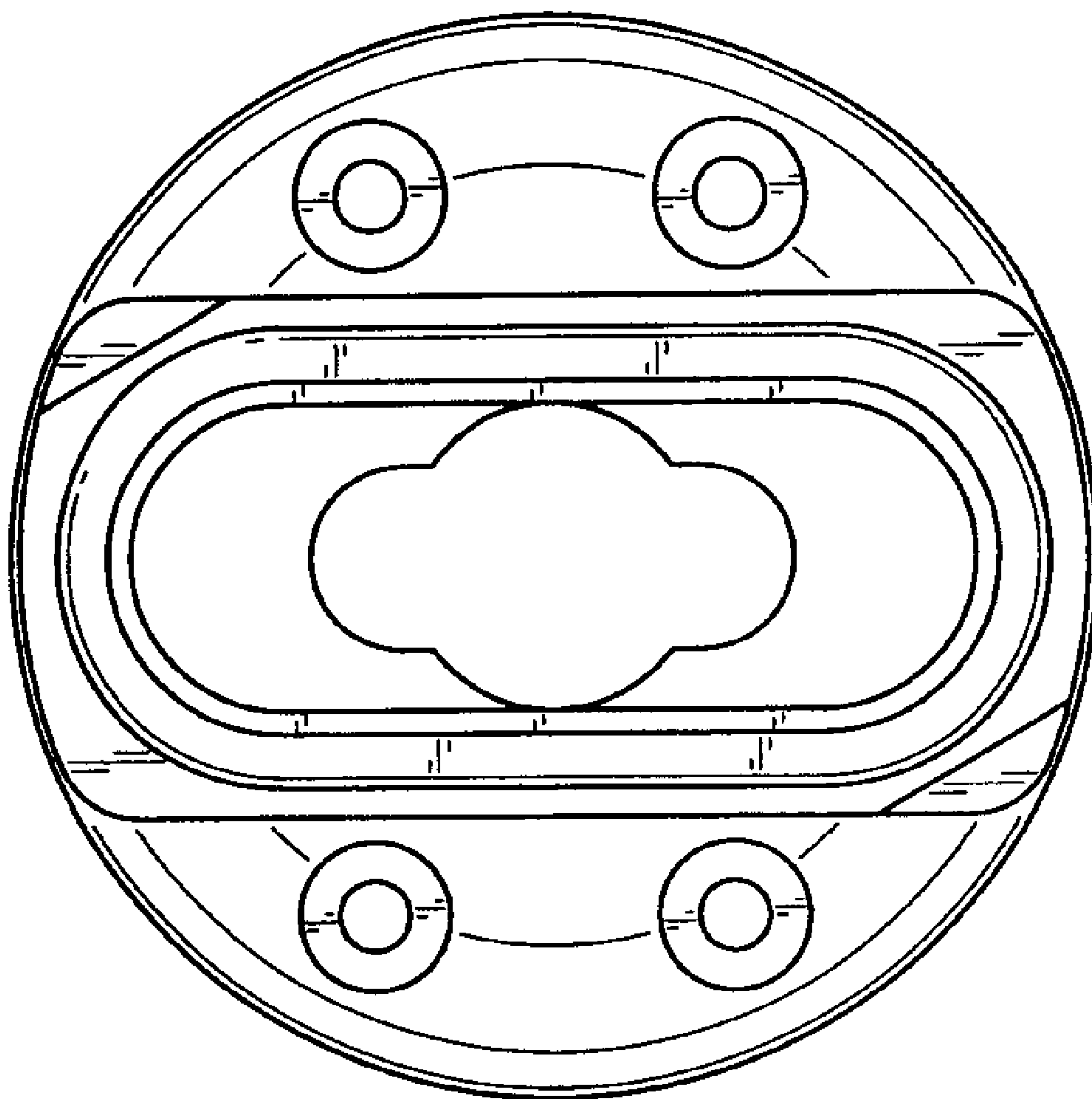
