FIG. 2 is a photograph of the rear elevational view of the light fixture.

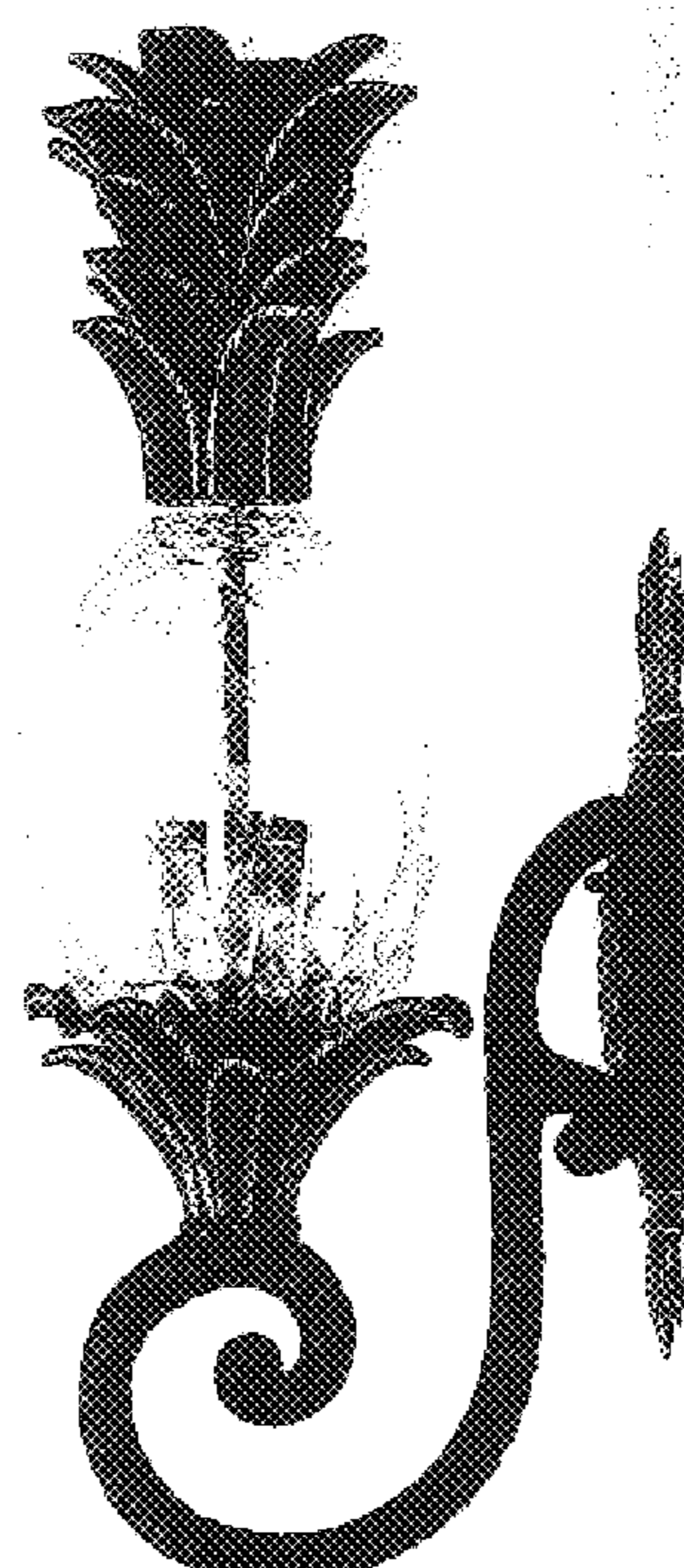
FIG. 3 is a photograph of the left side view of the light fixture.

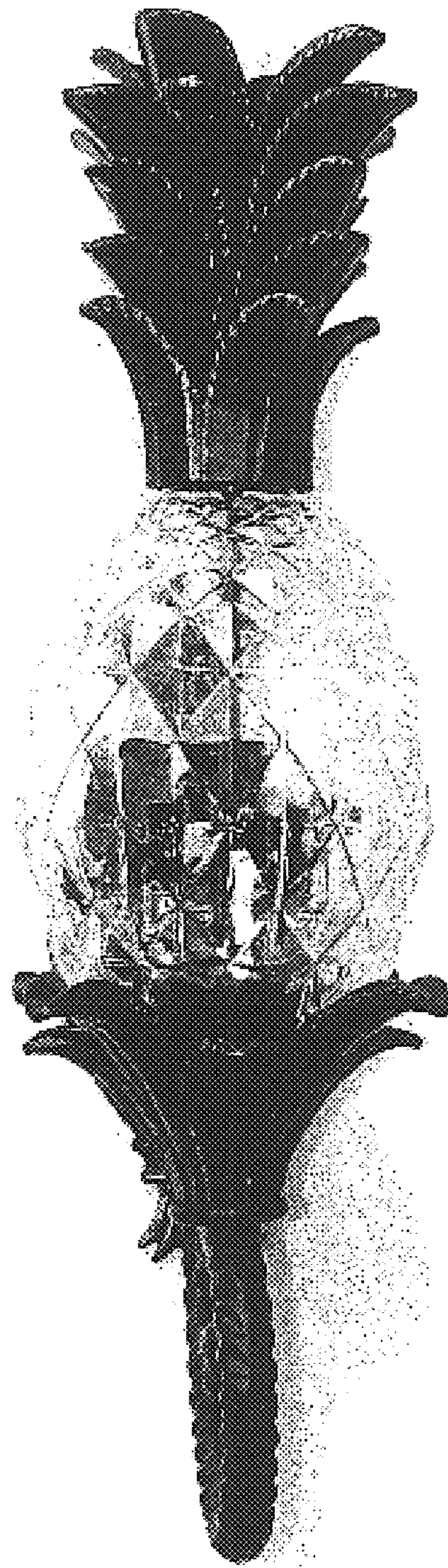

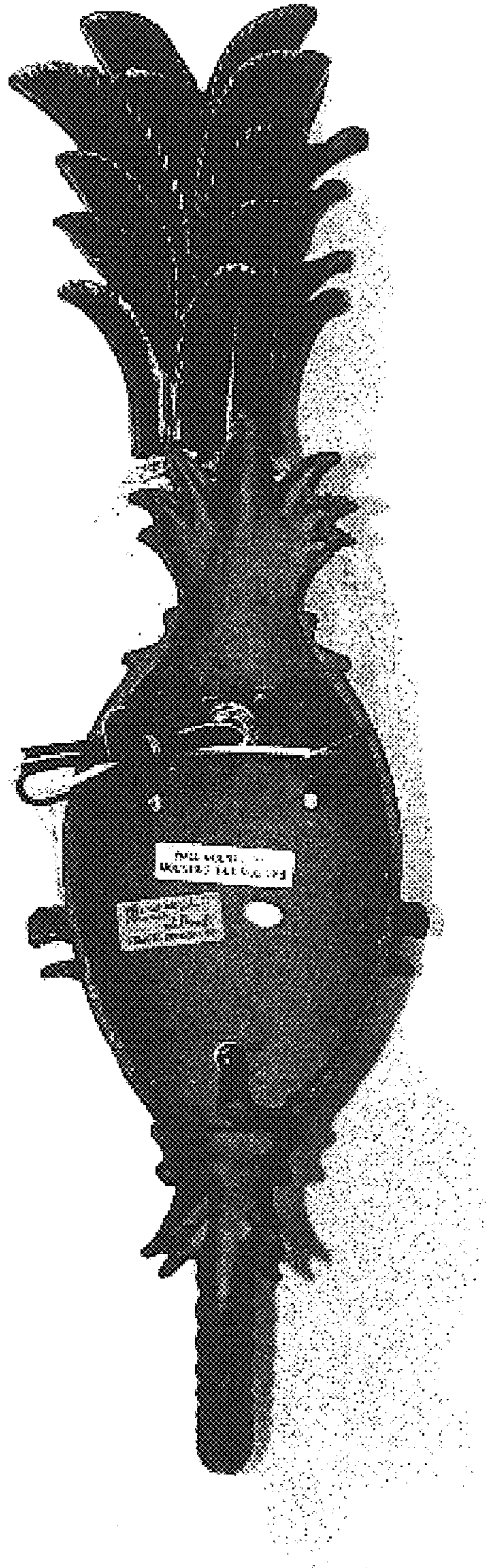

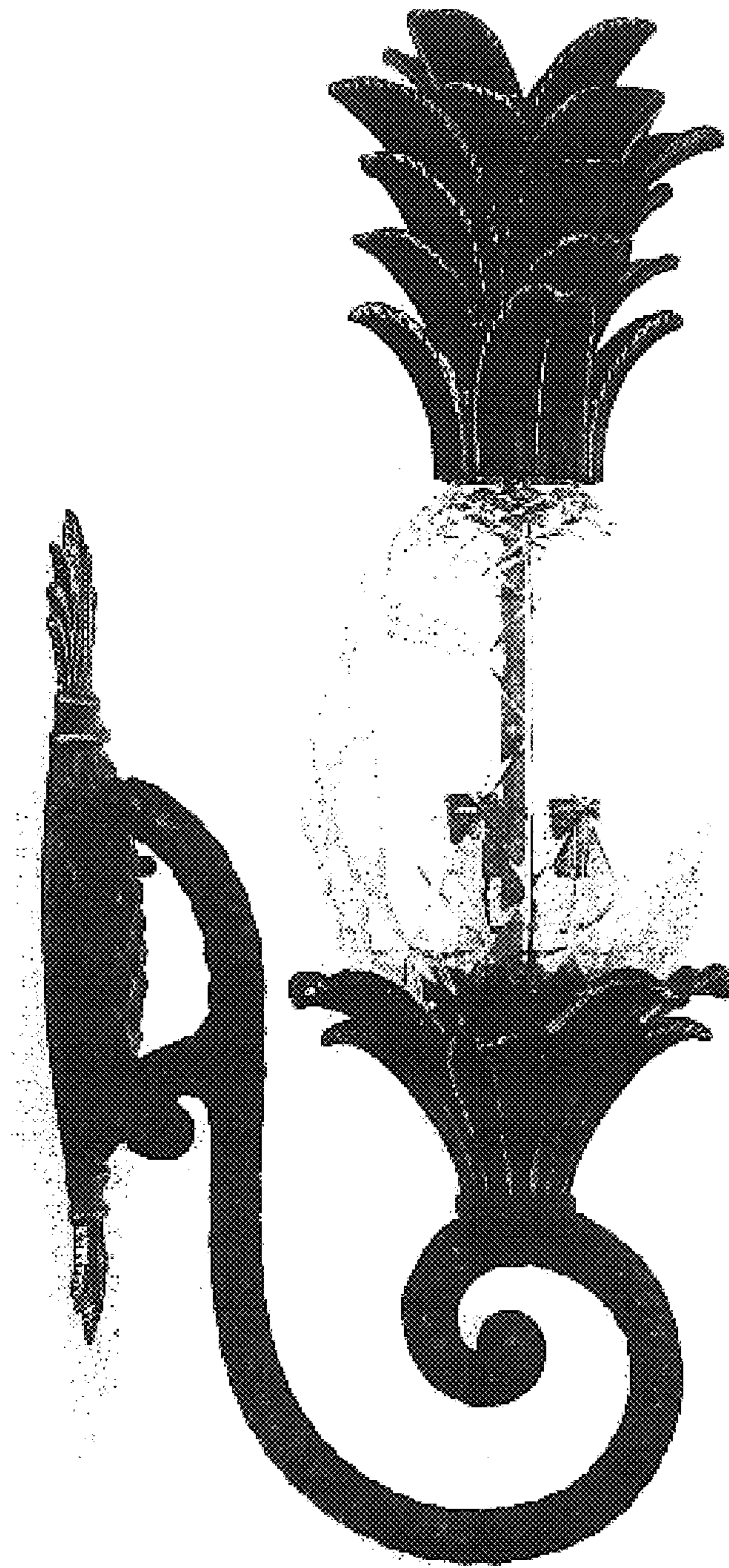

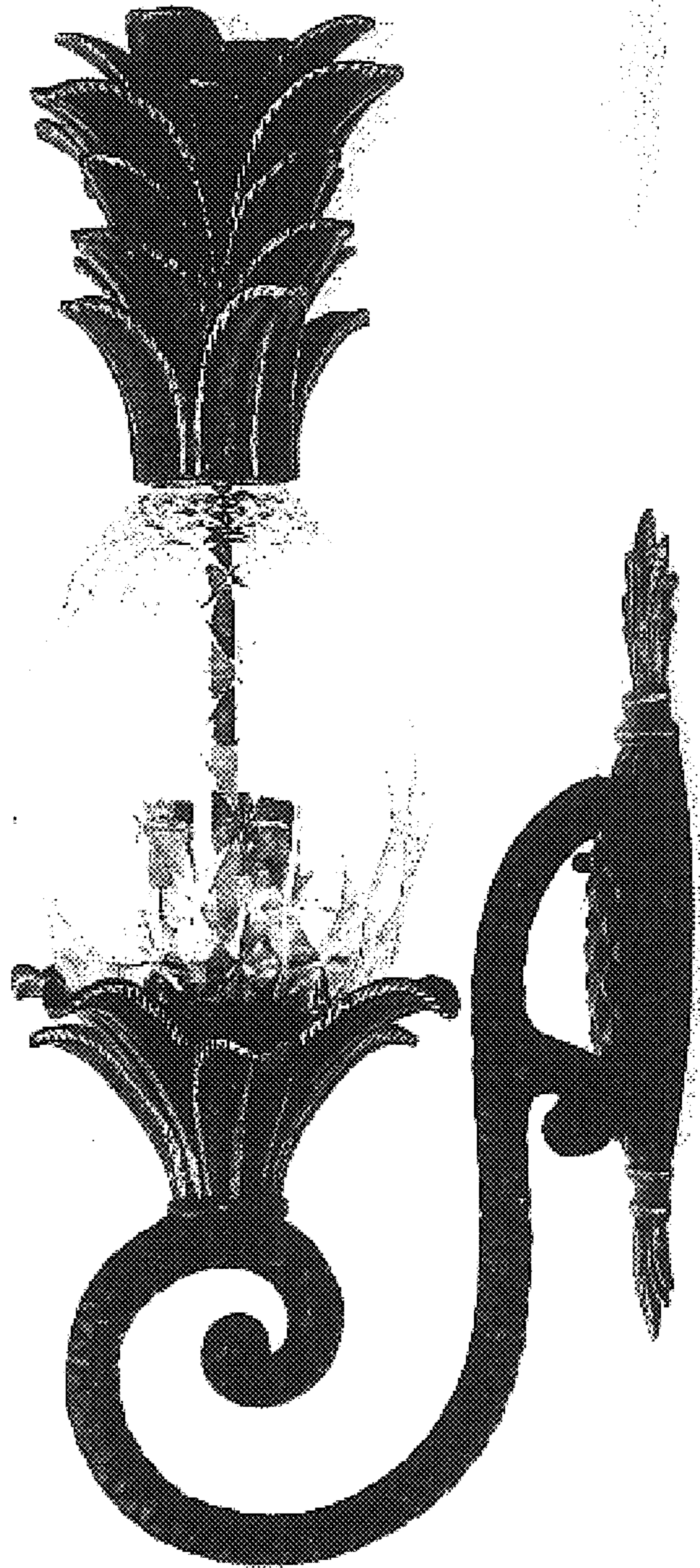

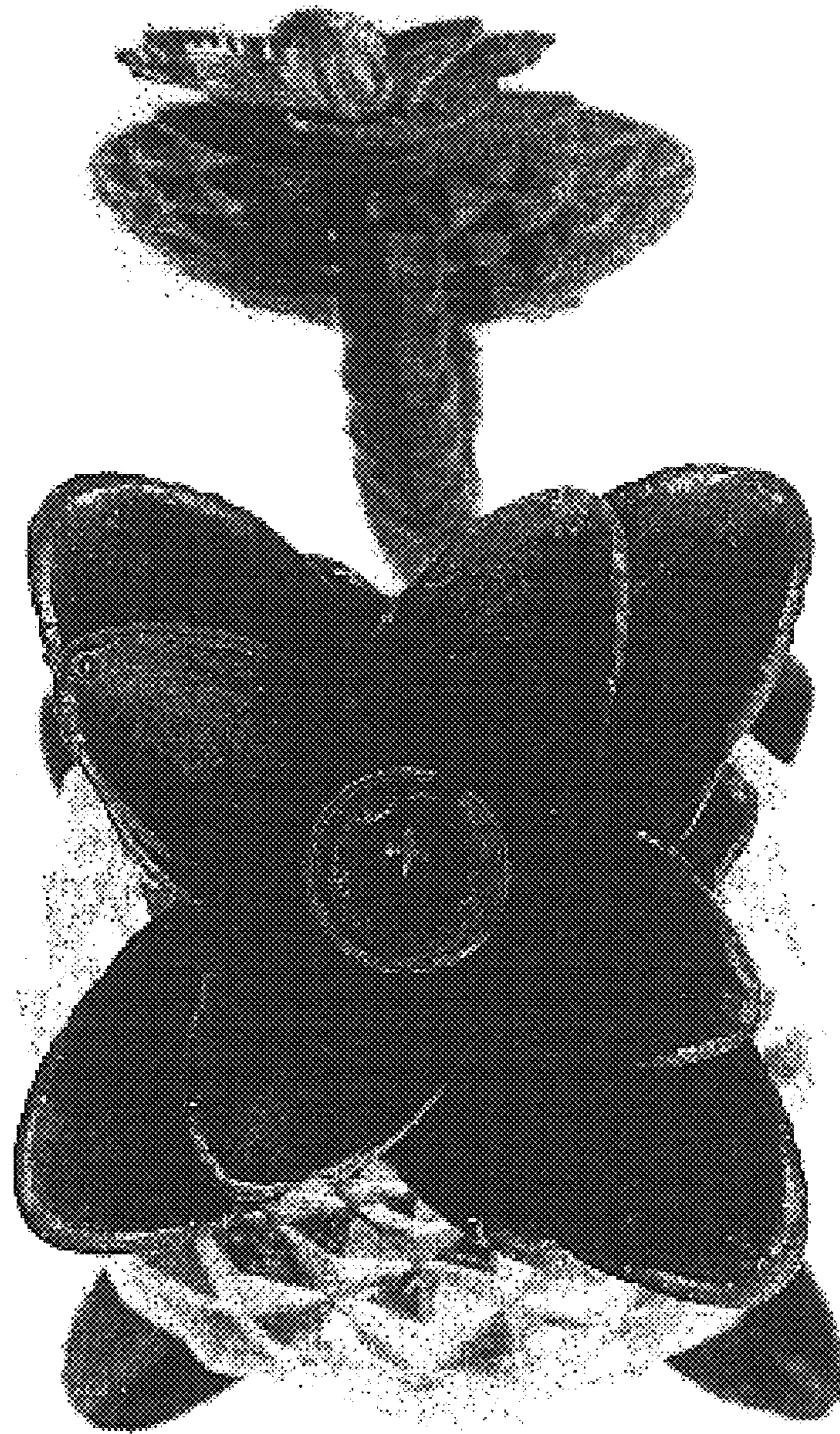

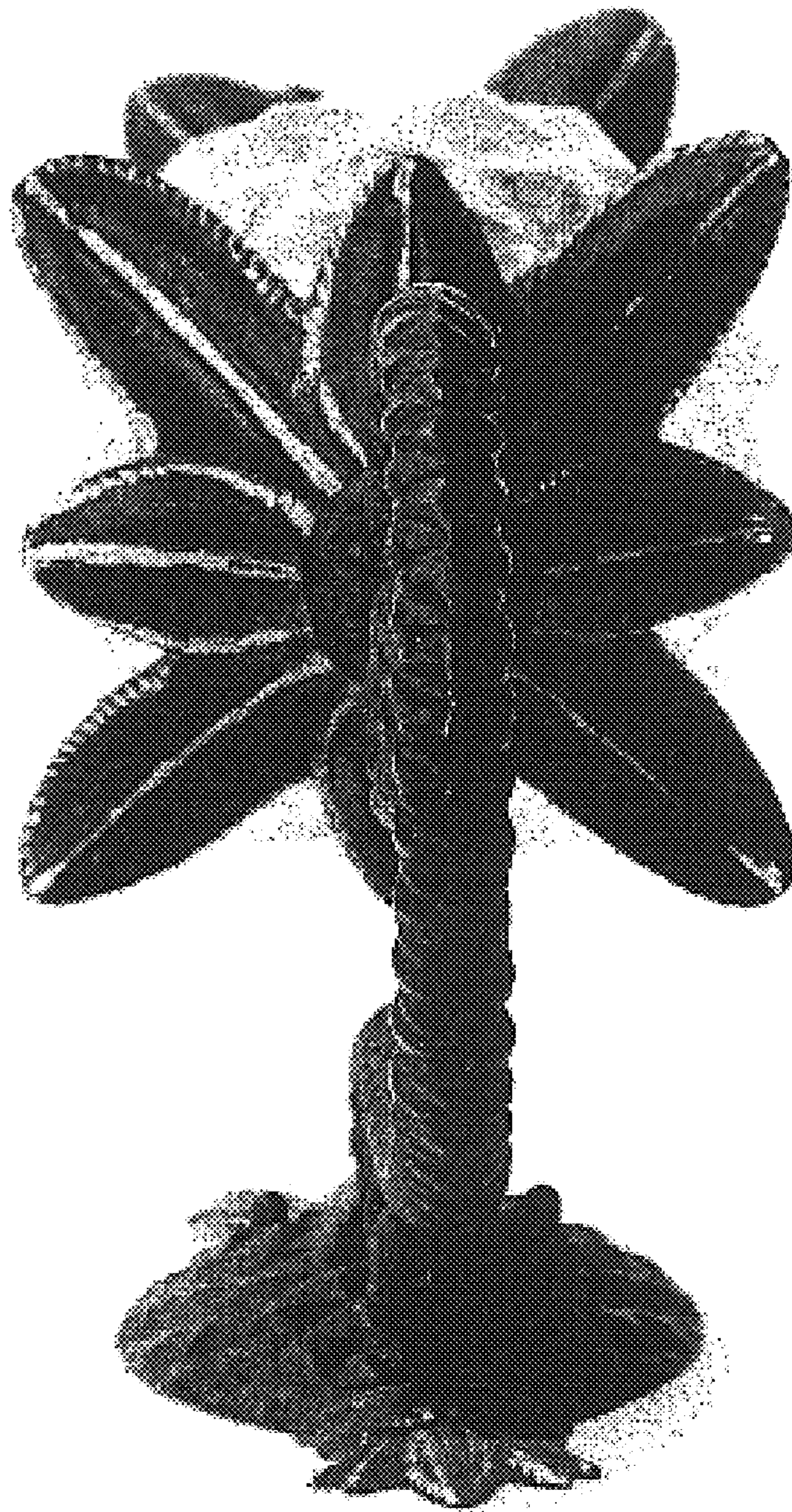
