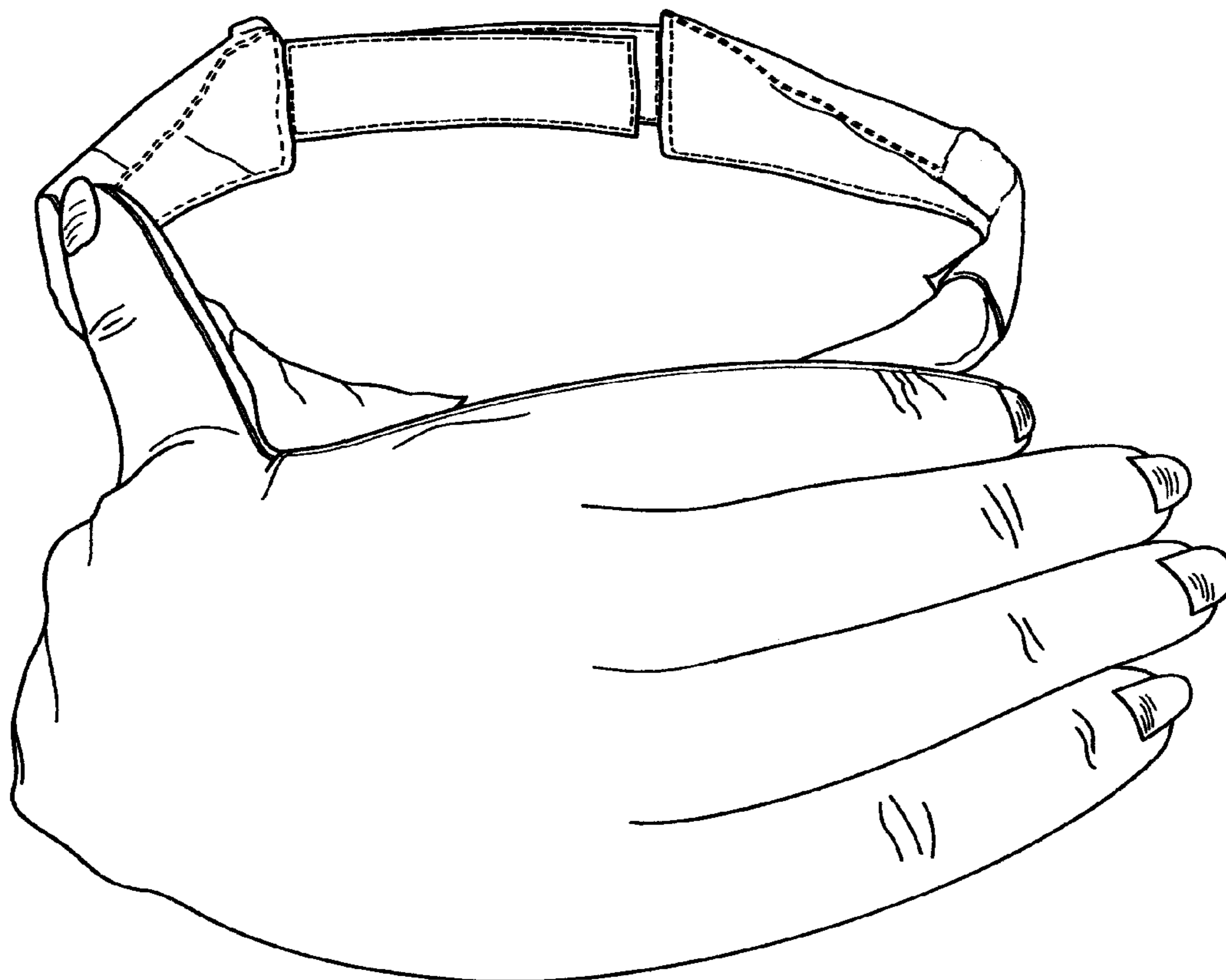
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a visor showing our new design;  
FIG. 2 is a front view of the visor;  
FIG. 3 is a rear view of the visor;  
FIG. 4 is a right side view of the visor;  
FIG. 5 is a left side view of the visor;  
FIG. 6 is a top view of the visor; and,  
FIG. 7 is a bottom view of the visor.

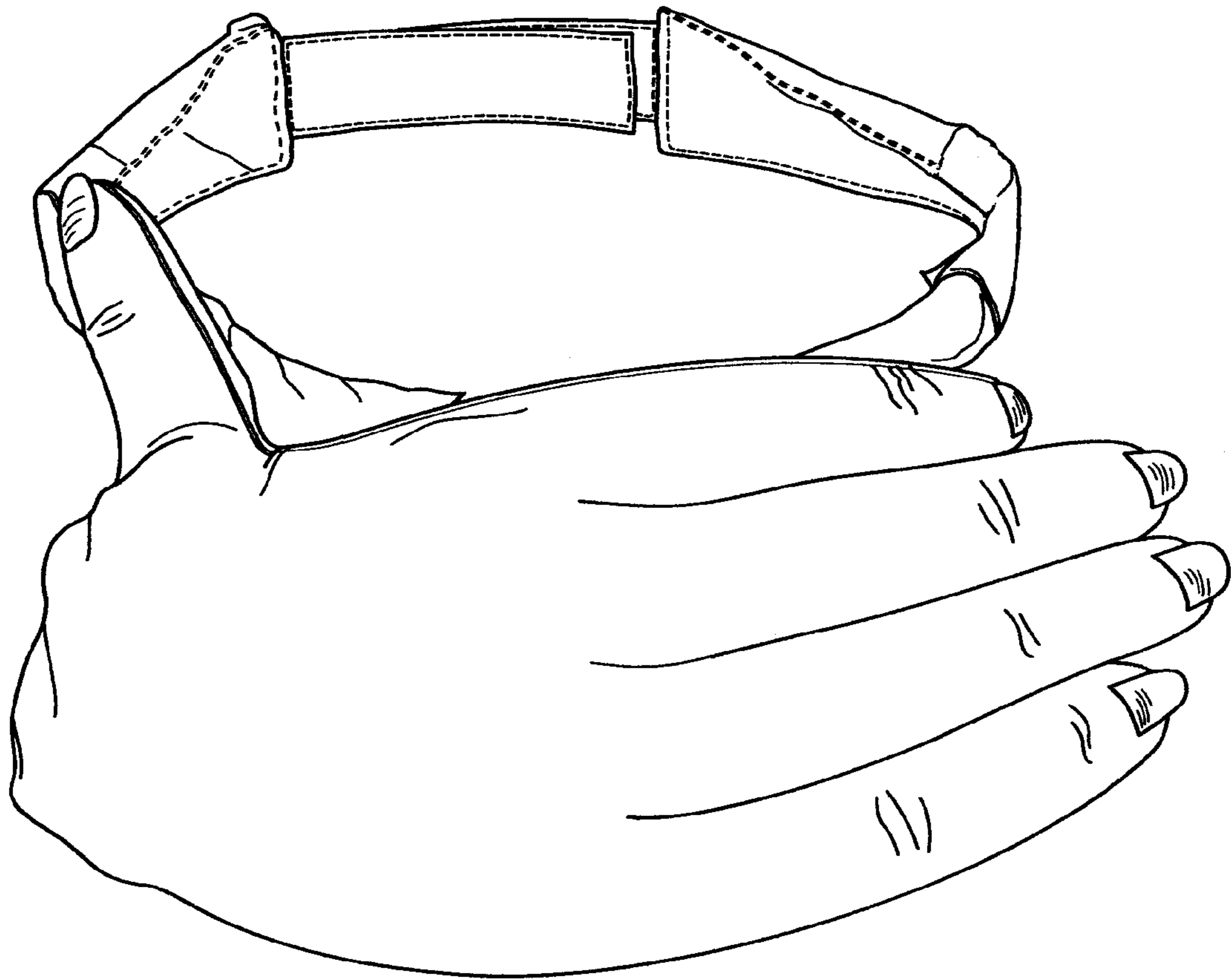

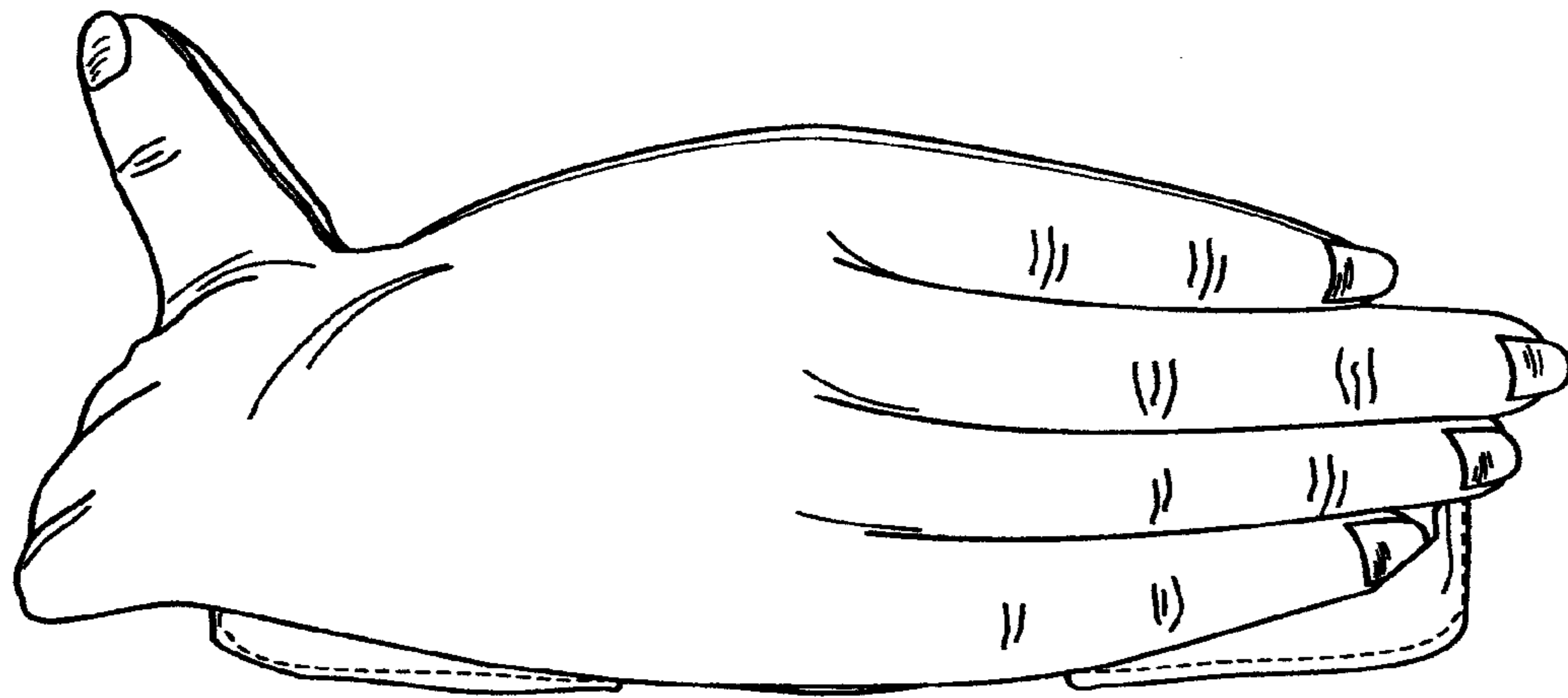

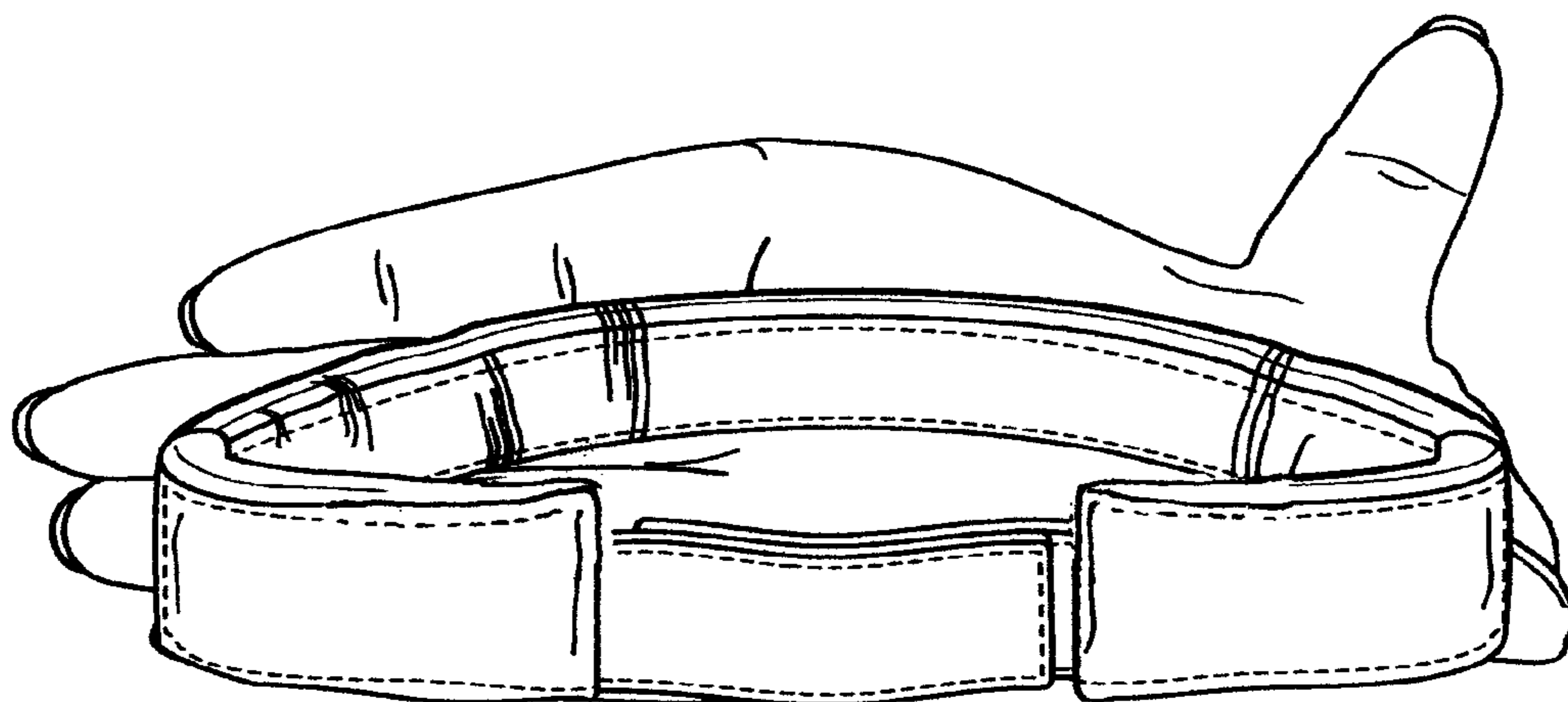

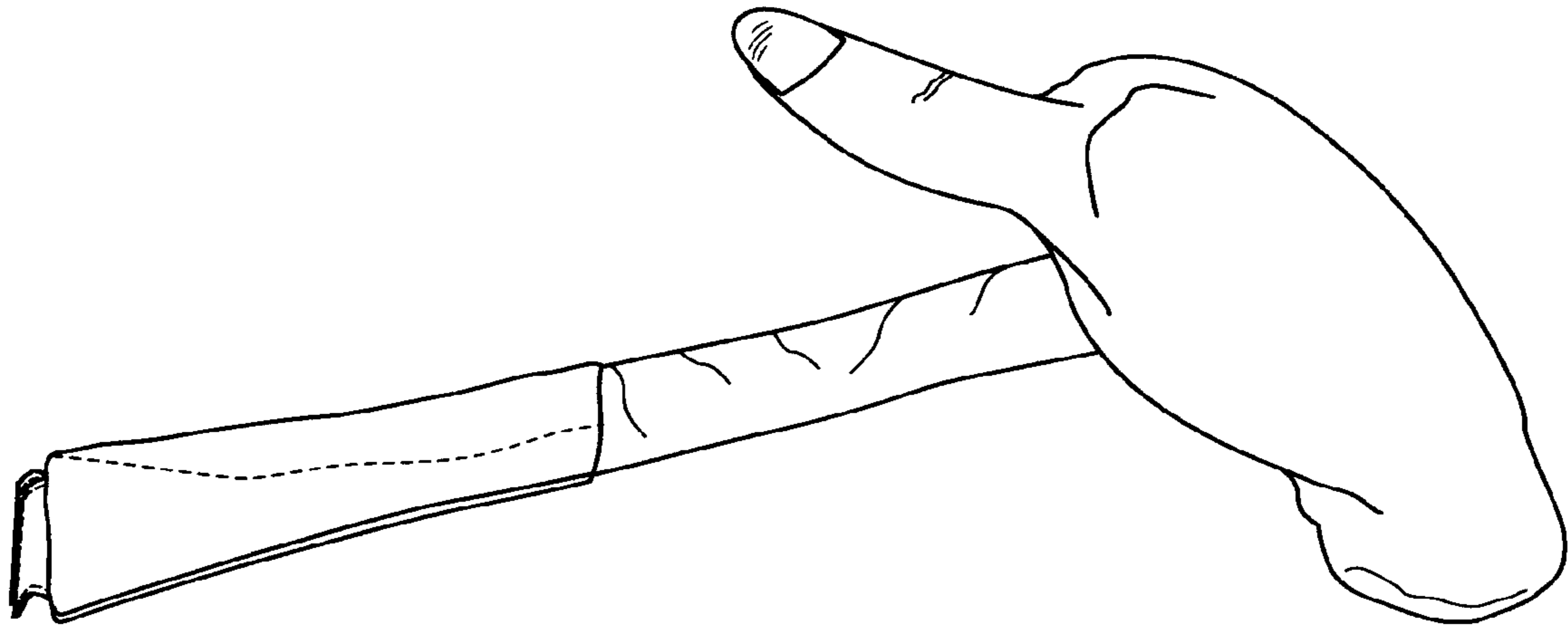

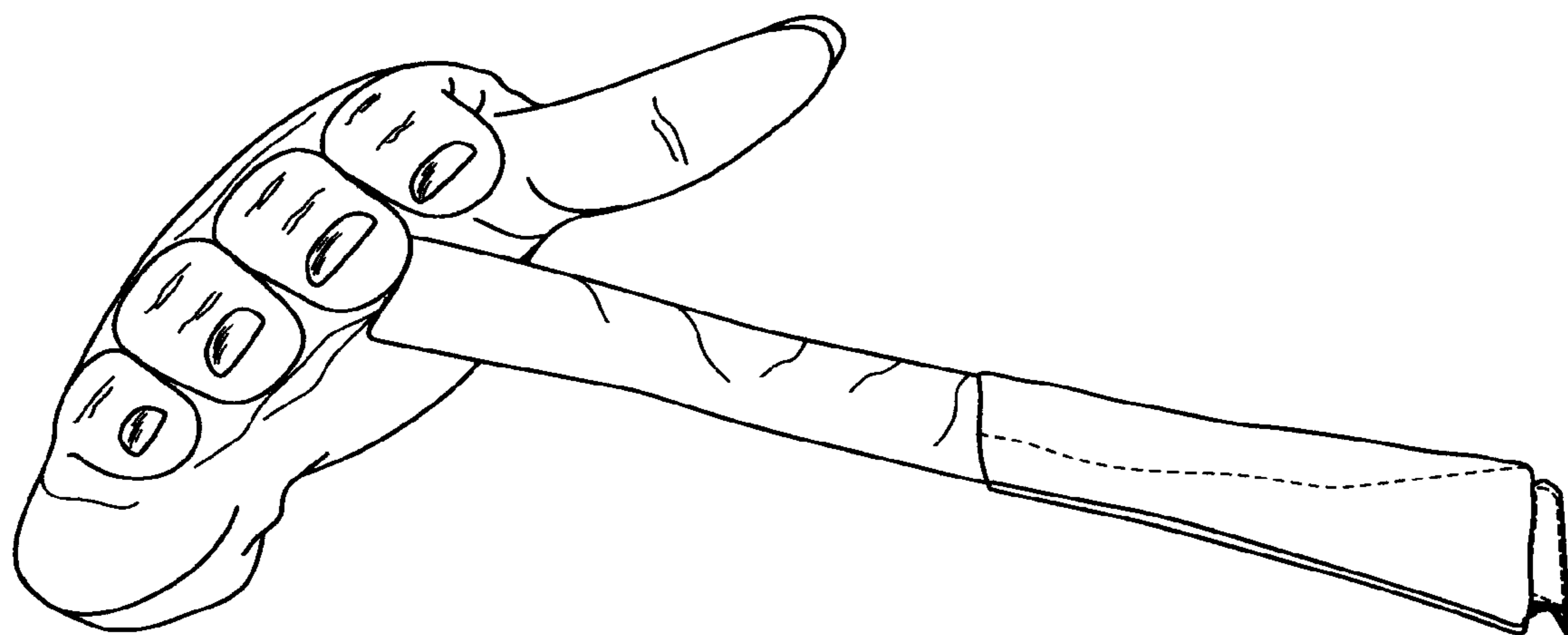

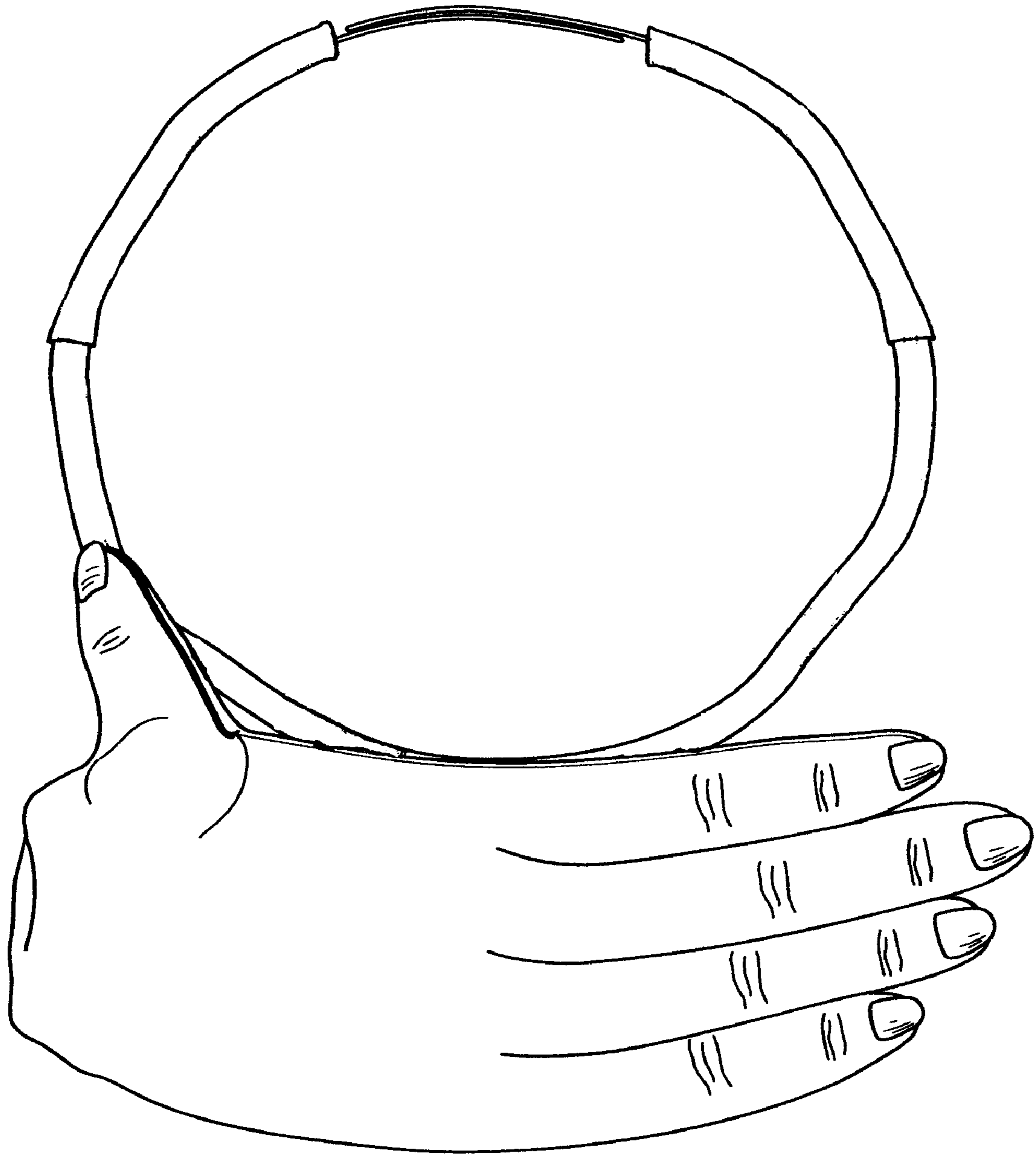

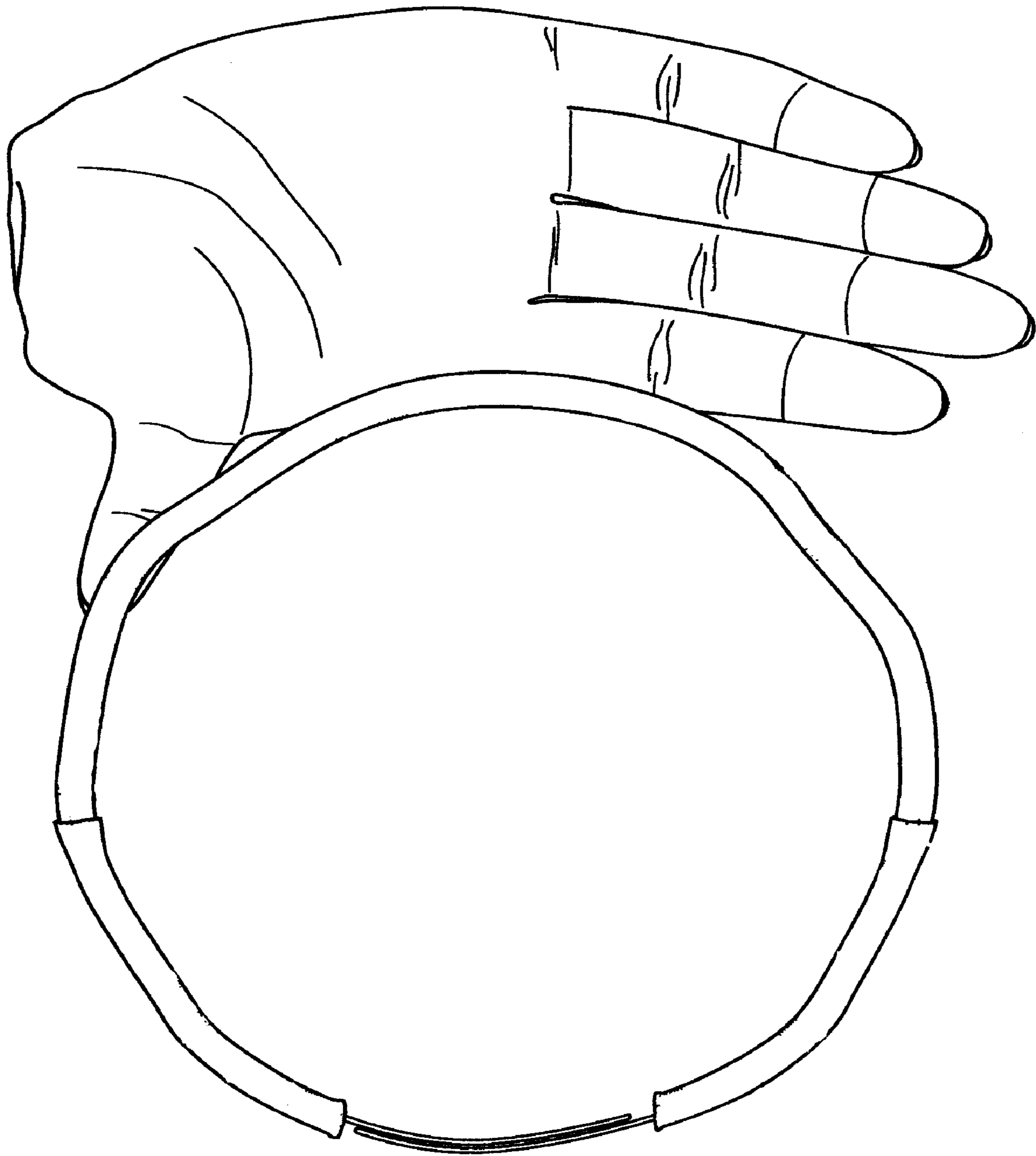
