DESCRIPTION

FIG. 1 is a perspective view of a purse showing my new design;

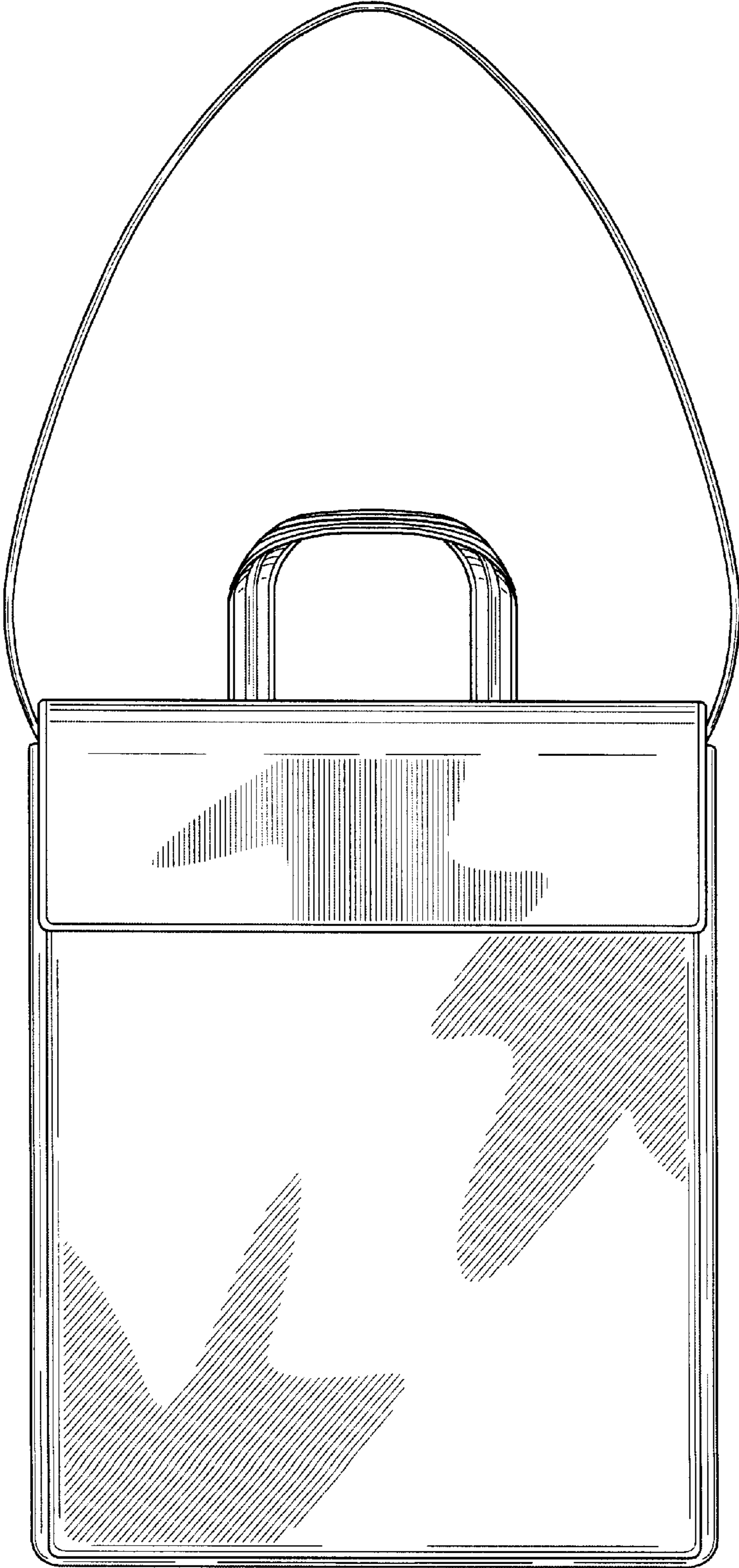

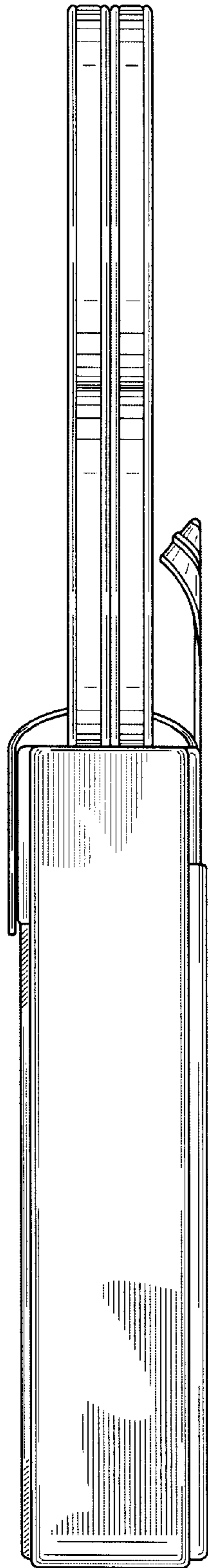

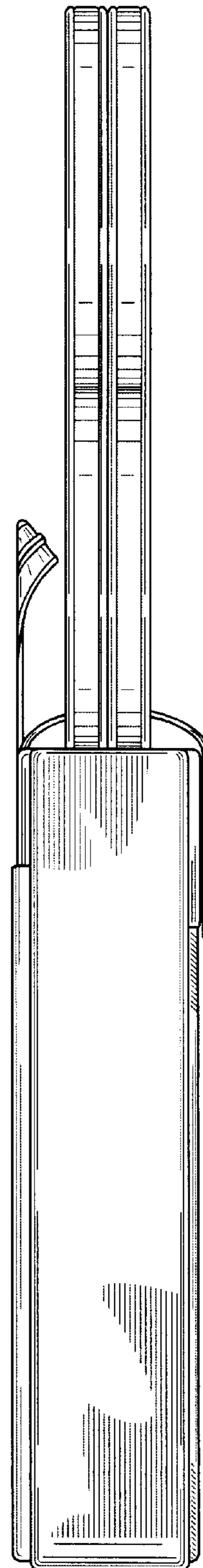

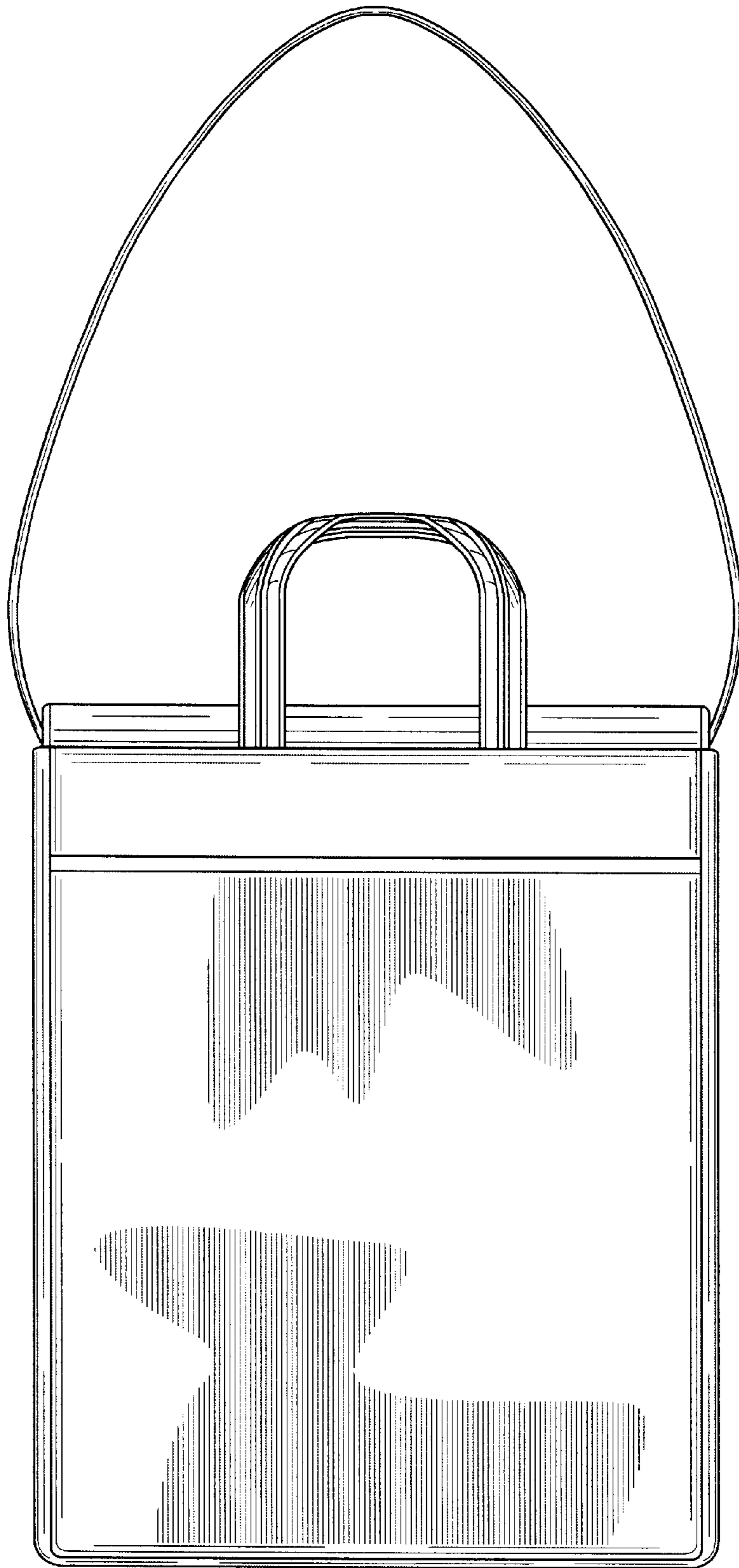

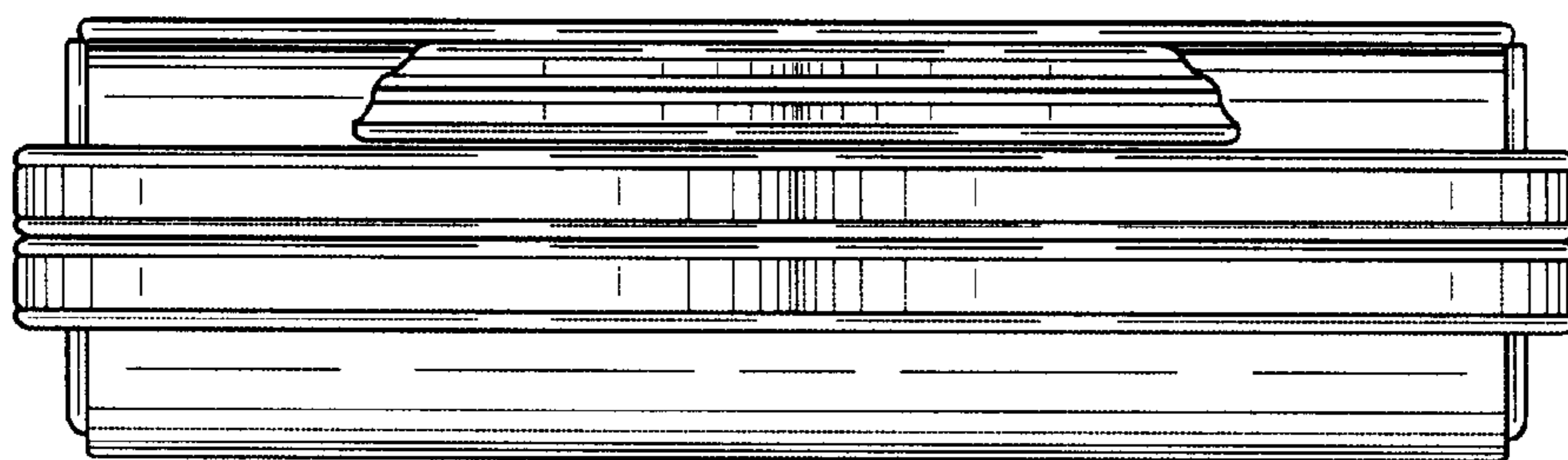

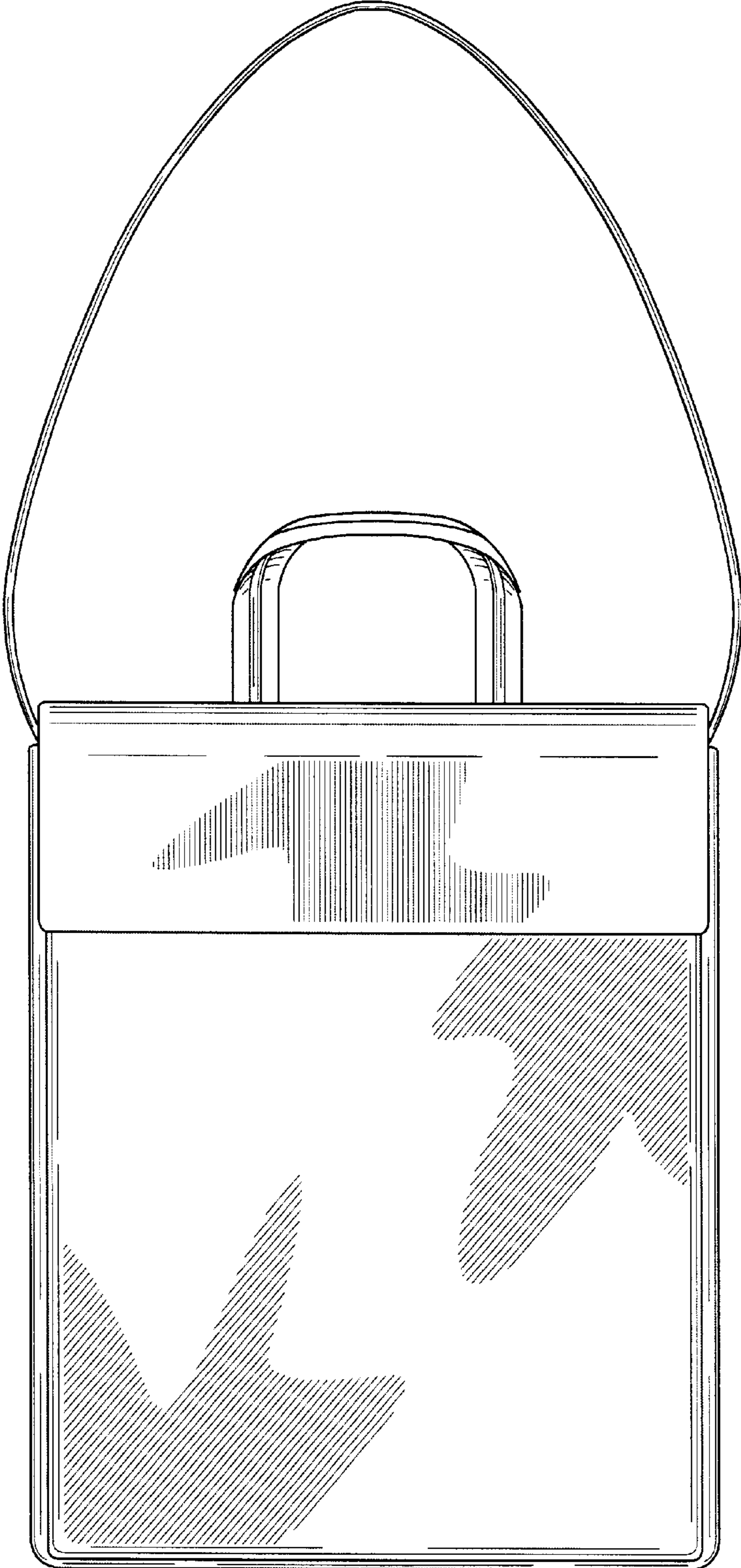

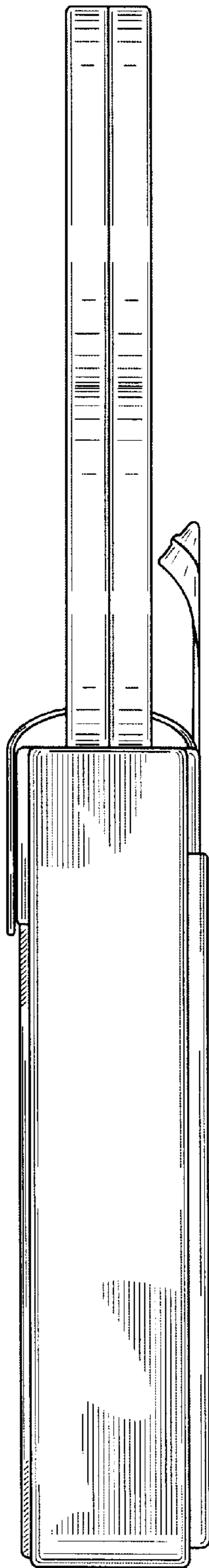

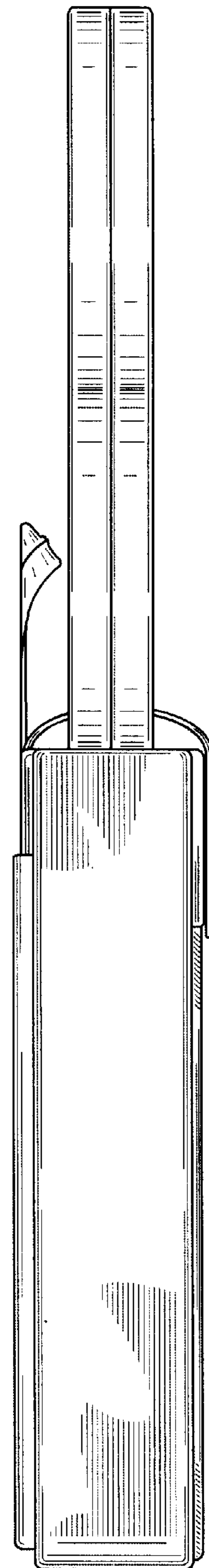

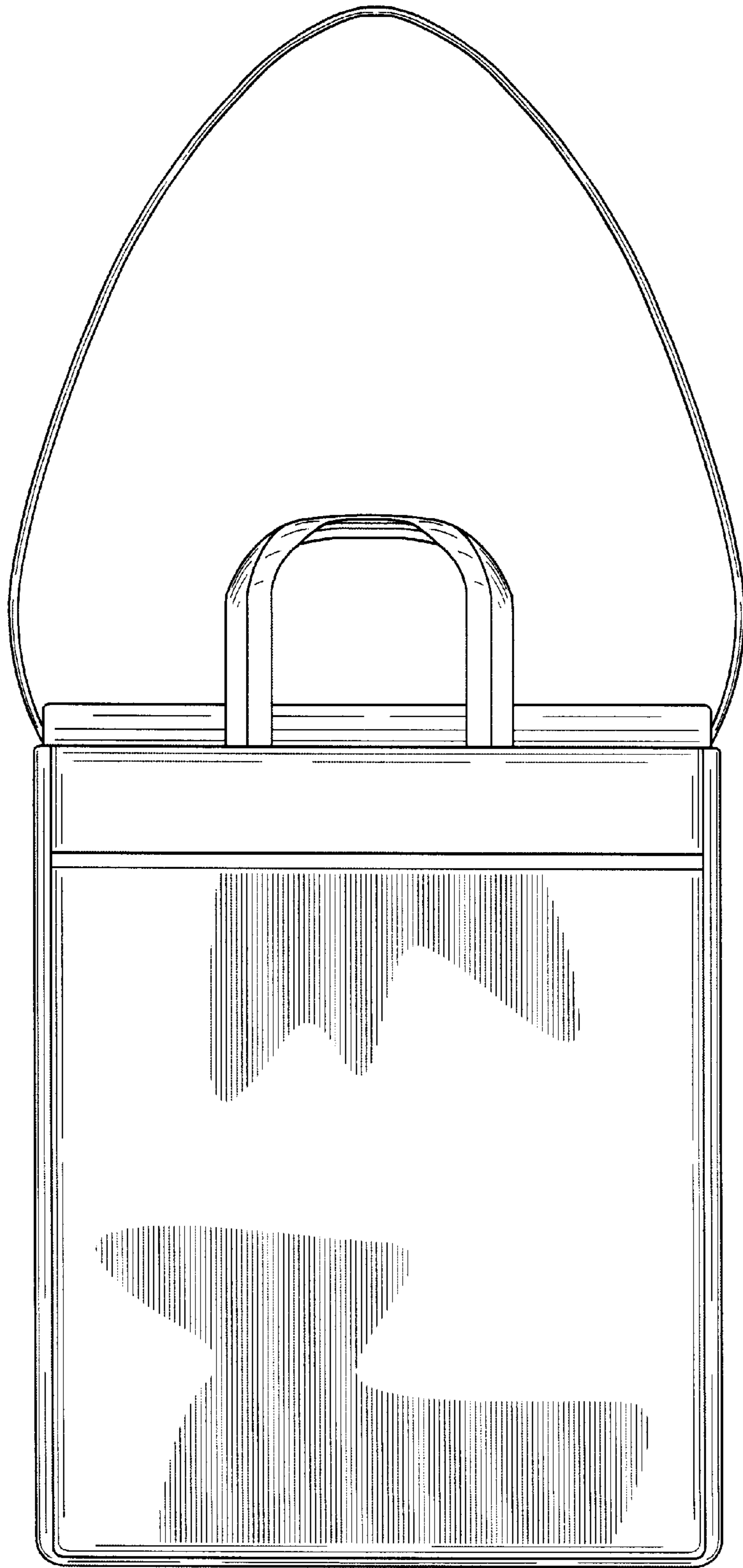

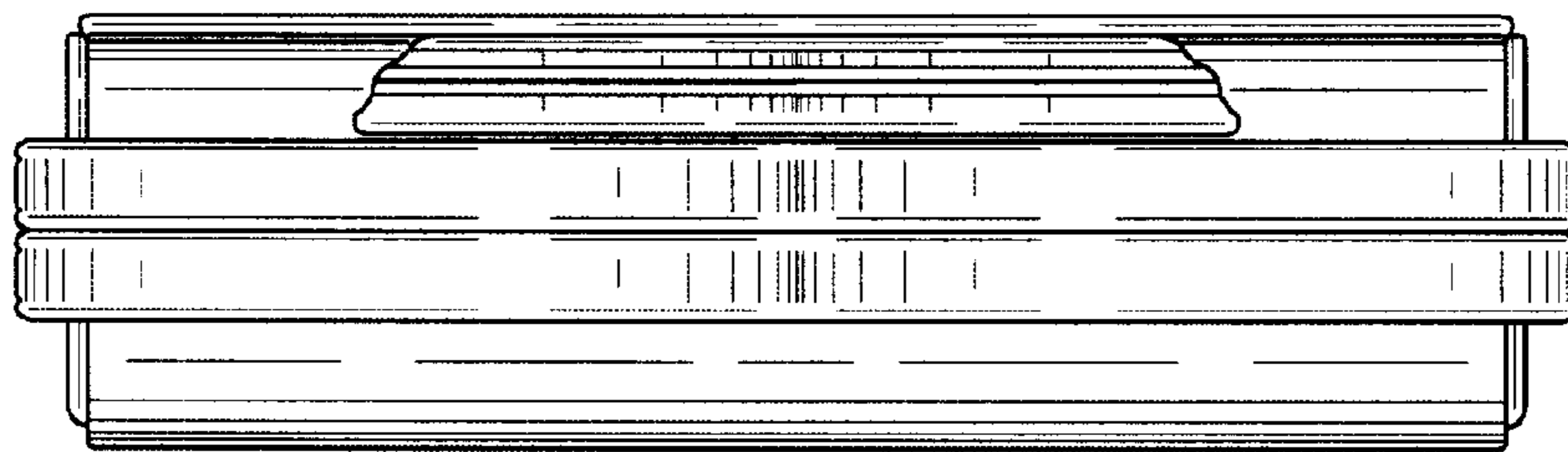

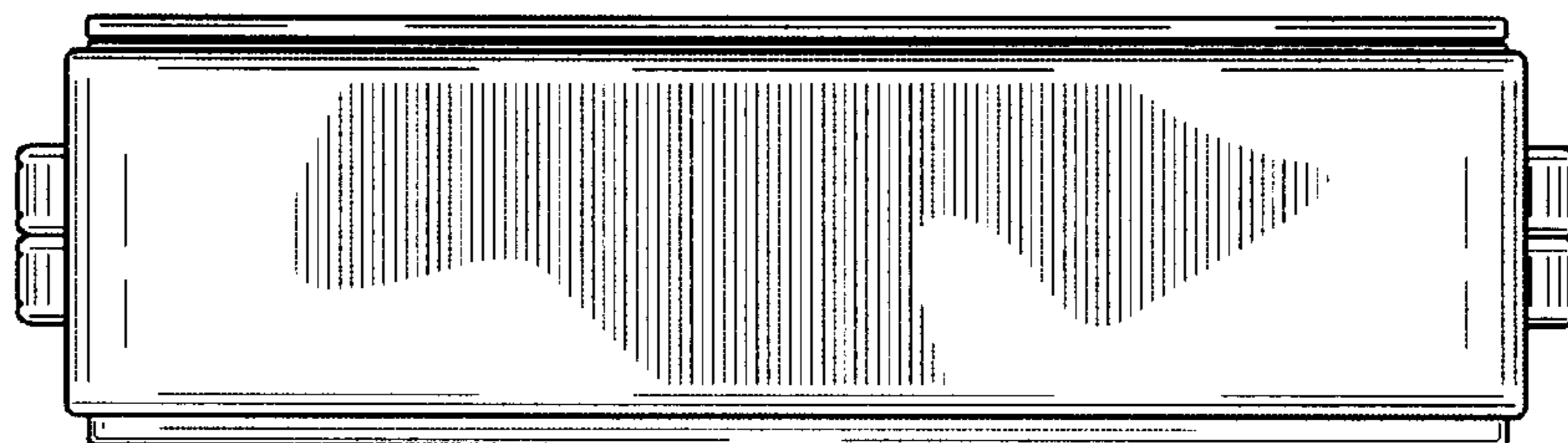
