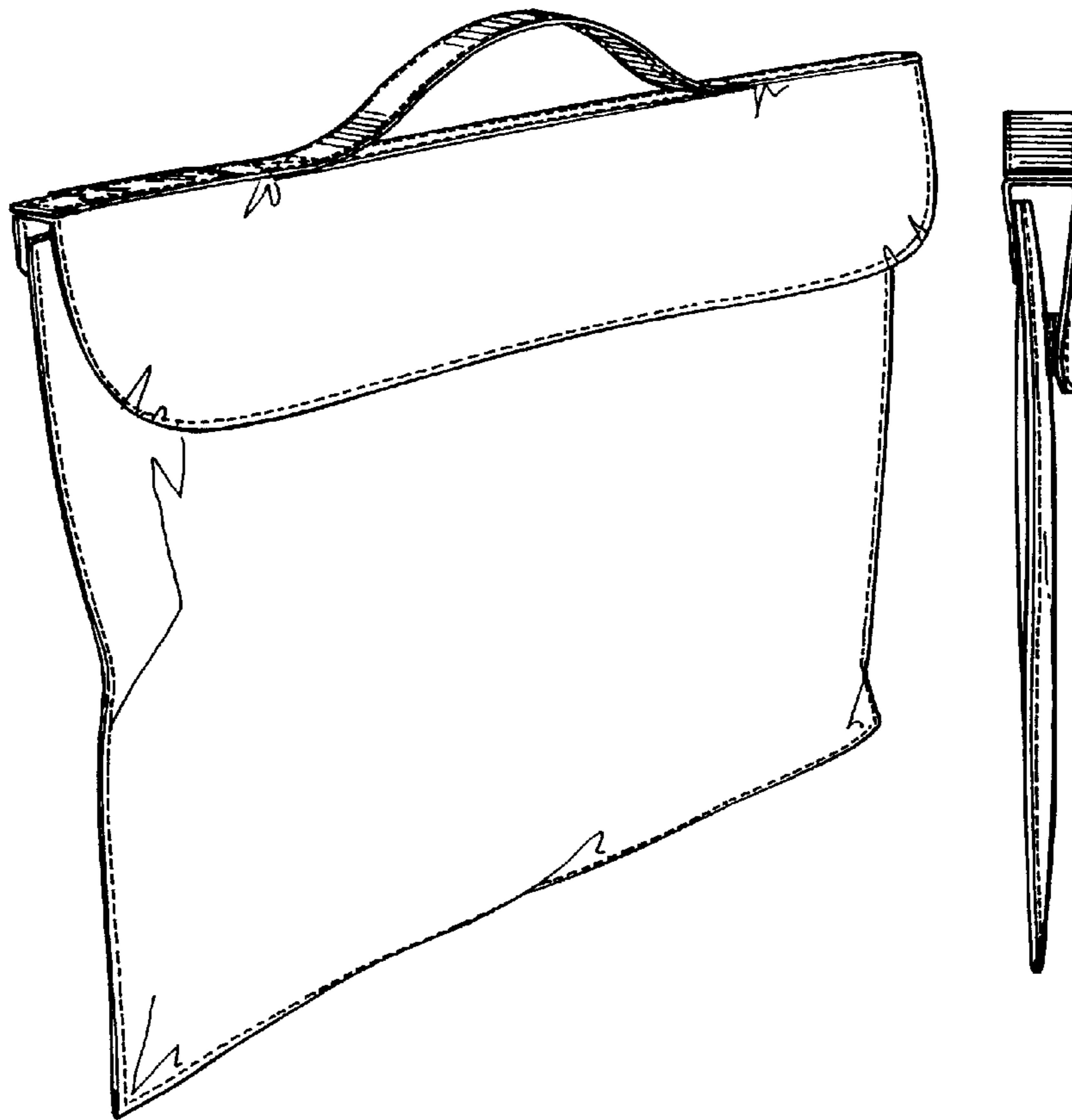
(57) **CLAIM**

The new and ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first bag showing my new design,
FIG. 2 is a front view thereof,
FIG. 3 is a rear view thereof,
FIG. 4 is a plan view thereof,
FIG. 5 is an inverted plan view thereof,
FIG. 6 is a left side view thereof, the right side being a mirror image; and,
FIG. 7 is a perspective view thereof, in a partly open position.
The dashed lines shown in all views are understood to be stitching.

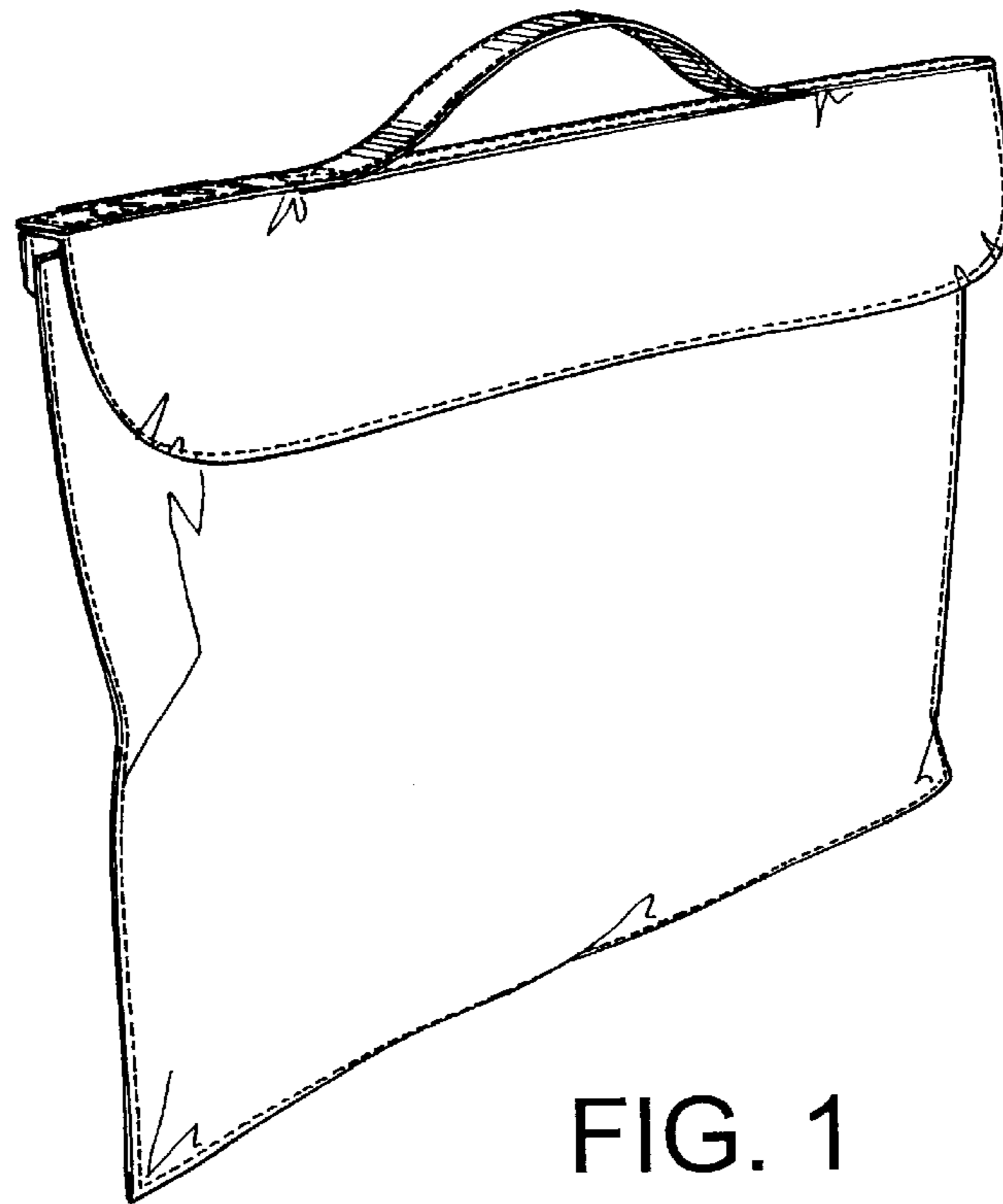

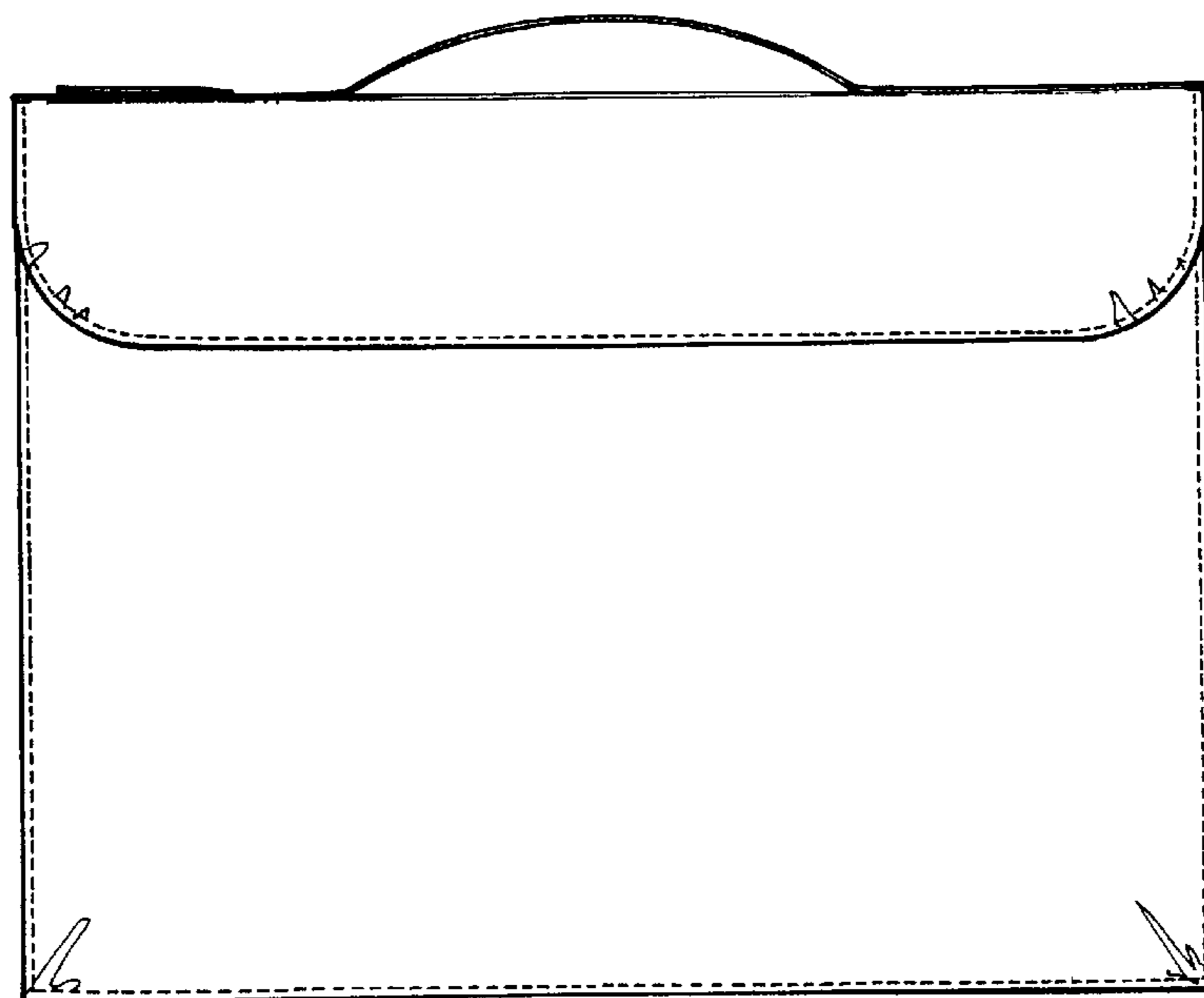

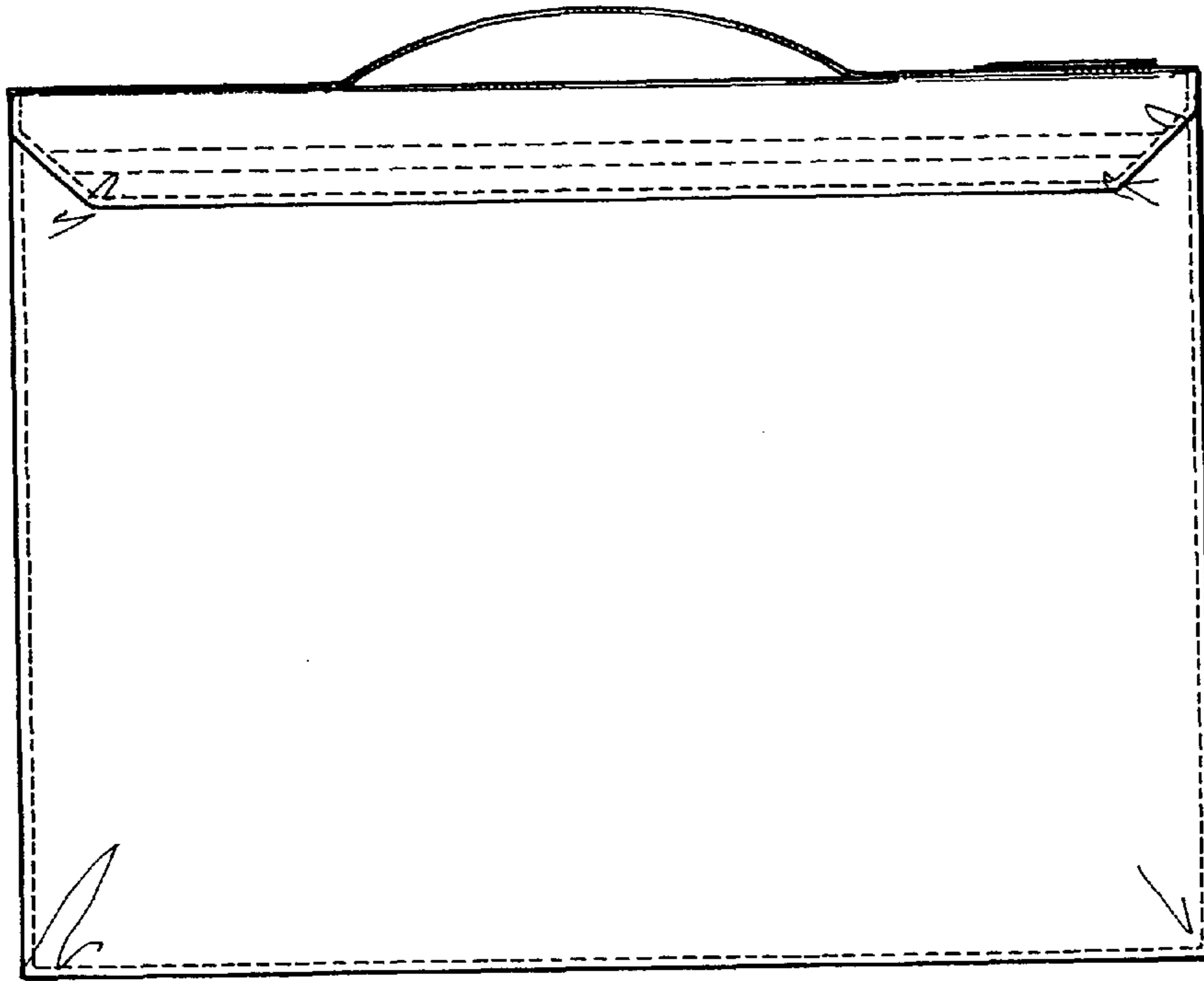

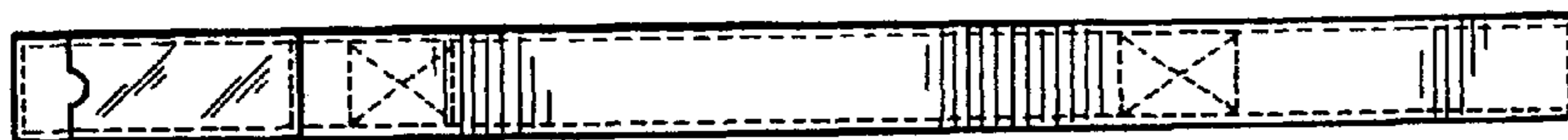

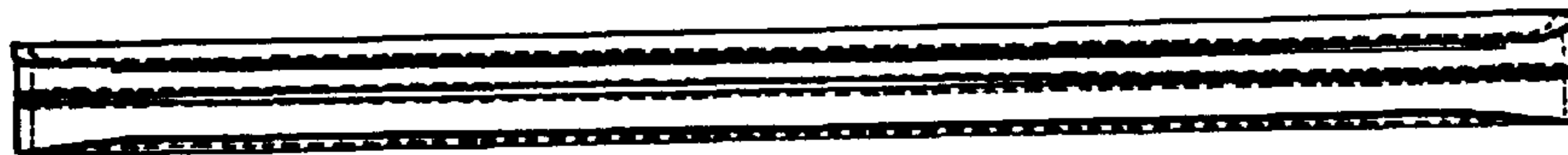

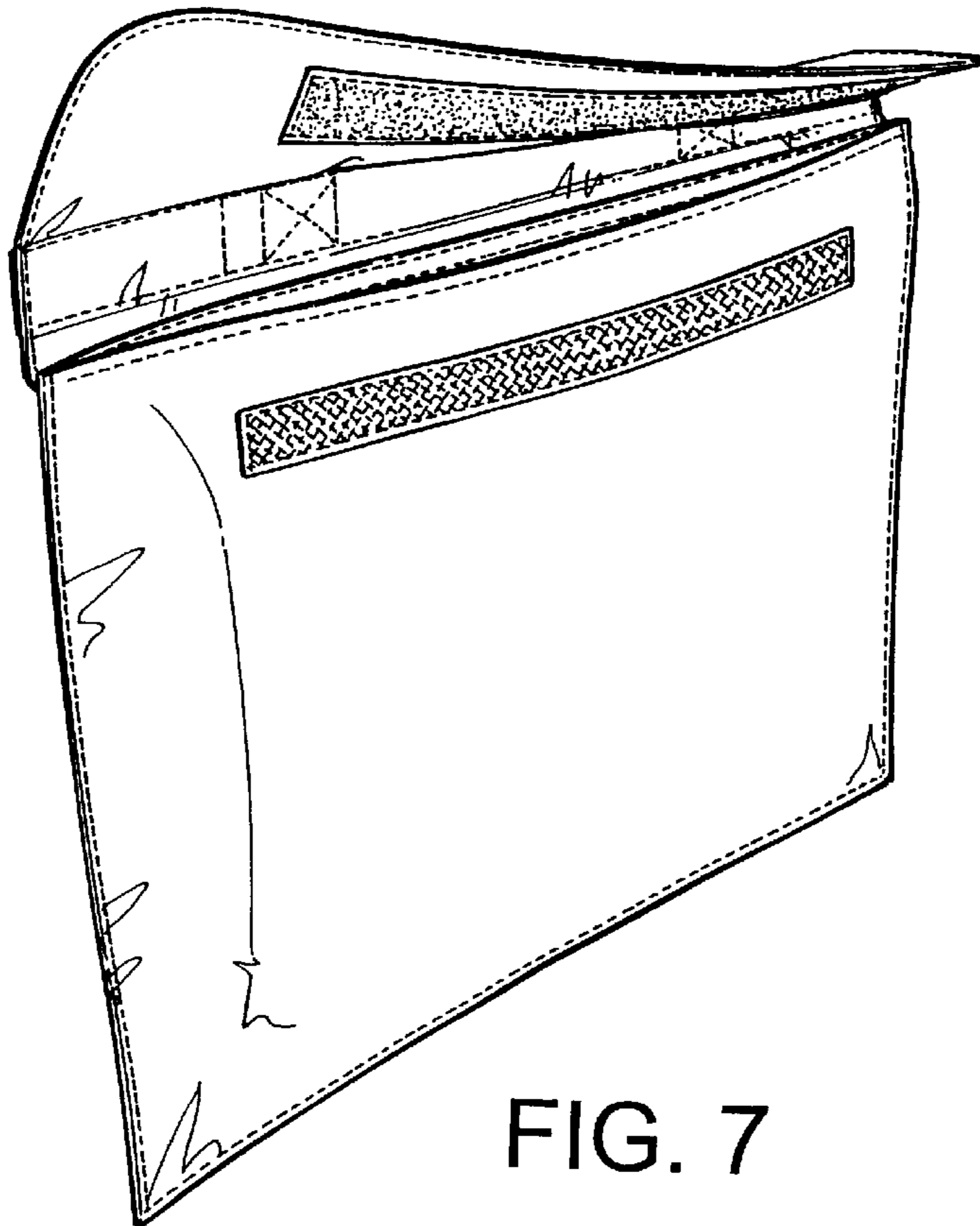
