The ornamental design for a merchandising display, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a merchandising display showing my new design;

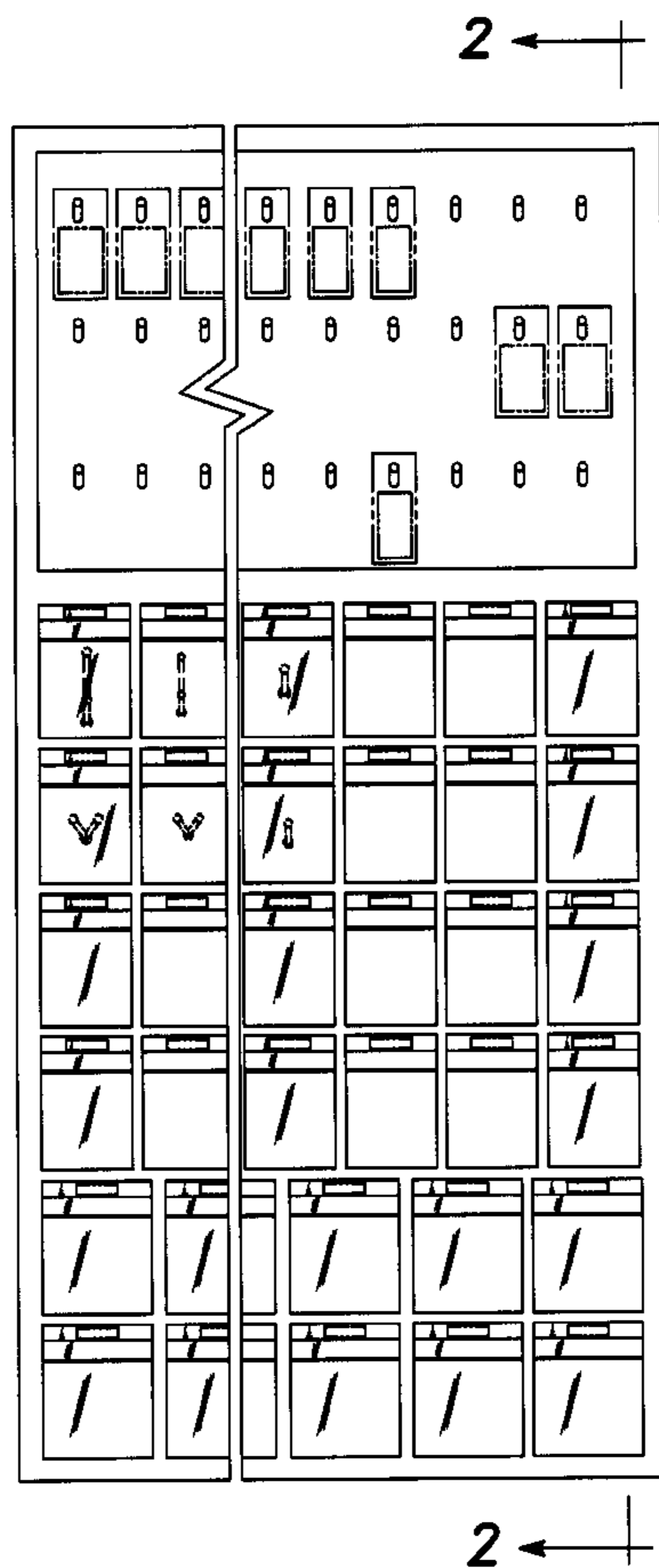
FIG. 2 is a cross-sectional view taken along line 2—2 of FIG. 1; and,

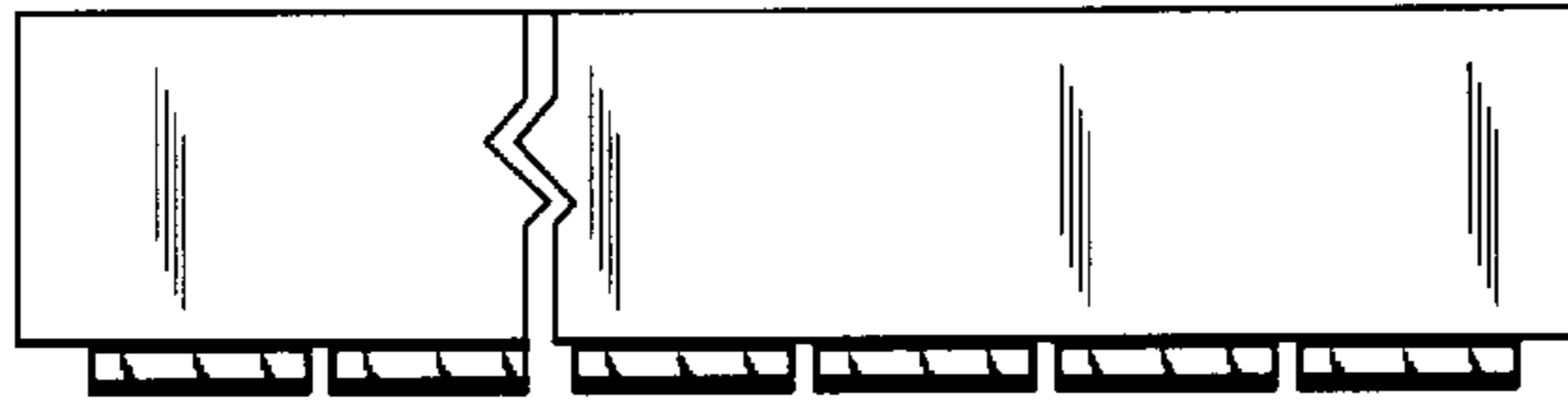

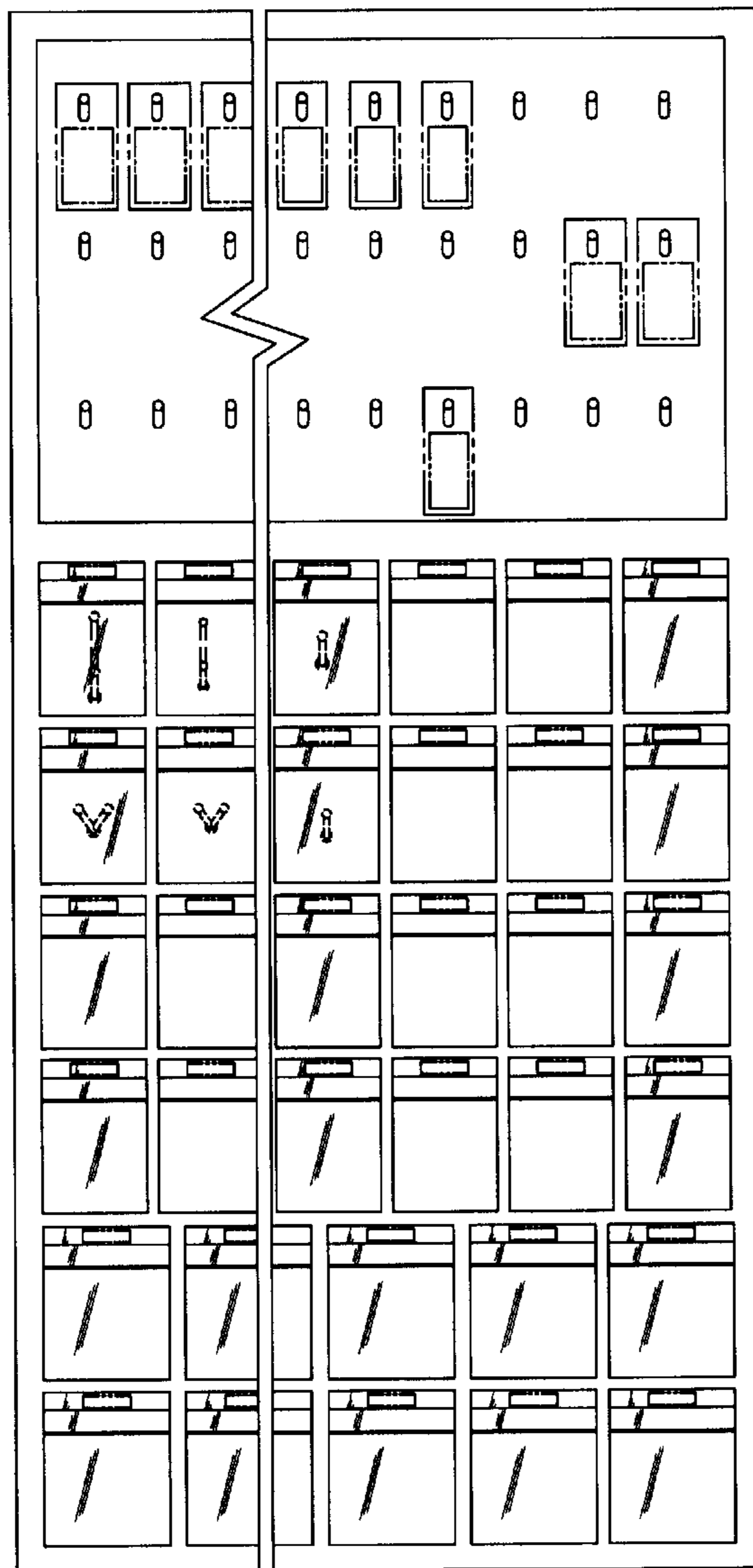

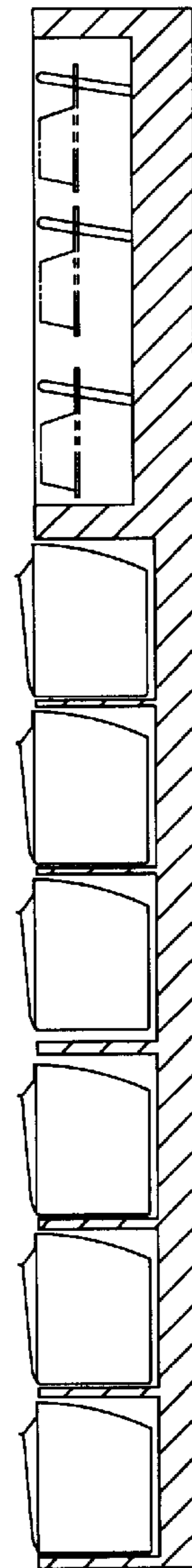
