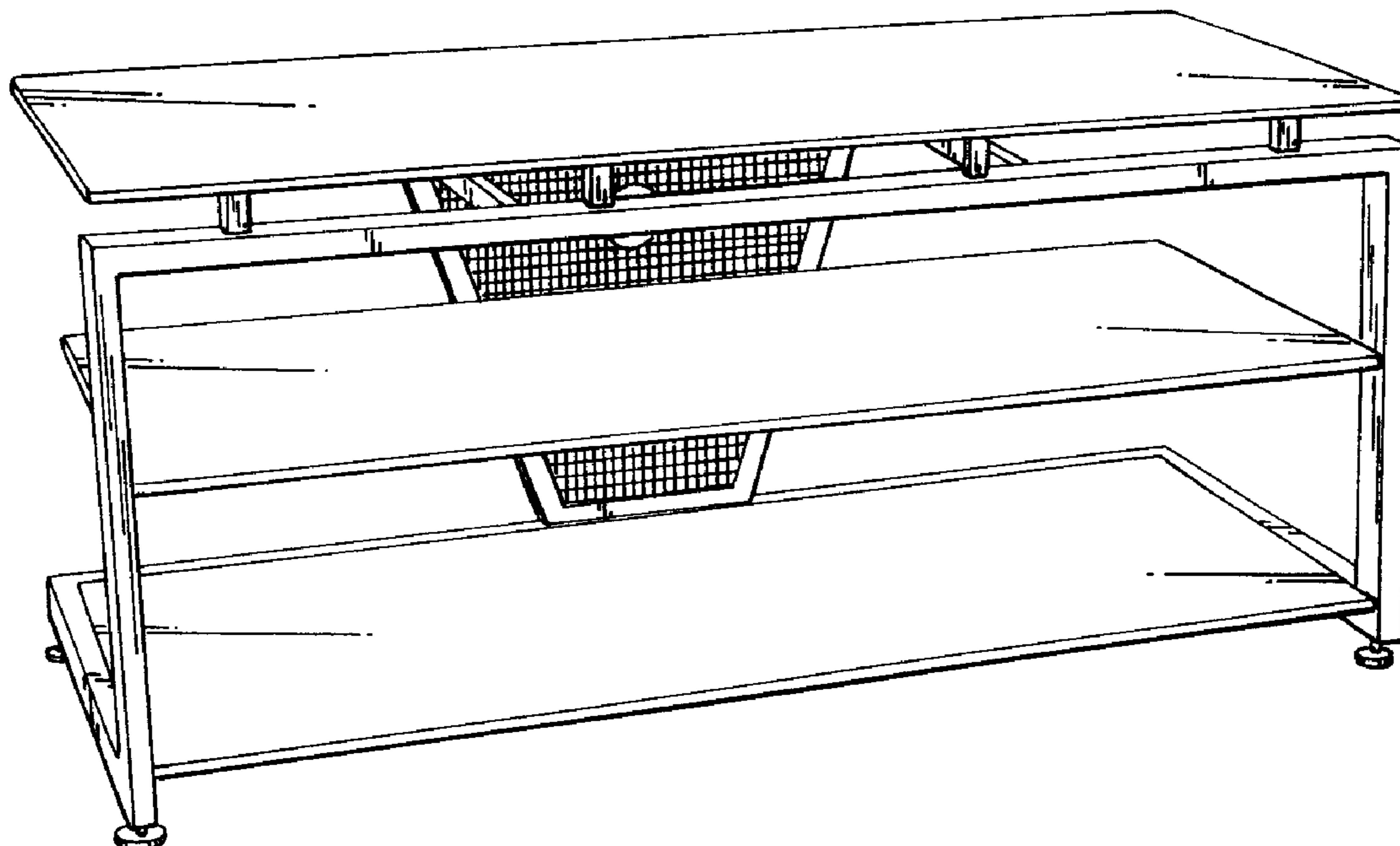
FIG. 1 is a perspective view of an audio-video storage unit showing my new design;

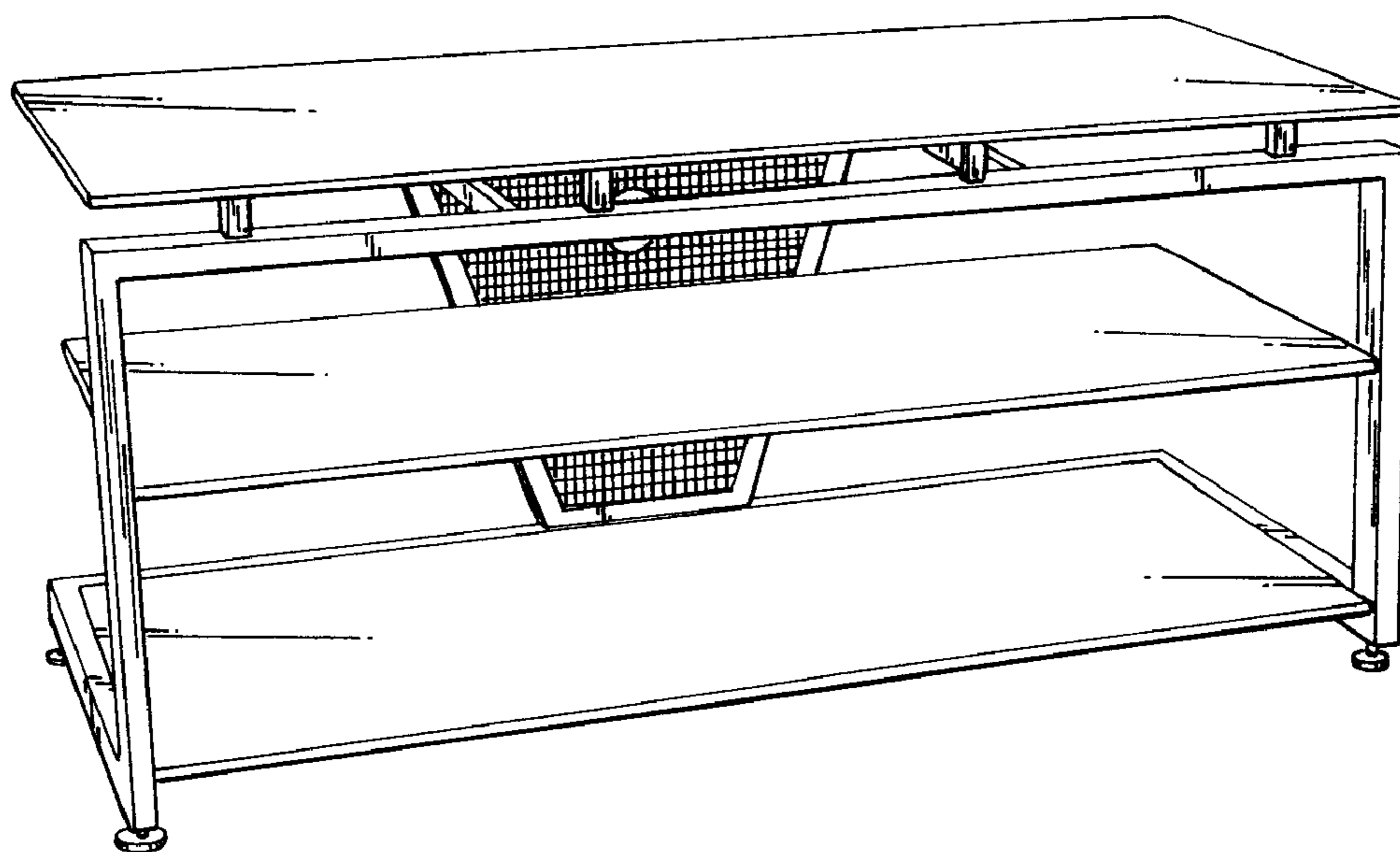

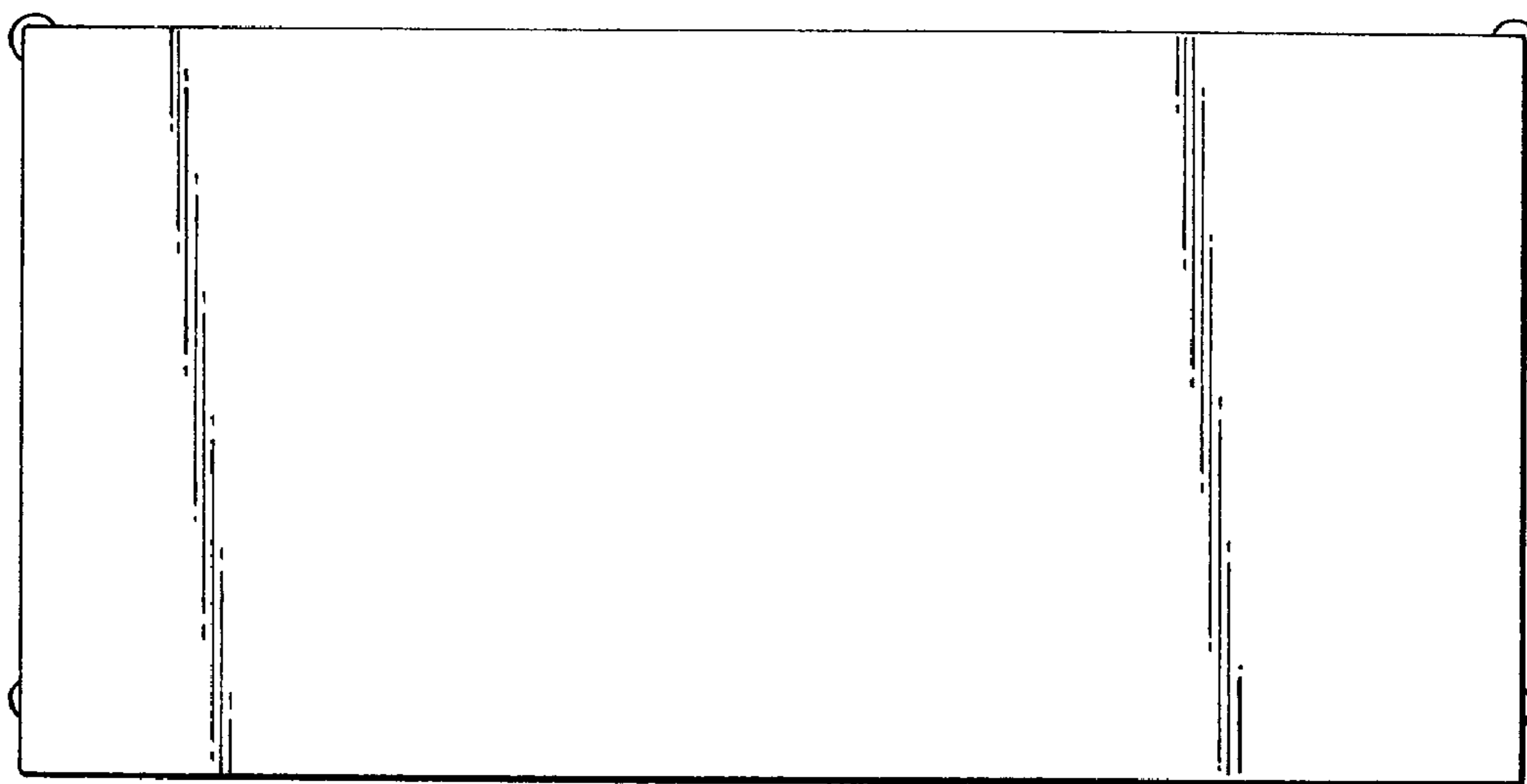

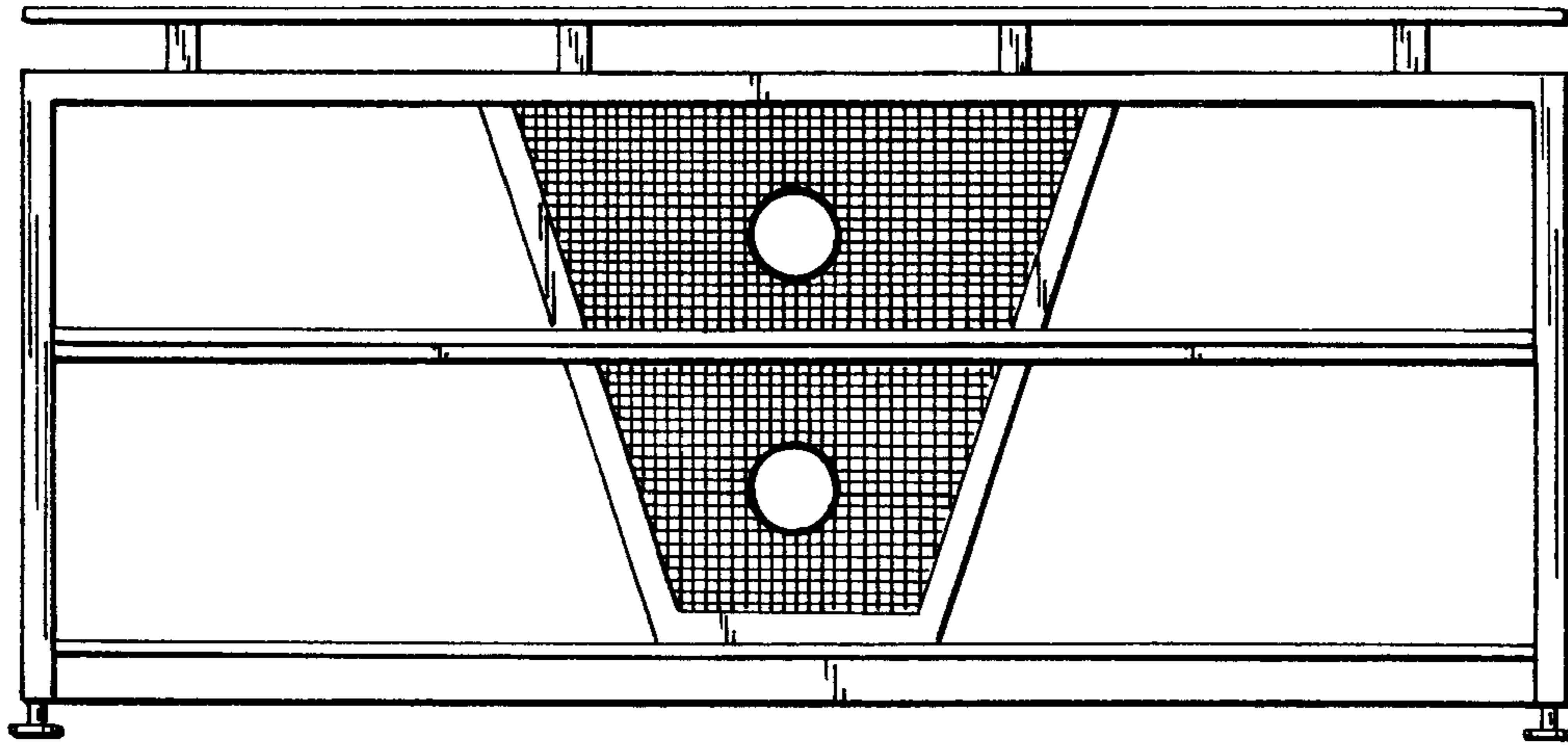

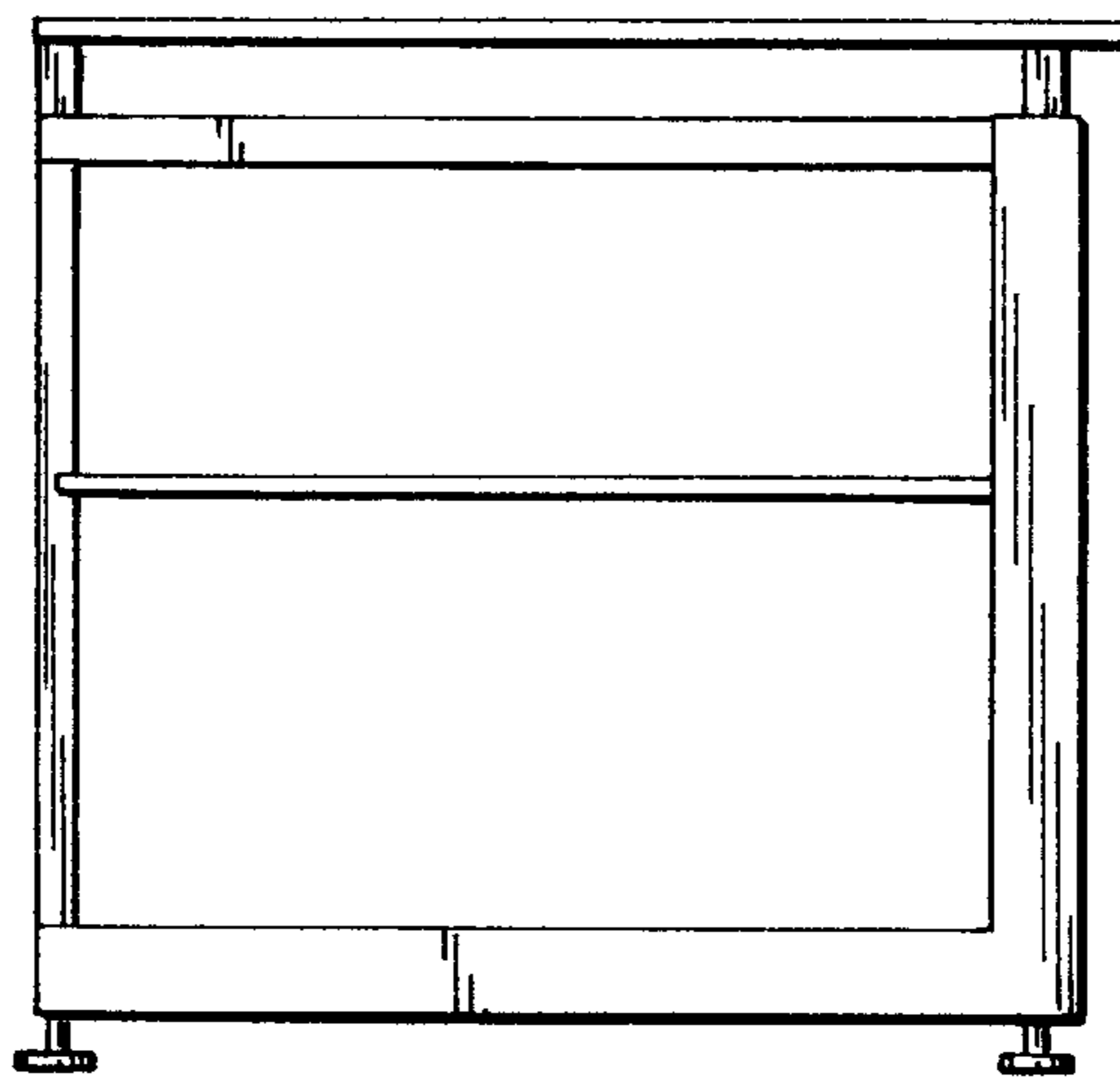

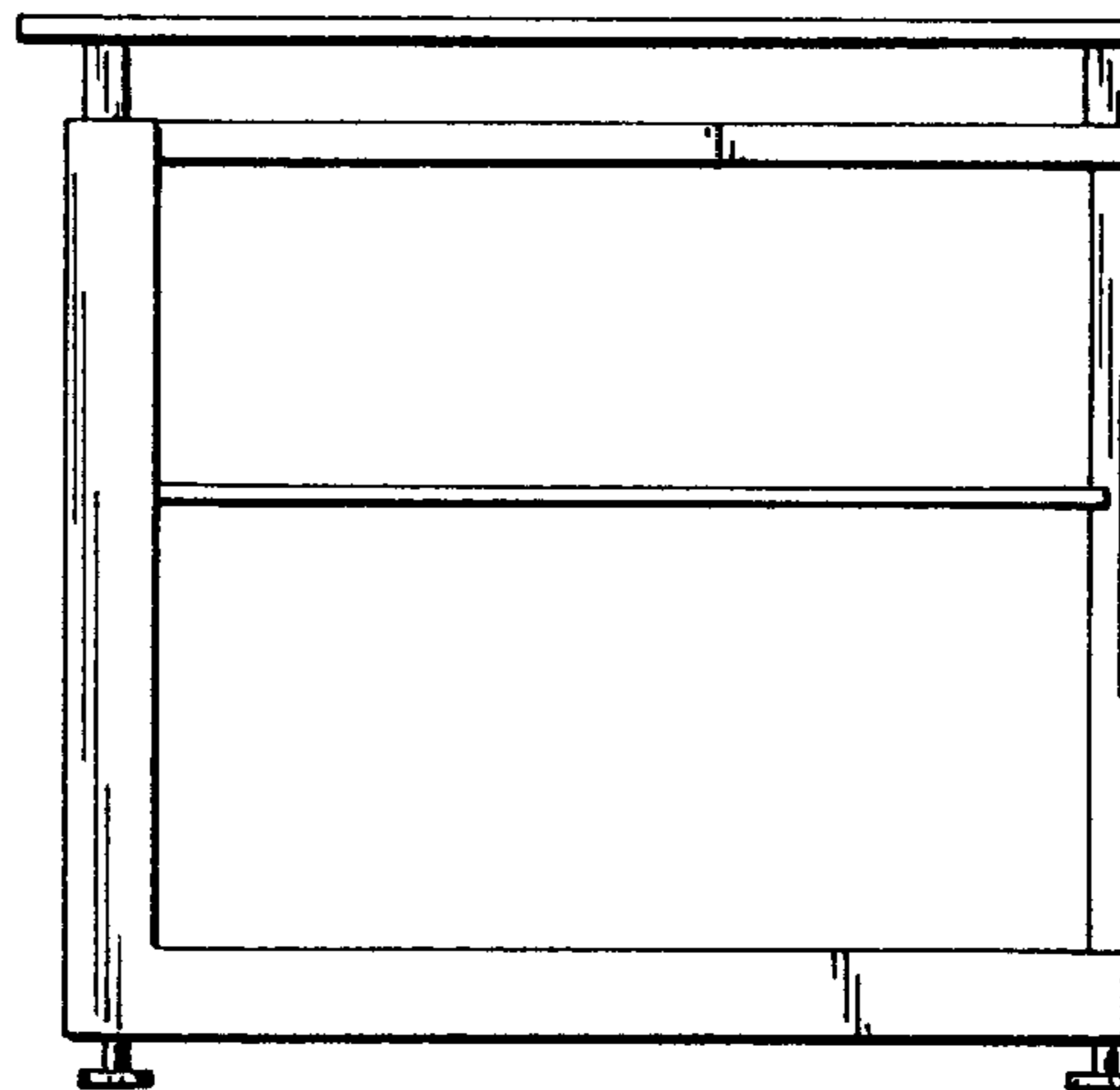

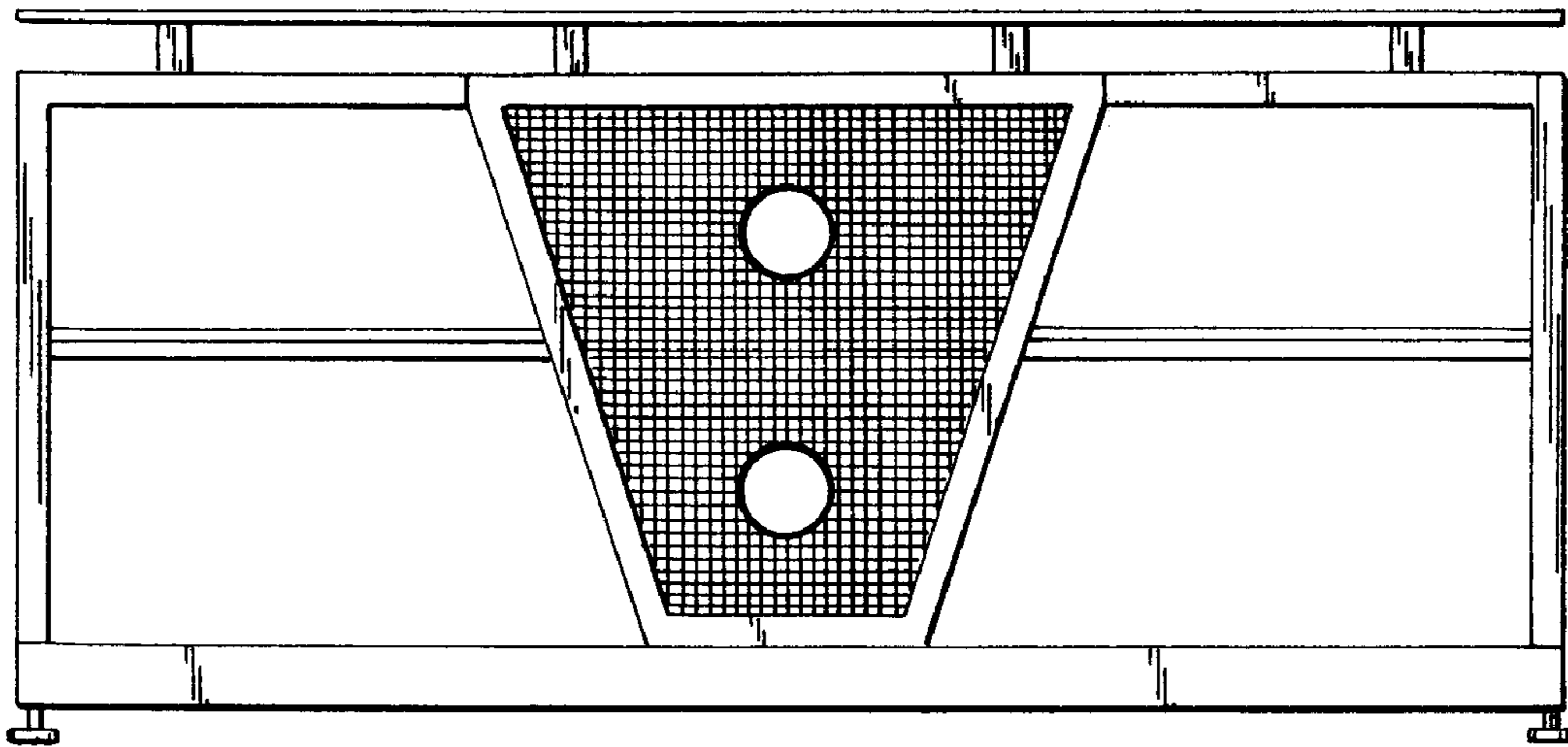

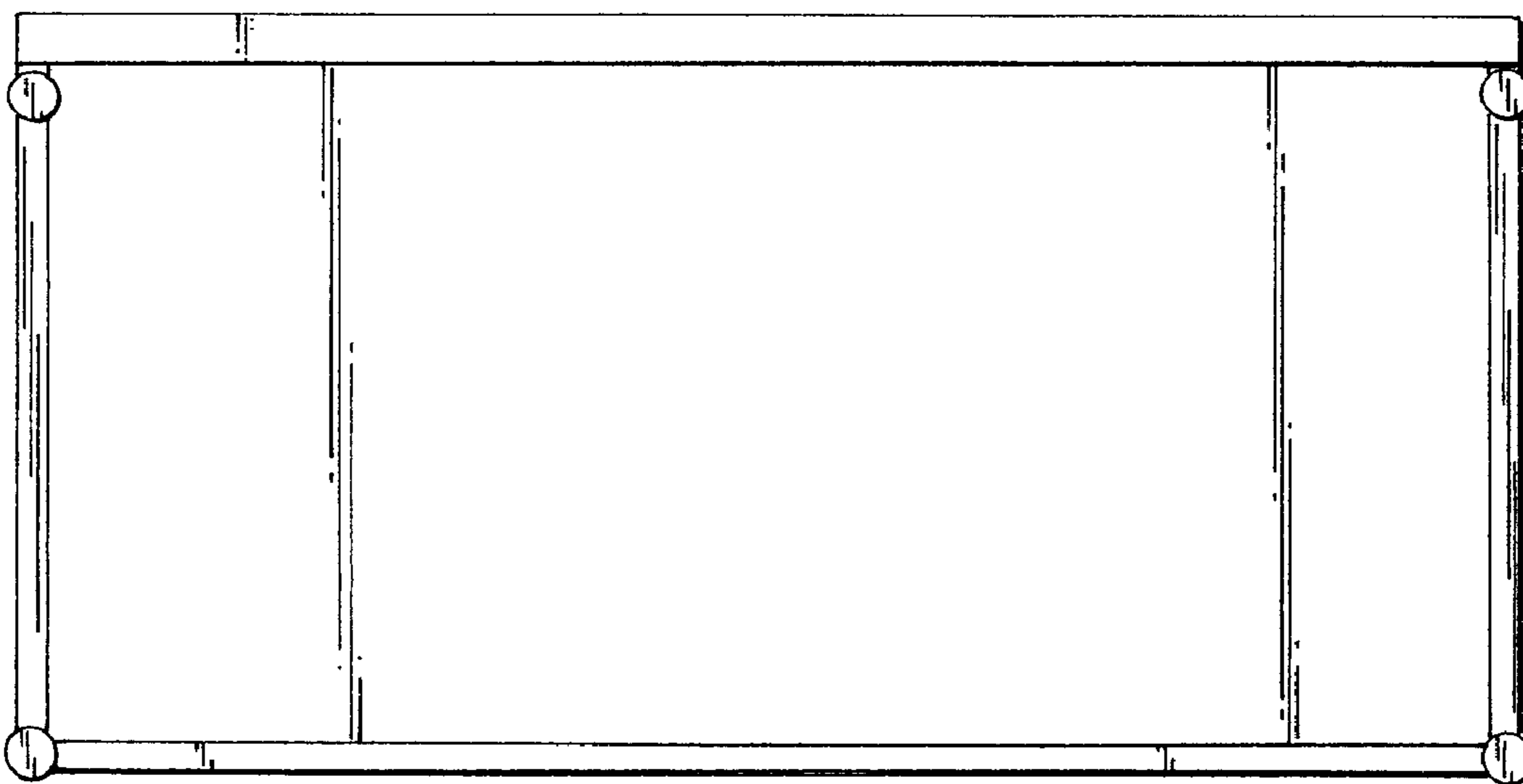

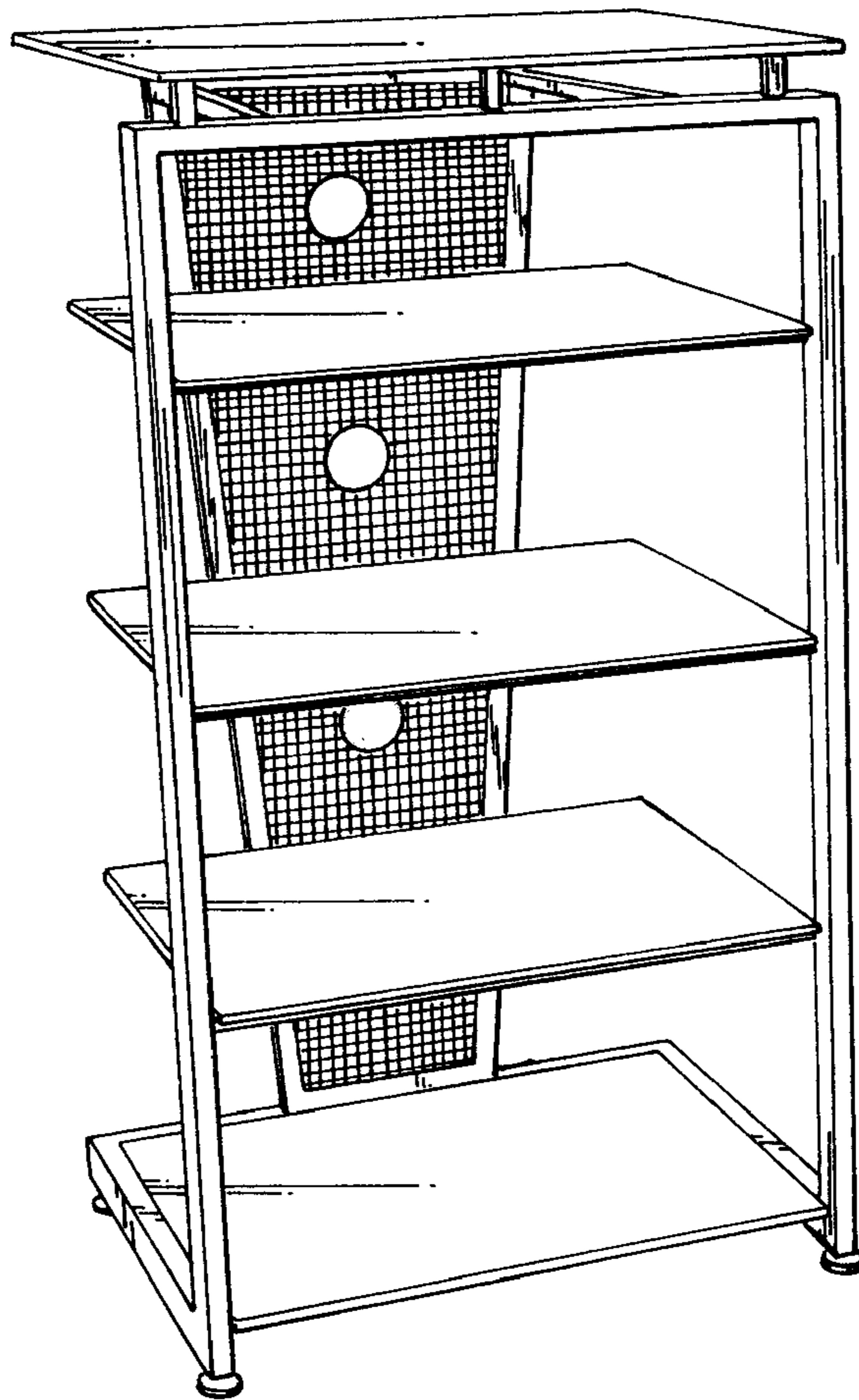

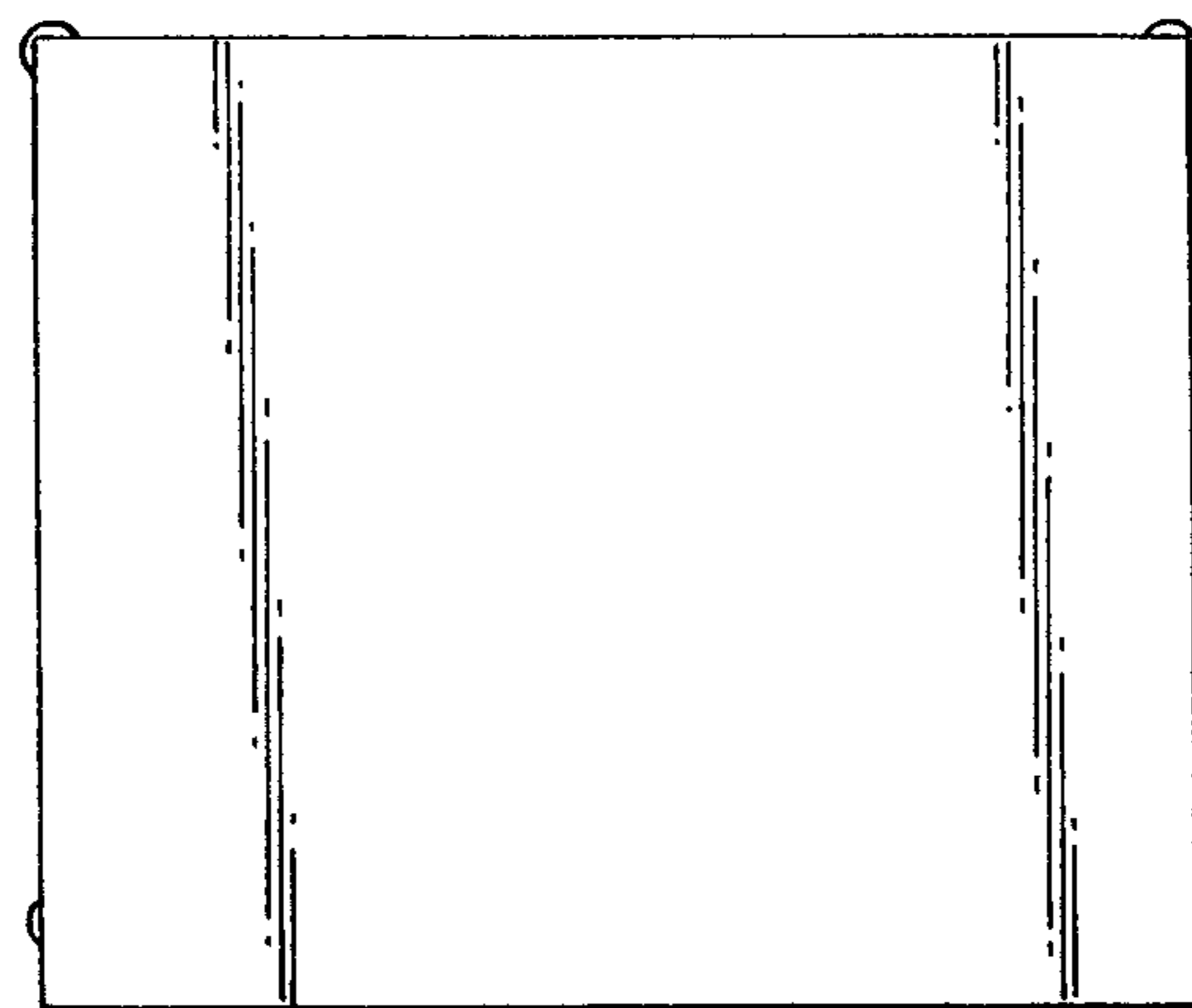

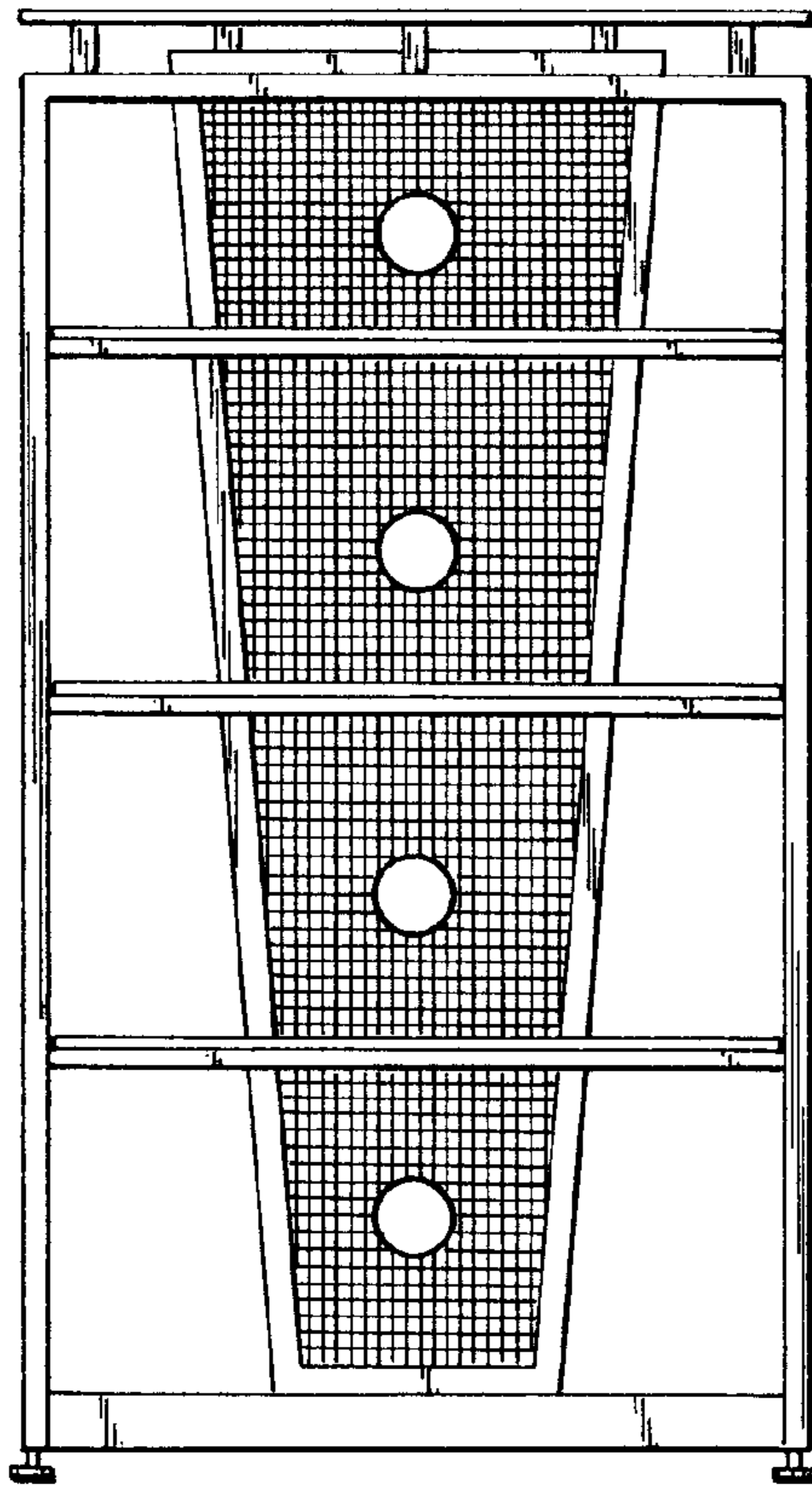

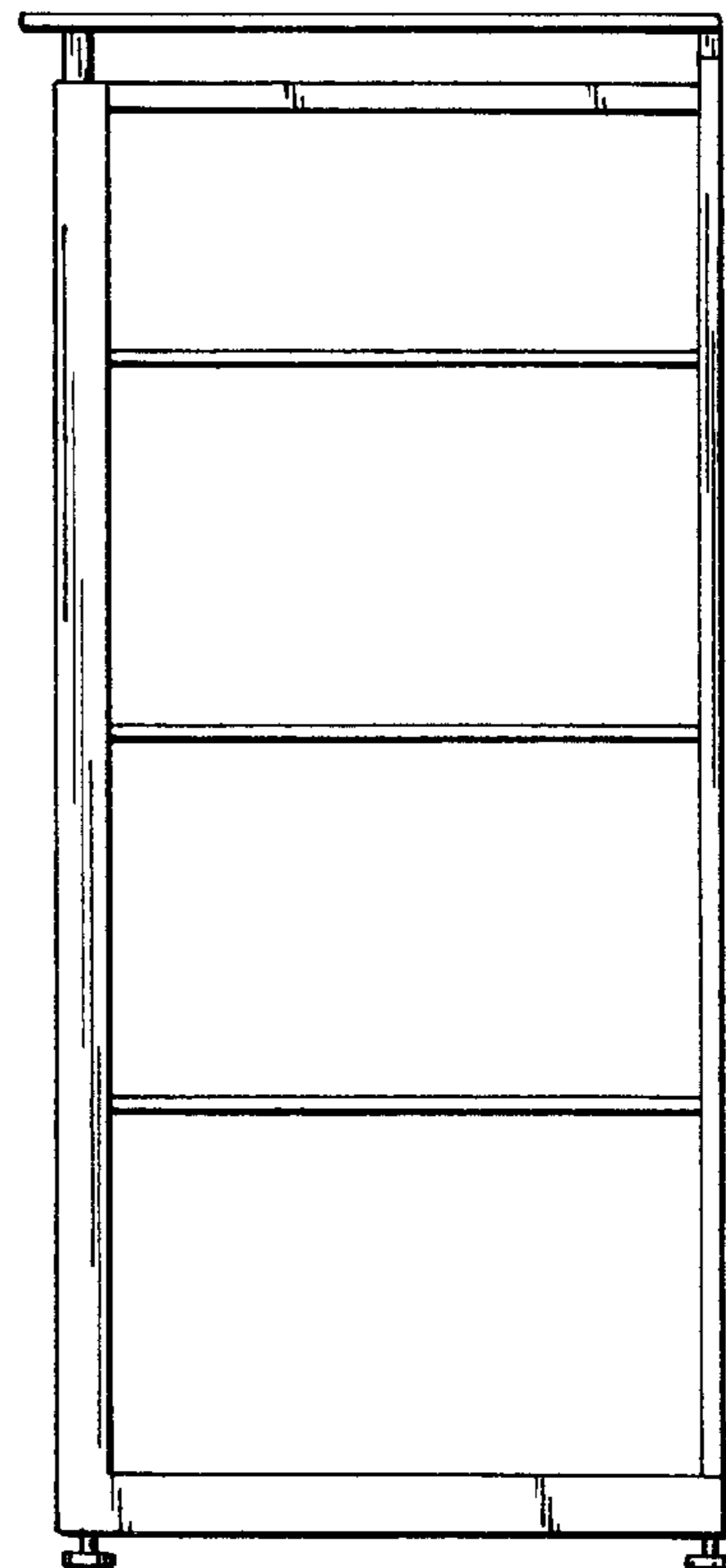

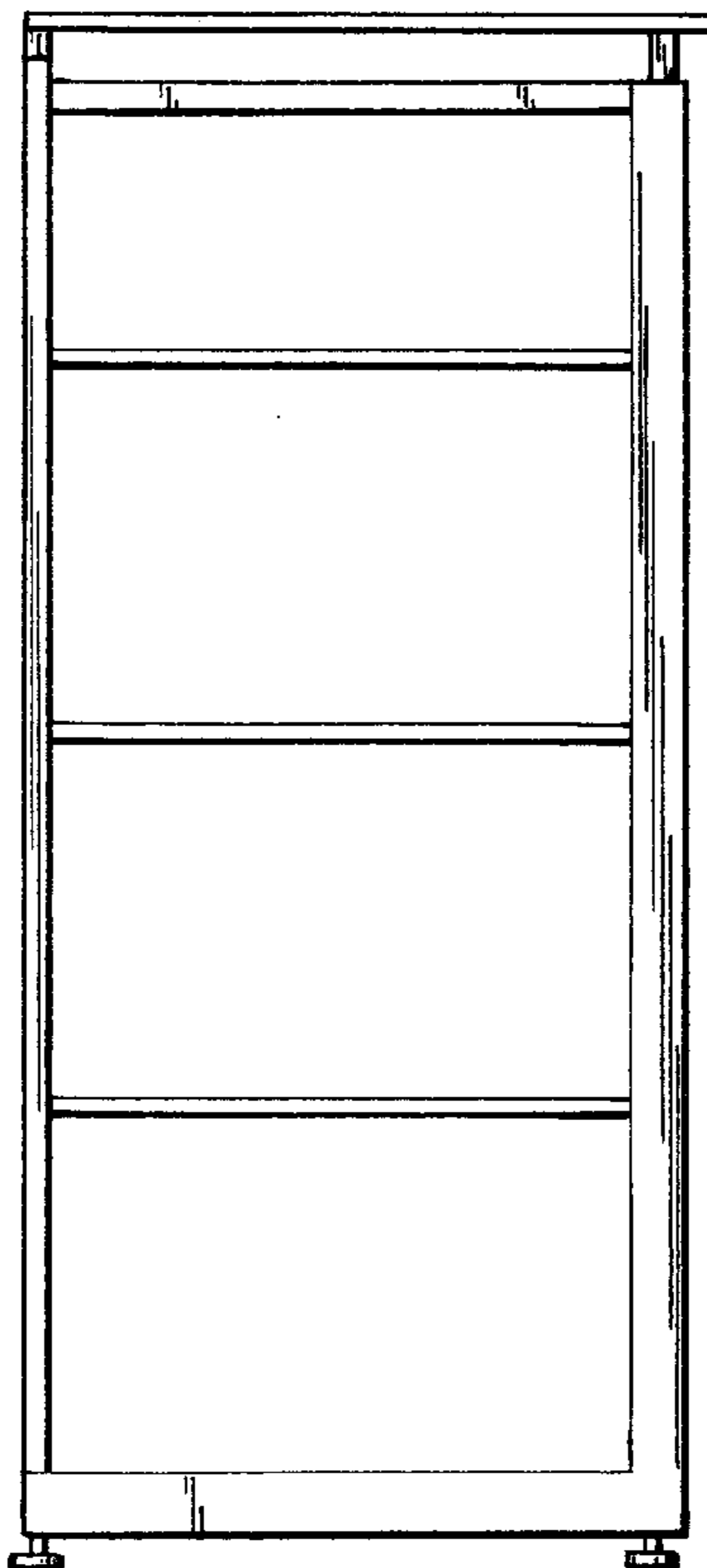

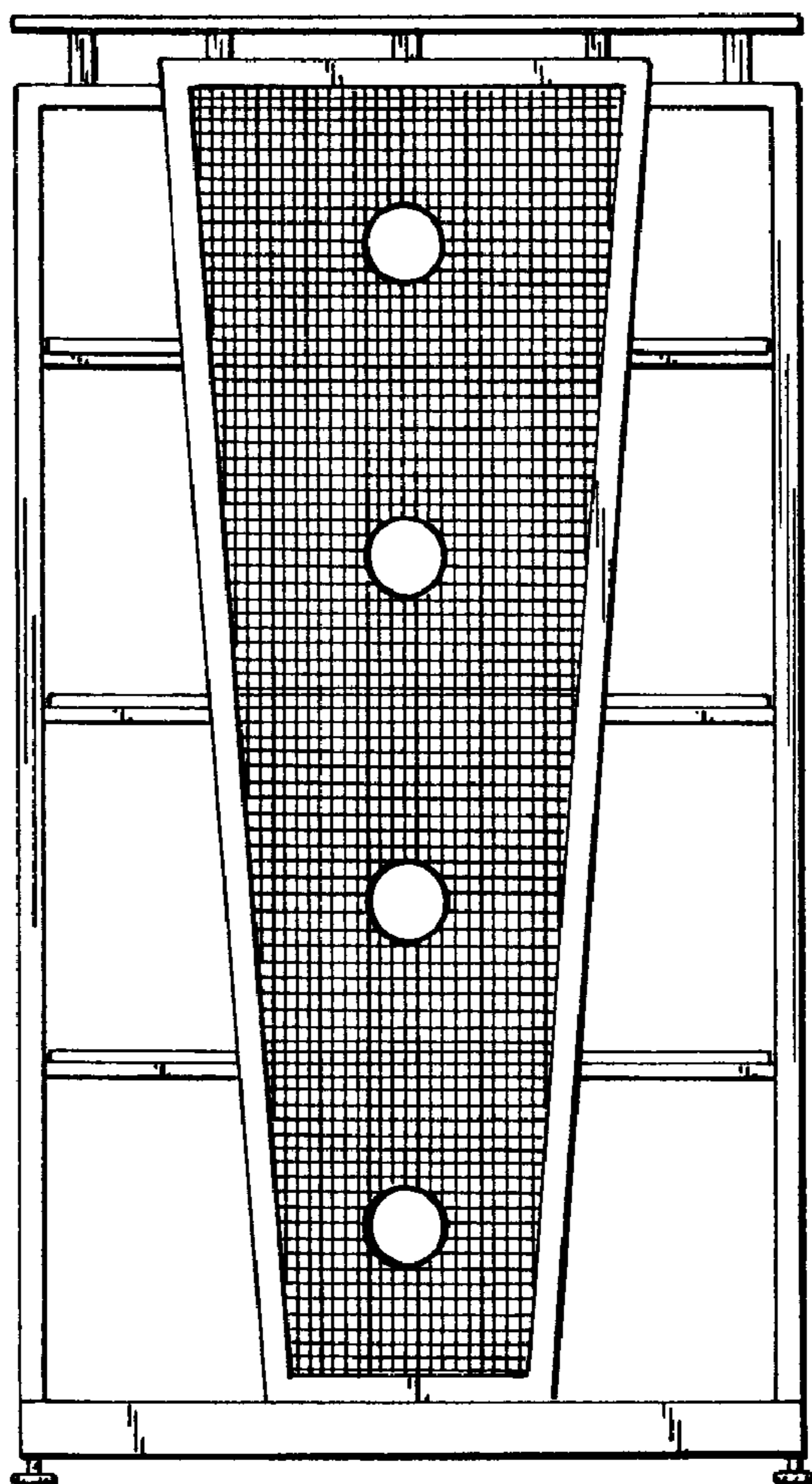

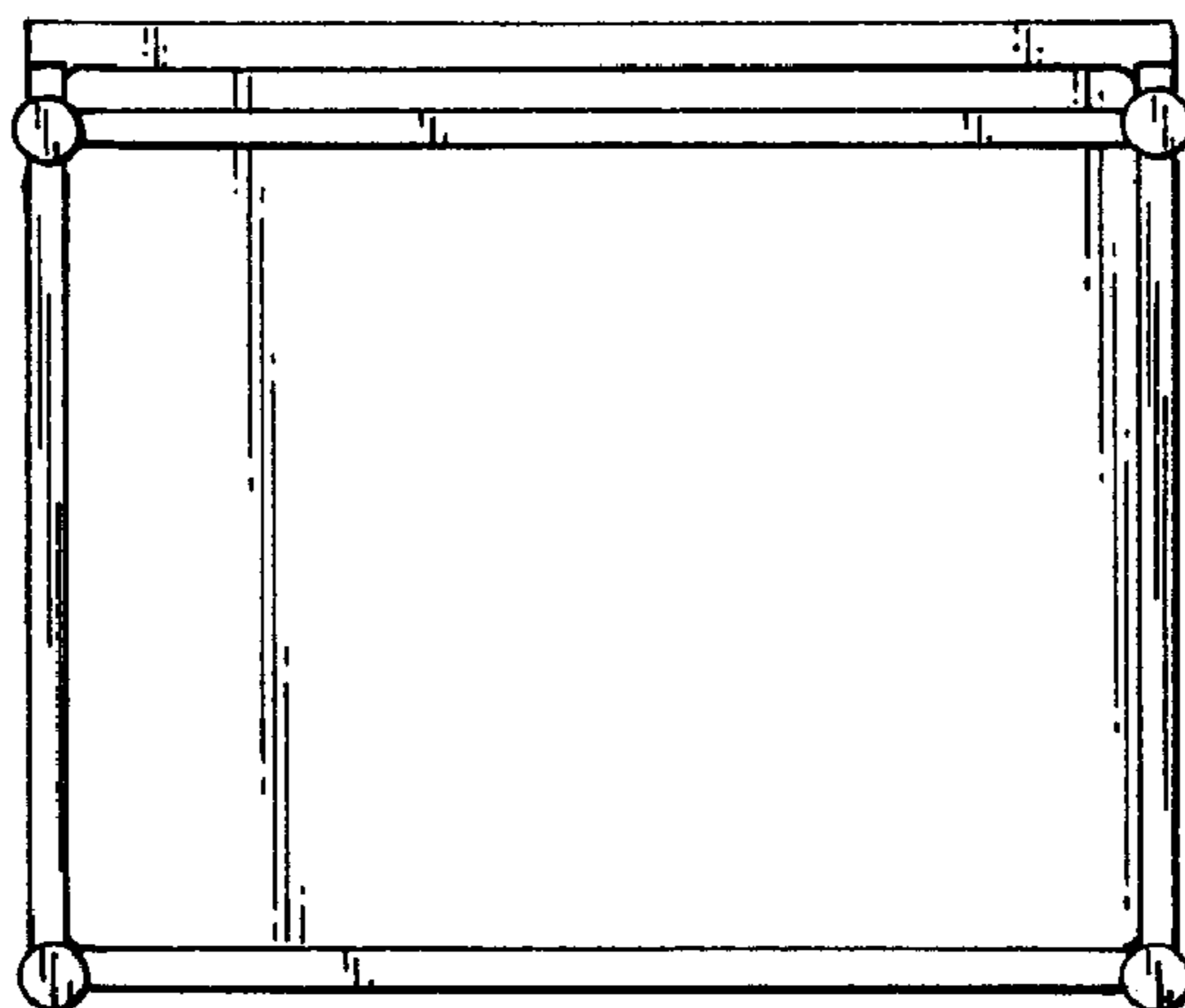
