FIG. 6 is a perspective view of the wall mountable utility box.

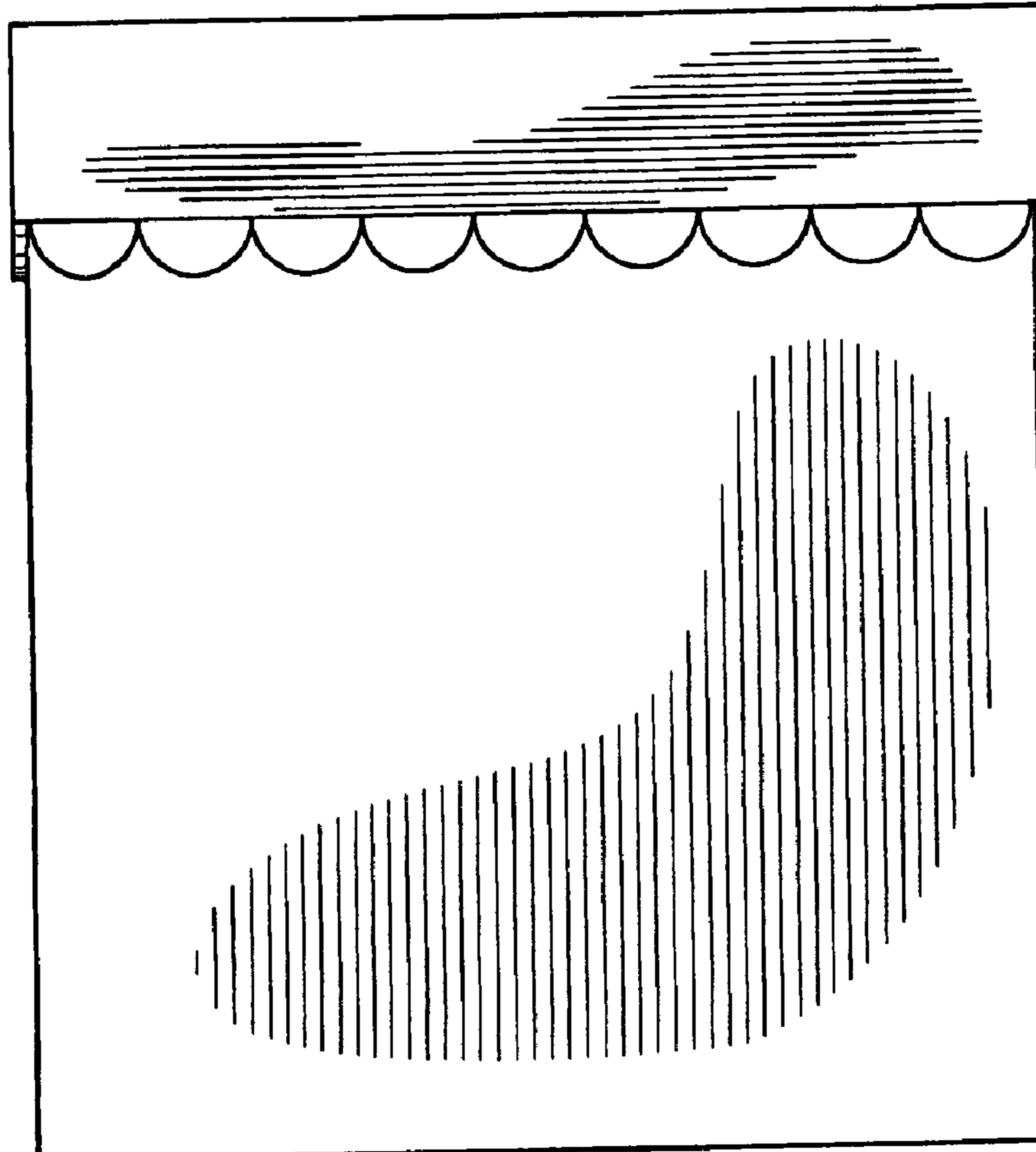

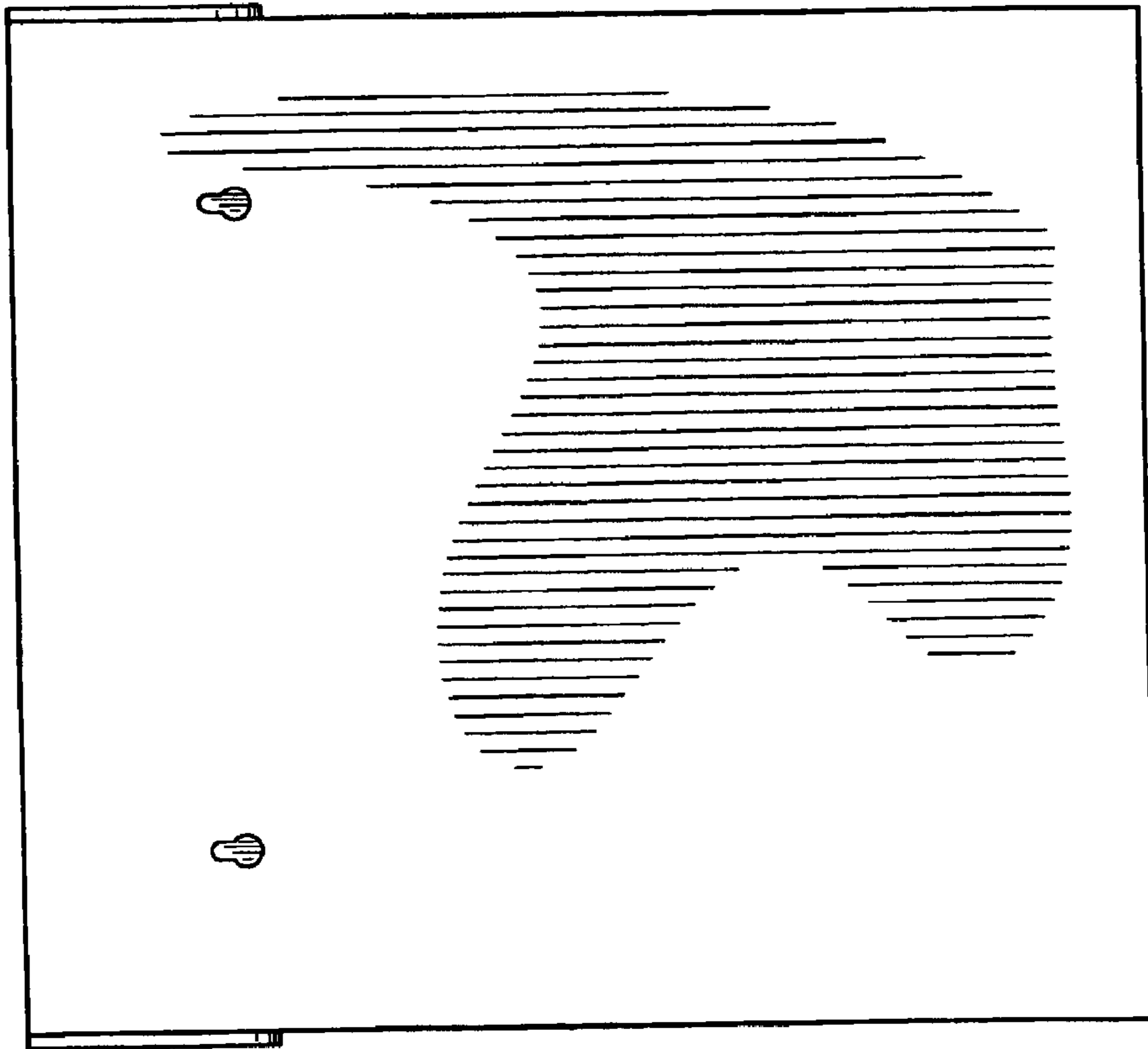

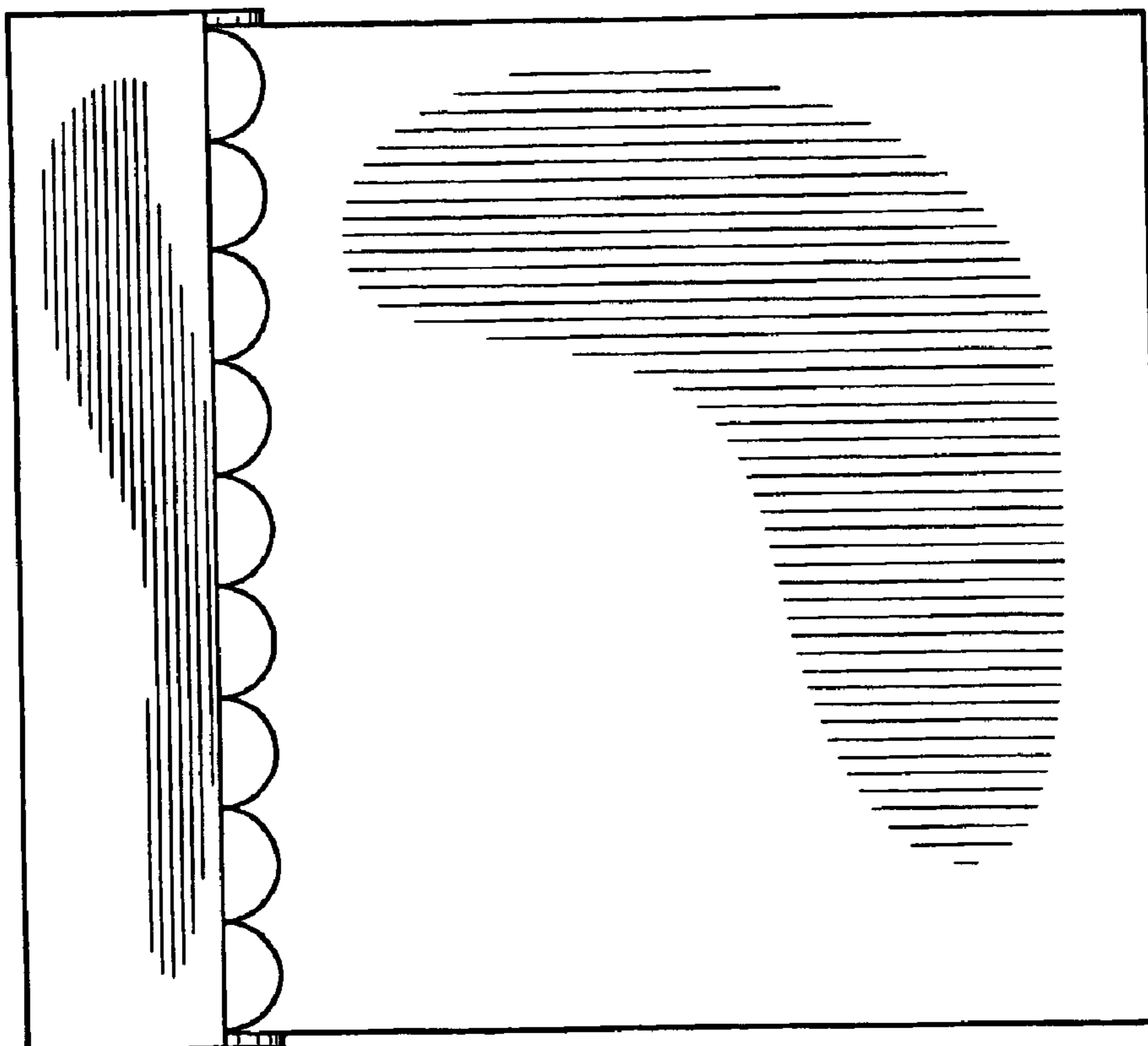

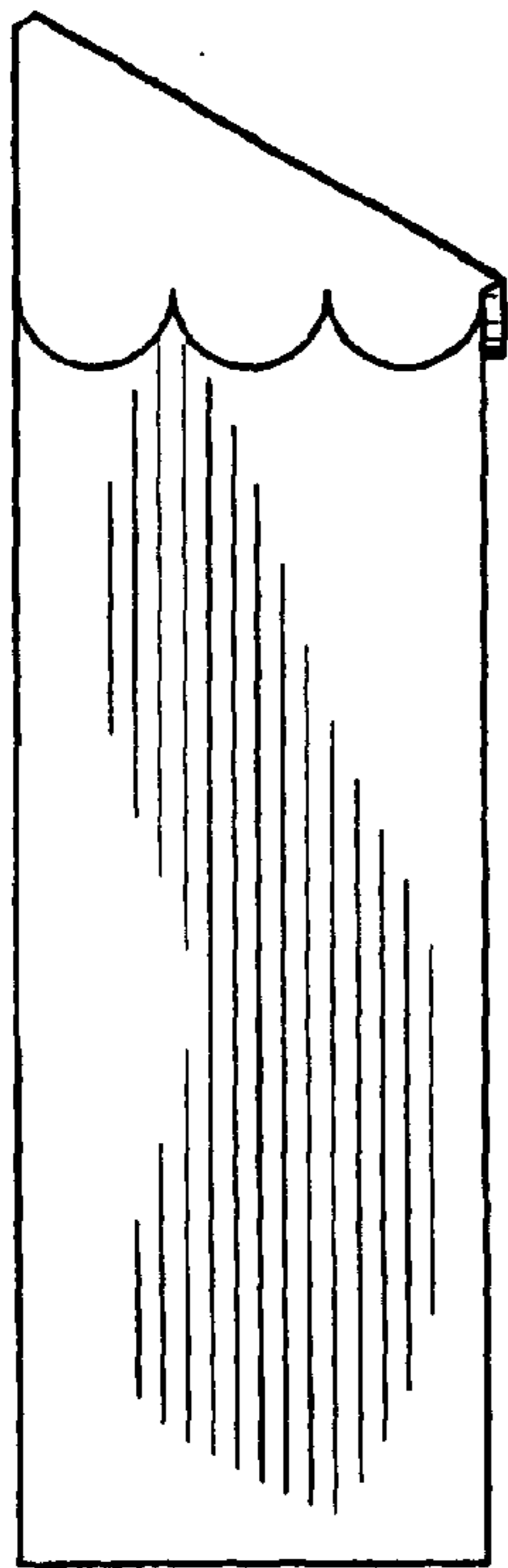

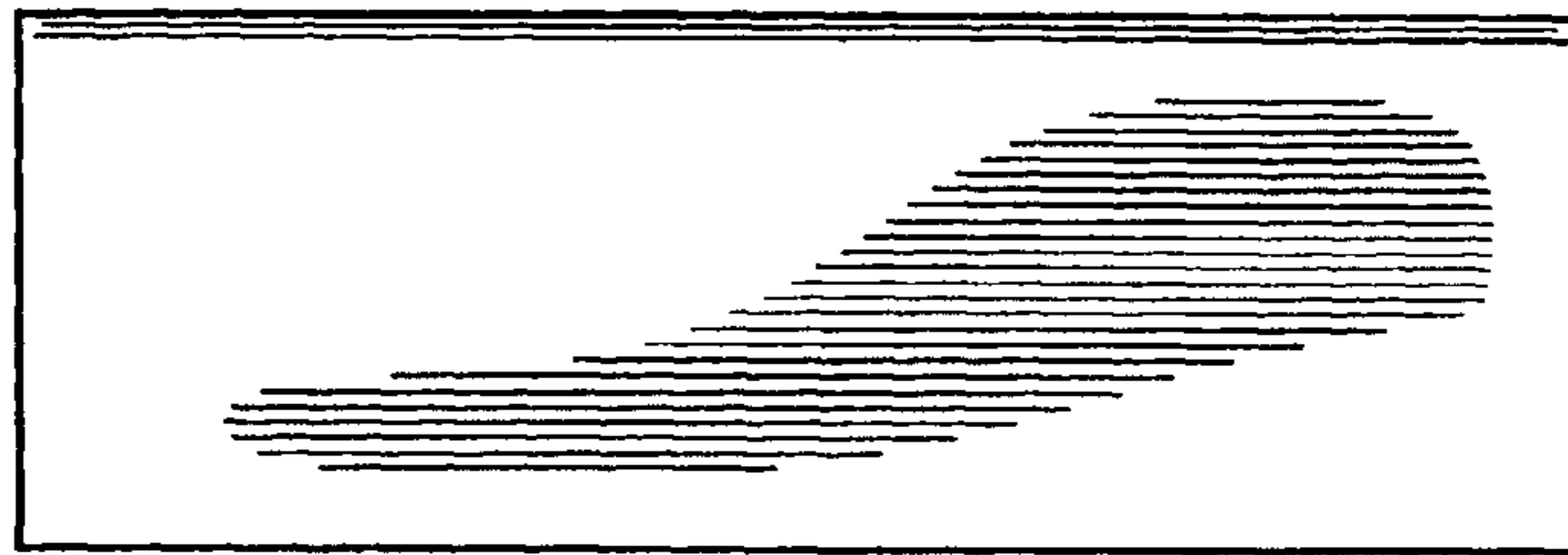

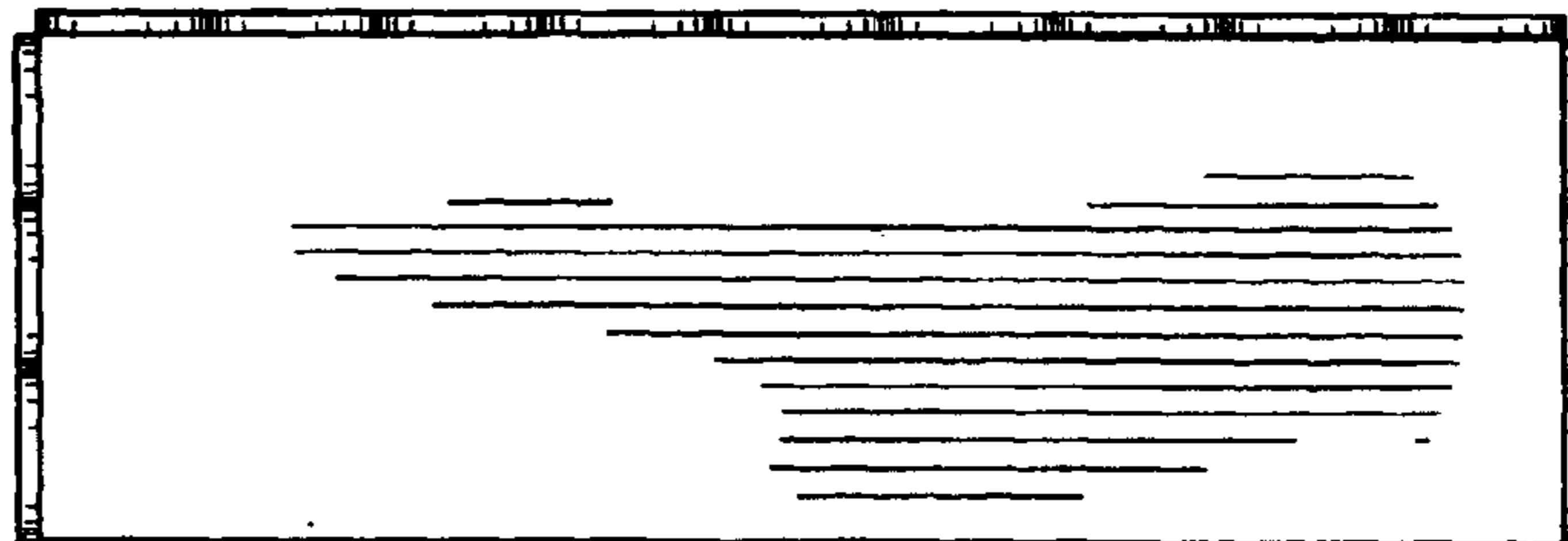

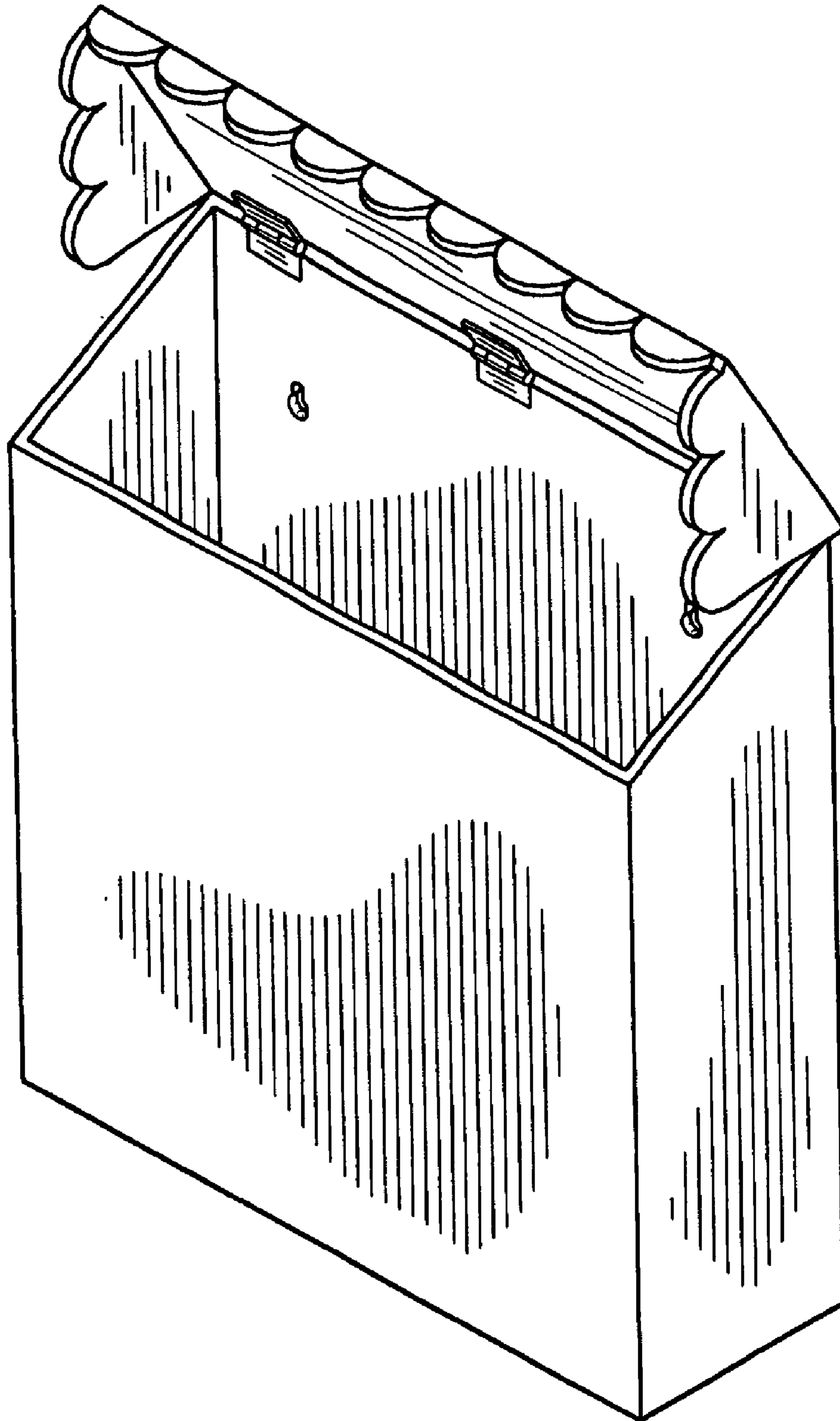
