FIG. 11 is a top view thereof;

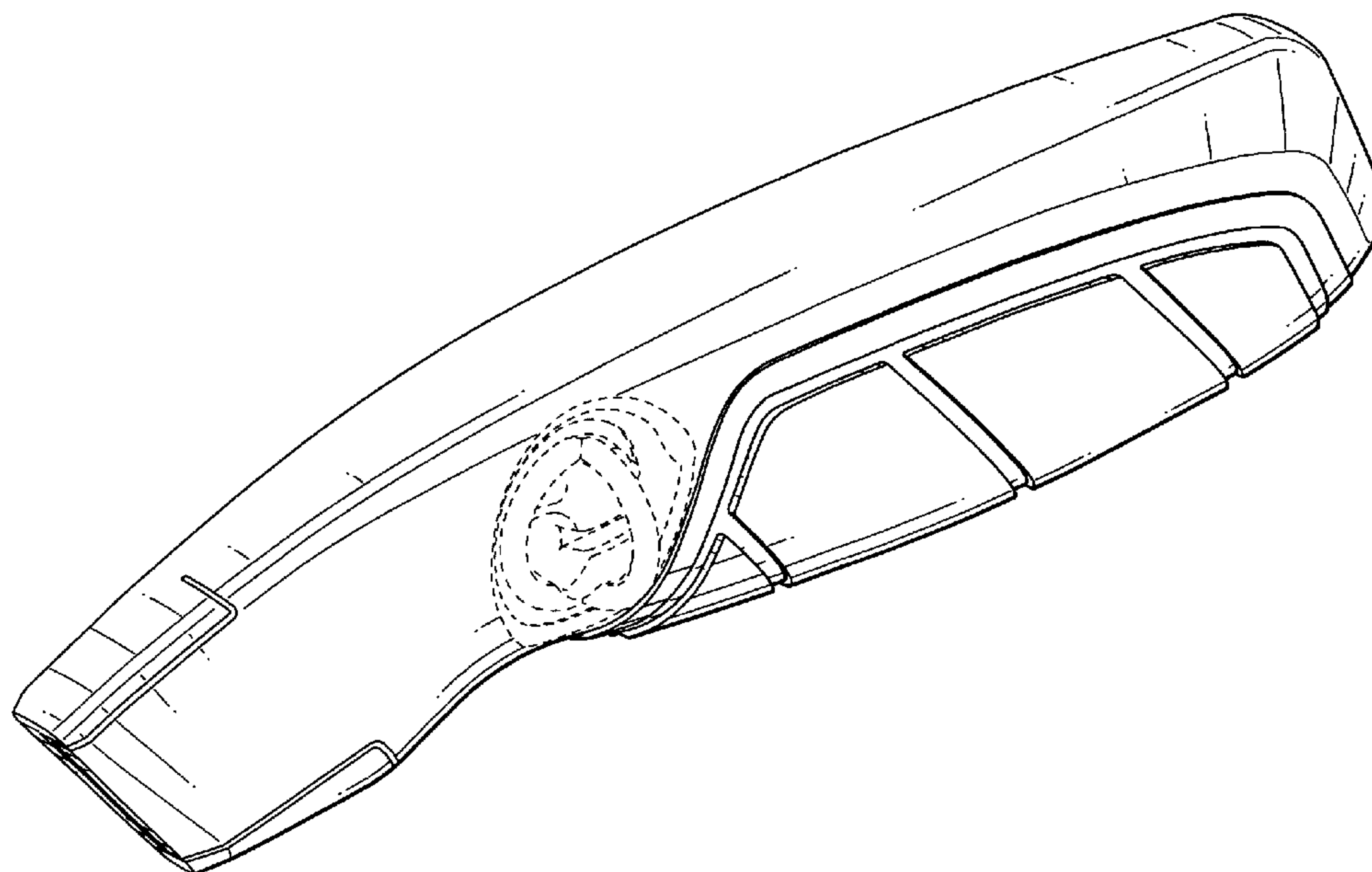
FIG. 12 is a bottom view thereof;

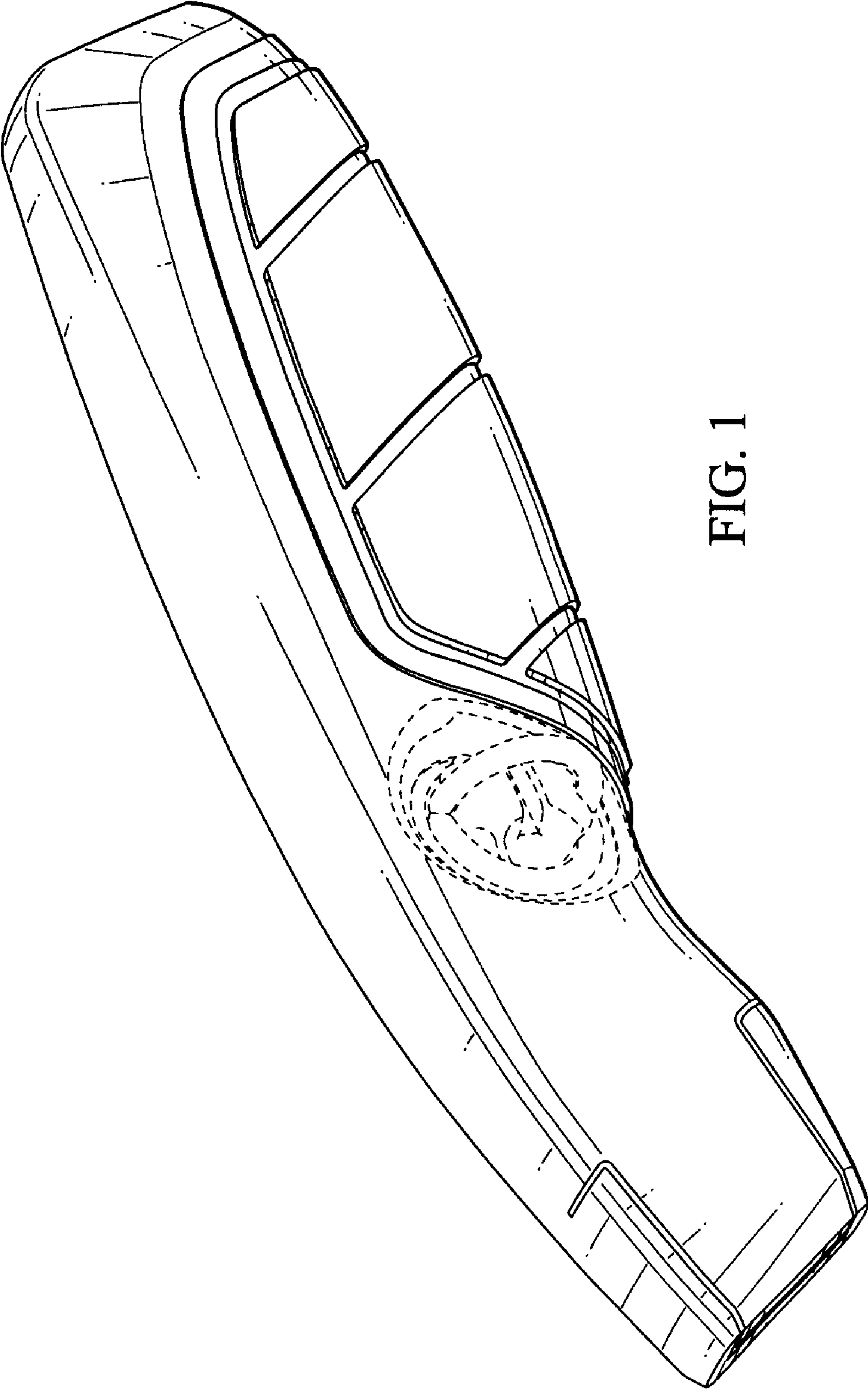

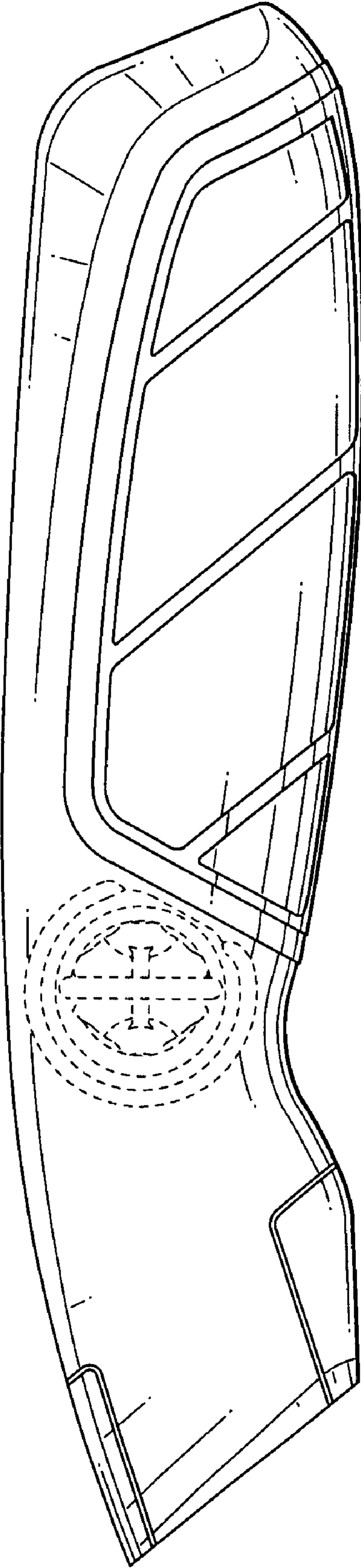

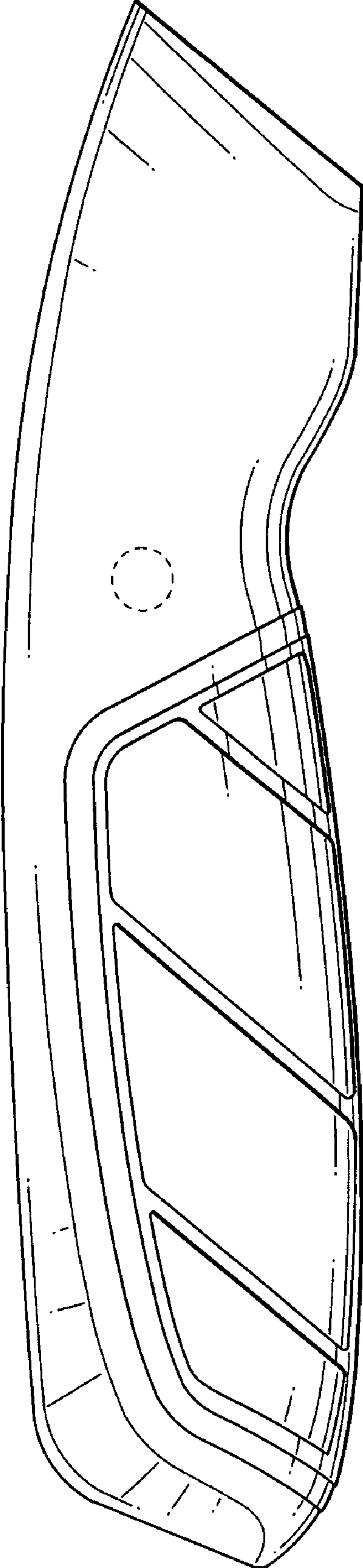

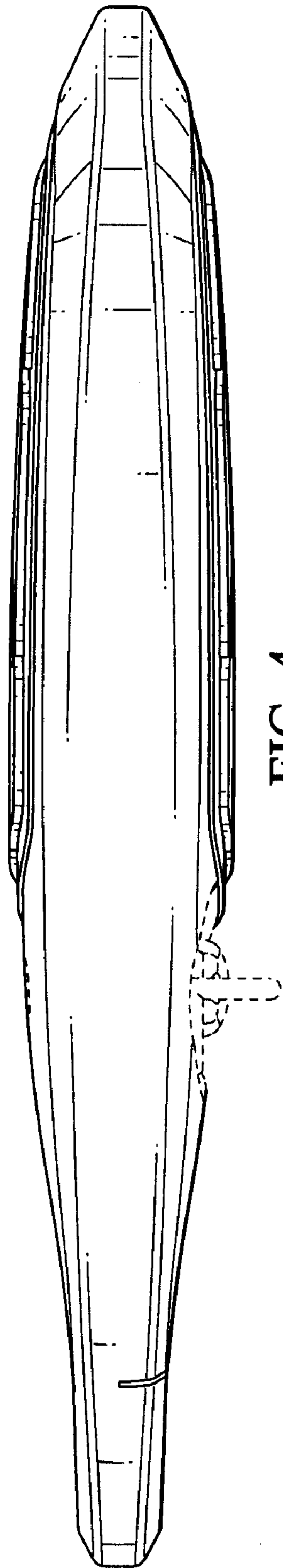

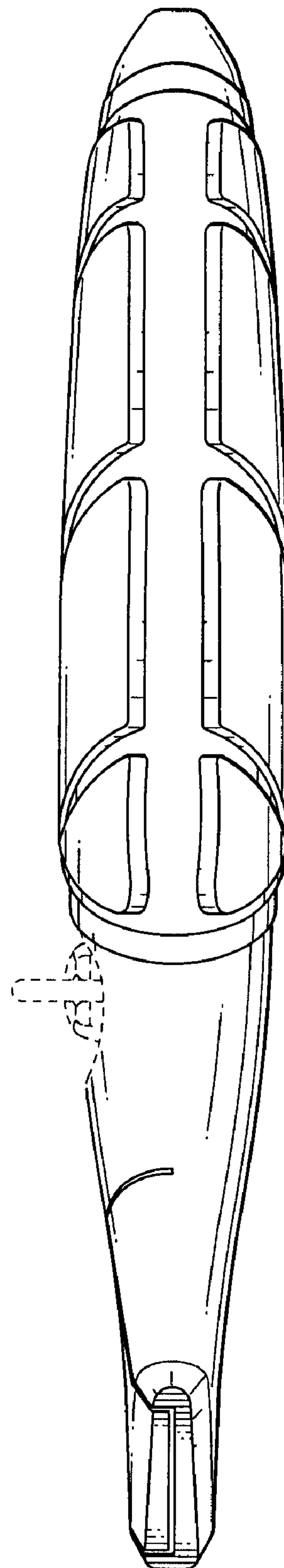

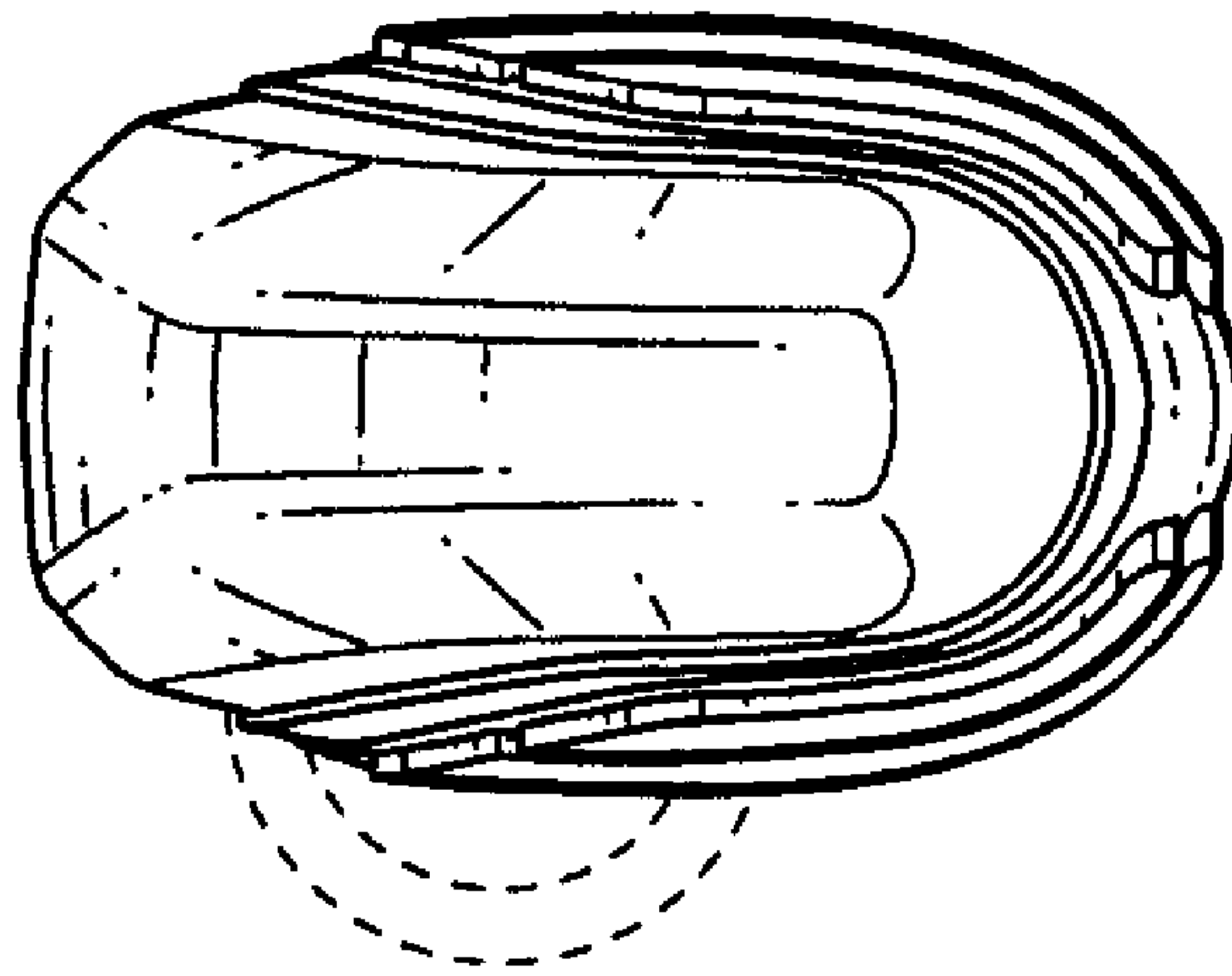

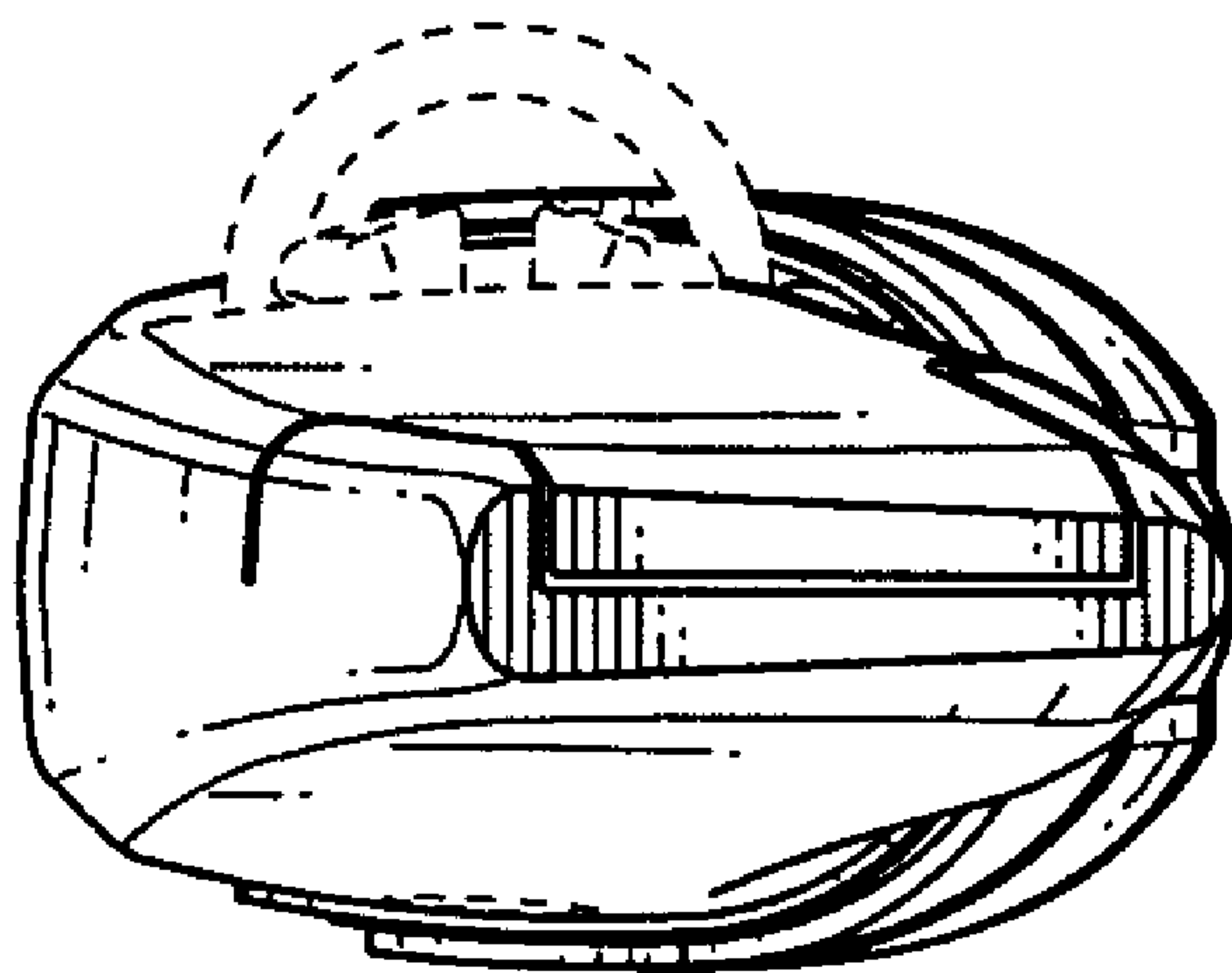

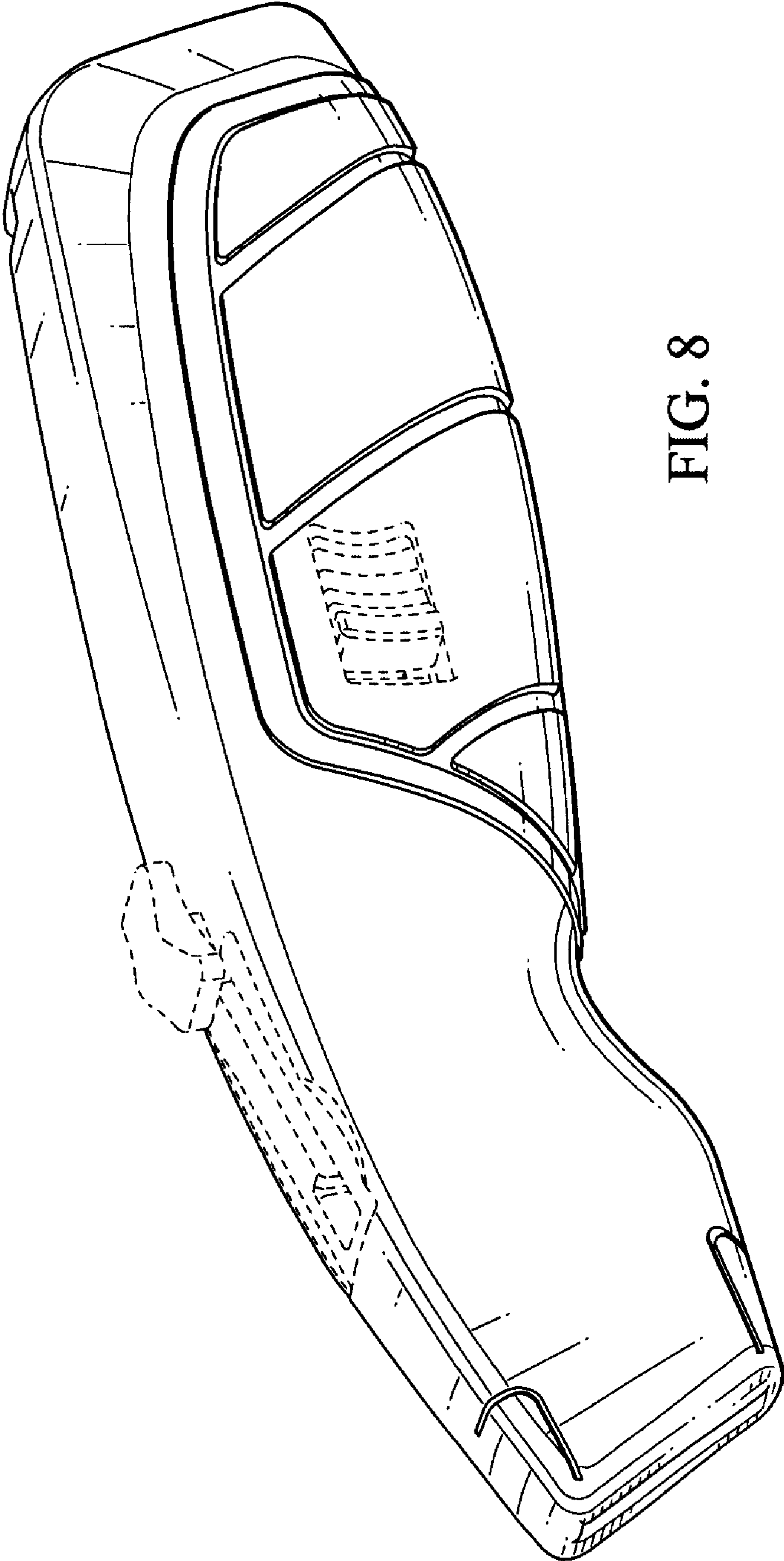

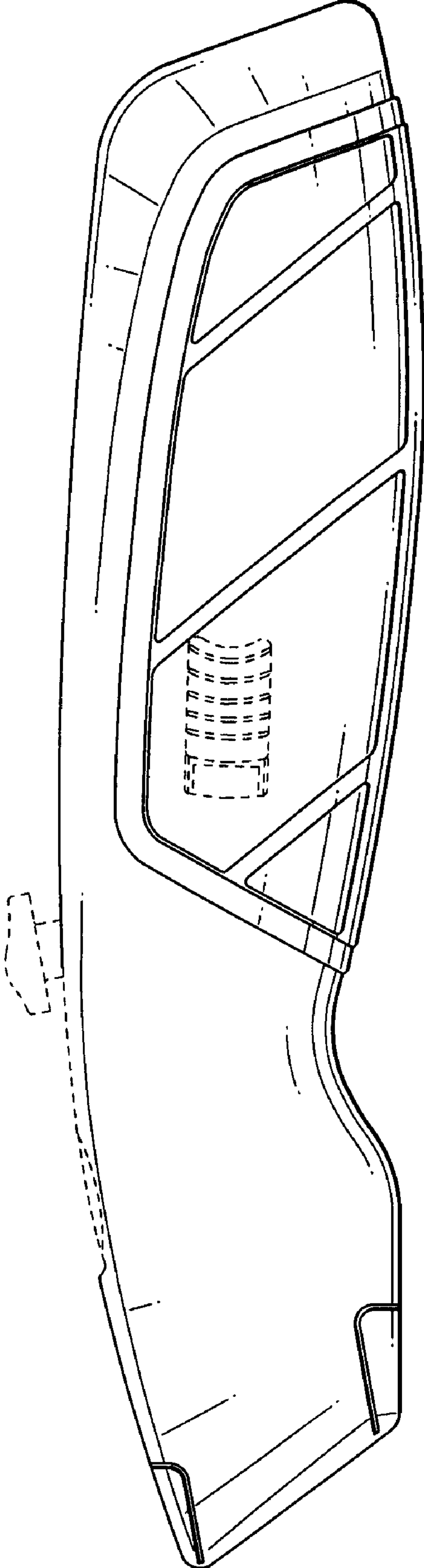

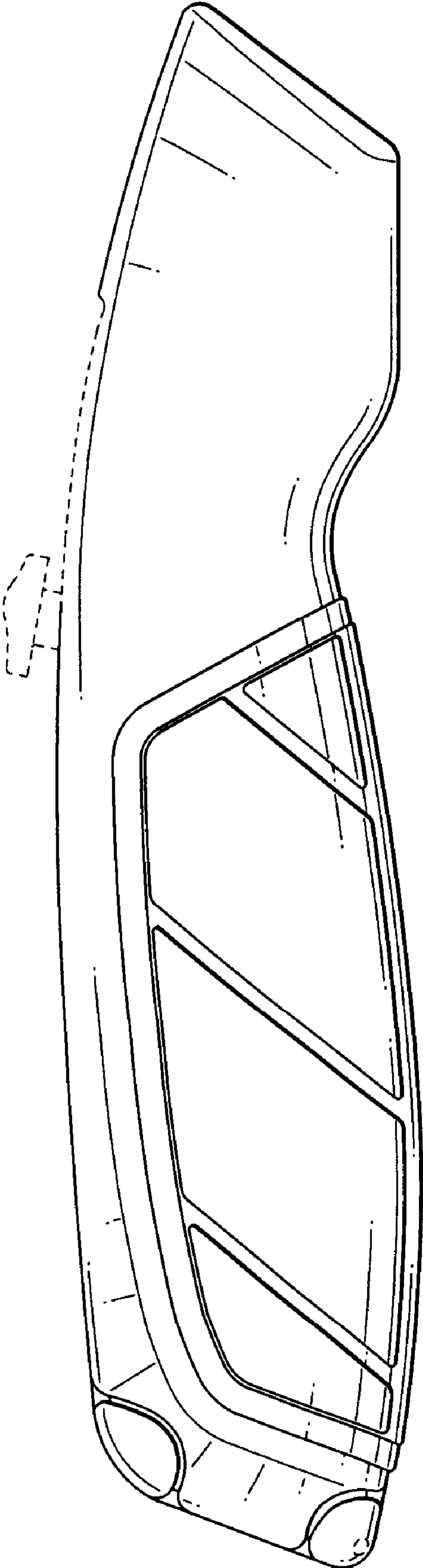

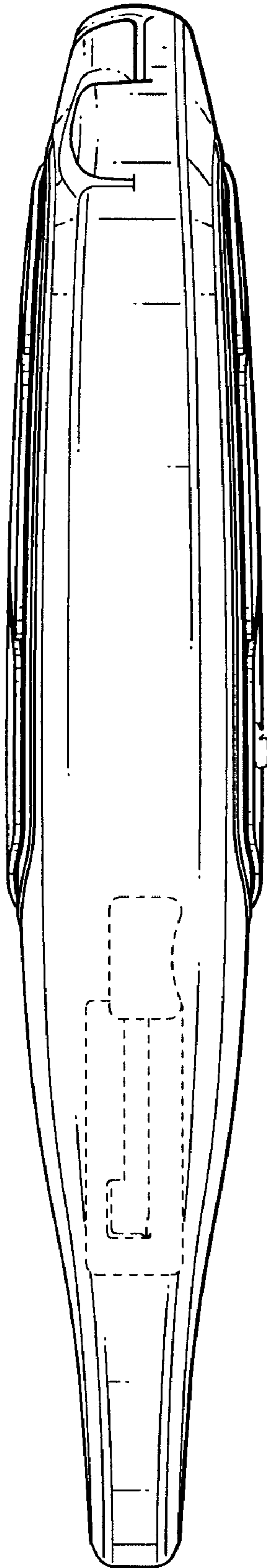

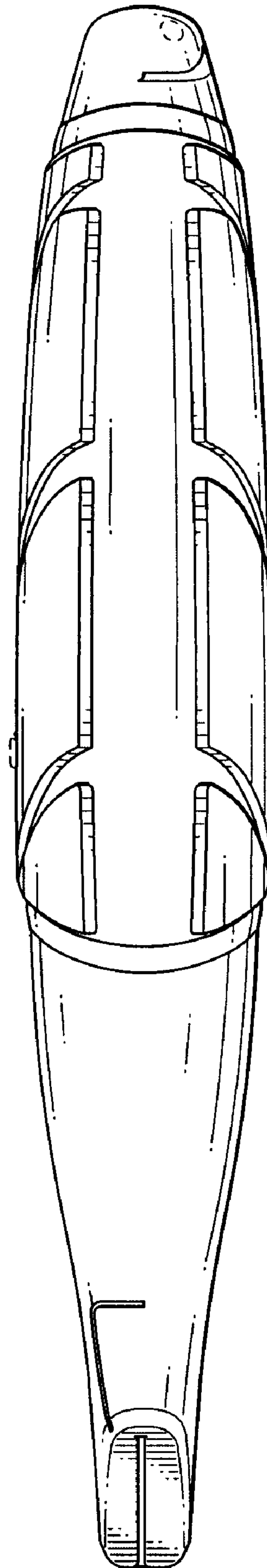

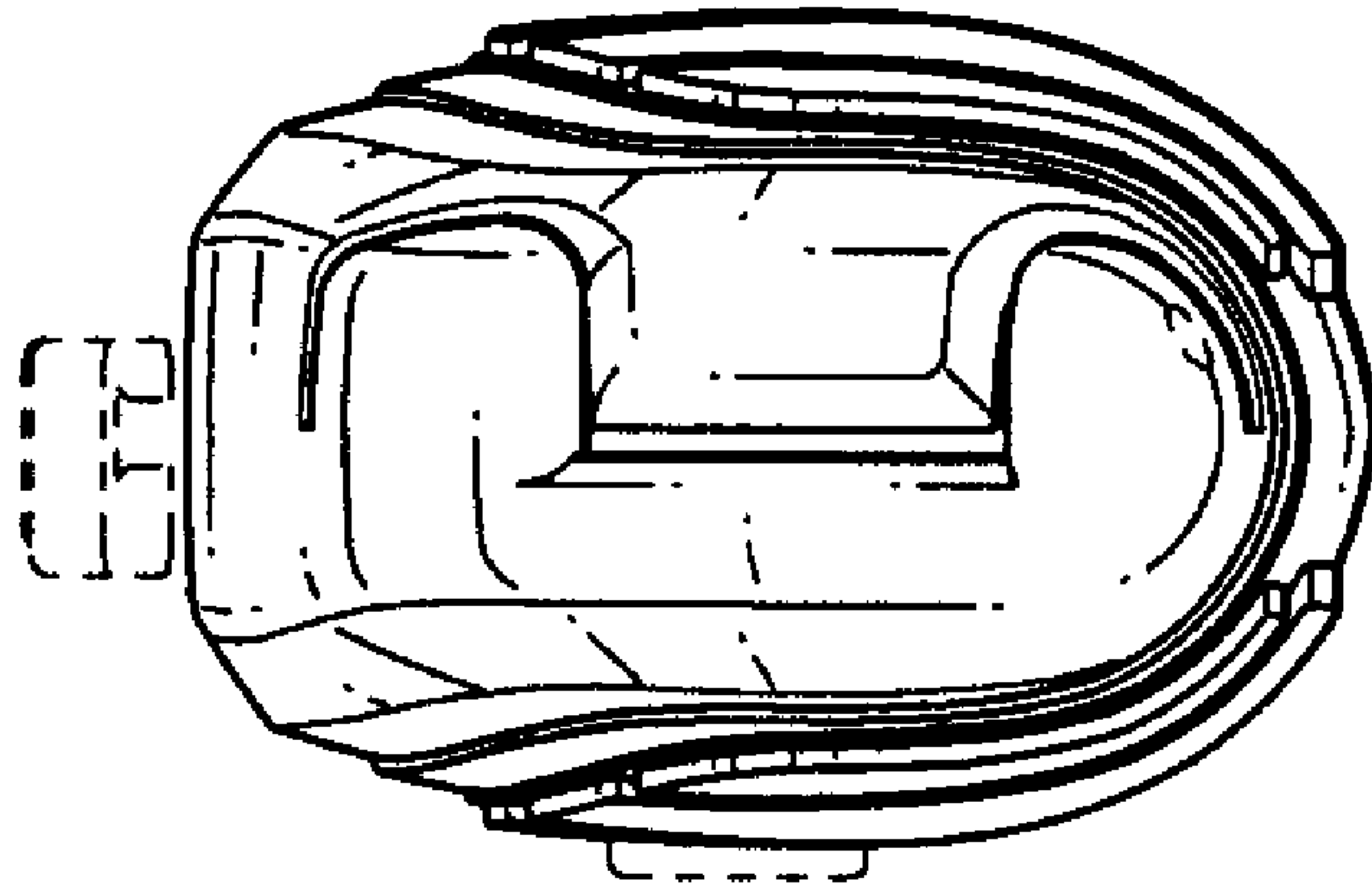

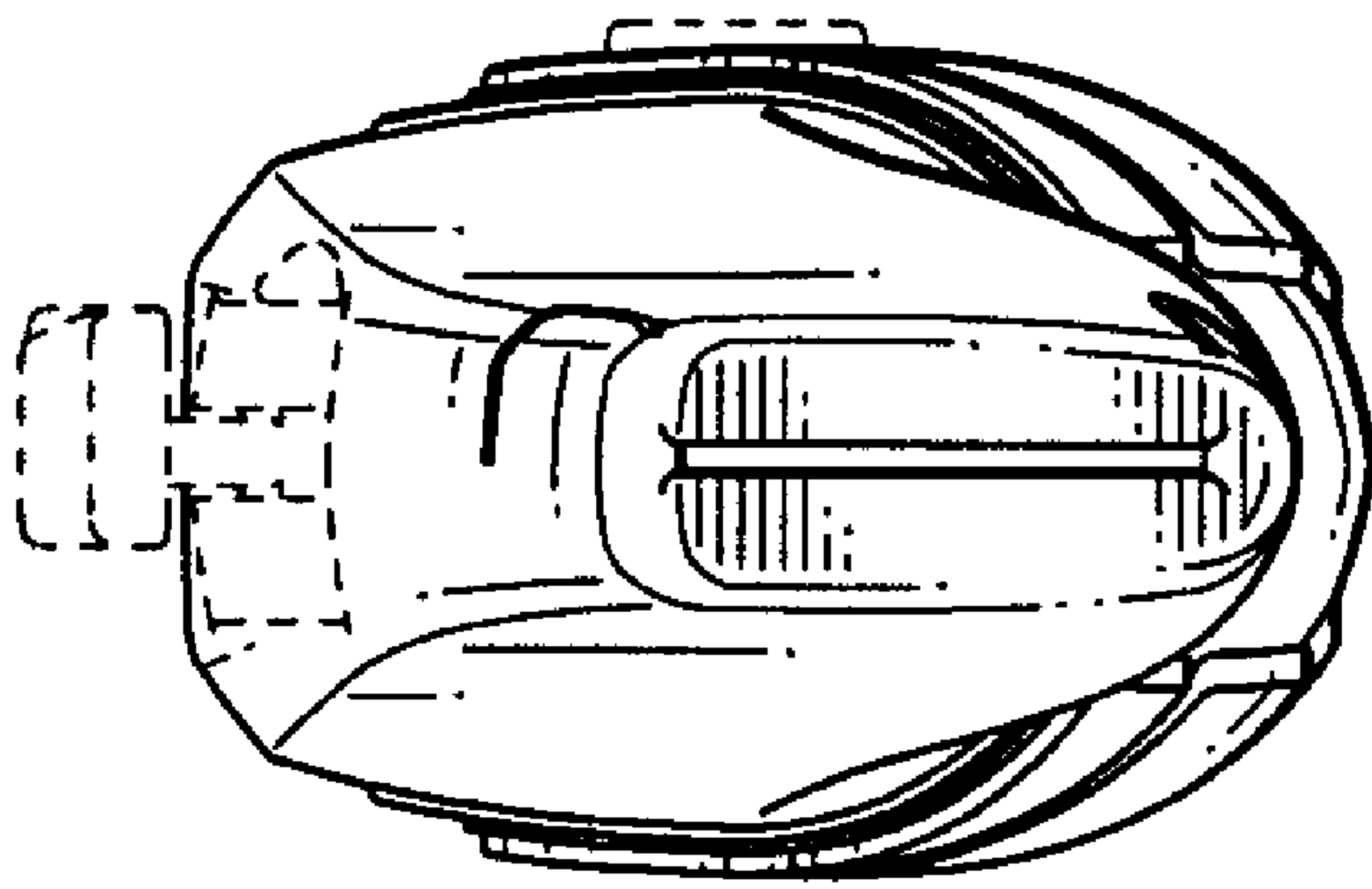
