DESCRIPTION

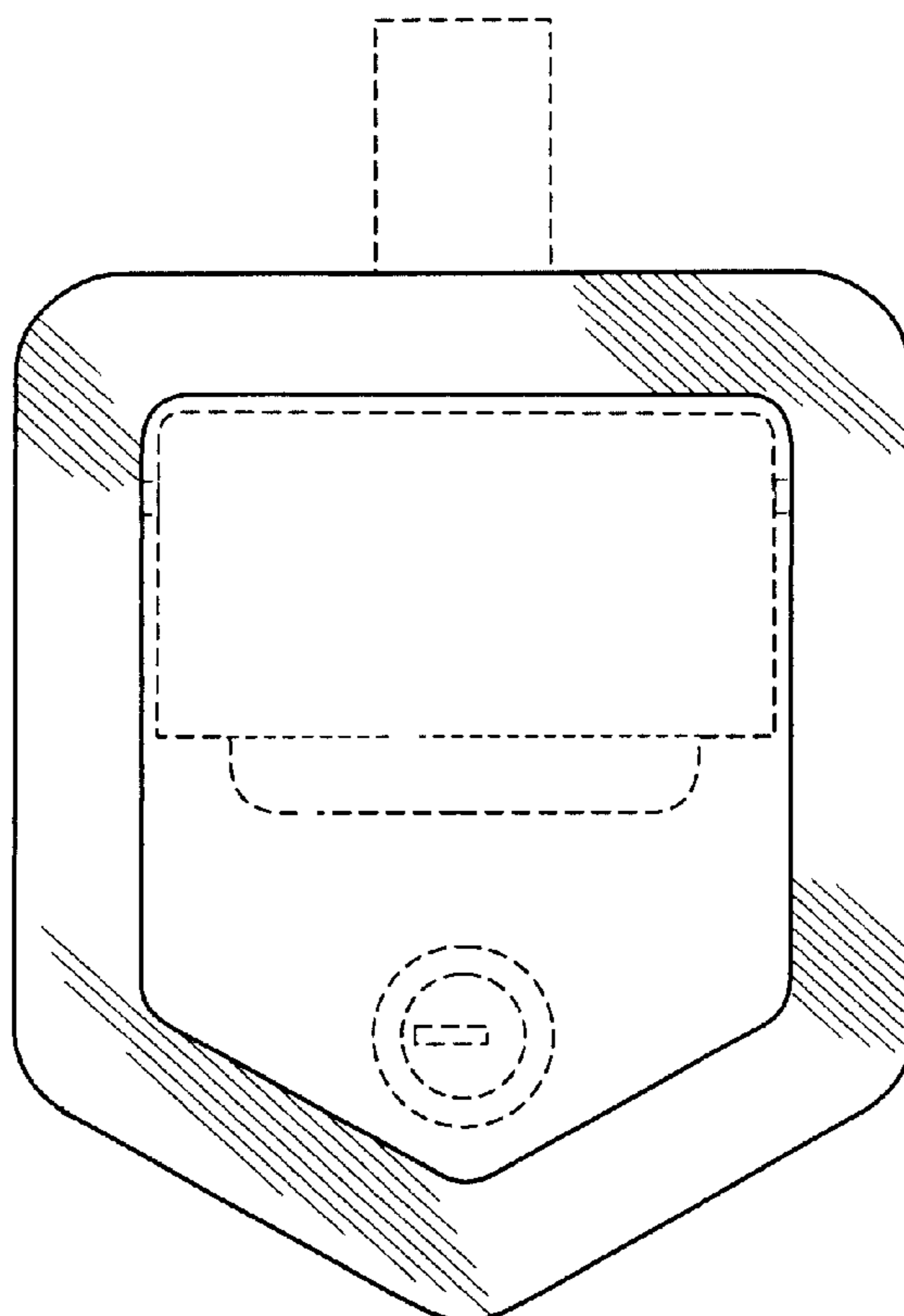
FIG. 1 is a top view of a paddle handle having a five sided flange;

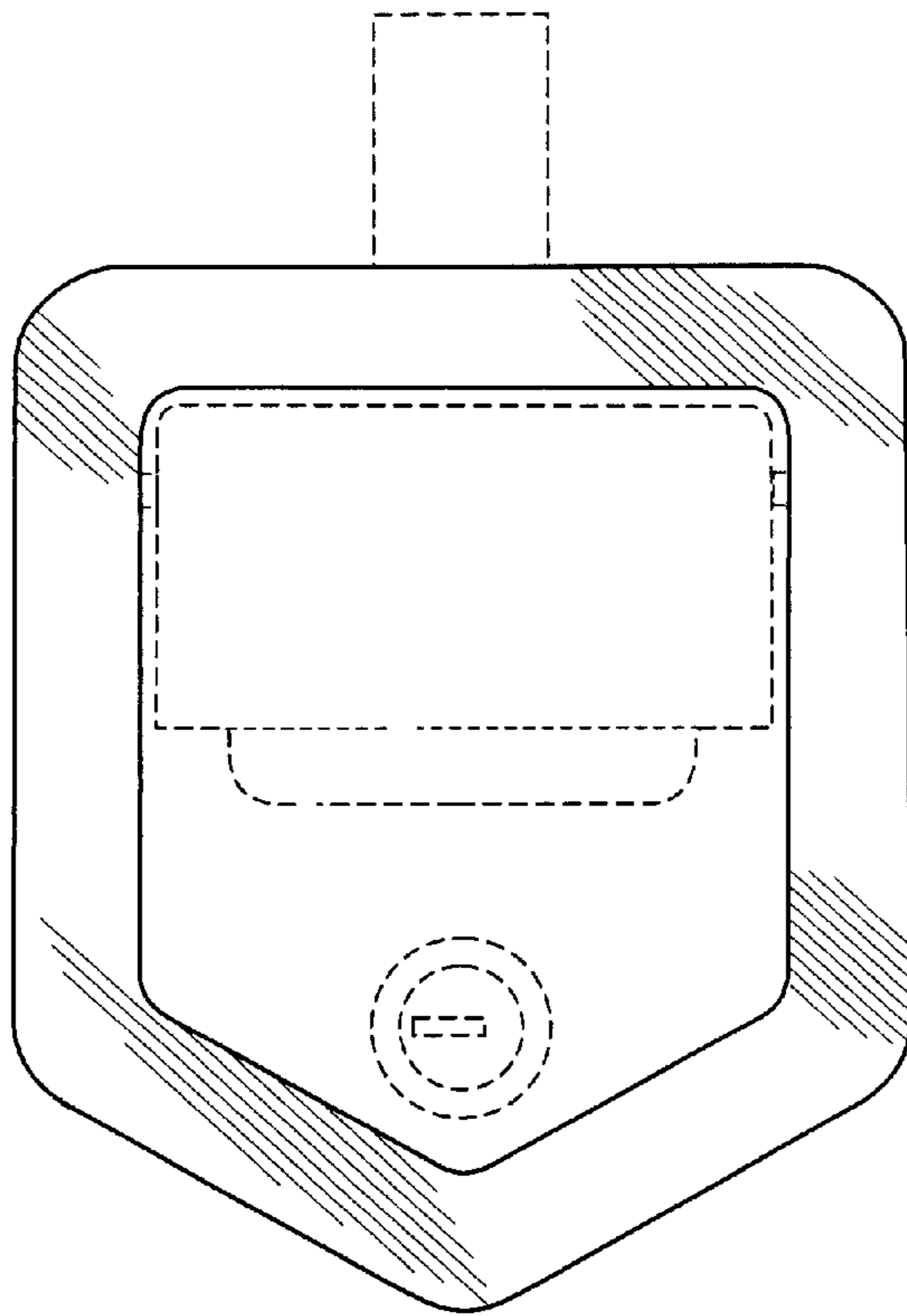

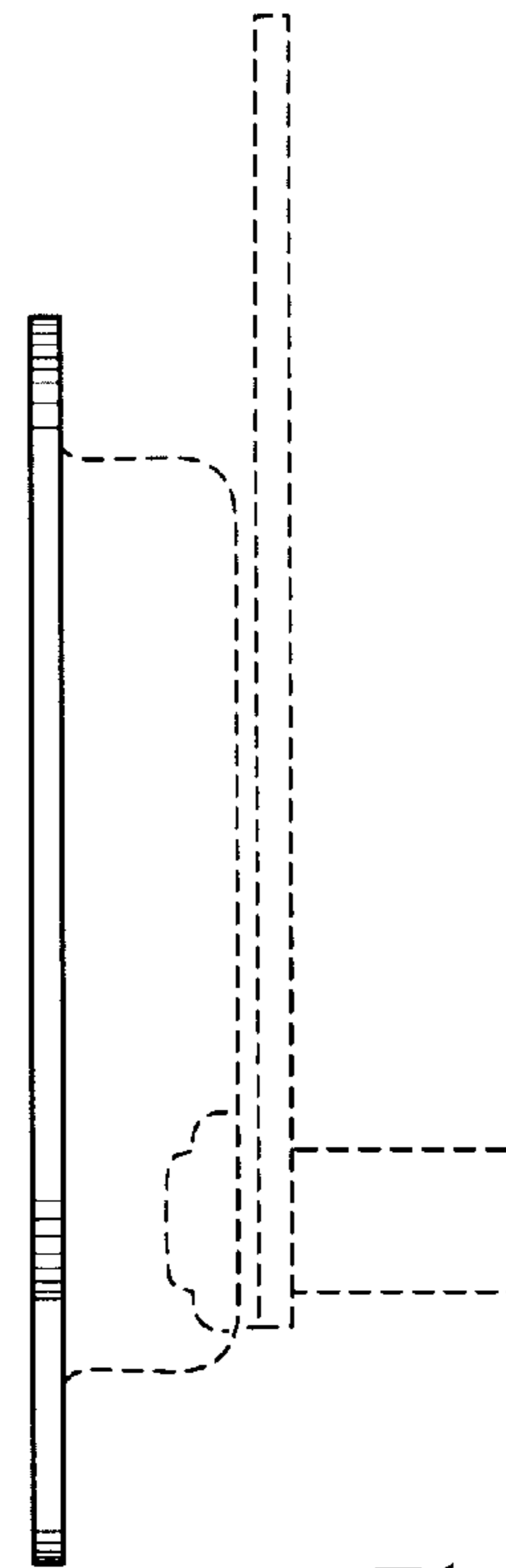

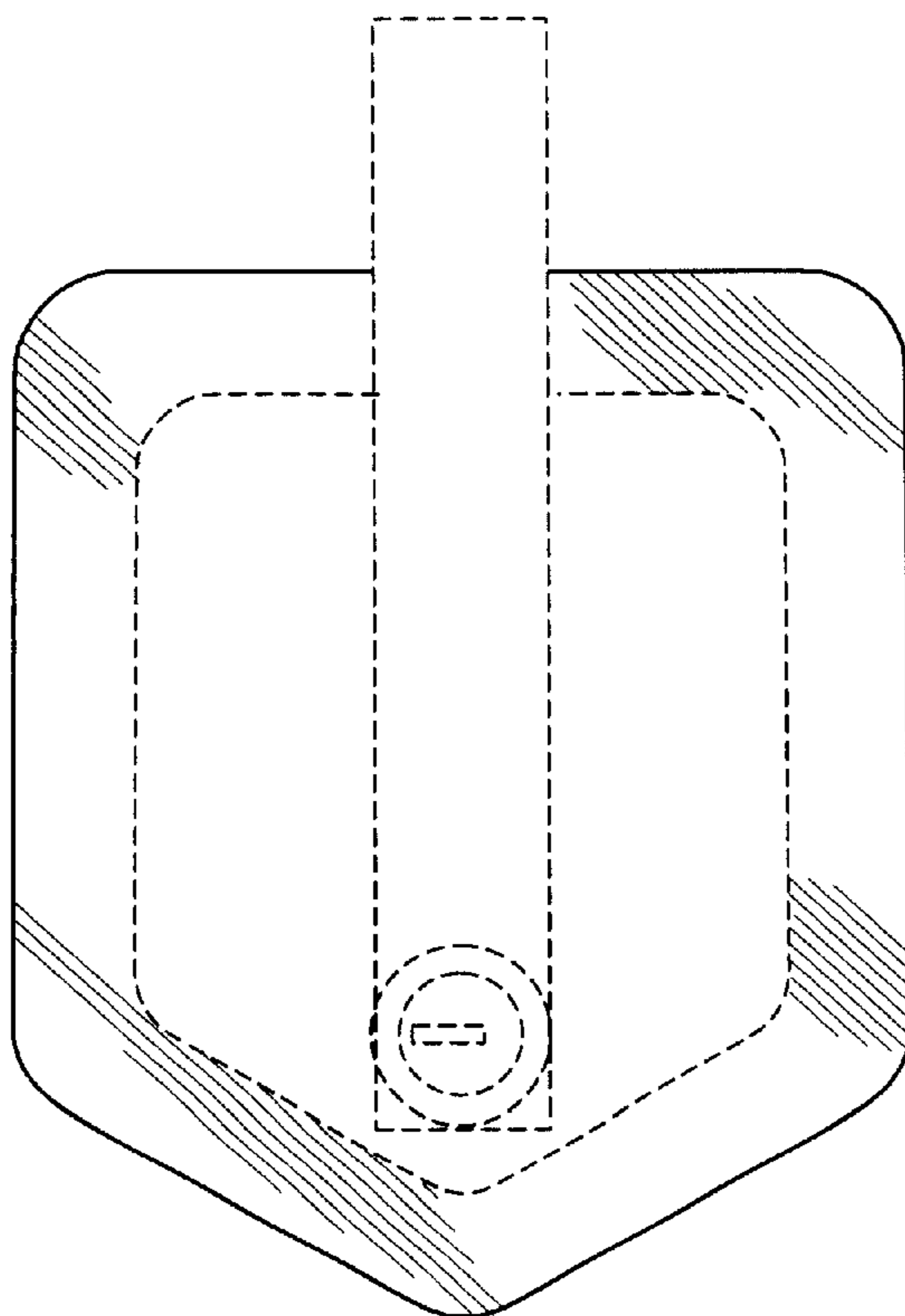
