The ornamental design for a key, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a key showing our new design;

FIG. 2 is a perspective view thereof;

FIG. 3 is a right side elevational view of the key of FIG. 1 the left side of which is a mirror image thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a bottom plan view thereof; and,

FIG. 6 is a rear view thereof.
