DESCRIPTION

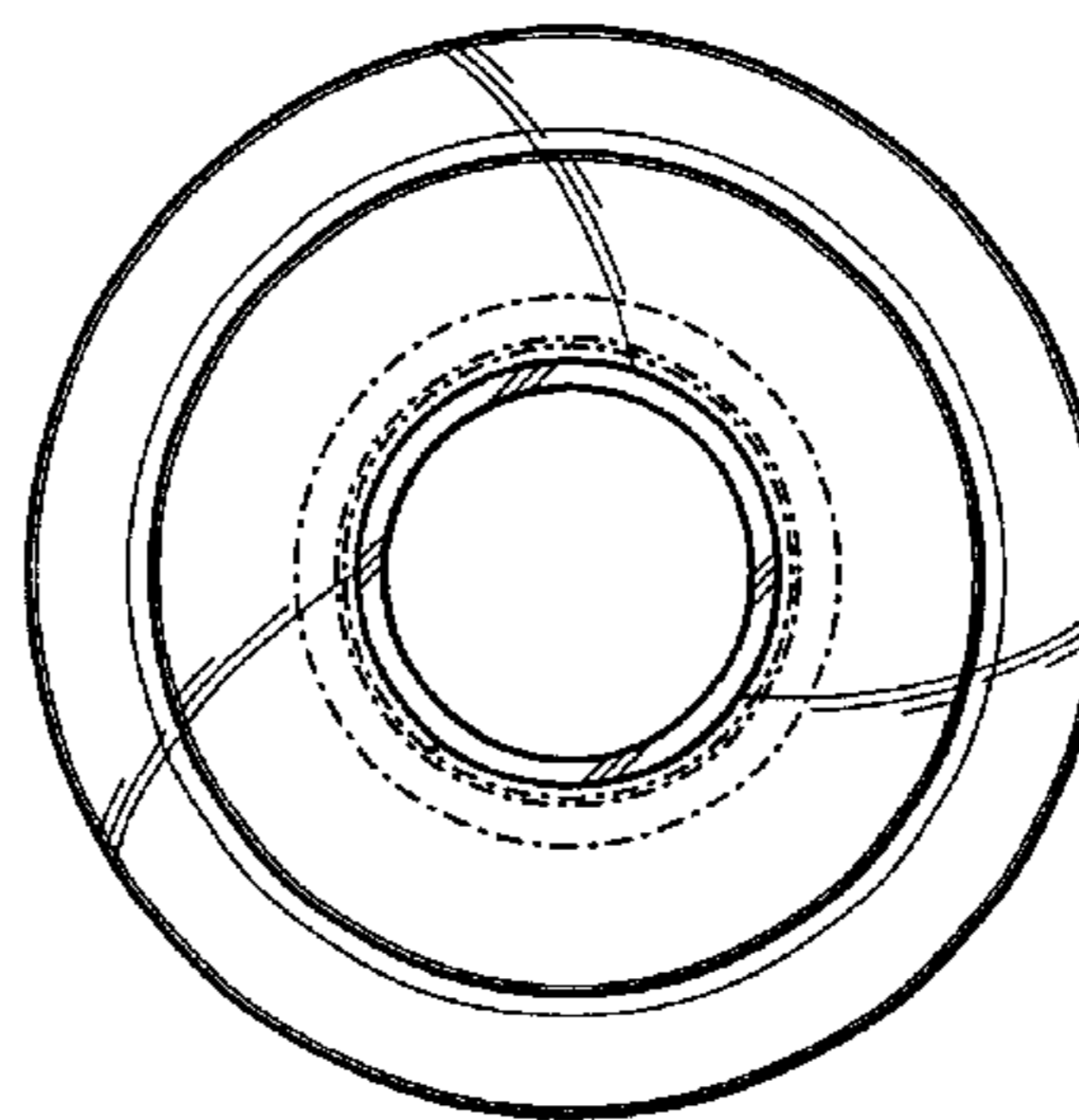
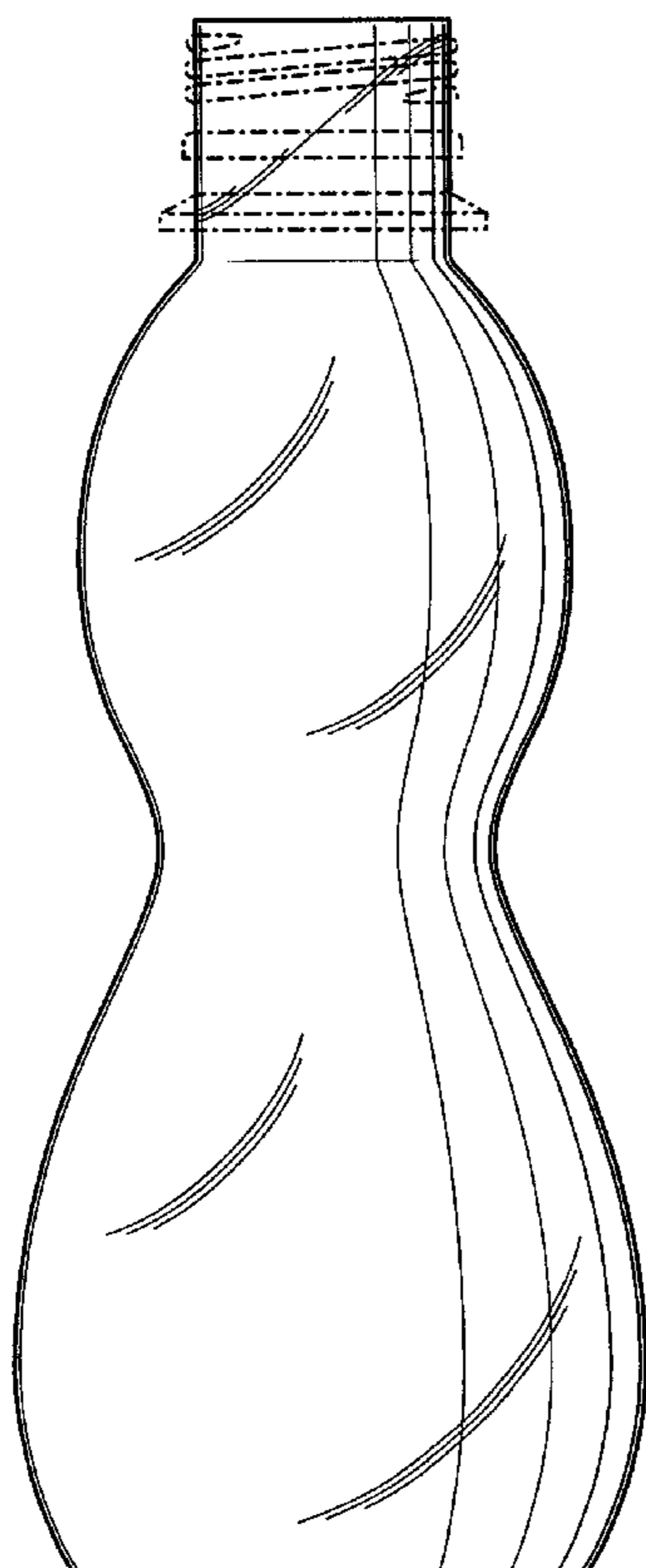
FIG. 1 is a perspective view of a bottle illustrating the design;

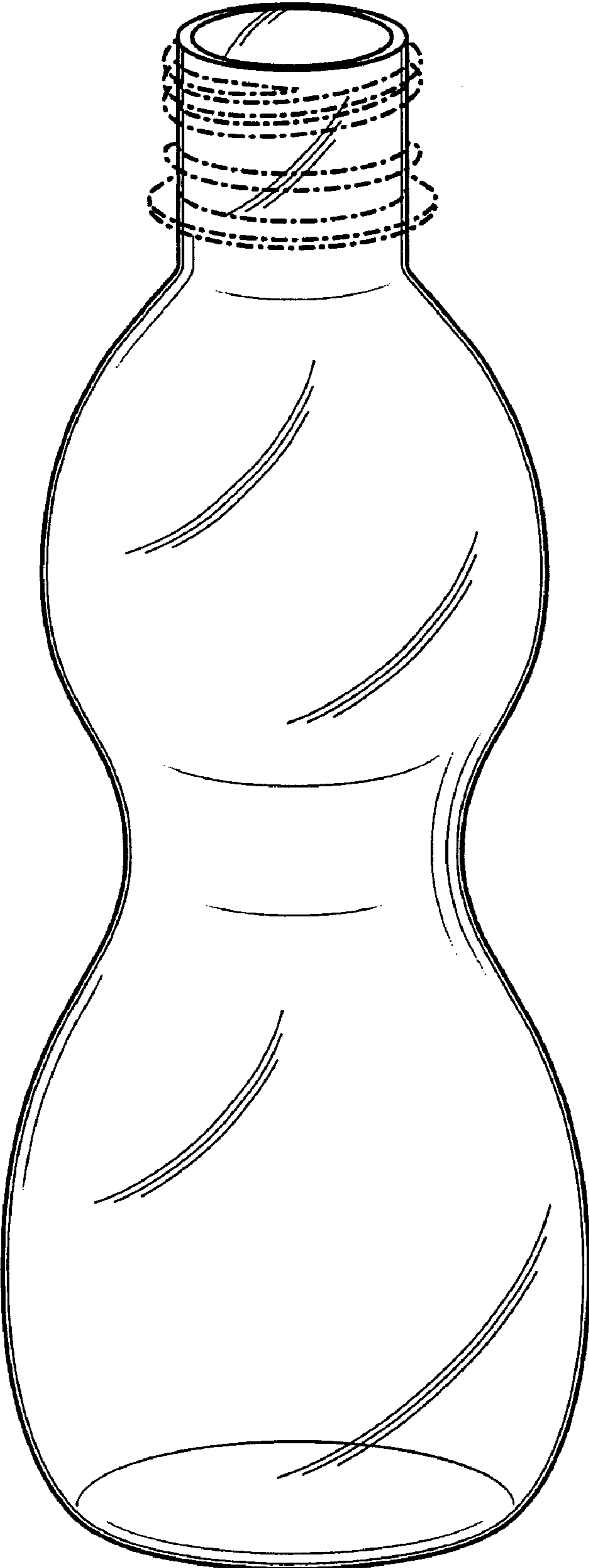

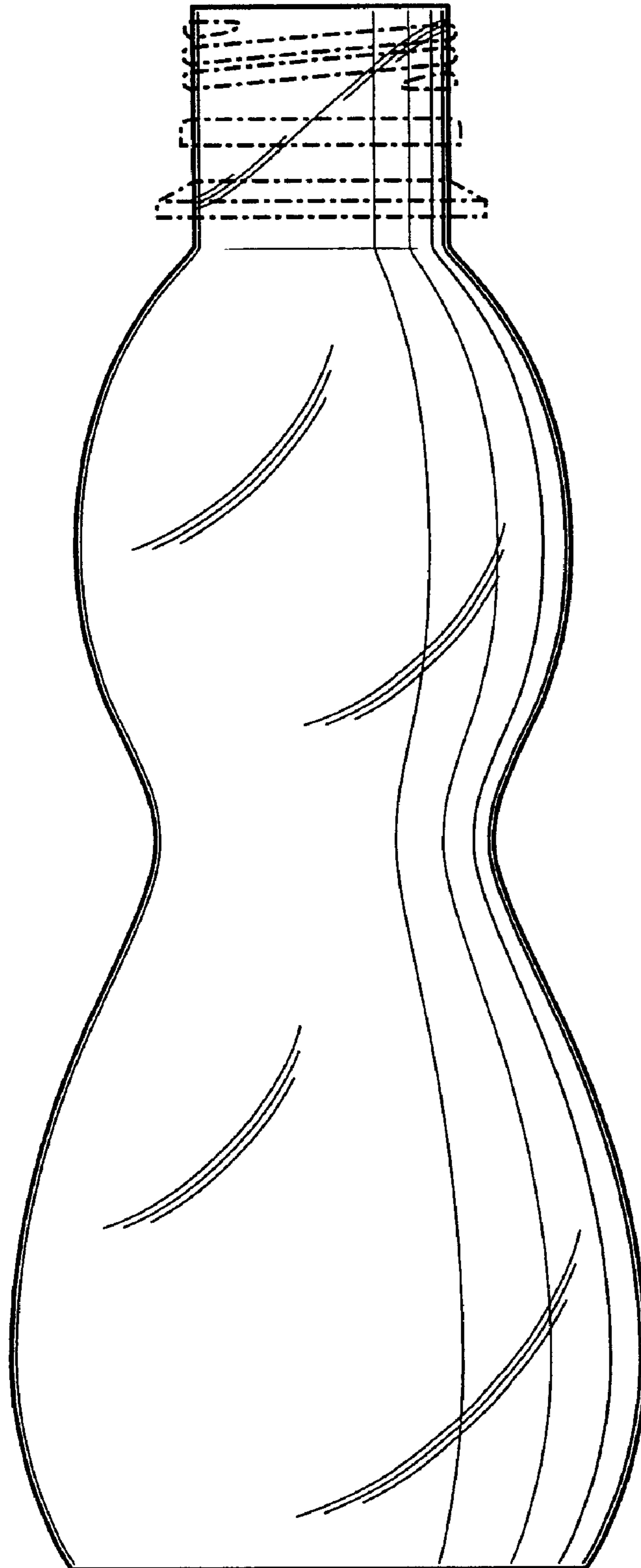

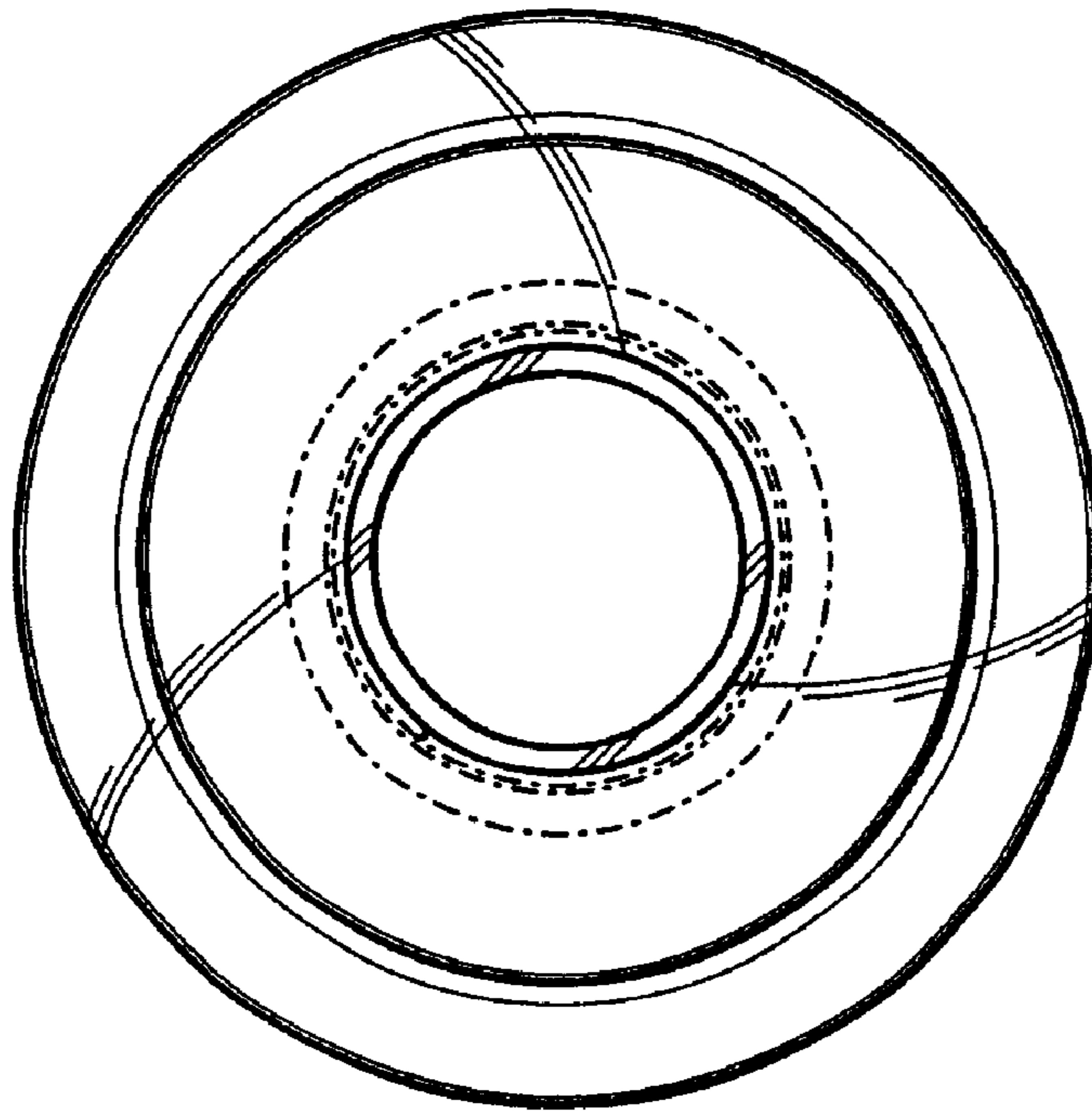

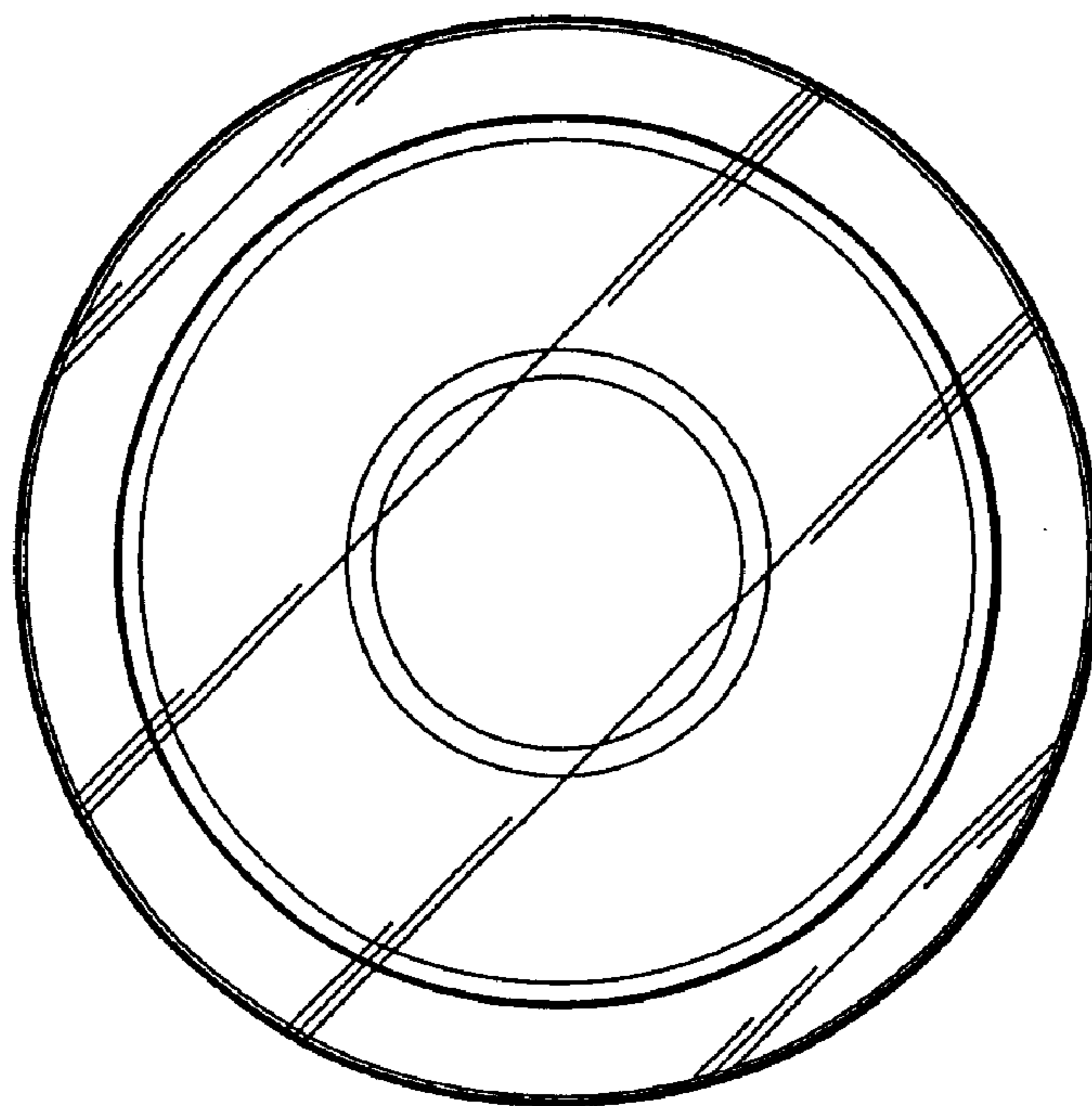
