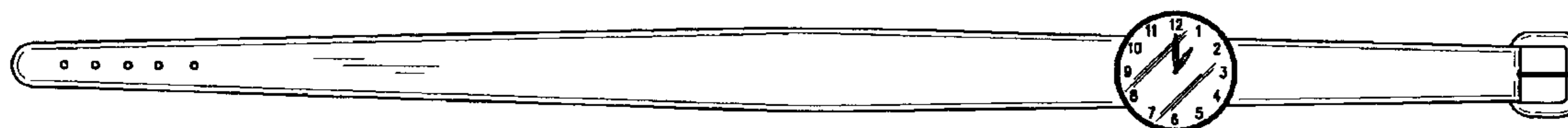
(57) **CLAIM**

The ornamental design for a necklace with timepiece, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a necklace with timepiece showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is an enlarged side view, taken from the left side of FIG. 1;
 FIG. 4 is an enlarged side view, taken from the right side of FIG. 1; and,
 FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image thereof.

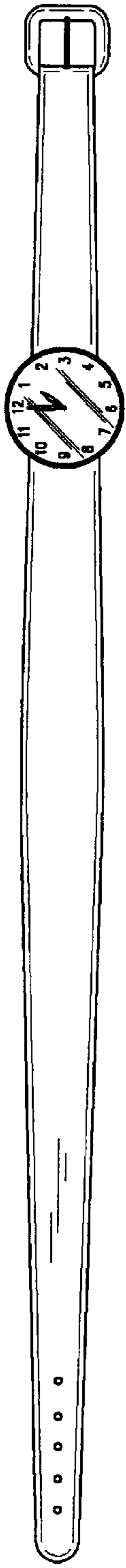

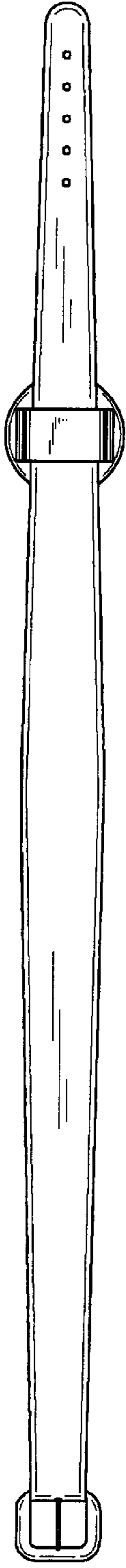

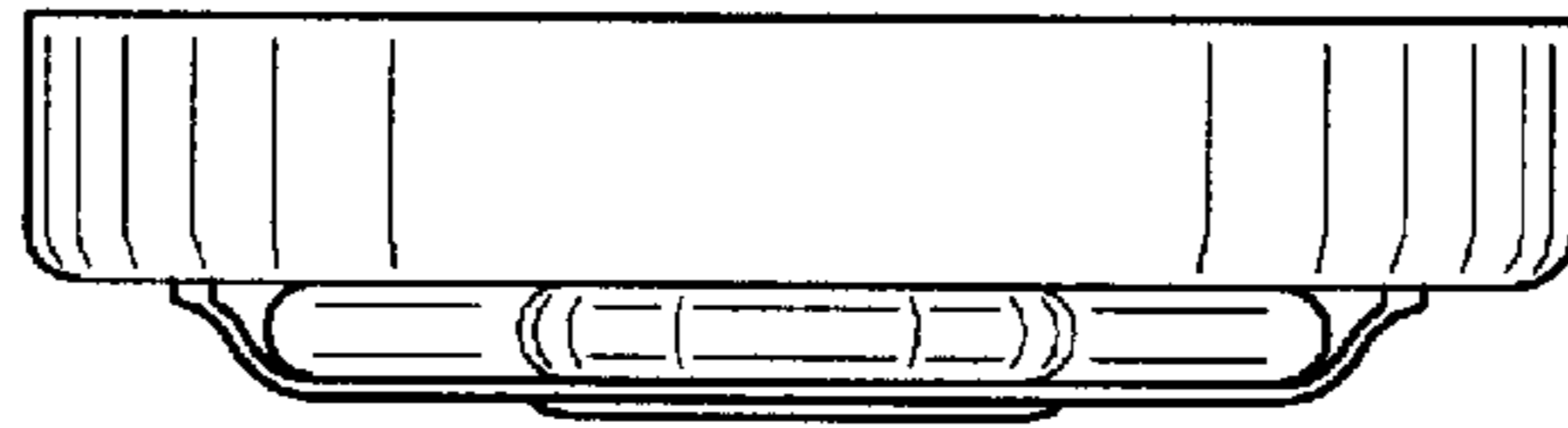

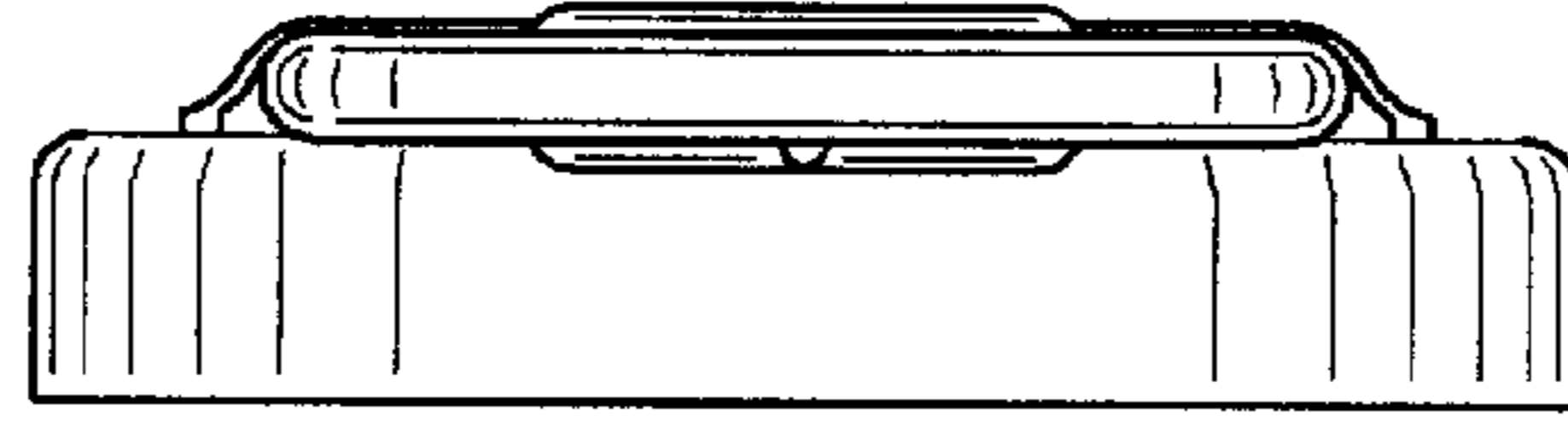
