(57) **CLAIM**

I claim the ornamental design for diamond ring with heart settings, as shown.

DESCRIPTION

FIG. 1 is a perspective view from the upper left side of the diamond ring with heart settings.

FIG. 2 is a left side elevational view of the ring.

FIG. 3 is a perspective view from the upper right side of the diamond ring with heart settings; and,

FIG. 4 is a right side view of the ring.

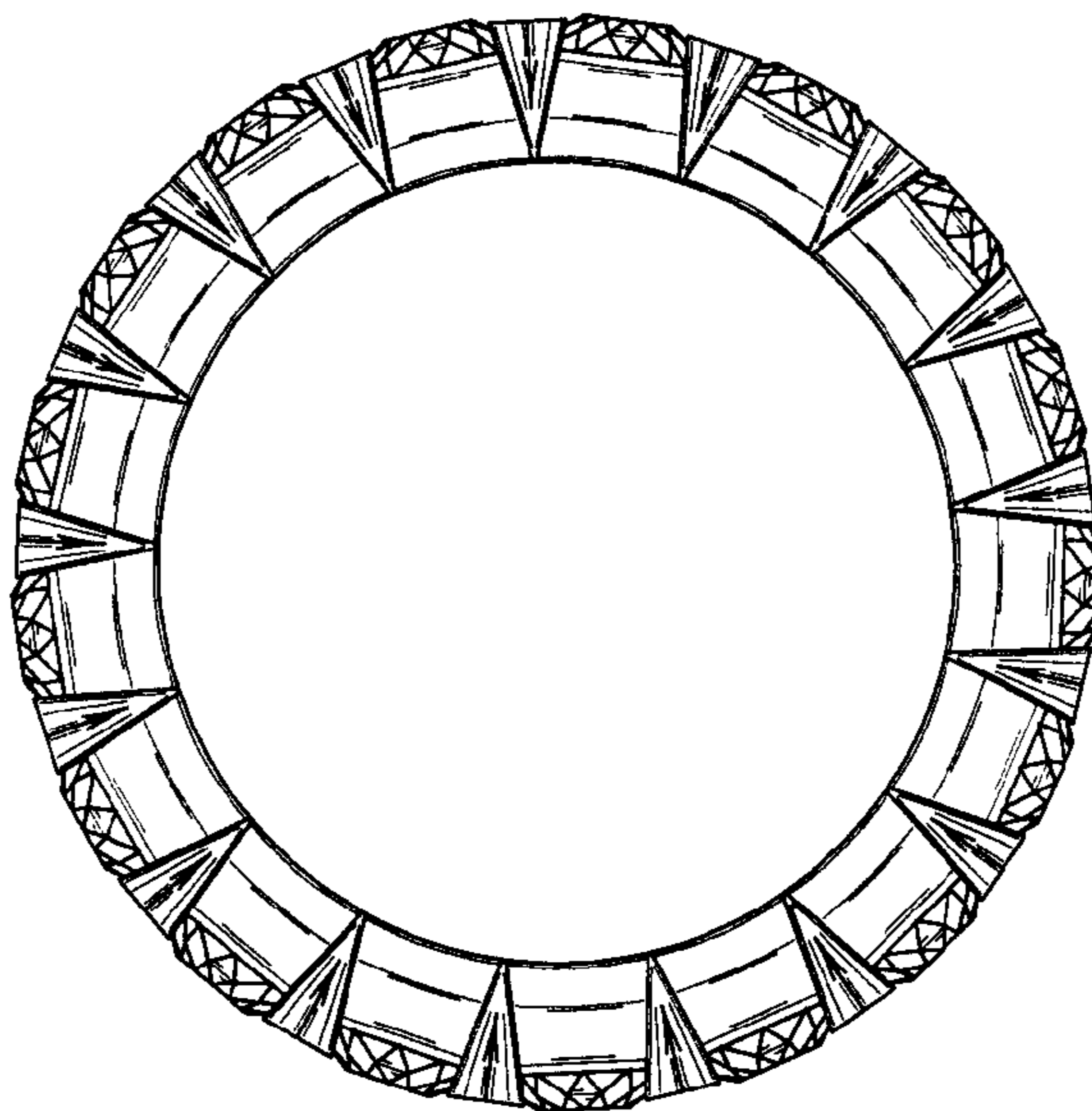

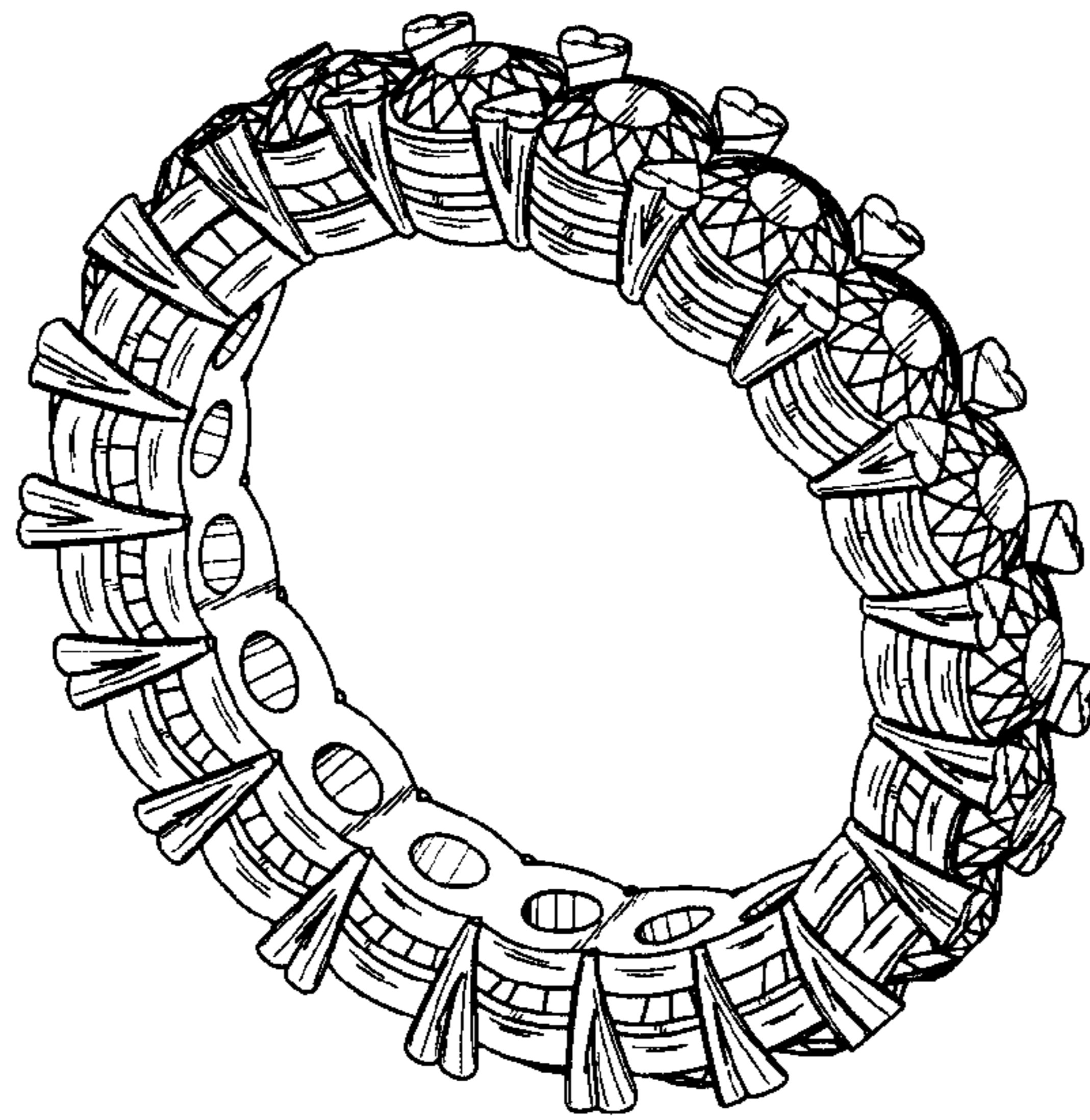

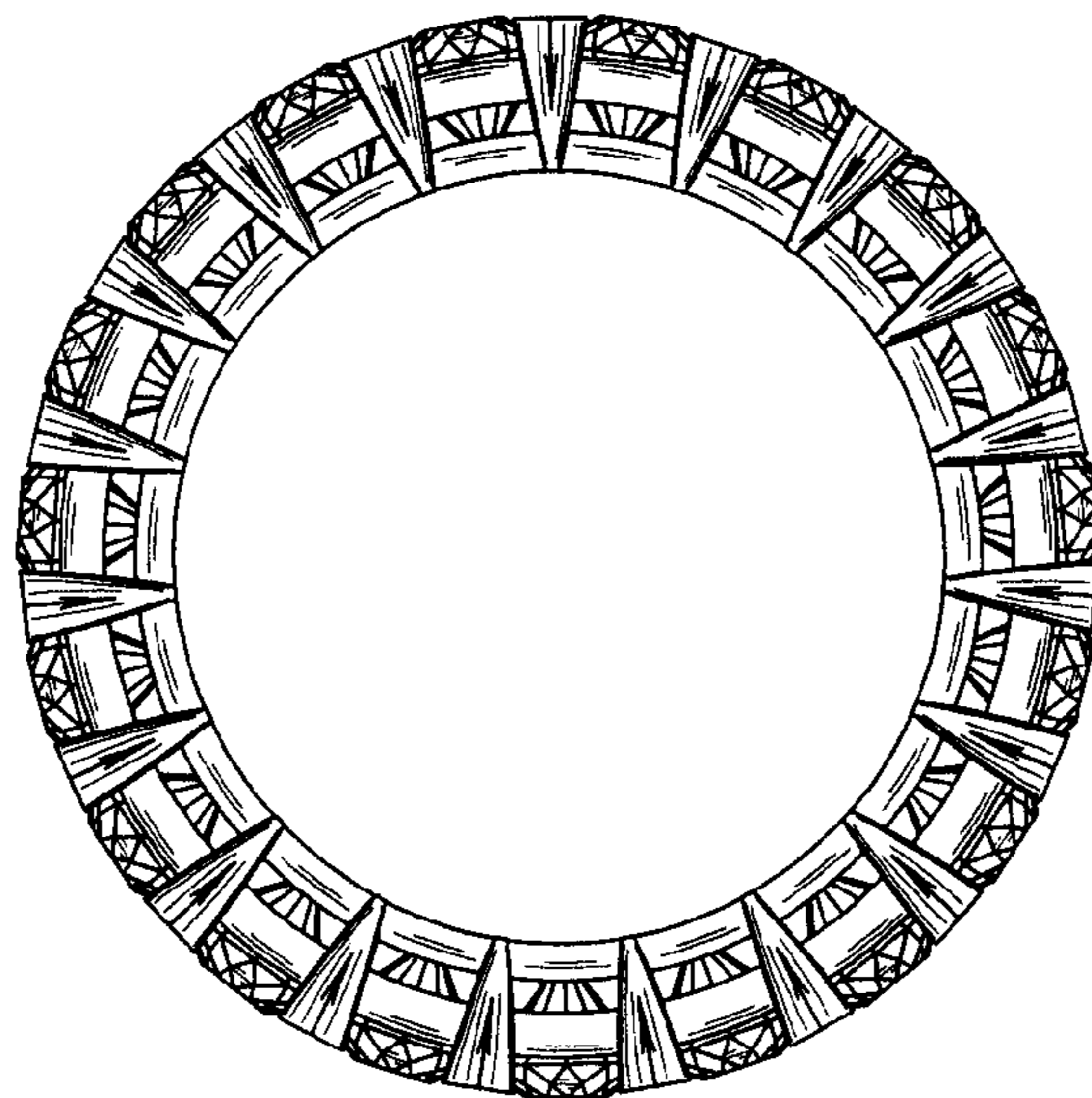
