The ornamental design for the coin, as shown.

DESCRIPTION

FIG. 1: is a front view of the coin showing my new design;

FIG. 2: is a rear view thereof;

FIG. 3: is a rear view of a second embodiment, the only difference being the printed matter;

FIG. 4: is a rear view of a third embodiment, the only difference being the printed matter;

FIG. 5: is a rear view of a fourth embodiment, the only difference being the printed matter;

FIG. 6: is a rear view of a fifth embodiment, the only difference being the printed matter; and

FIG. 7: is a rear view of a sixth embodiment, the only difference being the printed matter. Note that the front view in all embodiments is FIG. 1.

FIG. 8. Front View of the seventh embodiment of the Nightingale coin. Note using a different image of Florence Nightingale.

FIG. 9. Rear view of the eighth embodiment. Note the difference is the image of the healing lamp and the identified nursing attributes if In the Name of Courage, Dedication, Perseverance.

FIG. 10. Rear view of the ninth embodiment. Note only difference is the identified nursing attributes In the Name of Courage, Integrity, Truth. (Front view is the same as in FIG. 8).

FIG. 11. Rear view of the tenth embodiment. In the Name of Courage, Humility, Justice (Front view is the same as in FIG. 8).

FIG. 12. Rear view of the eleventh embodiment. In the Name of Inspiration, Reflection, Wisdom. (Front view is the same as in FIG. 8).

FIG. 13. Rear view of the twelfth embodiment. In the Name of Intuition, Intelligence, Wisdom. (Front view is the same as in FIG. 8); and,

FIG. 14. Rear view thirteenth embodiment. In the Name of Clarity, Vision, Wisdom. (Front view is the same as in FIG. 8).
