(57) **CLAIM**

The ornamental design for a front bumper for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a left-front, perspective view of a front bumper for an automobile of our new design:

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a right-side view of our new design, the left-side view being a mirror image thereof;

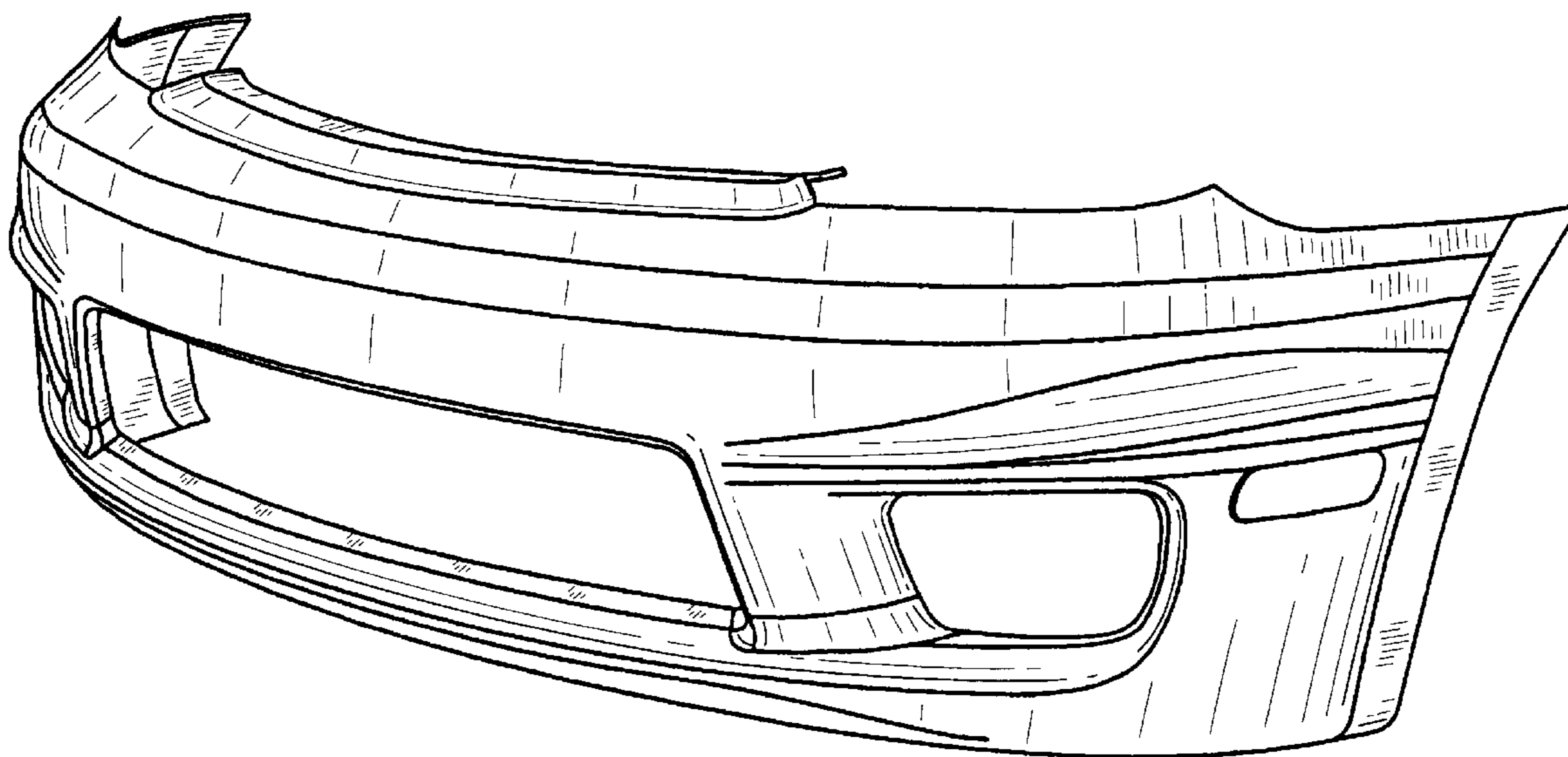
FIG. 7 is a cross-sectional view of our new design at 7—7 in FIG. 2;

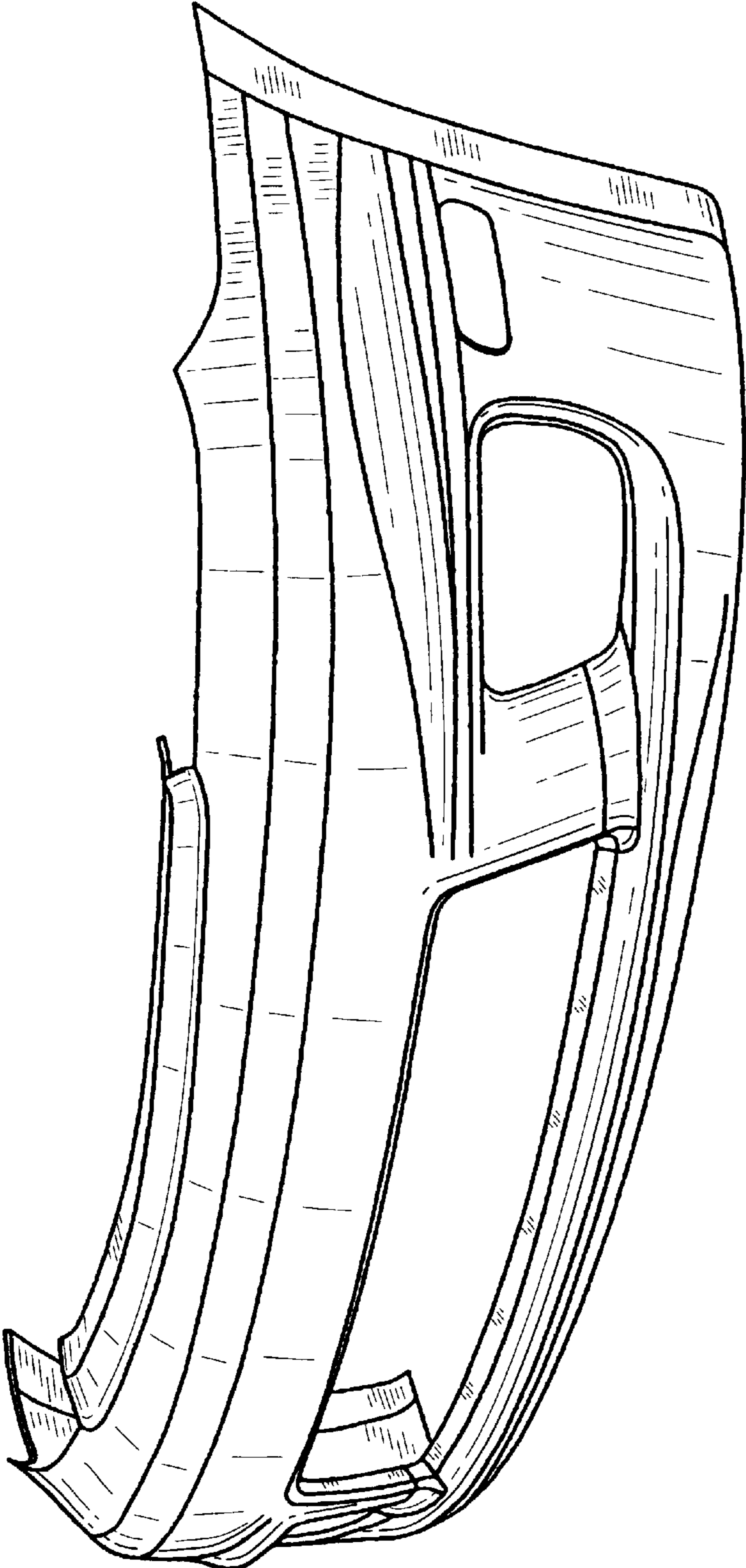

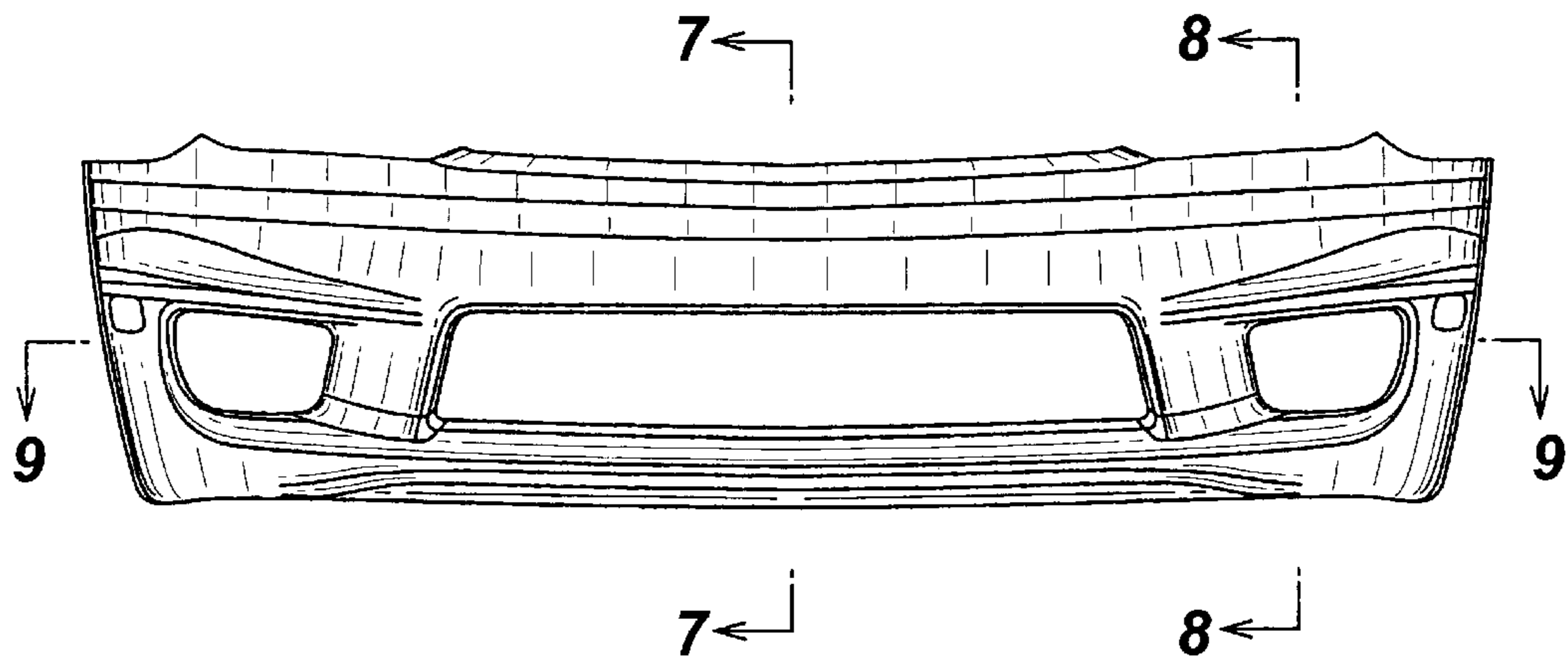

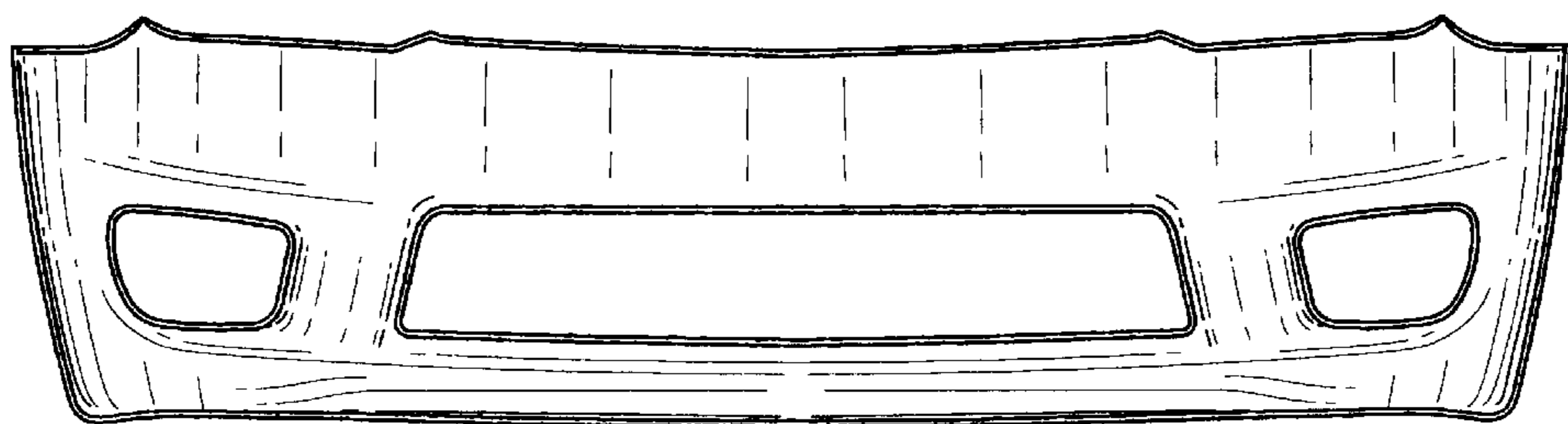

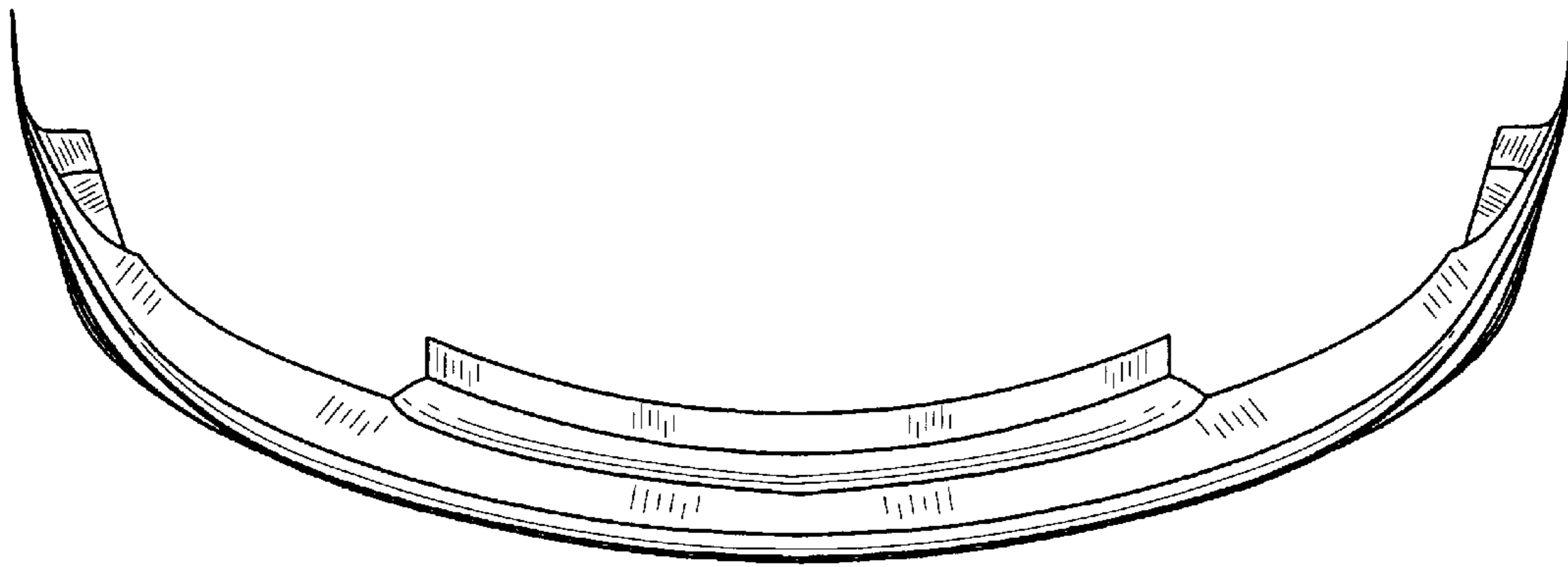

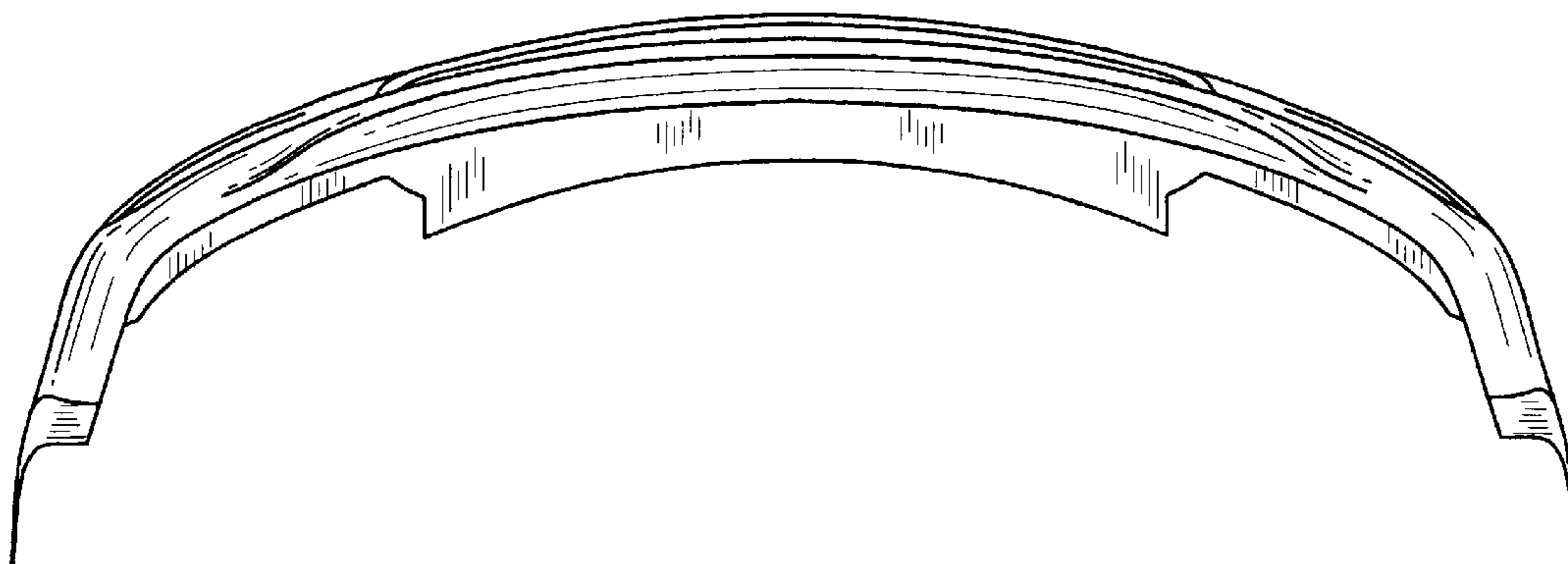

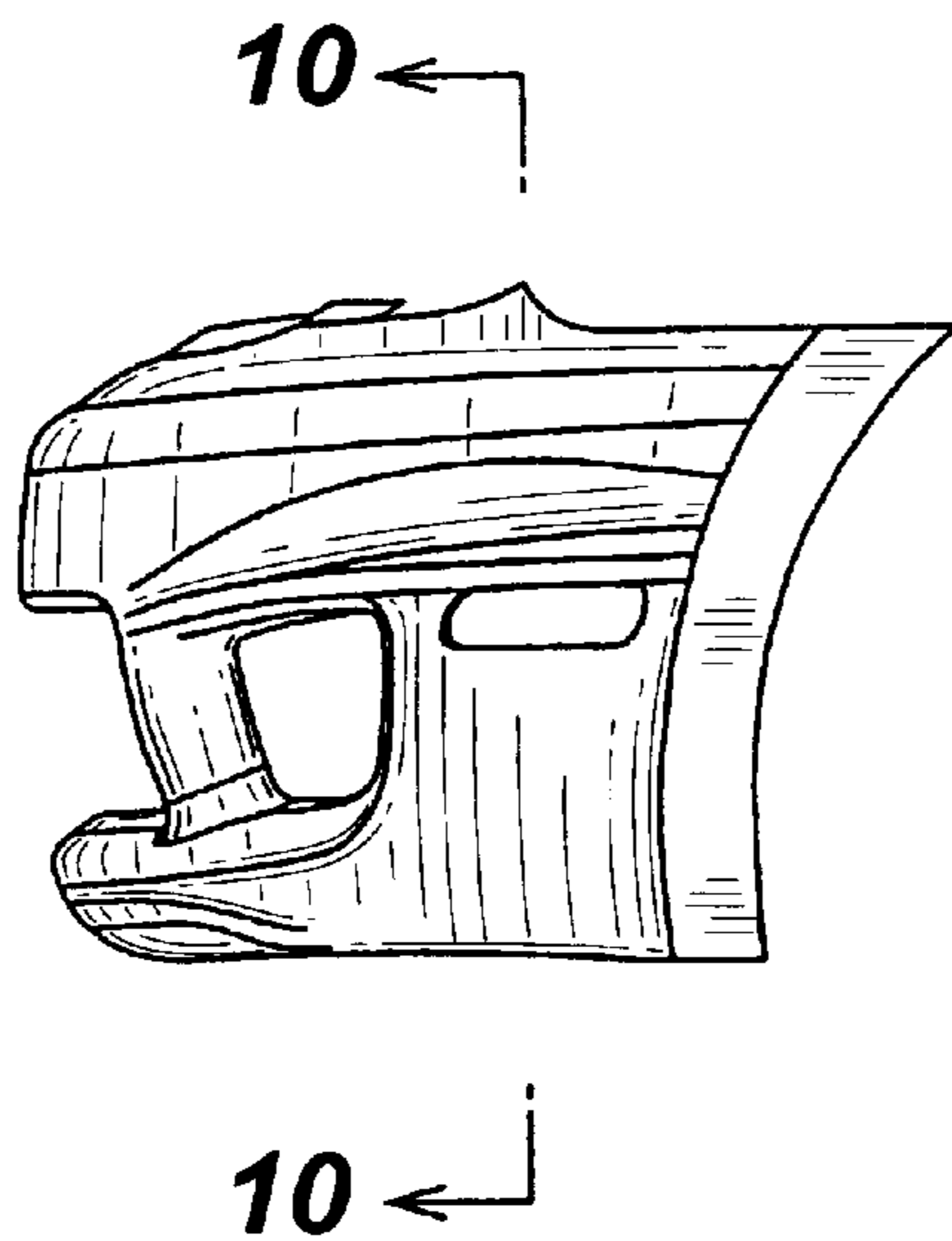

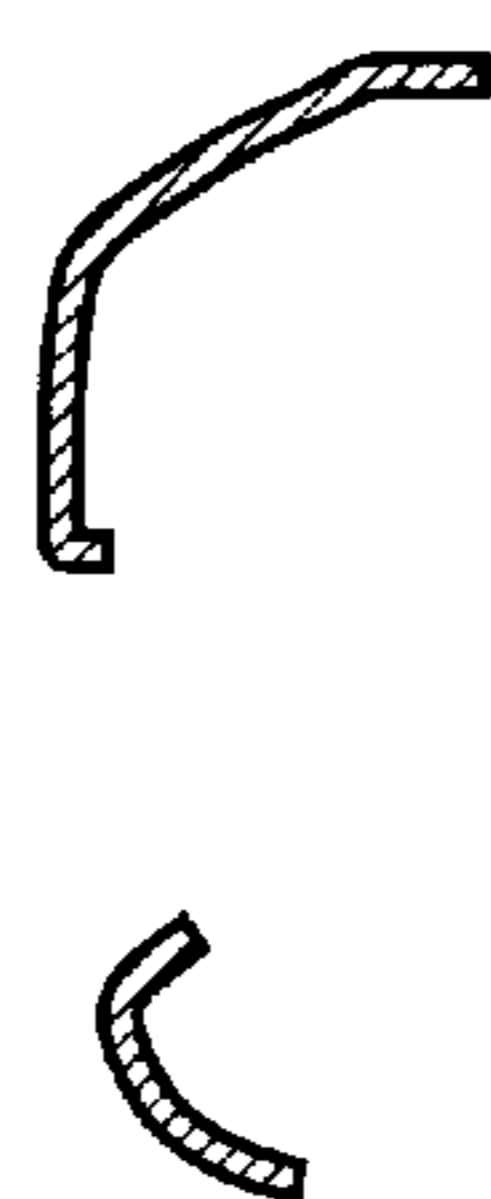
