(57) **CLAIM**

The ornamental design for a clutch and brake lever for motorcycles and bicycles, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the design for a clutch and brake lever for motorcycles and bicycles, with the connecting head portion of the clutch lever shown in broken lines for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a top view of FIG. 1;

FIG. 3 is a back view of FIG. 1;

FIG. 4 is a bottom view of FIG. 1;

FIG. 5 is an end view of the left end of FIG. 1;

FIG. 6 is an end view of the right end of FIG. 1;

FIG. 7 is a top view of a second environment of the design for a clutch and brake lever for motorcycles and bicycles, with the connecting head portion of the brake lever shown in broken lines for illustrative purposes only and forming no part of the claimed design;

FIG. 8 is a back view of FIG. 7;

FIG. 9 is a front view of FIG. 7;

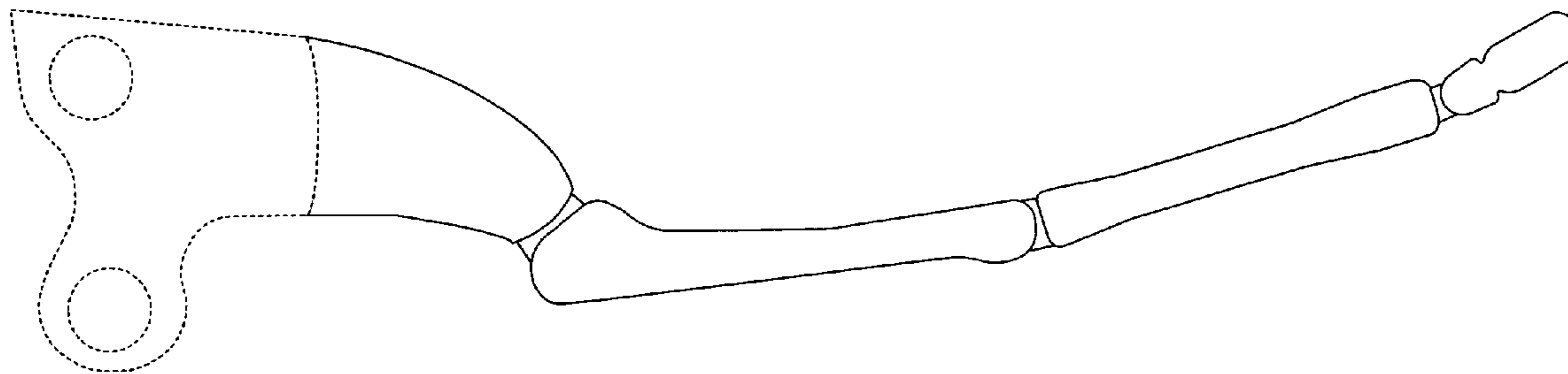
FIG. 10 is a bottom view of FIG. 7;

FIG. 11 is an end view of the right end of FIG. 7; and,

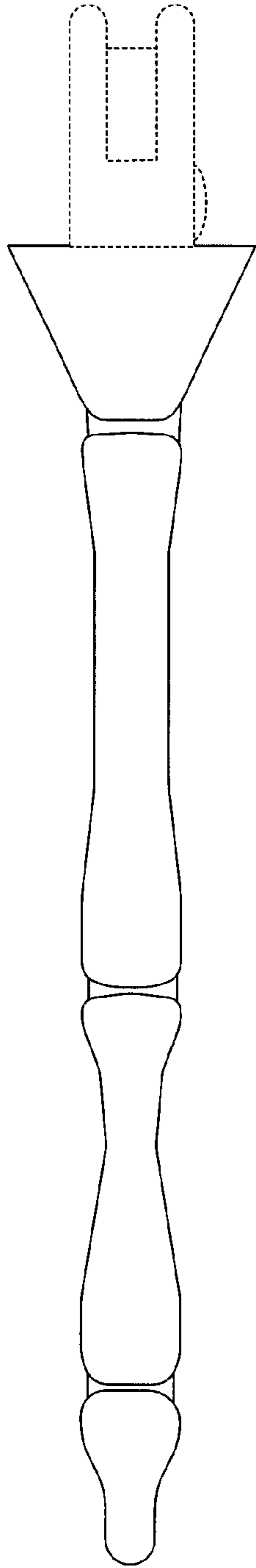

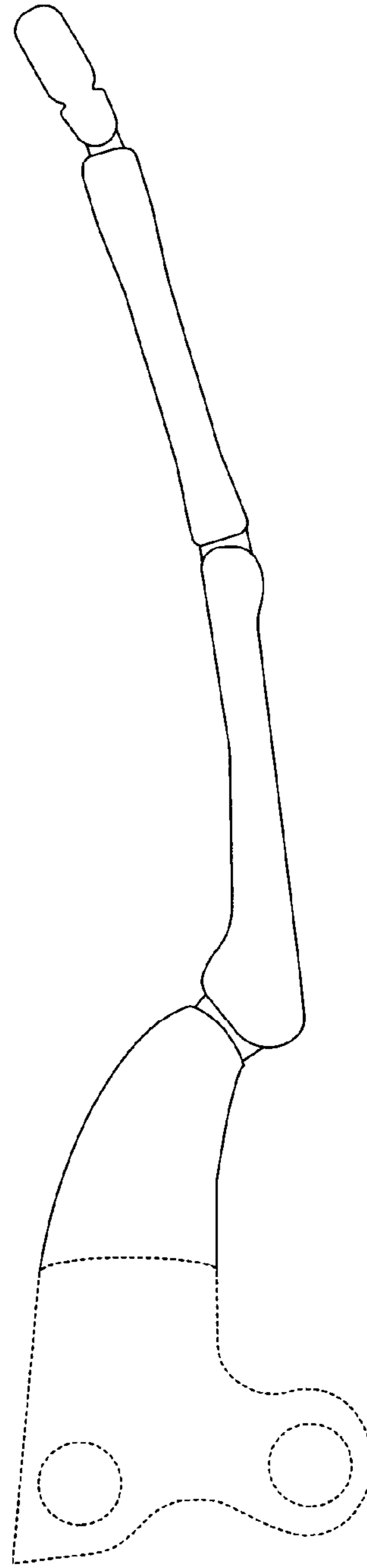

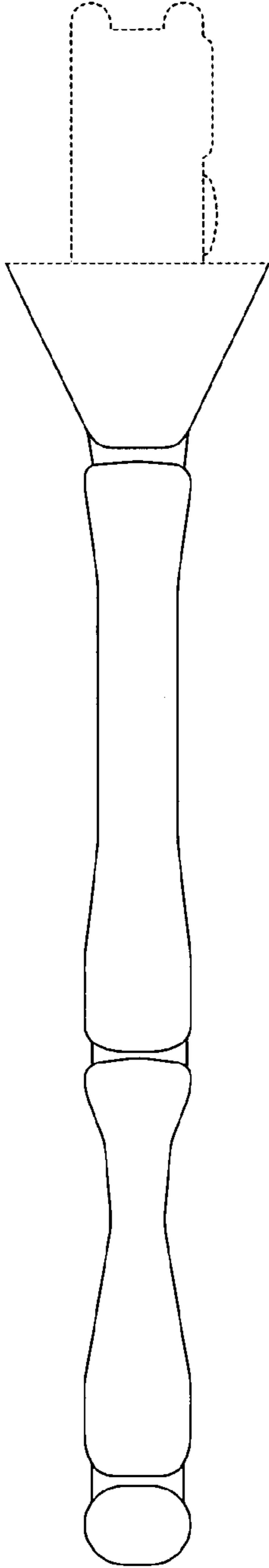

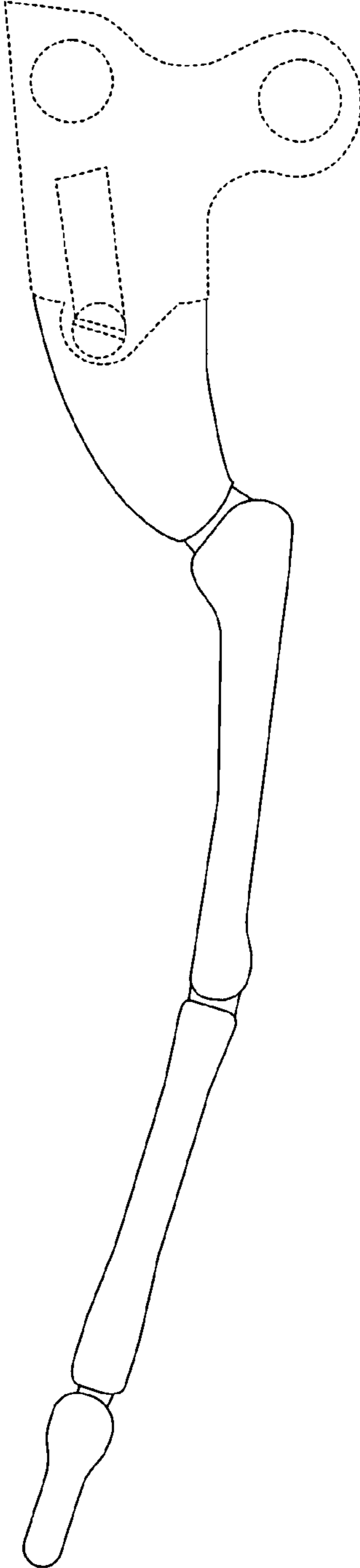

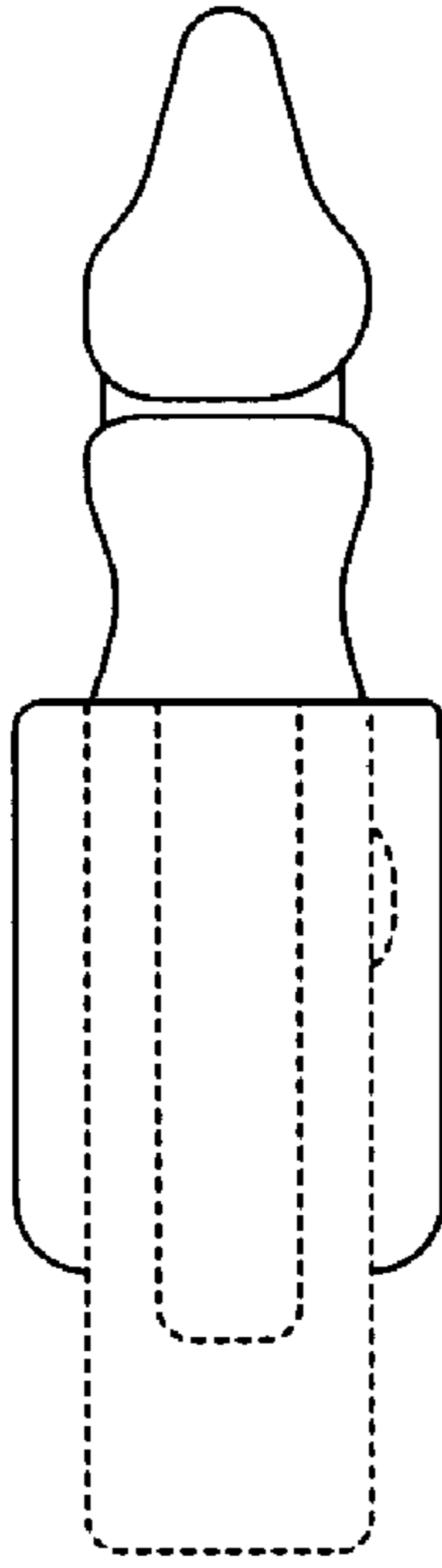

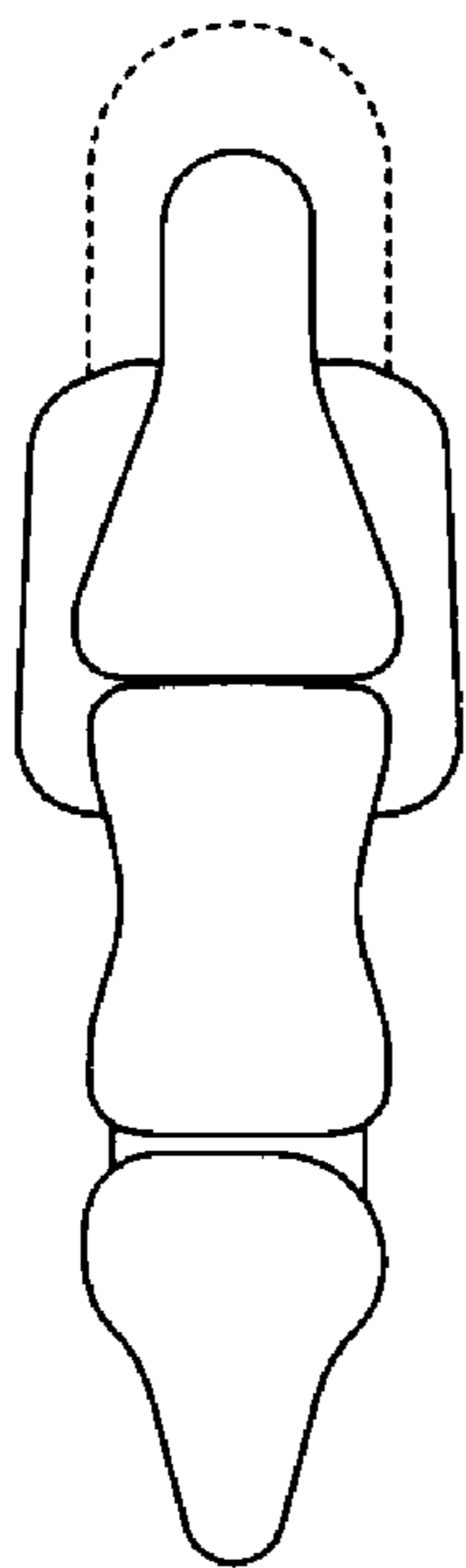

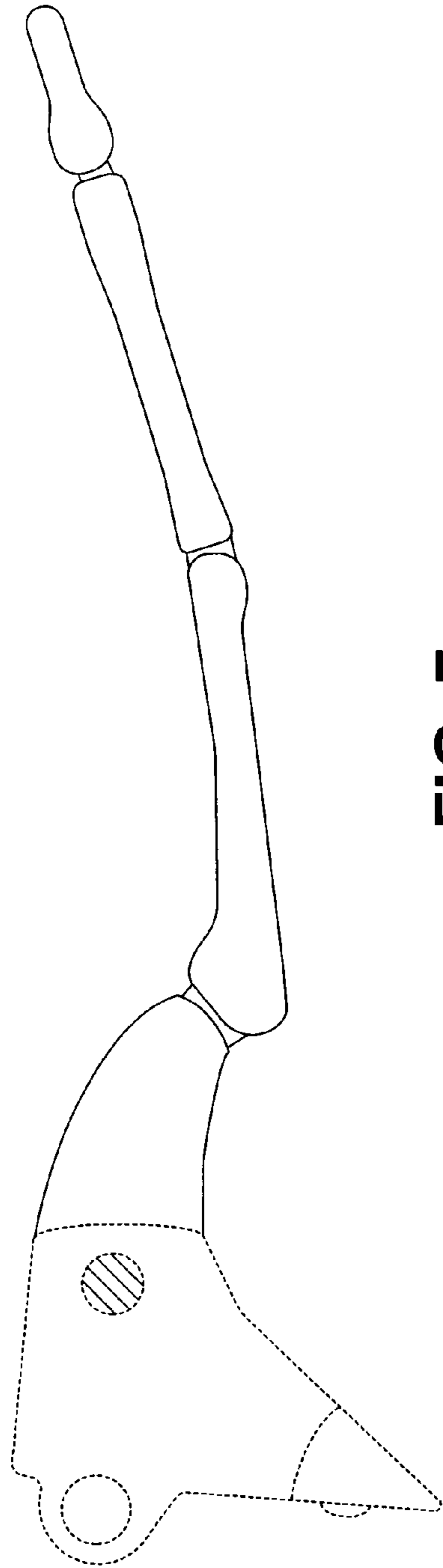

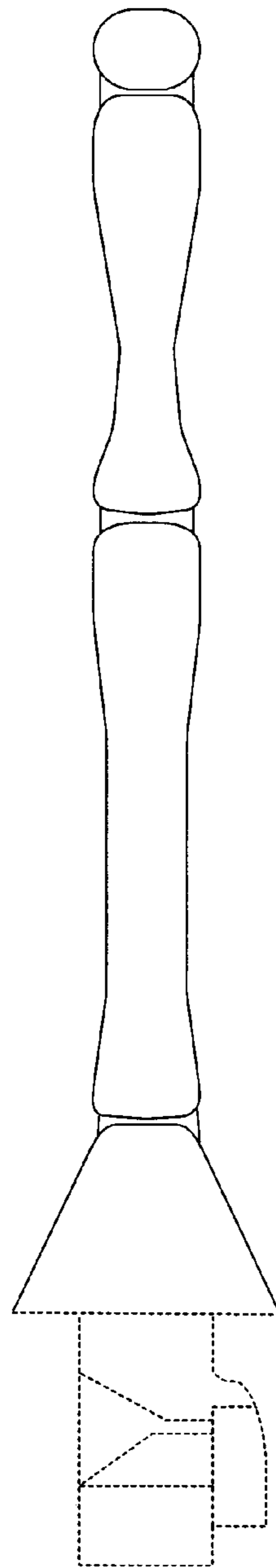

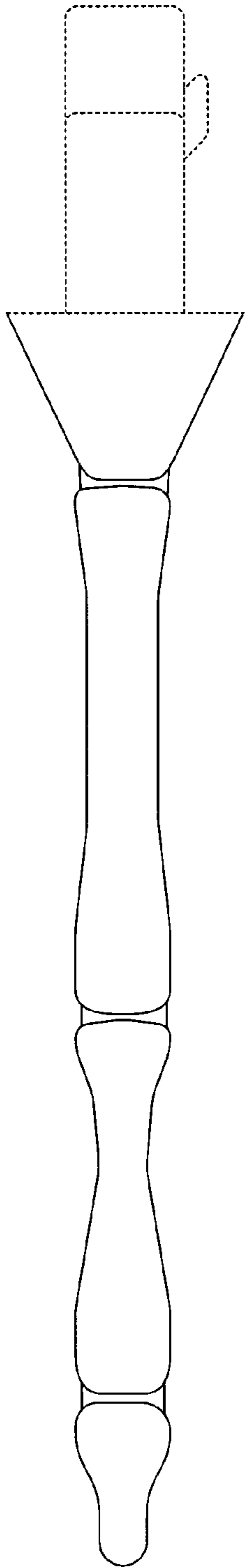

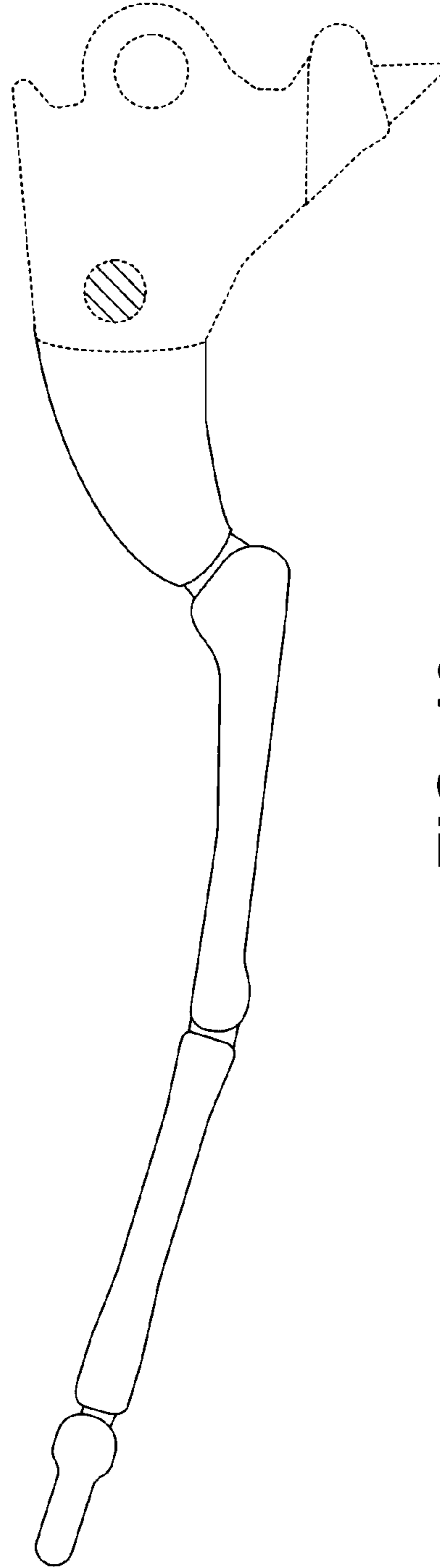

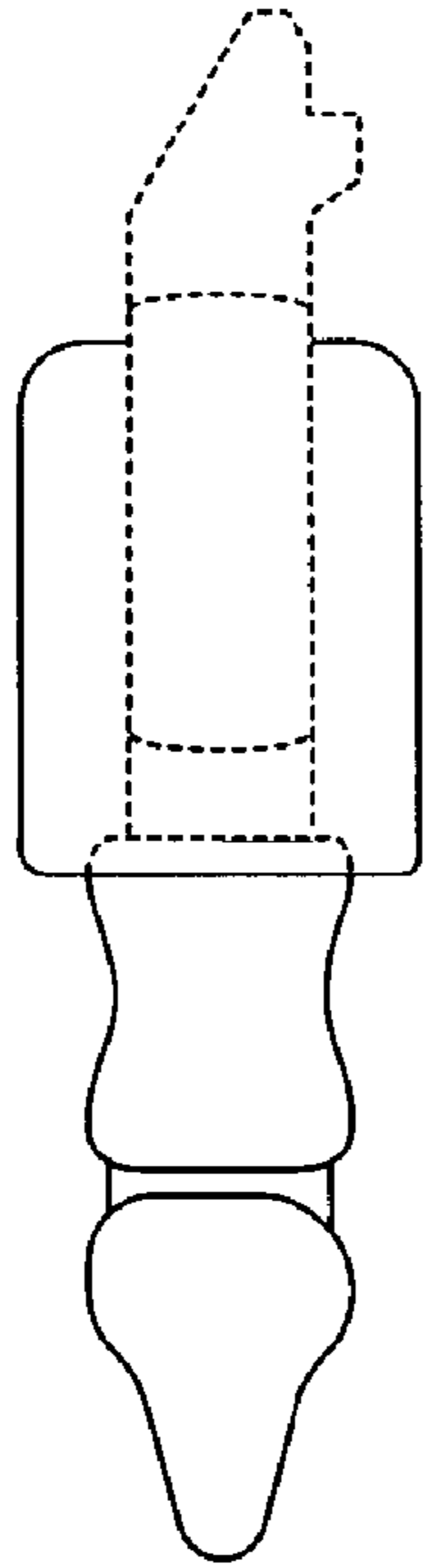

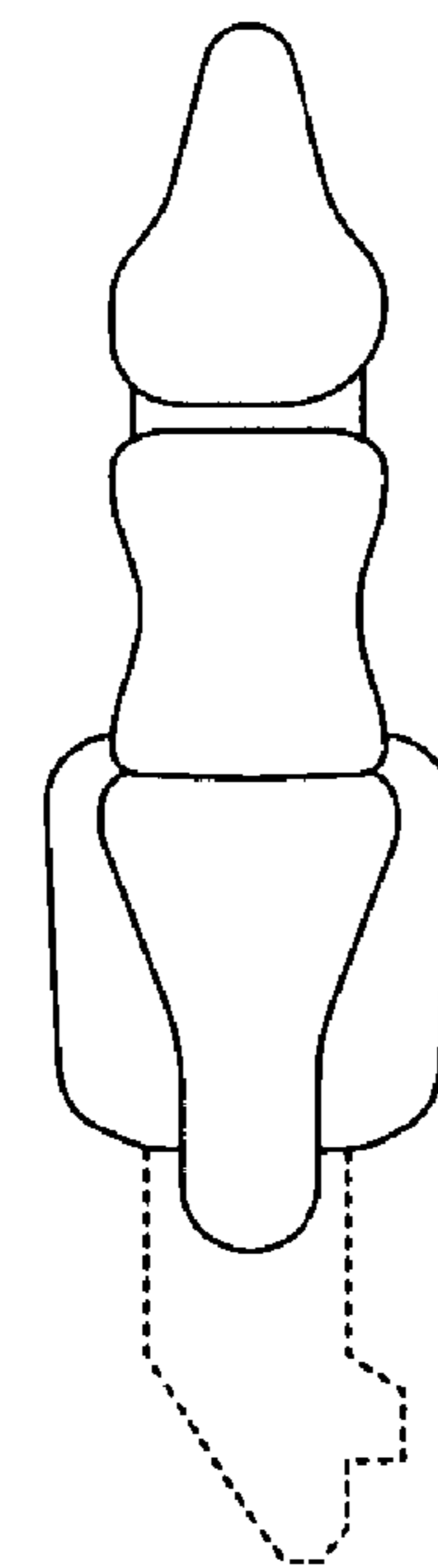
