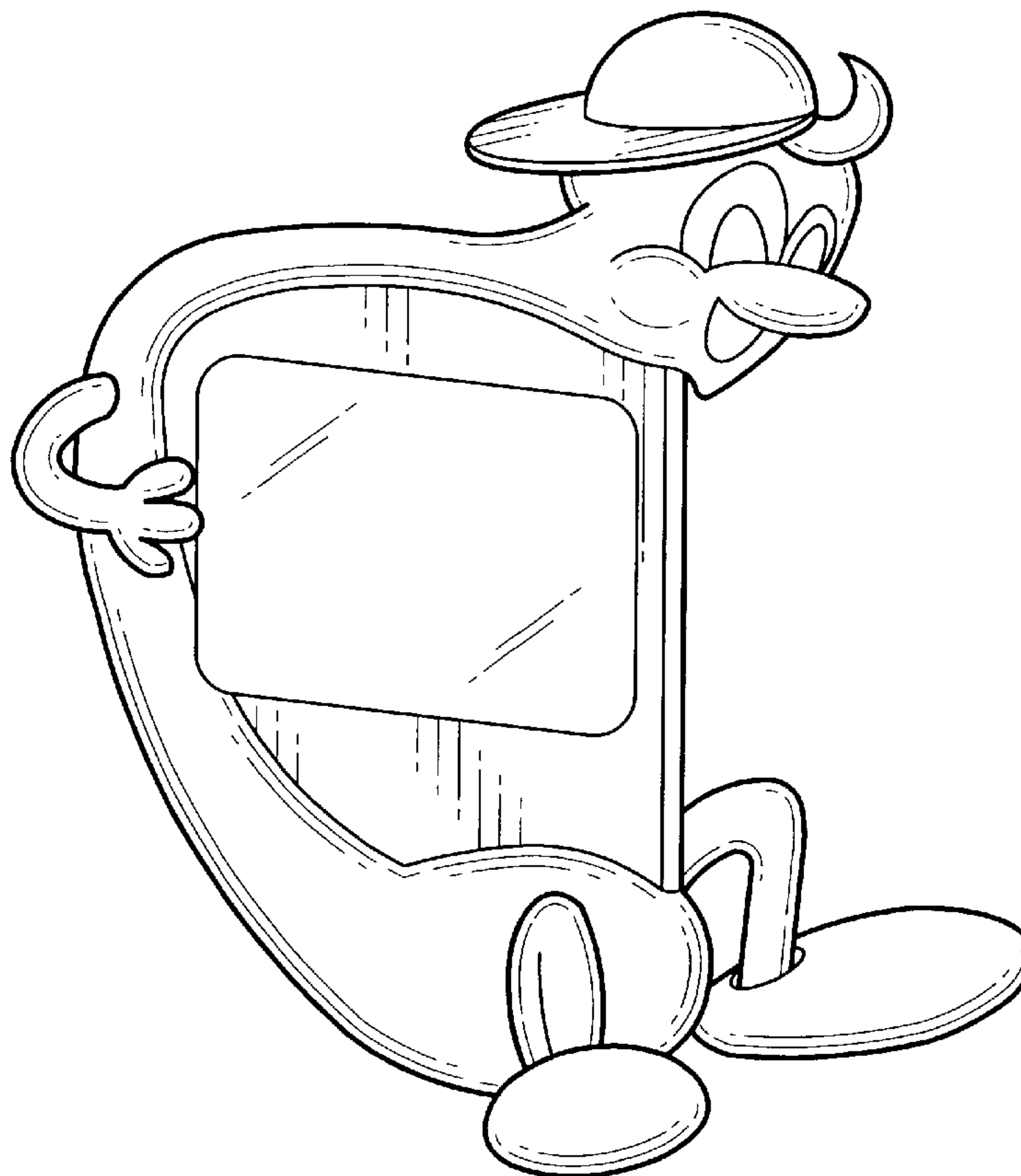
FIG. 1 is a front perspective view thereof;

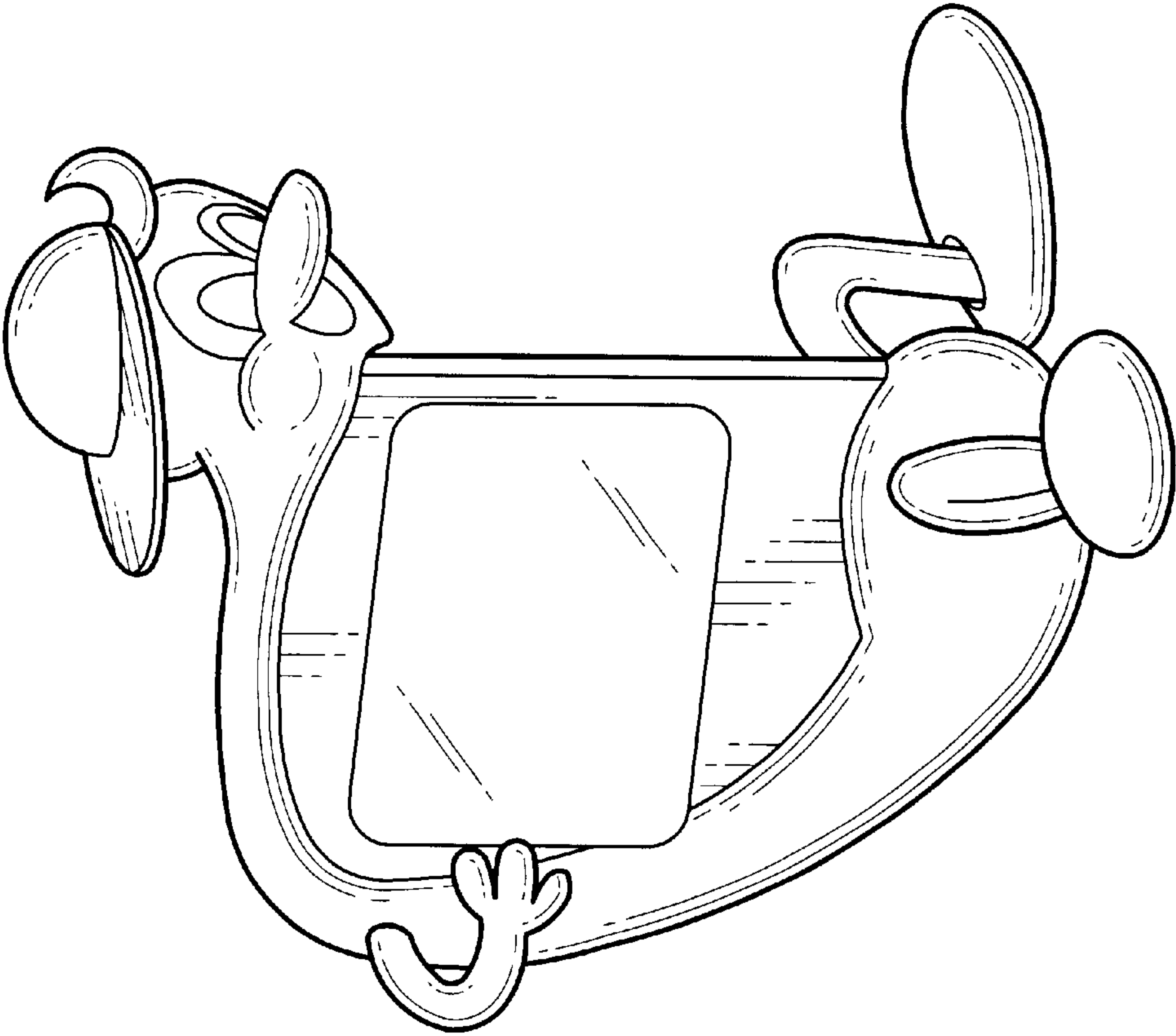

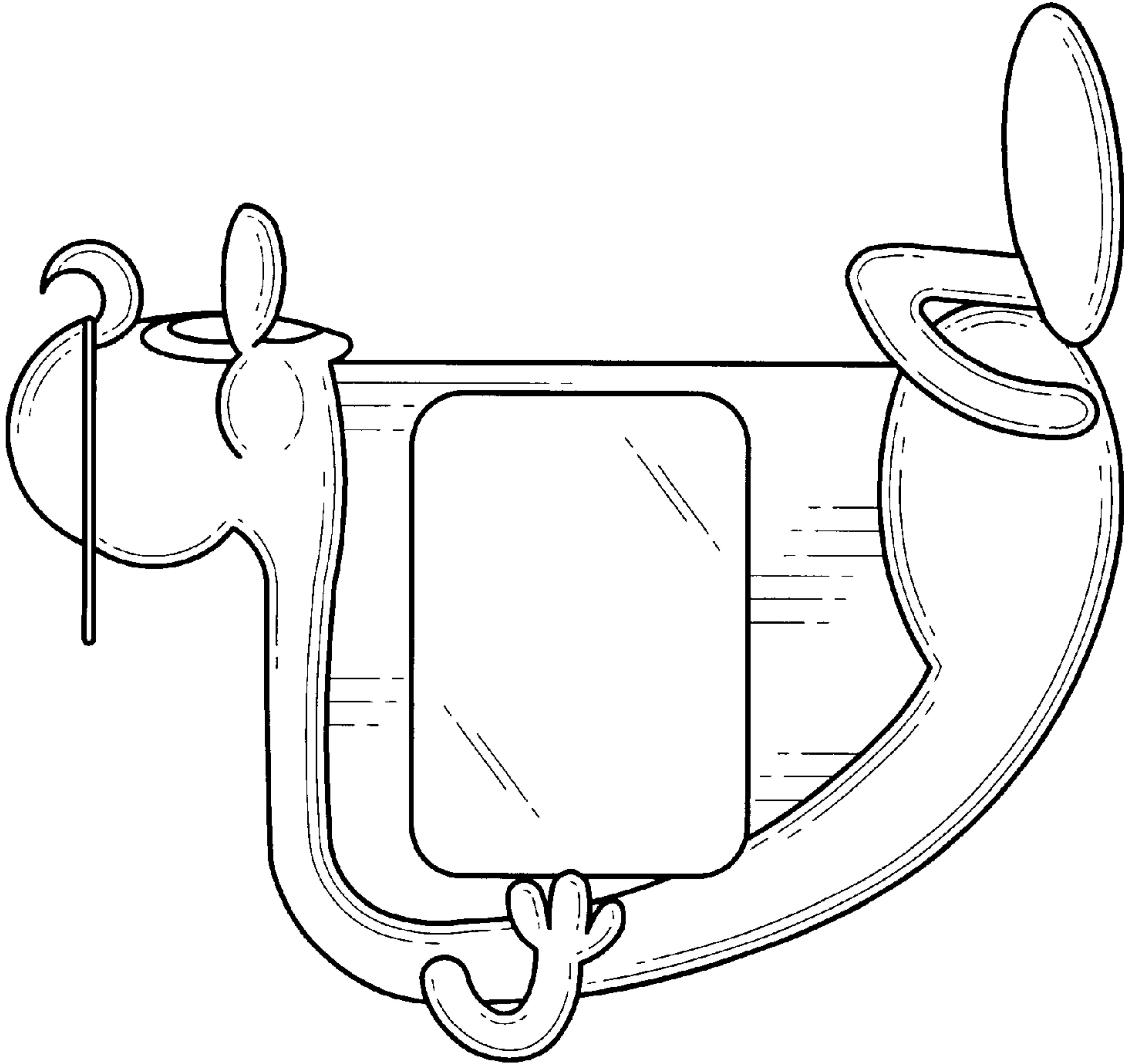

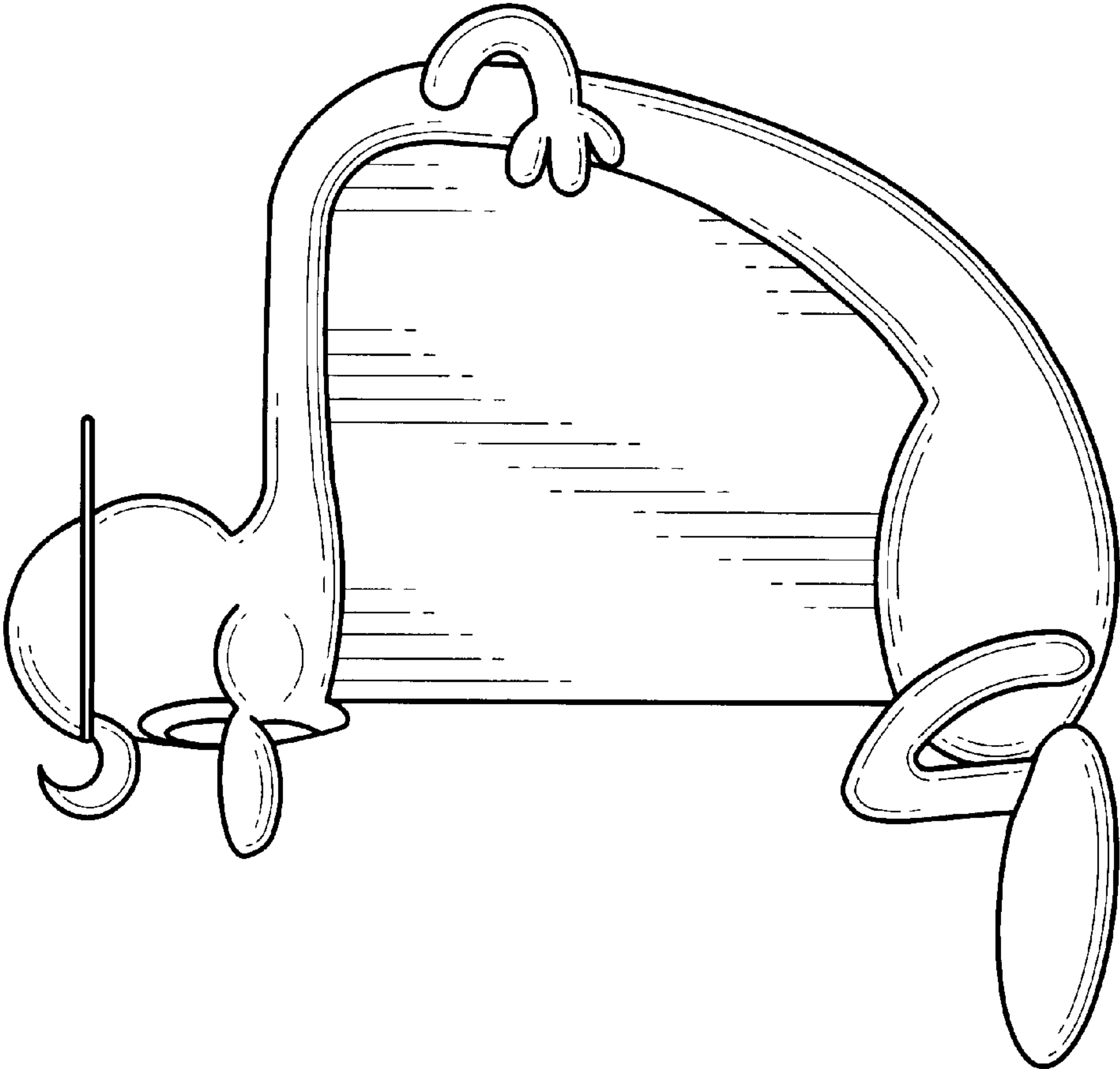

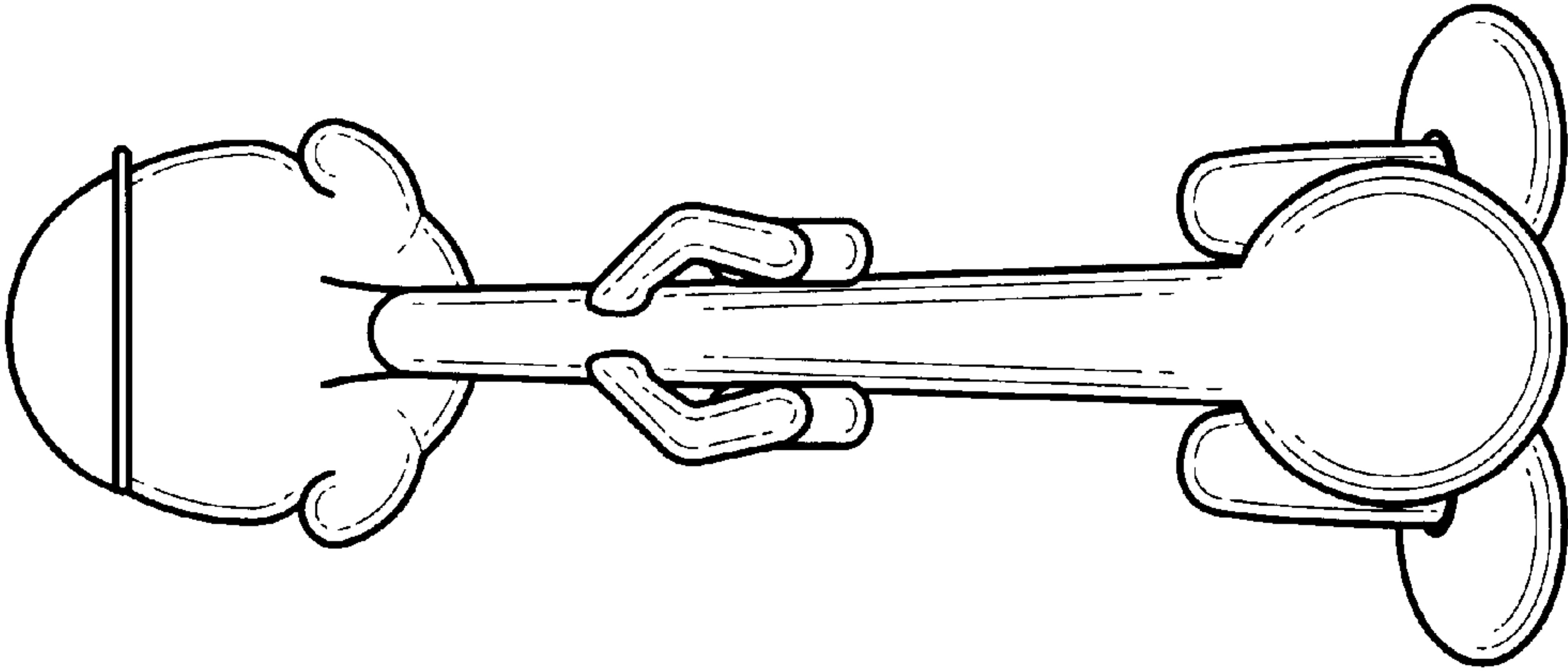

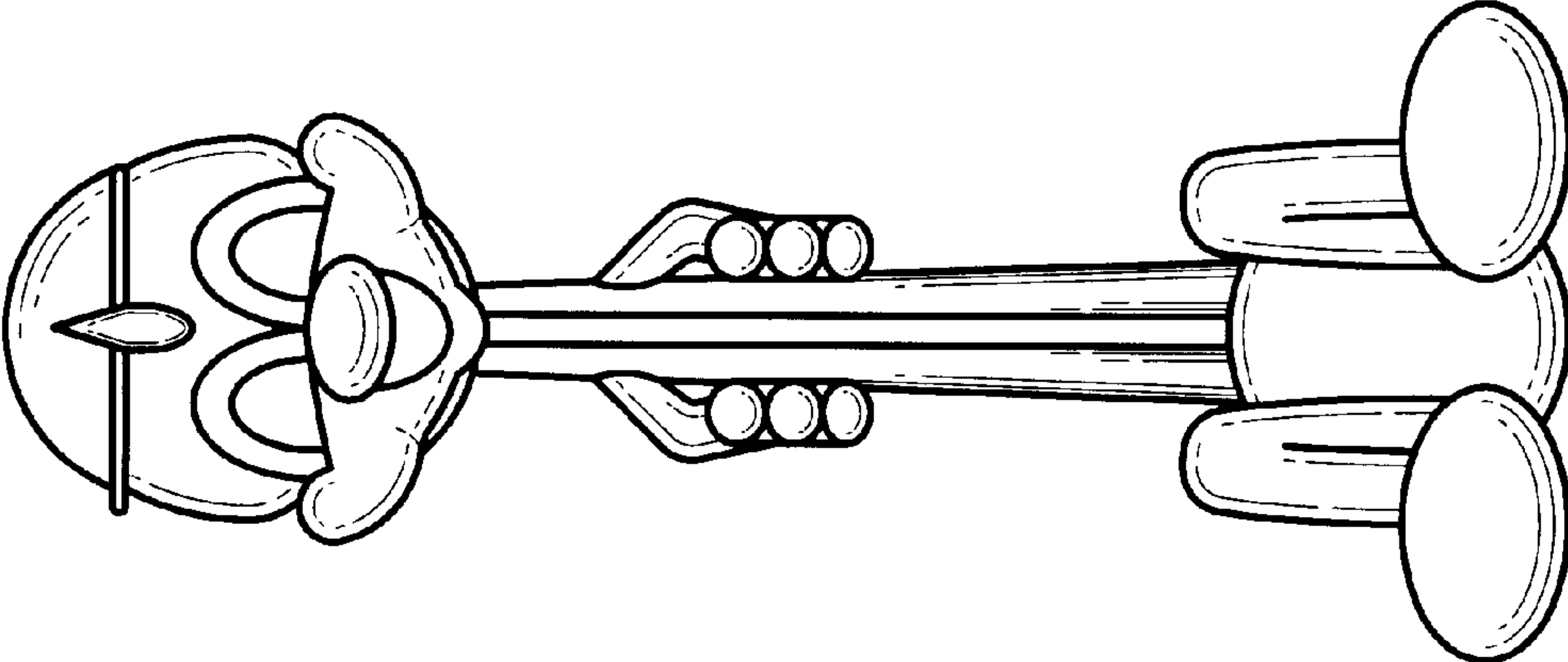

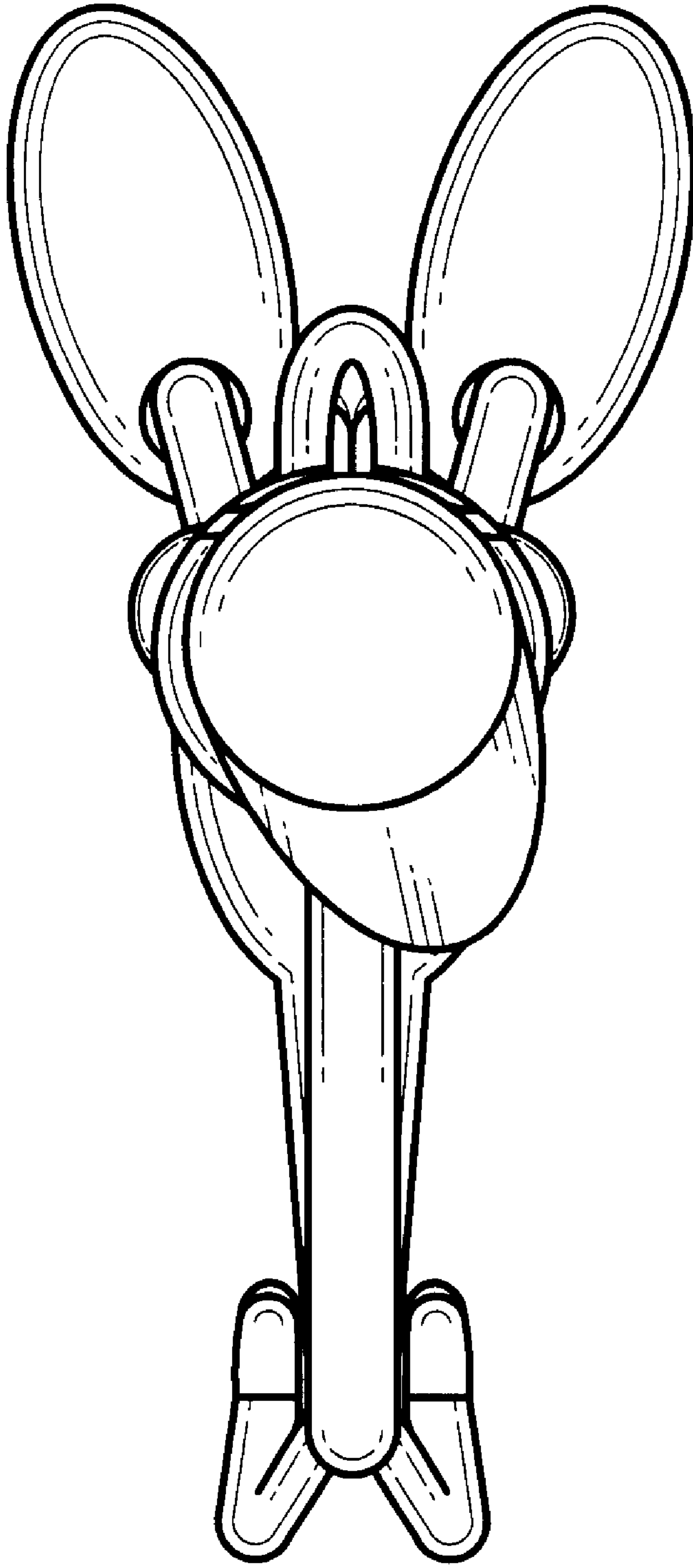

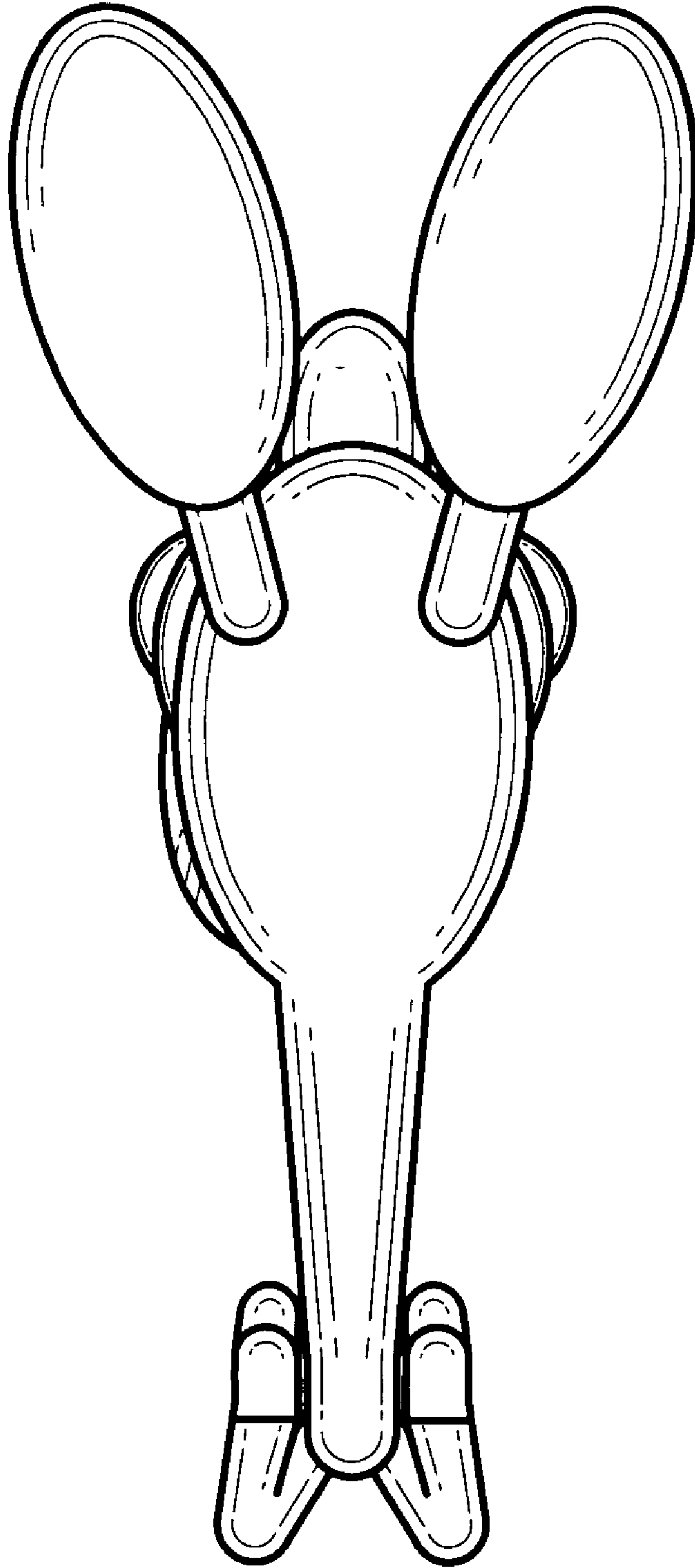
