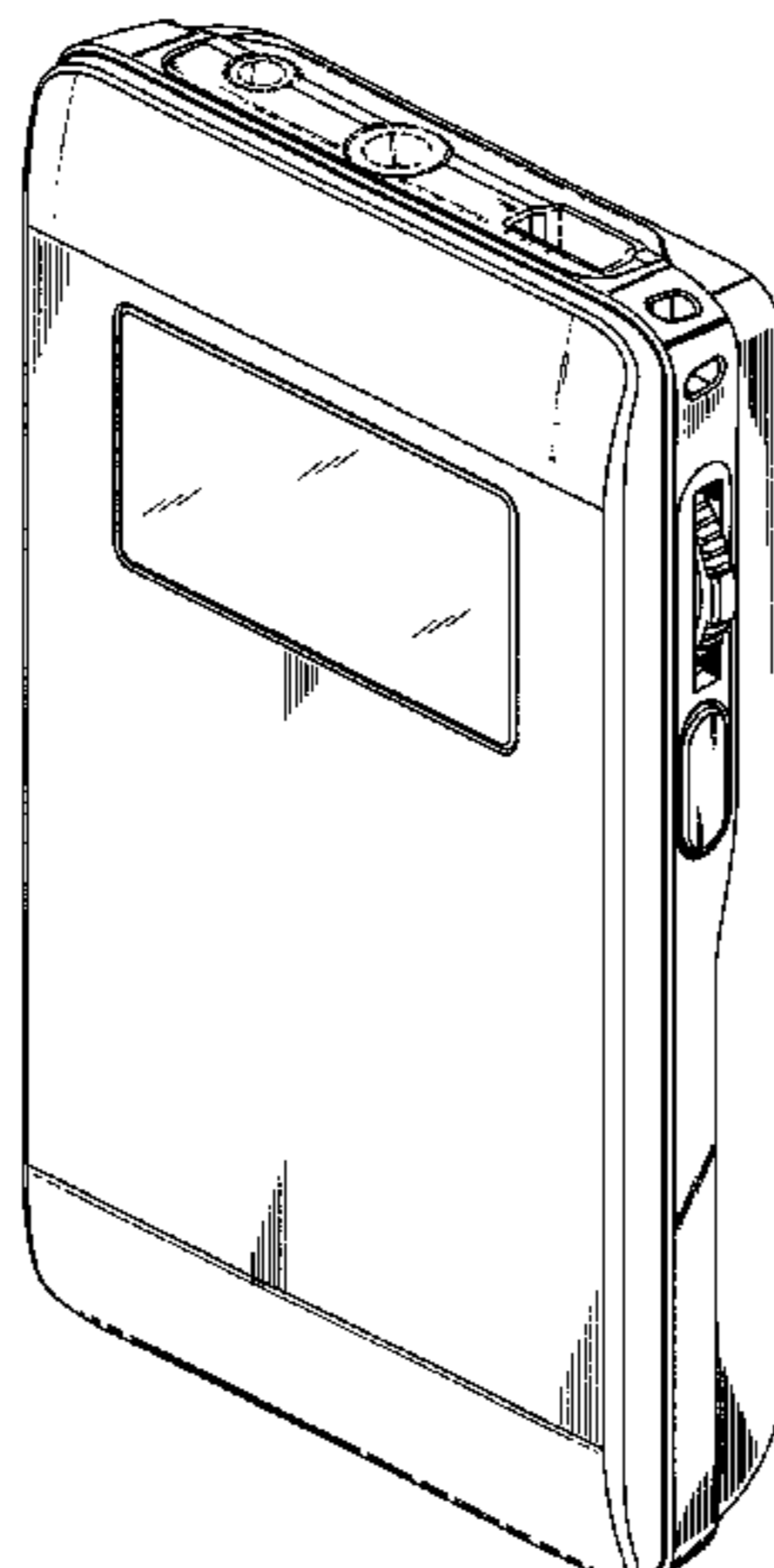
The ornamental design for a media player, substantially as shown and described.

FIG. 1 is a perspective front view of a media player in accordance with the present design;

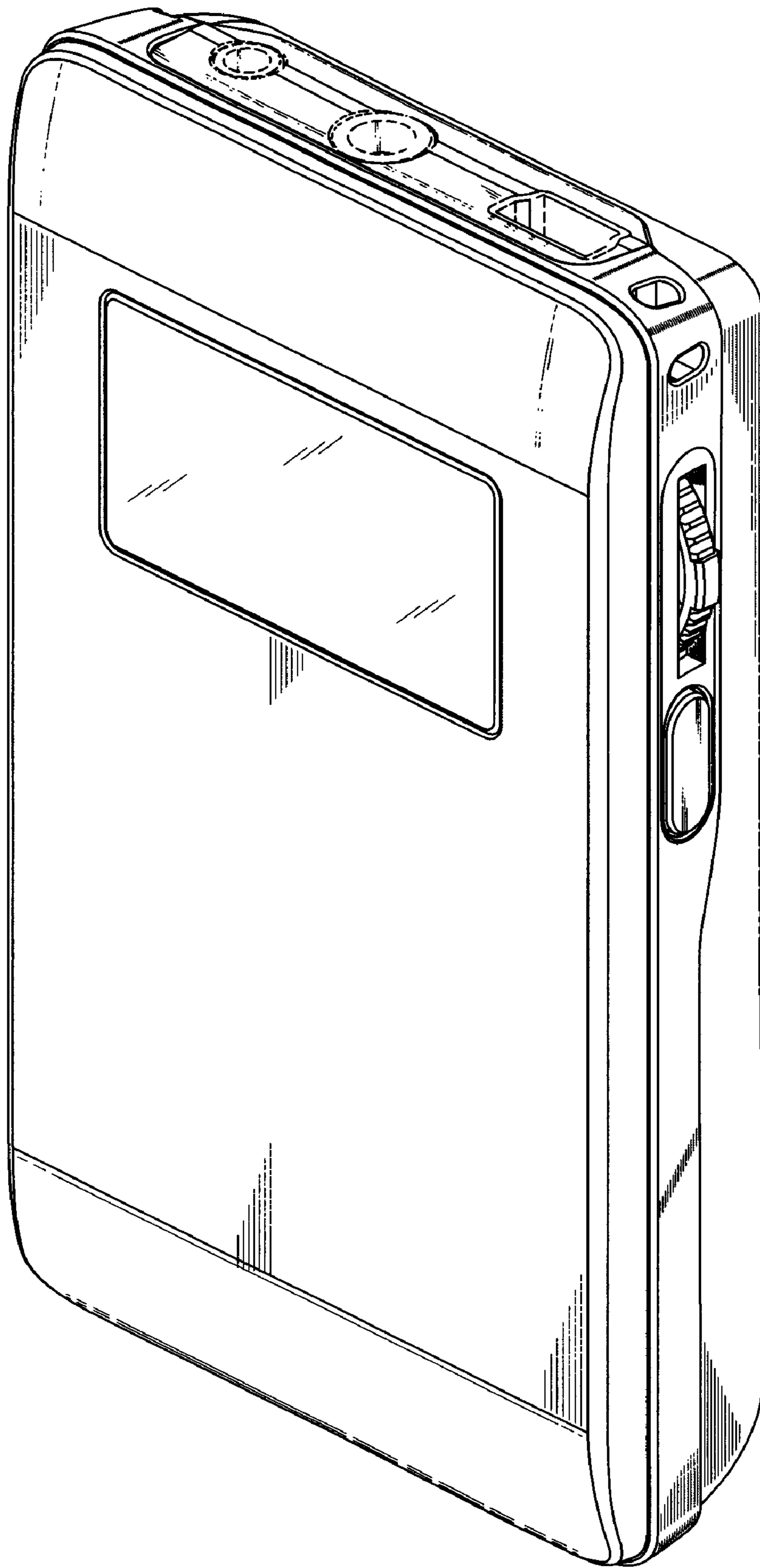

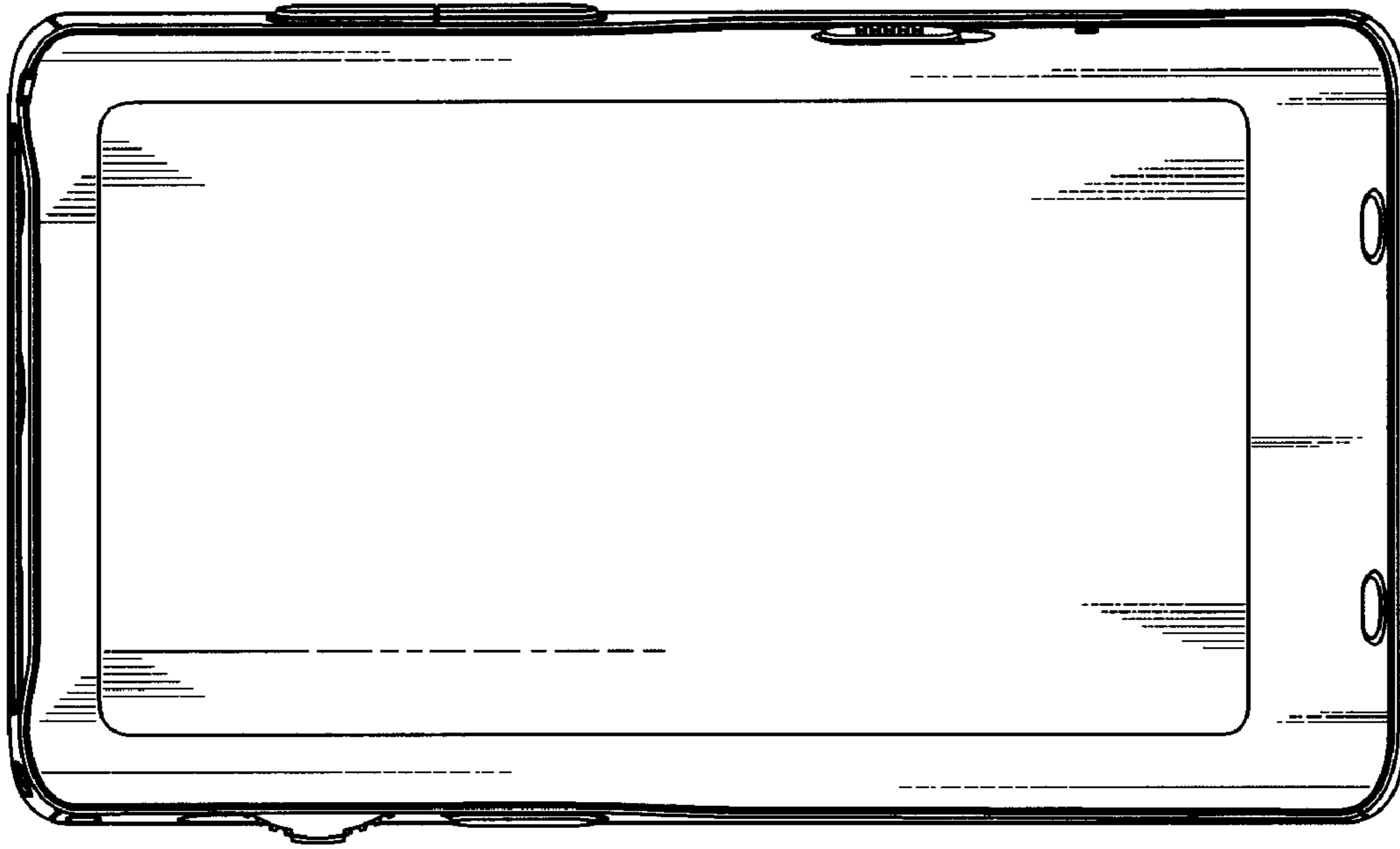

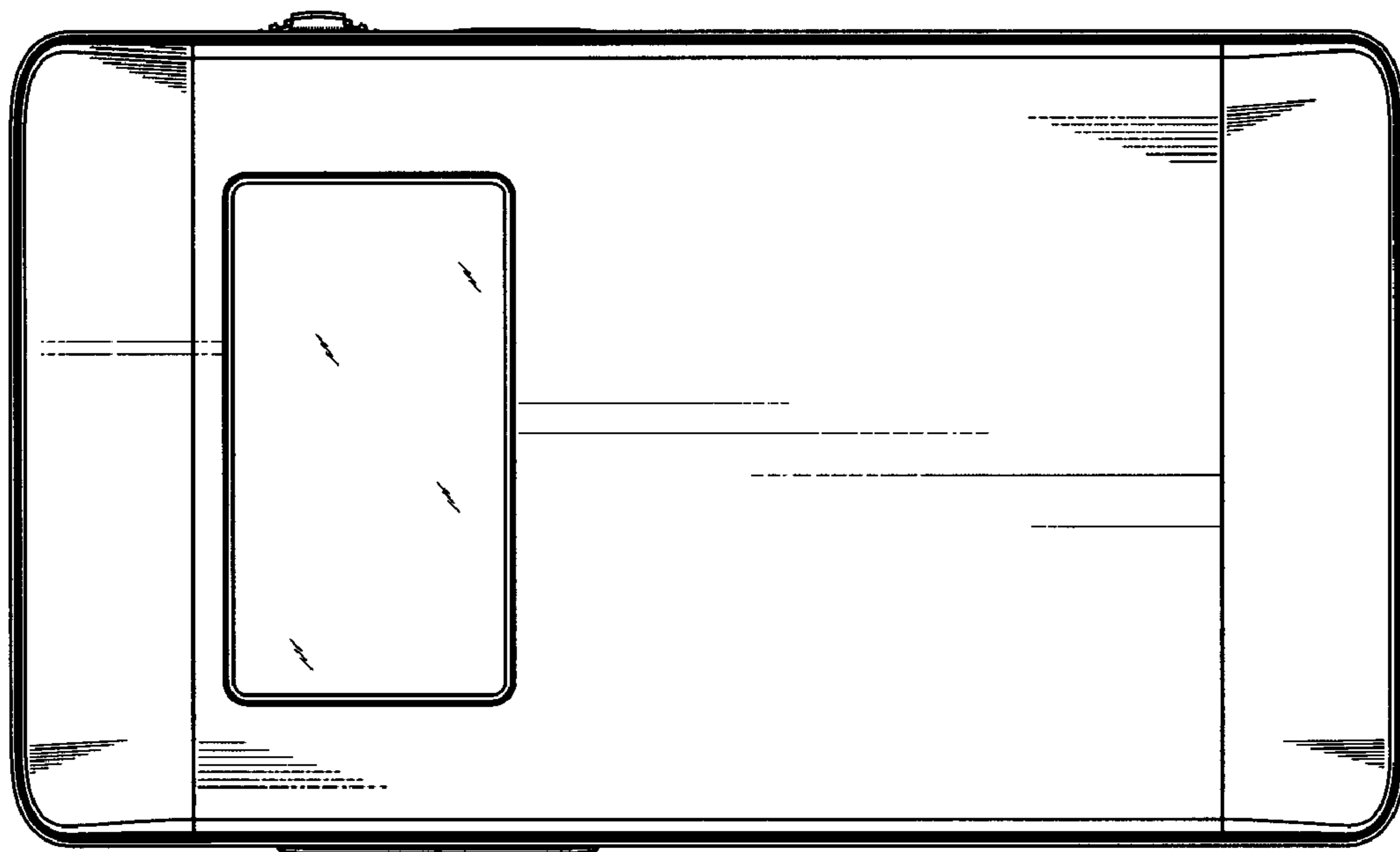

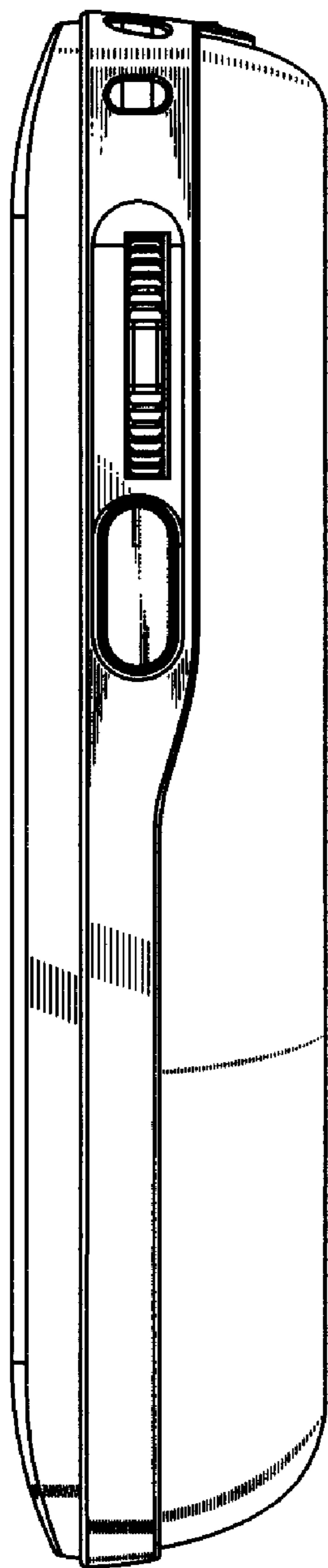

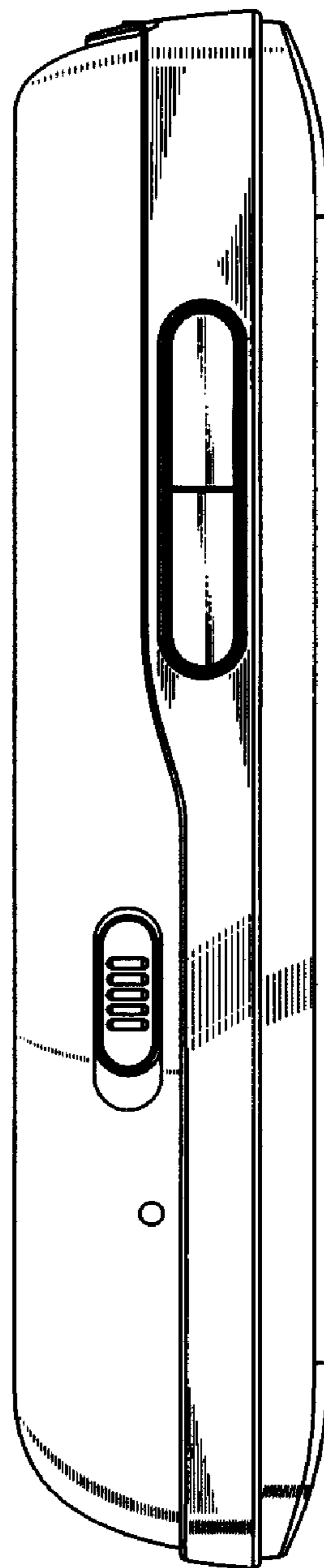

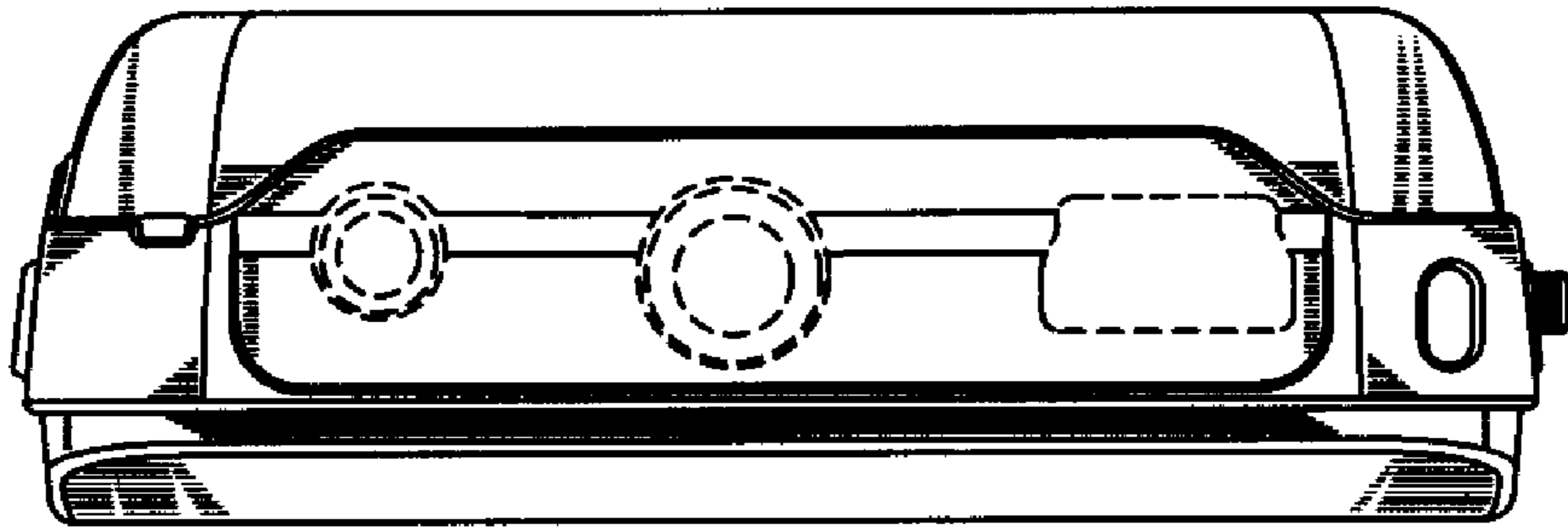

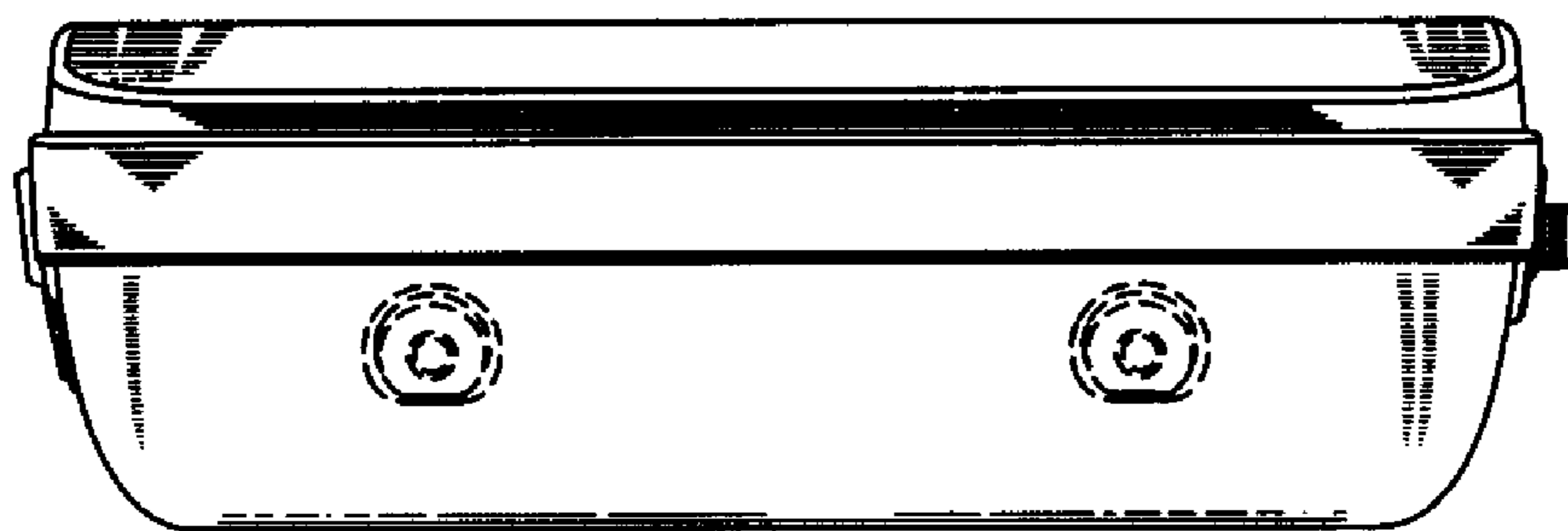
