FIG. 18 is a bottom plan view of FIG. 13.

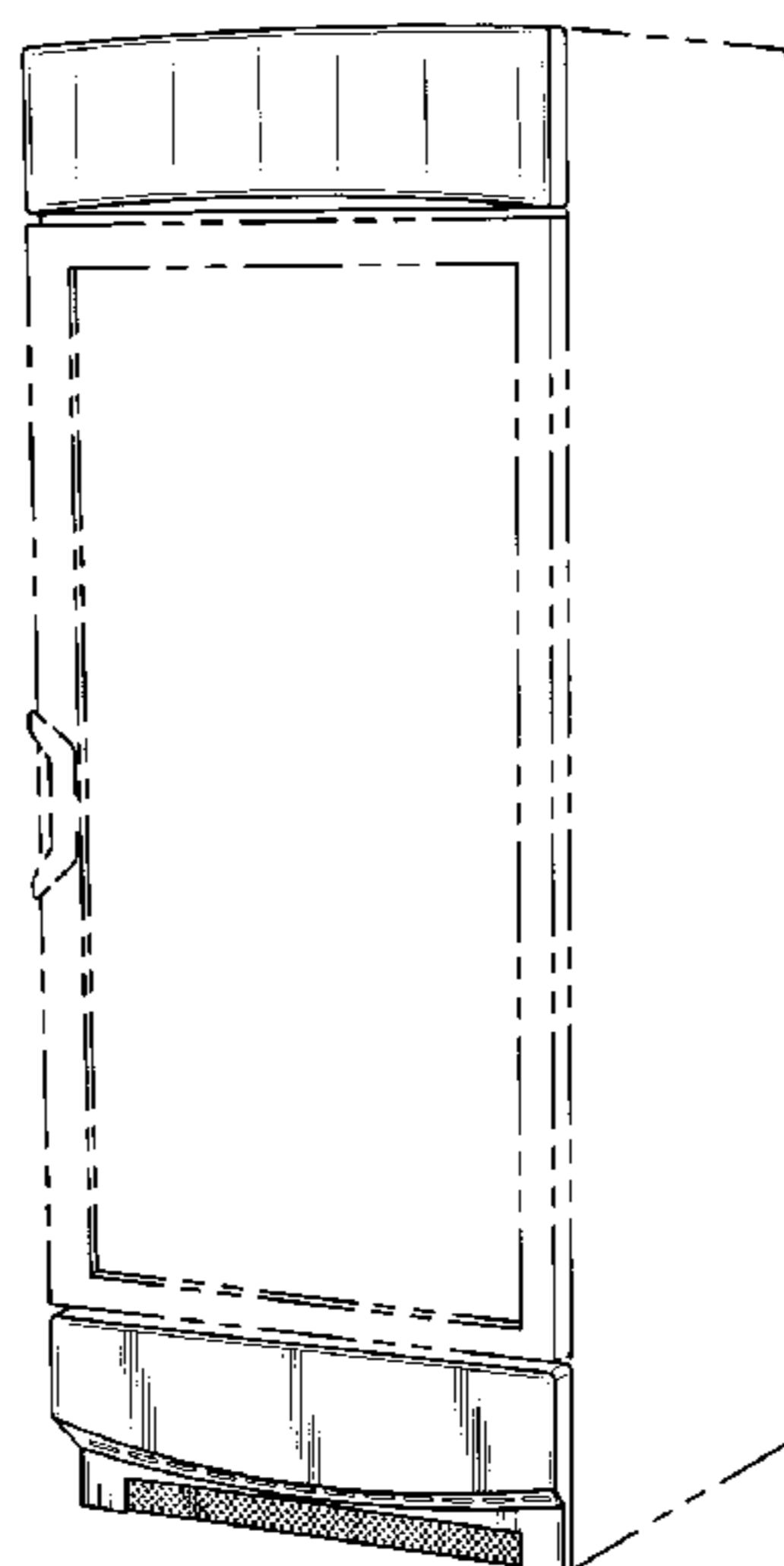

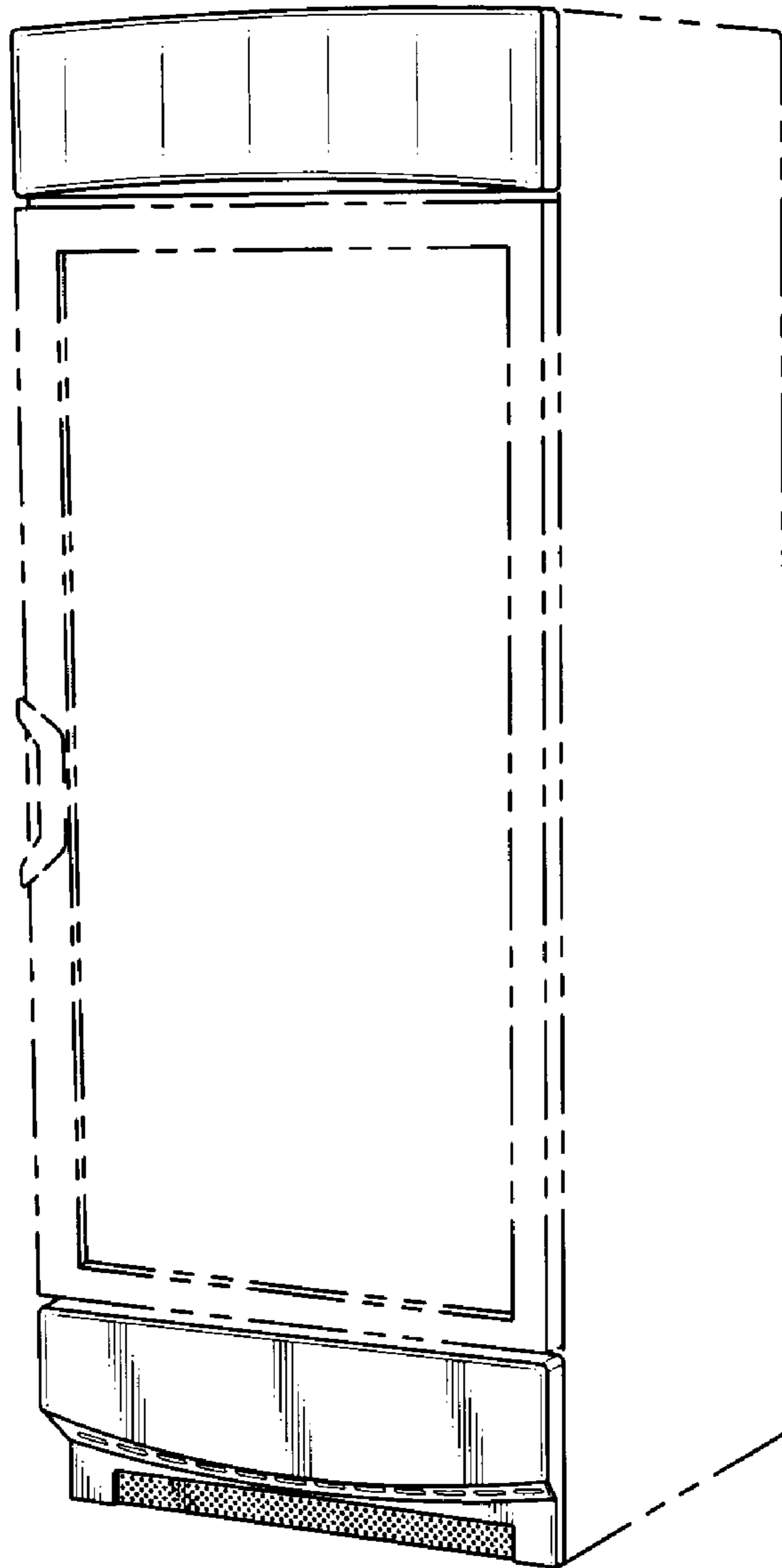

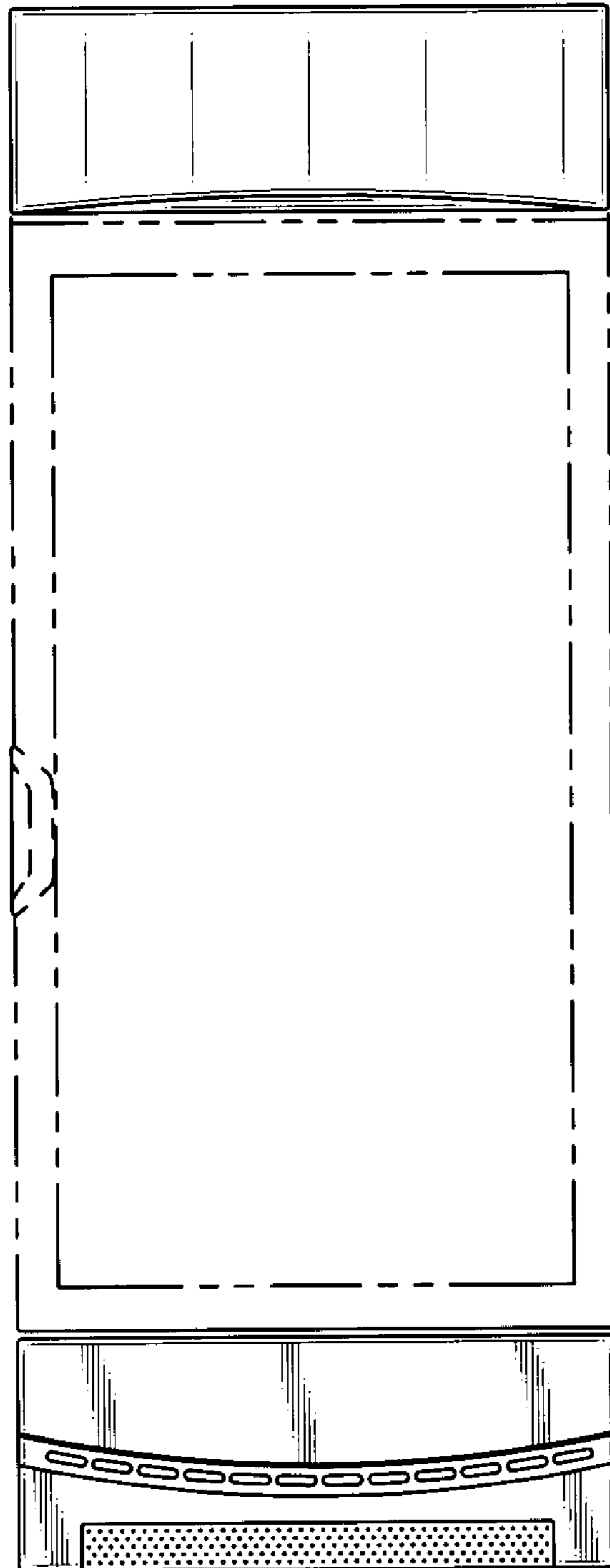

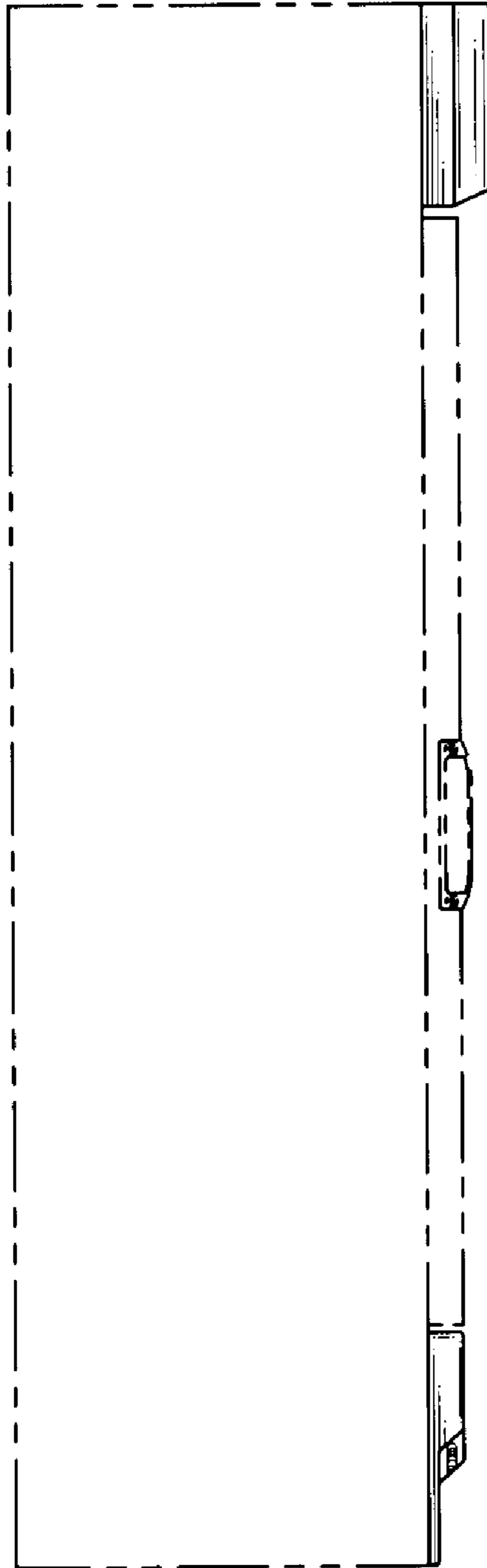

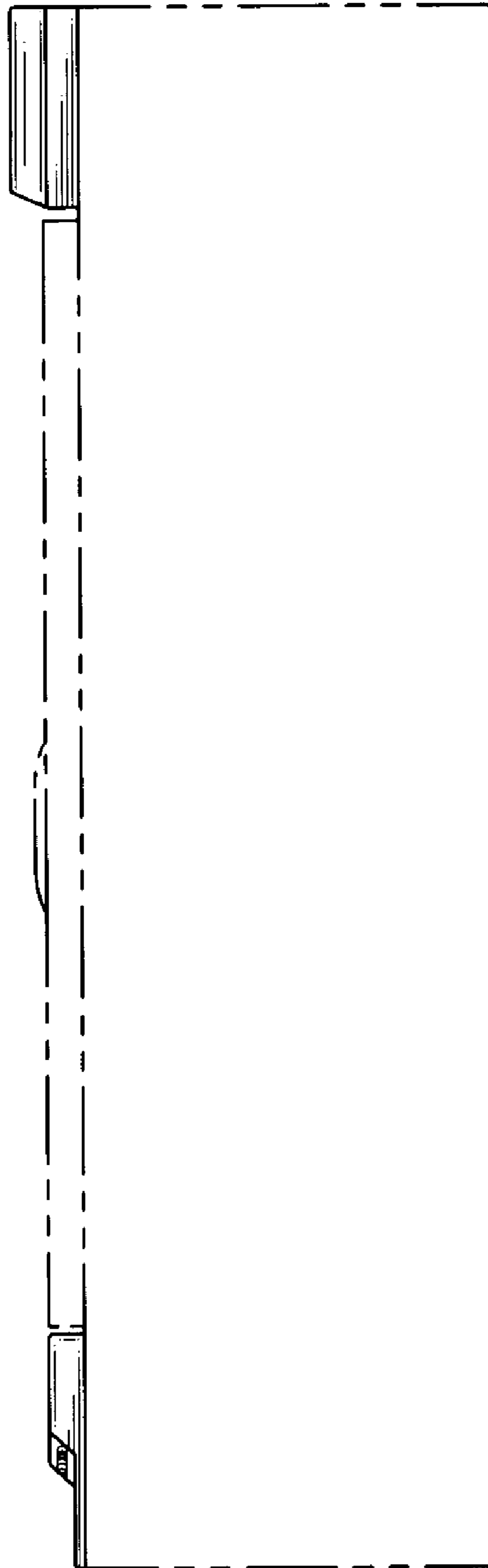

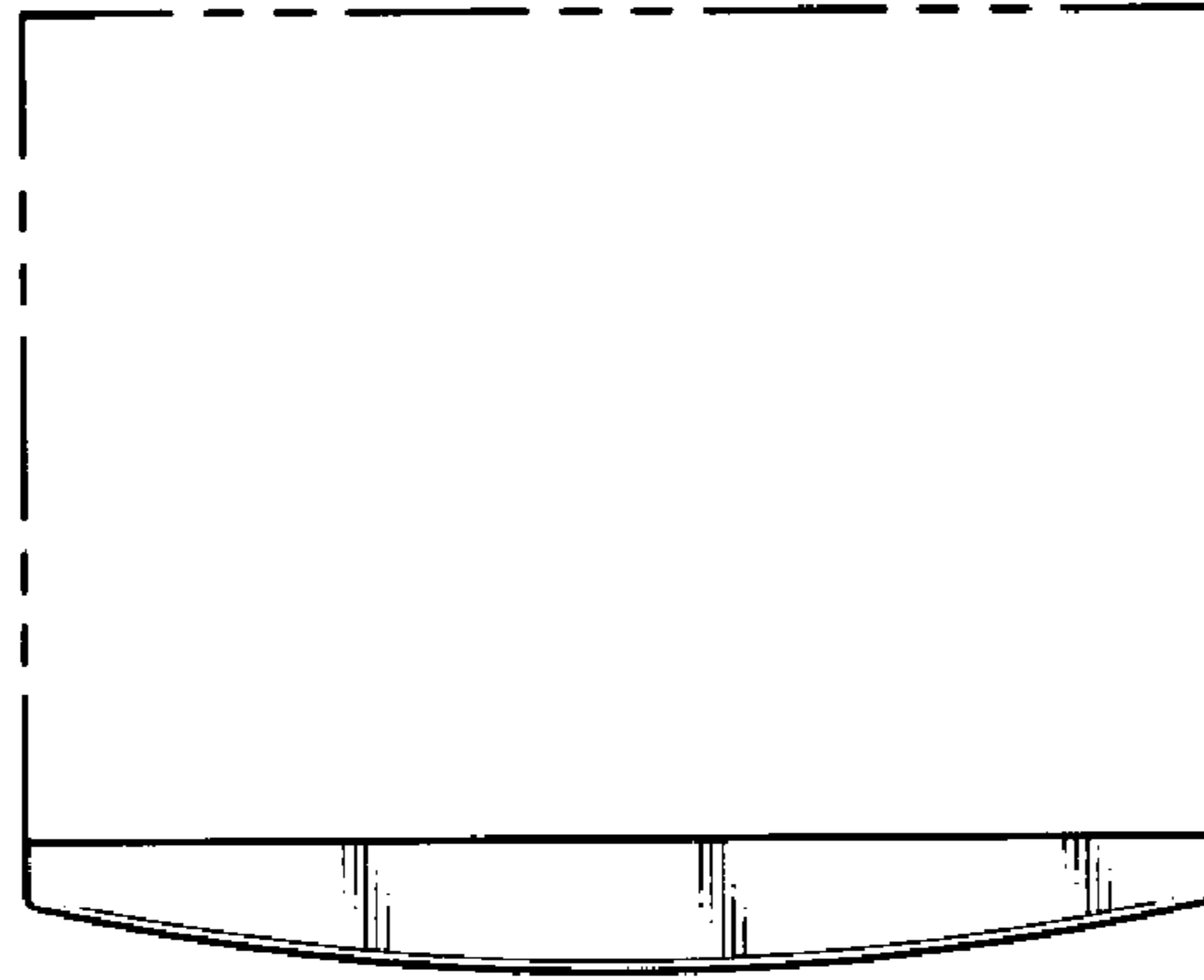

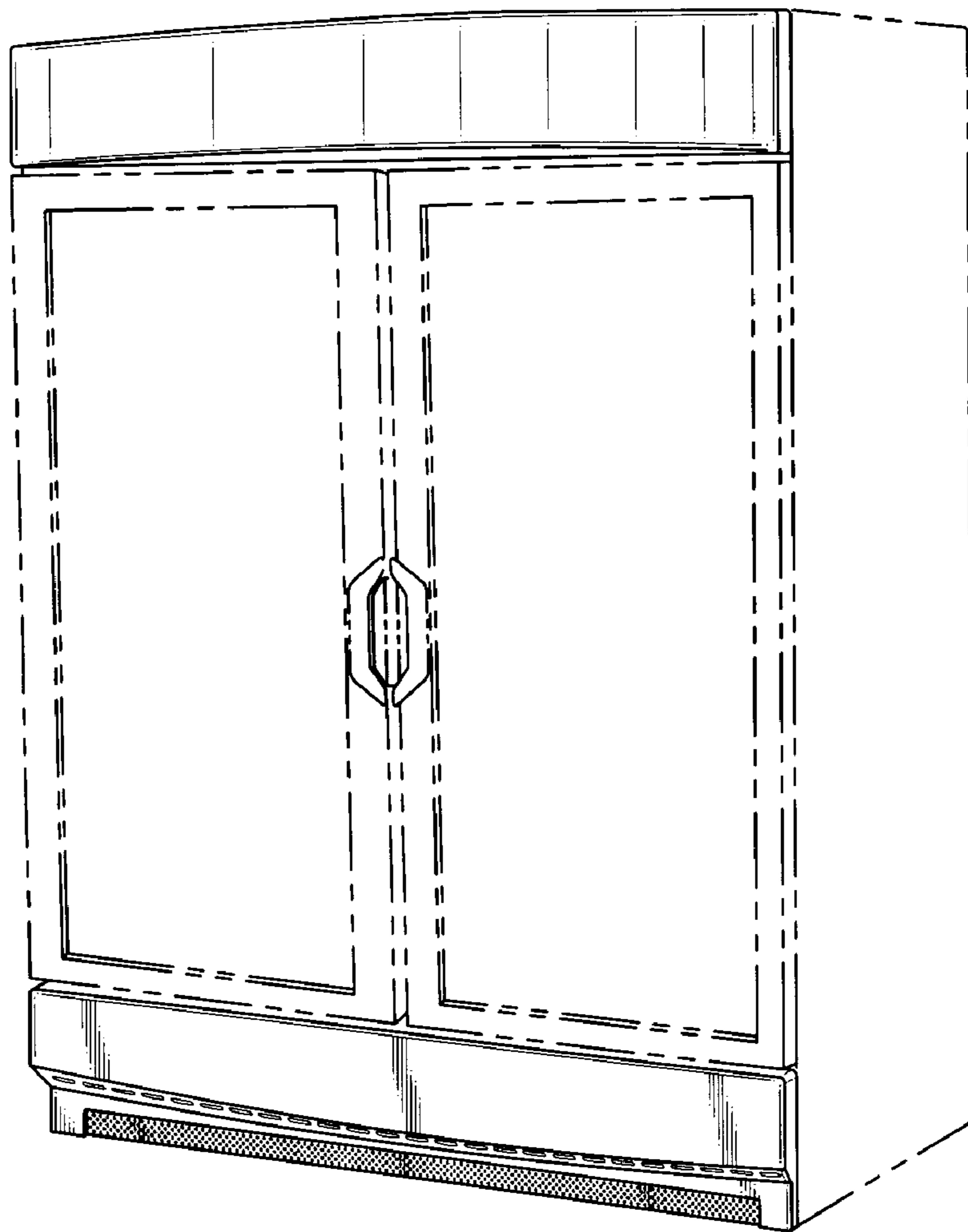

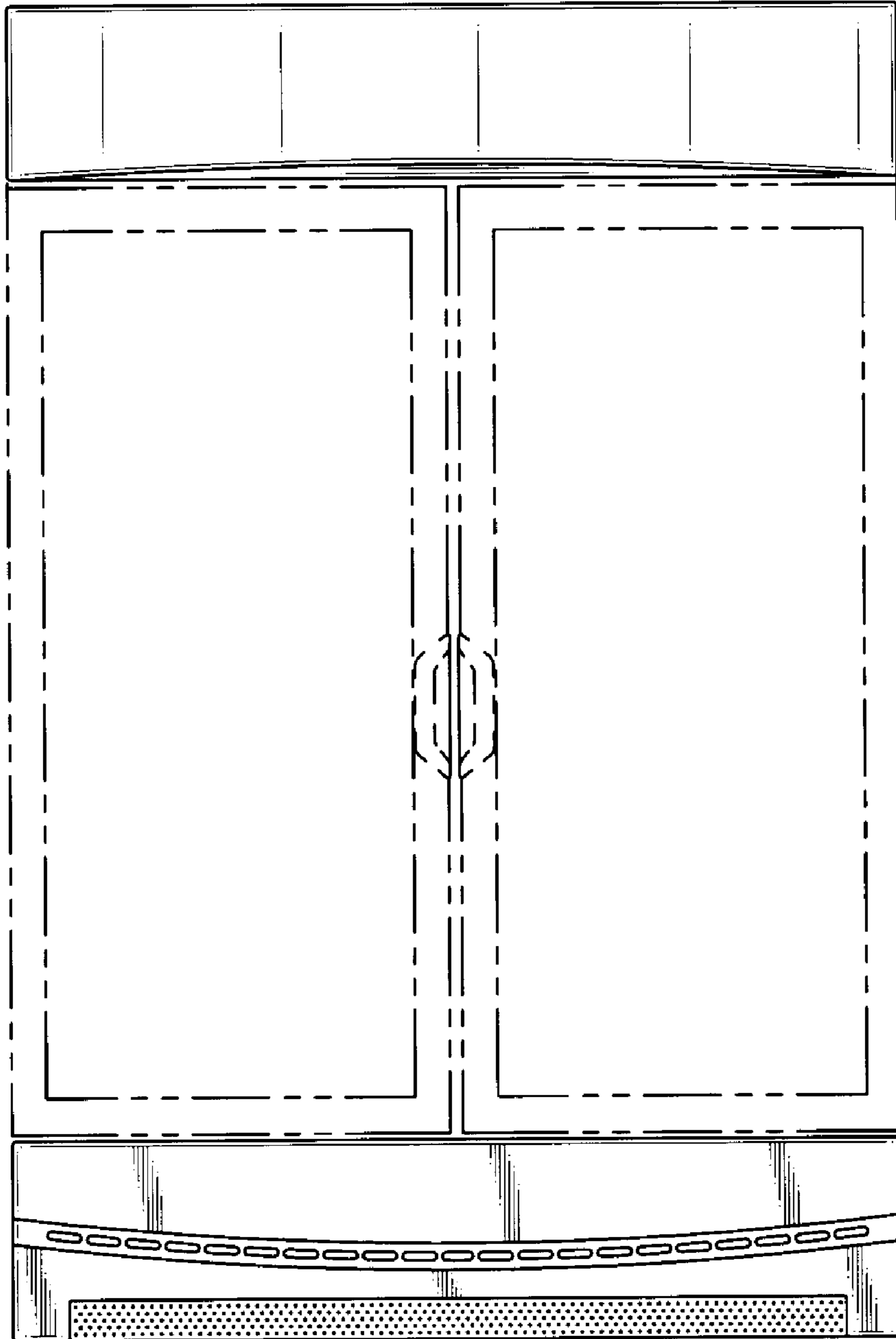

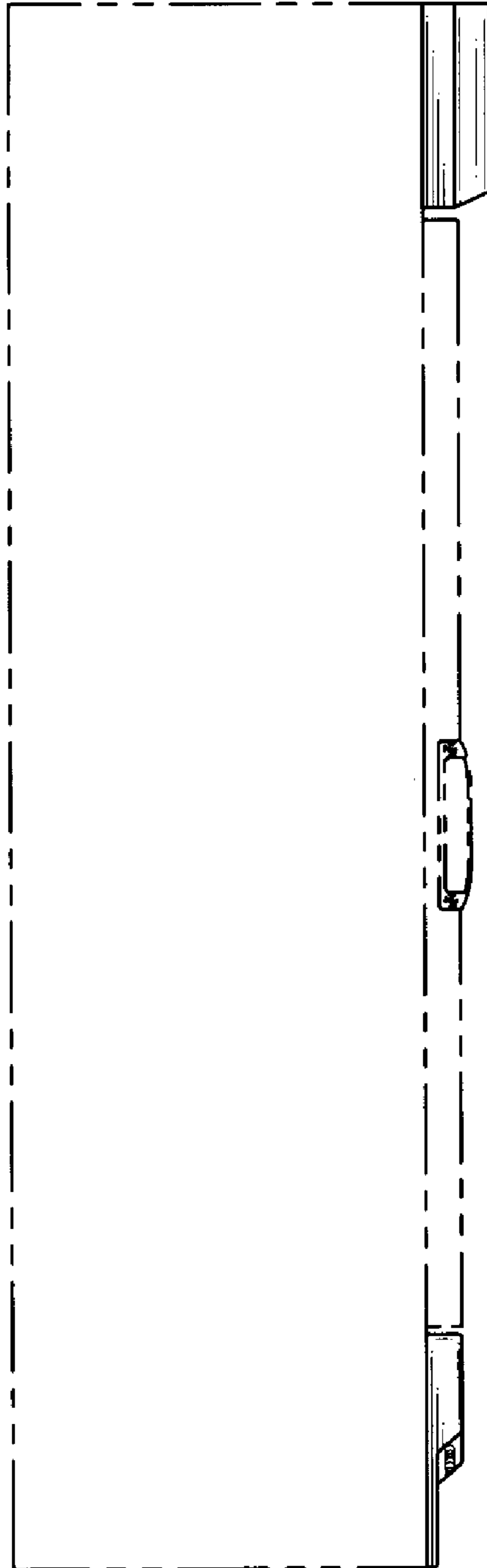

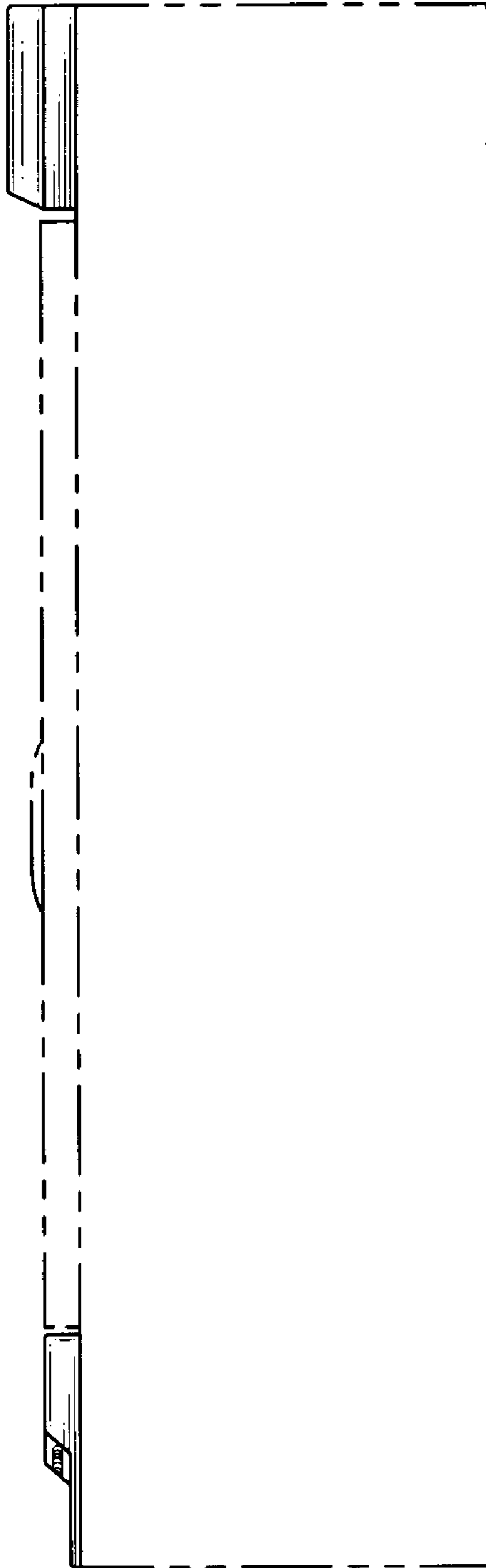

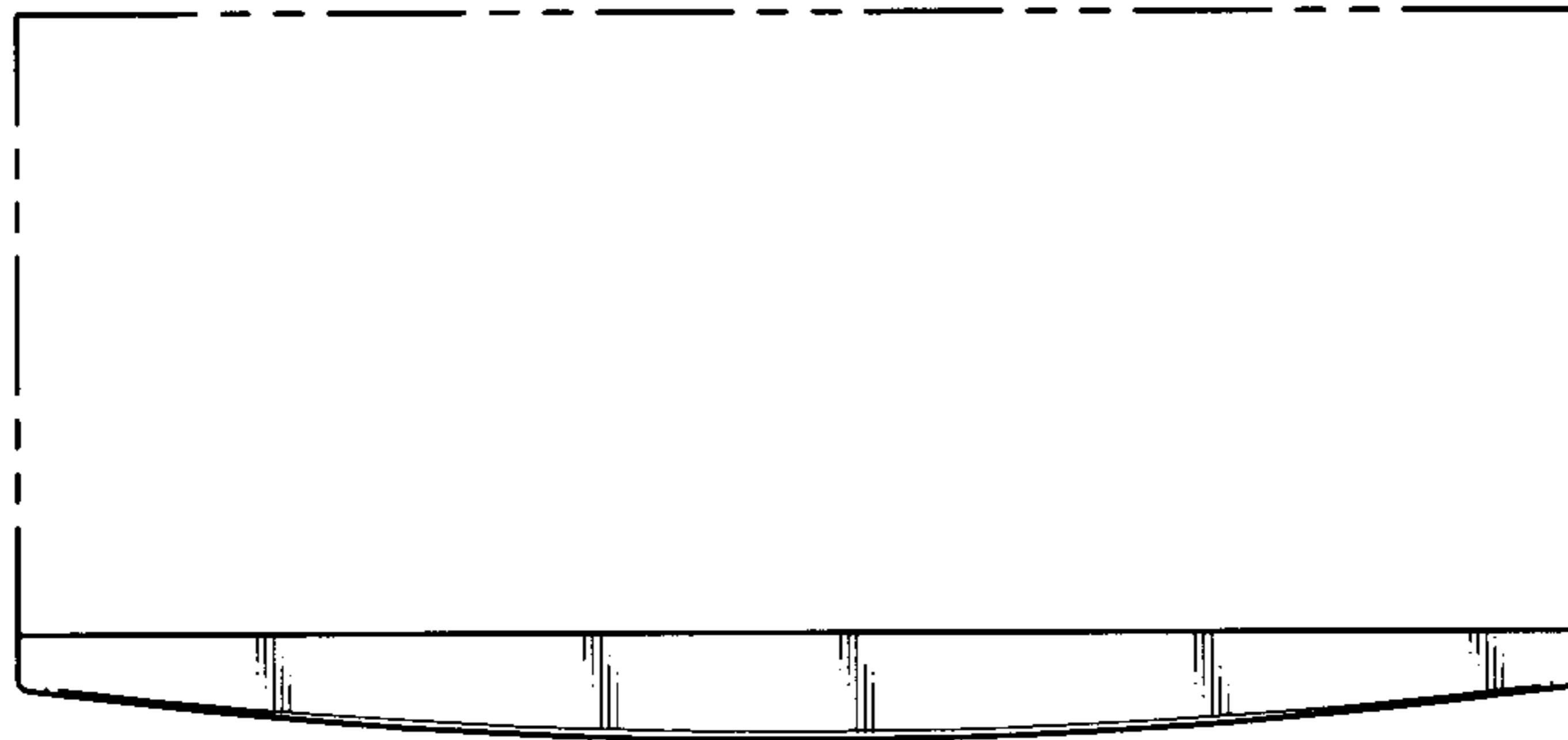

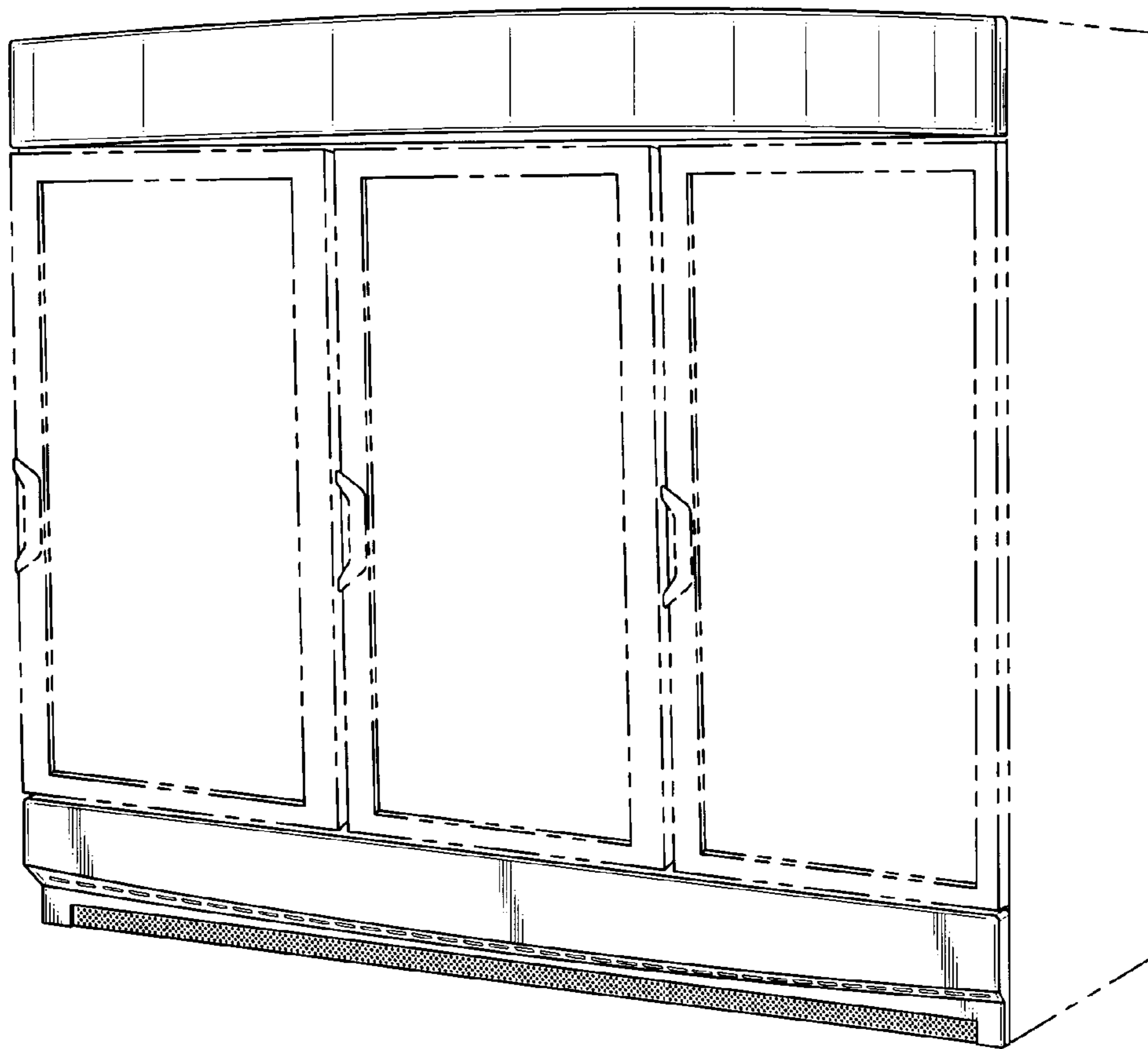

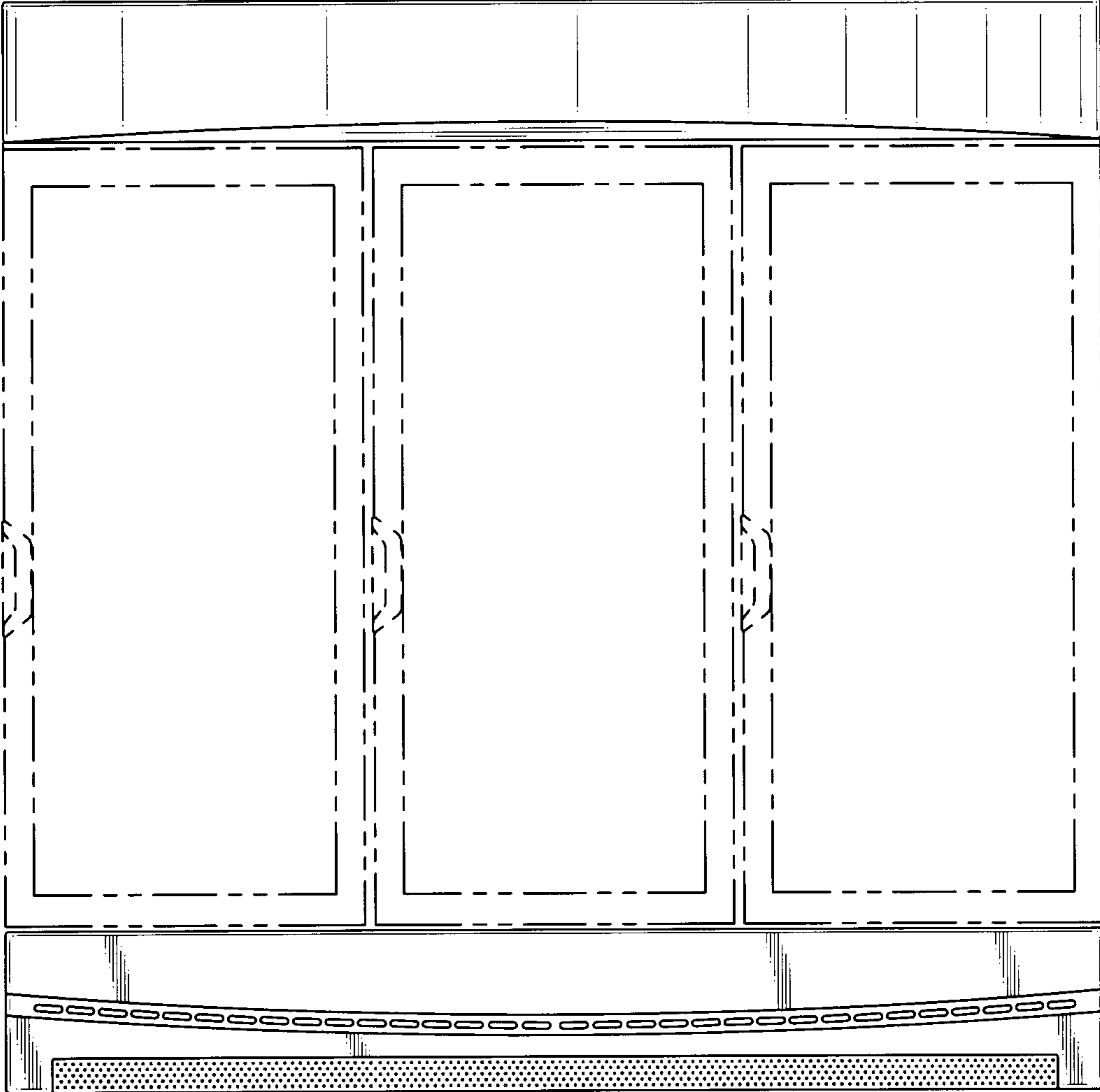

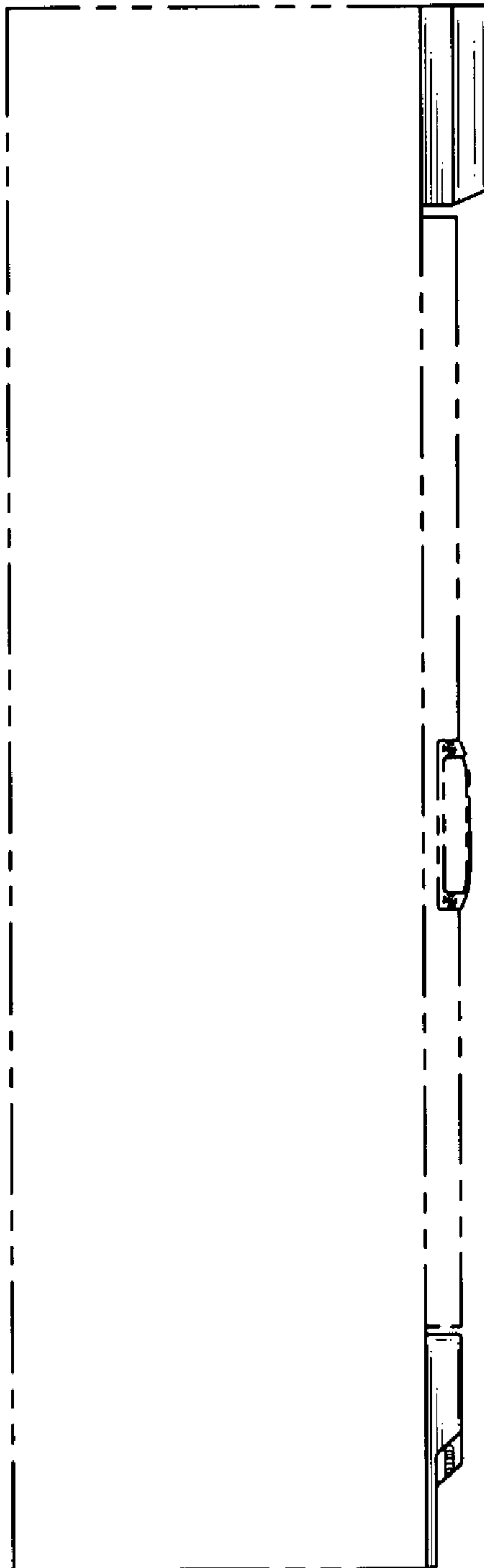

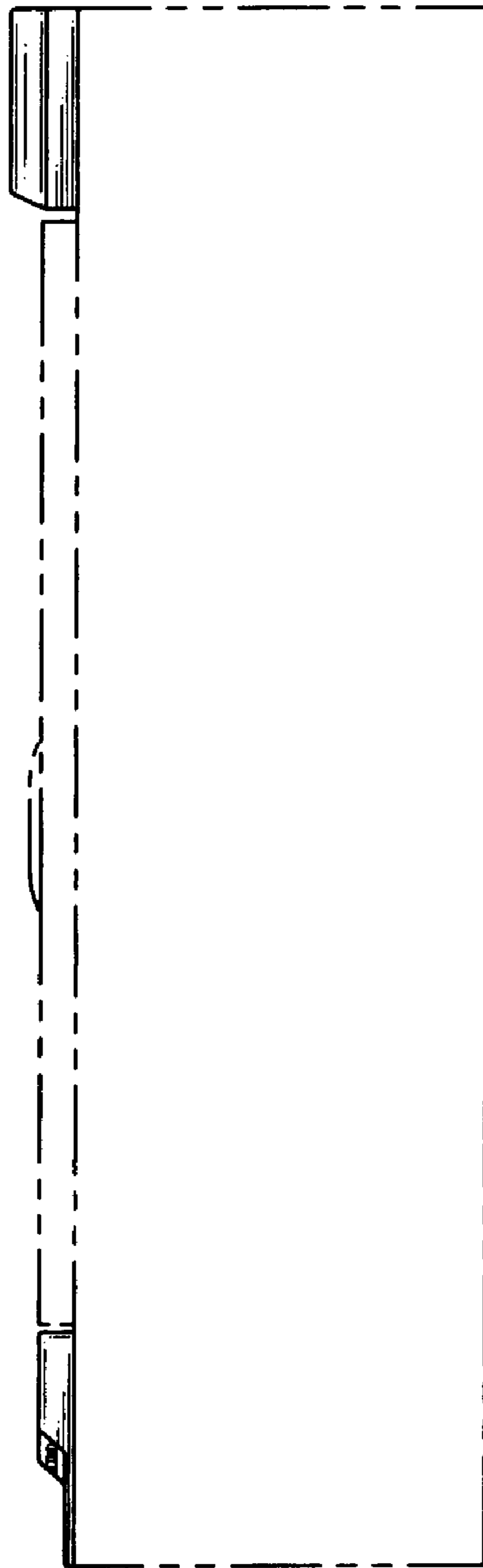

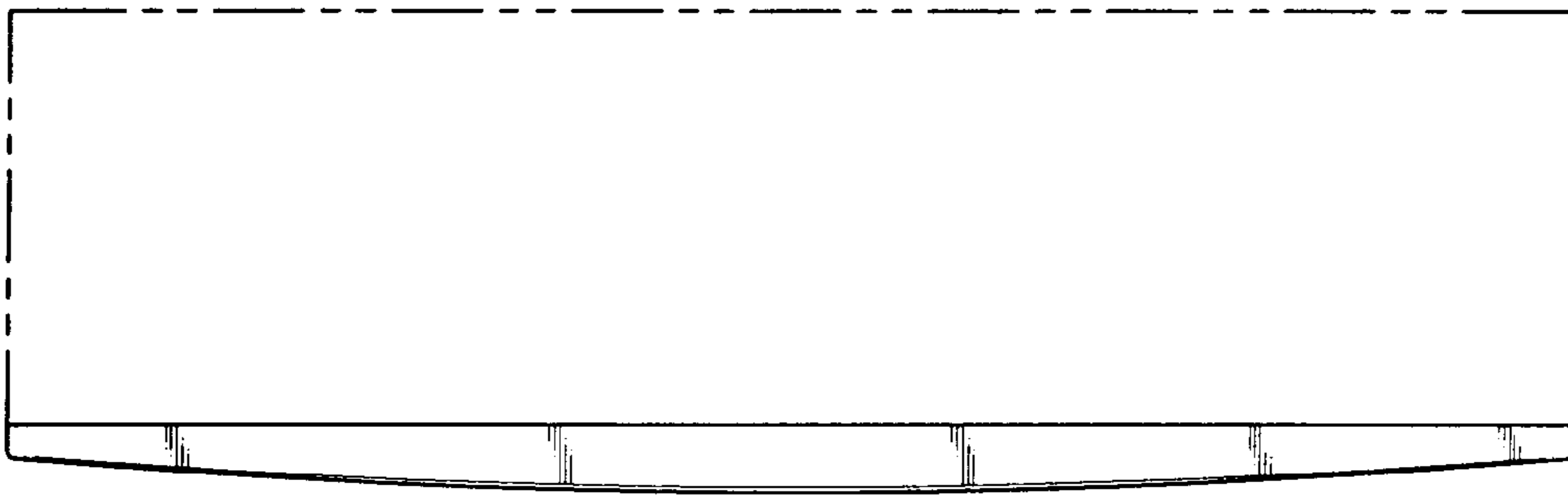

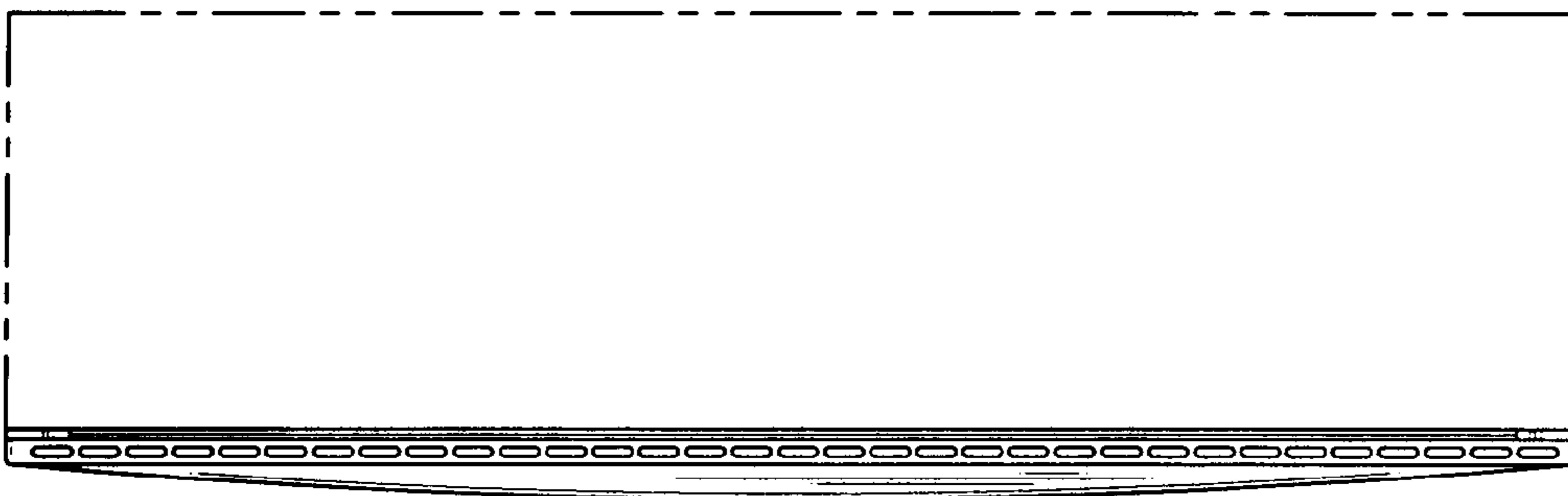
