FIG. 5 is a bottom plan view thereof shown on an enlarged scale; and,

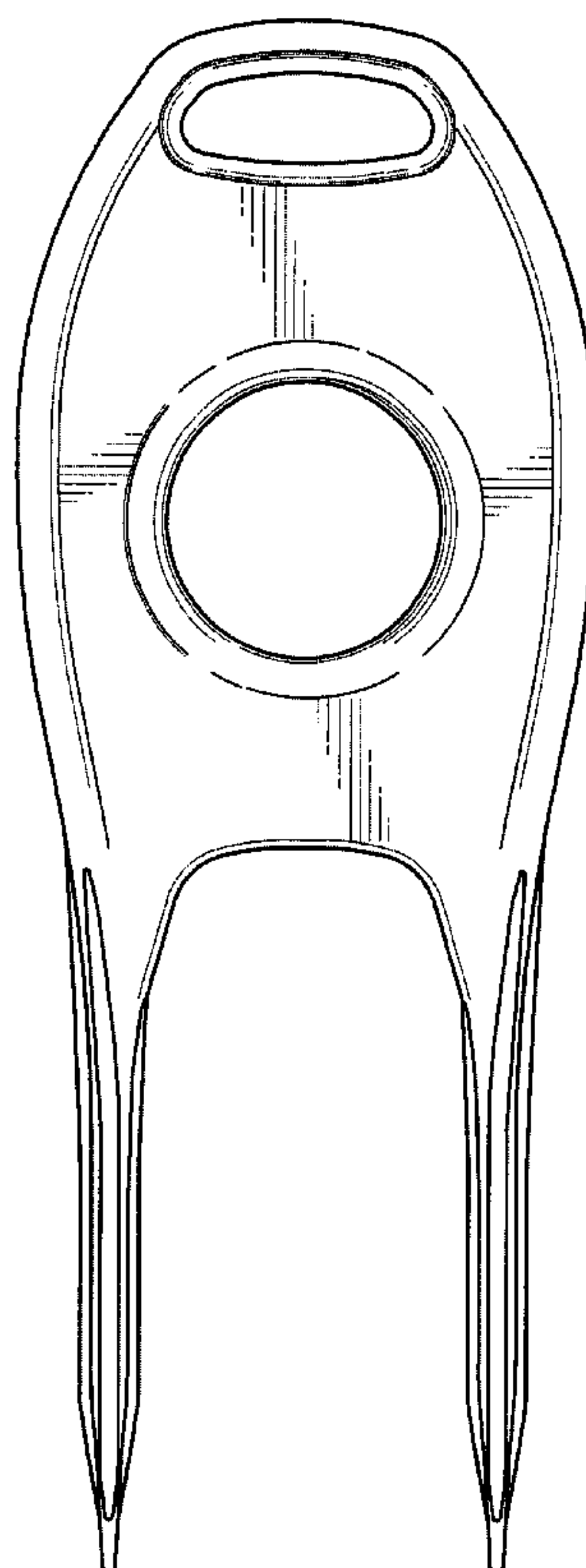
FIG. 6 is a top plan view thereof shown on an enlarged scale.

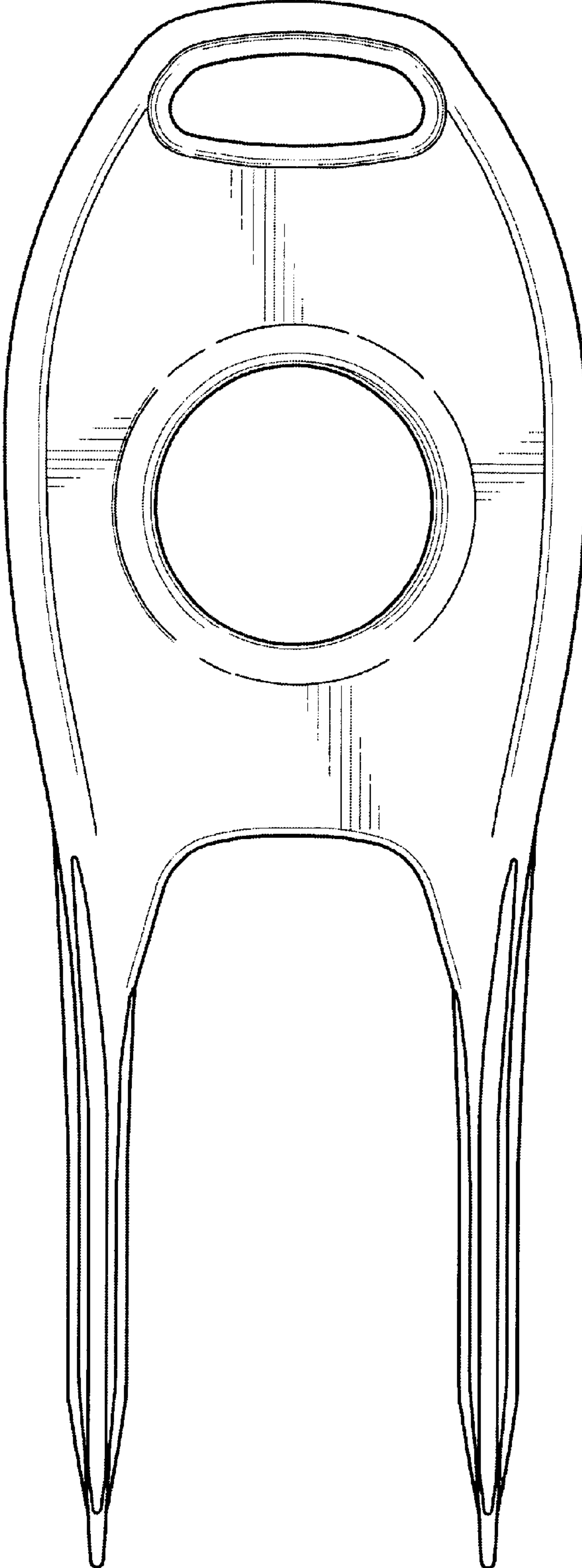

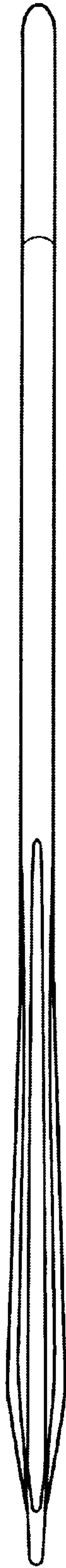

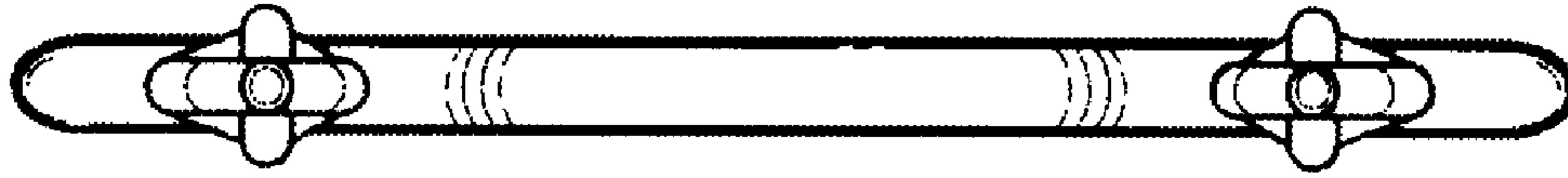

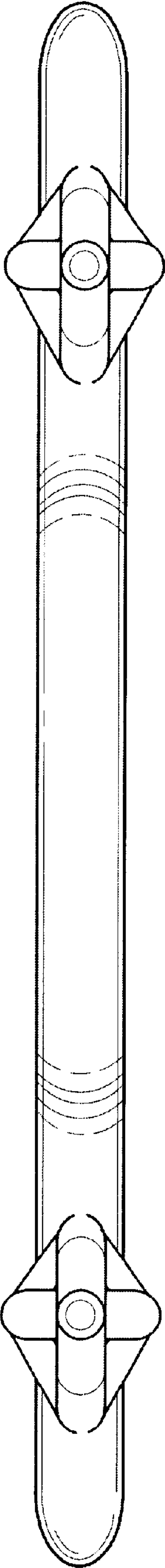

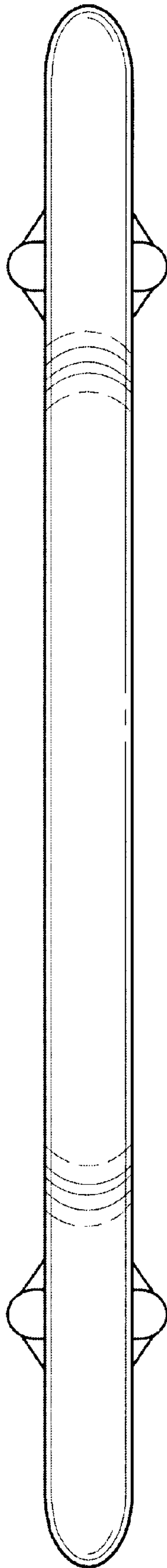
