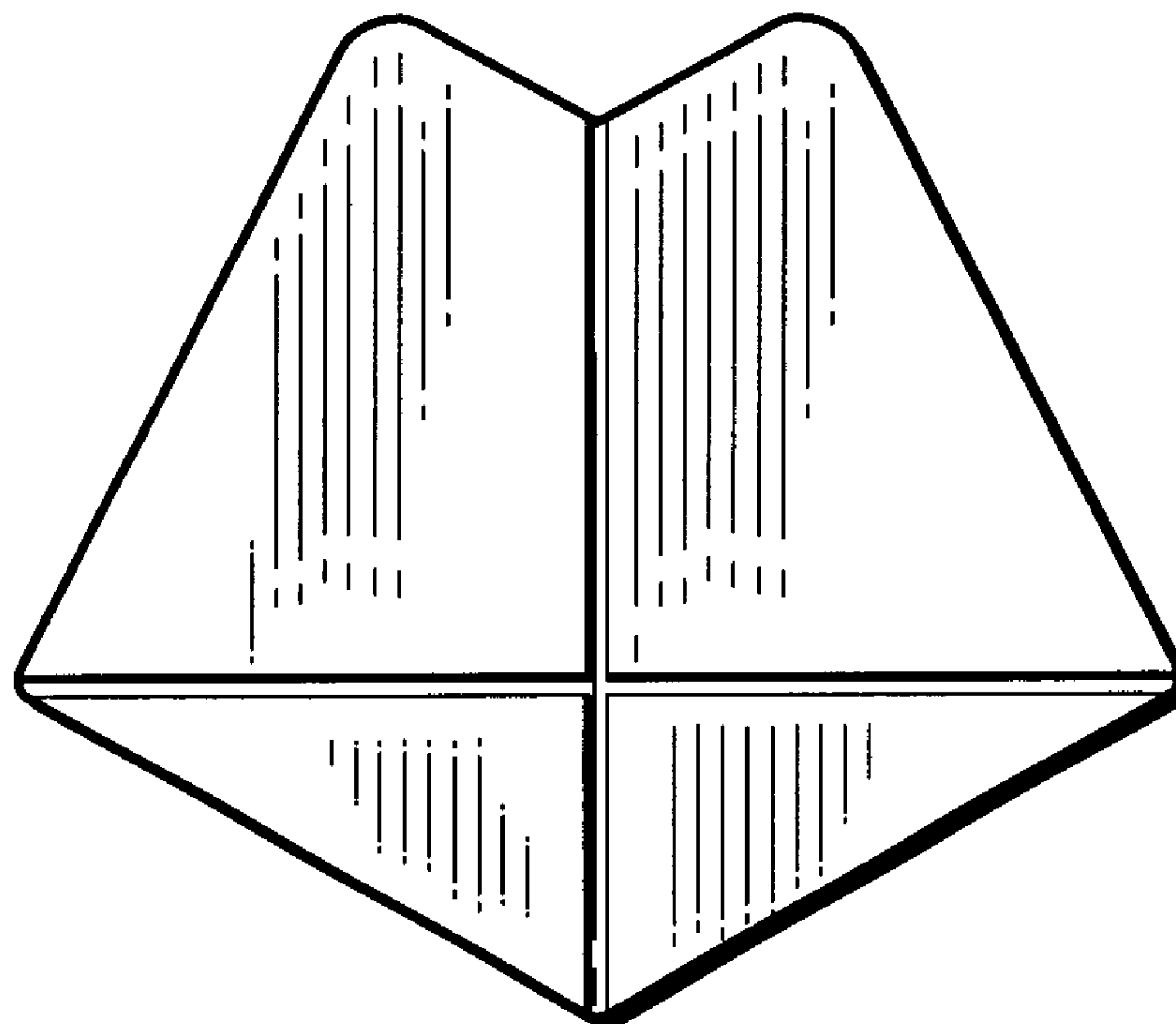
FIG. 8 is a side view of the golf ball marker of FIG. 6 taken from the right in FIG. 6;

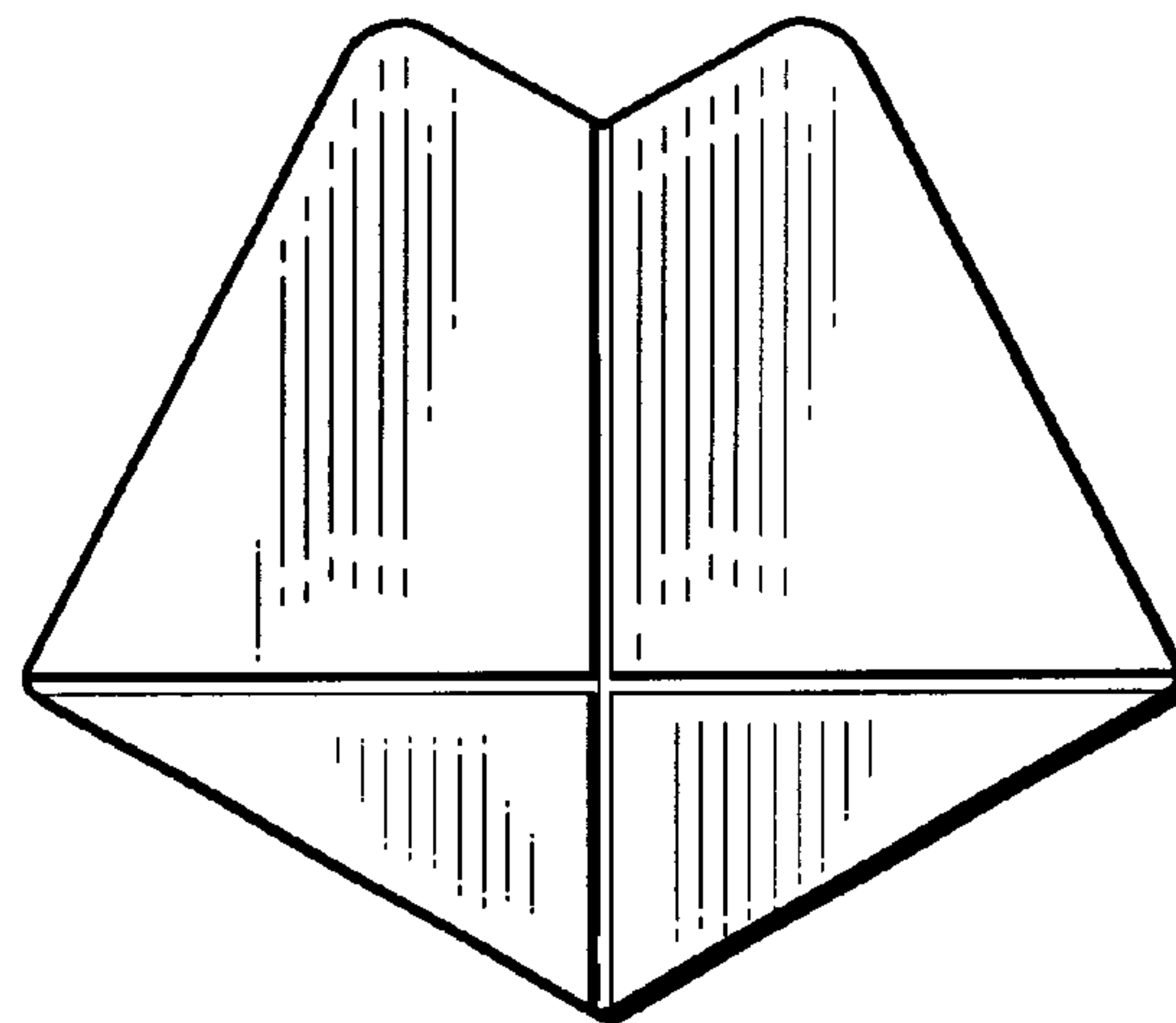

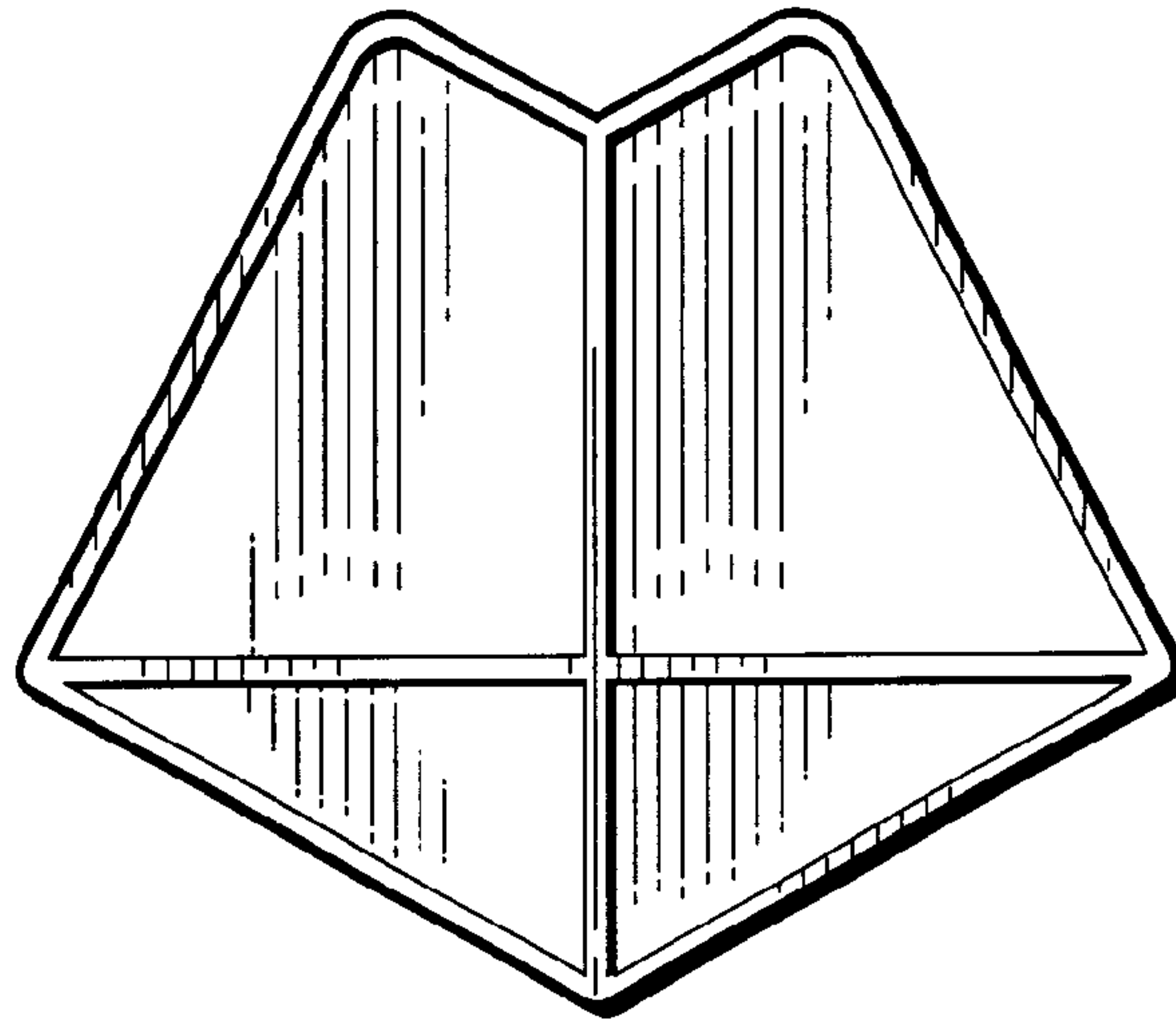
