DESCRIPTION

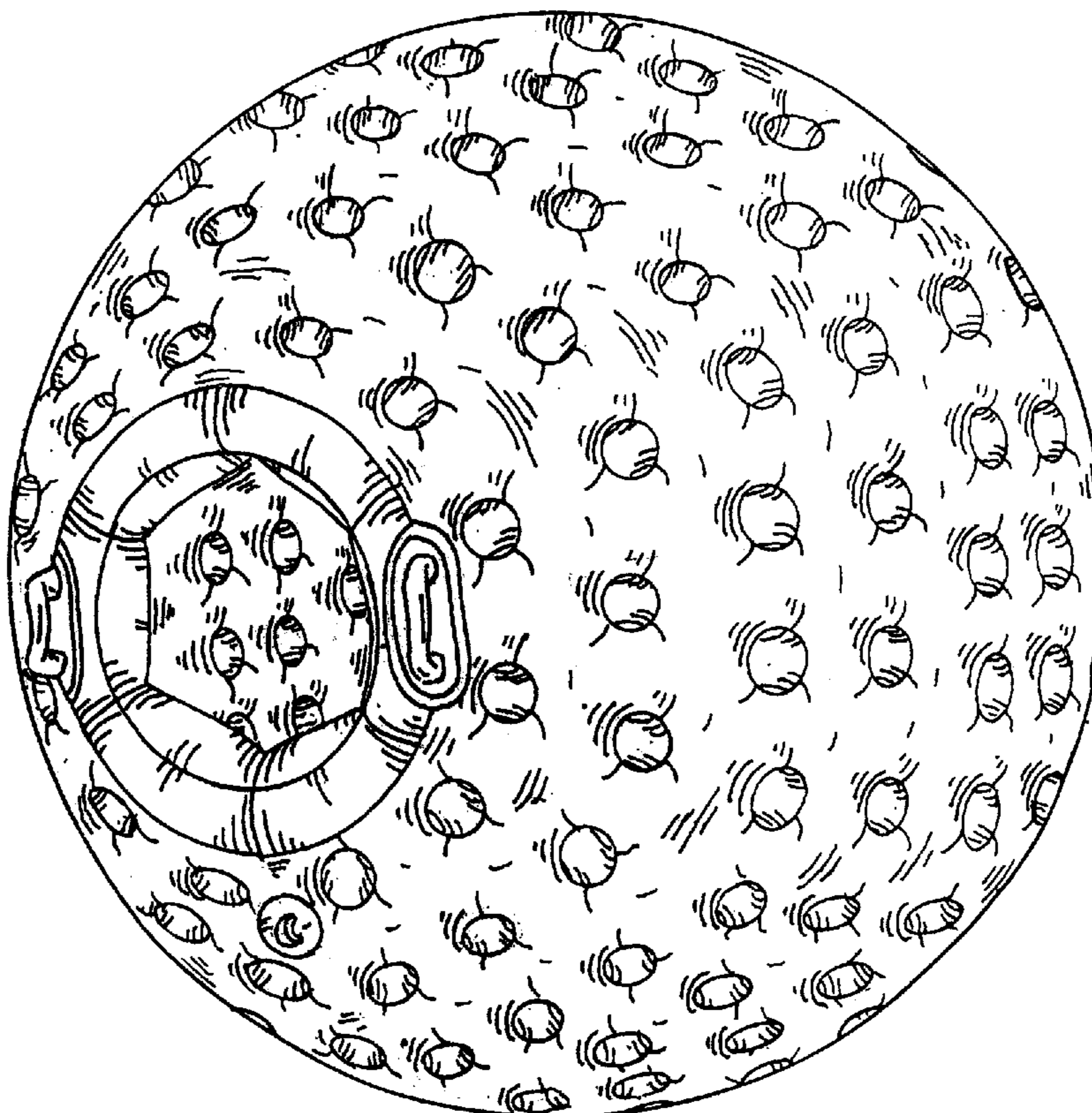
FIG. 1 is a perspective view of the watersports globe showing my new design;

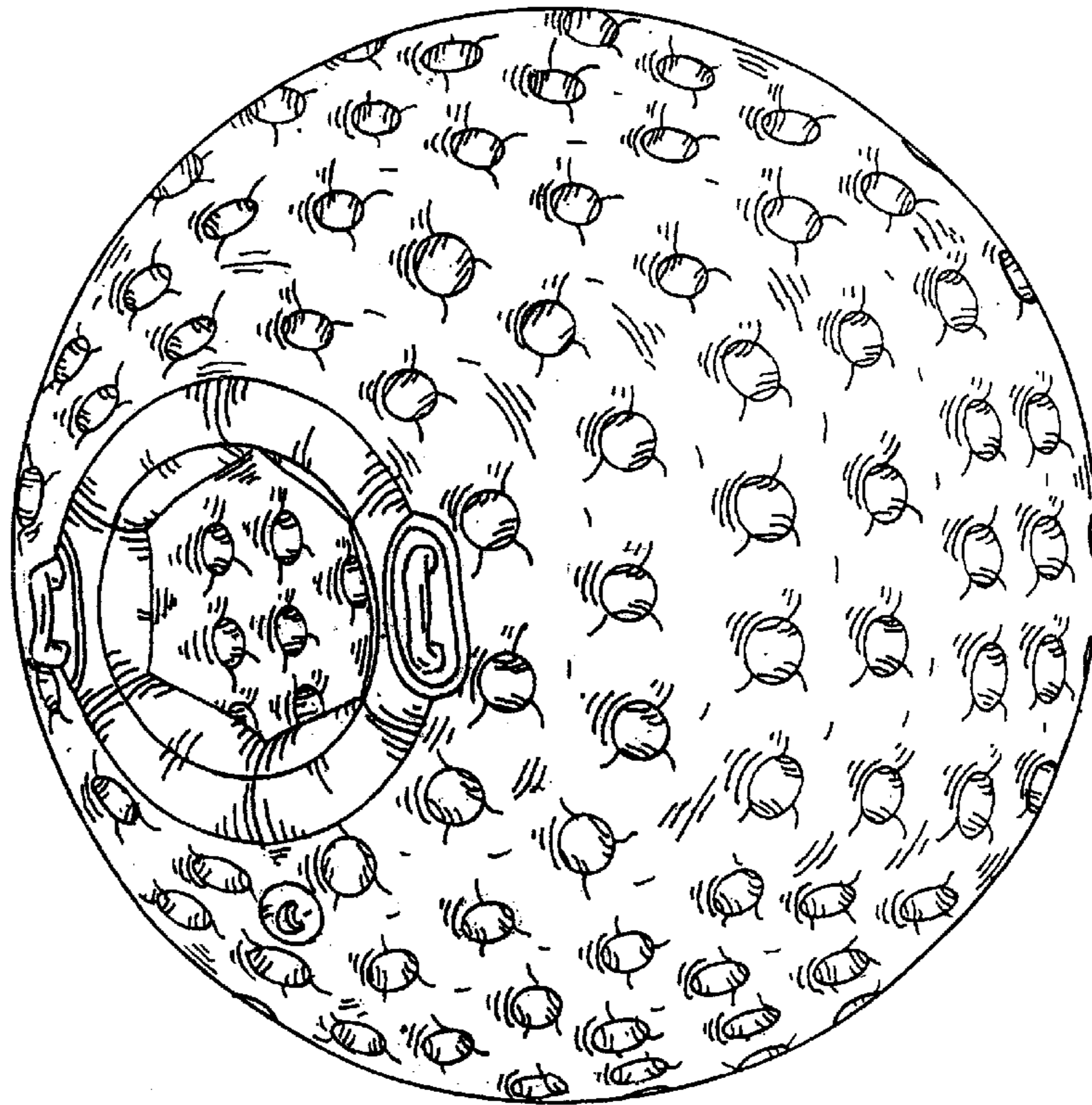

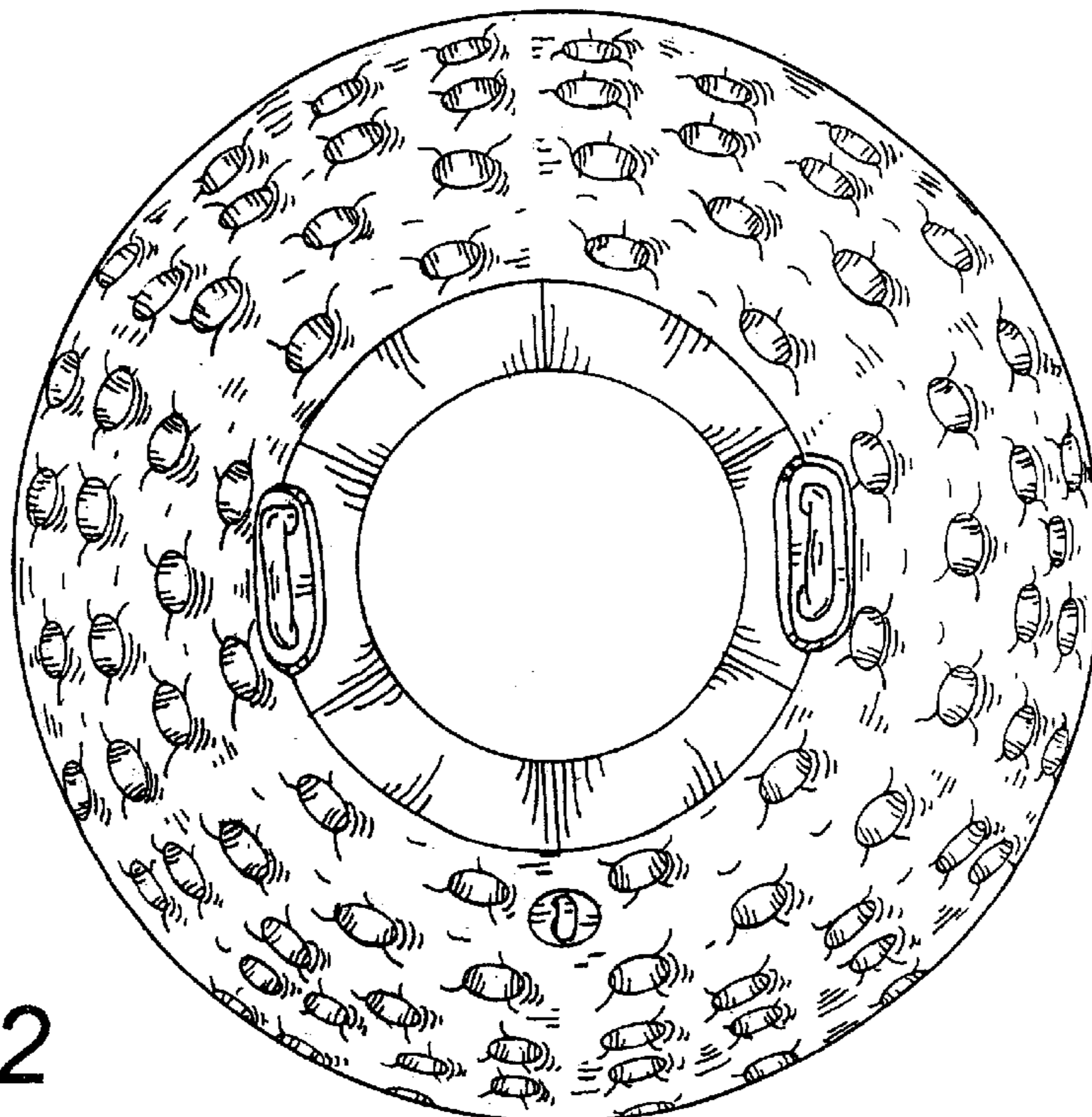

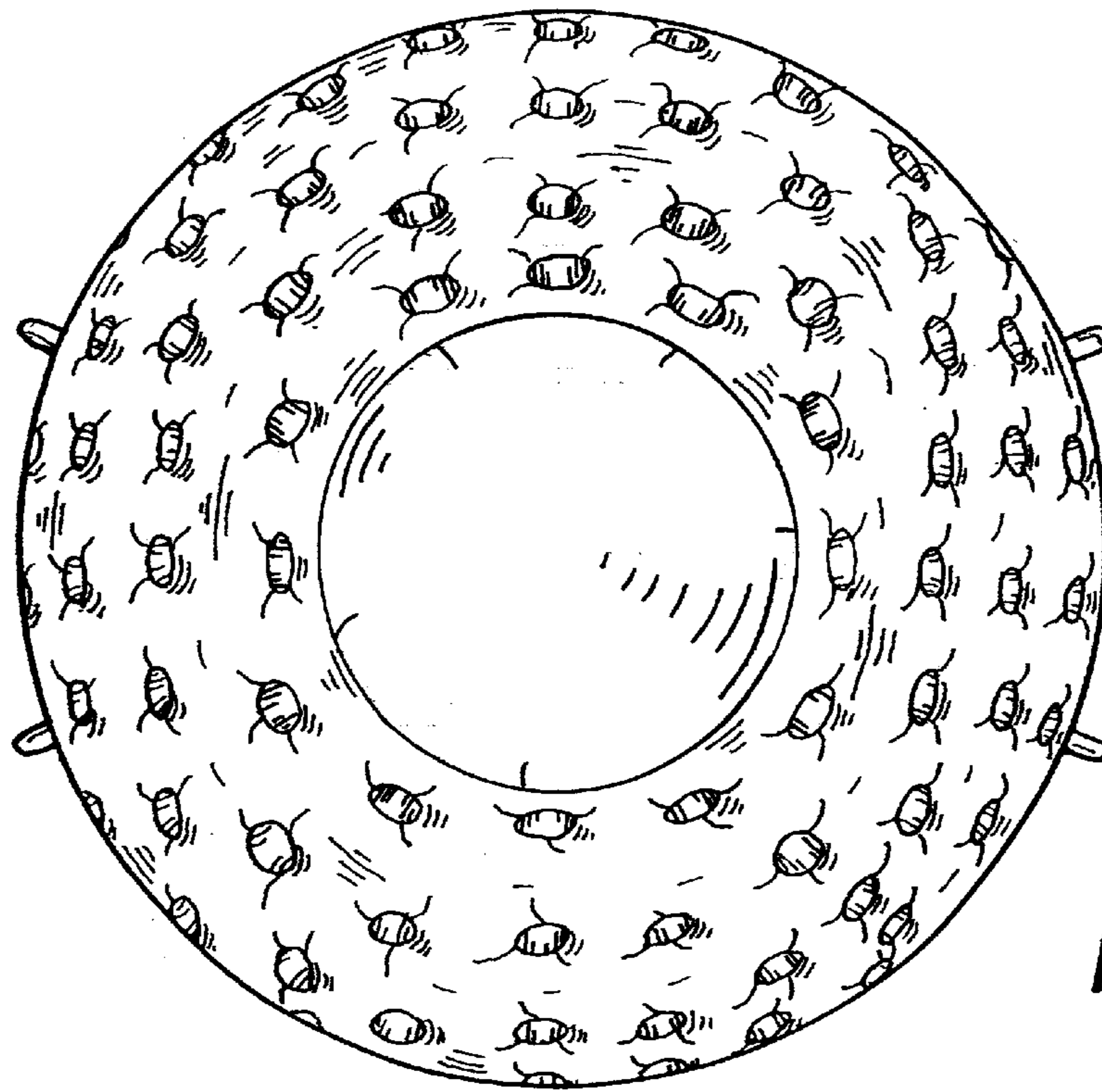

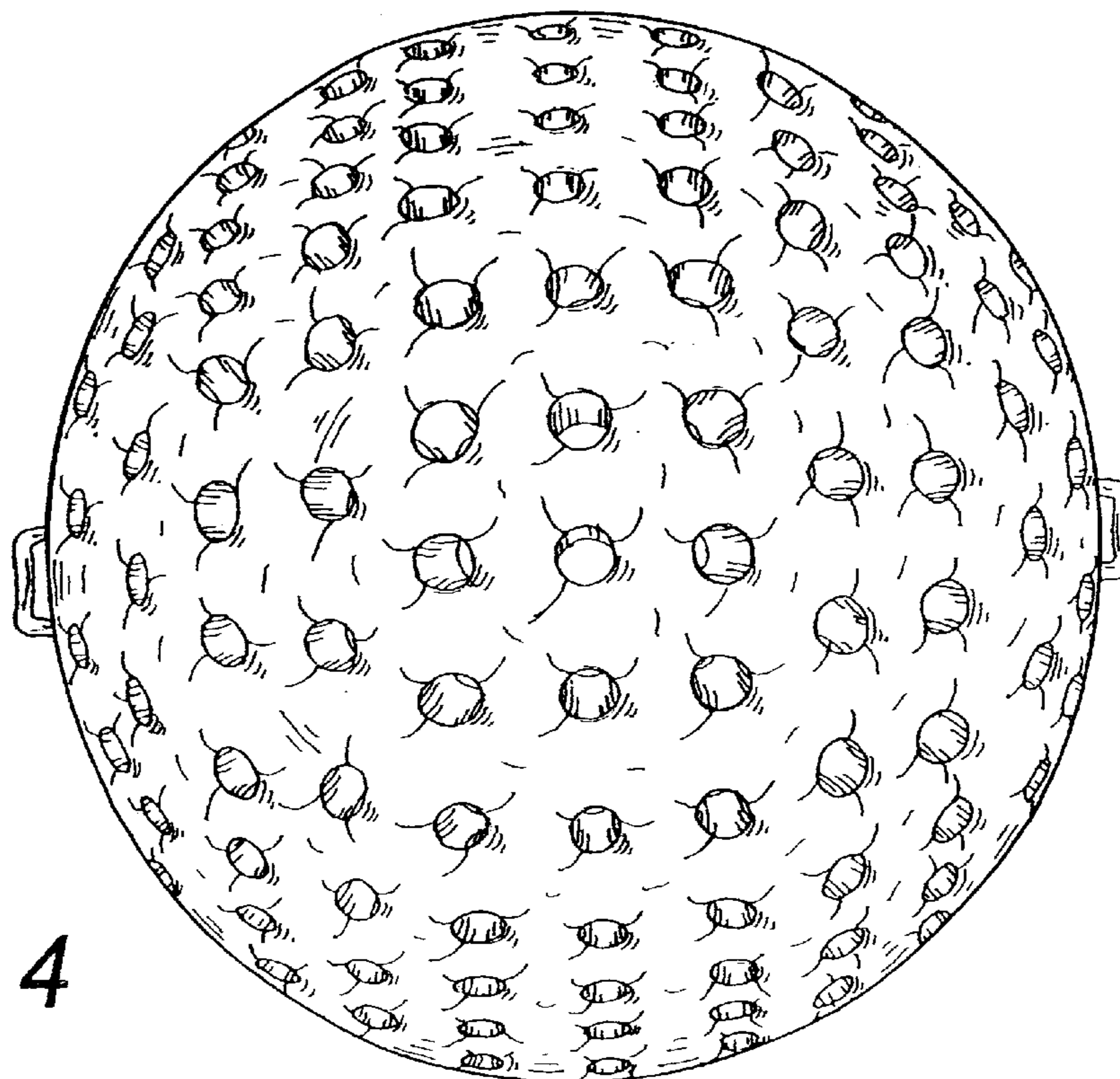
