(57) **CLAIM**

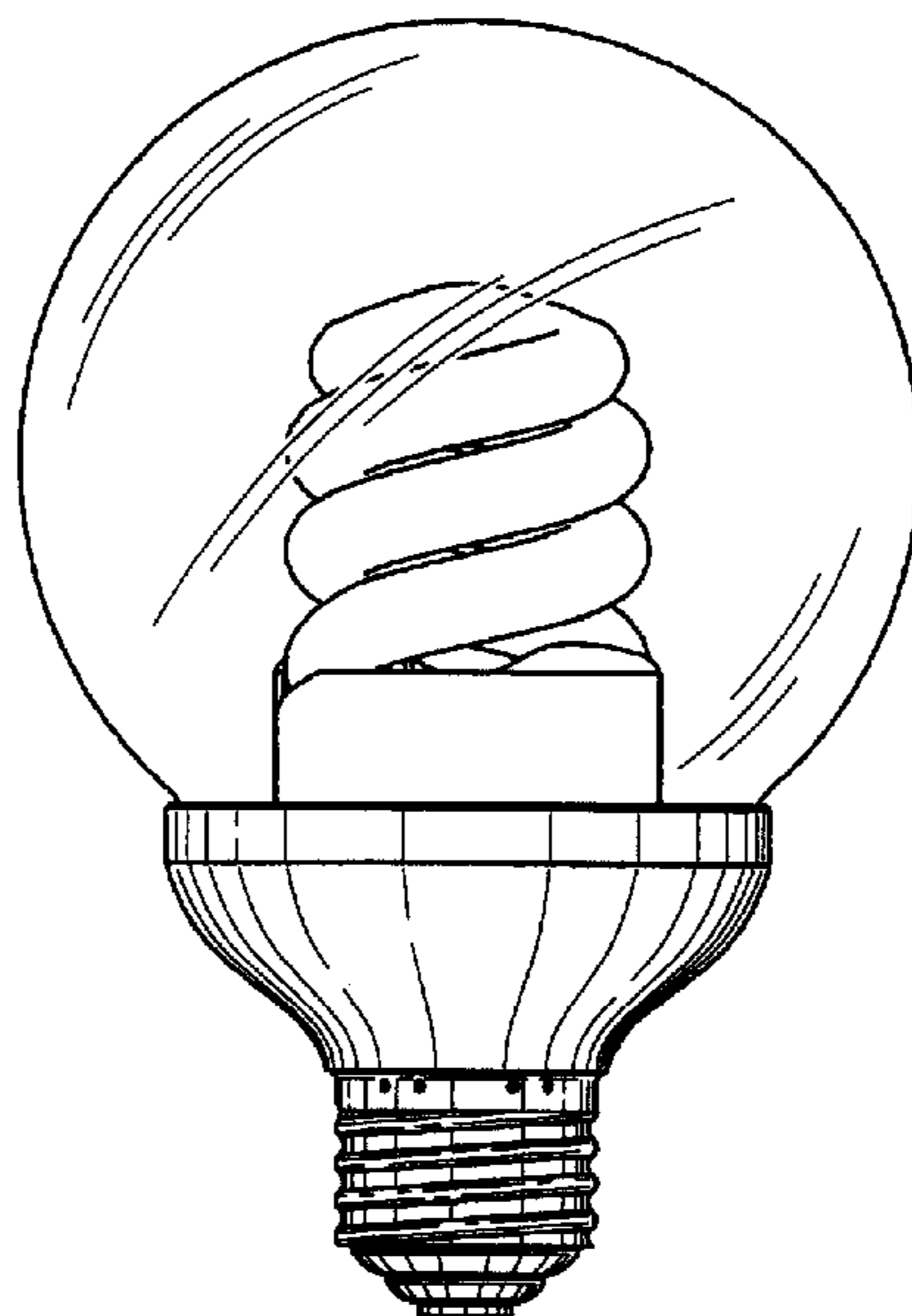
We claim the ornamental design for a fluorescent lamp, as shown and described.

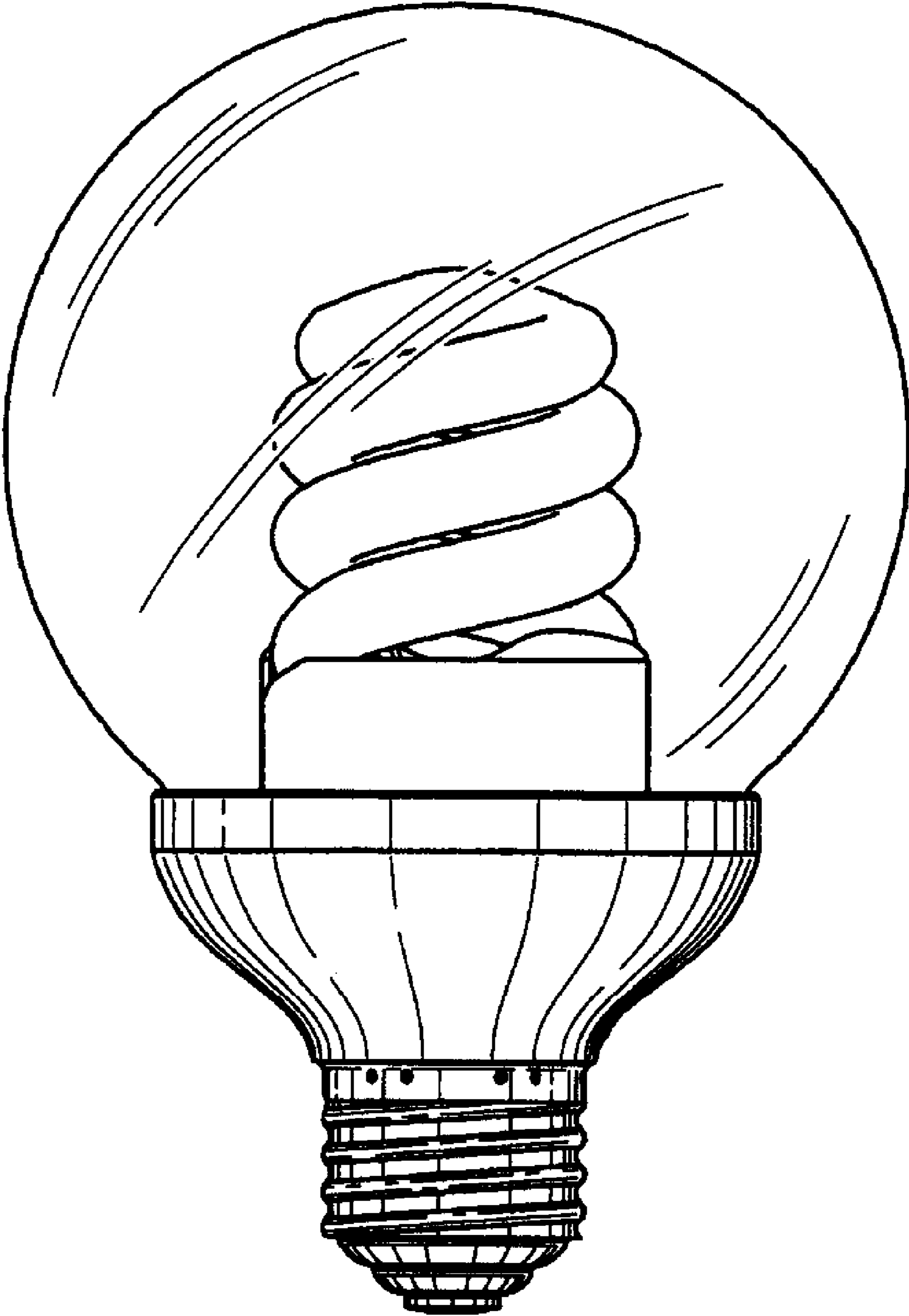

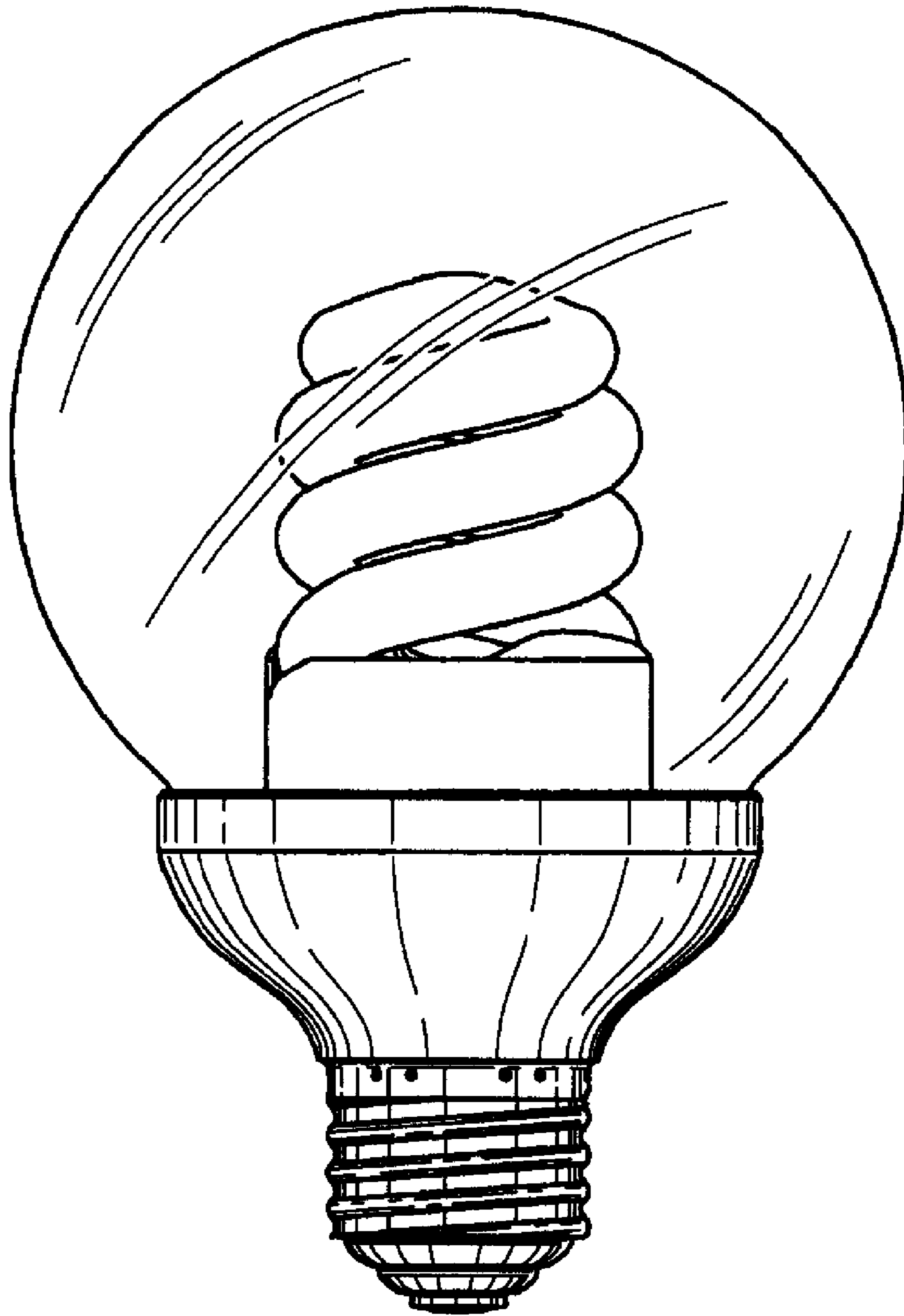

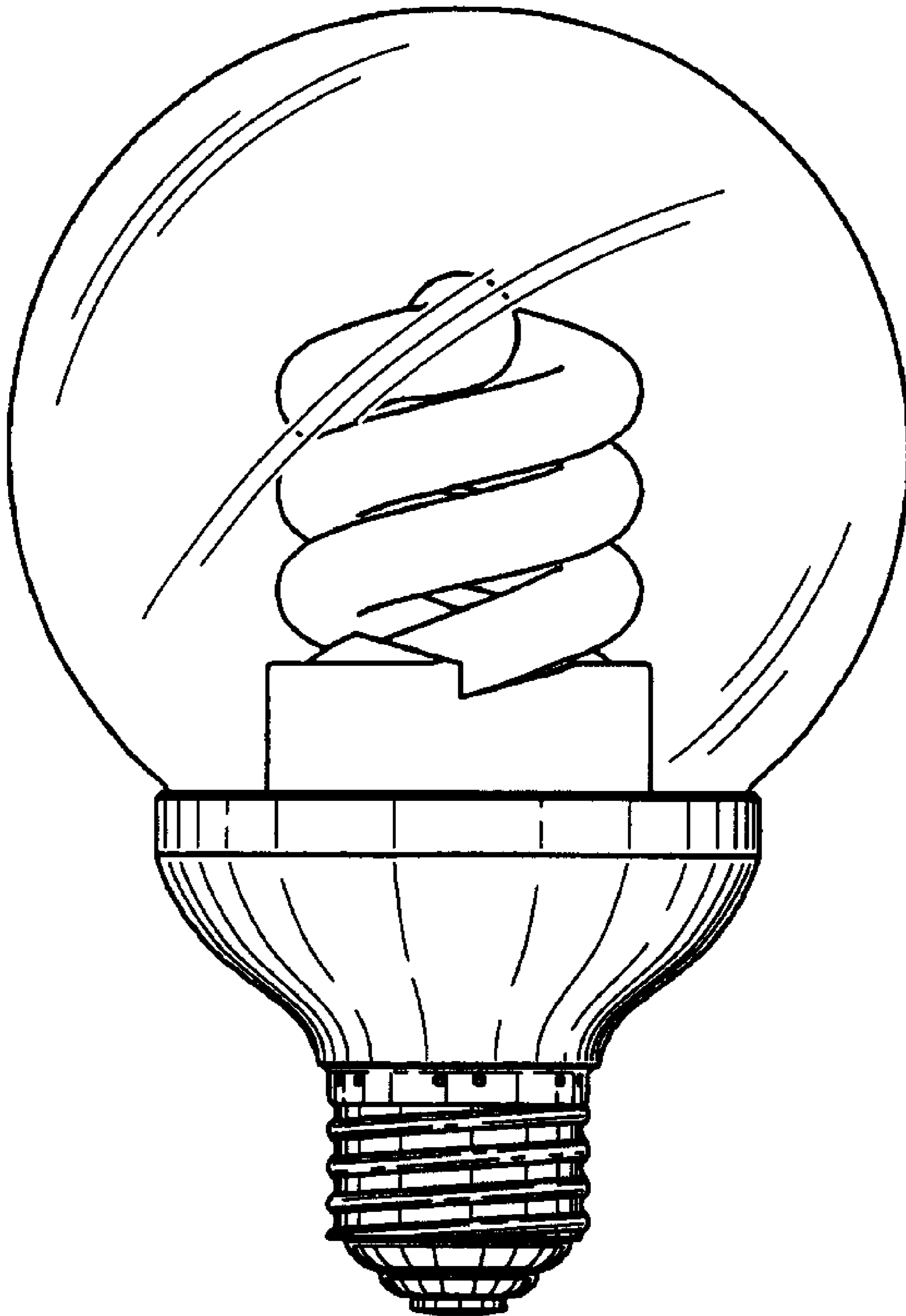

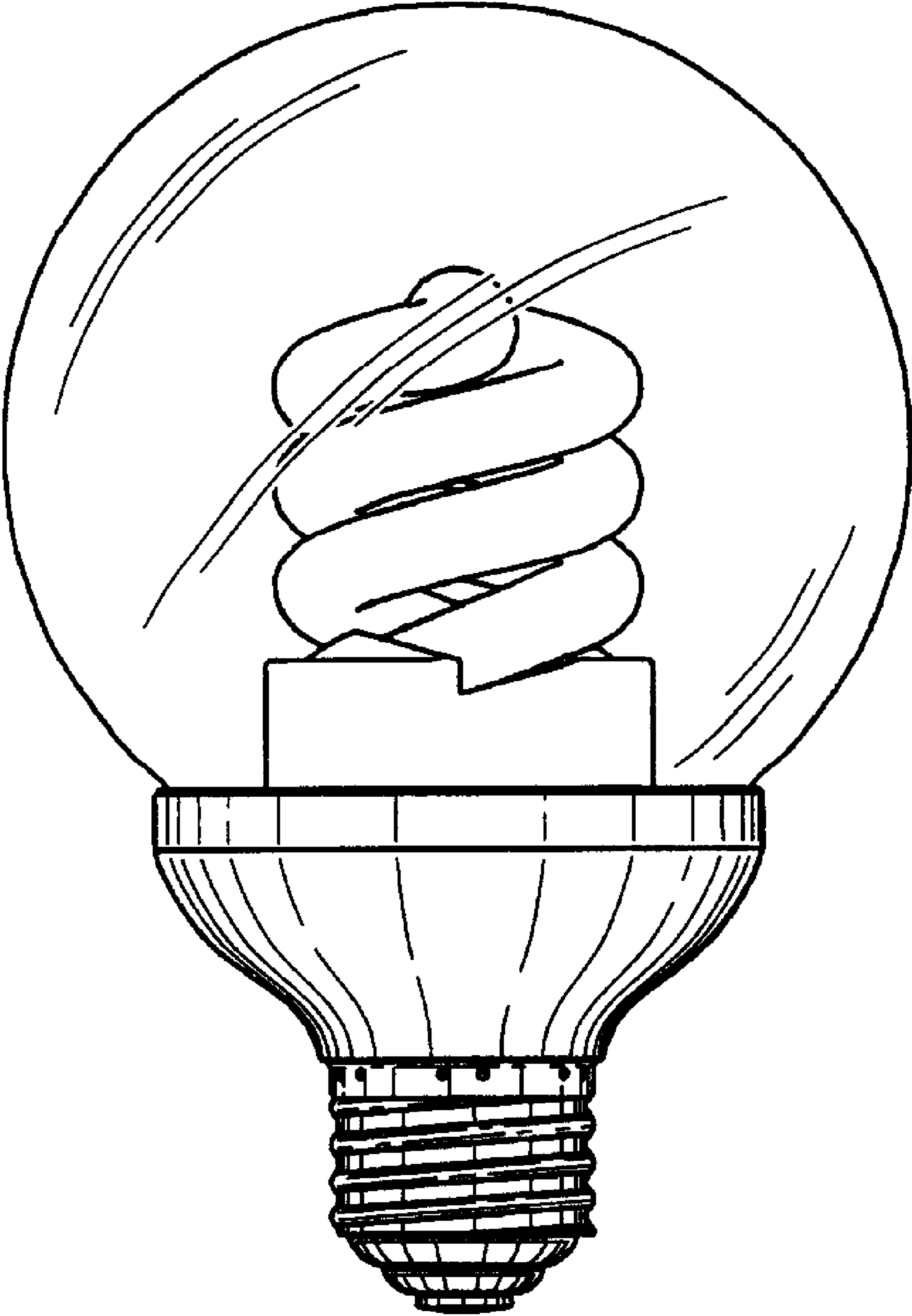

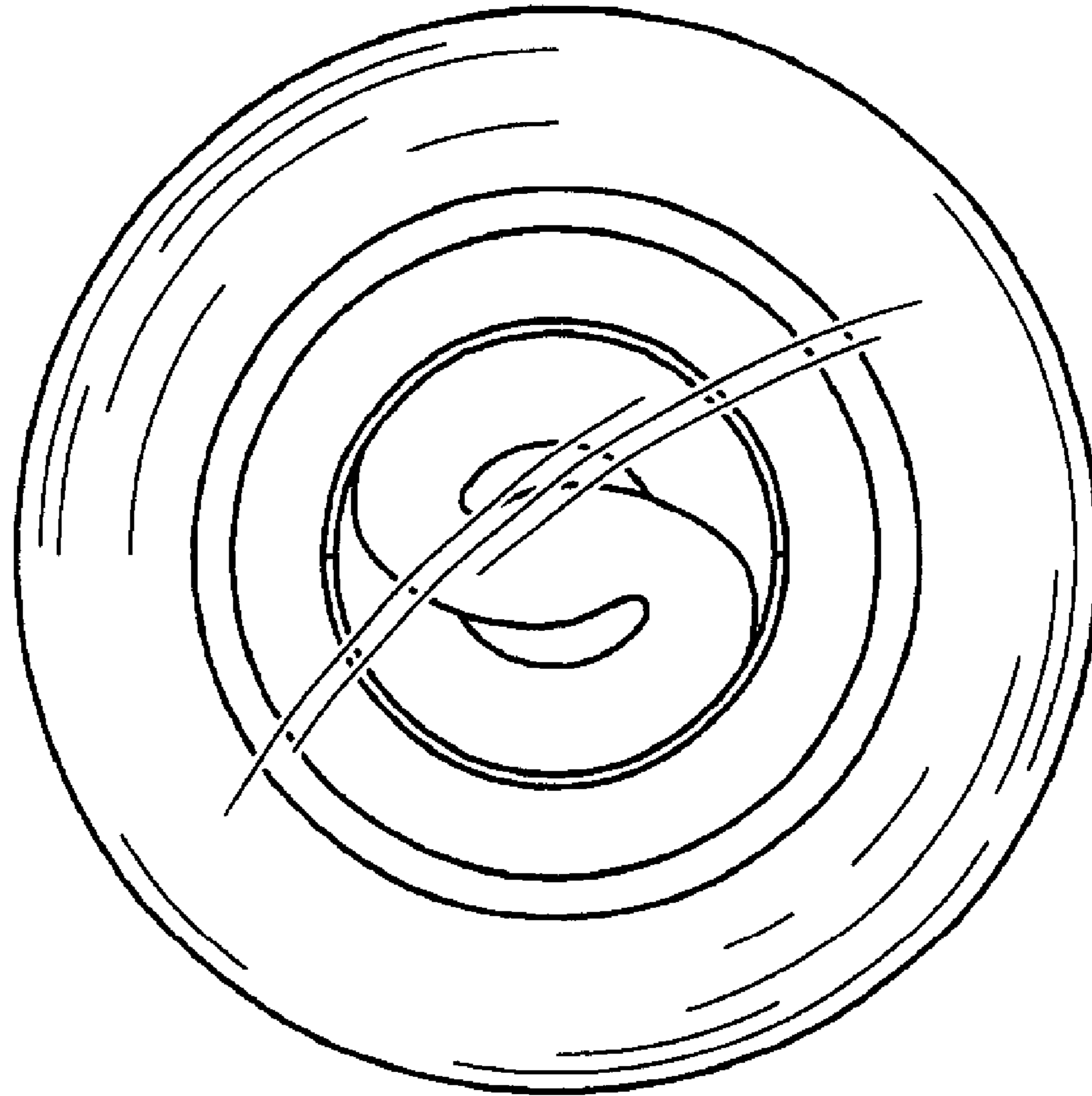

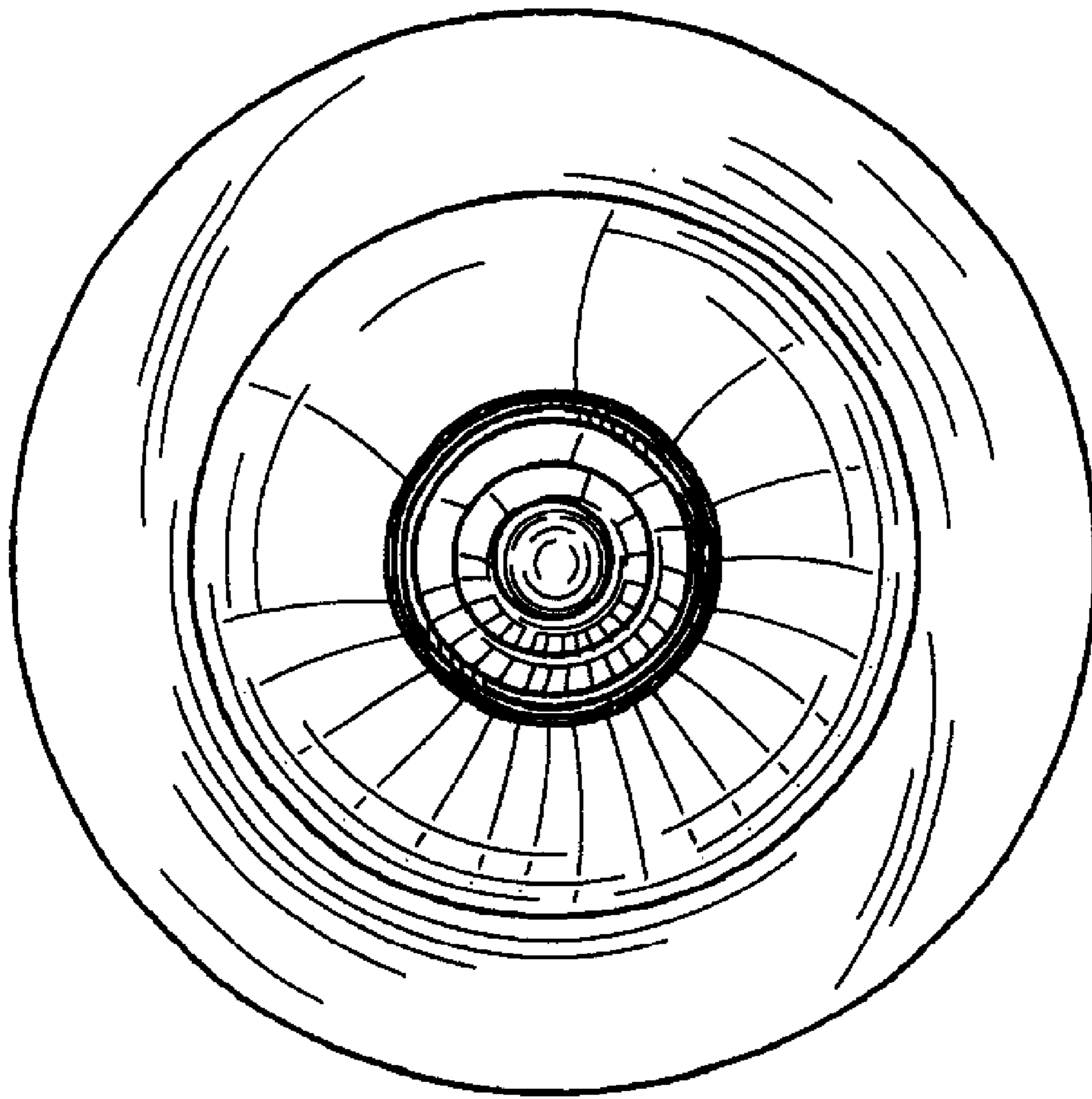
