DESCRIPTION

FIG. 1 is a perspective view of the laundry cart with large diameter tubing and angular basket structure of the present invention;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right-side elevation view thereof, the left-side elevation view being a mirror image;

FIG. 4 is a back elevation thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of a laundry cart with large diameter tubing and angular basket structure according to a first alternative embodiment of the present invention; and,

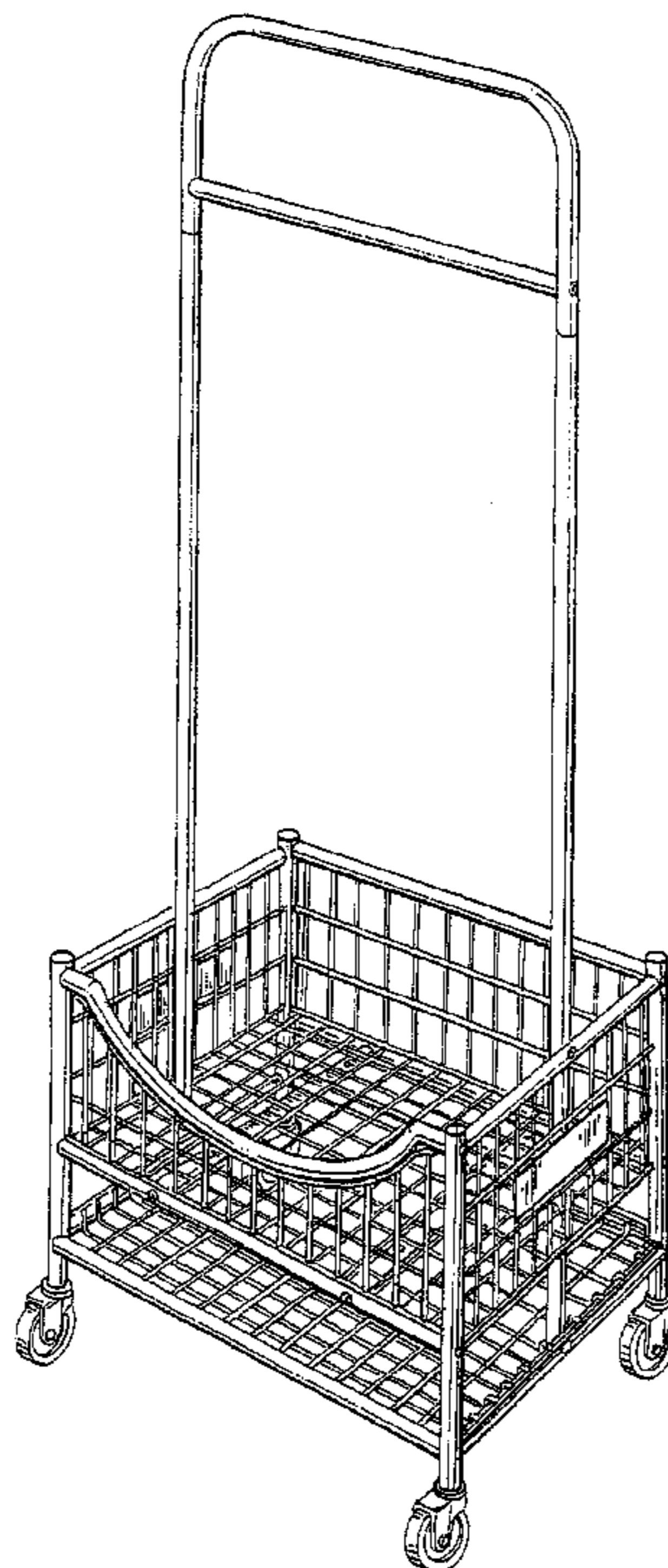
FIG. 8 is a perspective view of a laundry cart with large diameter tubing and angular basket structure according to a second alternative embodiment of the present invention;

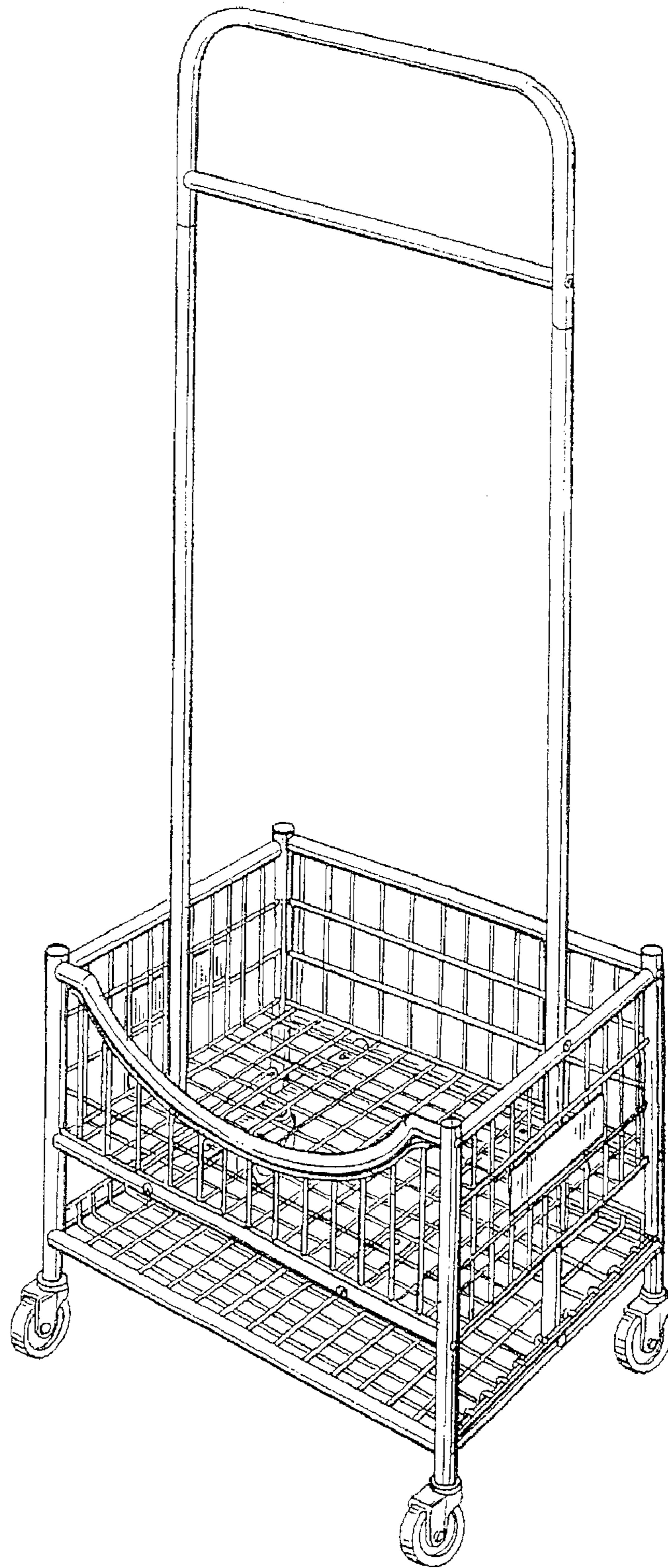

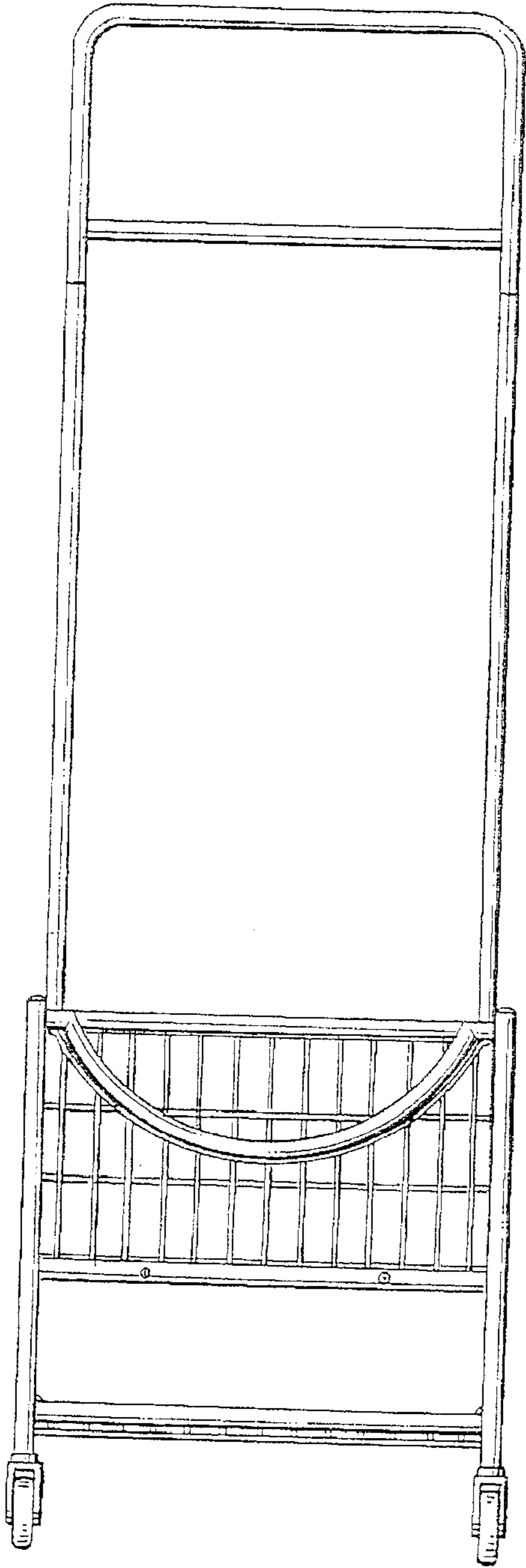

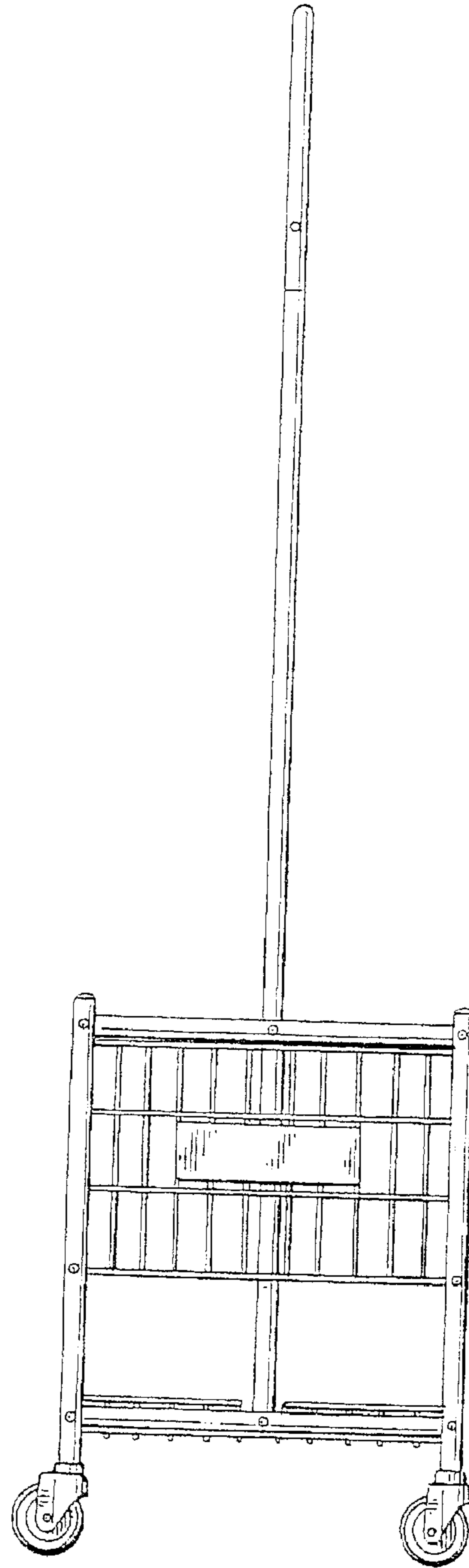

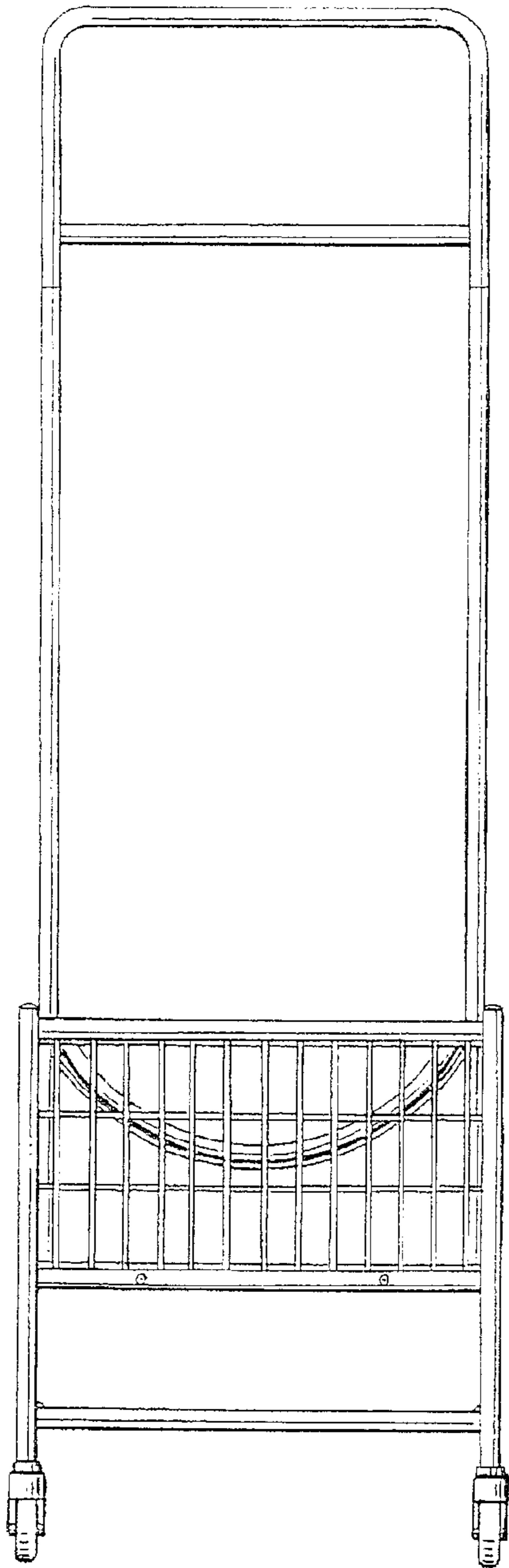

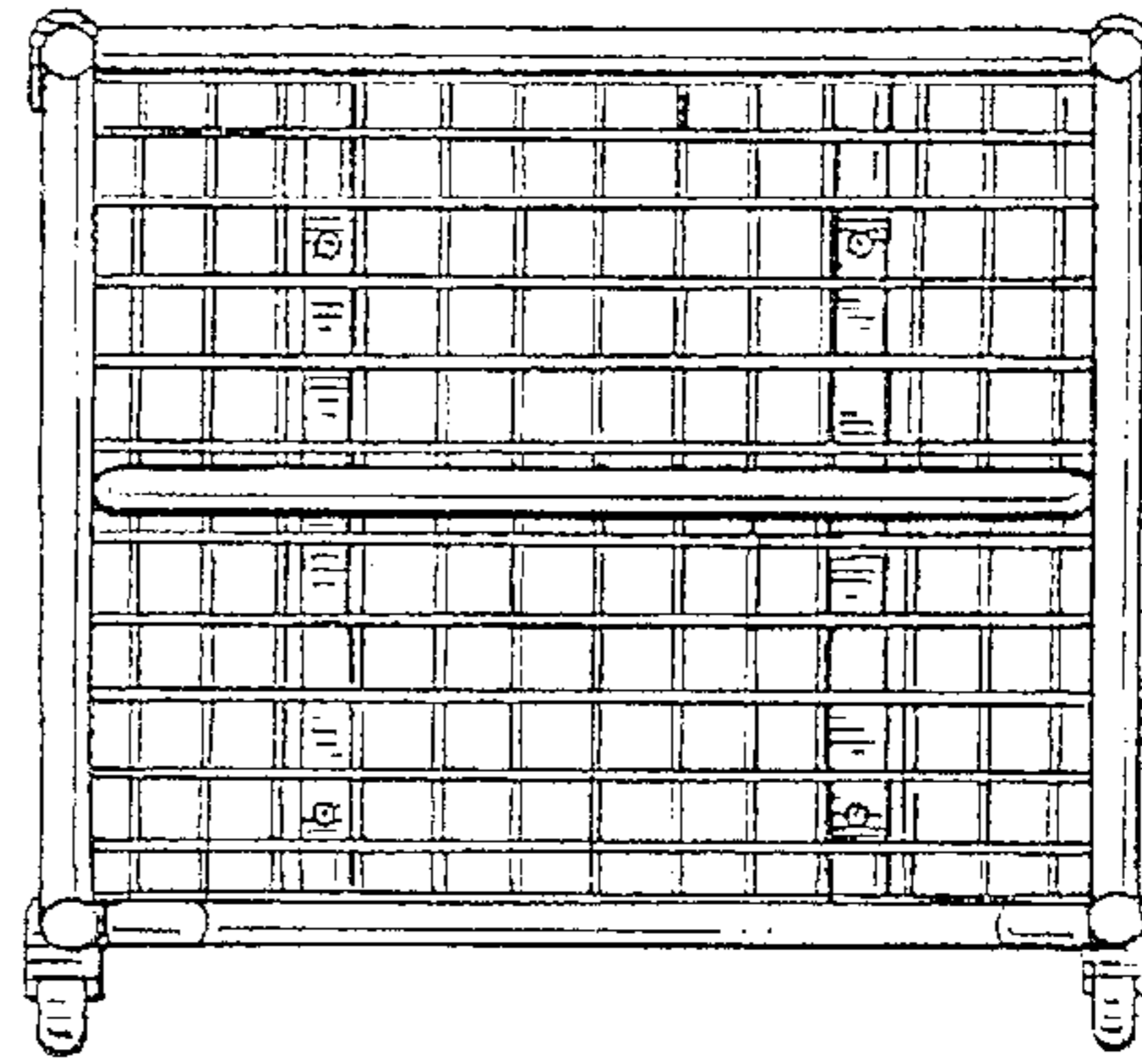

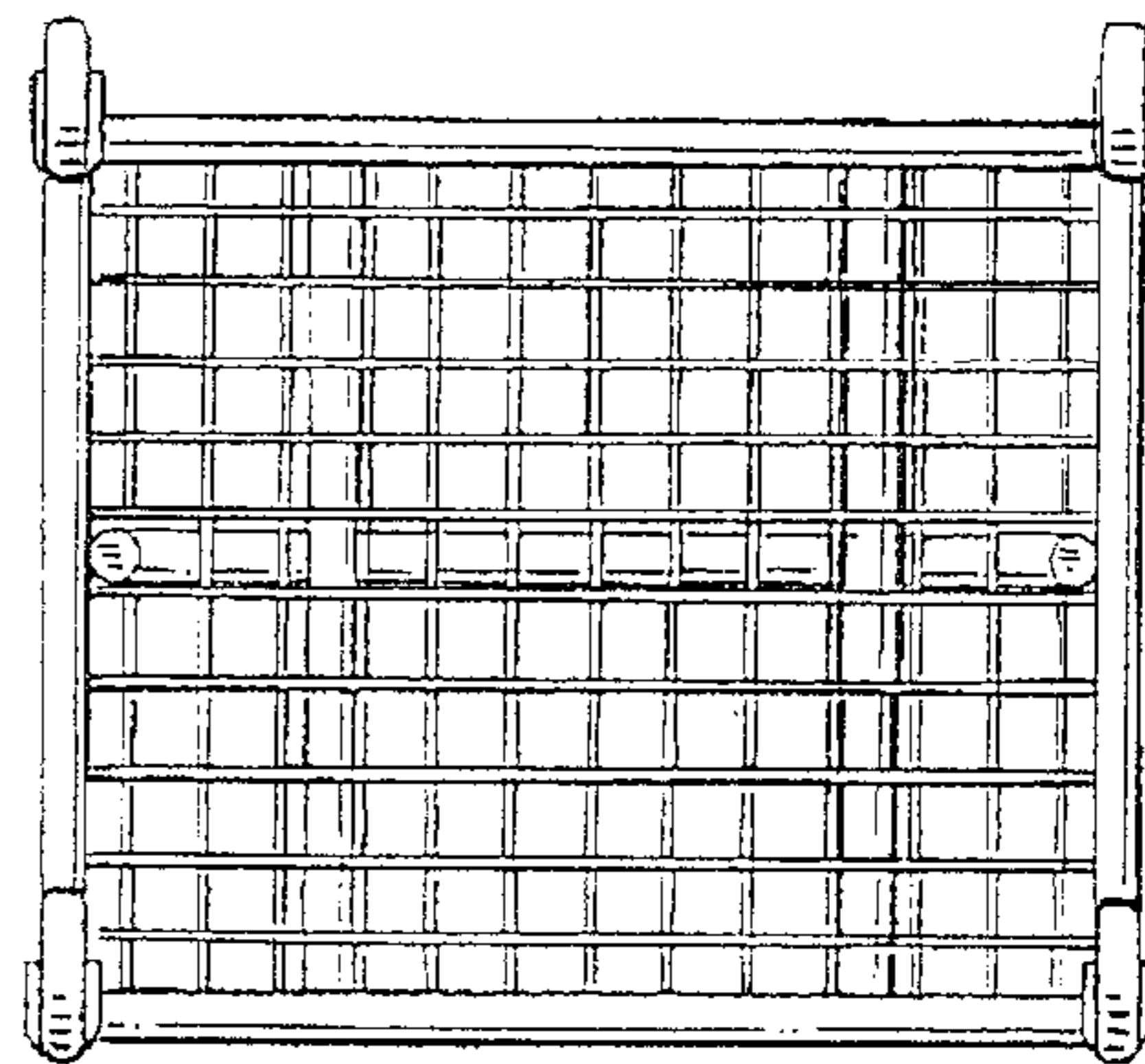

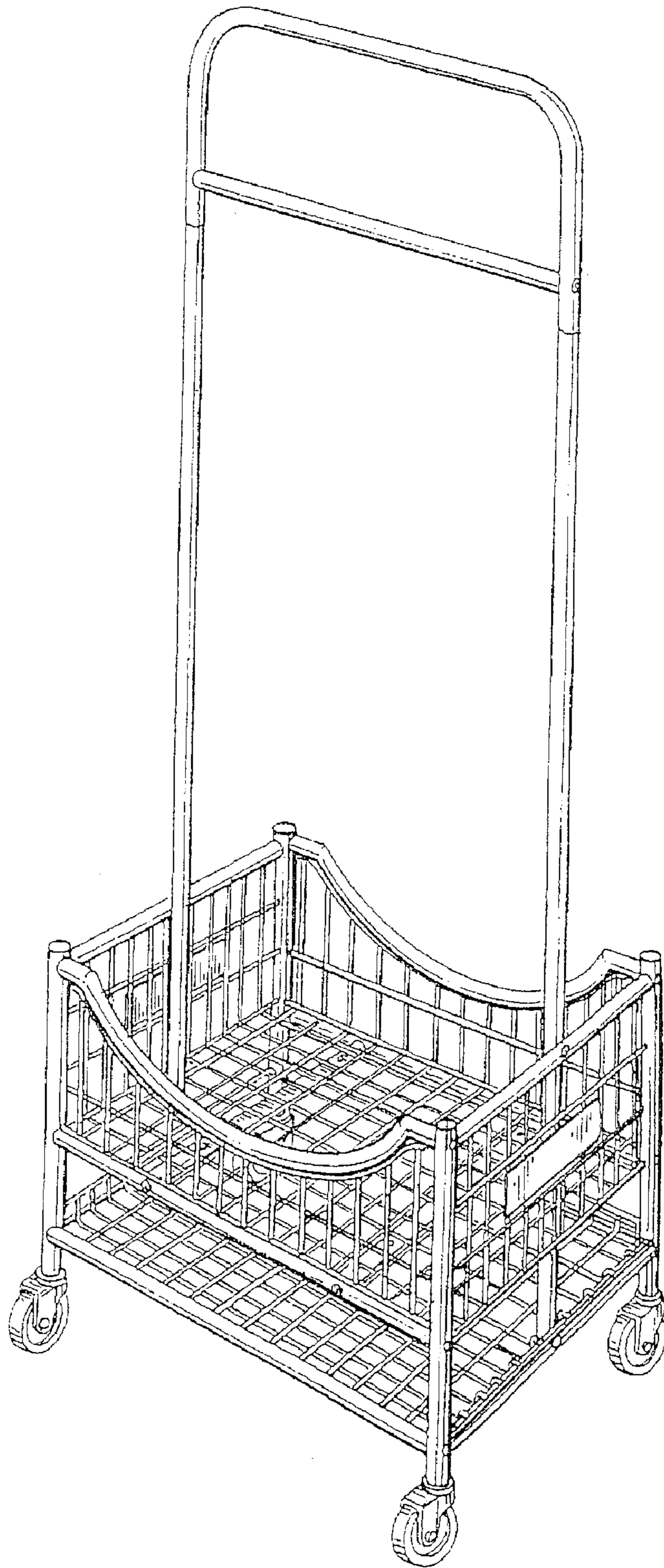

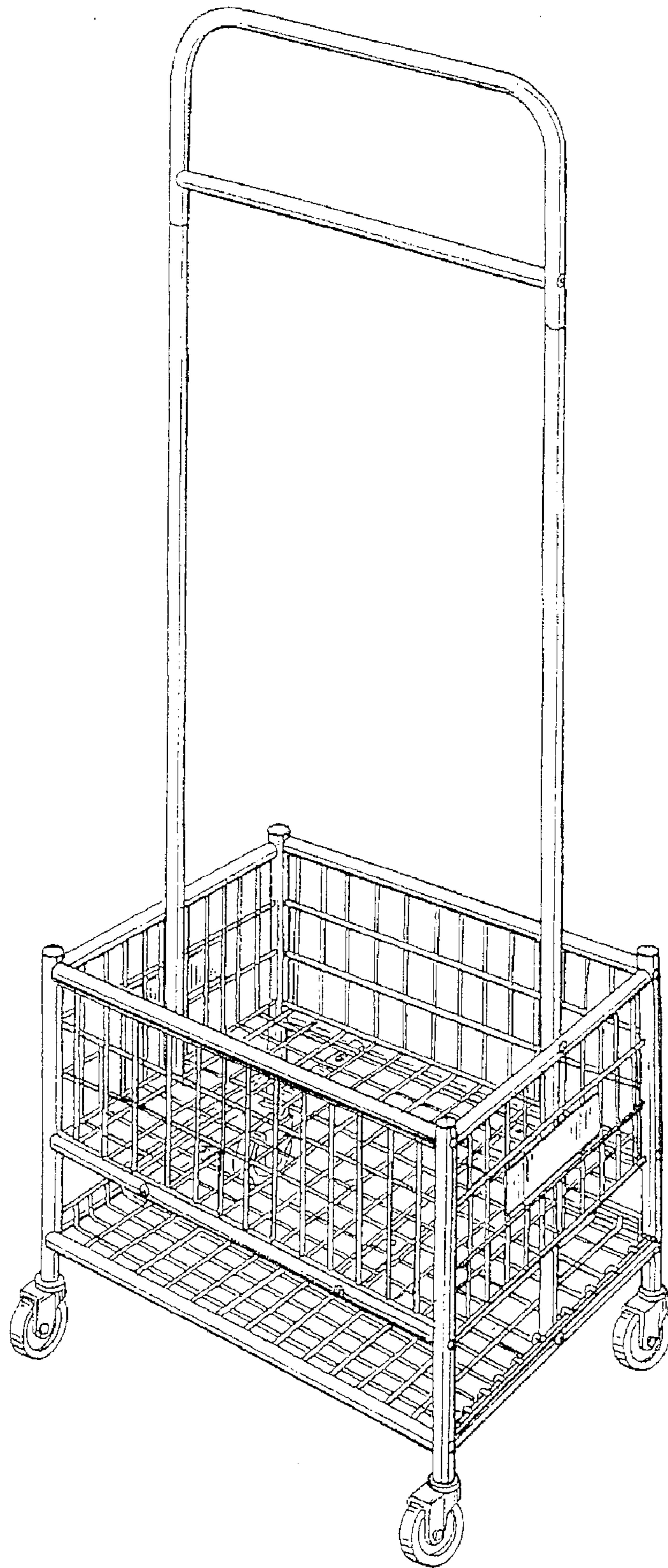
