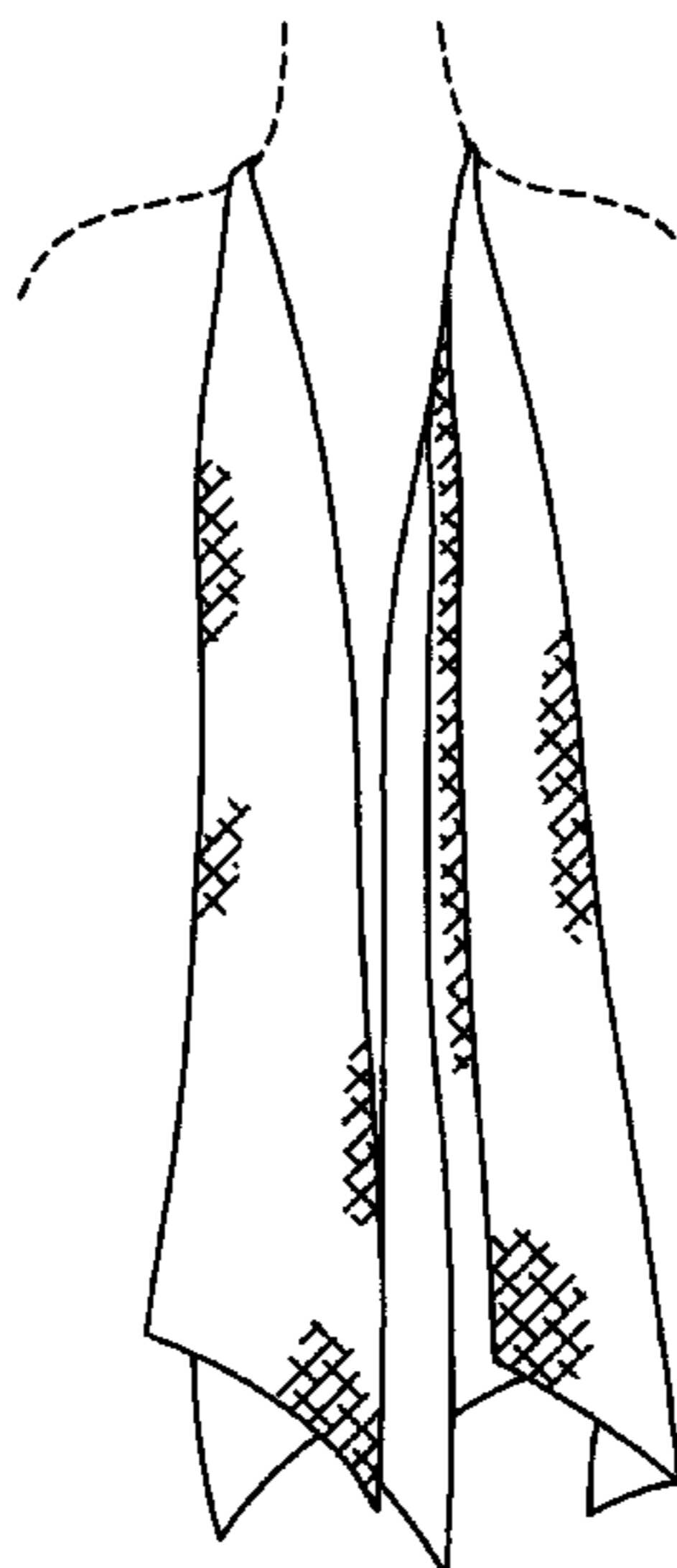
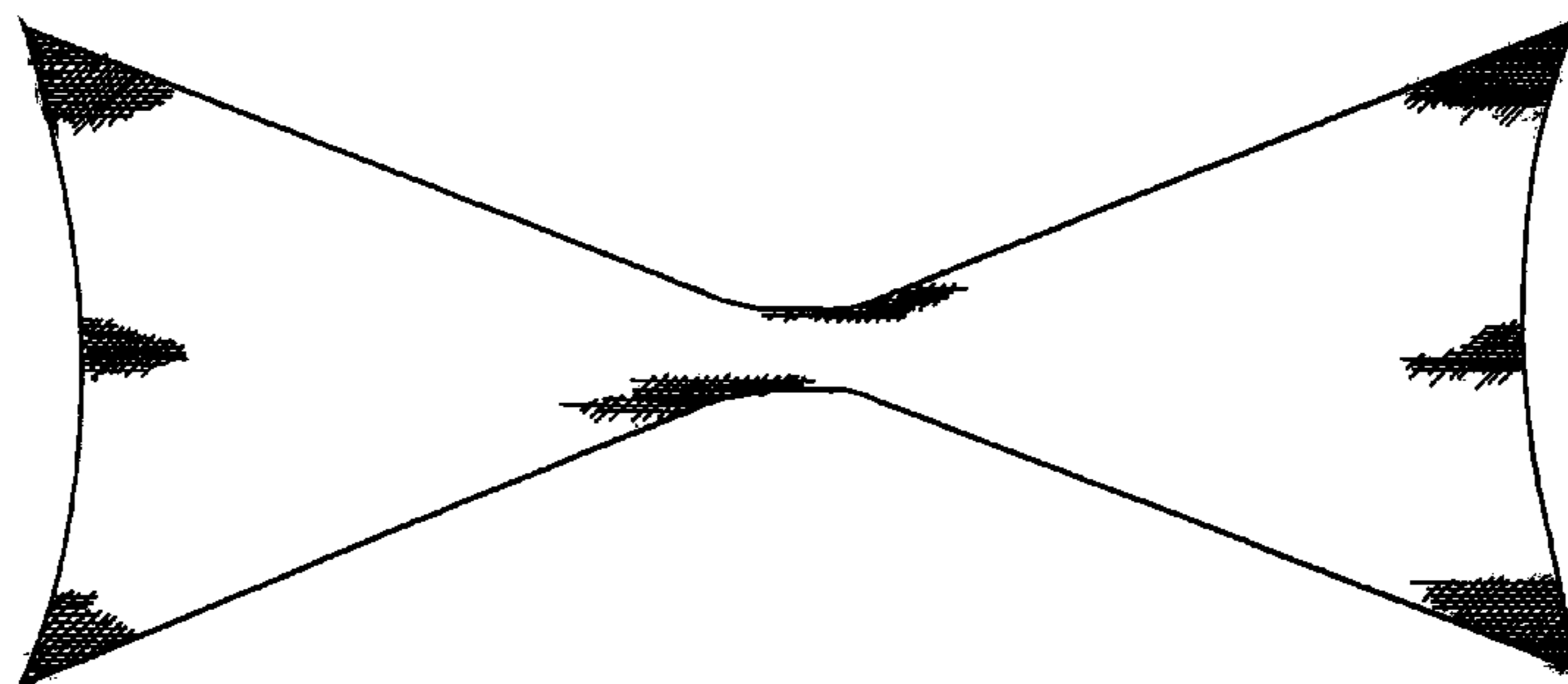
(57) **CLAIM**

The ornamental design for a scarf, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a scarf showing my new design; FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side view. FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image of the top plan view; FIG. 4 is a front perspective view thereof; and, FIG. 5 is a rear perspective view thereof.

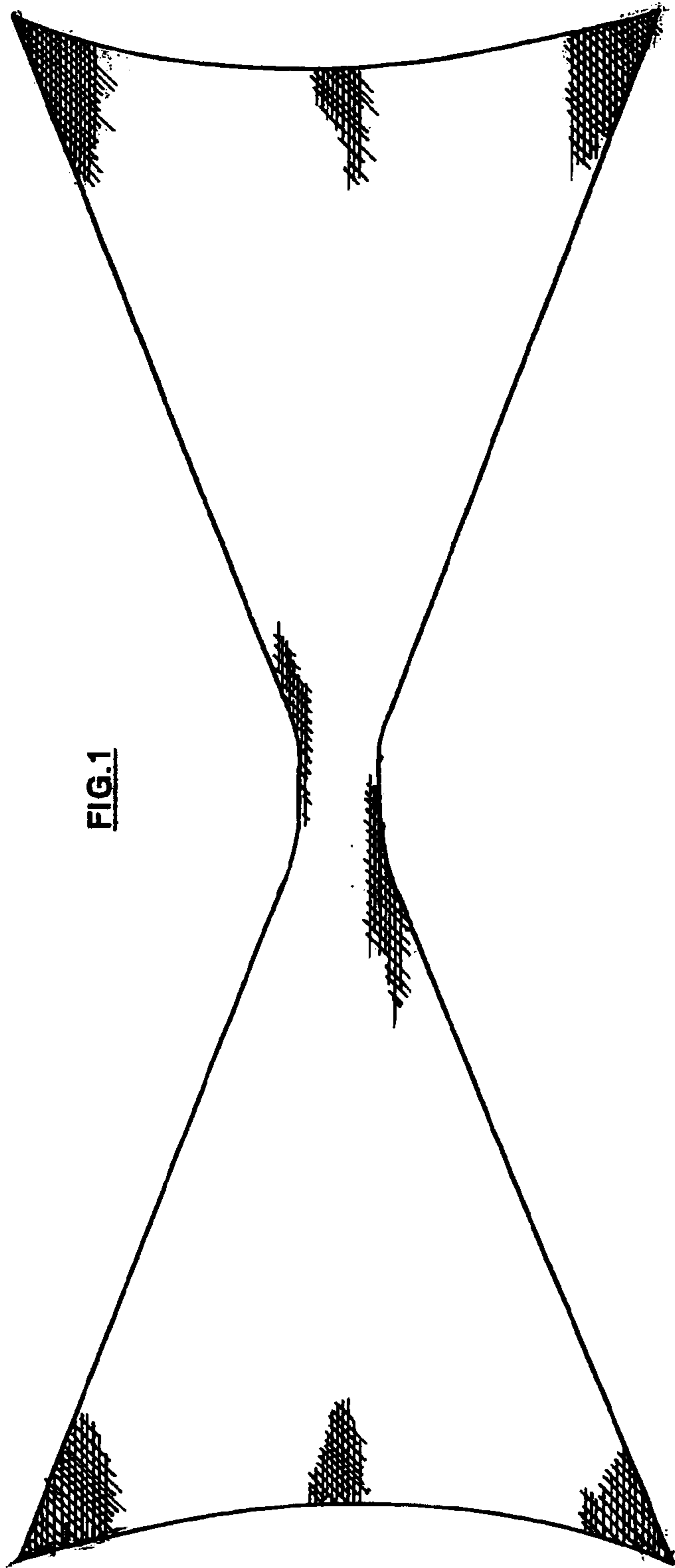

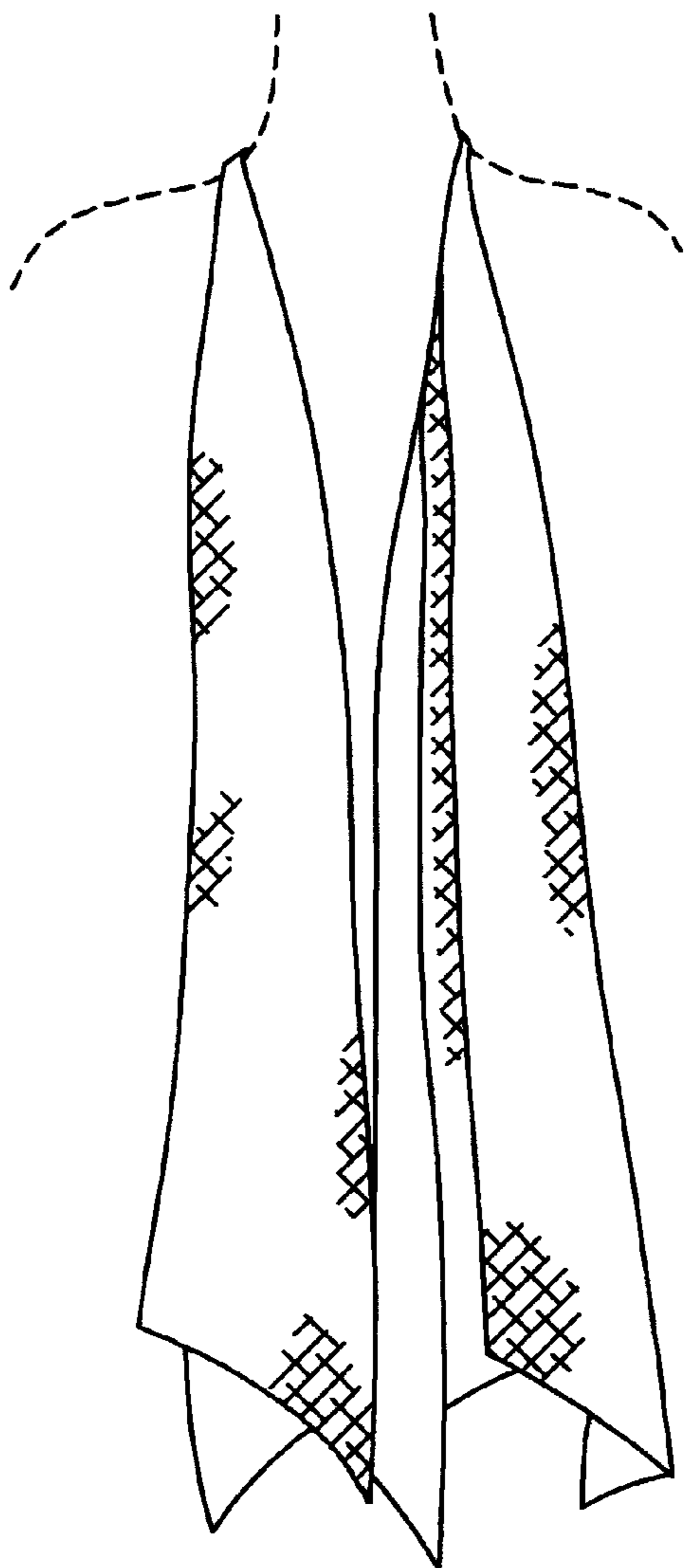
