(57) **CLAIM**

I claim the ornamental design for a musical instrument case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a musical instrument case showing our design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top perspective view thereof;

FIG. 6 is a bottom perspective view thereof;

FIG. 7 is a back elevational view thereof;

FIG. 8 is perspective view an alternative embodiment of a musical instrument case showing our design;

FIG. 9 is a front elevational view of the alternative embodiment which is substantially the same as FIG. 2;

FIG. 10 is a left side elevational view of the alternative embodiment which is substantially the same as FIG. 3;

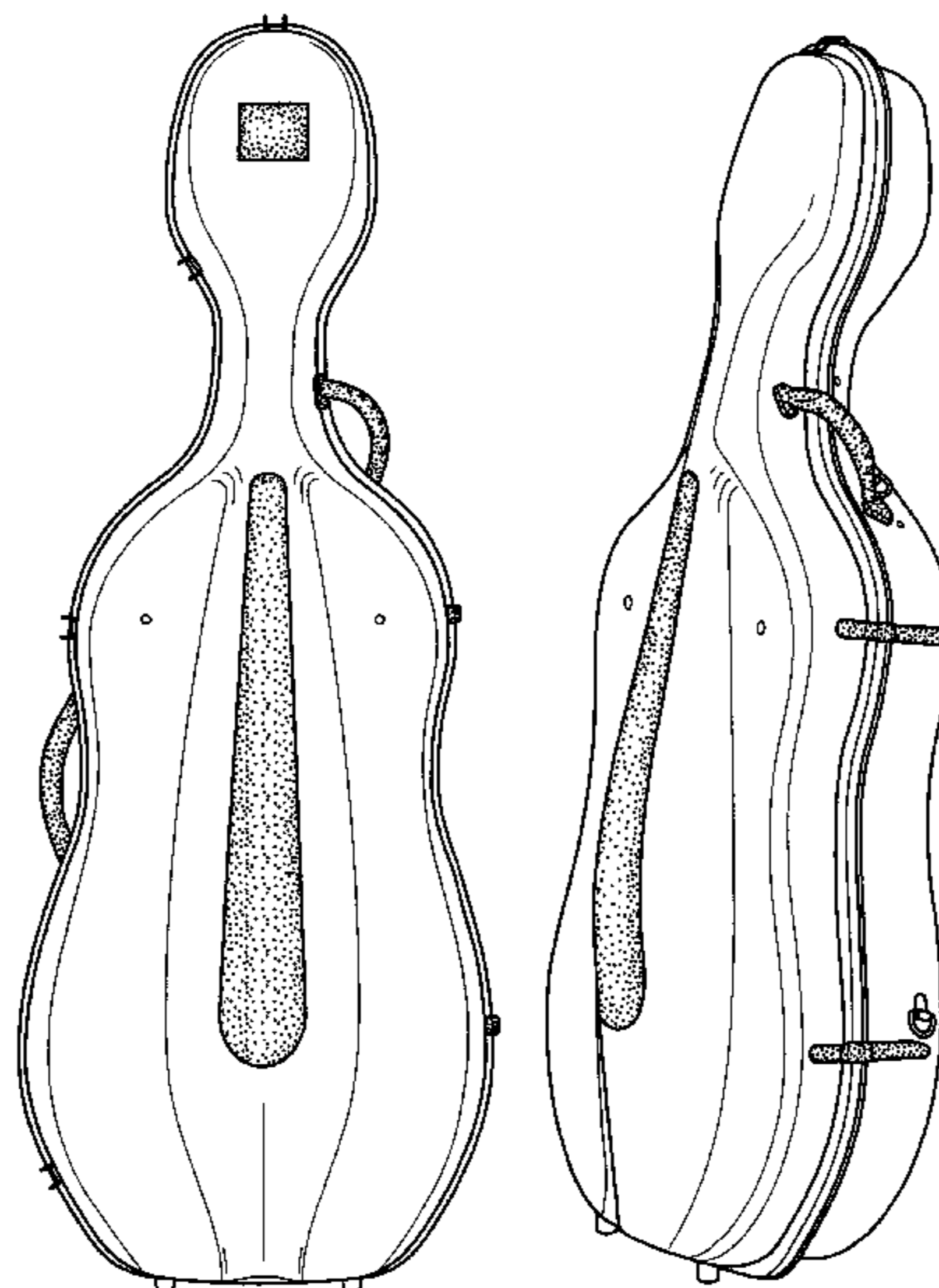
FIG. 11 is a right side elevational view of the alternative embodiment which is substantially the same as FIG. 4;

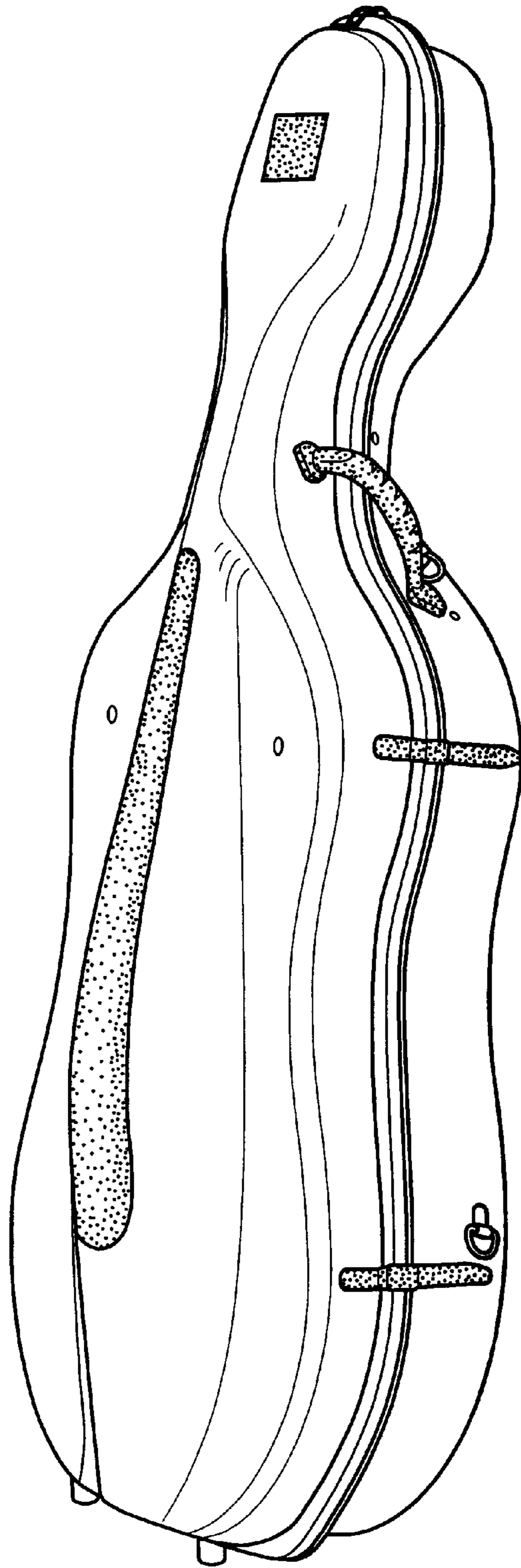
FIG. 12 is a top perspective view of the alternative embodiment which is substantially the same as FIG. 5;

FIG. 13 is bottom perspective view of the alternative embodiment which is substantially the same as FIG. 6; and,

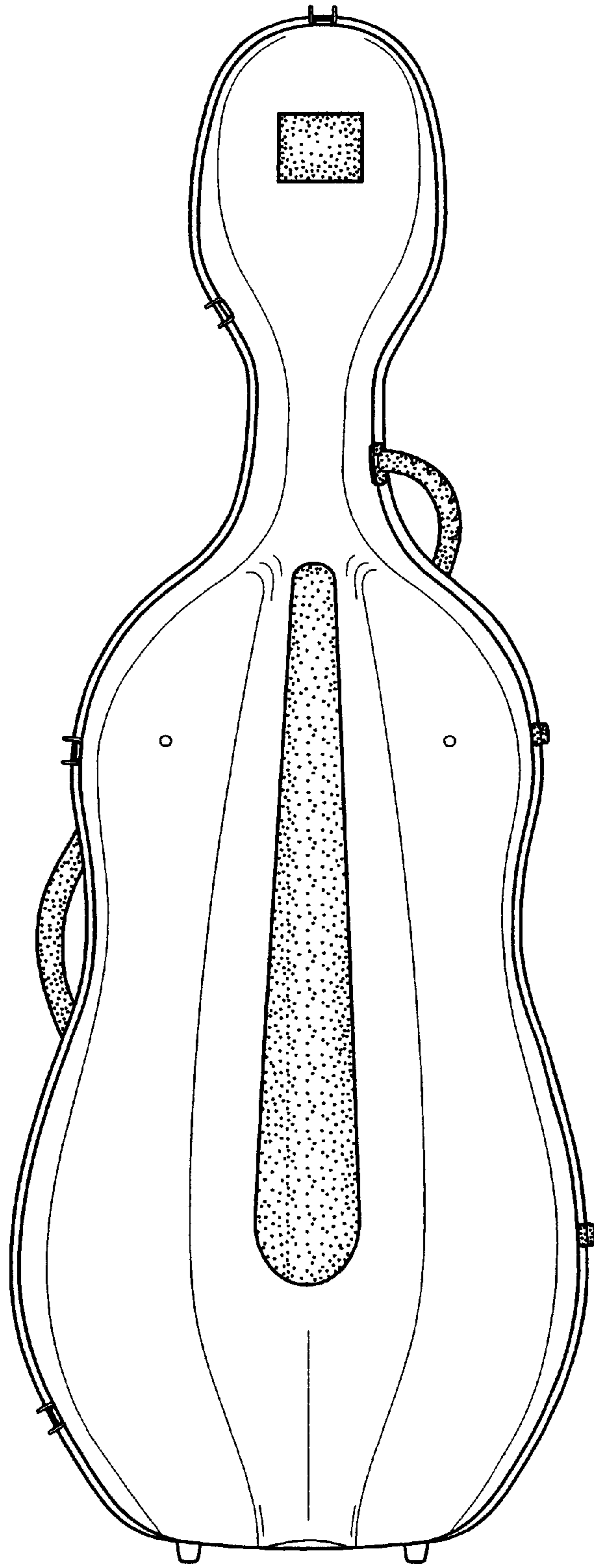
FIG. 14 is a back elevational view of the alternative embodiment which is substantially the same as FIG. 7.

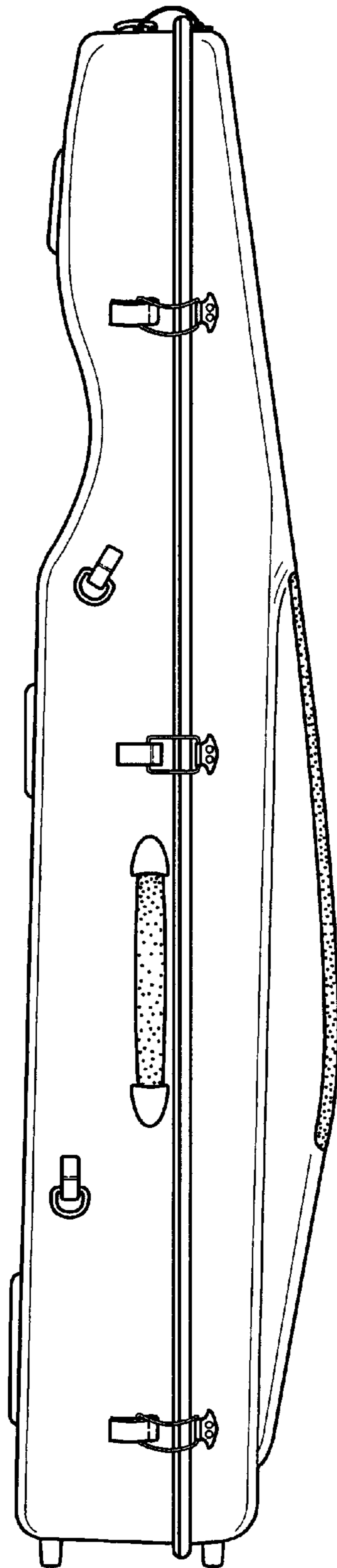




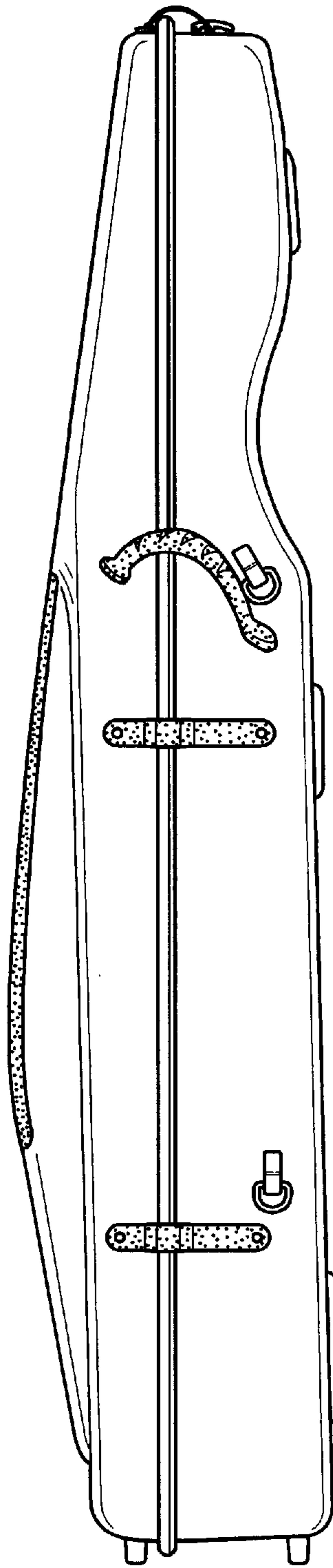

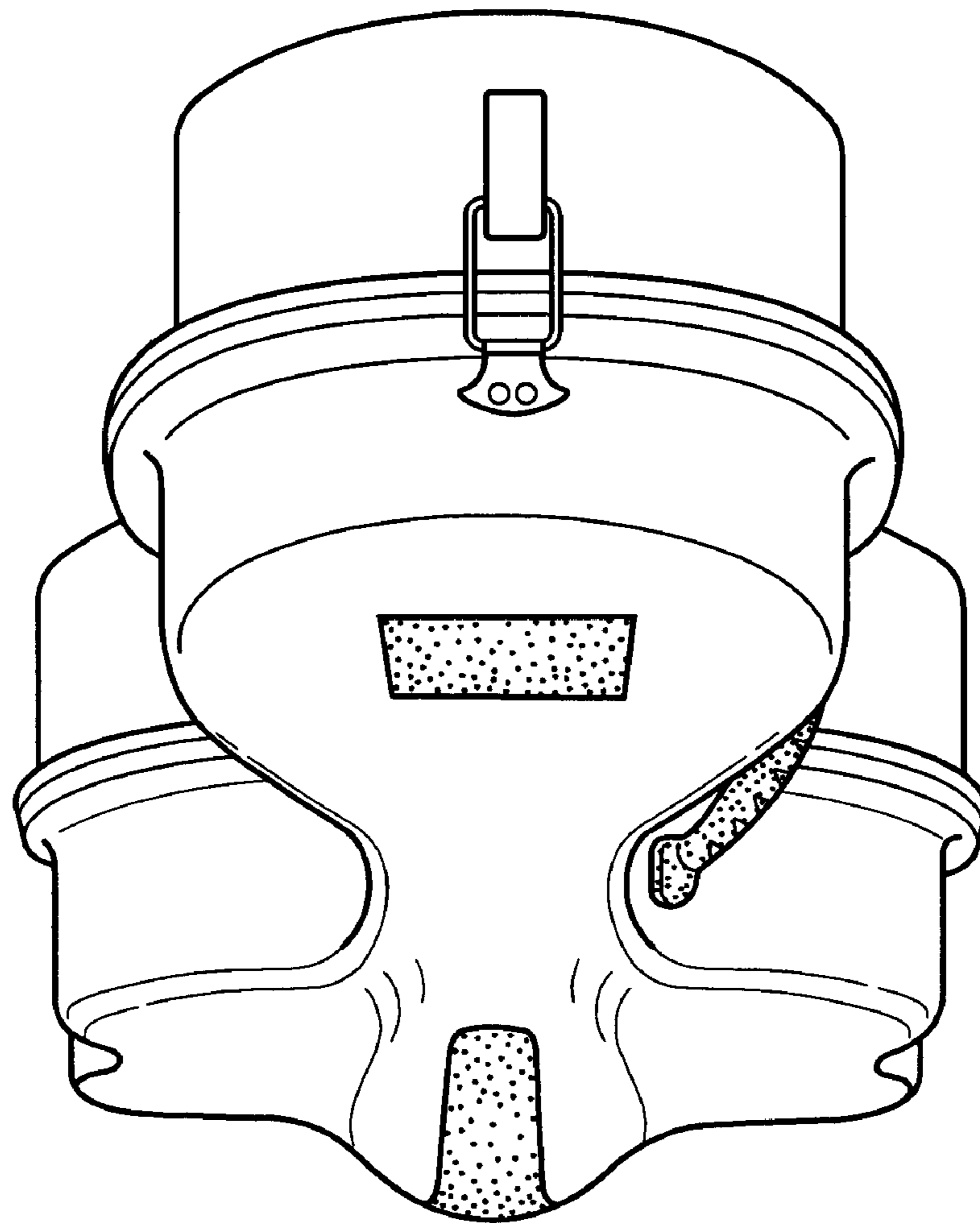

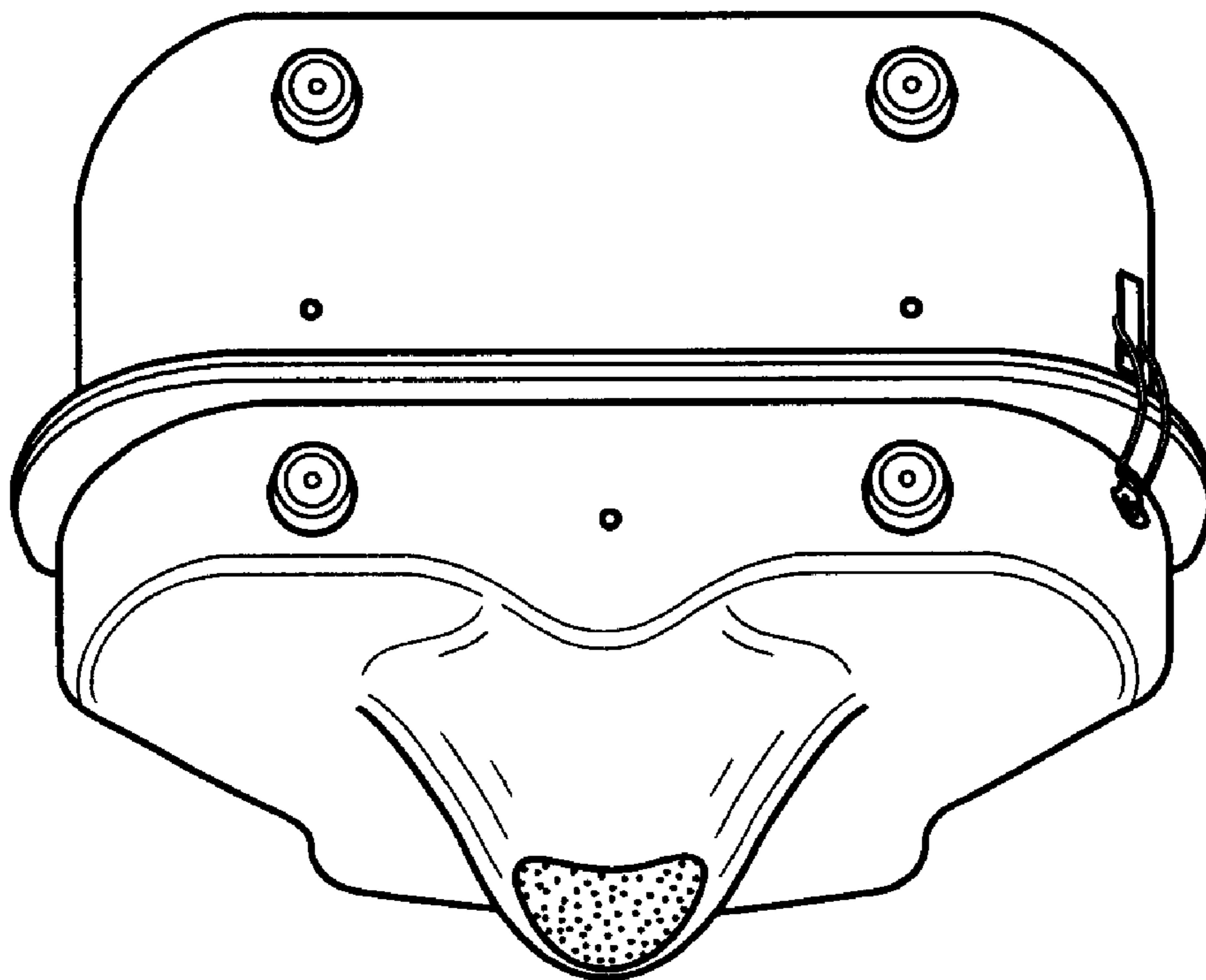

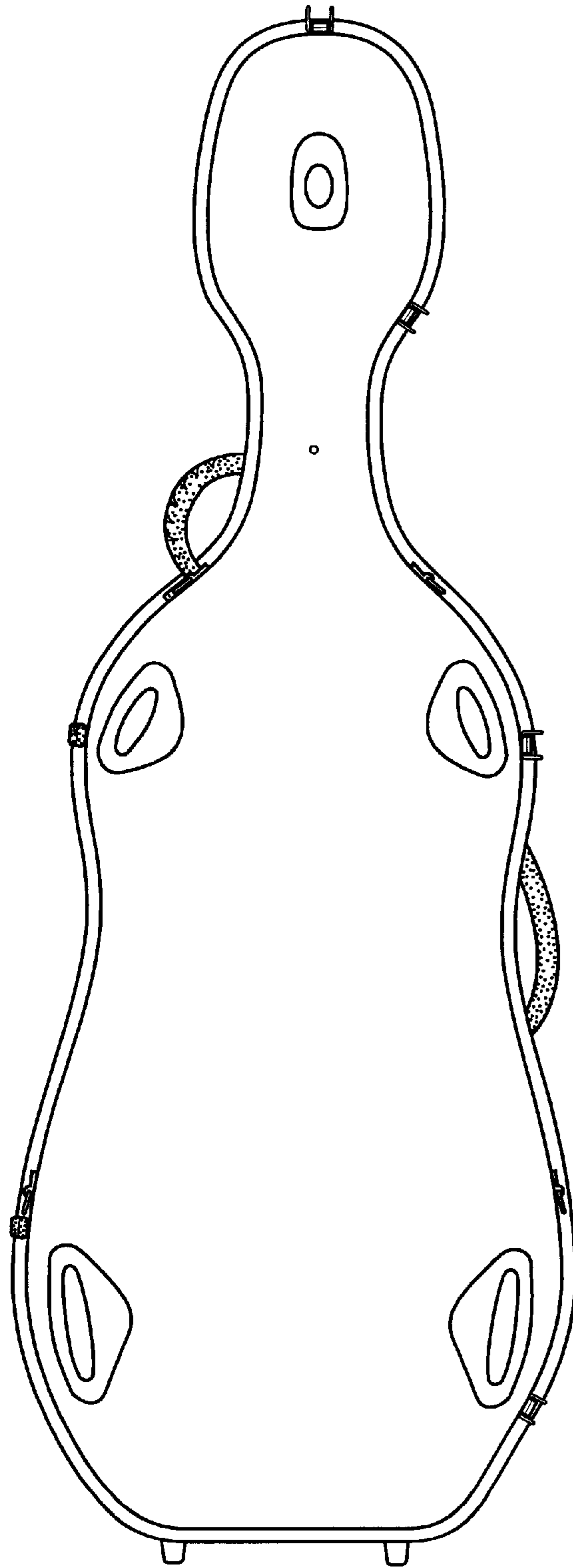
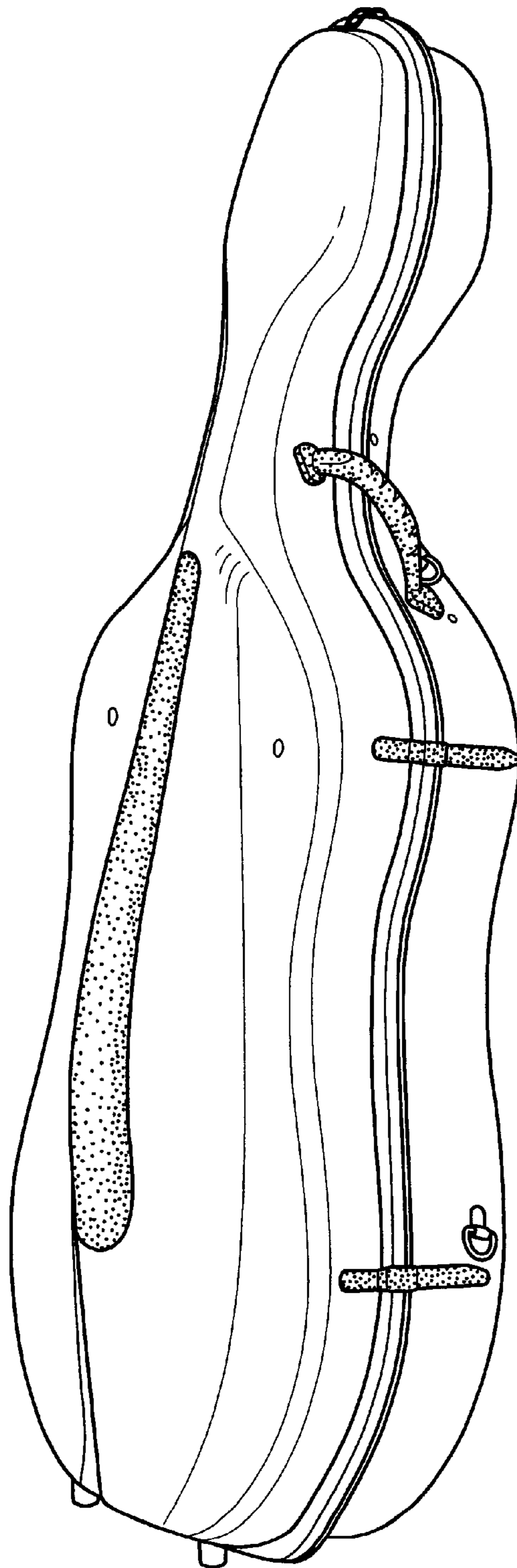
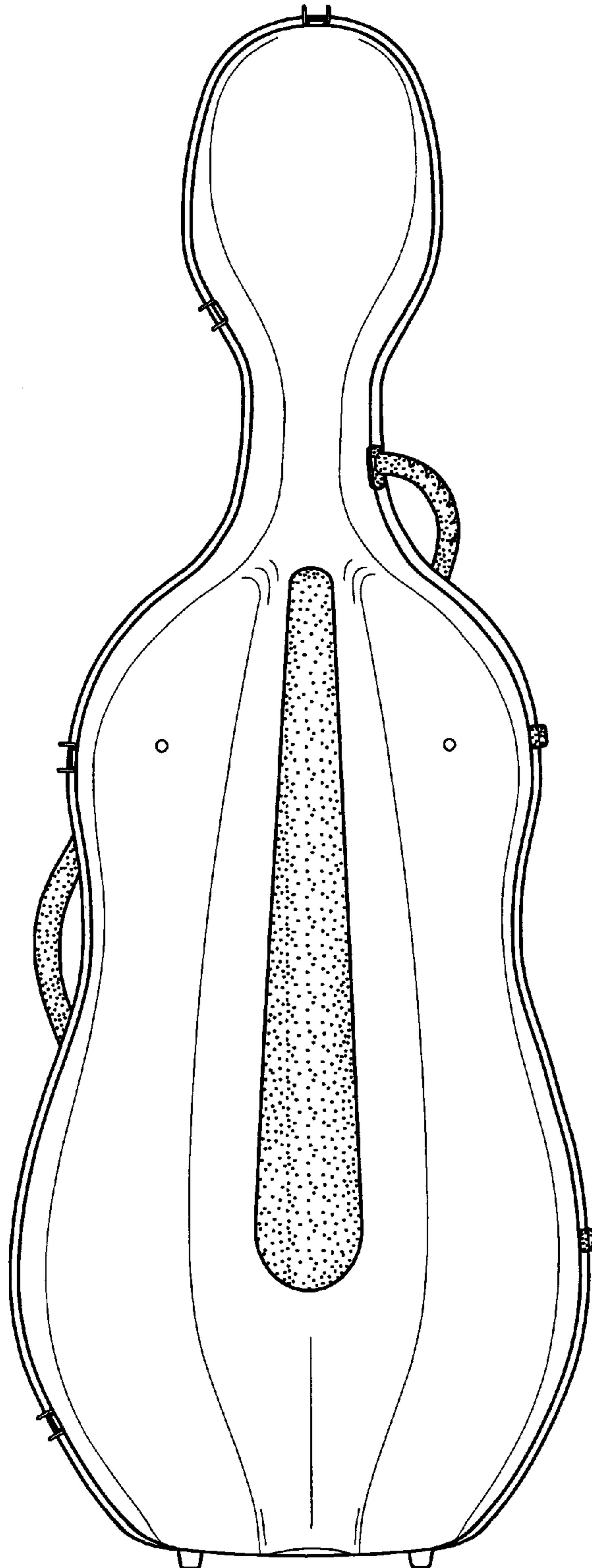

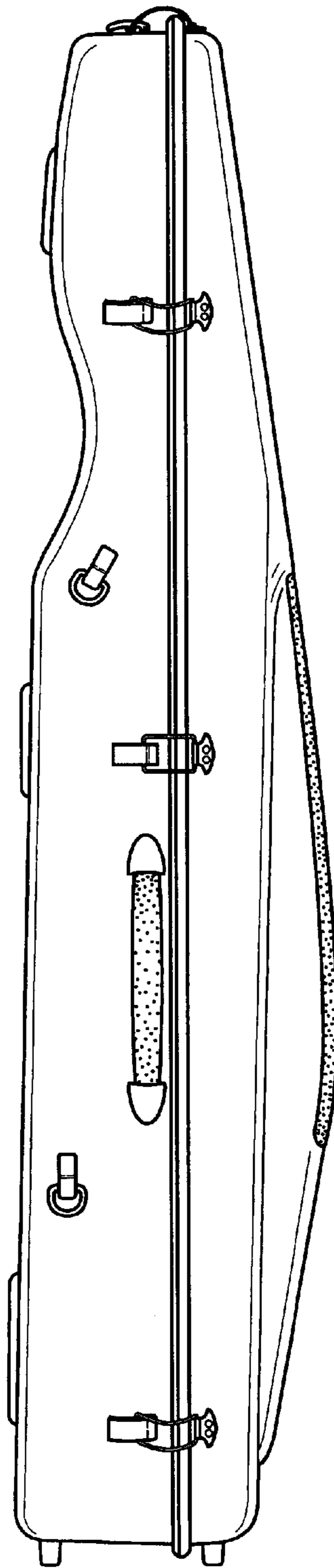




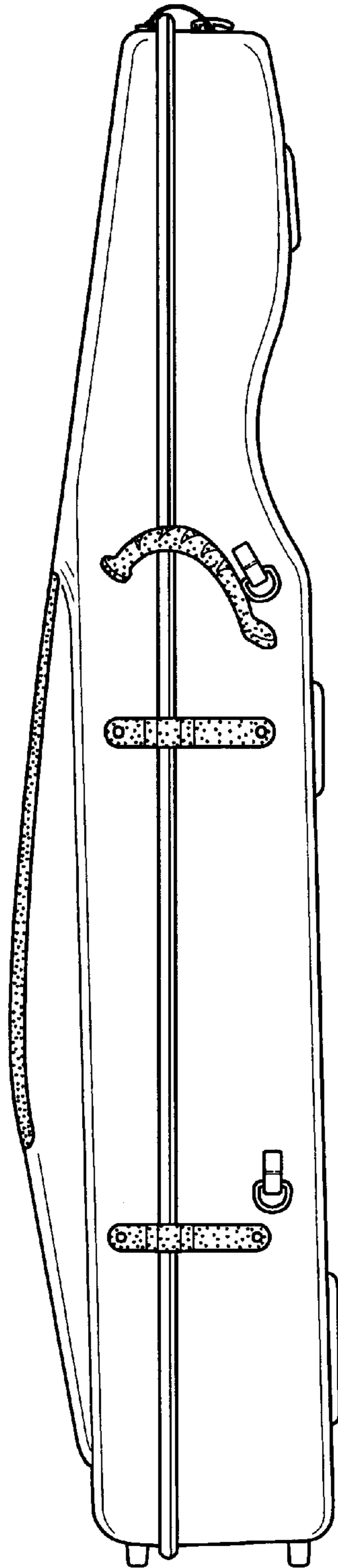

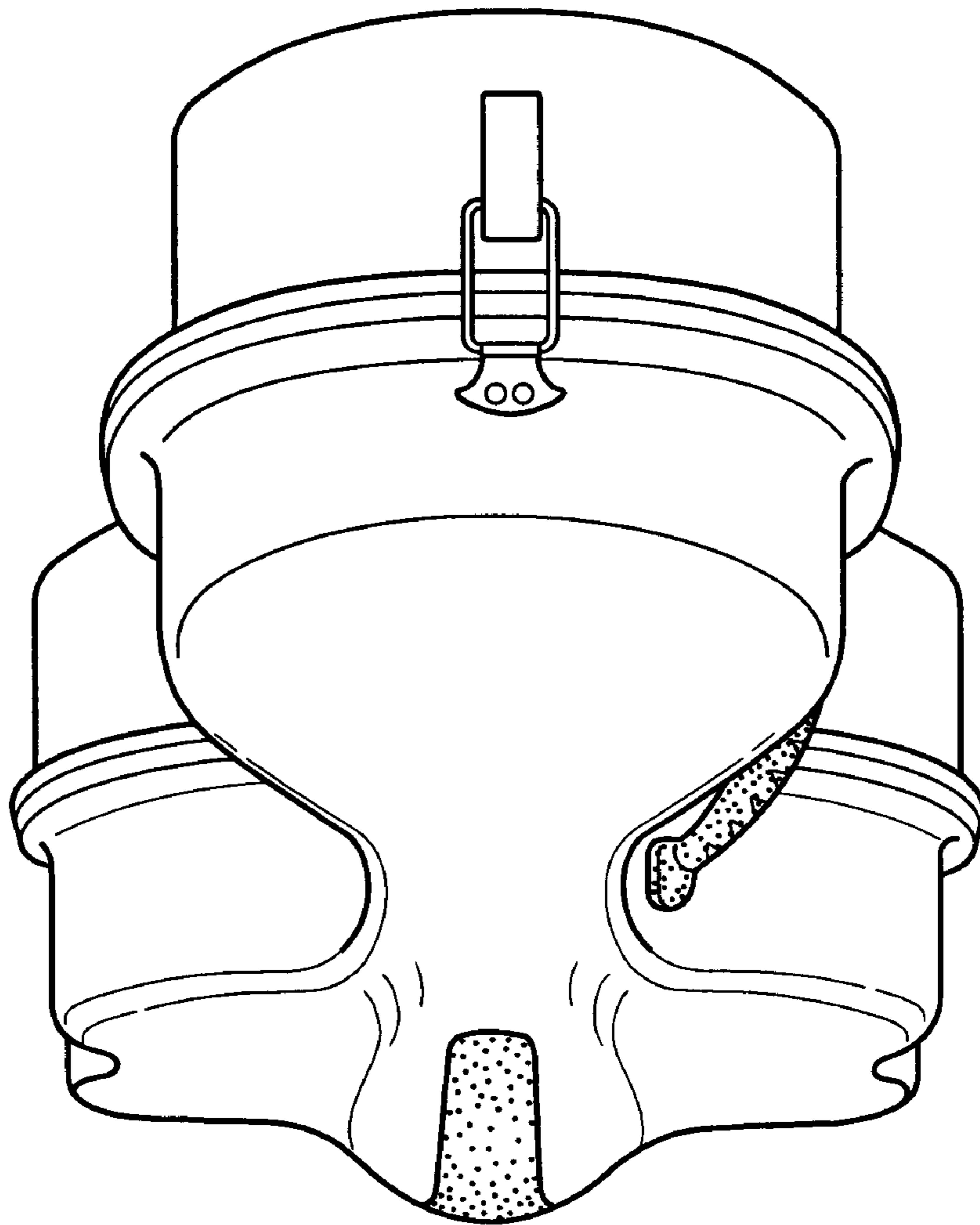

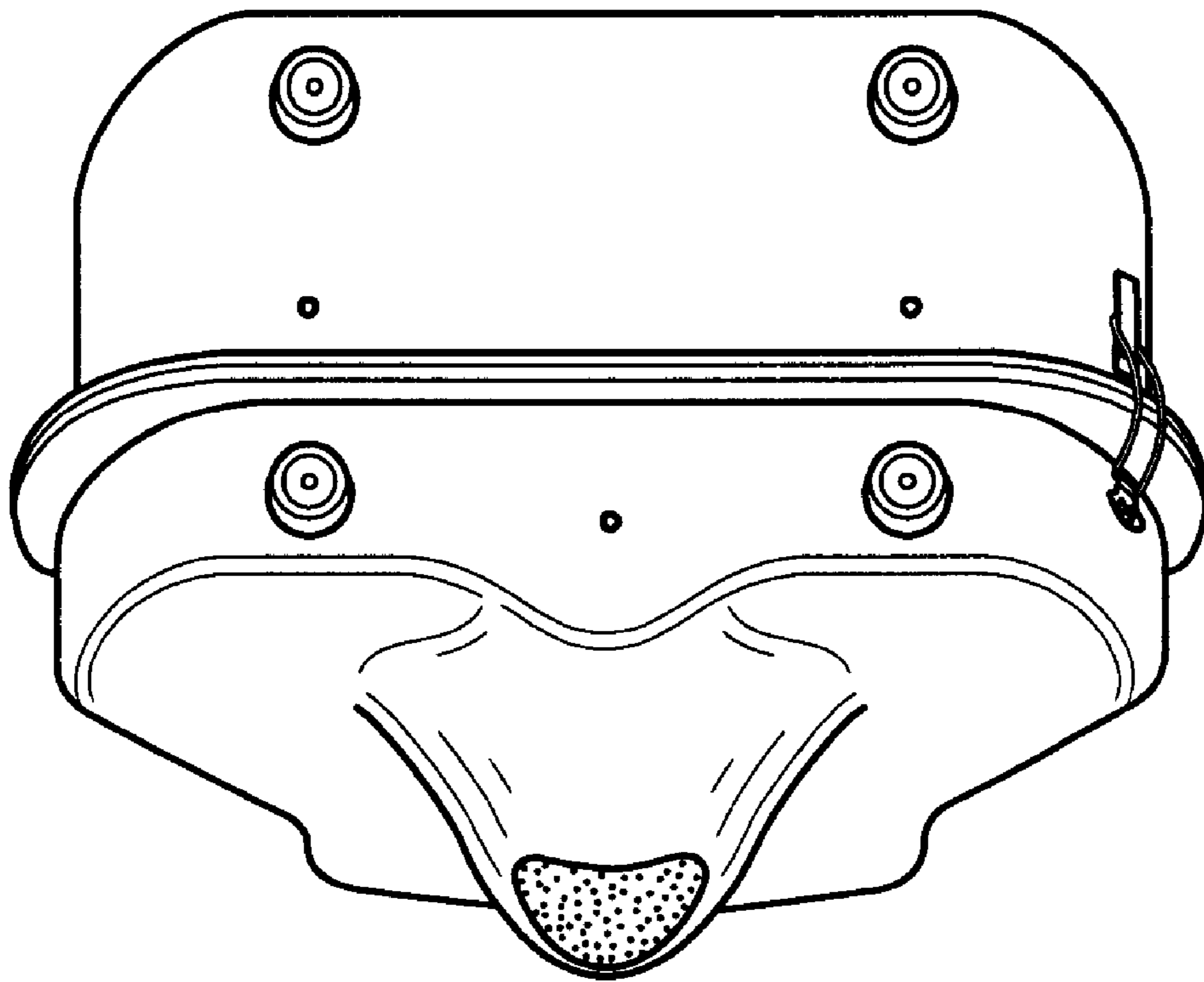

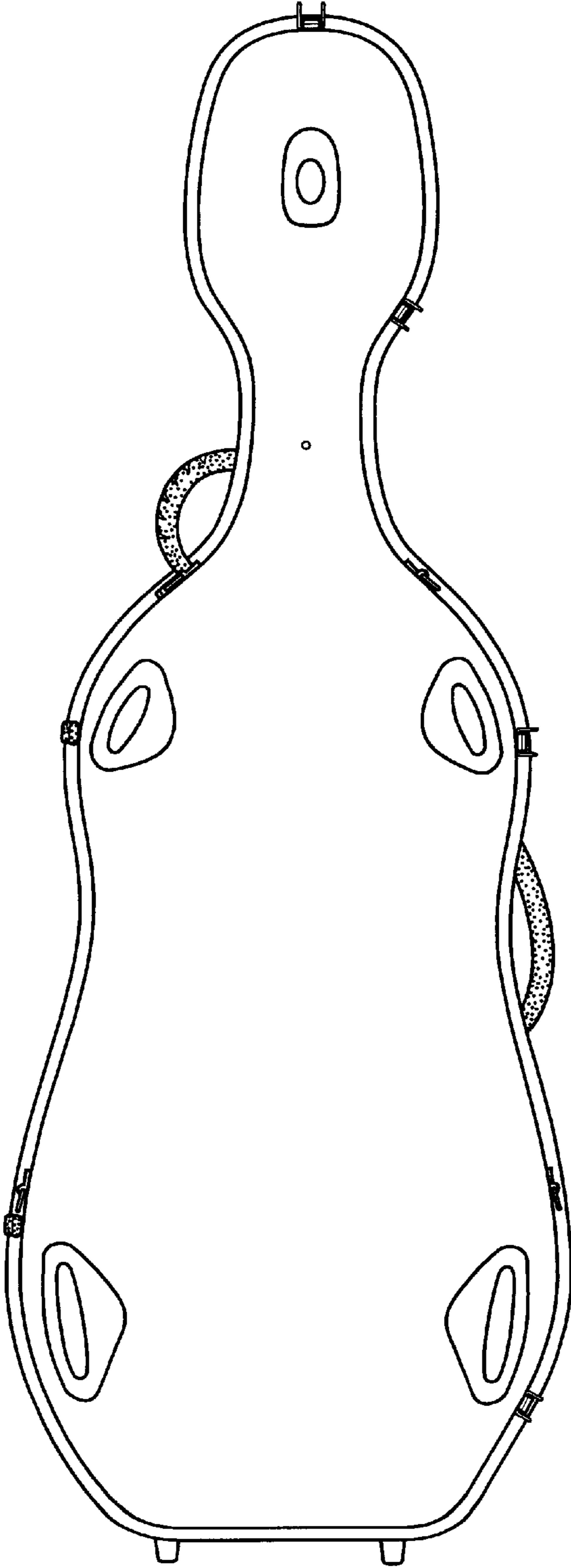
