FIG. 7 is a side view of the merchandising system shown in FIG. 6.

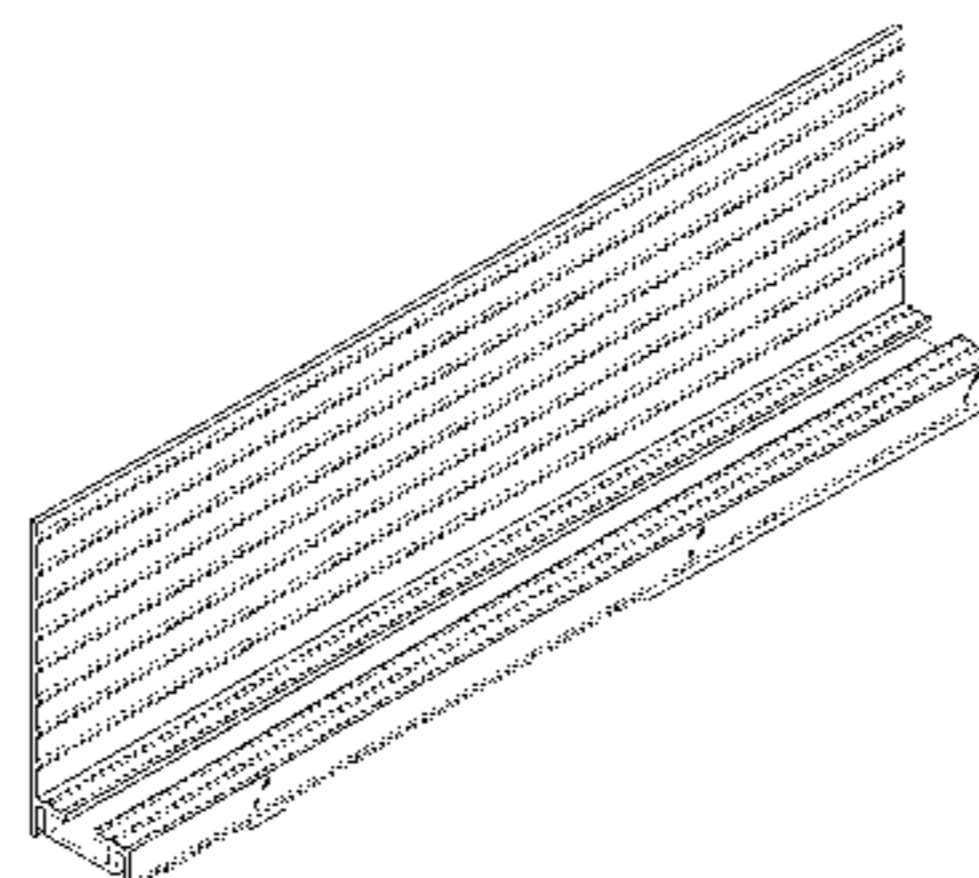
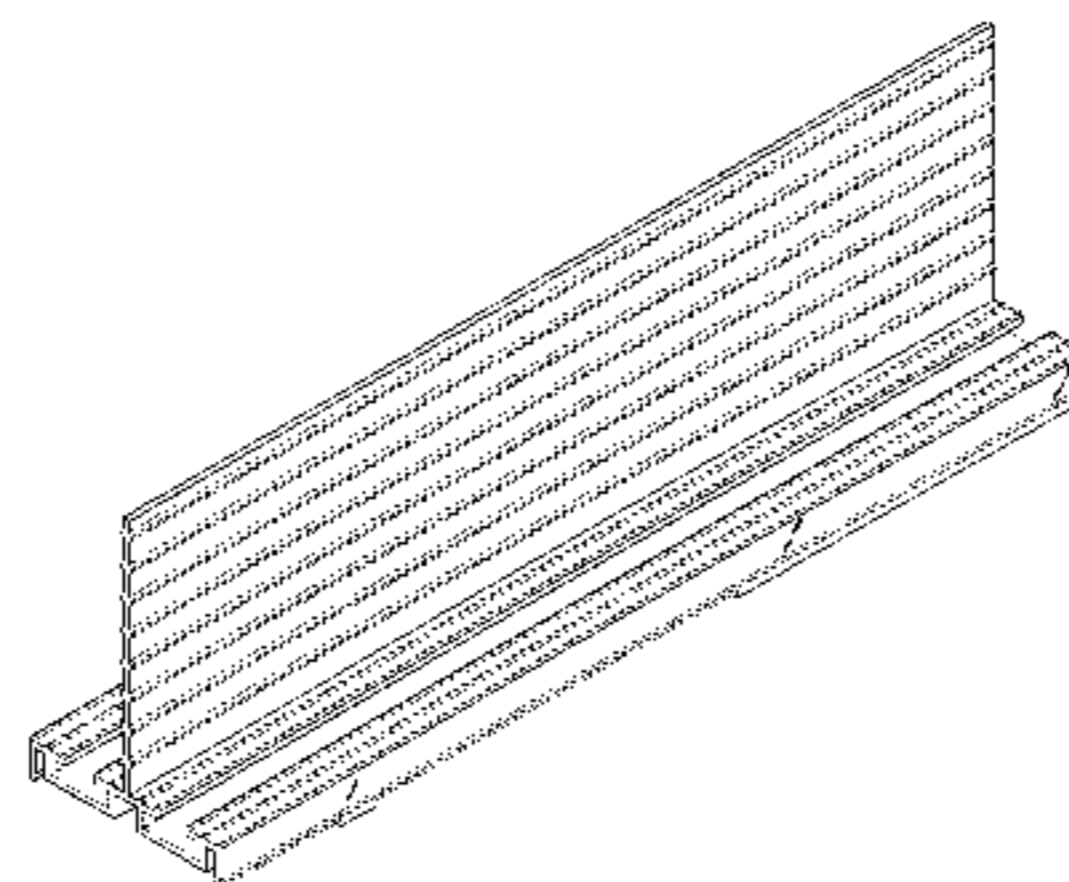
FIG. 8 is a front view of the merchandising system shown in FIG. 6.

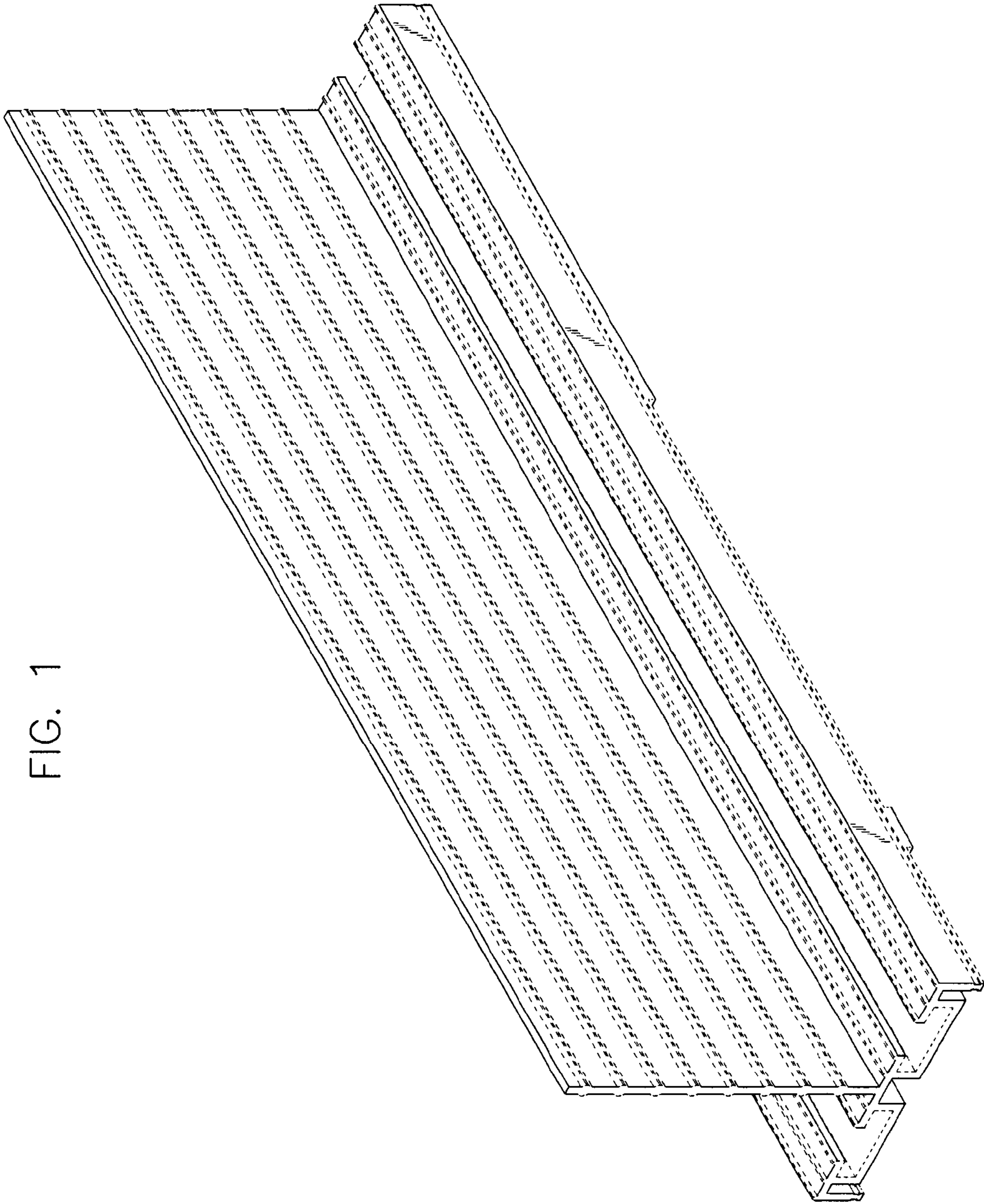

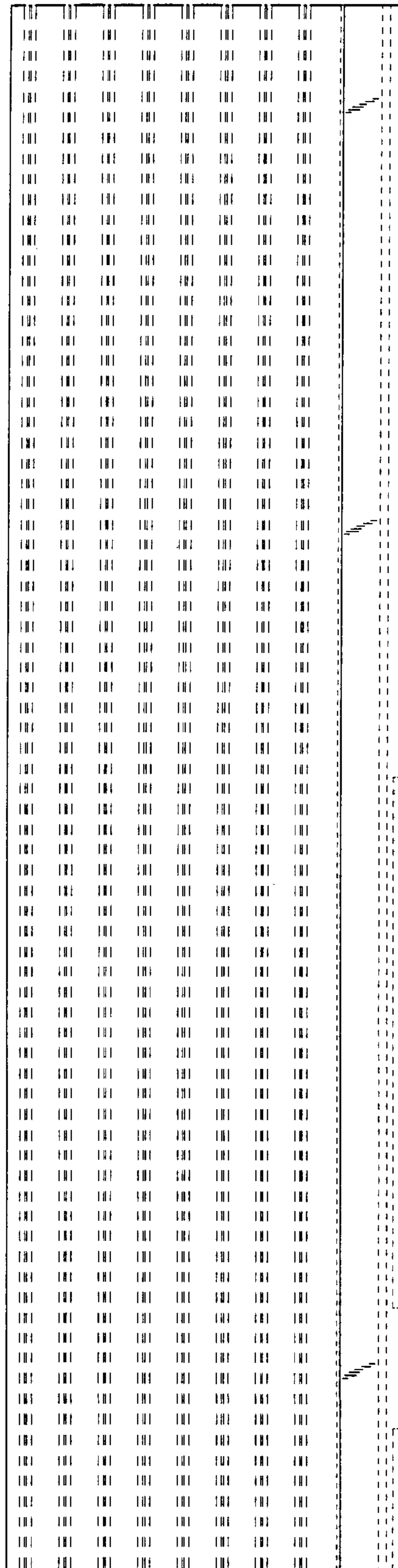

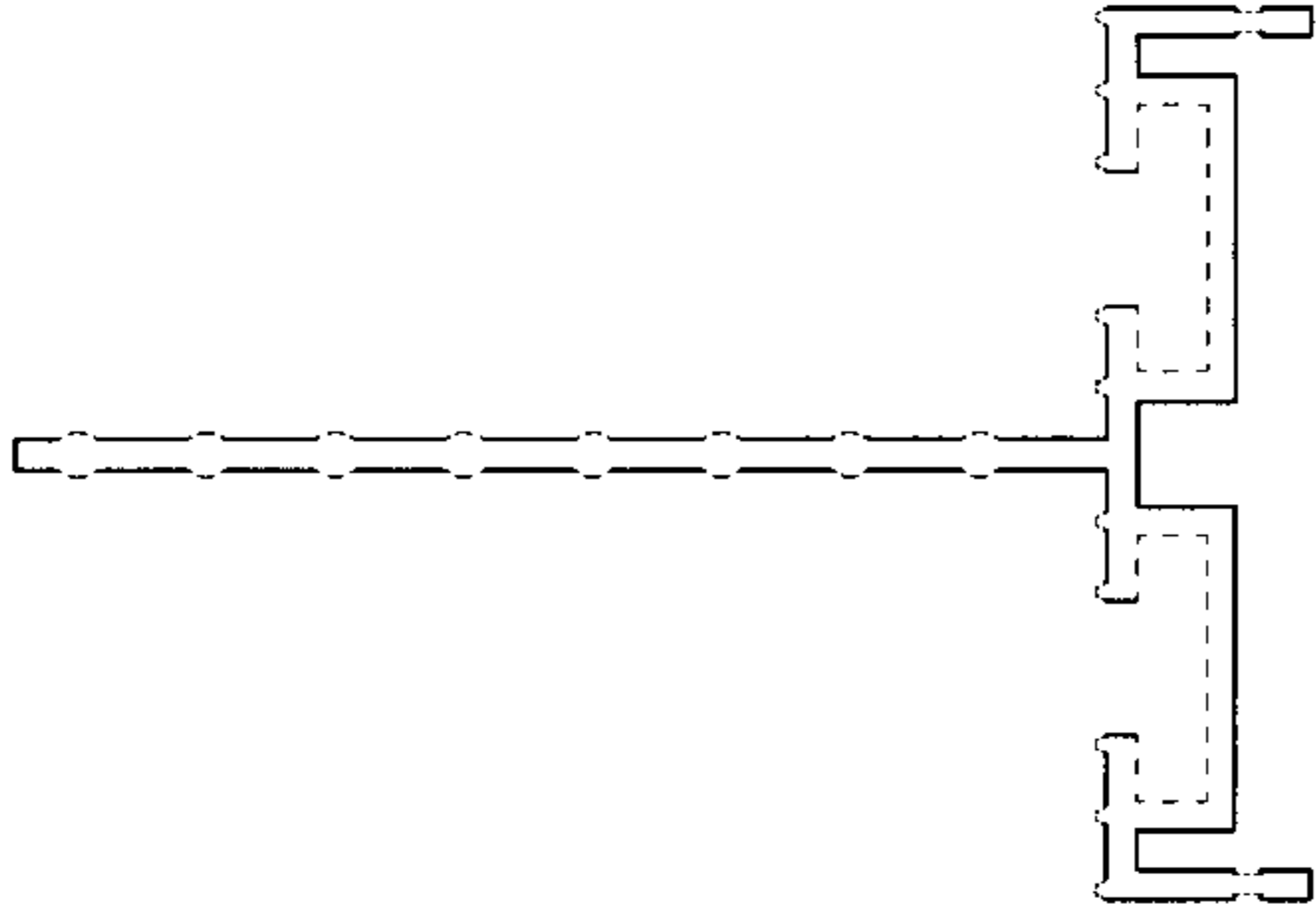

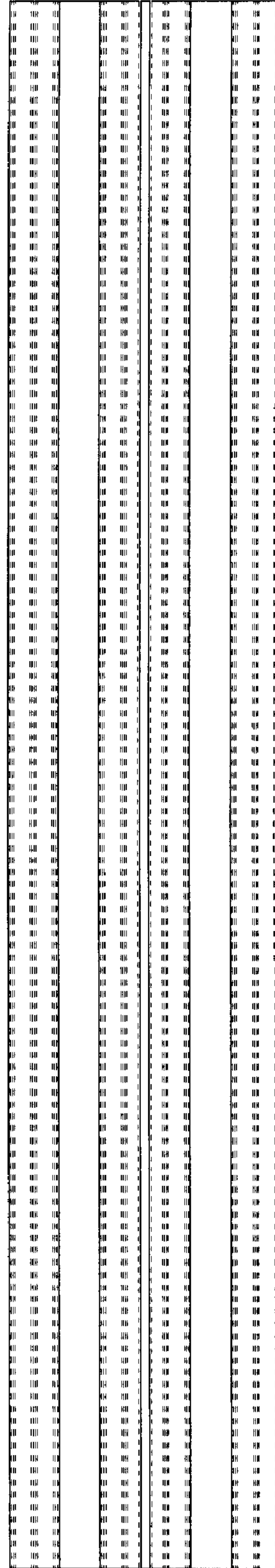
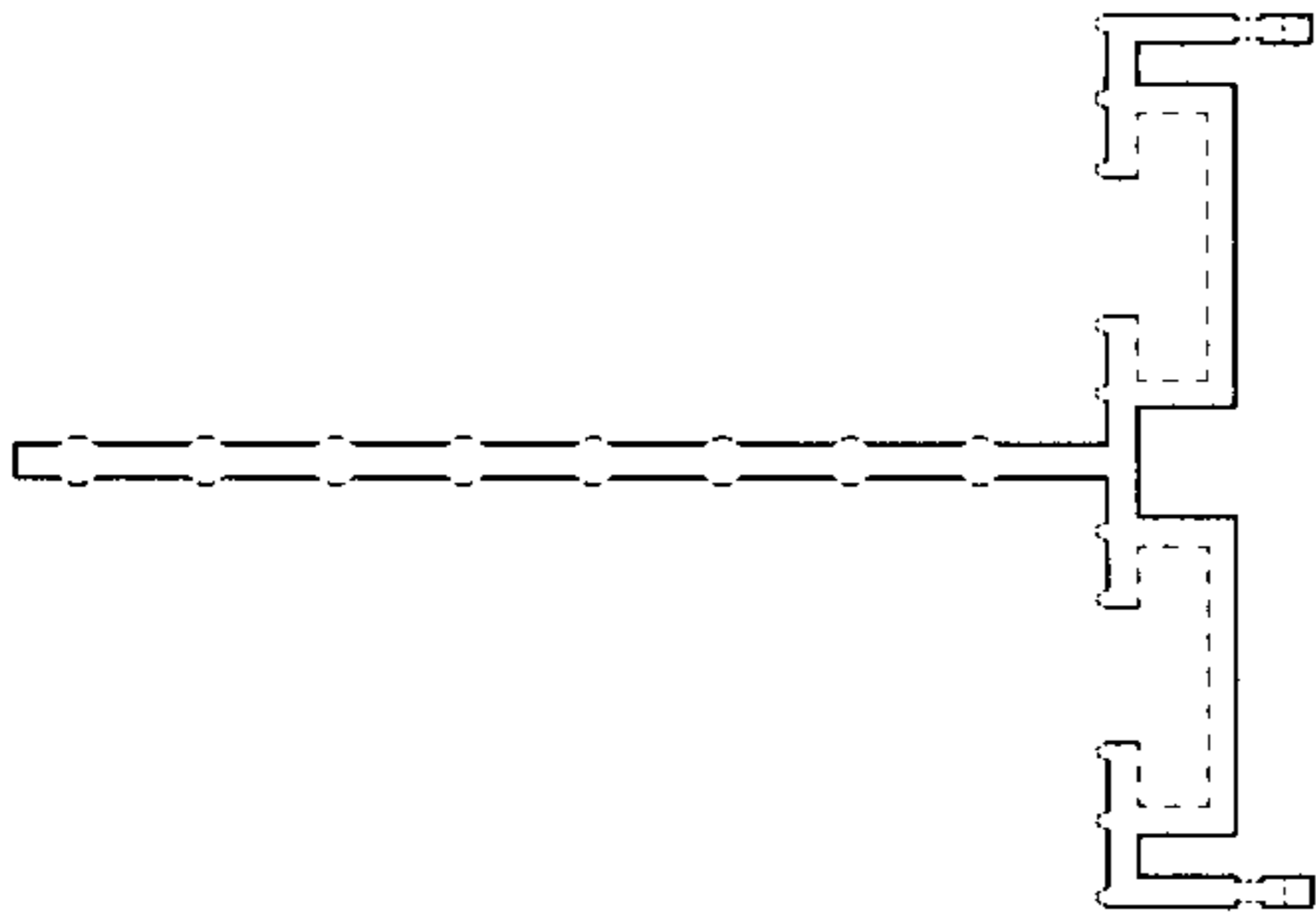

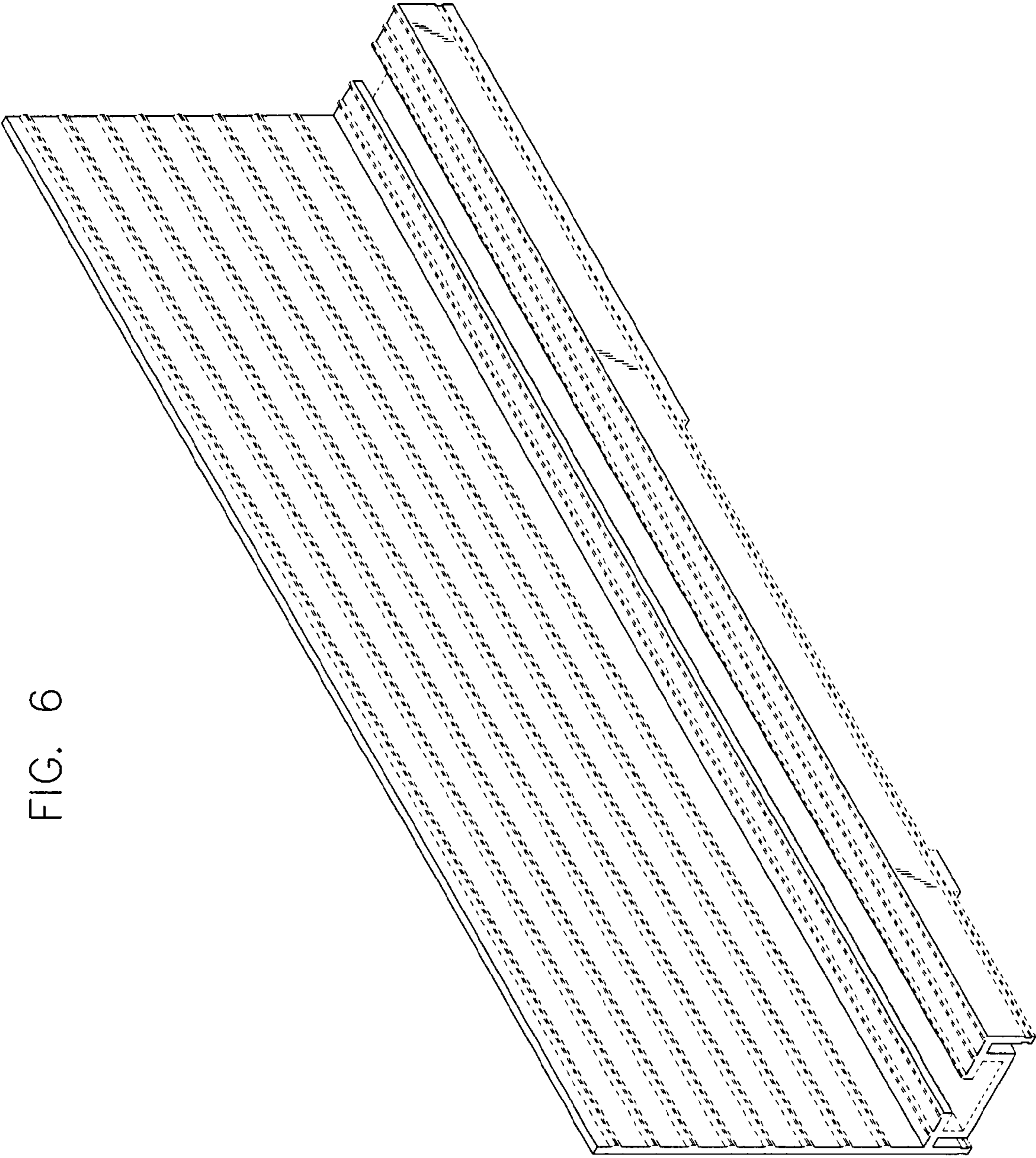

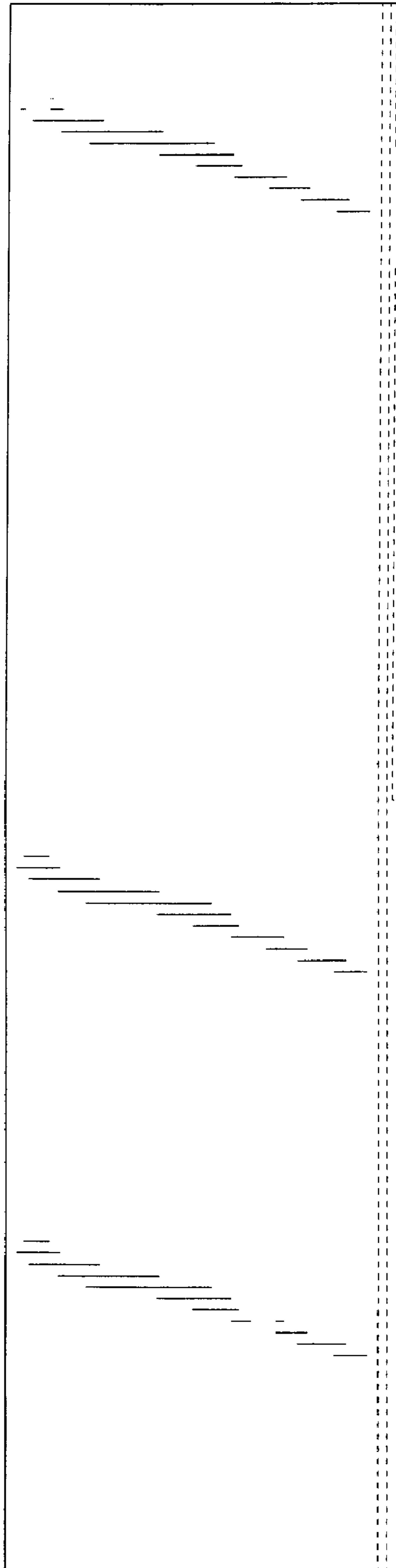

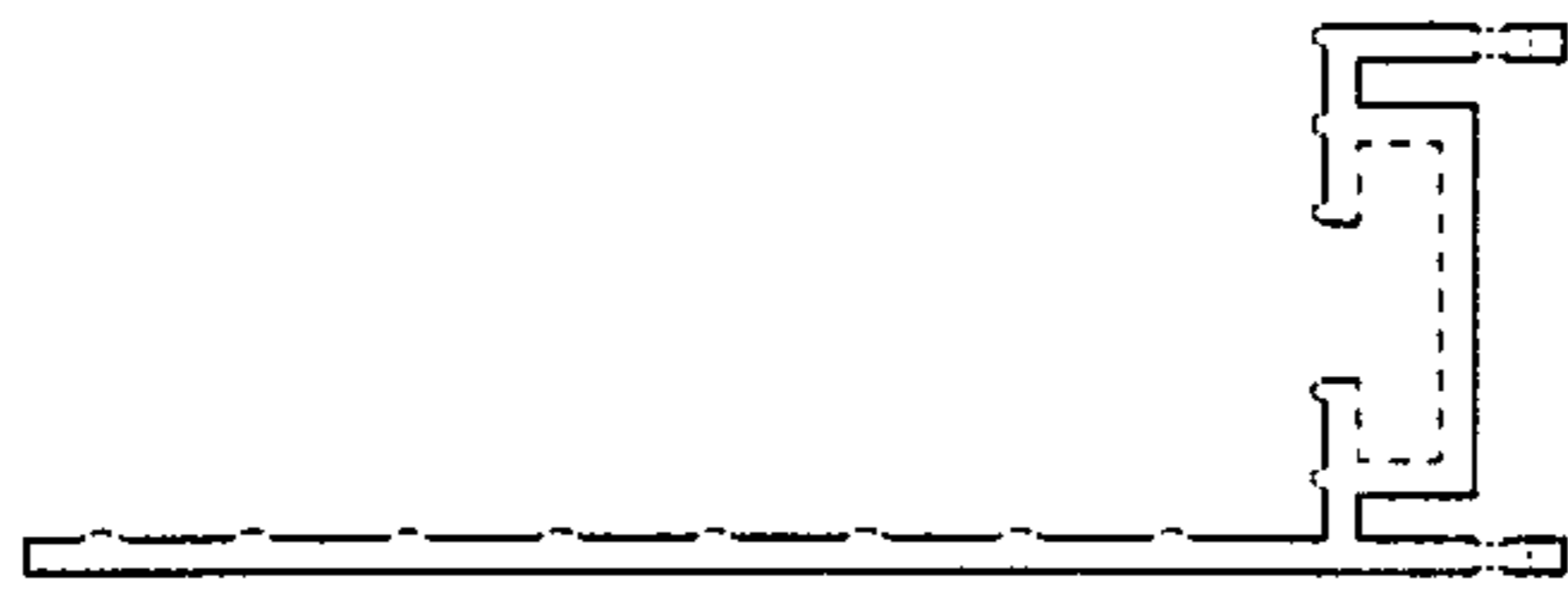

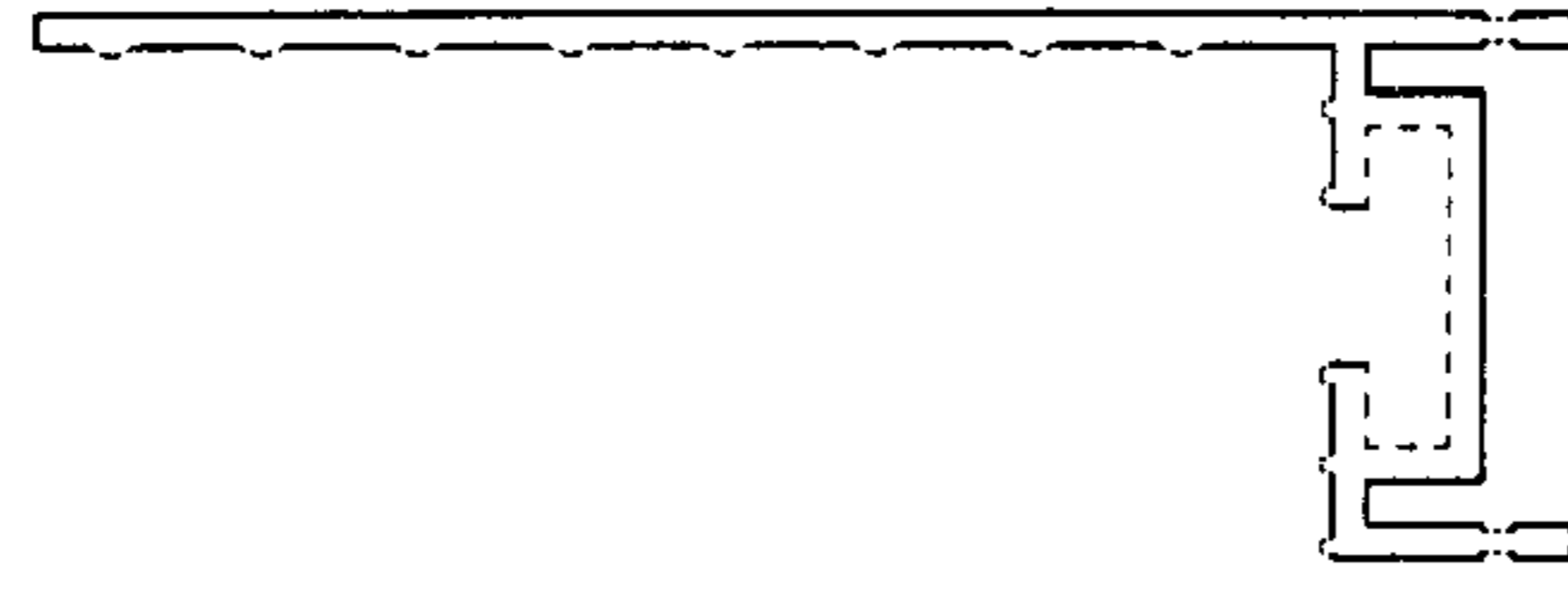
