(57) **CLAIM**

We claim the ornamental design for a utensil handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a utensil handle of the present invention;

FIG. 2 is a top plan view of the handle of FIG. 1;

FIG. 3 is a front elevational view of the handle of FIG. 1, the rear elevational view being a mirror image thereof;

FIG. 4 is a front elevational view of the handle of FIG. 1 rotated 180° about its longitudinal axis;

FIG. 5 is a left-end elevational view of the handle of FIG. 1; FIG. 6 is a right-end elevational view of the handle of FIG. 1;

FIG. 7 is an enlarged sectional view of the handle of FIG. 2 taken along line 7—7;

FIG. 8 is an enlarged sectional view of the handle of FIG. 2 taken along line 8—8;

FIG. 9 is a perspective view of a first alternative embodiment of the utensil handle of FIG. 1;

FIG. 10 is a top plan view of the handle of FIG. 9;

FIG. 11 is a front elevational view of the handle of FIG. 9;

FIG. 12 is a front elevational view of the handle of FIG. 9 rotated 180° about its longitudinal axis;

FIG. 13 is a left-end elevational view of the handle of FIG. 9;

FIG. 14 is a right-end elevational view of the handle of FIG. 9;

FIG. 15 is a perspective view the second alternative embodiment of the handle of FIG. 1;

FIG. 16 is a top plan view of the handle of FIG. 15;

FIG. 17 is a front elevational view of the handle of FIG. 15;

FIG. 18 is a front elevational view of the handle of FIG. 15 rotated 180° about its longitudinal axis;

FIG. 19 is a left-end elevational view of the handle of FIG. 15;

FIG. 20 is a right-end elevational view of the handle of FIG. 15;

FIG. 21 is a perspective view of a third alternative embodiment of the handle of FIG. 1;

FIG. 22 is a top plan view of the handle of FIG. 21;

FIG. 23 is a front elevational view of the handle of FIG. 21;

FIG. 24 is a front elevational view of the handle of FIG. 21 rotated 180° about its longitudinal axis;

FIG. 25 is a right-end elevational view of the handle of FIG. 21;

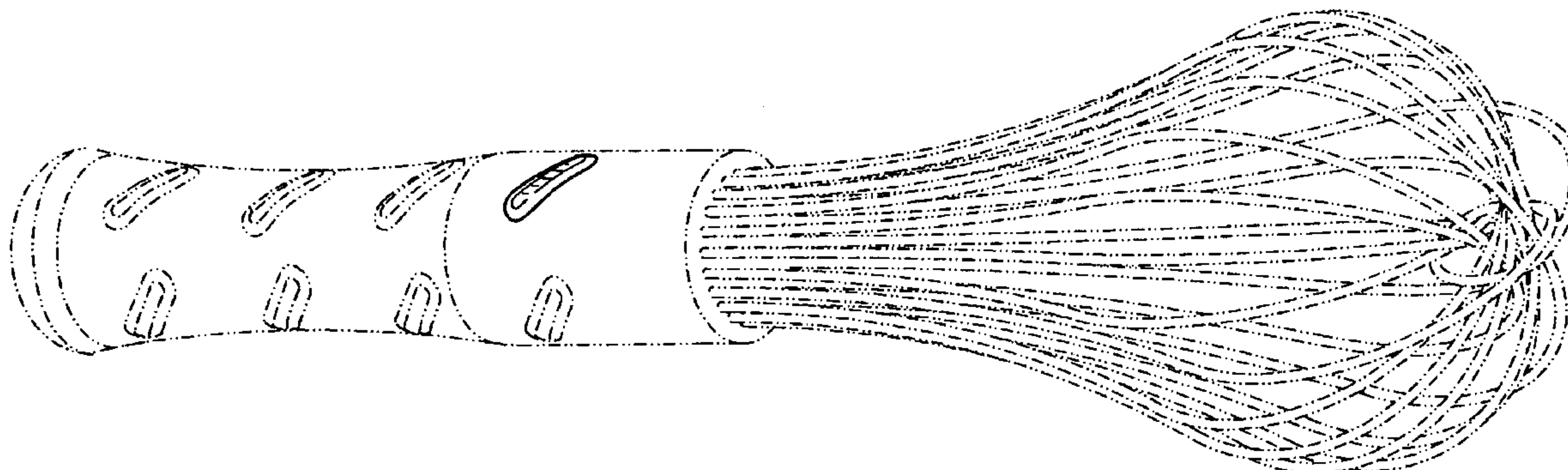
FIG. 26 is a left-end elevational view of the handle of FIG. 21;

FIG. 27 is a perspective view of a fourth alternative embodiment of the handle of FIG. 1; and,

FIG. 28 is a top plan view of the handle of FIG. 27.

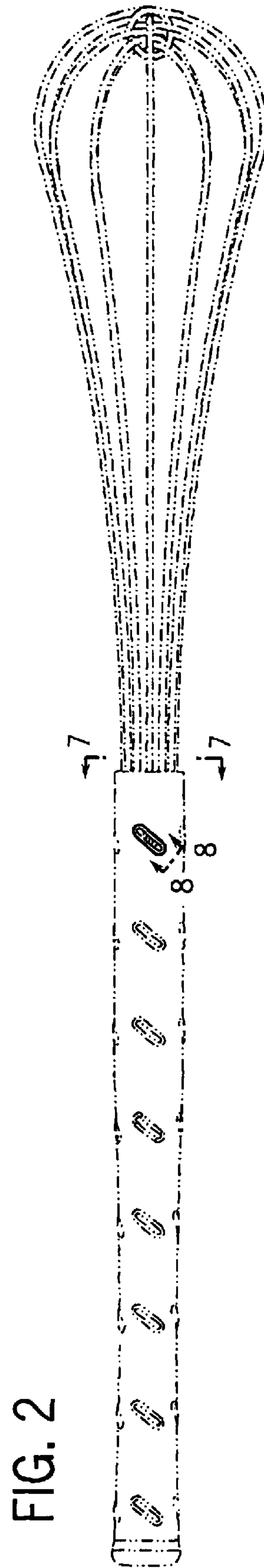
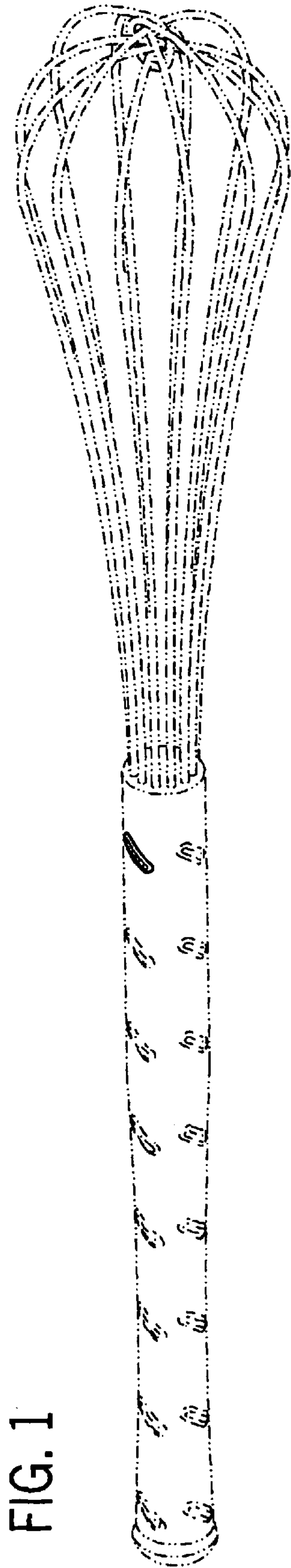

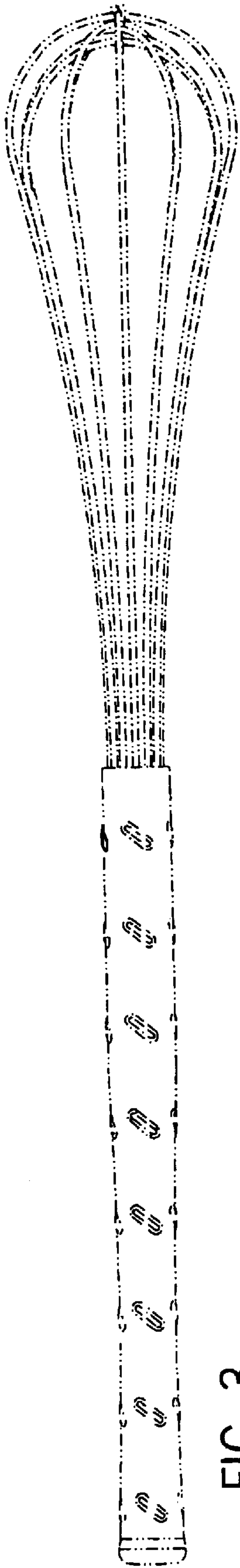

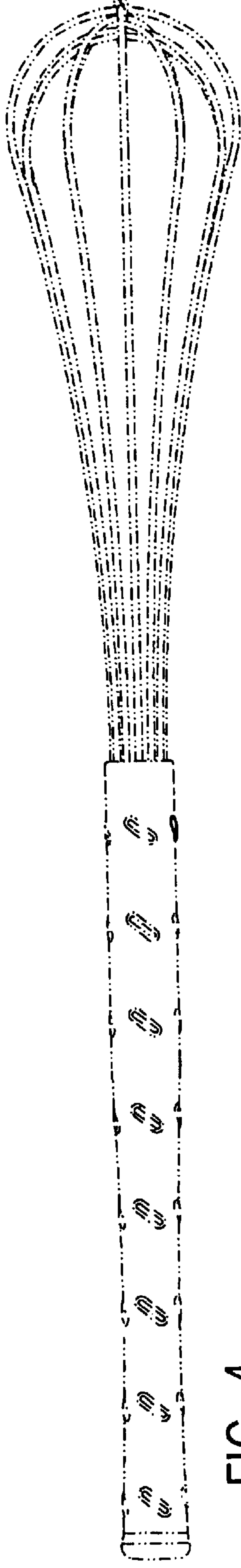

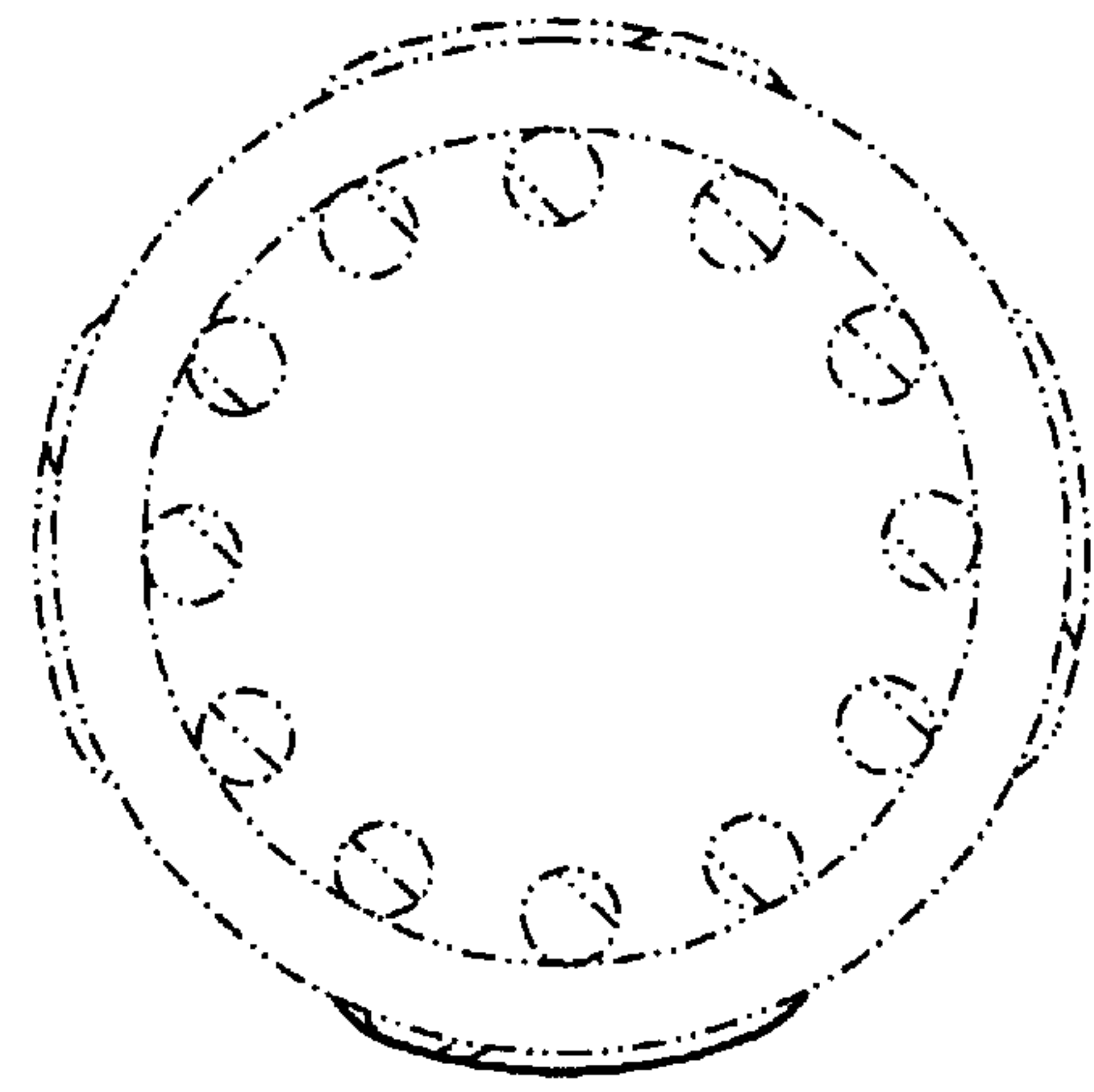

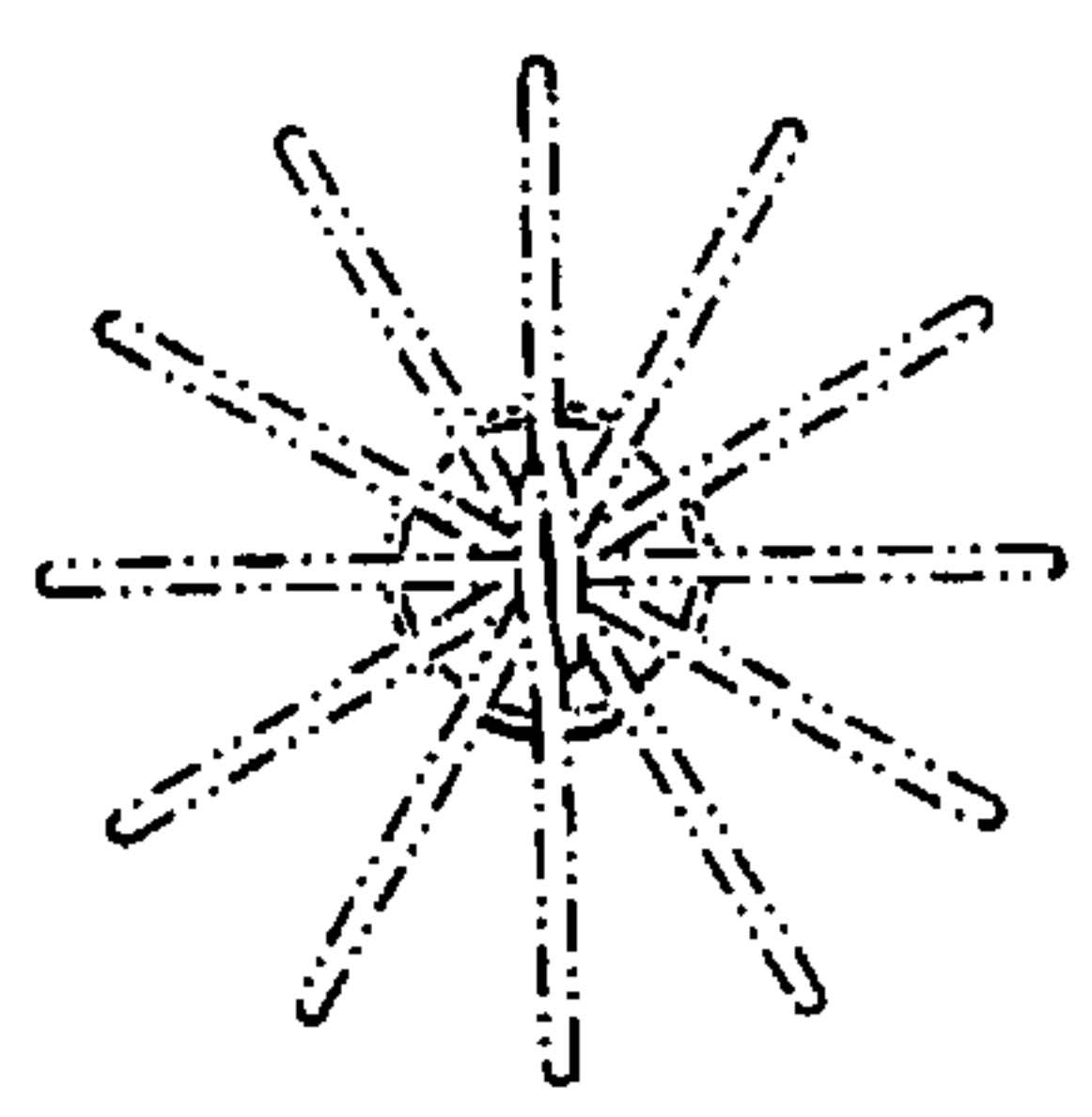

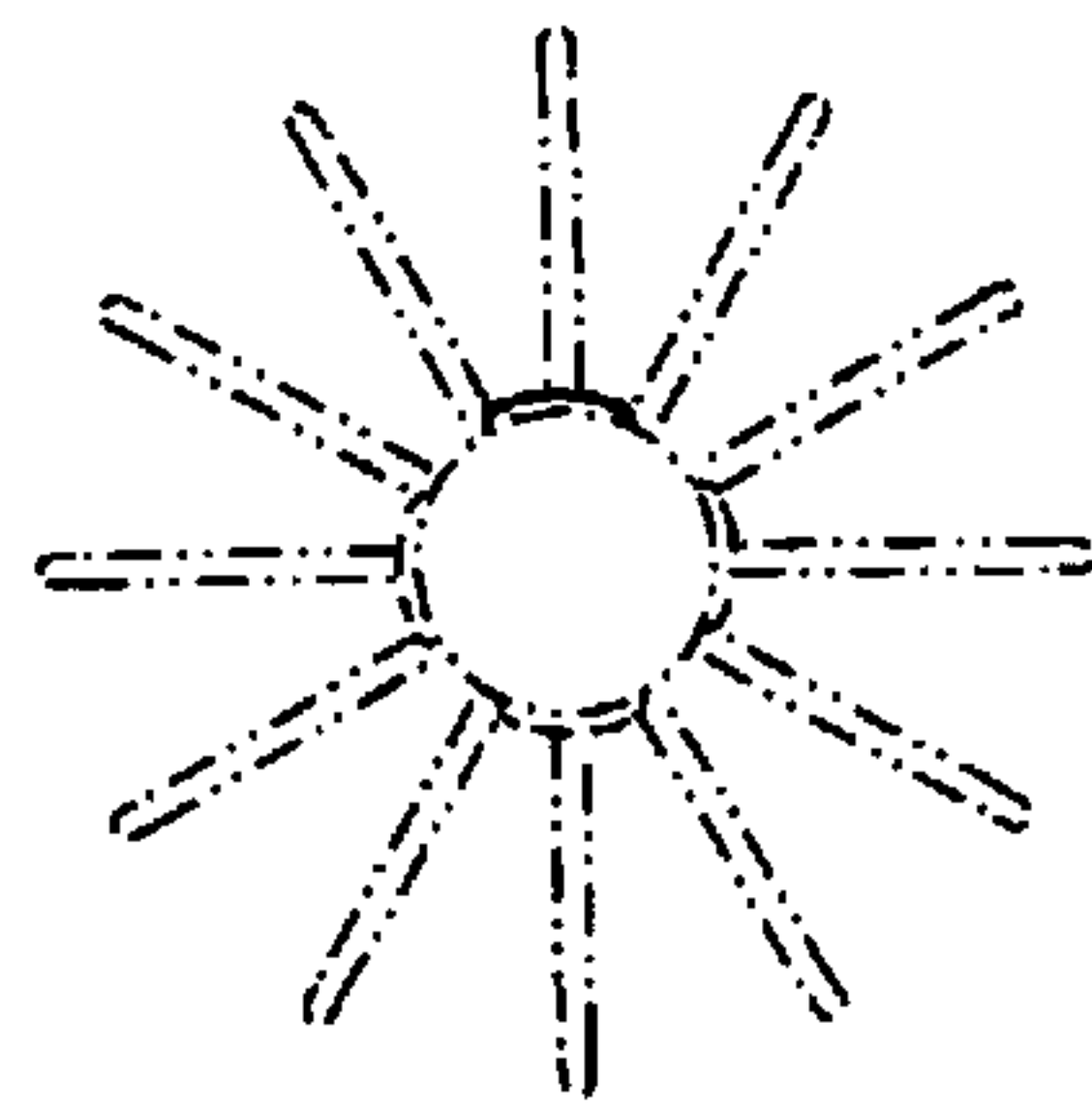

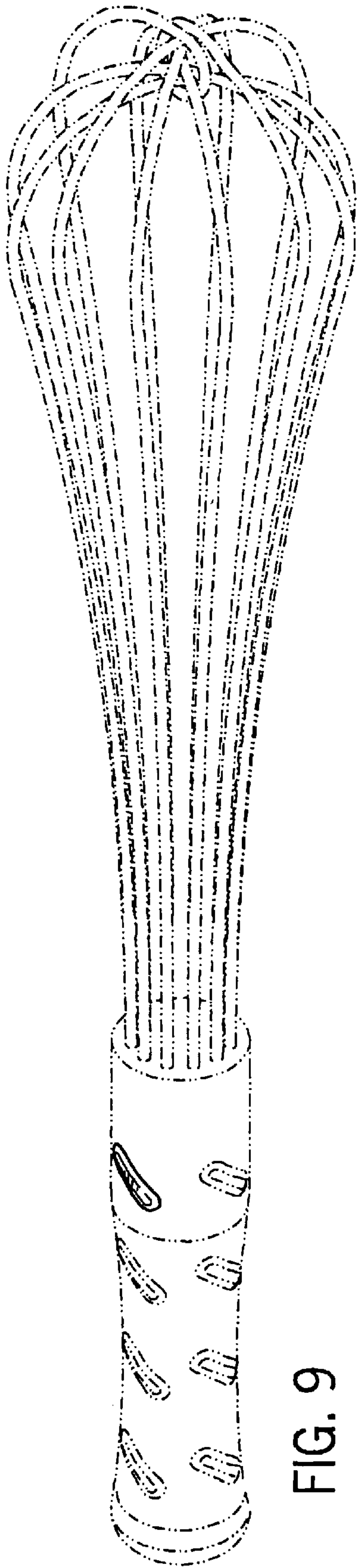

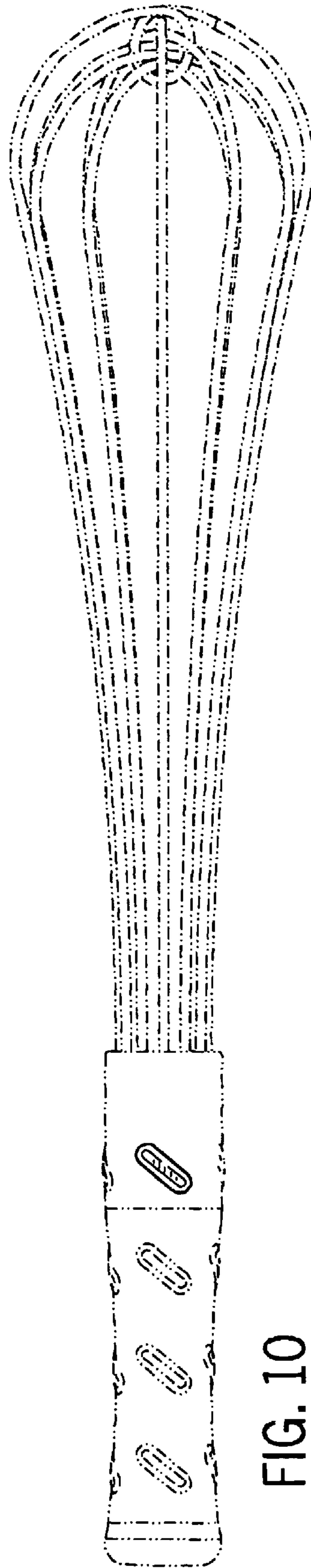

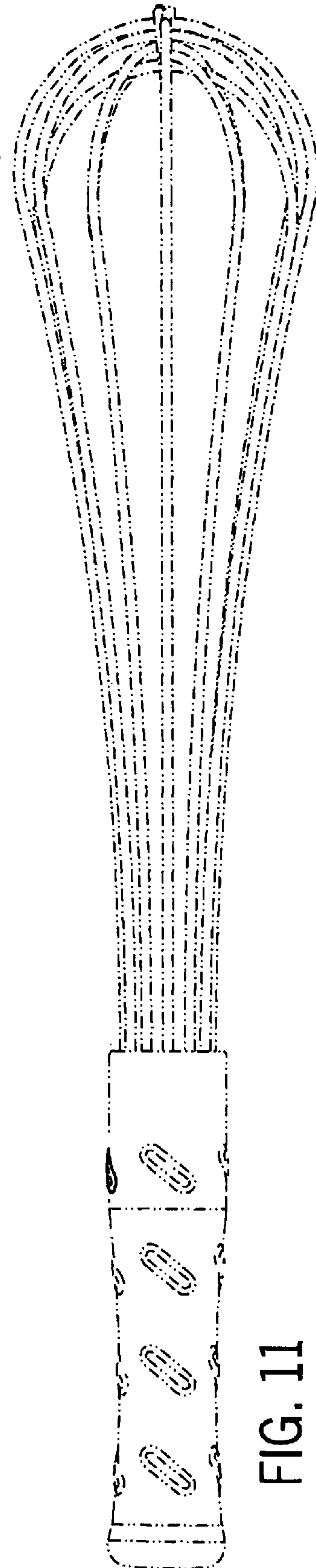

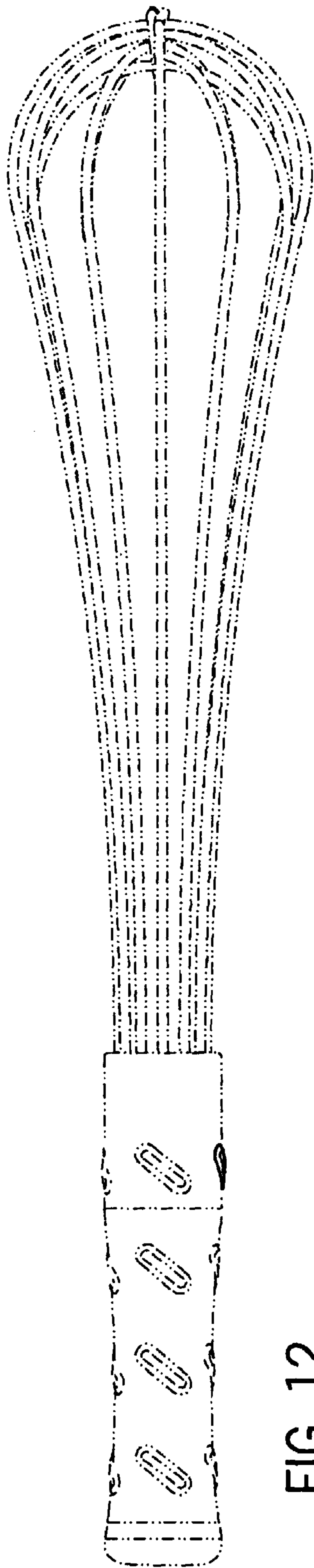

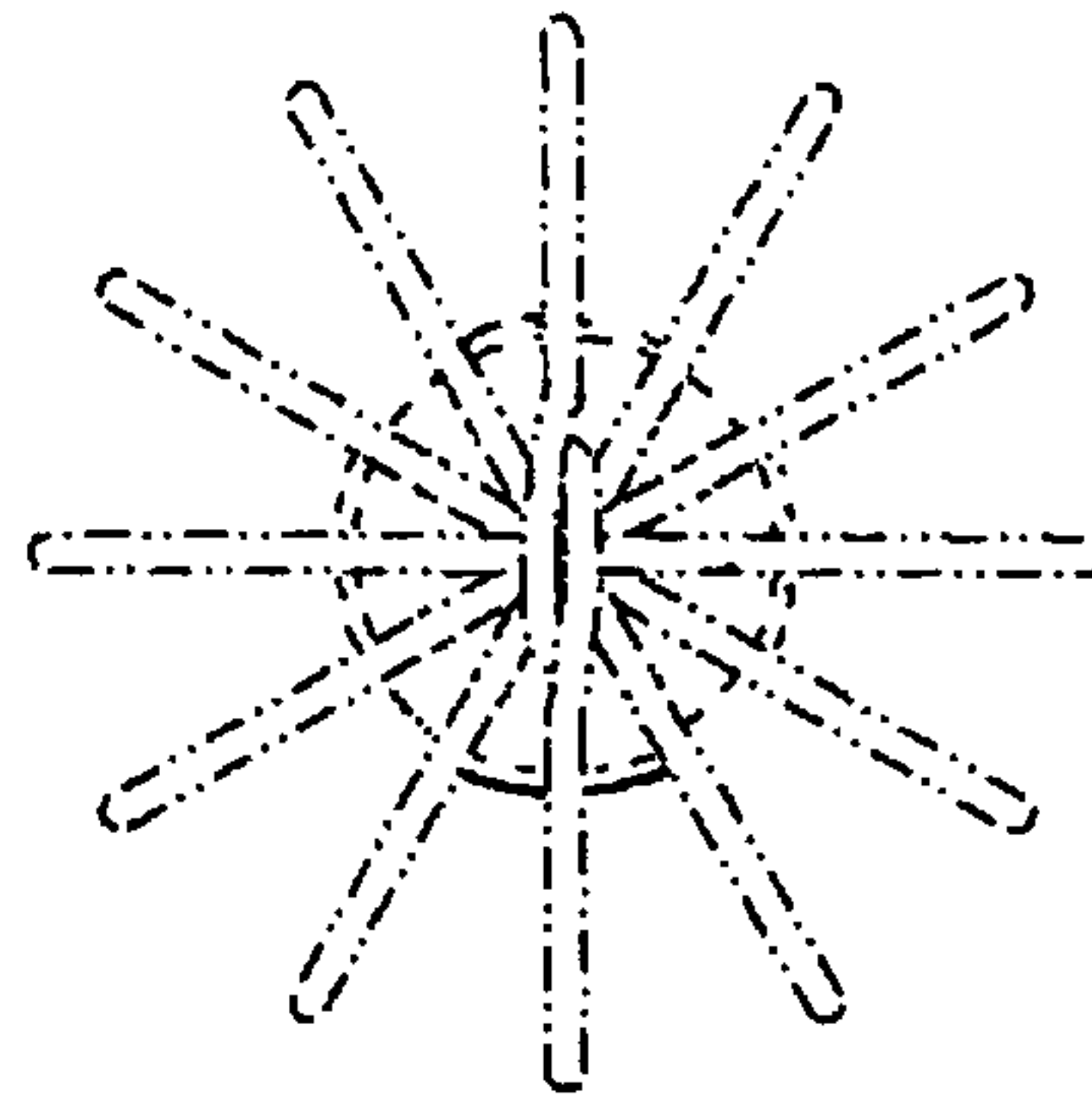

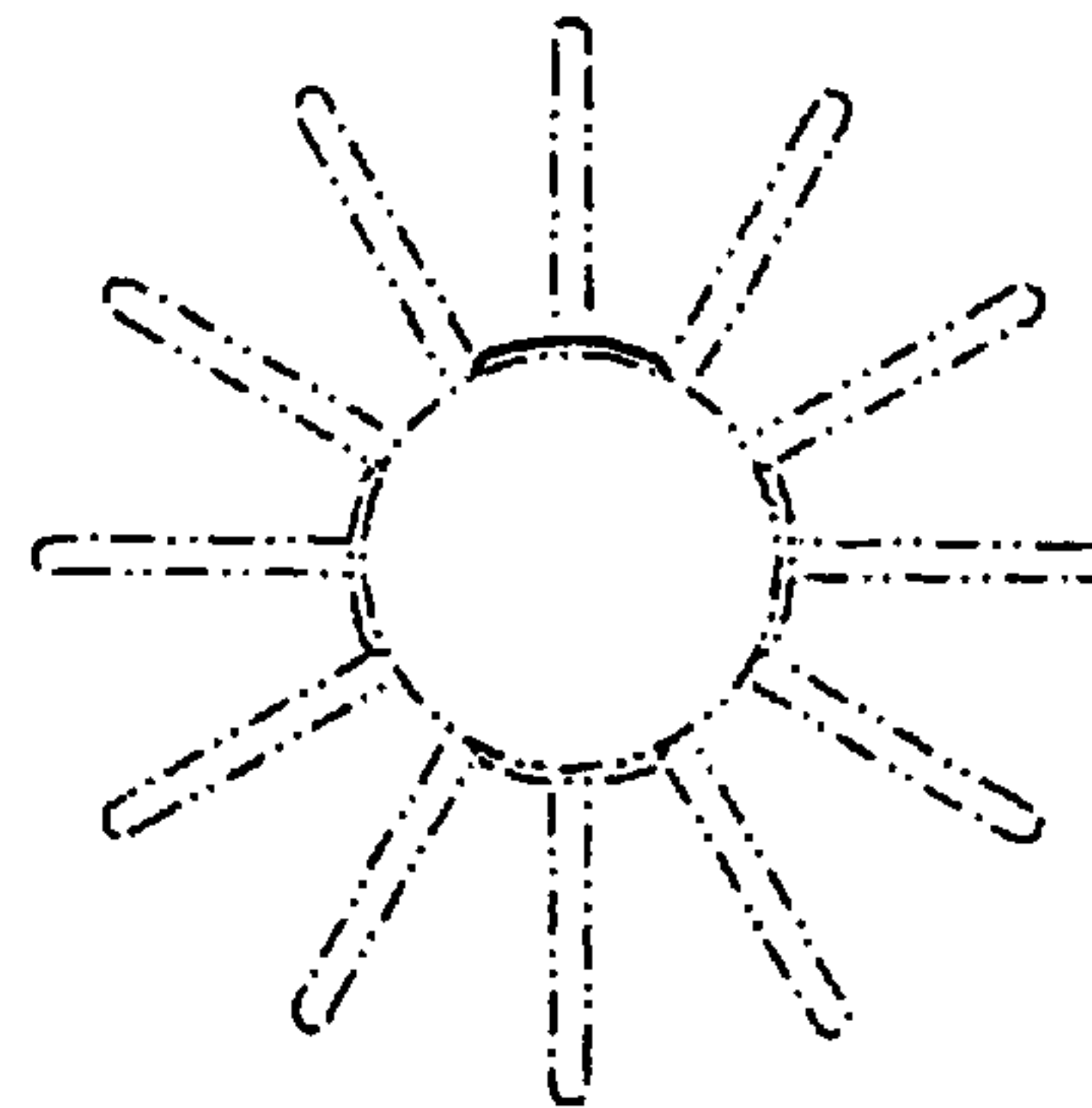

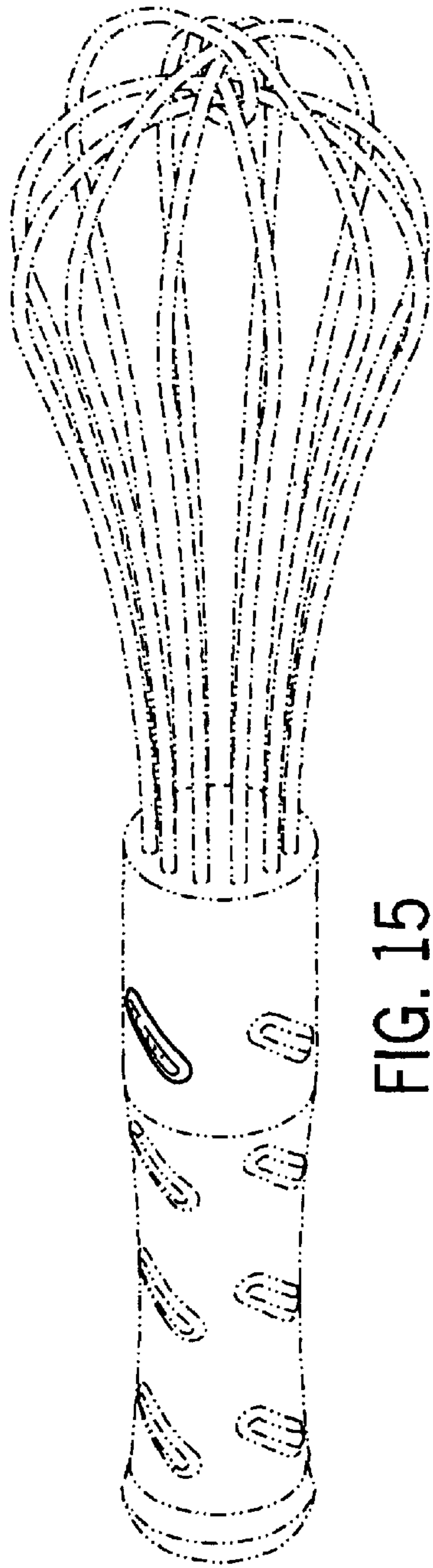

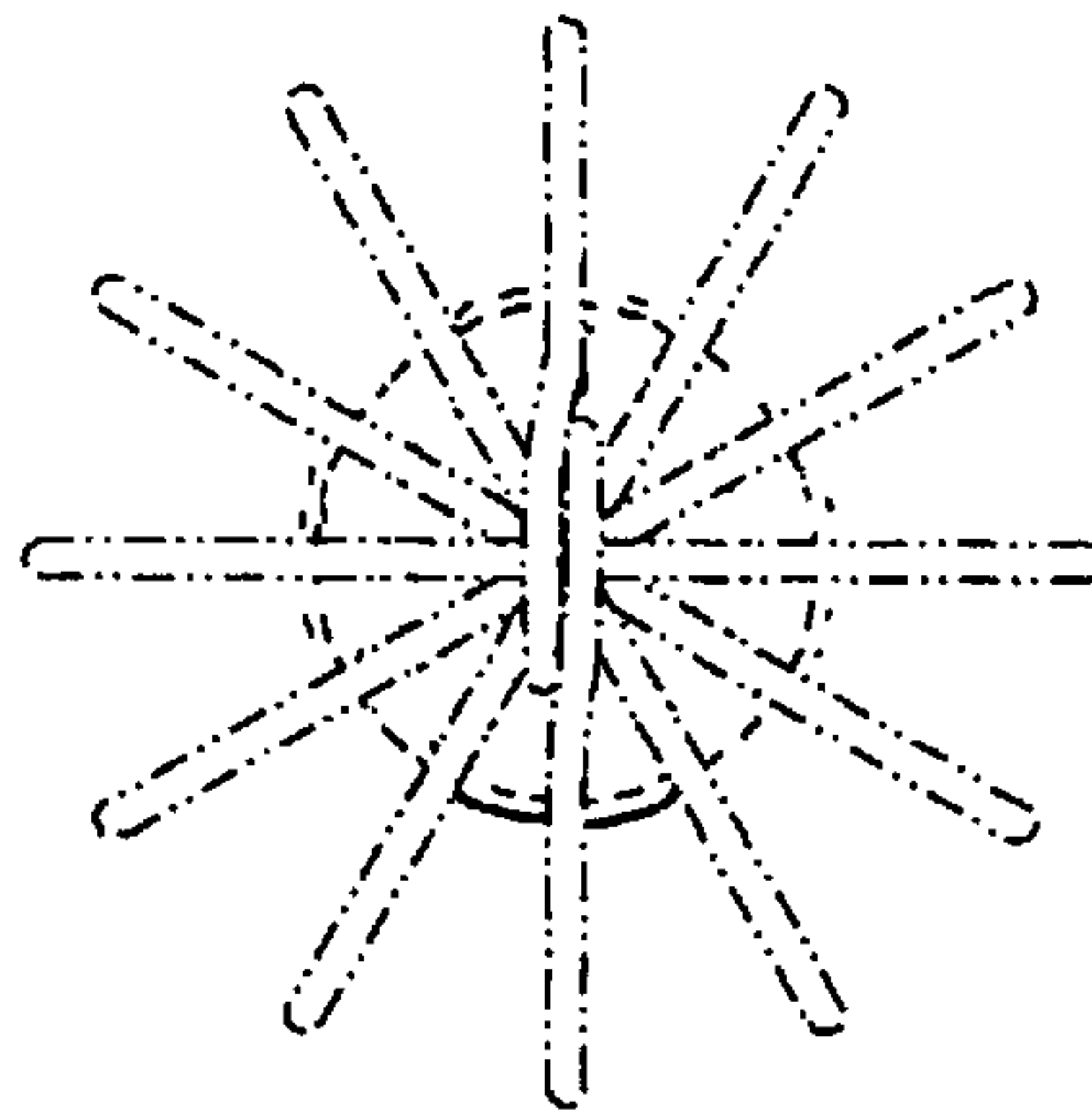

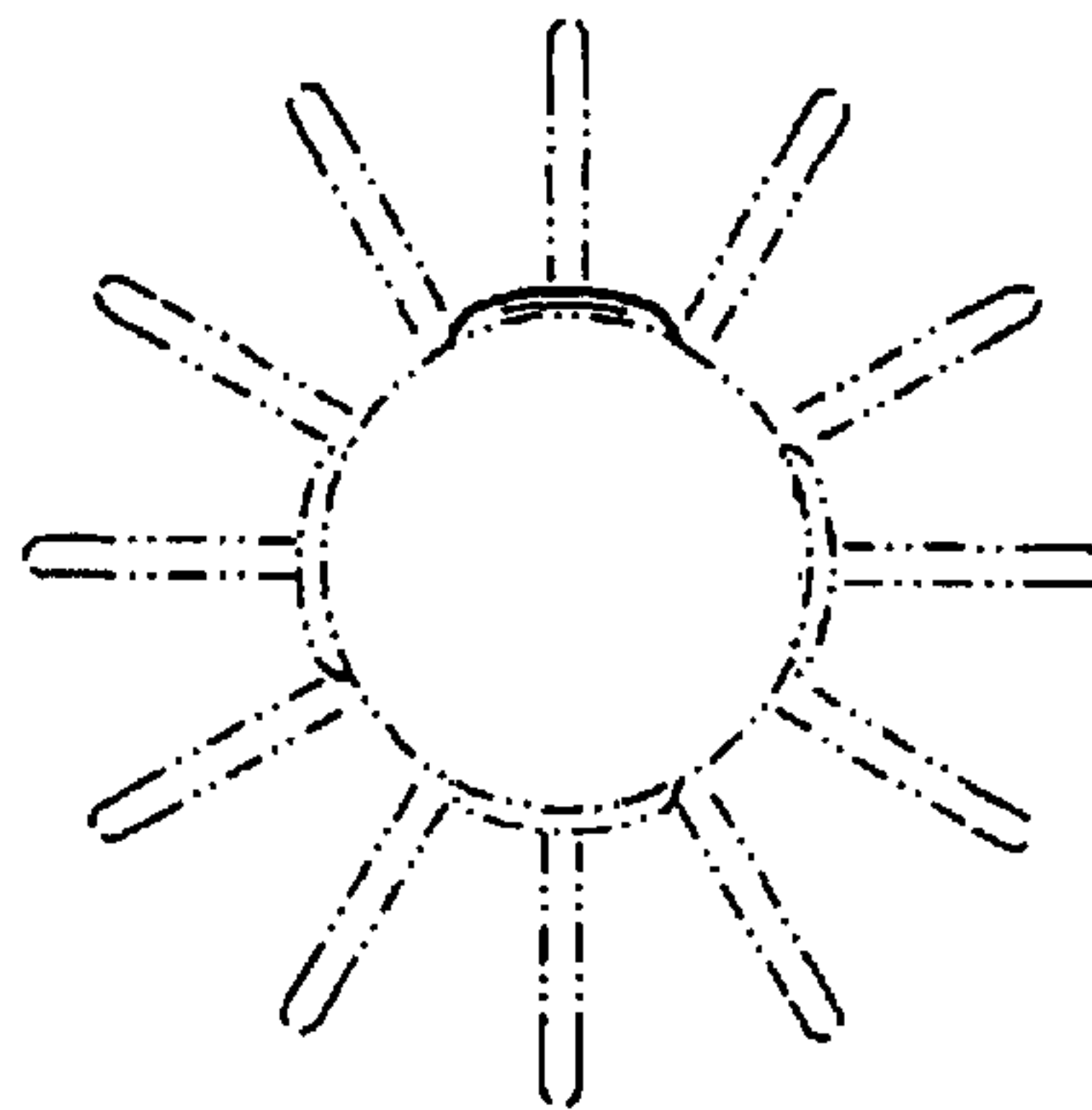

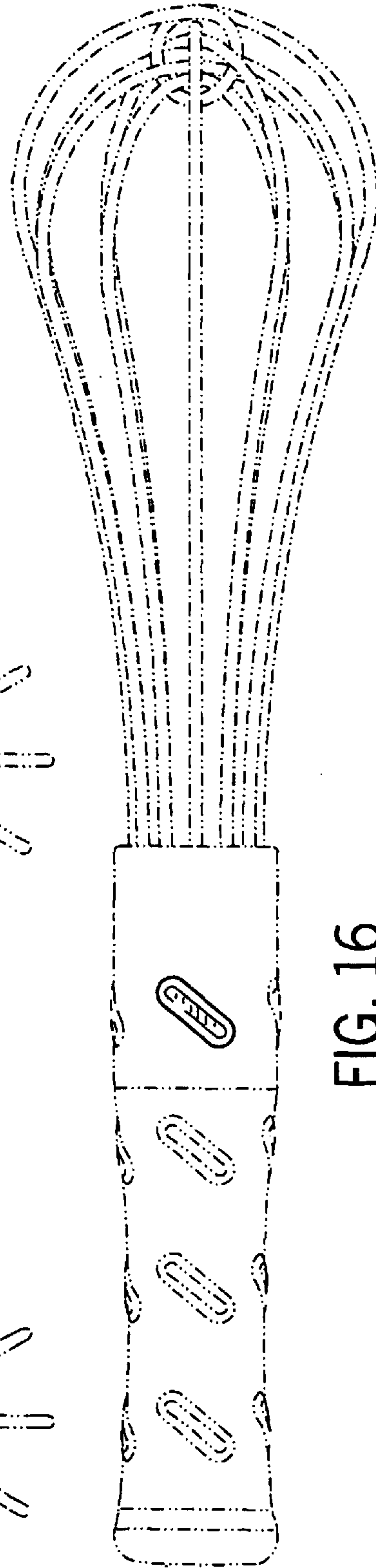

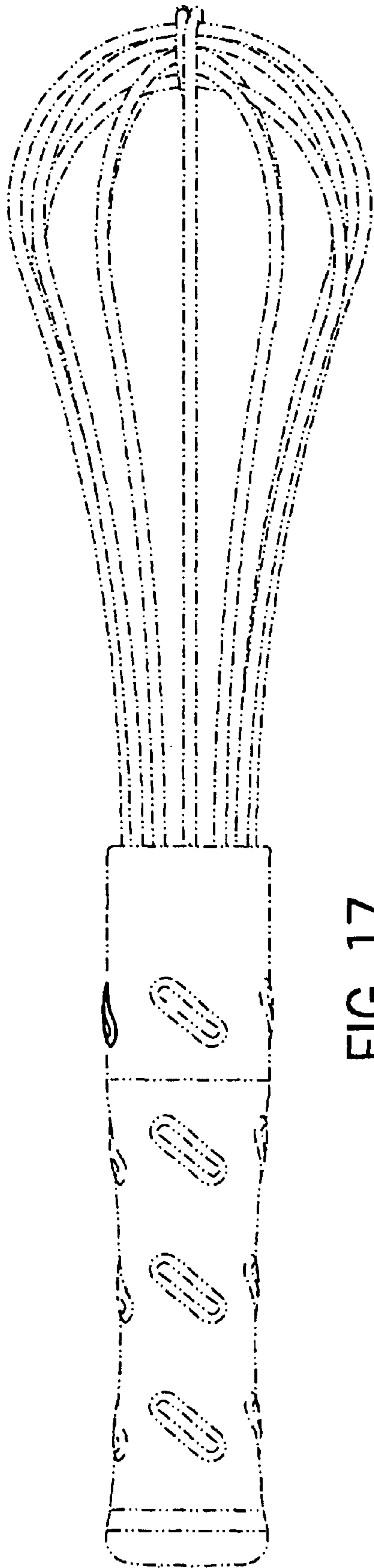

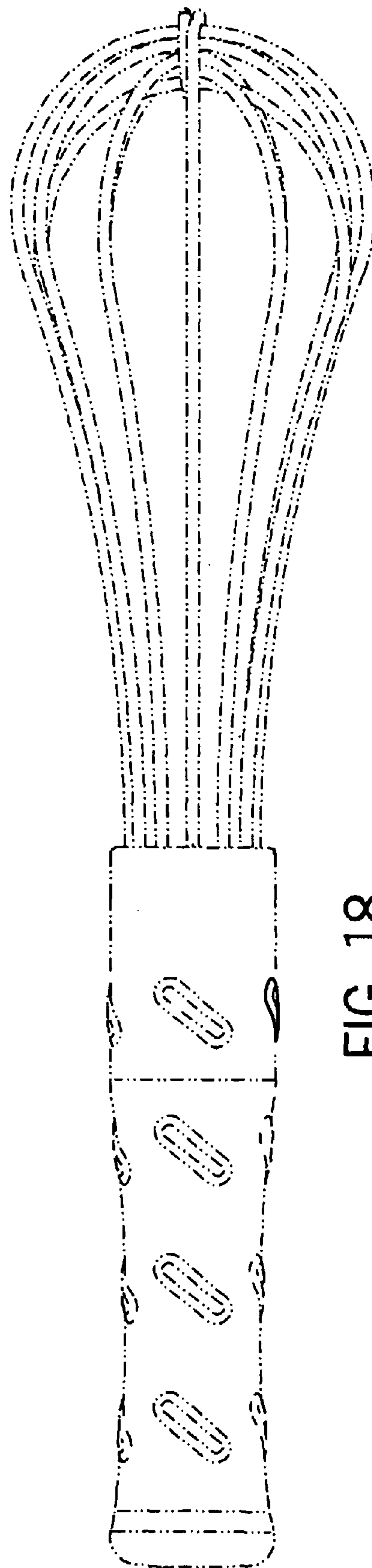

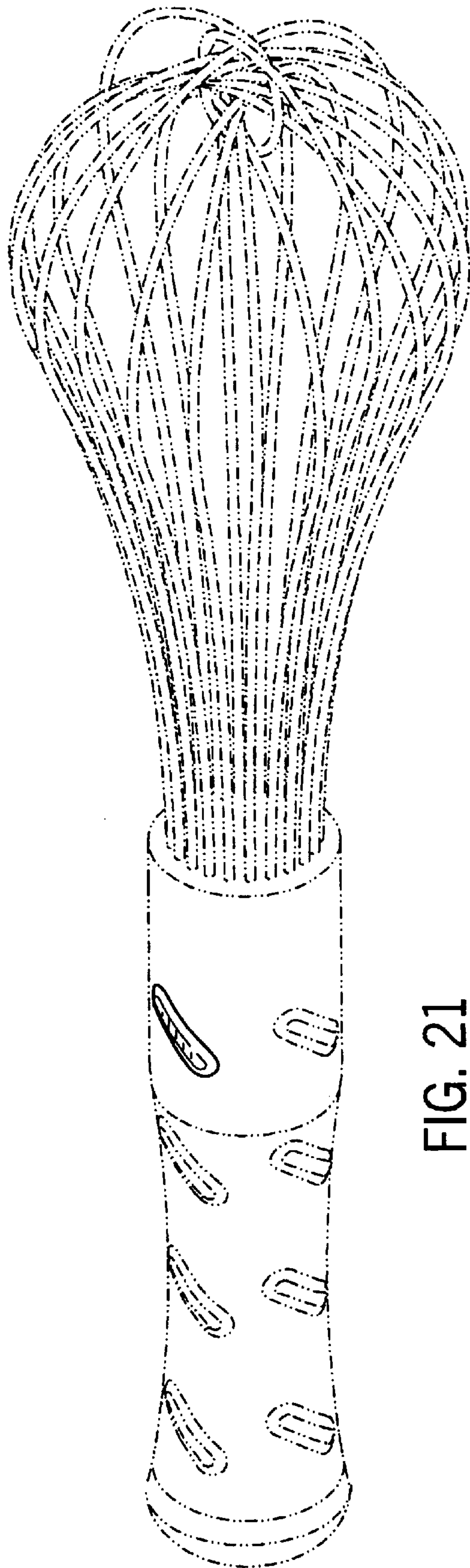

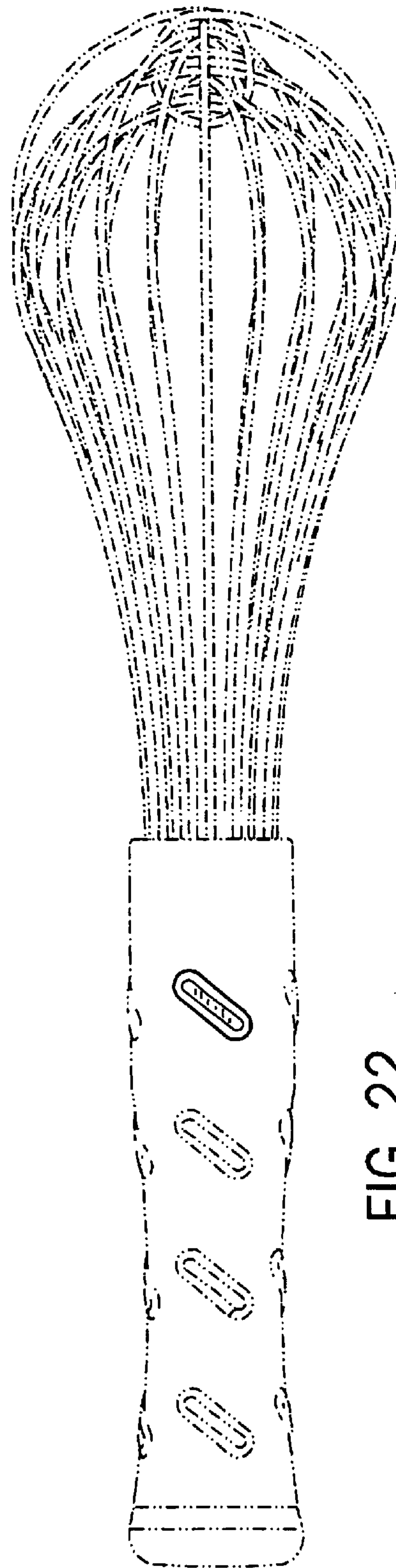

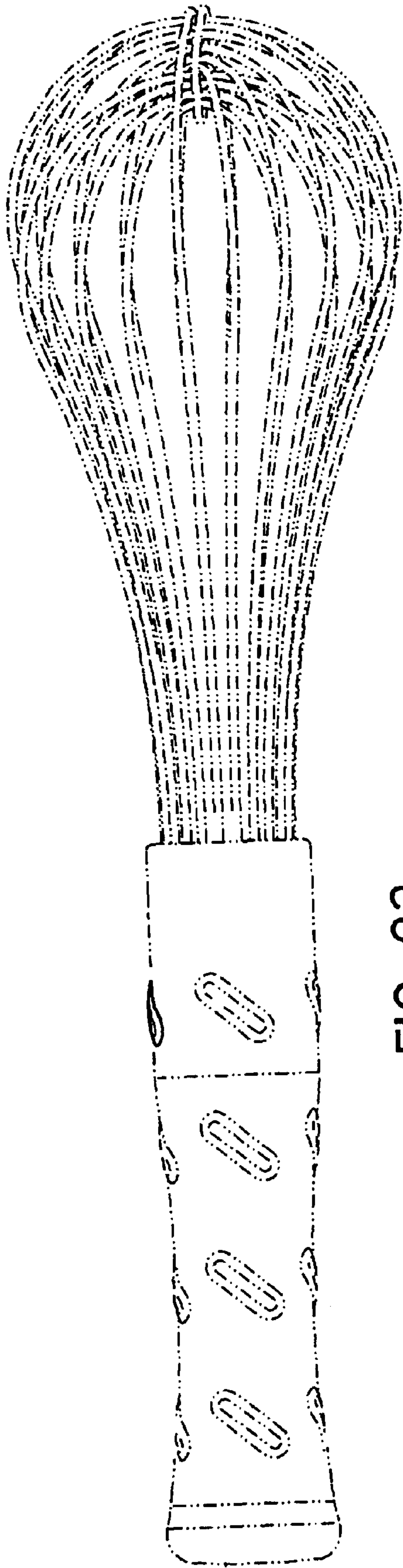

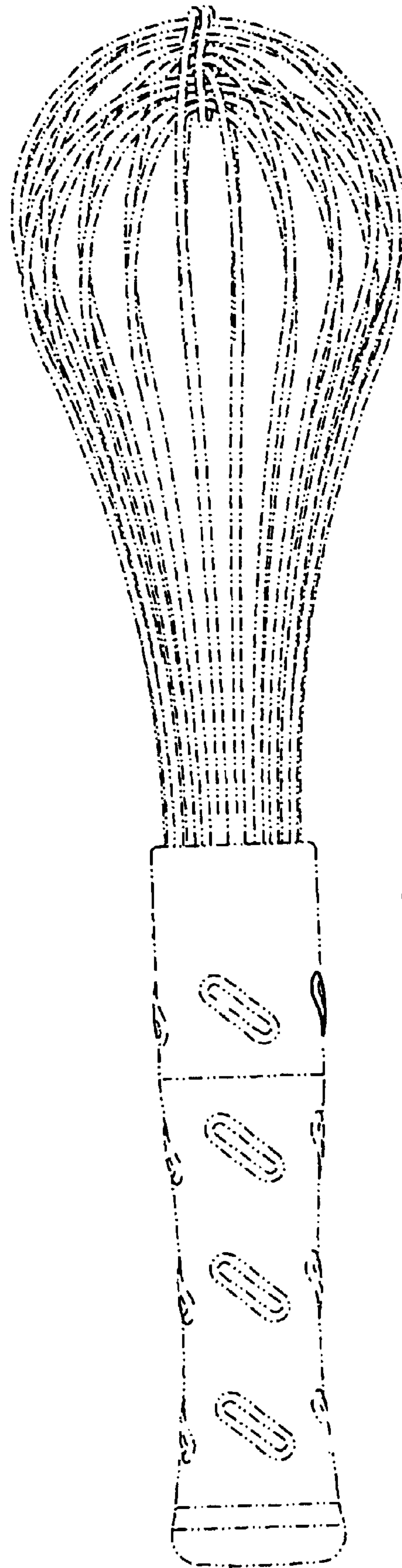

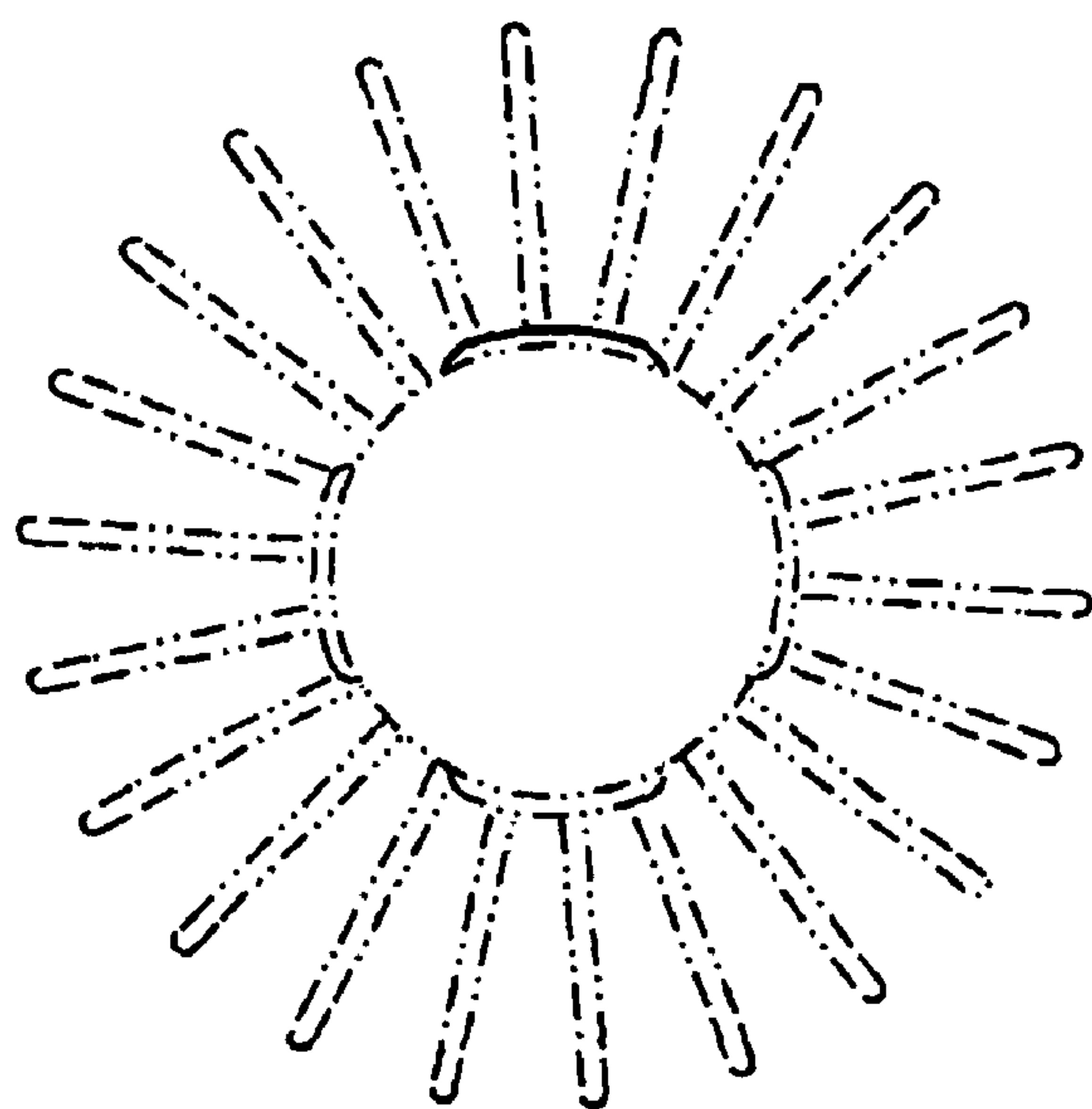

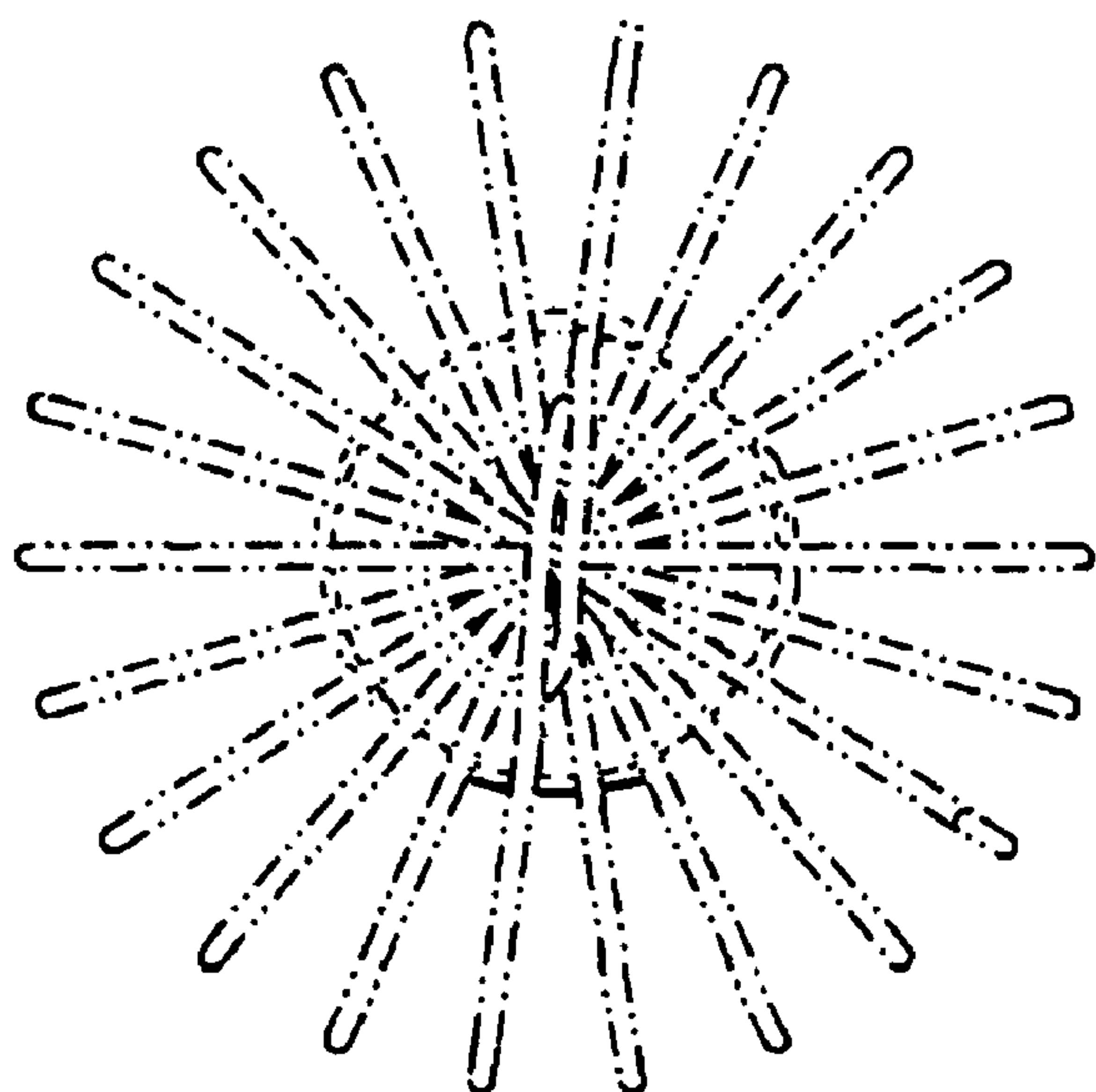

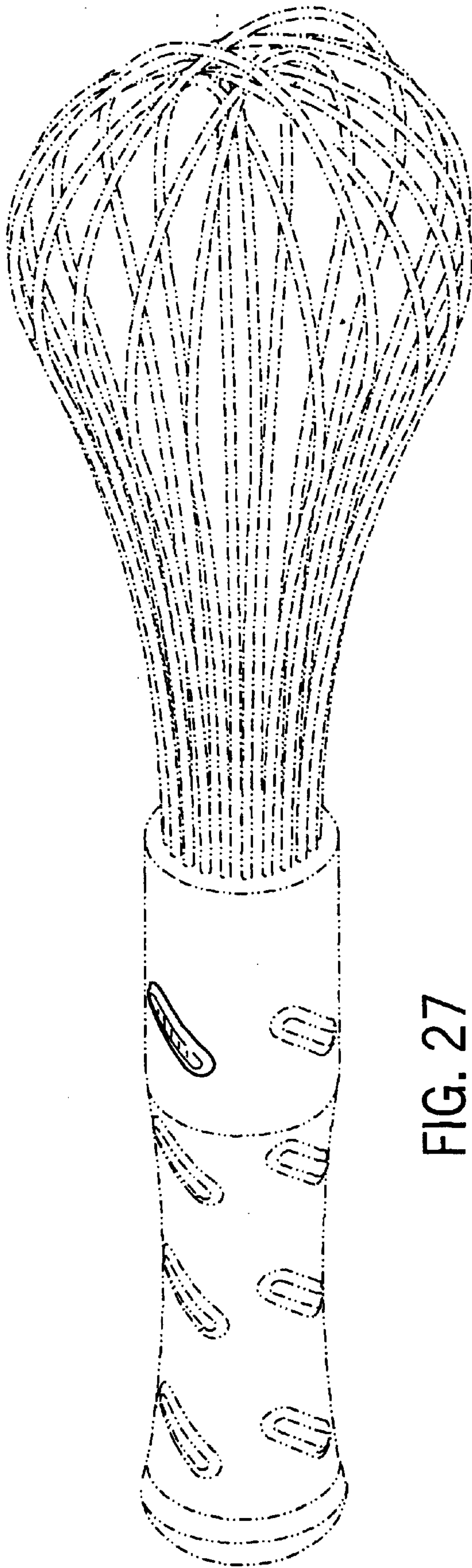

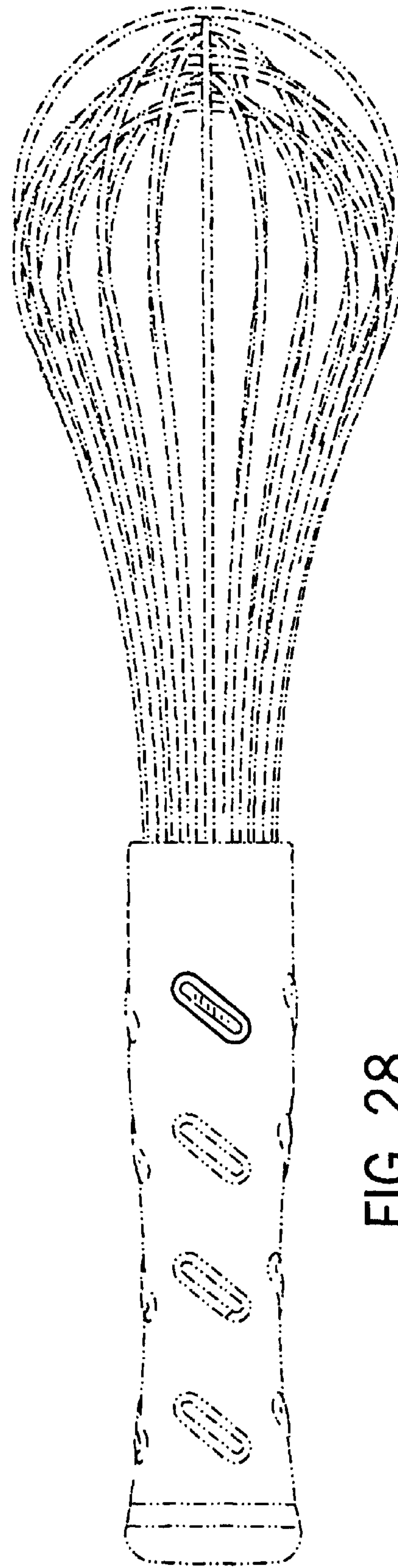
