FIG. 1 is a perspective view of a wrench showing my new design;

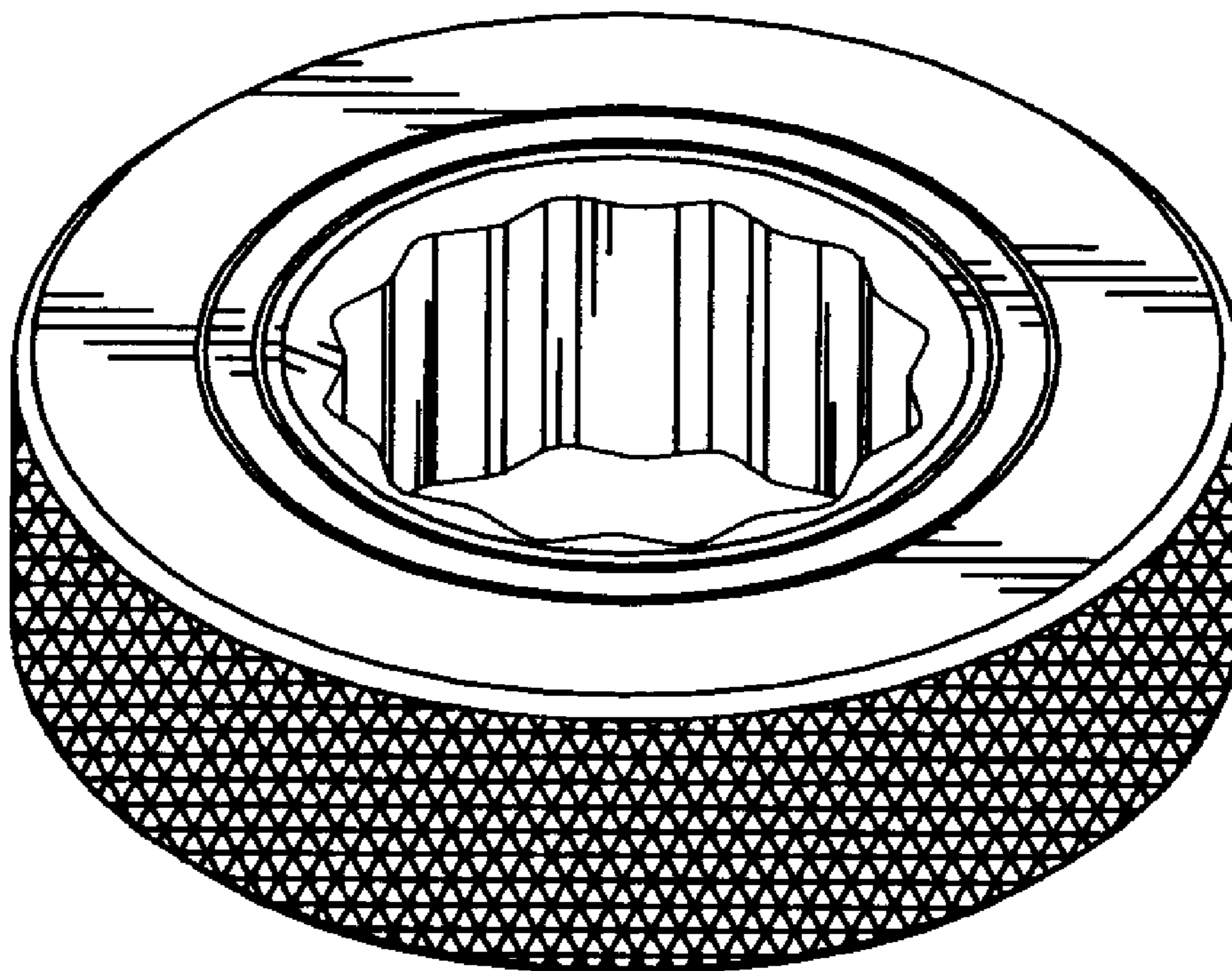
FIG. 2 is a front view thereof; the opposite side being a mirror image of the shown;

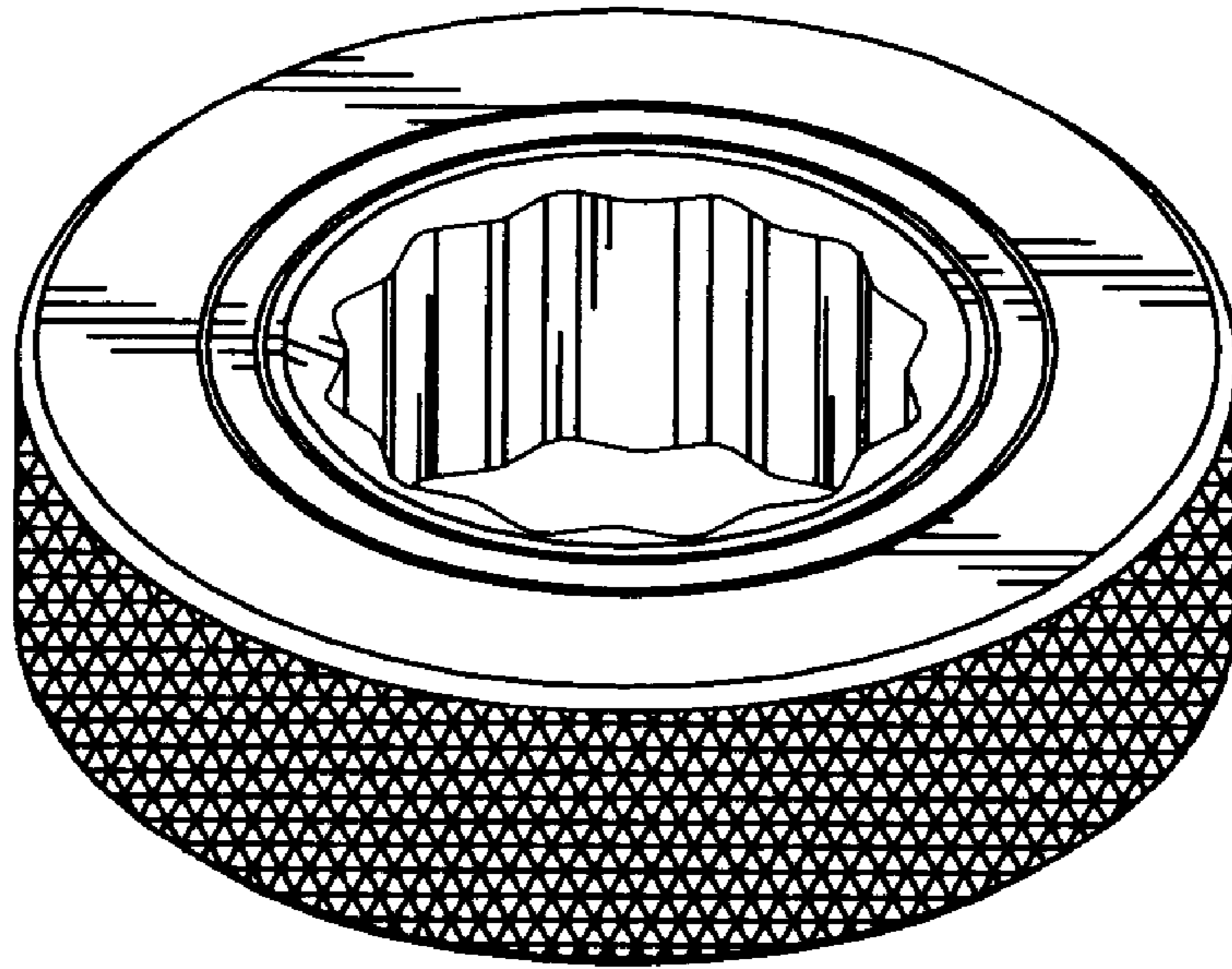

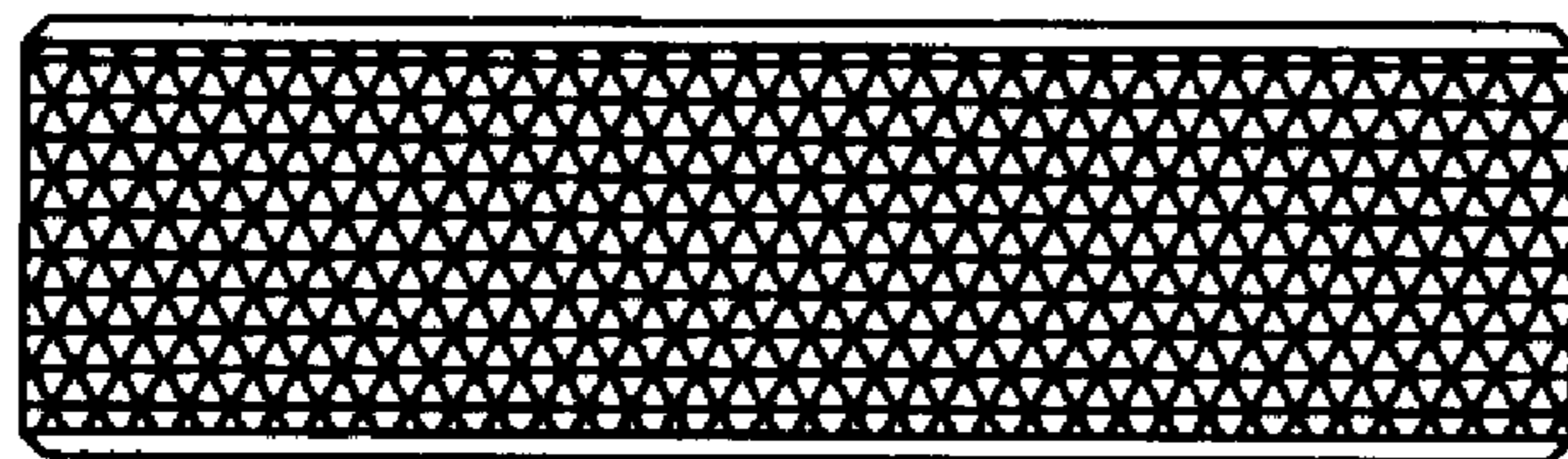

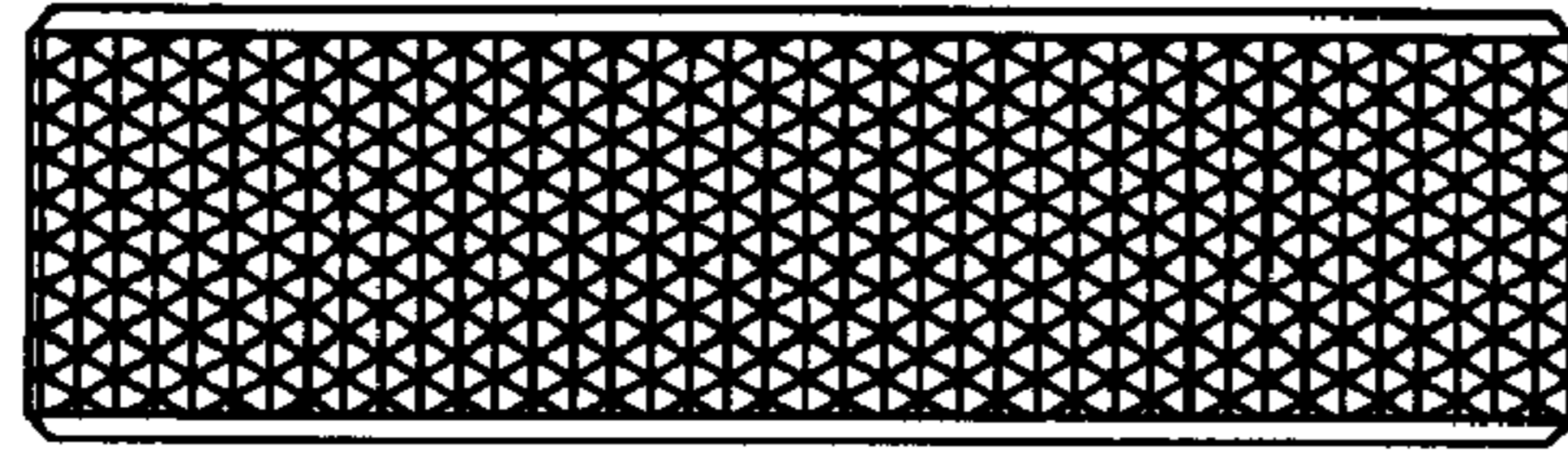

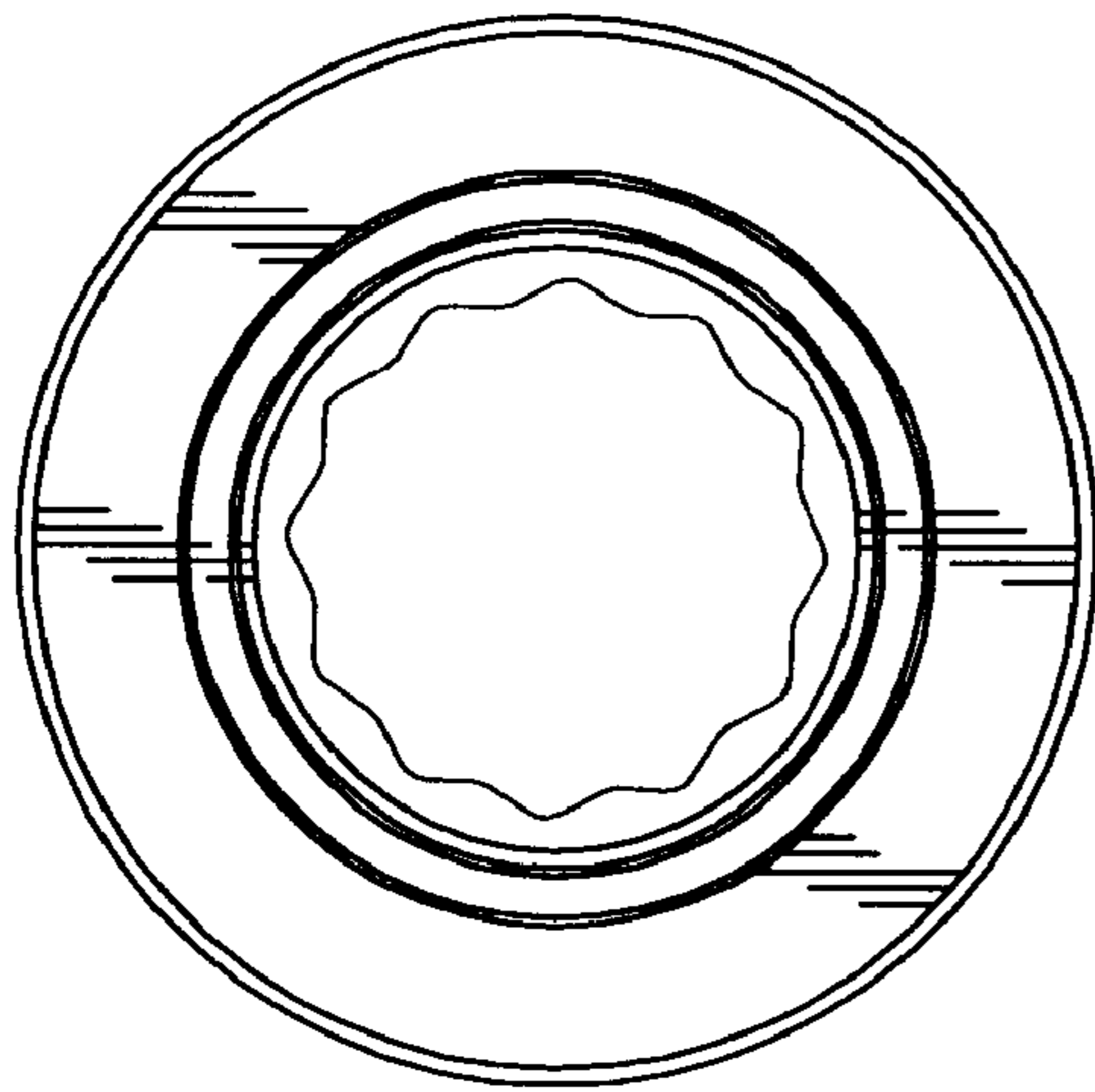

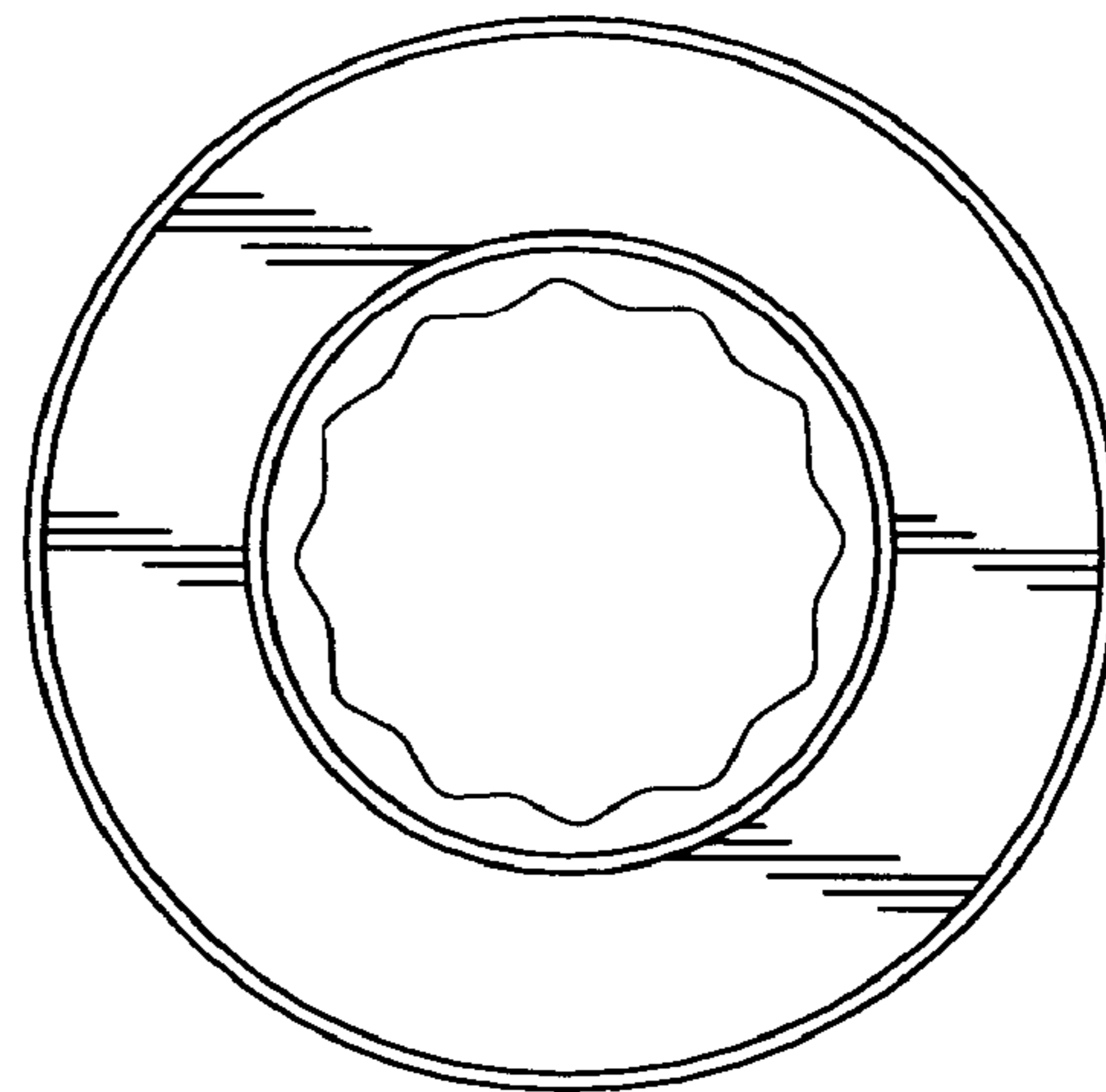
