(57) **CLAIM**

The ornamental design for a fish shaped bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of my new design for a fish shaped bottle opener, the opposite side being a mirror image thereof. FIG. 2 is a right side elevation thereof. FIG. 3 is a left side elevation thereof. FIG. 4 is a back side elevation thereof. FIG. 5 is a front side elevation thereof; and, FIG. 6 is a top perspective view thereof.

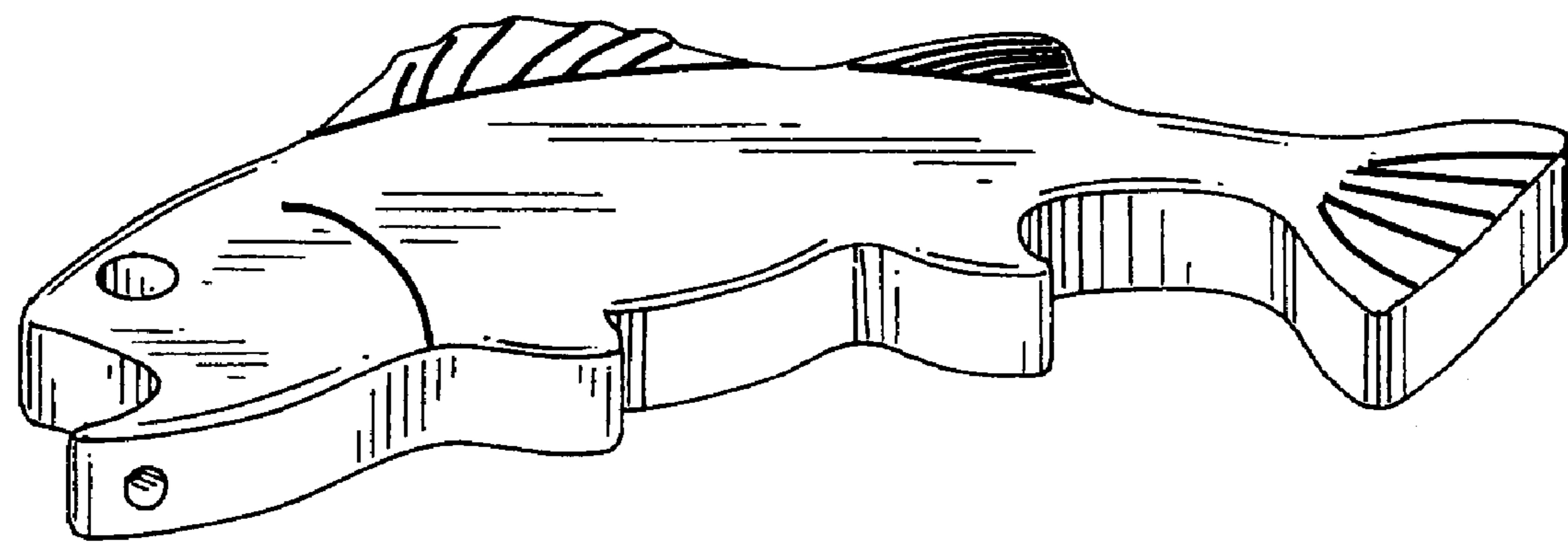

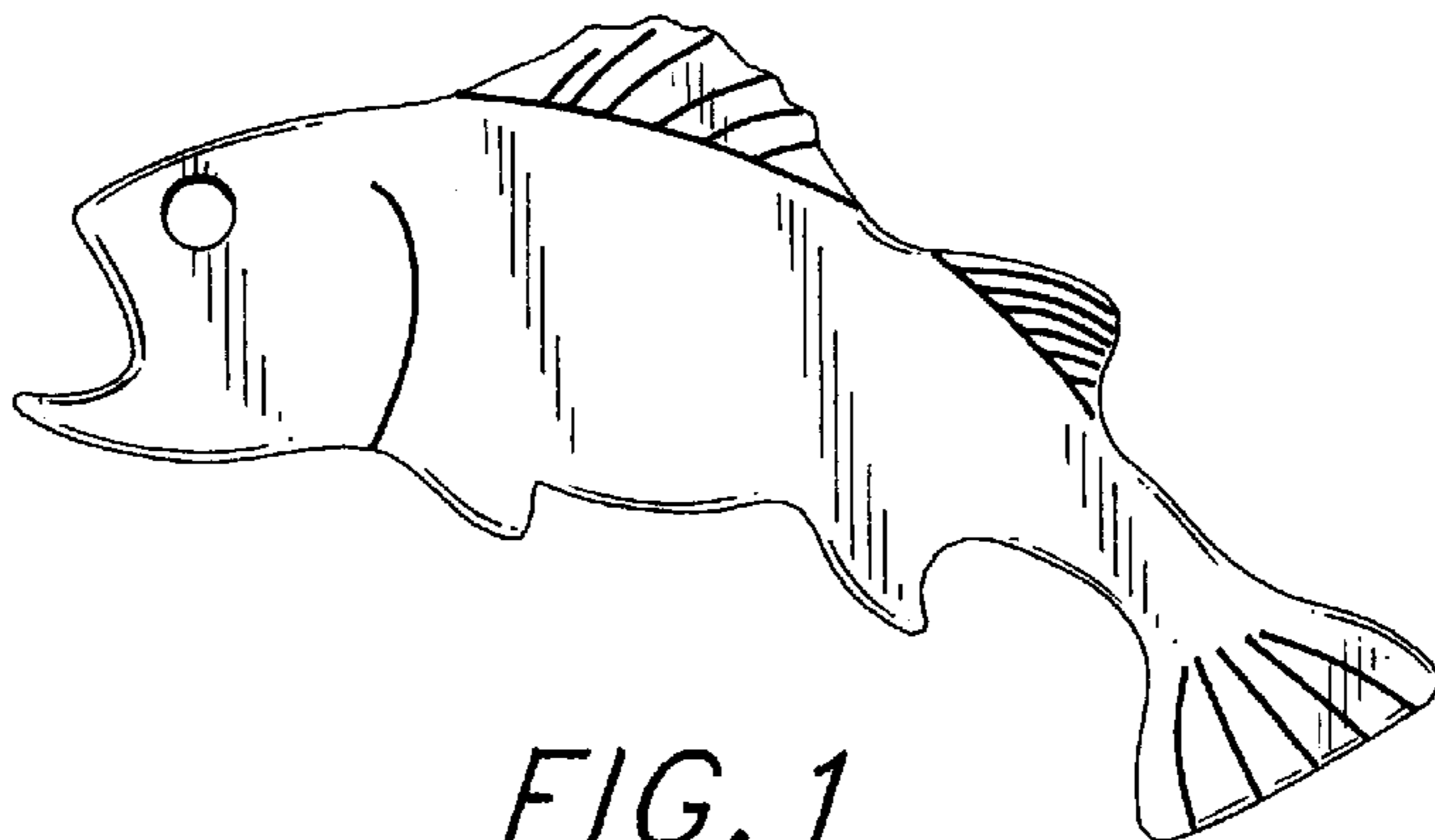

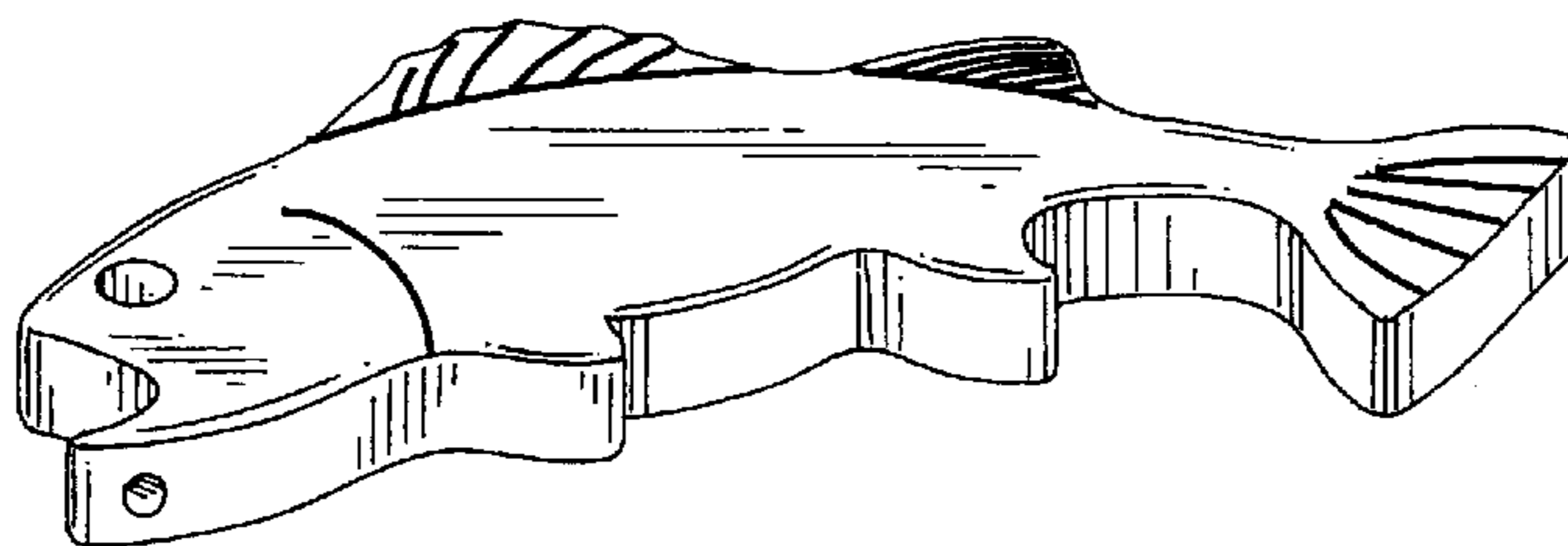
