(57) **CLAIM**

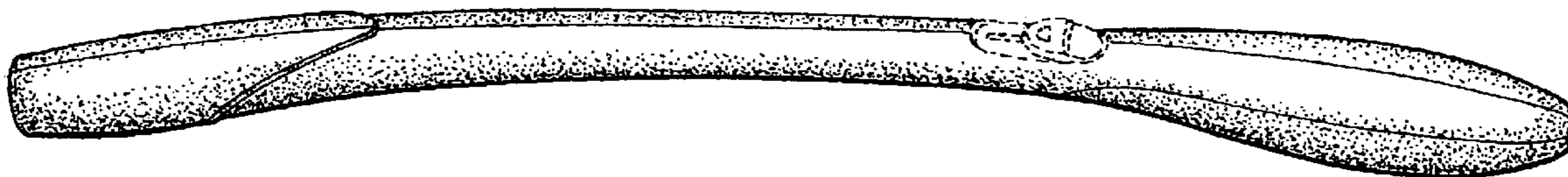
The ornamental design for a handle for a cleaning tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for a cleaning tool embodying the new design;
FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view.

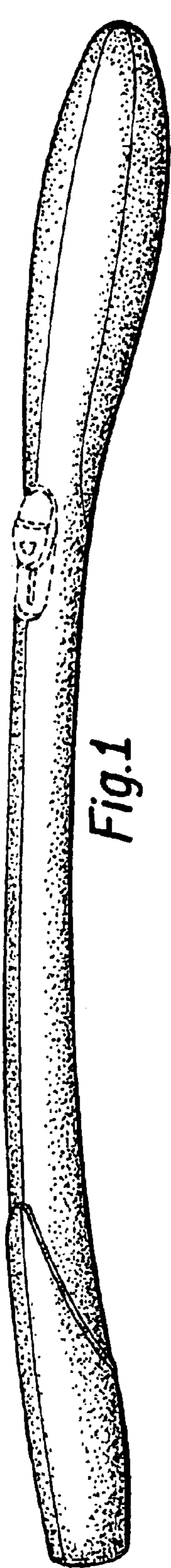

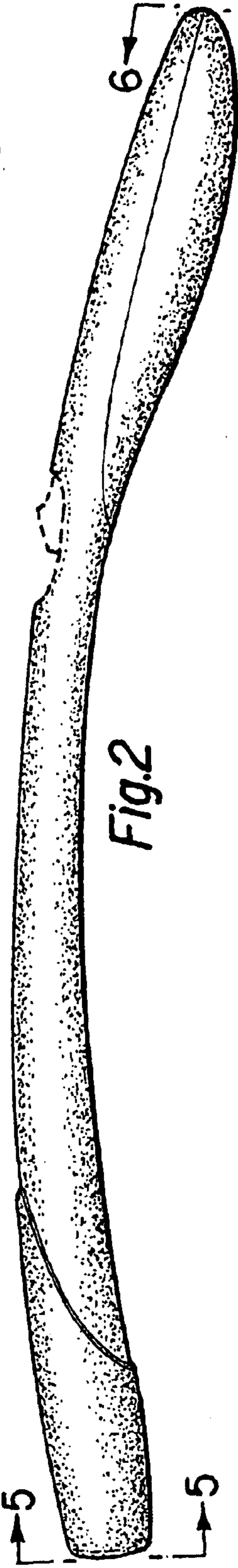

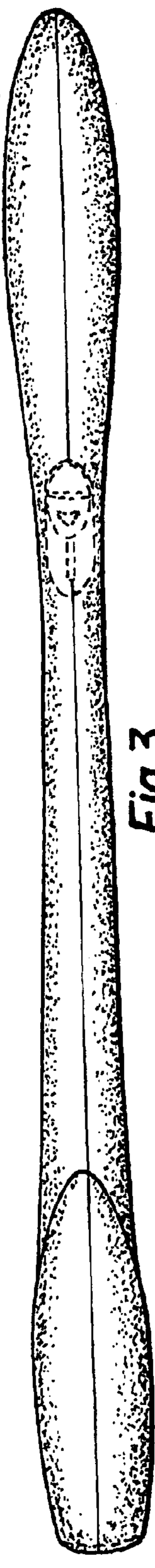

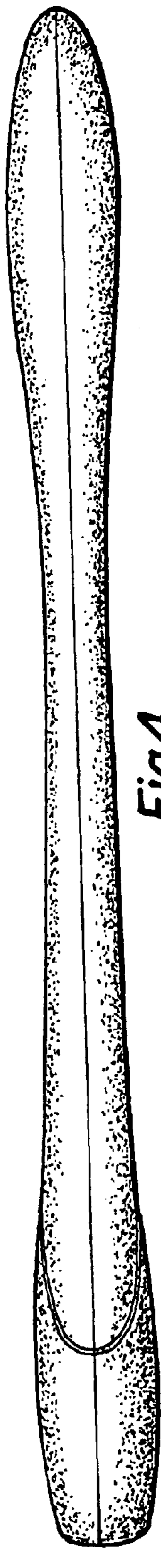

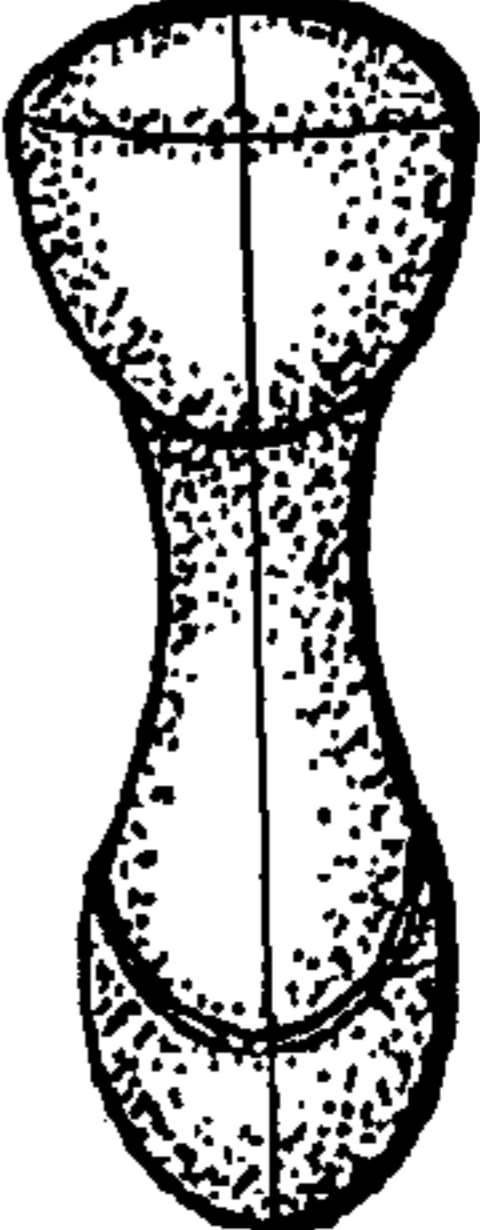
