DESCRIPTION

FIG. 4 is a rear plan view of a hang tab for footwear showing a fourth embodiment of my new design,

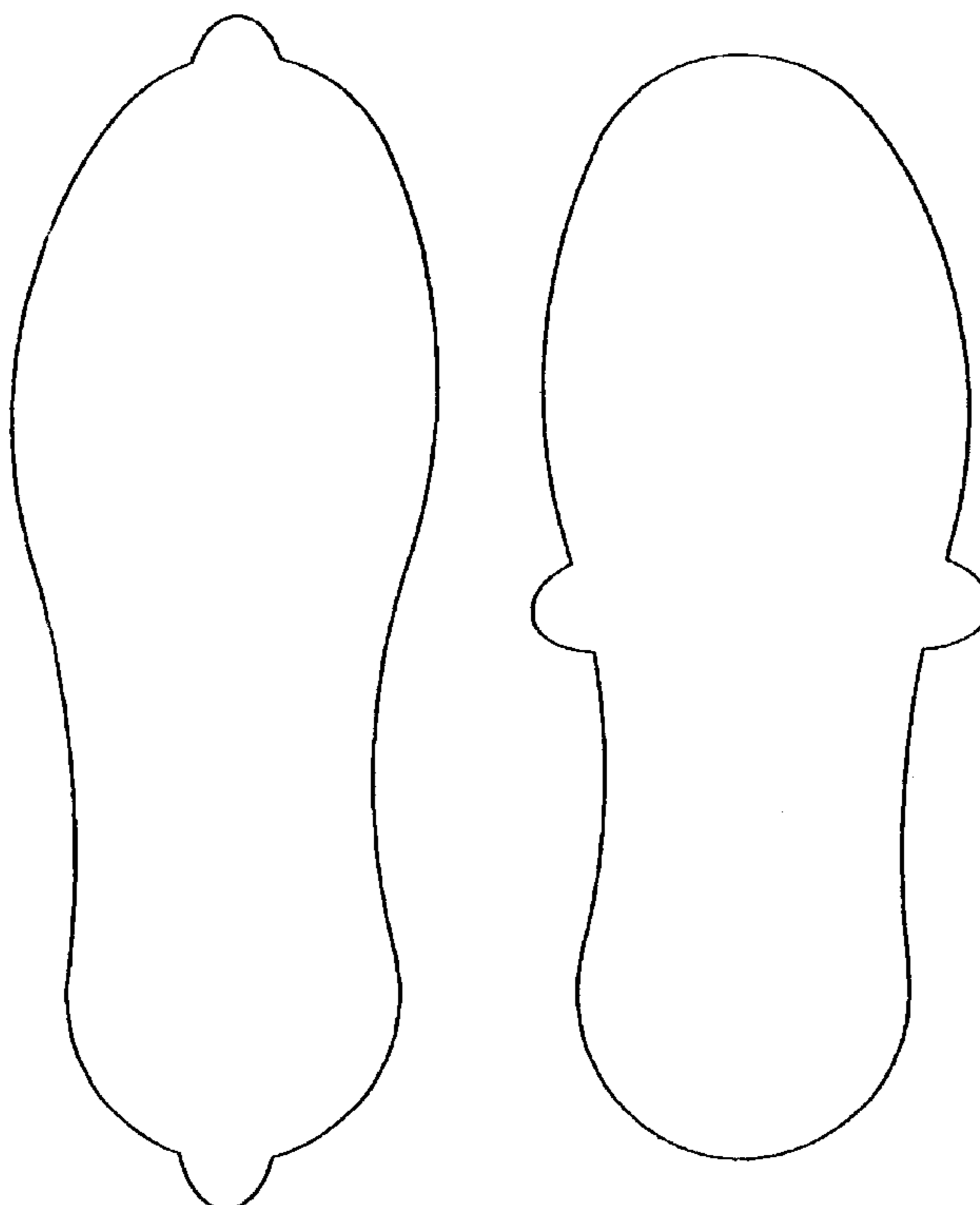
FIG. 5 is a rear plan view of a hang tab for footwear showing a fifth embodiment of my new design,

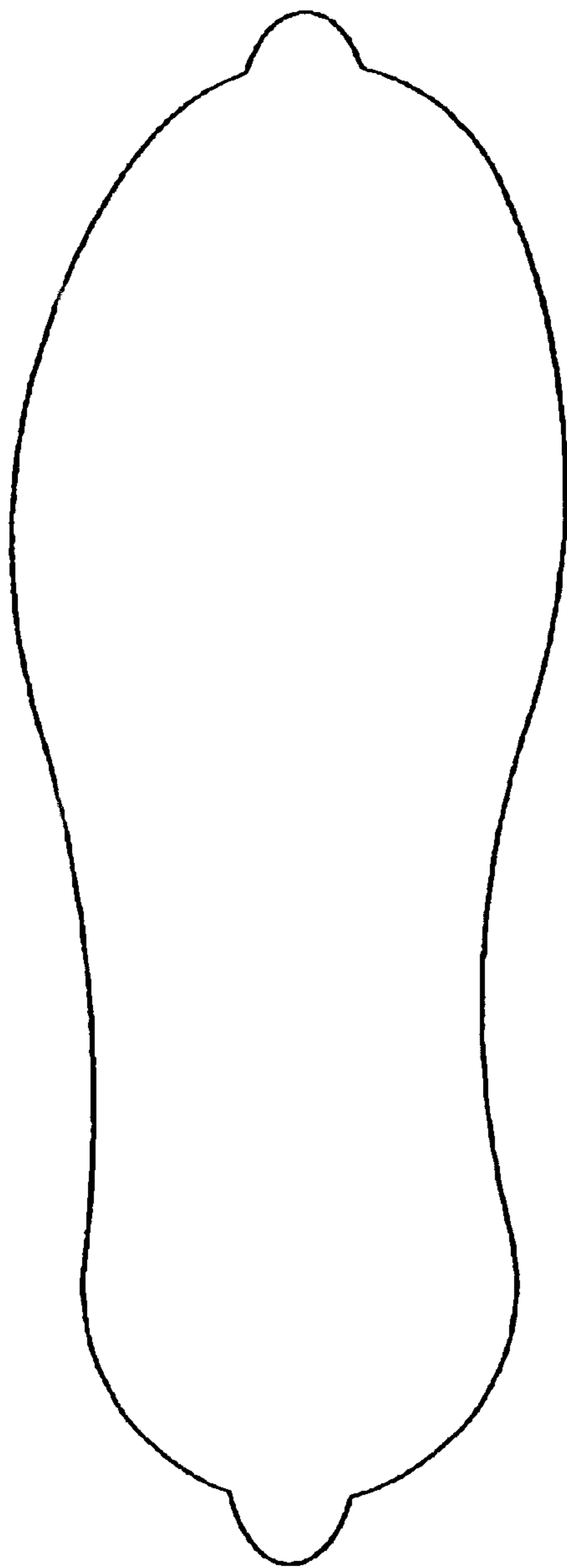

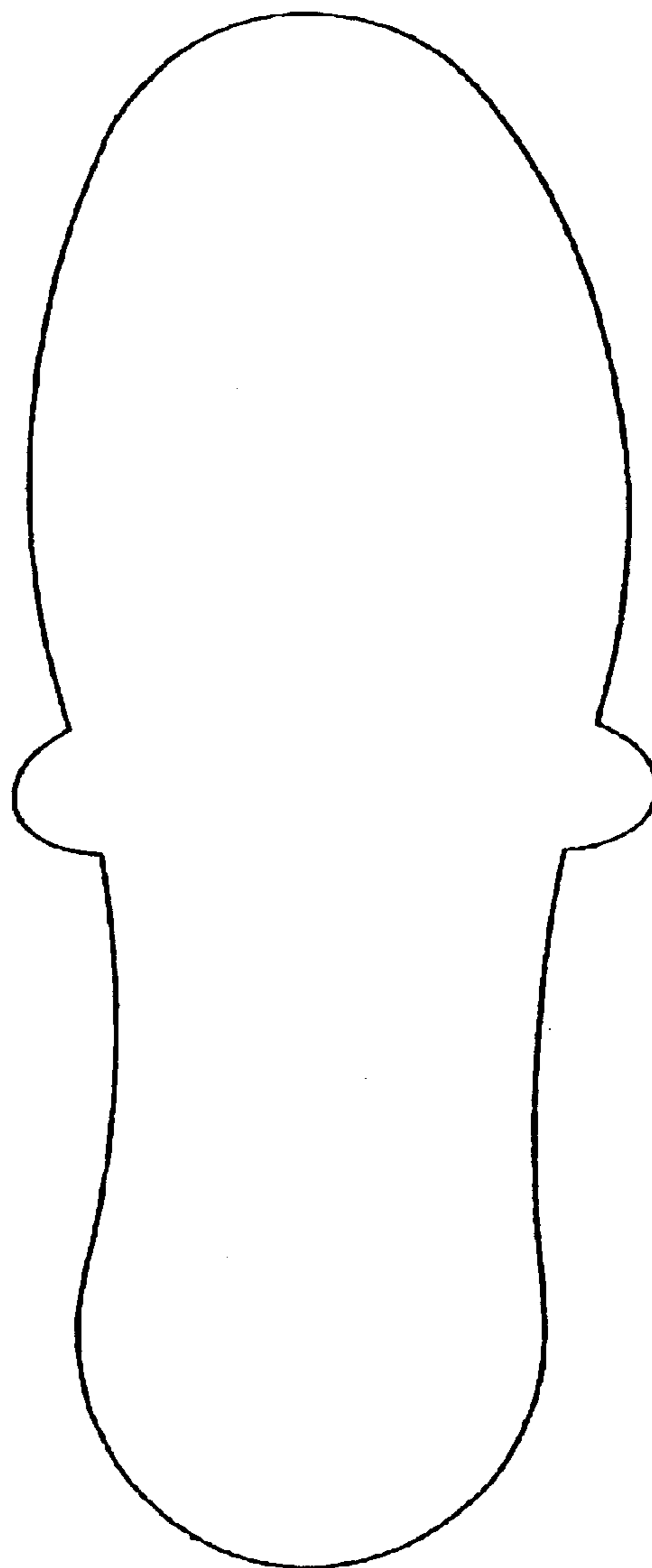

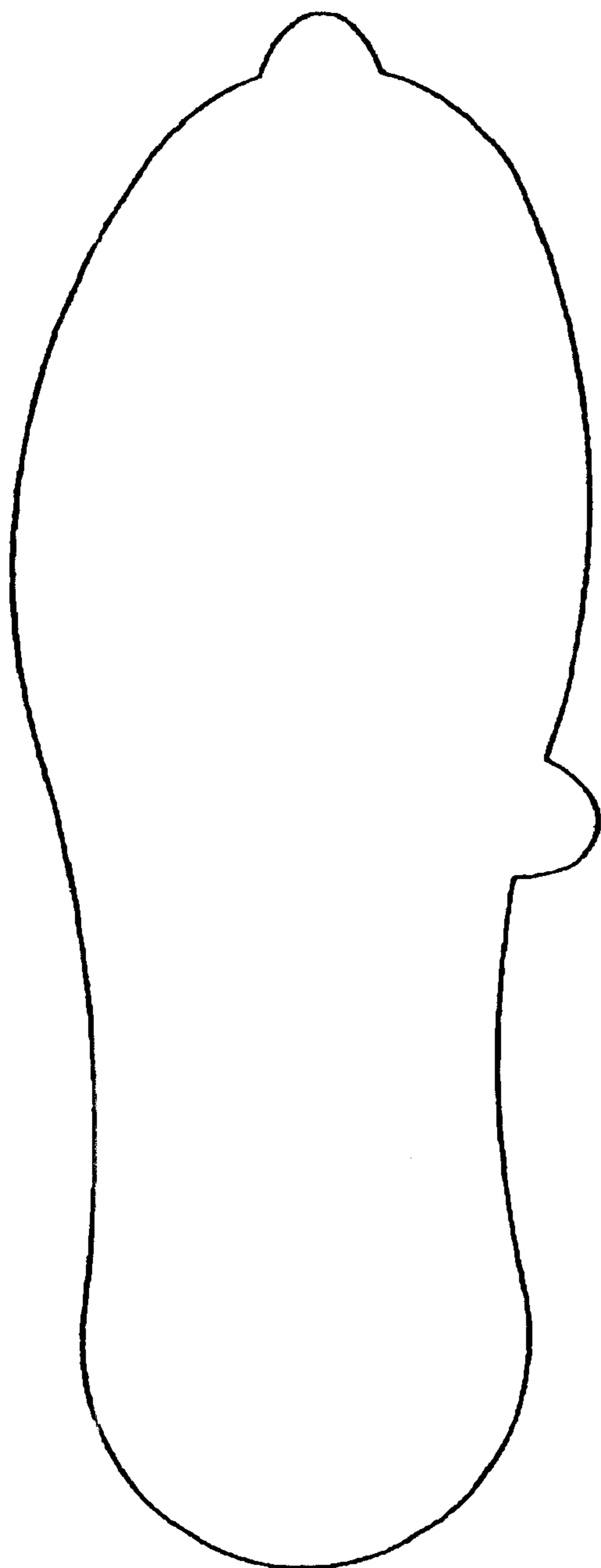

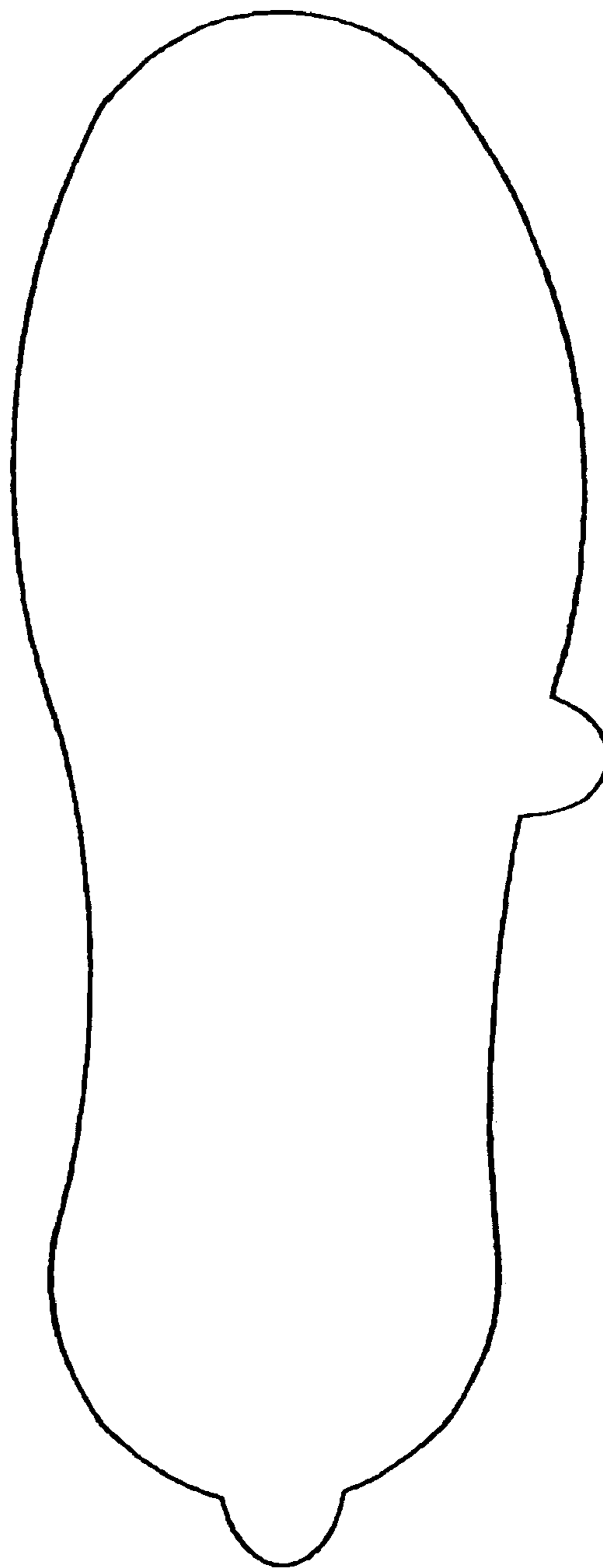

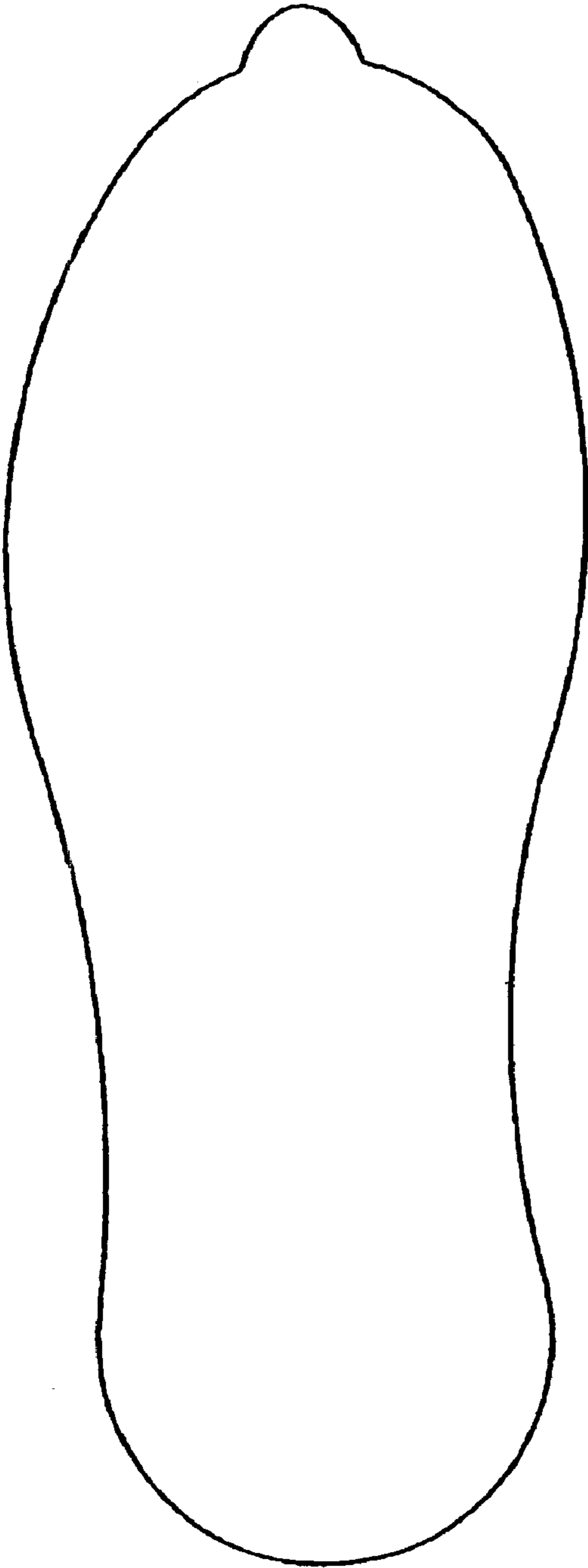

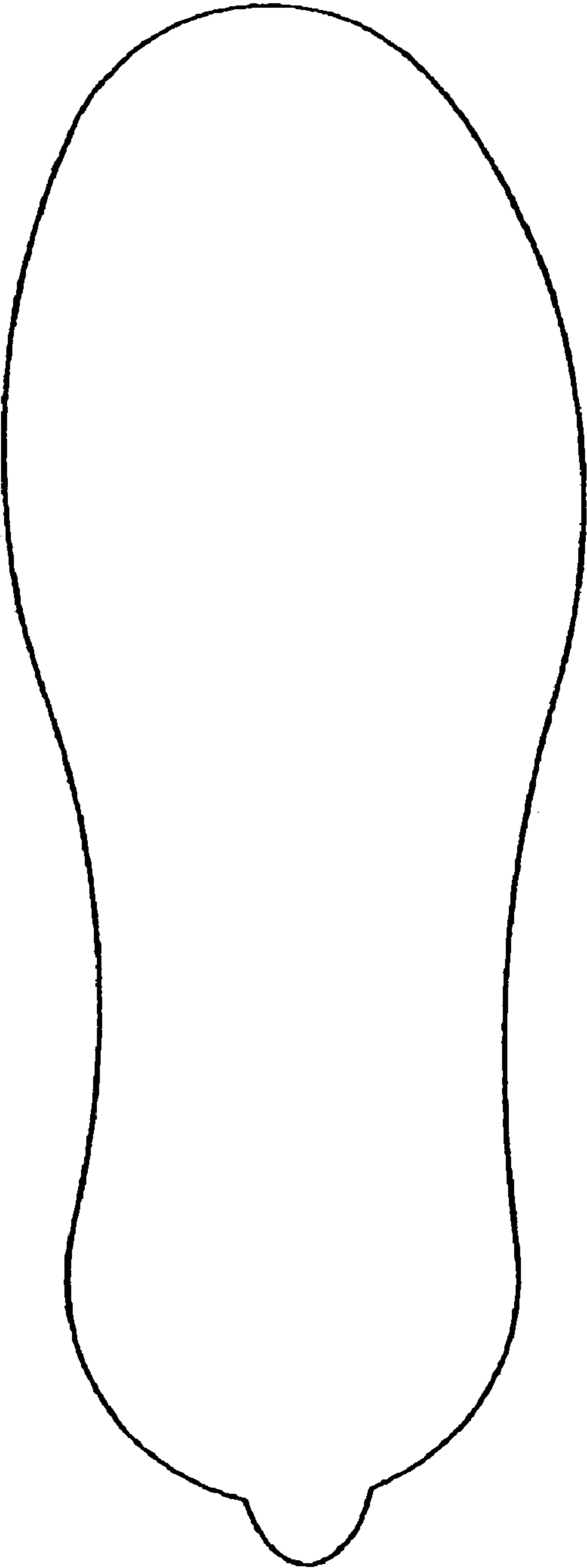

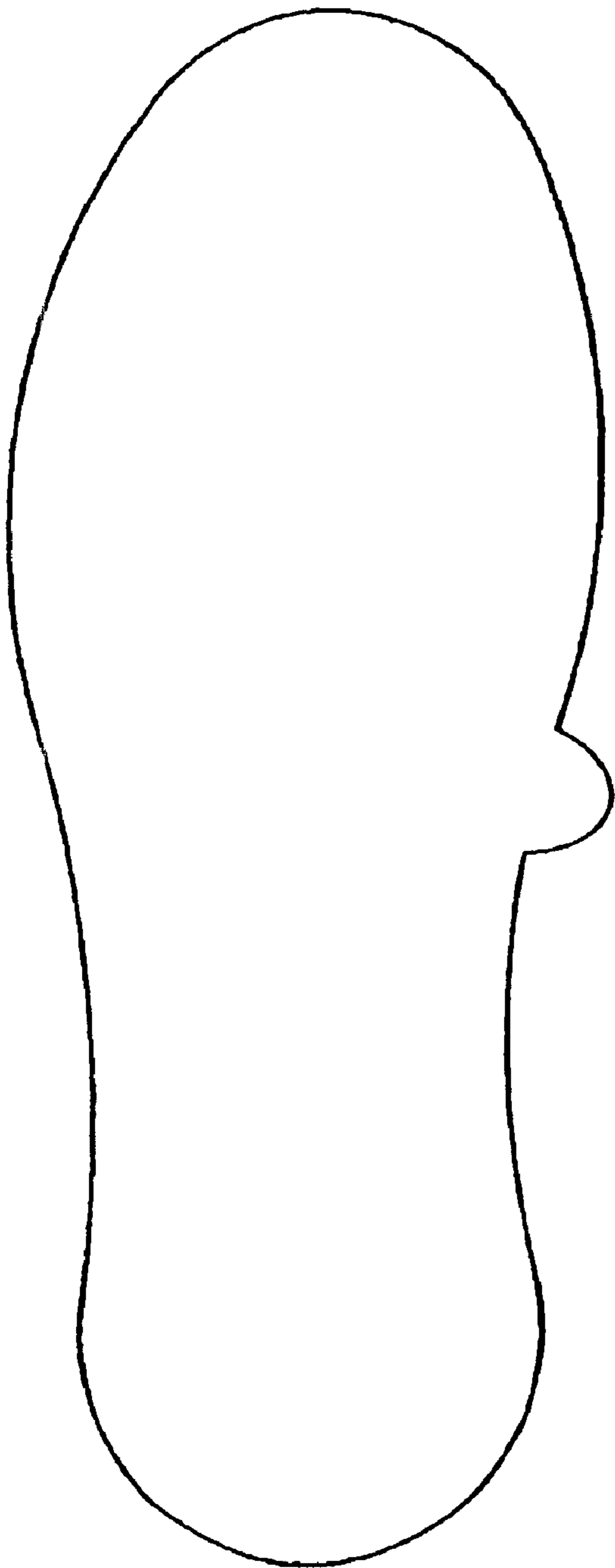

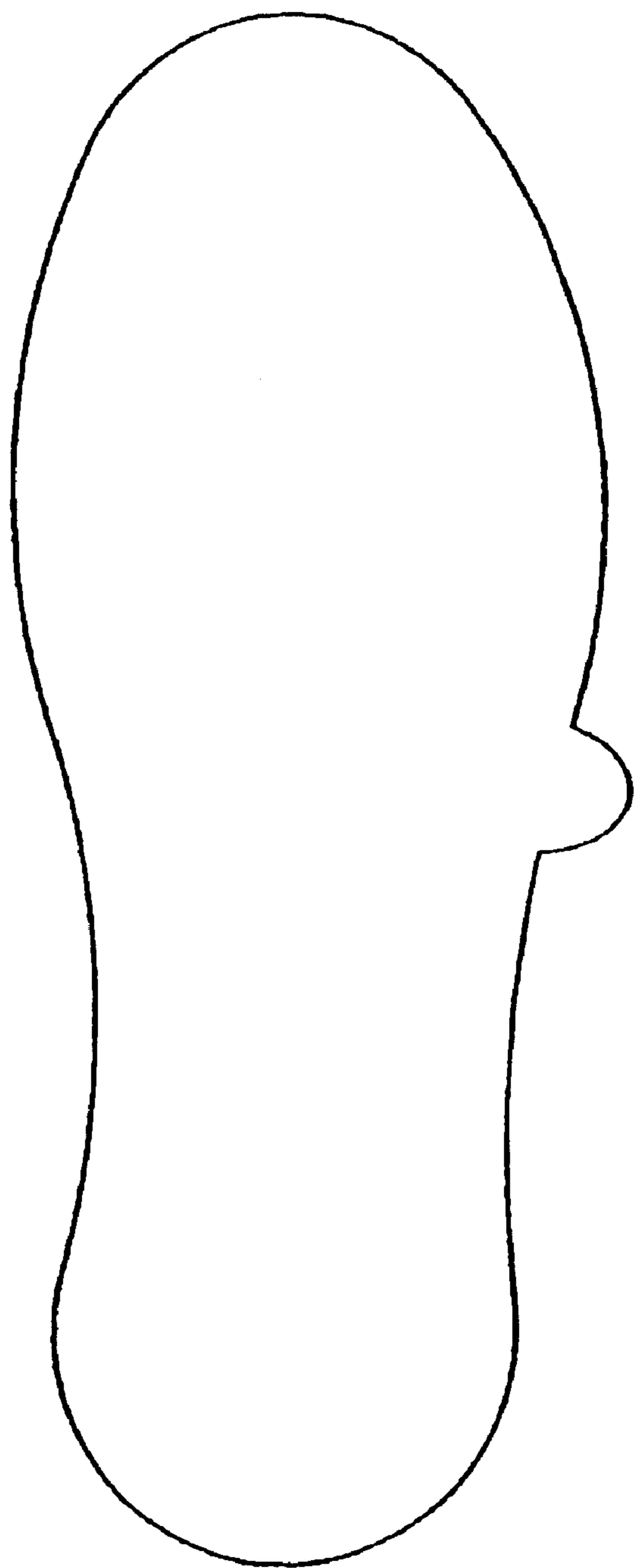
