FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image;

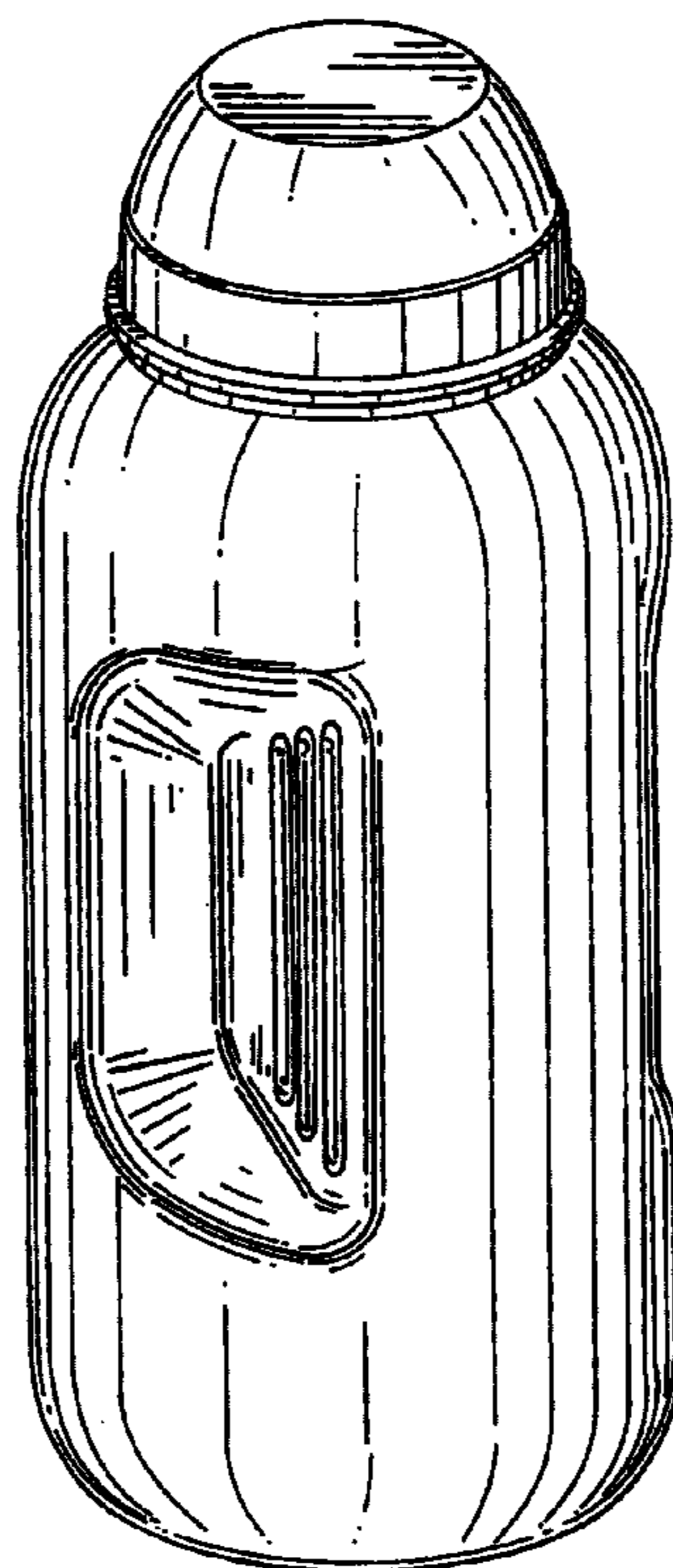
FIG. 3 is a right side elevational view thereof;

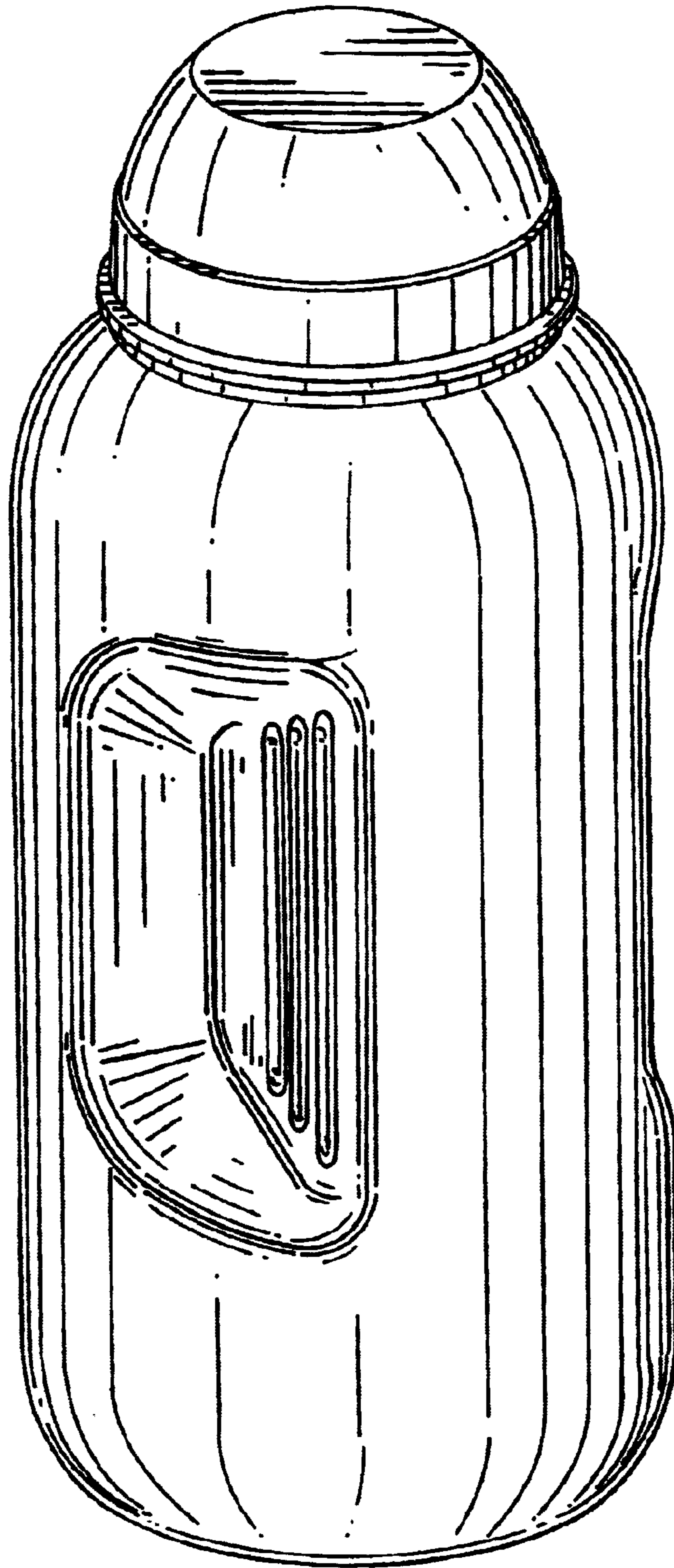
FIG. 4 is a left side elevational view thereof;

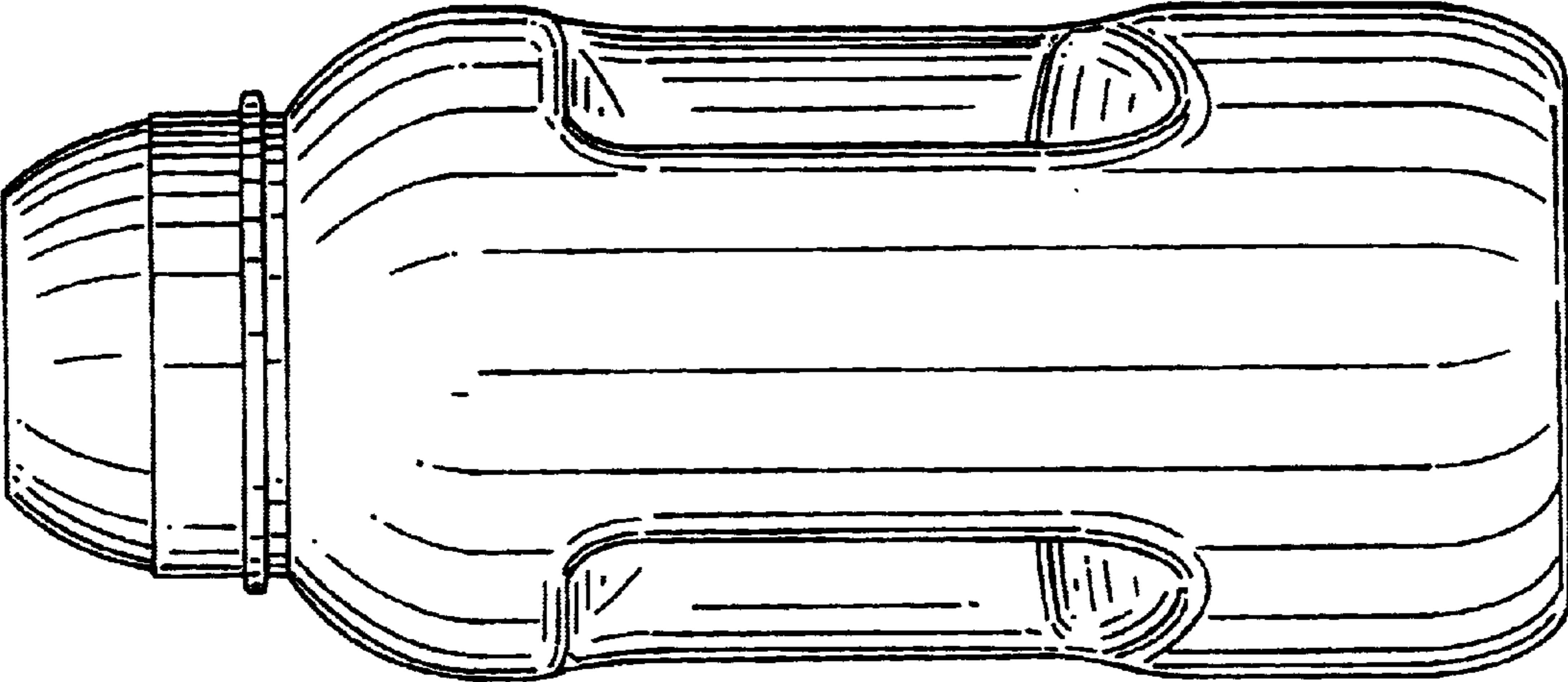
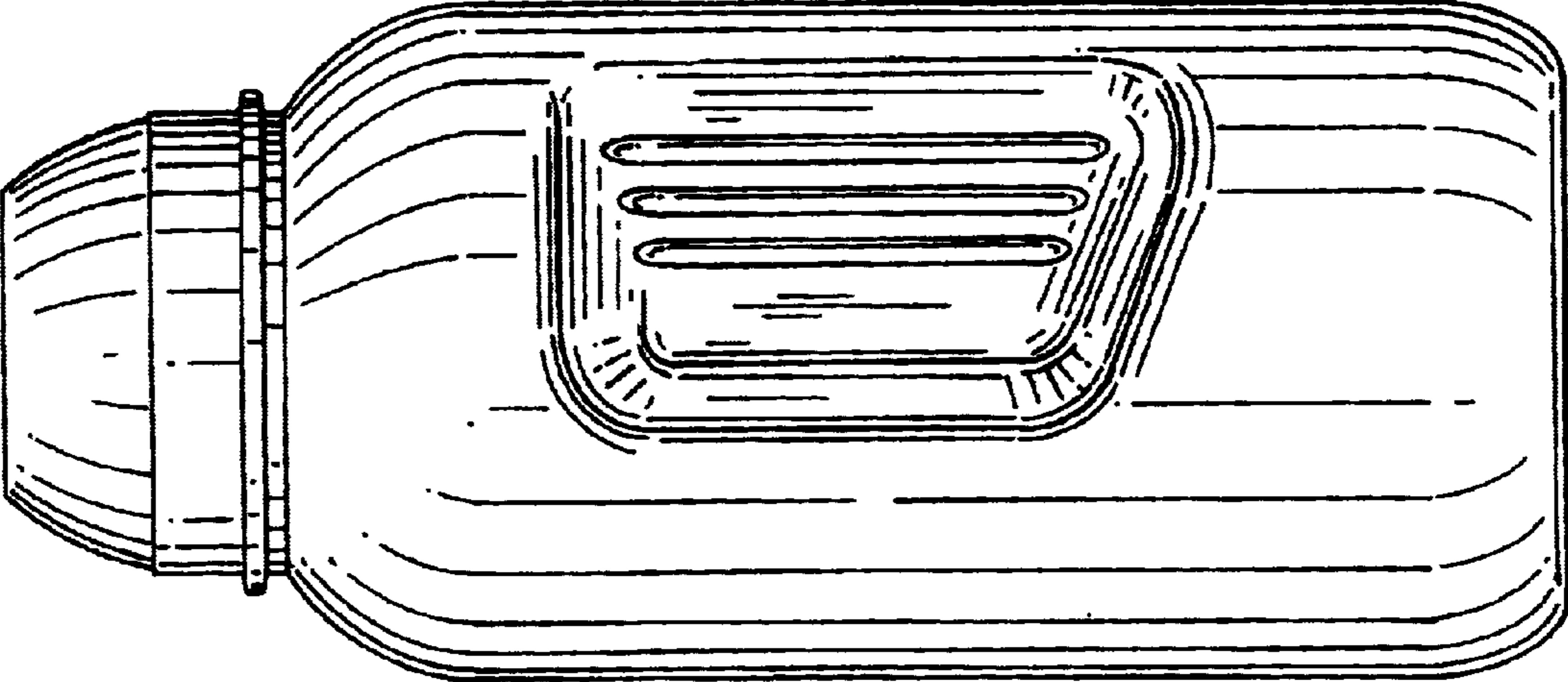
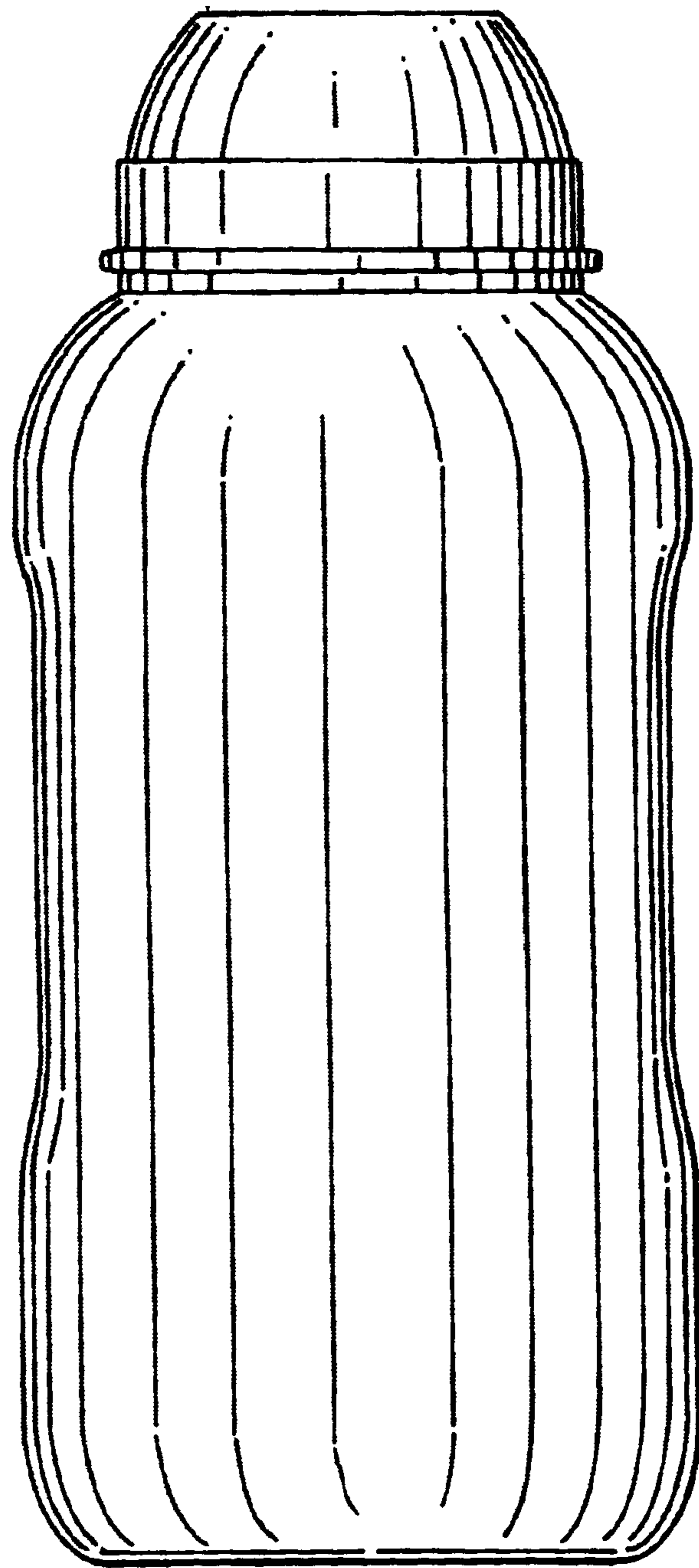

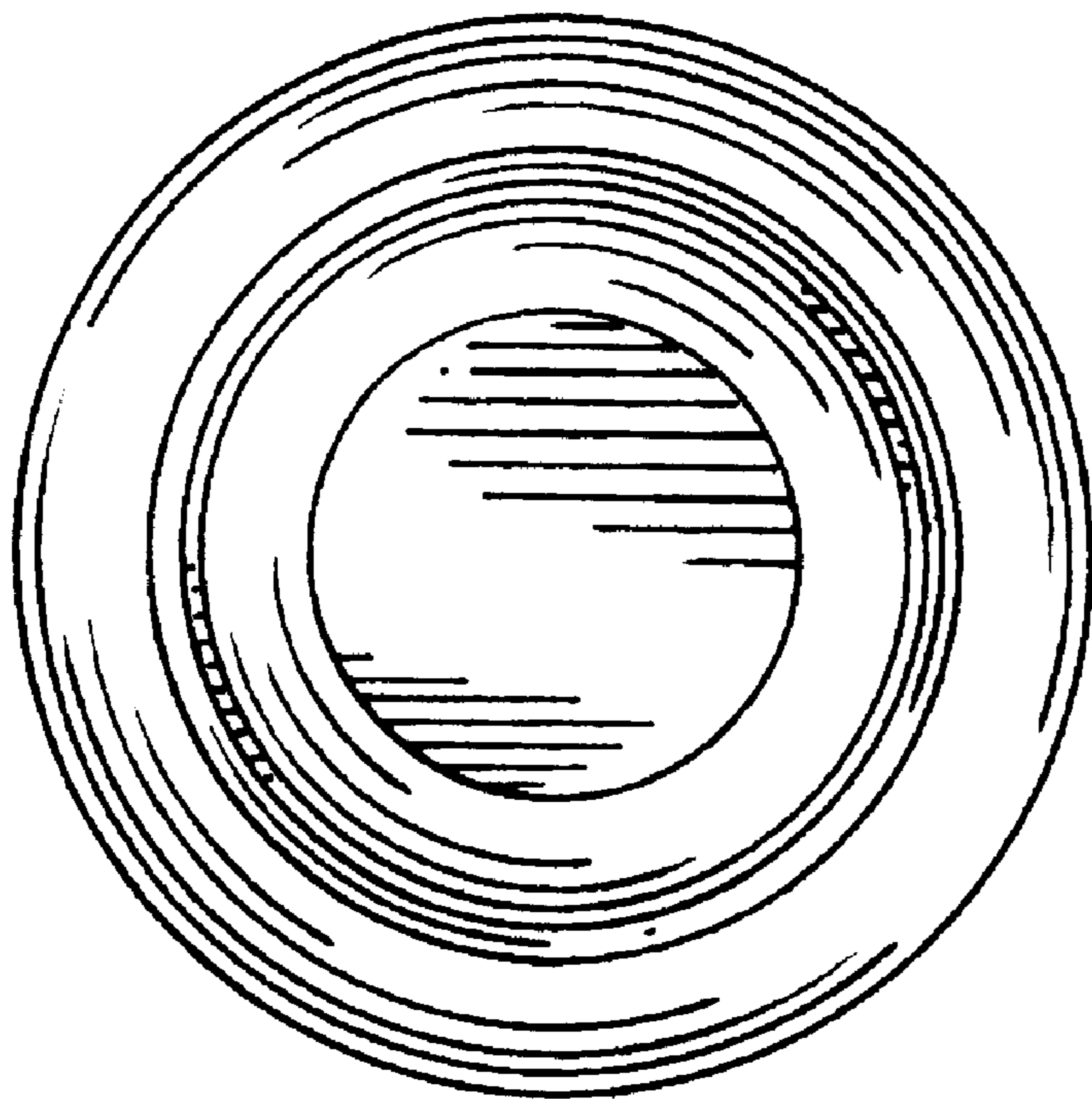

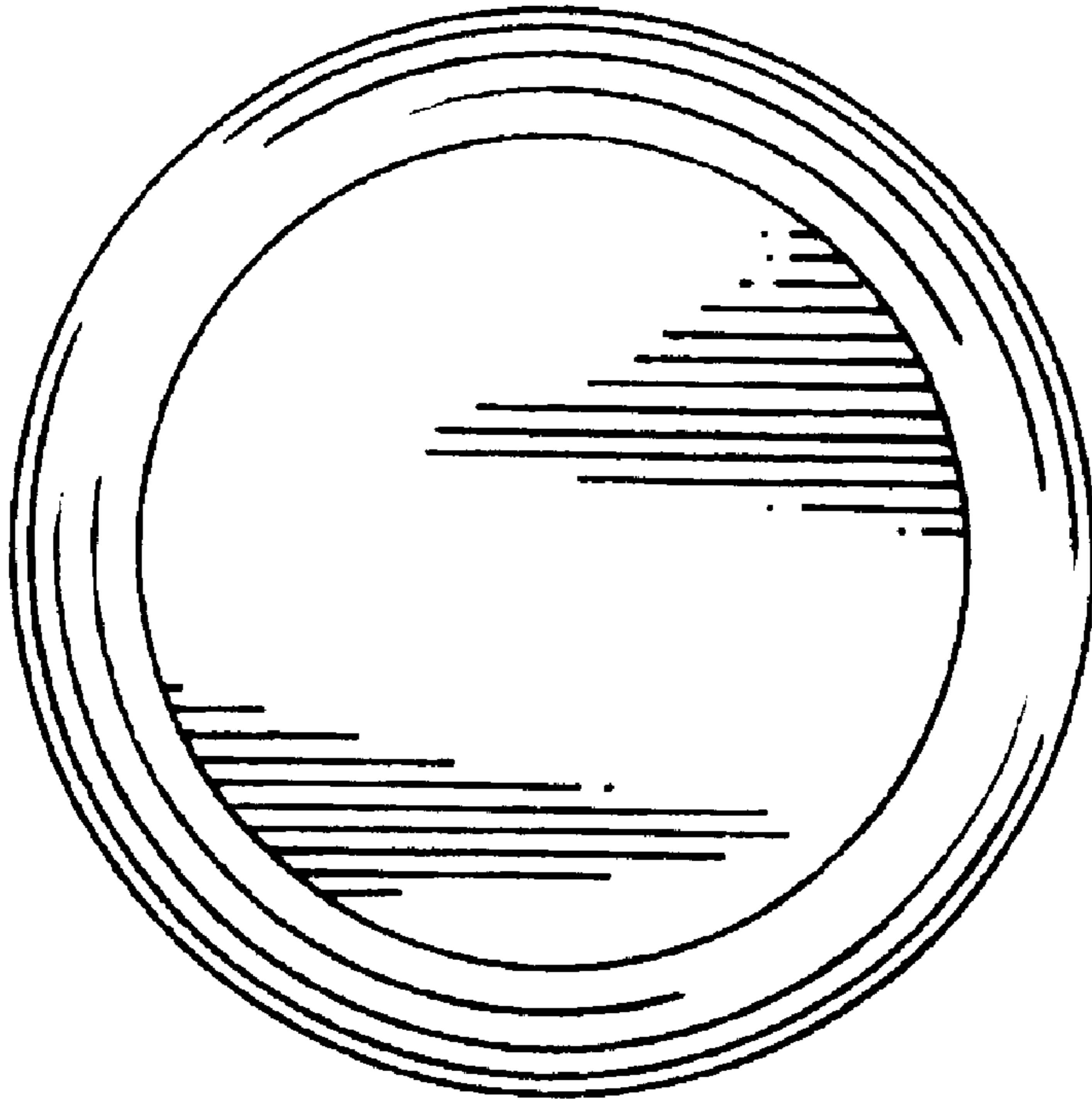
