FIG. 1 is a front perspective view of the beverage holder showing my new design, the broken lines are for illustrative purposes only and form no part of the claimed design;

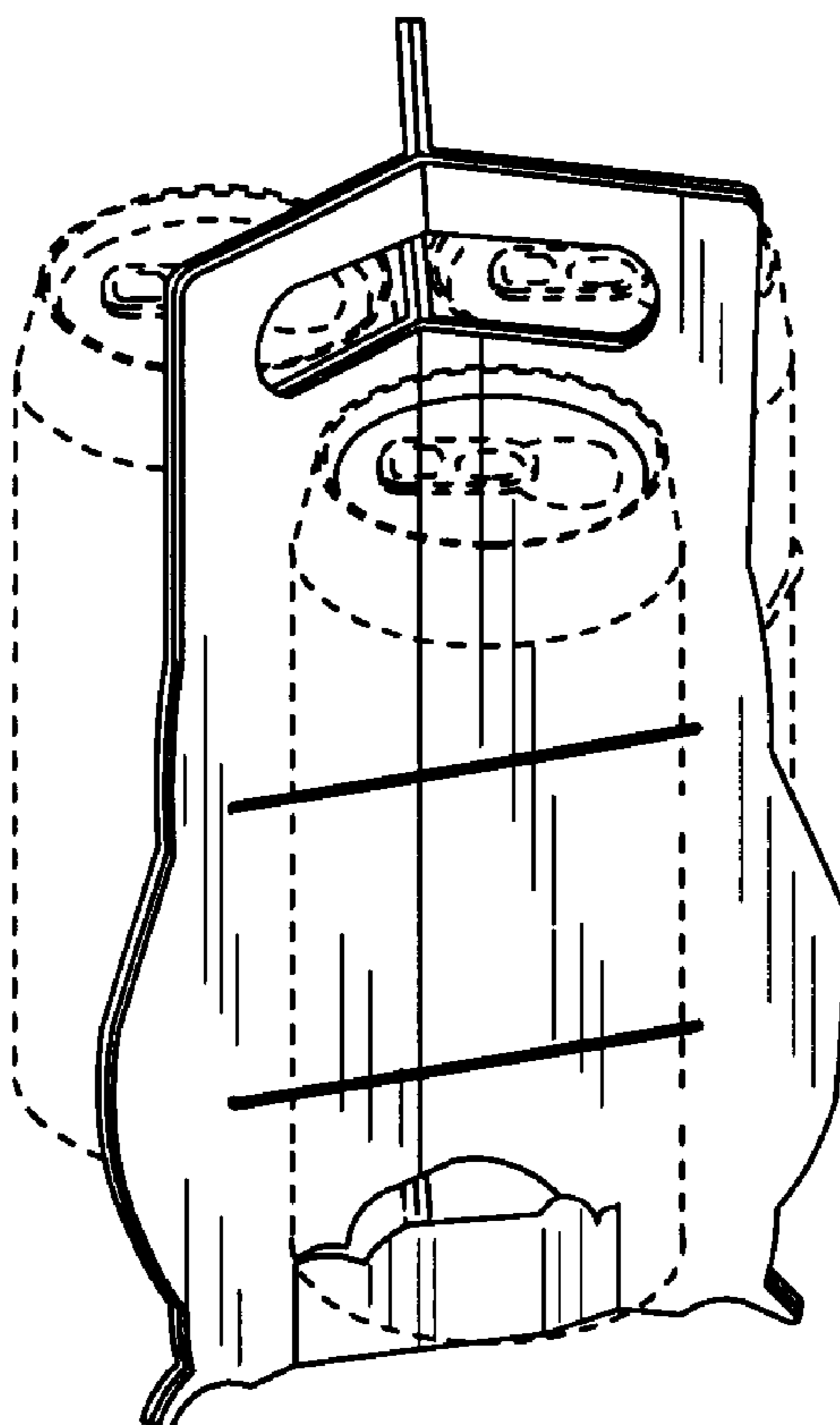
FIG. 2 is a top plan view of the invention illustrated in FIG. 1;

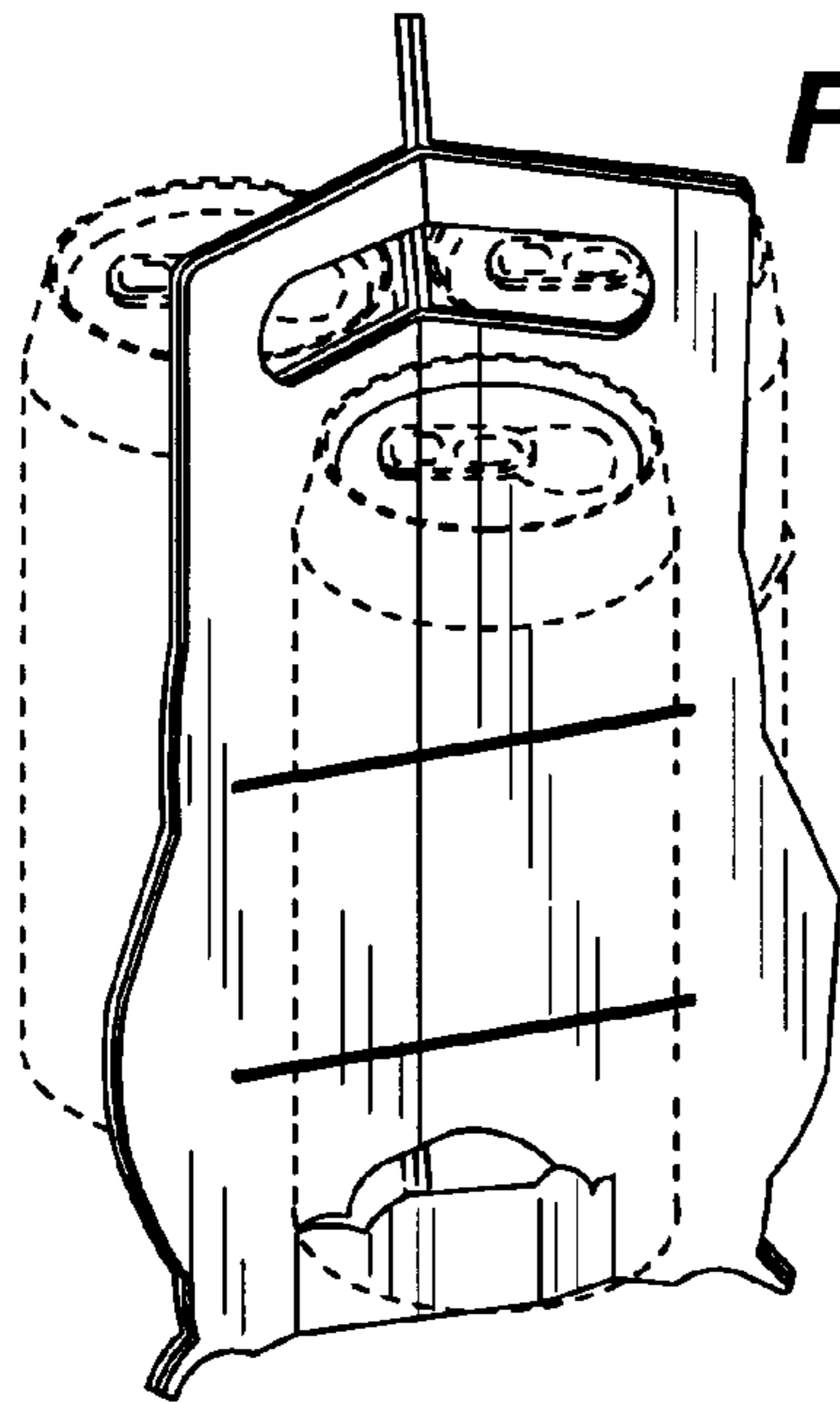

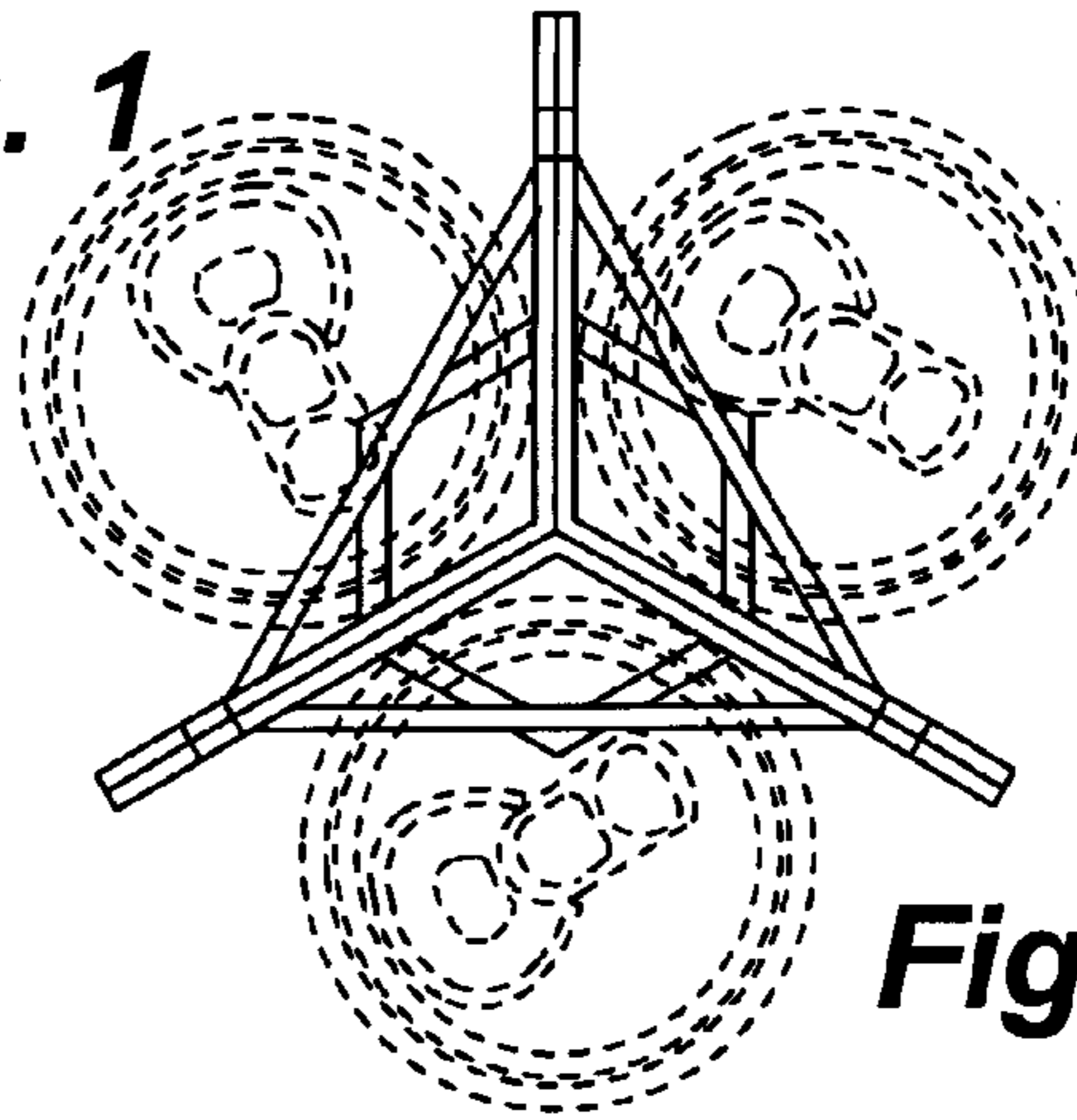

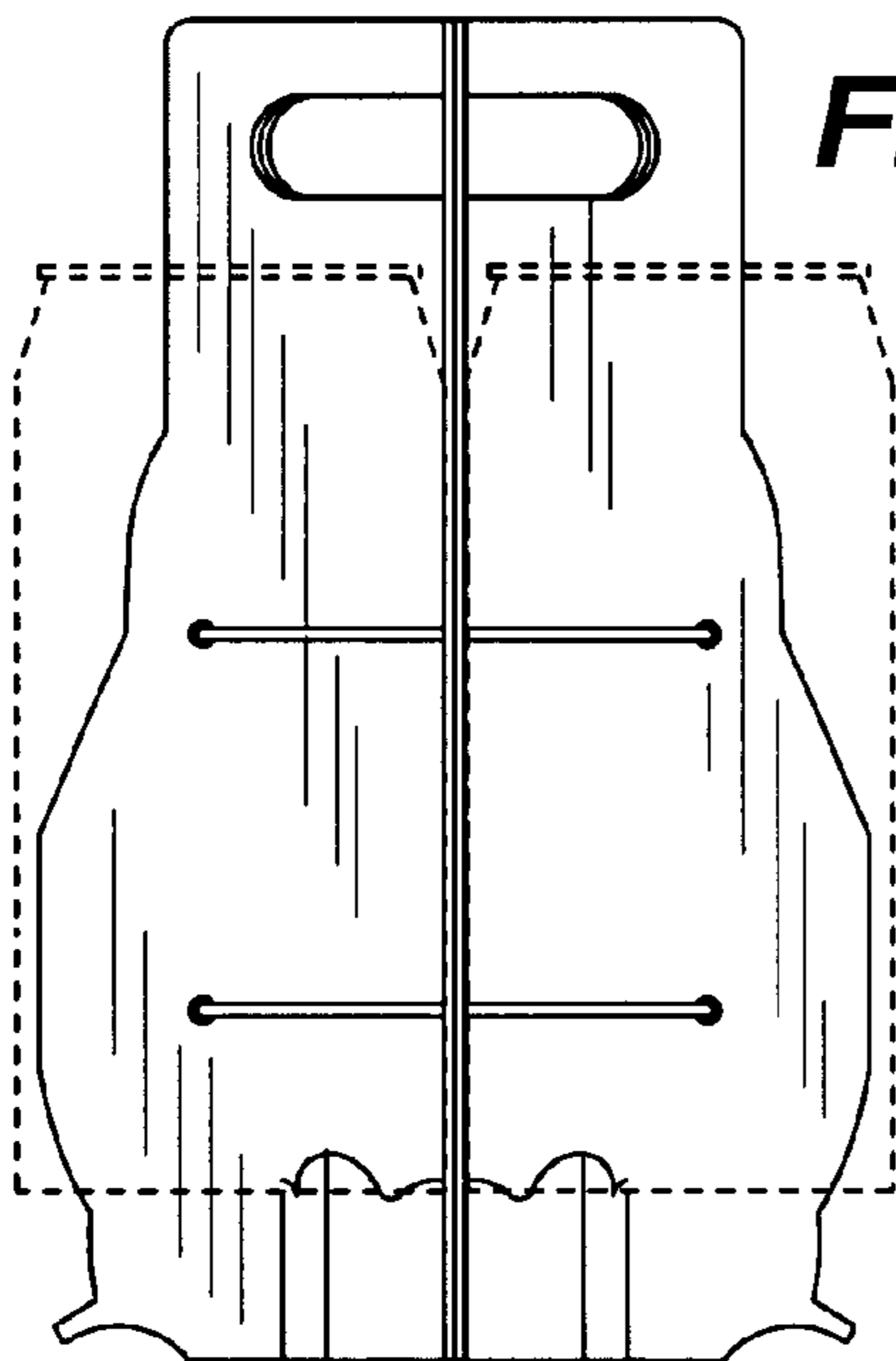

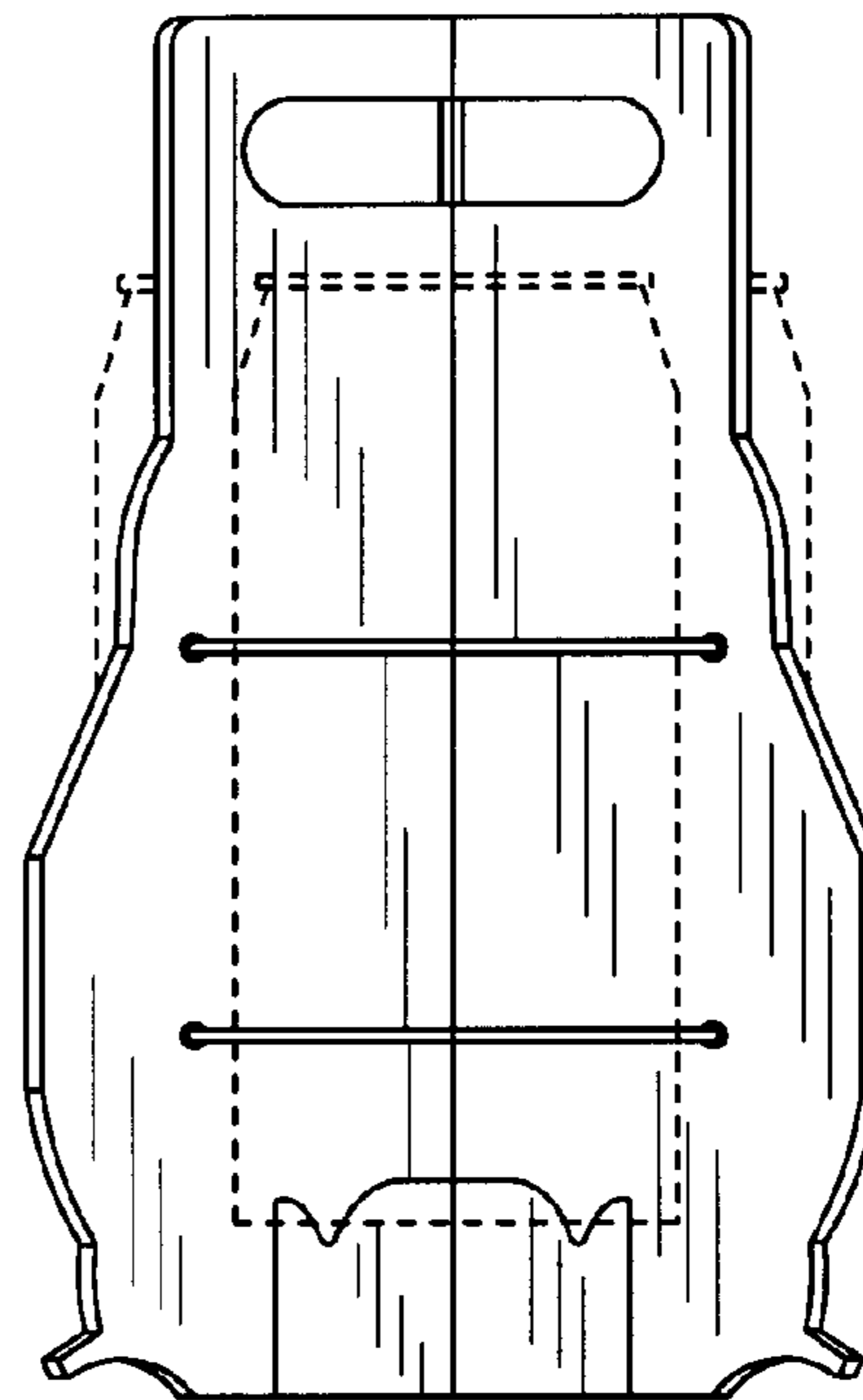

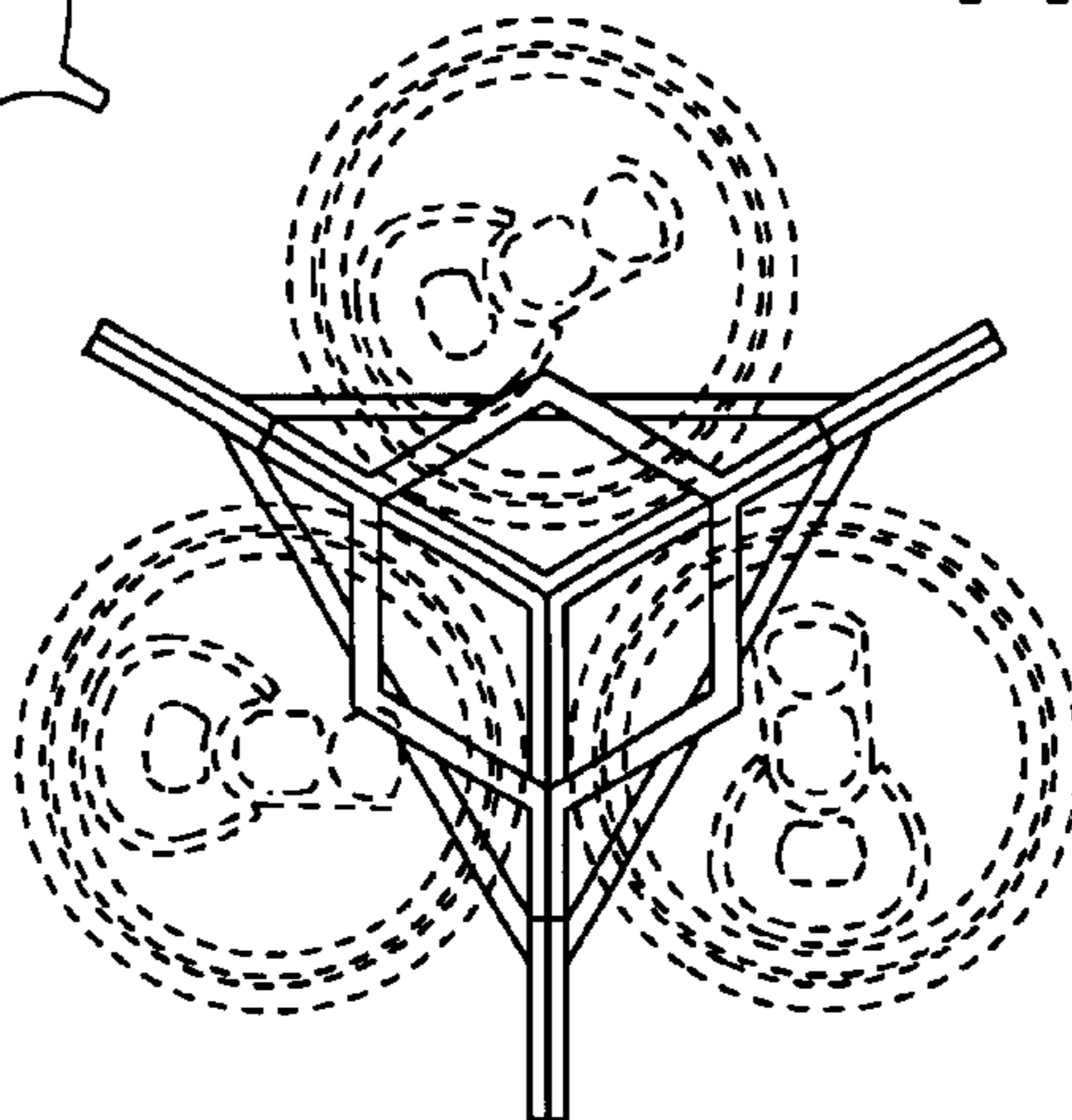
