(57) **CLAIM**

We claim the ornamental design for an exhaust pipe for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an exhaust pipe for a motorcycle;

FIG. 2 is a right side view of the exhaust pipe for a motorcycle of FIG. 1;

FIG. 3 is a bottom view of the exhaust pipe for a motorcycle of FIG. 1;

FIG. 4 is a top view of the exhaust pipe for a motorcycle of FIG. 1;


FIG. 5 is a left side view of the exhaust pipe for a motorcycle of FIG. 1;














