(57) **CLAIM**

The ornamental design for a modular pontoon for a water vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of the modular pontoon for a water vehicle showing my new design, the left side view being a mirror image thereof;

FIG. 2 is a top plan view of the modular pontoon of FIG. 1; FIG. 3 is a bottom plan view of the modular pontoon of FIG. 1;

FIG. 4 is a perspective view of the front module of the modular pontoon of FIG. 1;

FIG. 5 is a top plan view of the front module of FIG. 4;

FIG. 6 is a left side elevational view of the front module of FIG. 4, the right side elevational view being a mirror image thereof;

FIG. 7 is an end view, at the right side of the front module in FIG. 1;

FIG. 8 is a front view of the front module of FIG. 4;

FIG. 9 is a perspective view of the central module of the modular pontoon of FIG. 1;

FIG. 10 is an end view of the central module of FIG. 9;

FIG. 11 is an opposite end view of the central module of FIG. 9;

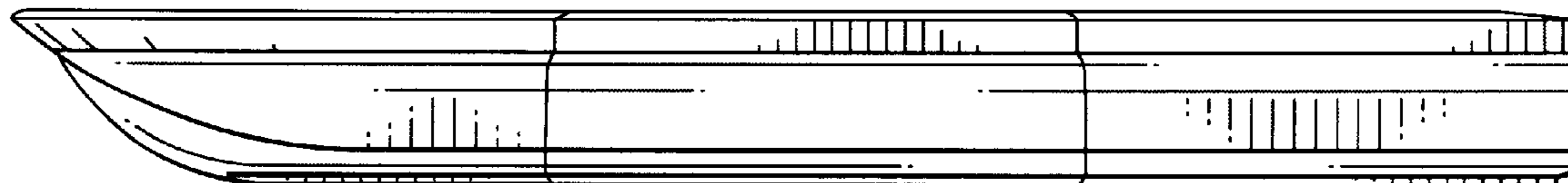
FIG. 12 is a perspective view of the end module of the modular pontoon of FIG. 1;

FIG. 13 is an end view of the end module of FIG. 12;

FIG. 14 is a partial cross section of FIG. 10 taken along the lines 14—14; and,

FIG. 15 is a partial cross section of the male plug which fits into the socket of FIG. 14 along the line 15—15 in FIG. 11. Elements of the modular pontoon are shown detached for clarity of illustration.

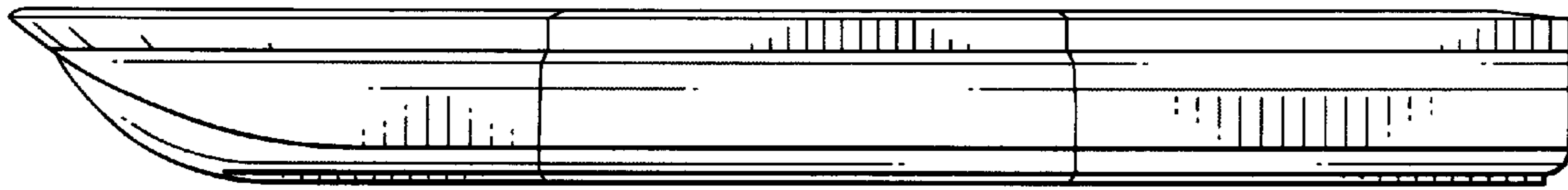

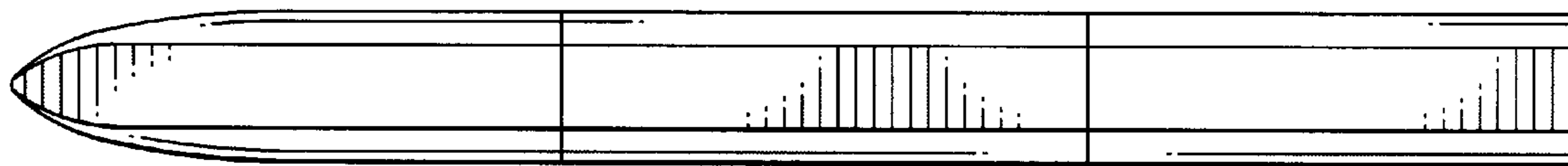

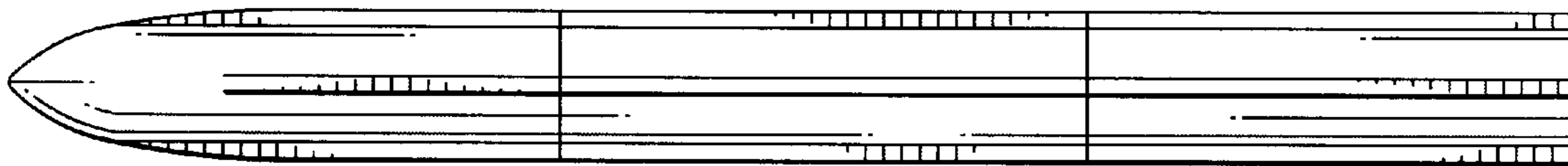

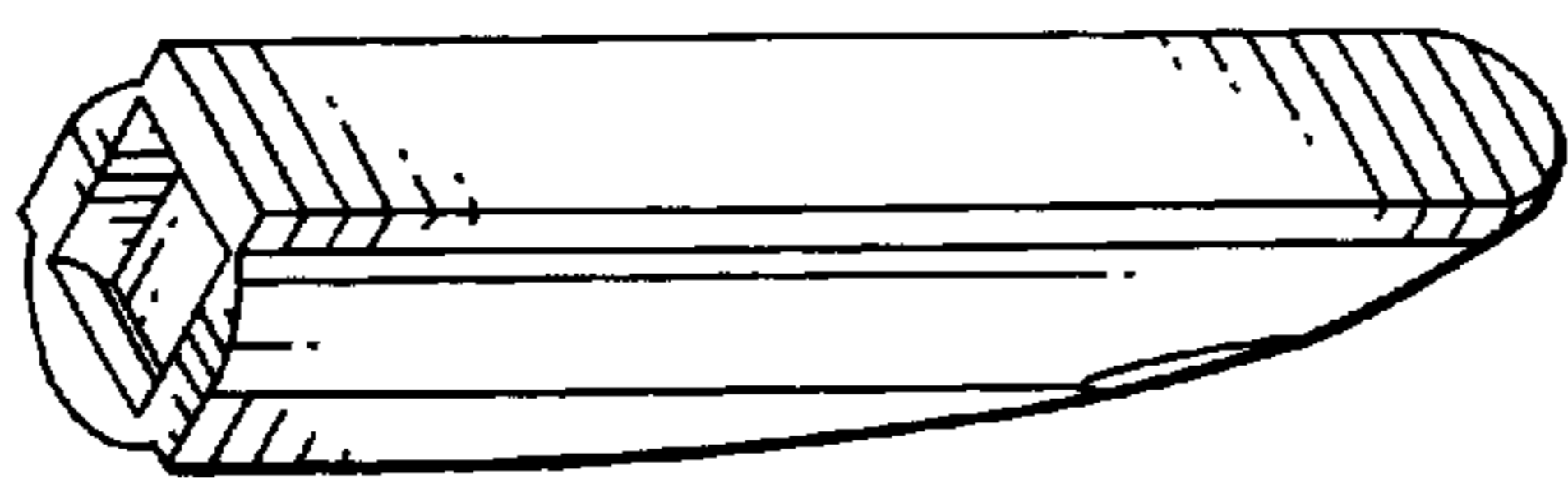

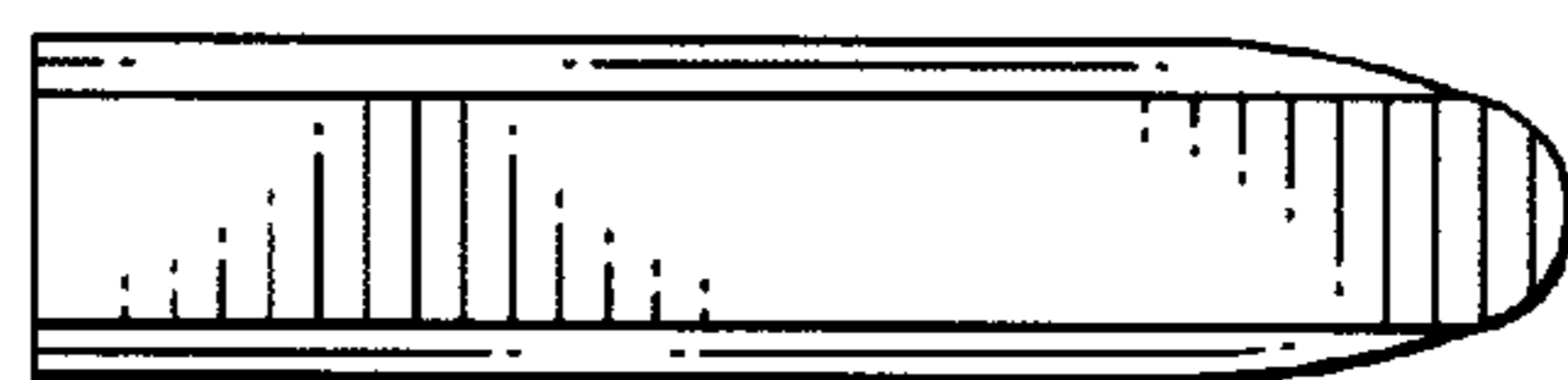

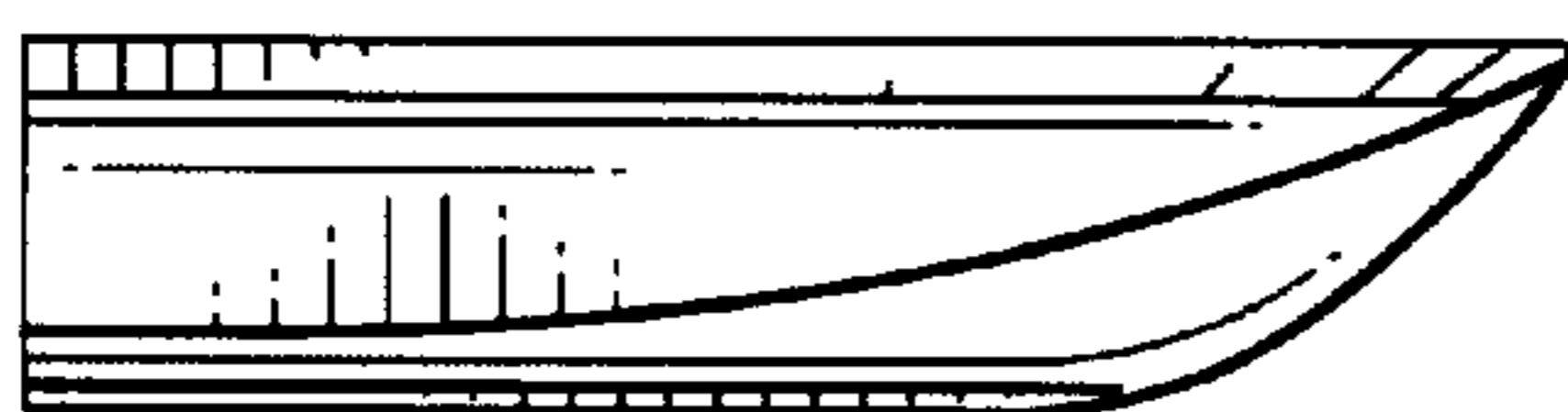

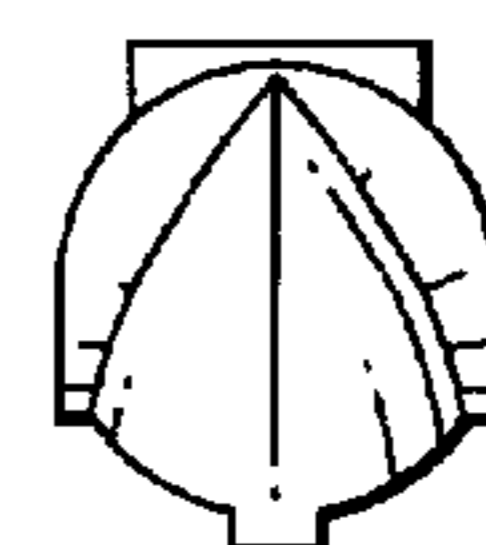

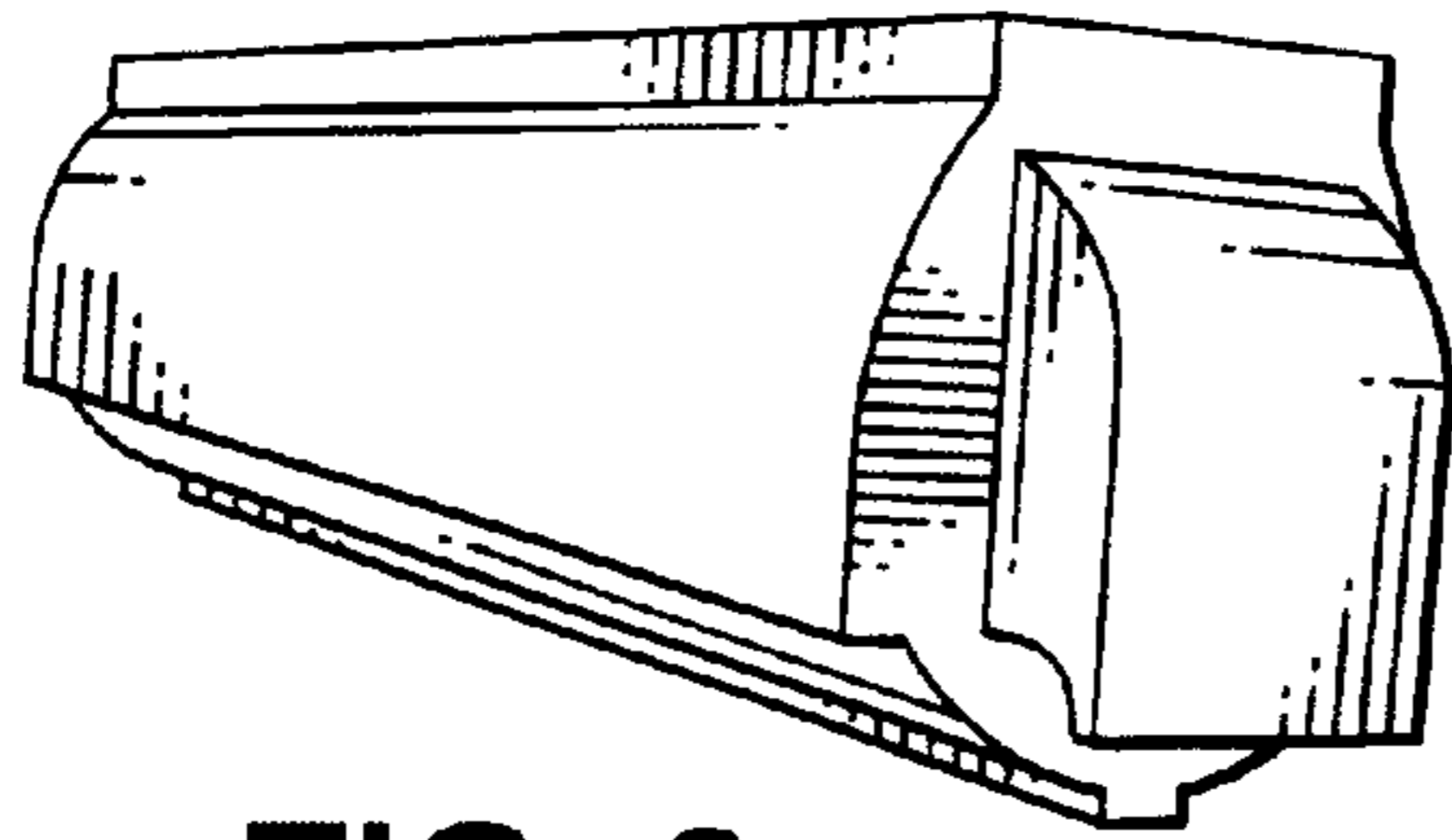

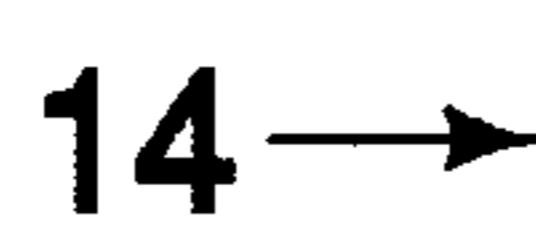
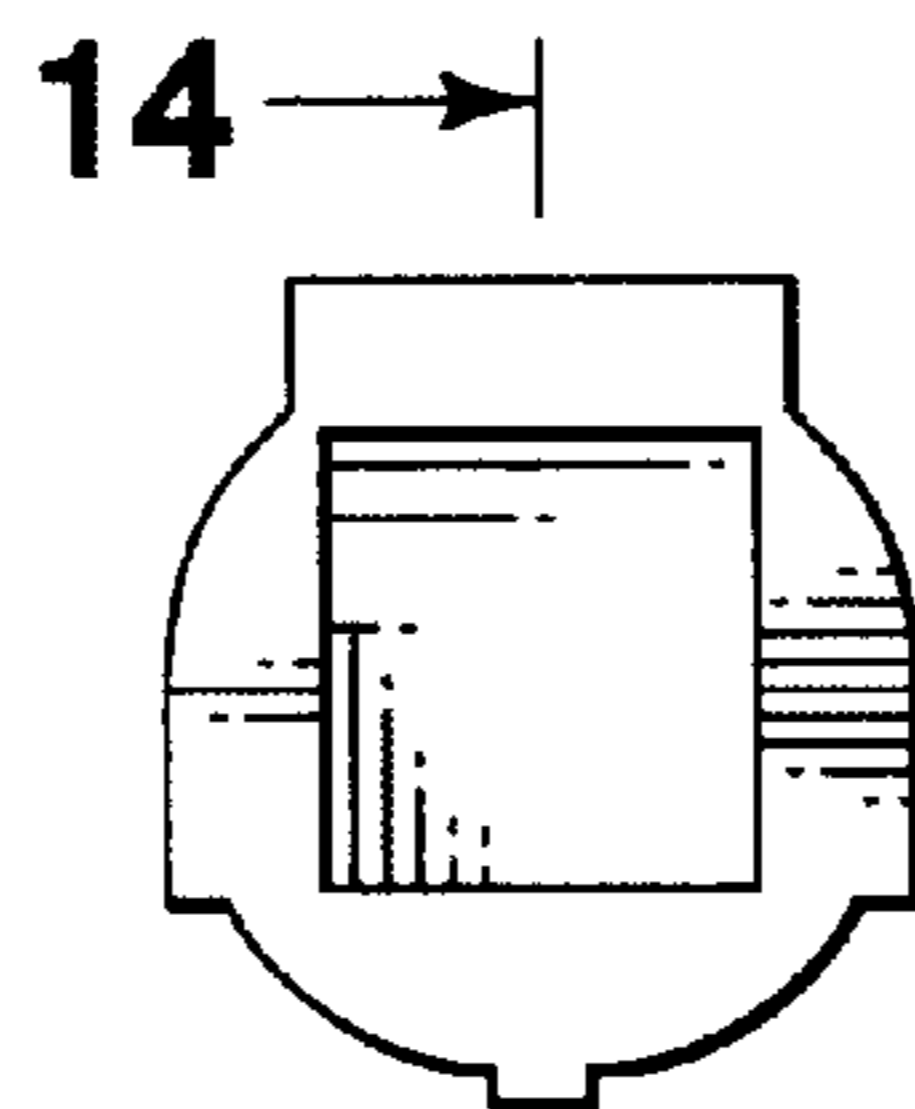

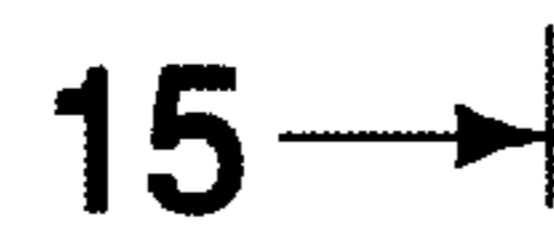
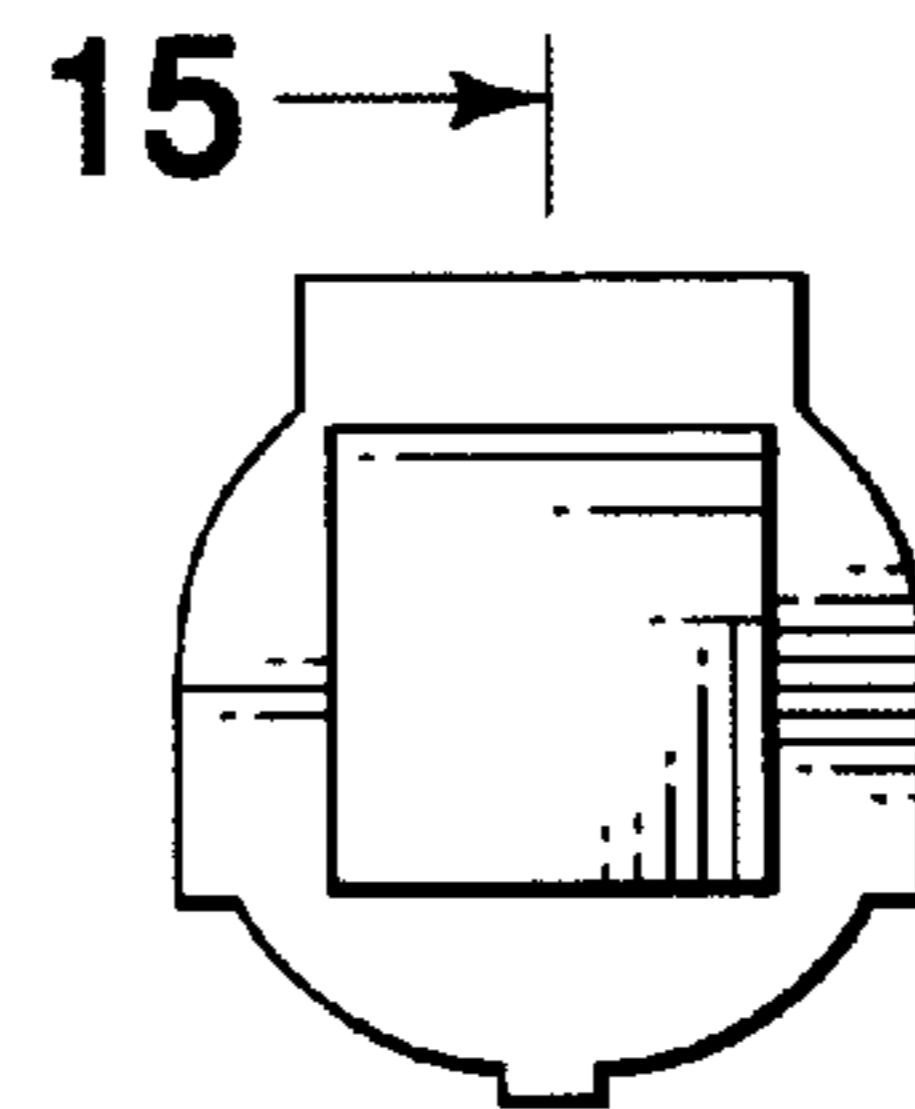

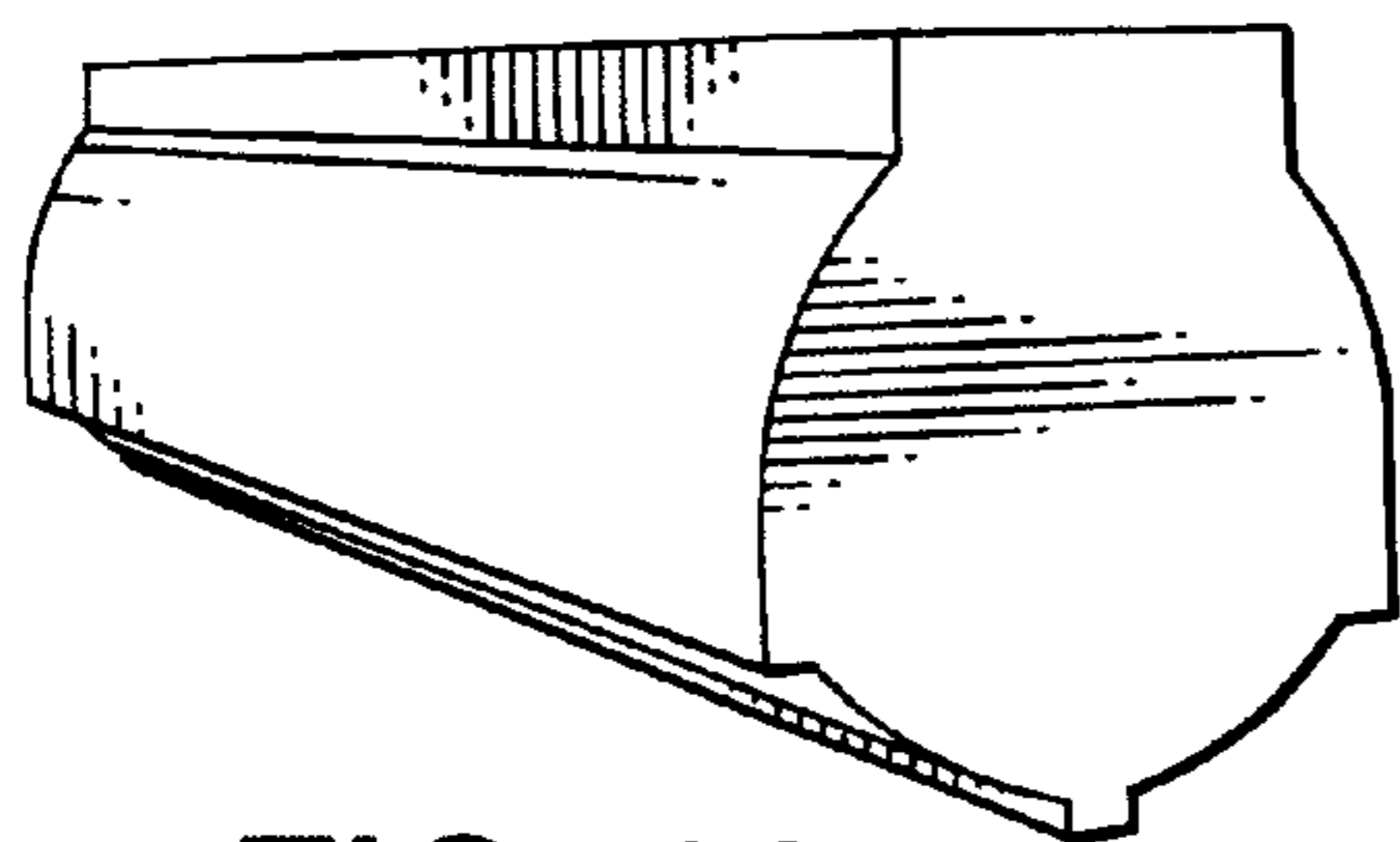

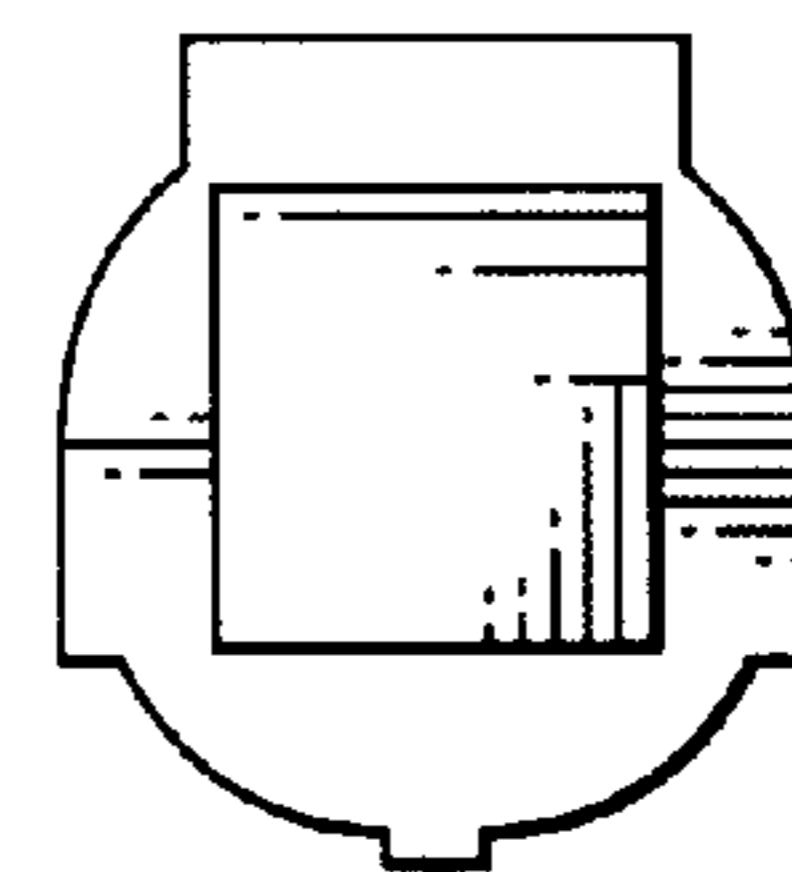

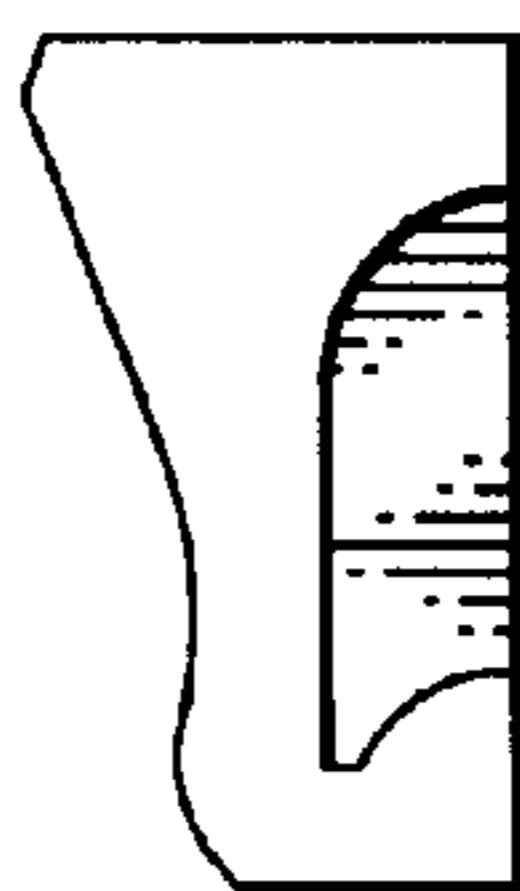

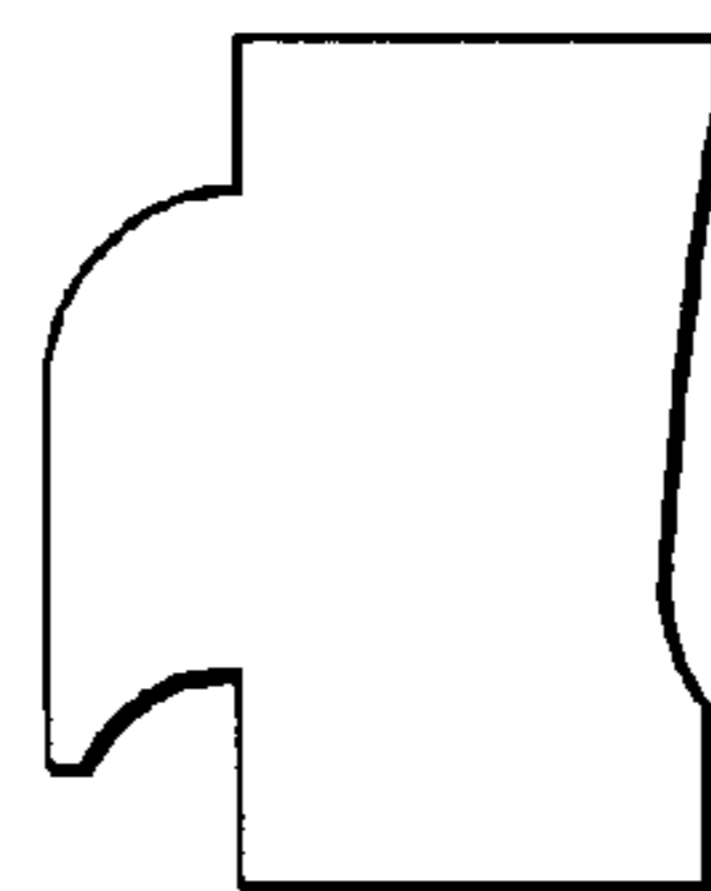
