(57) **CLAIM**

The ornamental design for a multi-purpose storage rack for a sport utility vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a multi-purpose storage rack for a sport utility vehicle;

FIG. 2 is a left elevation view of the design illustrated in FIG. 1;

FIG. 3 is a right elevation view of the design illustrated in FIG. 1;

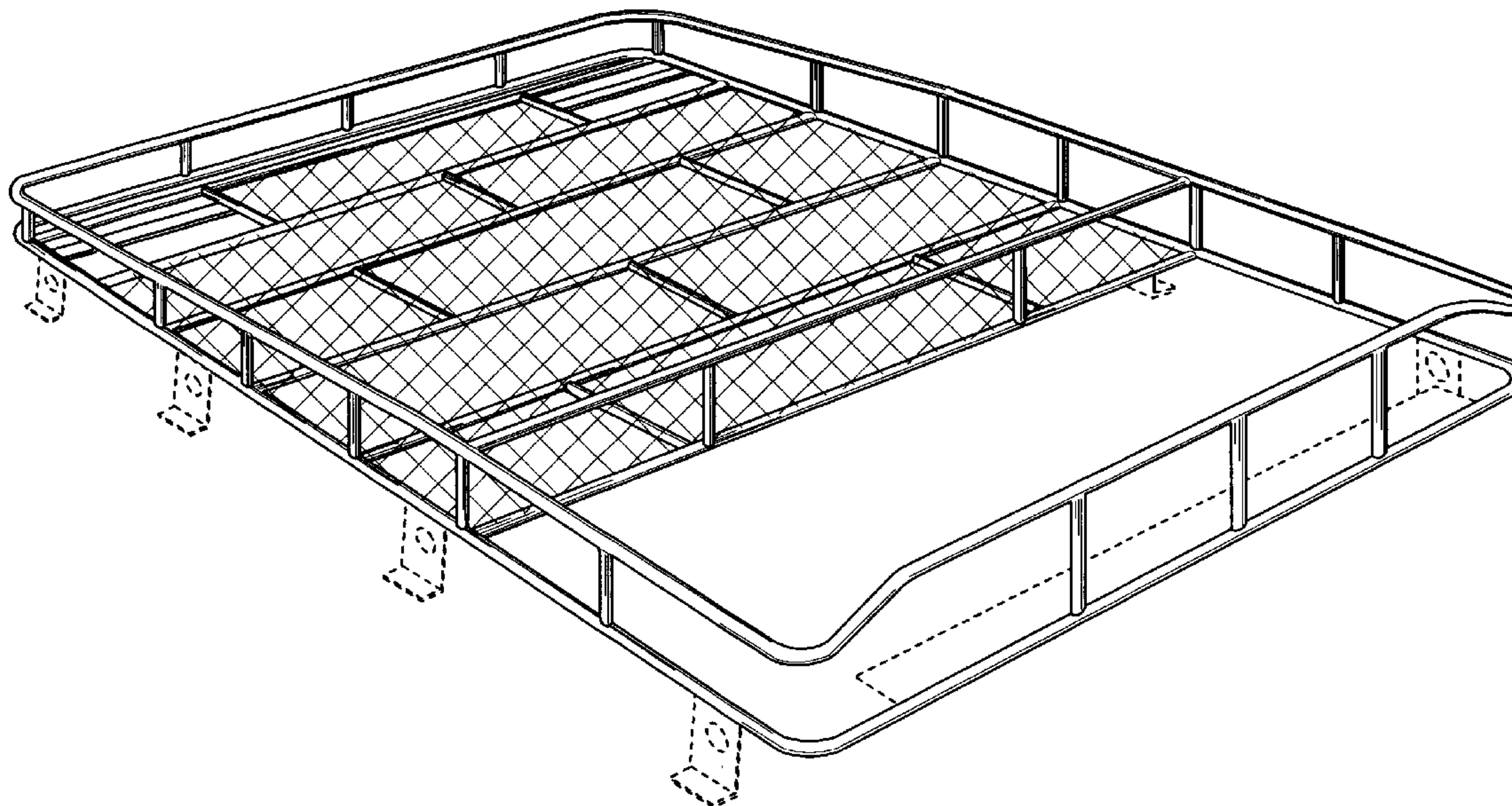
FIG. 4 is a front elevation view of the design illustrated in FIG. 1;

FIG. 5 is a perspective view of the design illustrated in FIG. 1;

FIG. 6 is a perspective view of a second embodiment of the multi-purpose storage rack for a sport utility vehicle shown in FIG. 1, the only difference being that this configuration includes the addition of mesh in the forward area of the rack; and,

FIG. 7 is a perspective view of a multi-purpose storage rack for a sport utility vehicle showing the new design positioned opposite a sport utility vehicle, the broken lines showing environment for illustrative purposes only and forming no part of the claimed design.

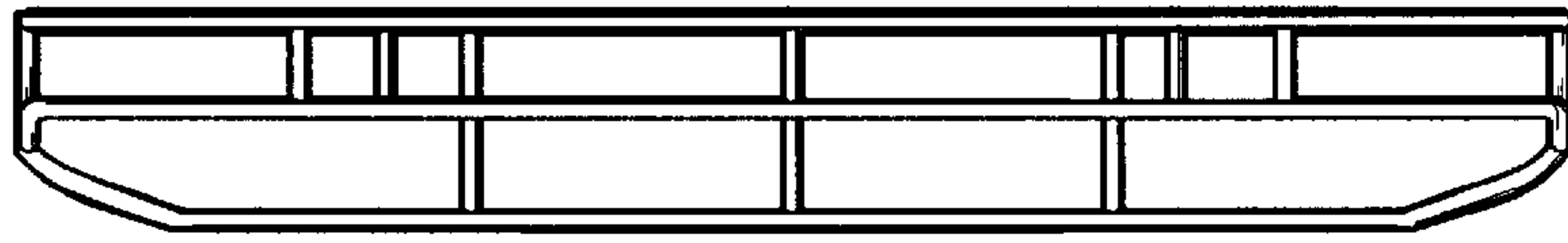

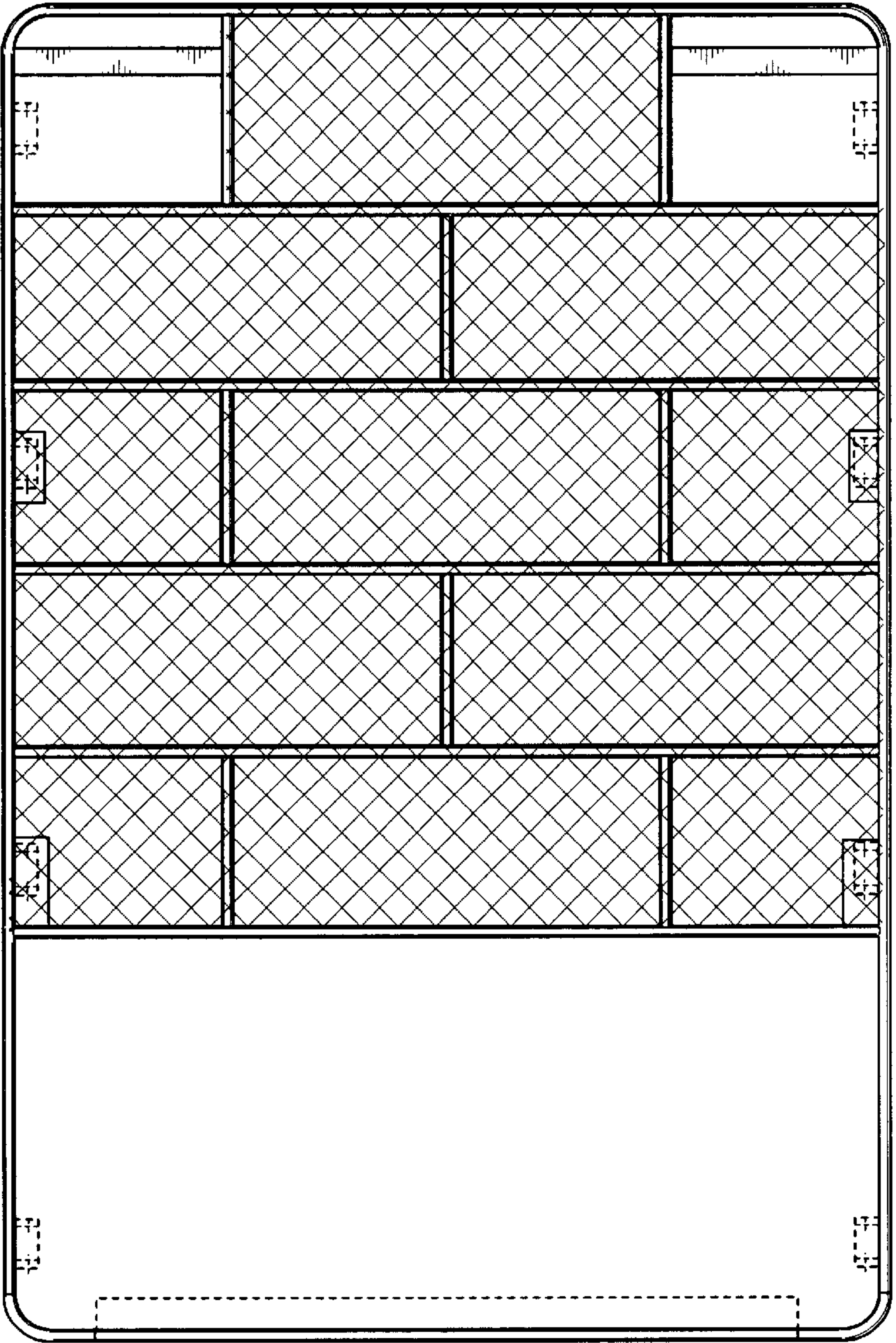

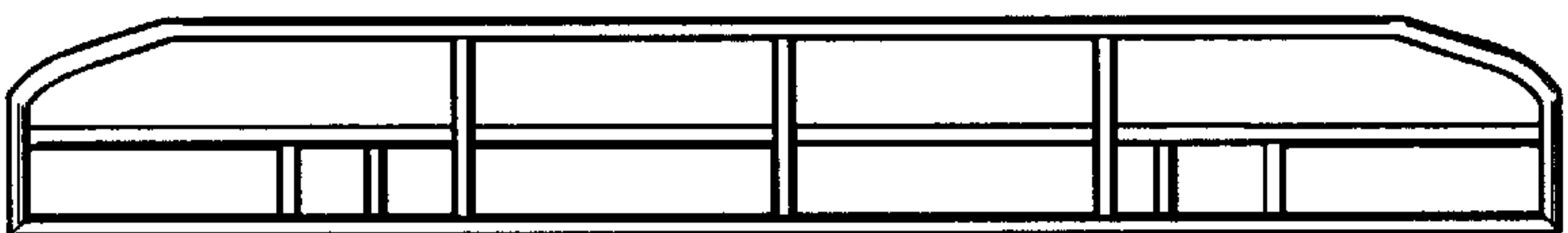

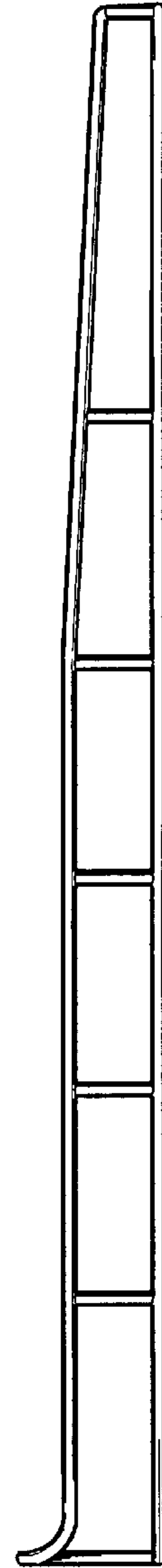

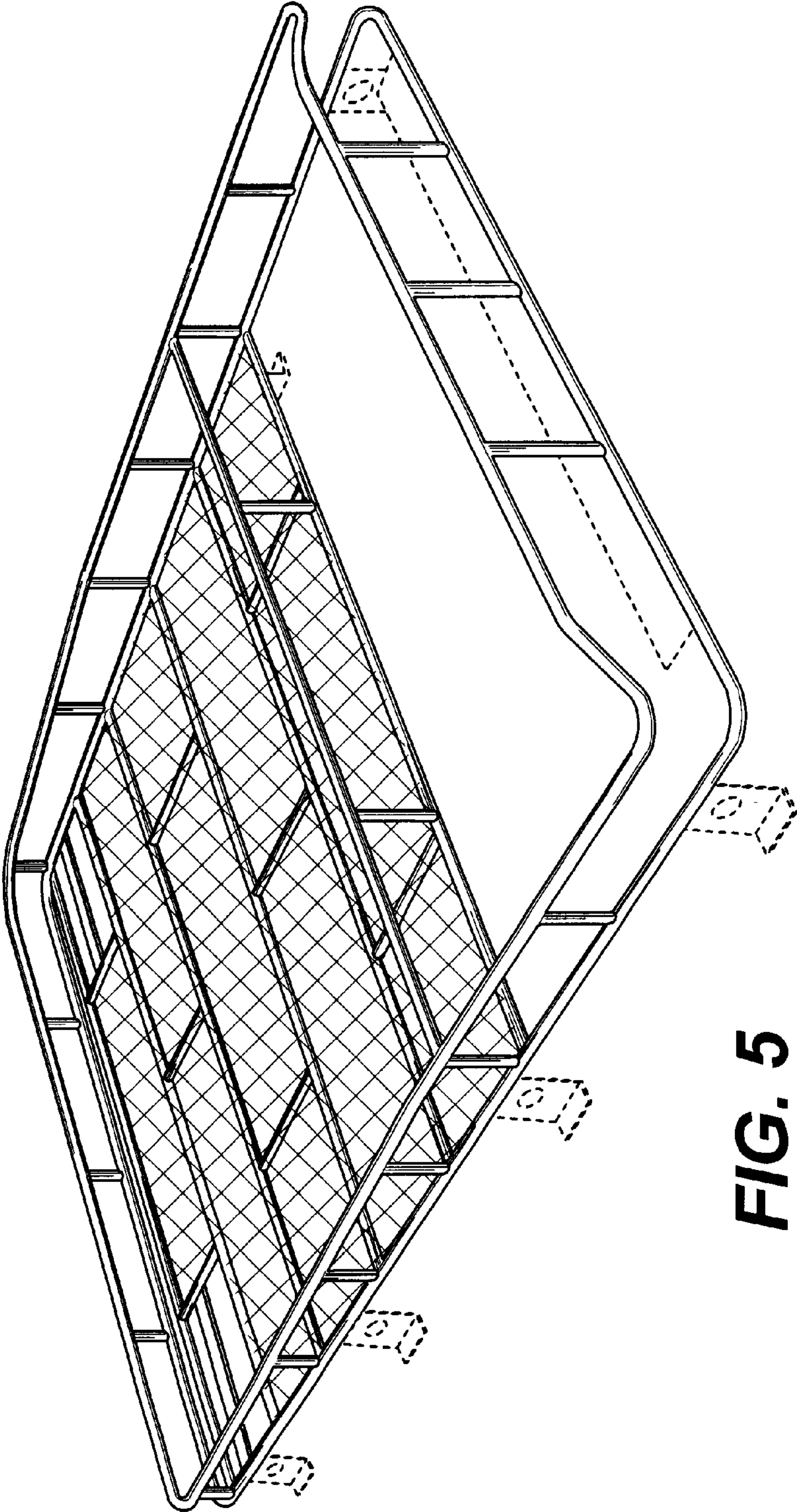

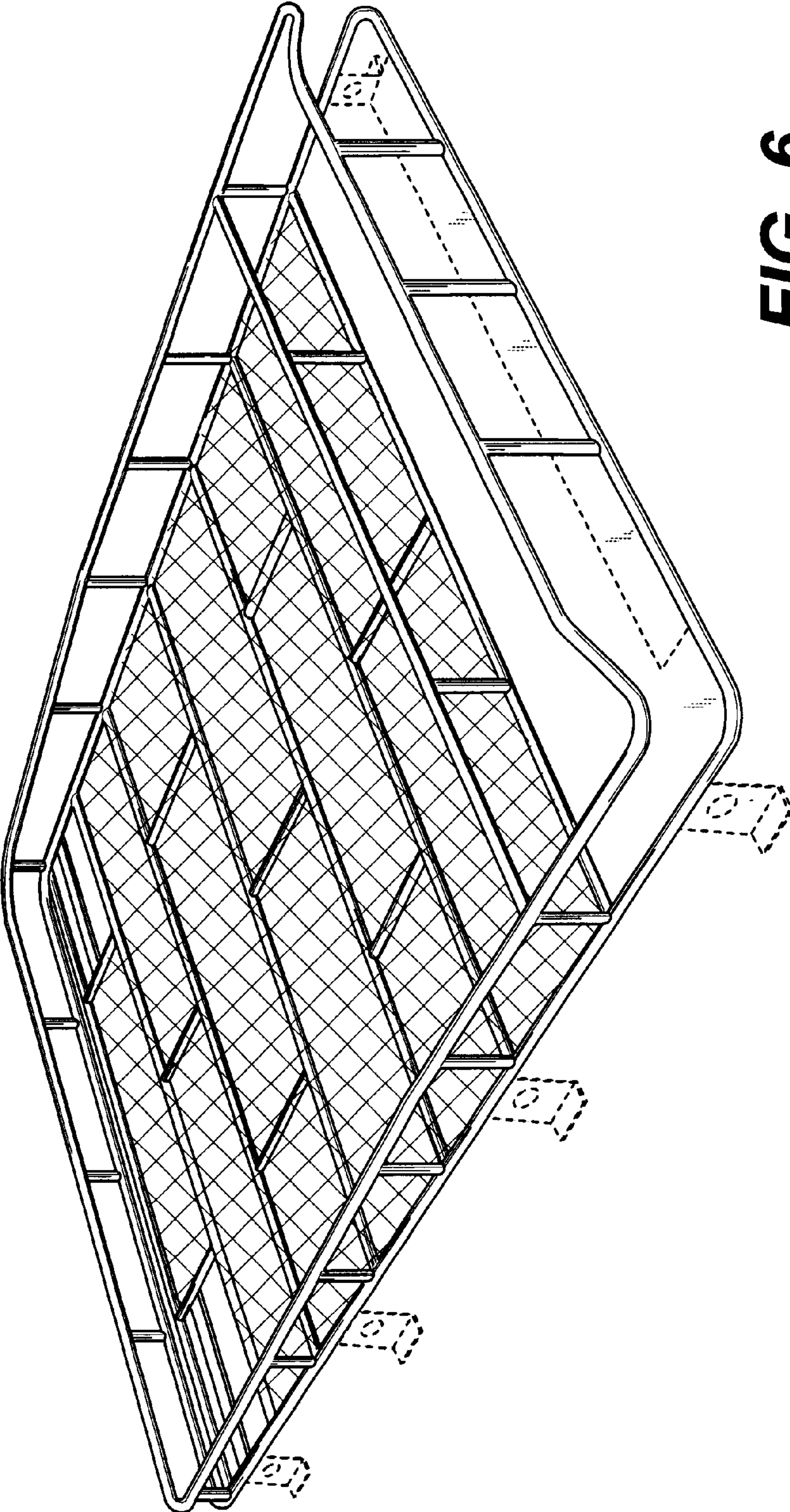

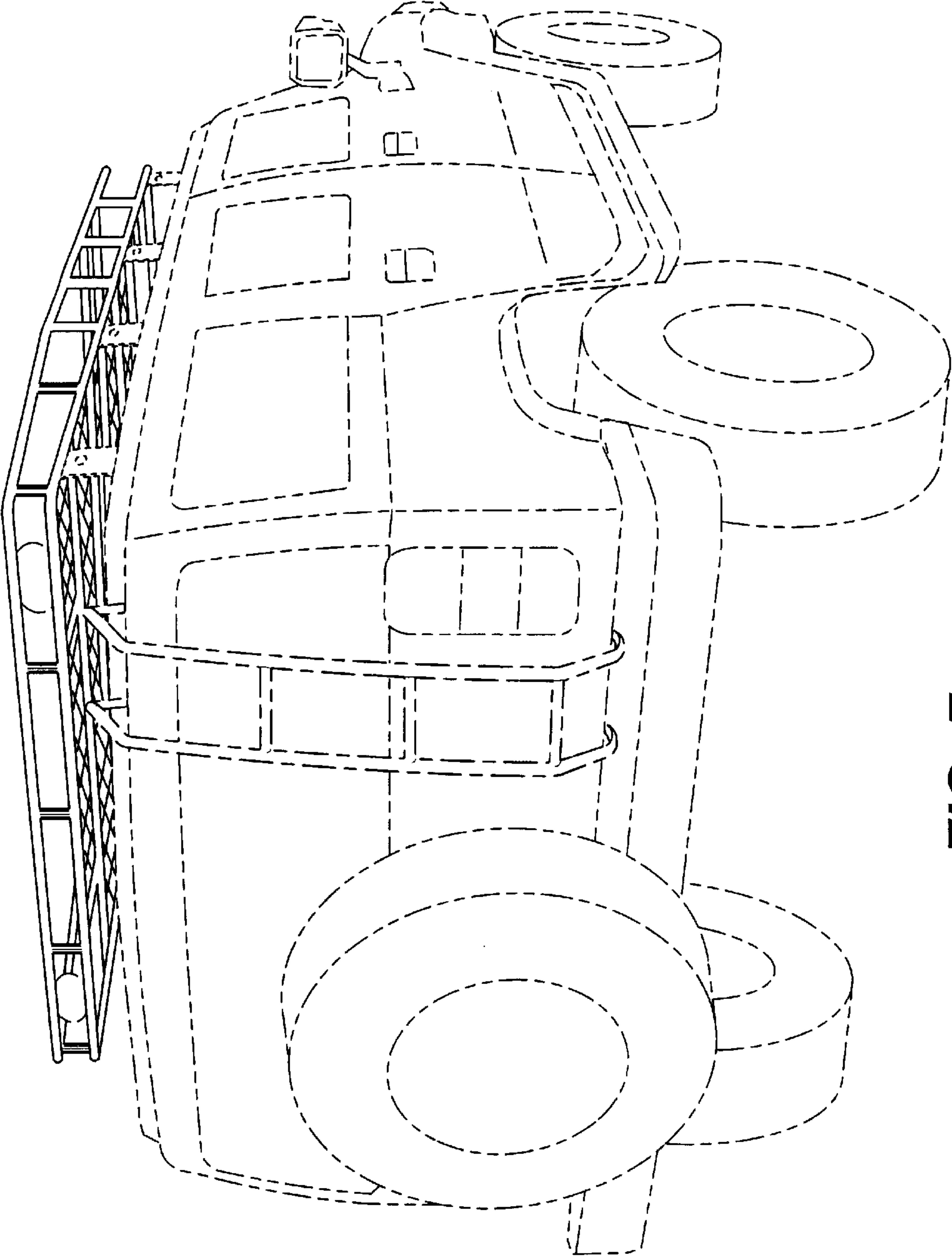
