DESCRIPTION

FIG. 1 is a front elevation of a full color multi-function printing machine according to the present invention;

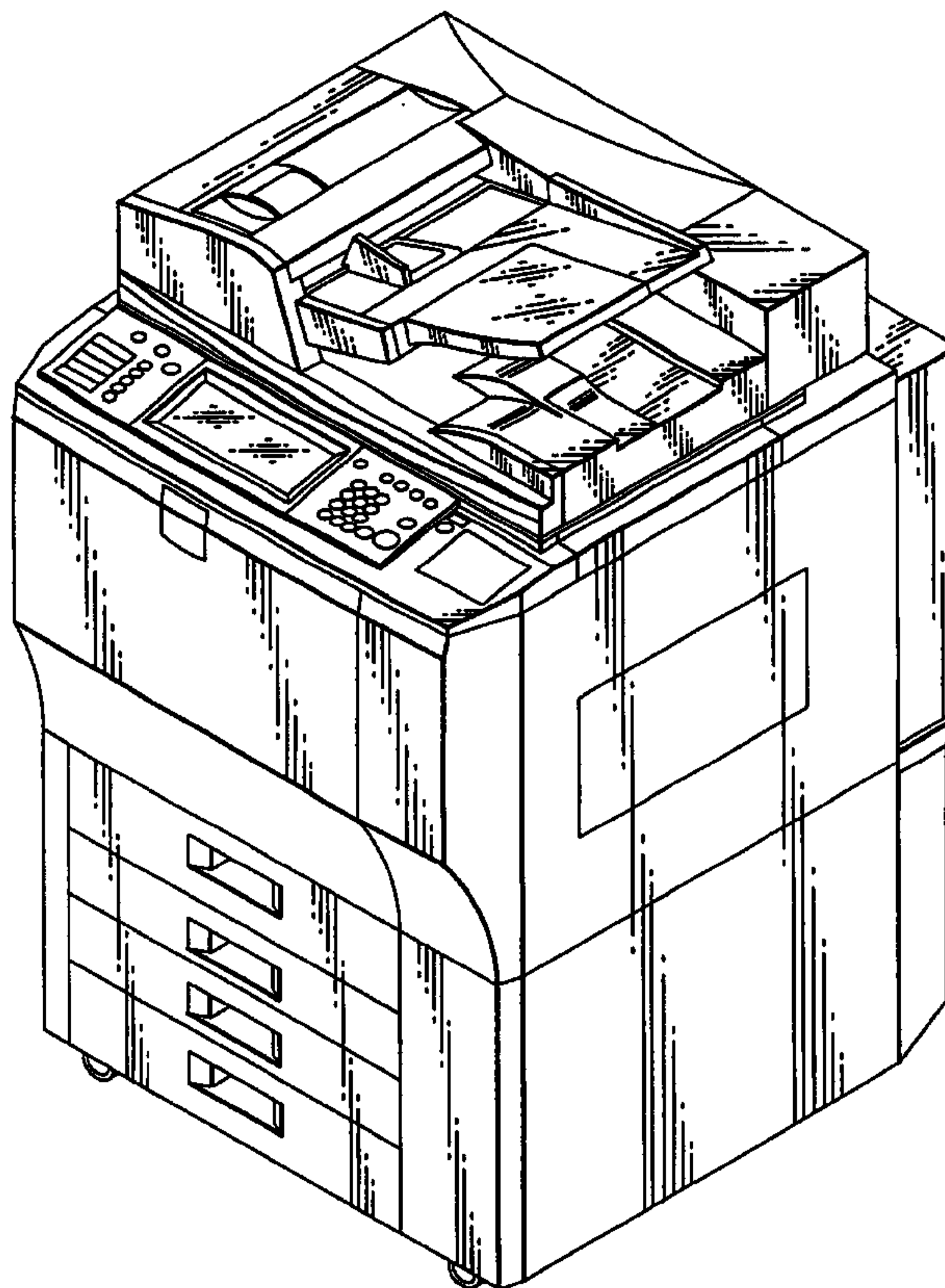

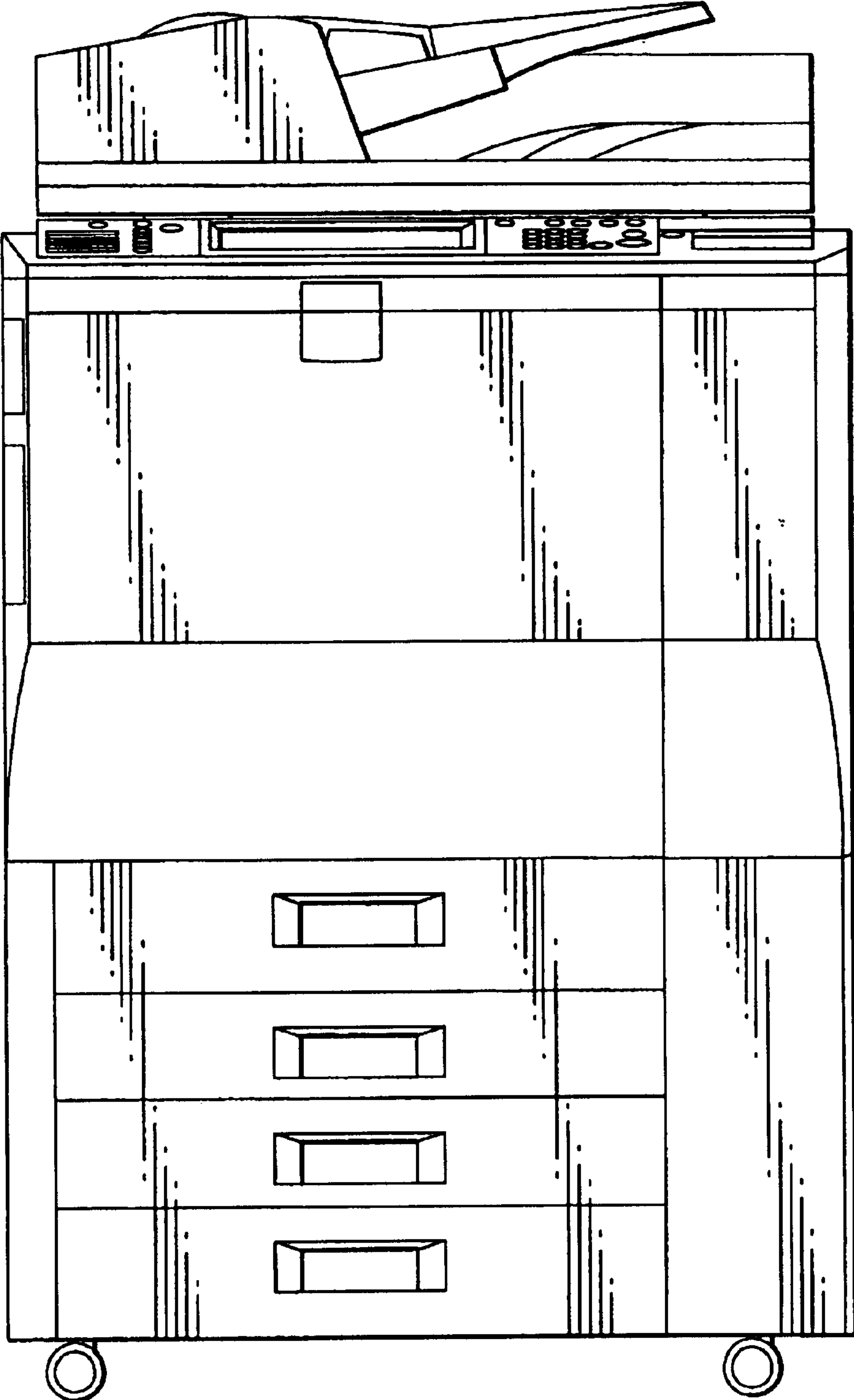

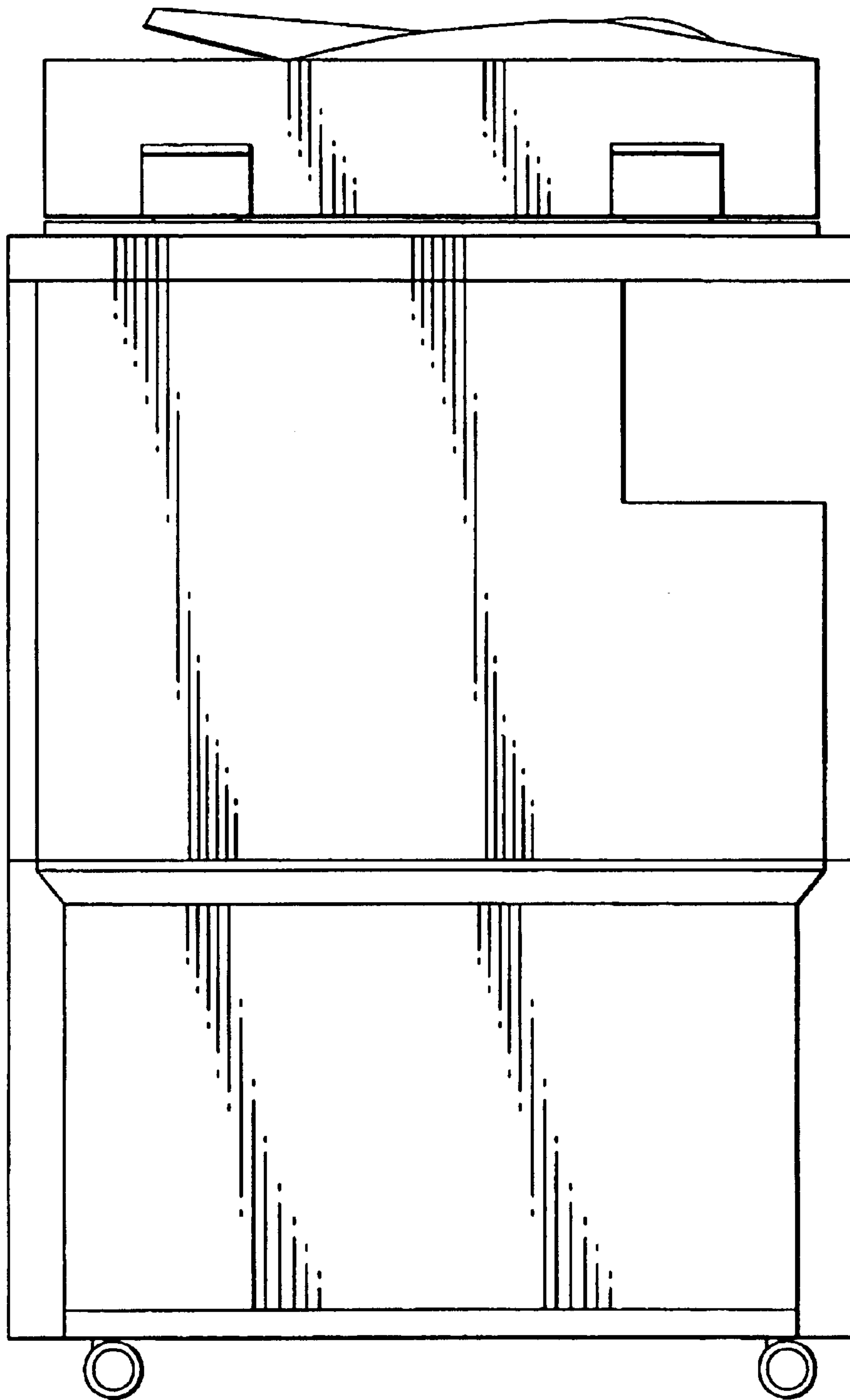

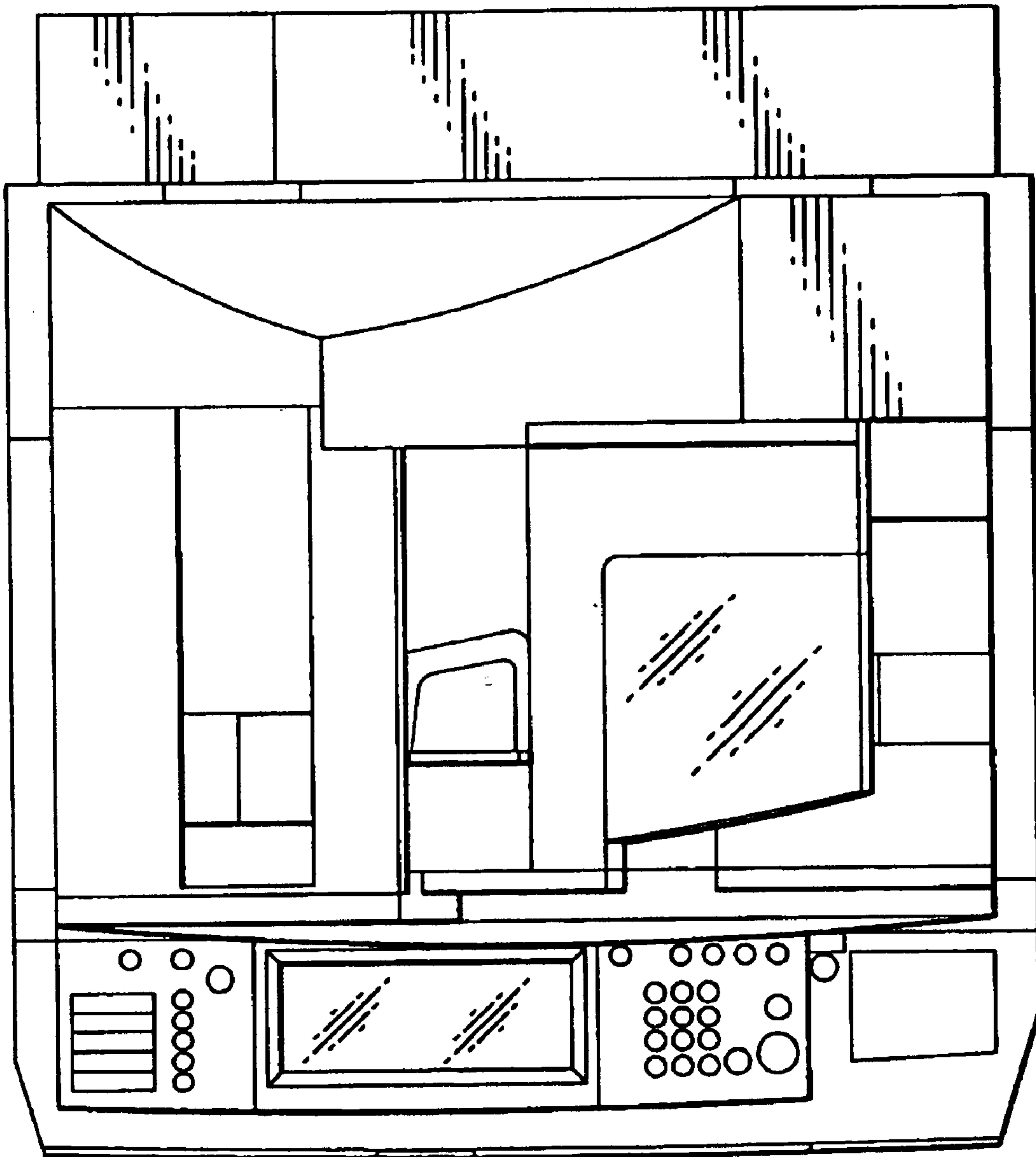

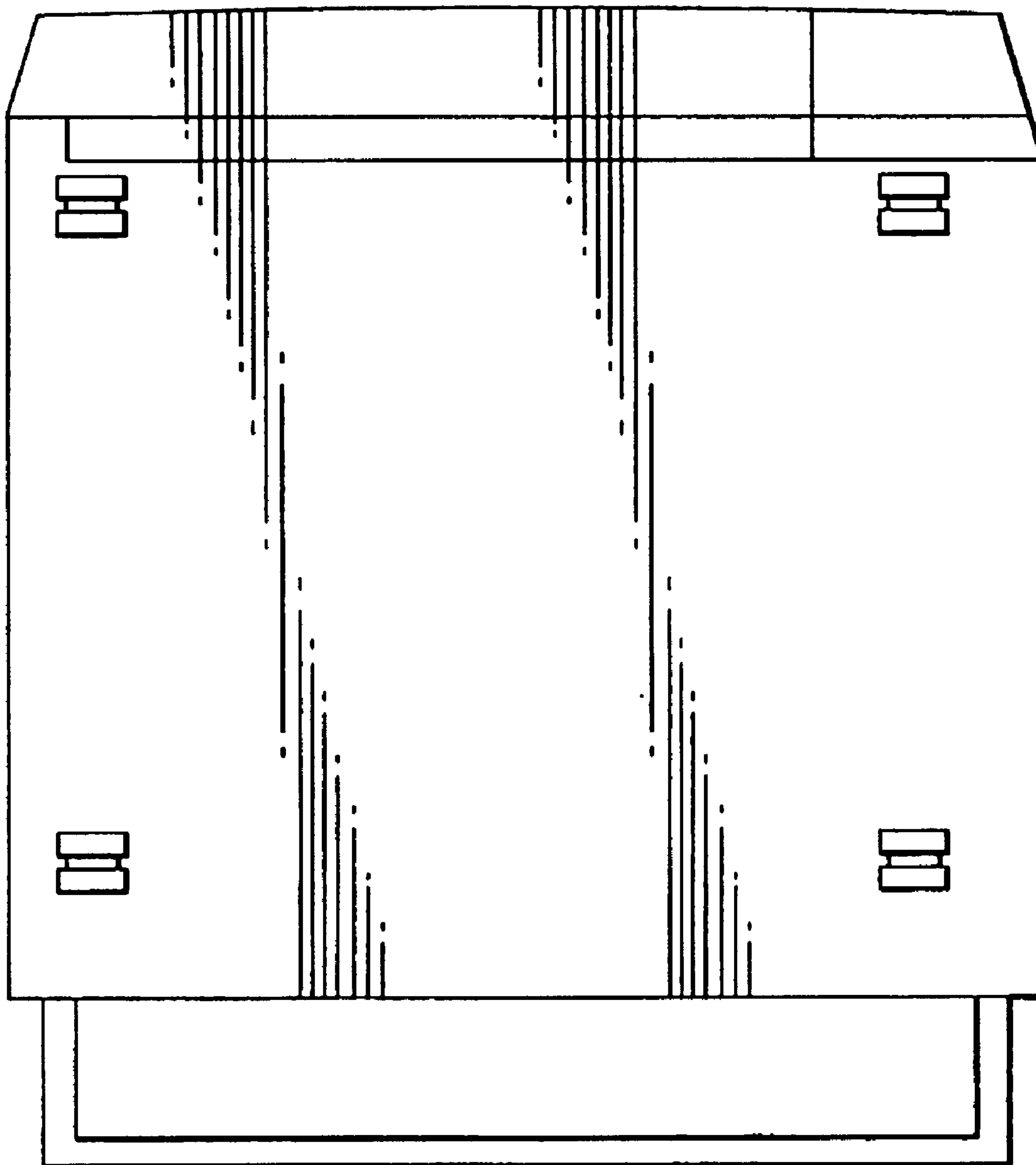

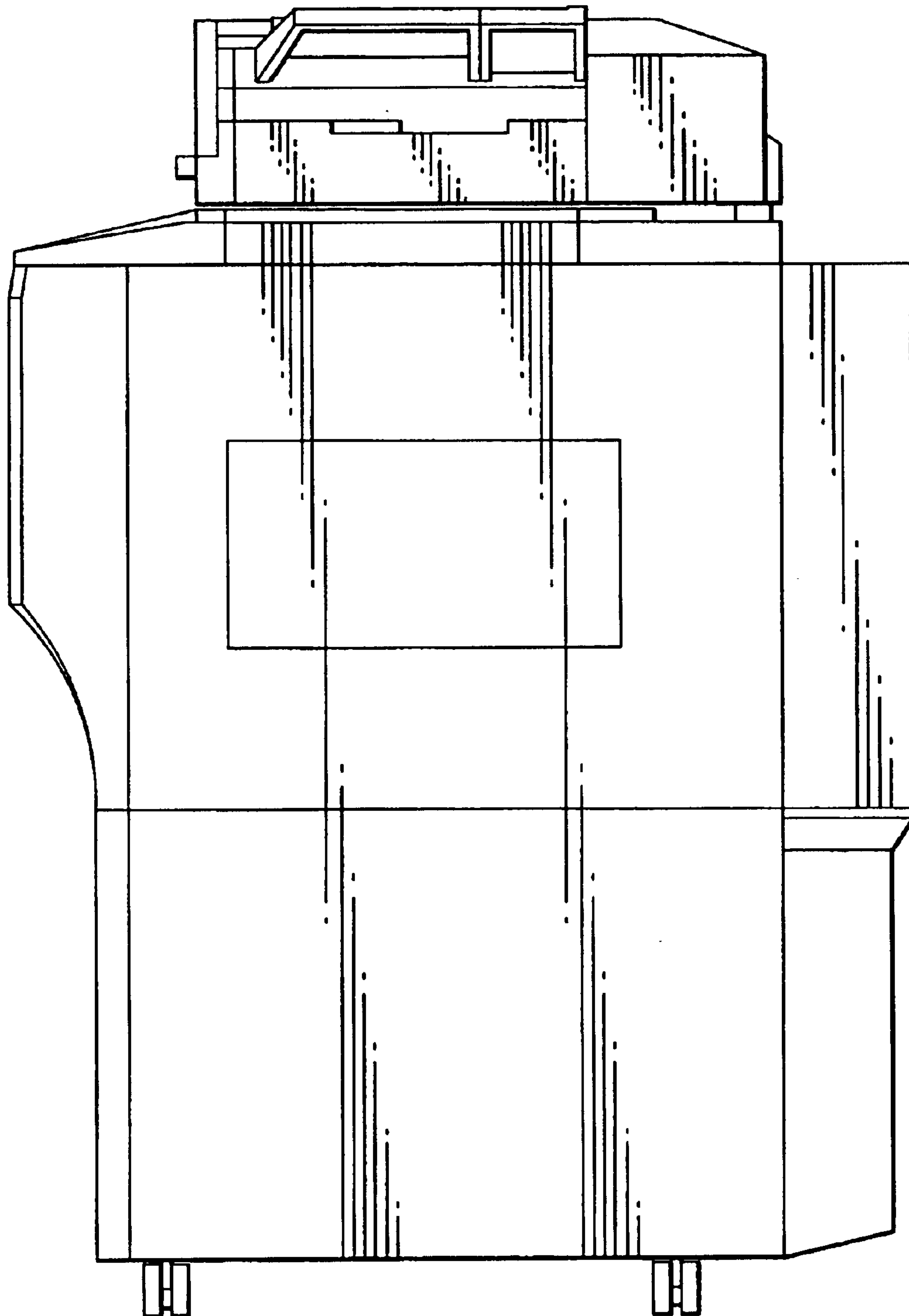

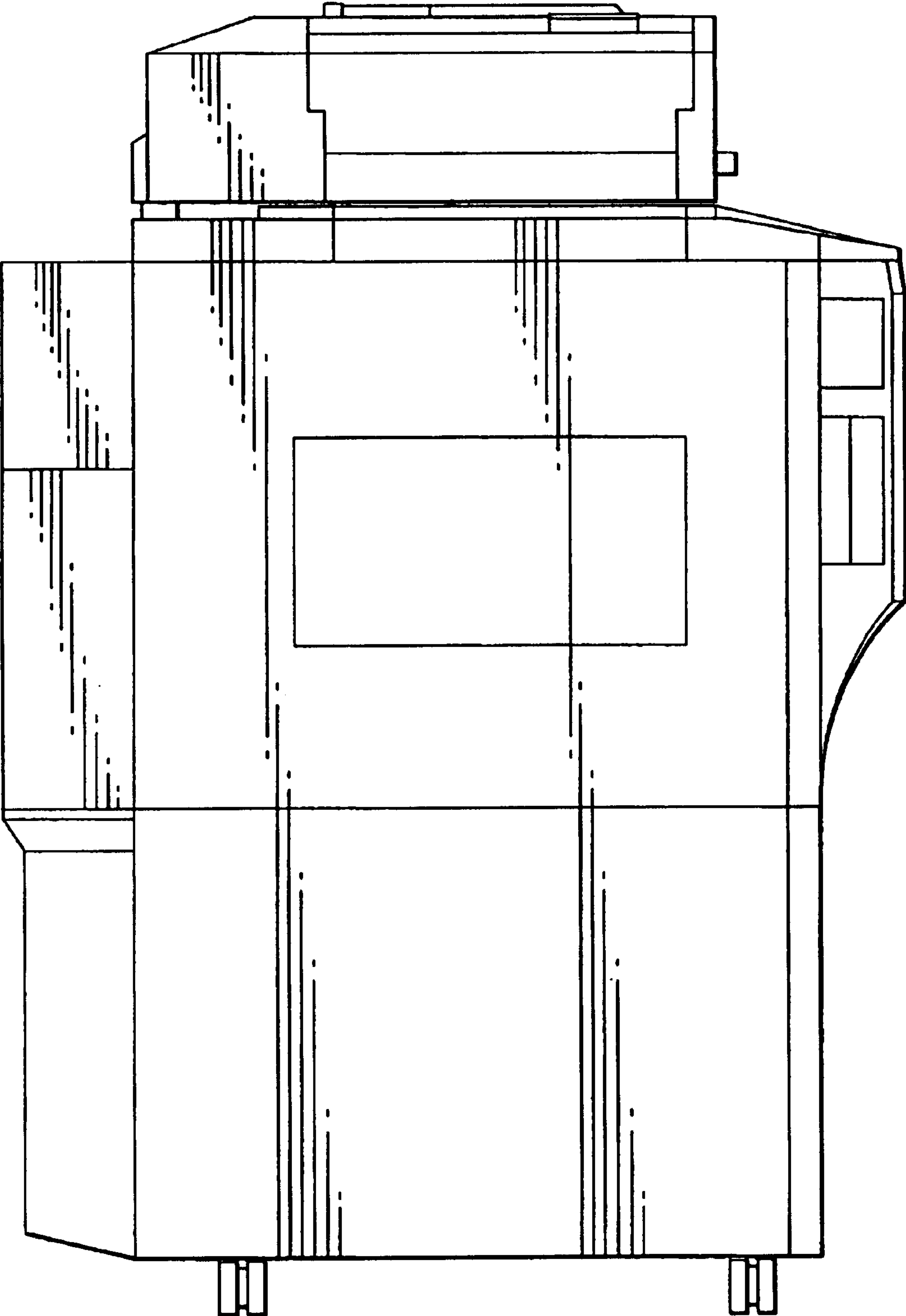
