(57) **CLAIM**

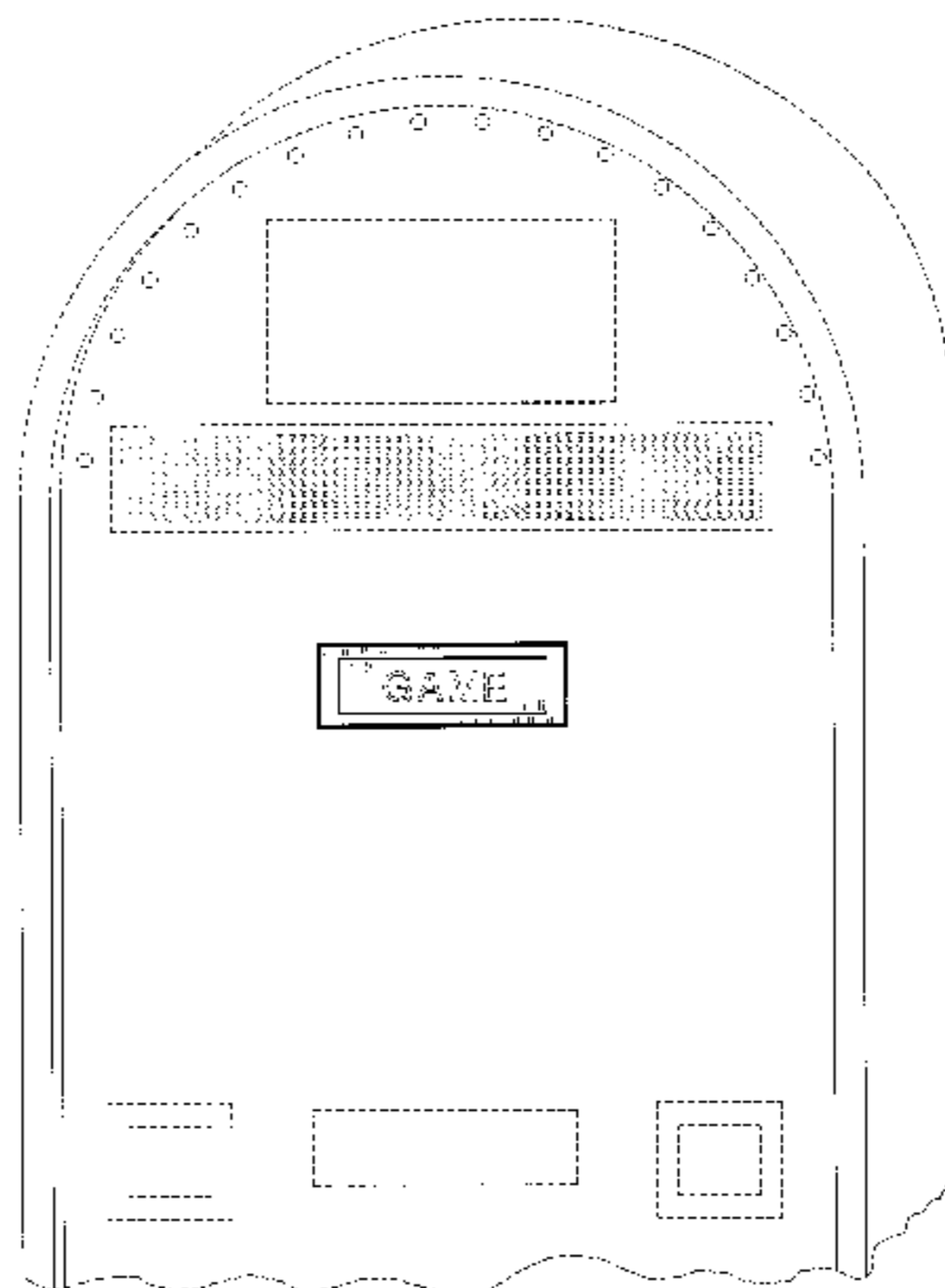
The ornamental design for a gaming device having a symbol display, as shown and described.

DESCRIPTION
