**DESCRIPTION**

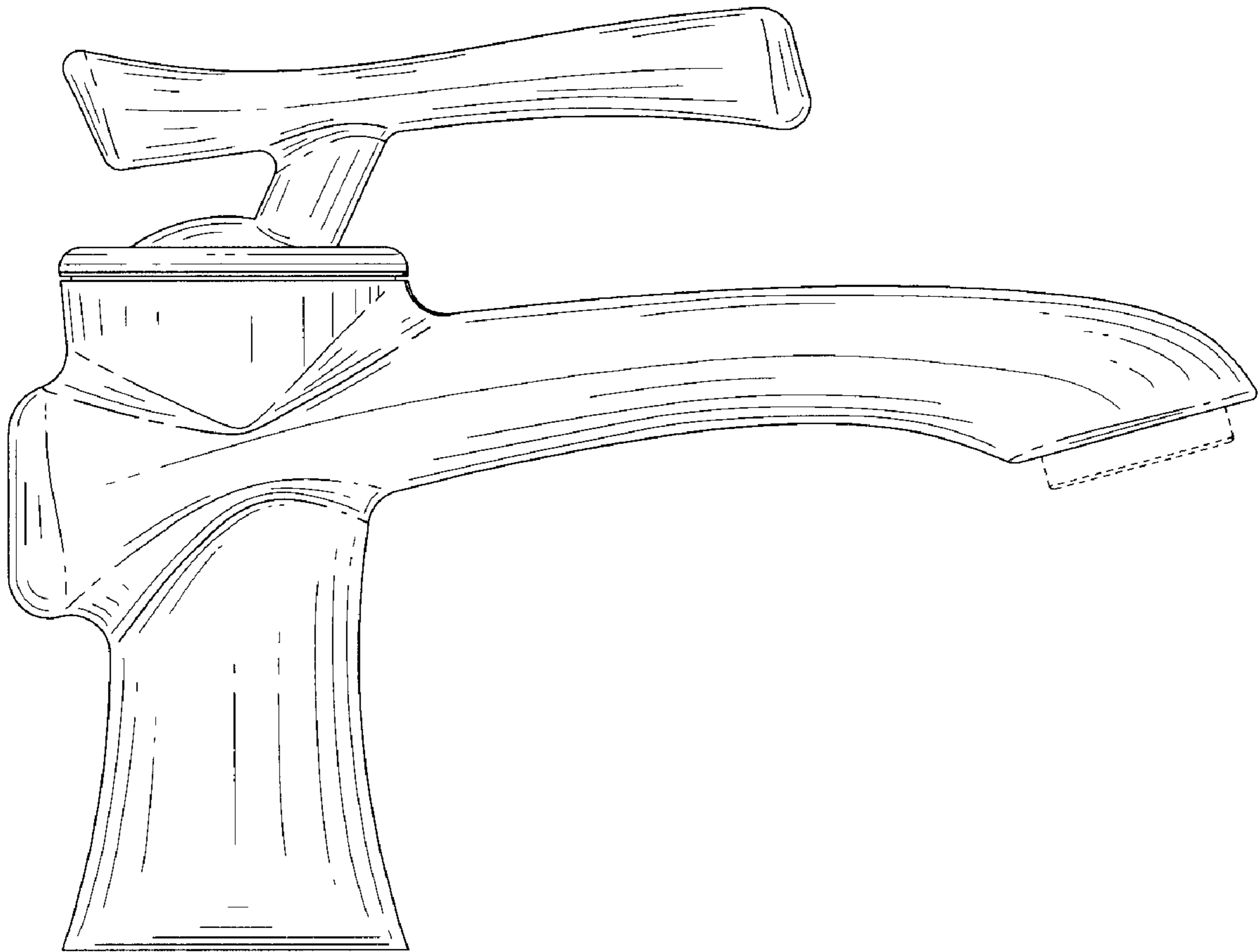
FIG. 1 is a front perspective view of a faucet assembly showing my design;

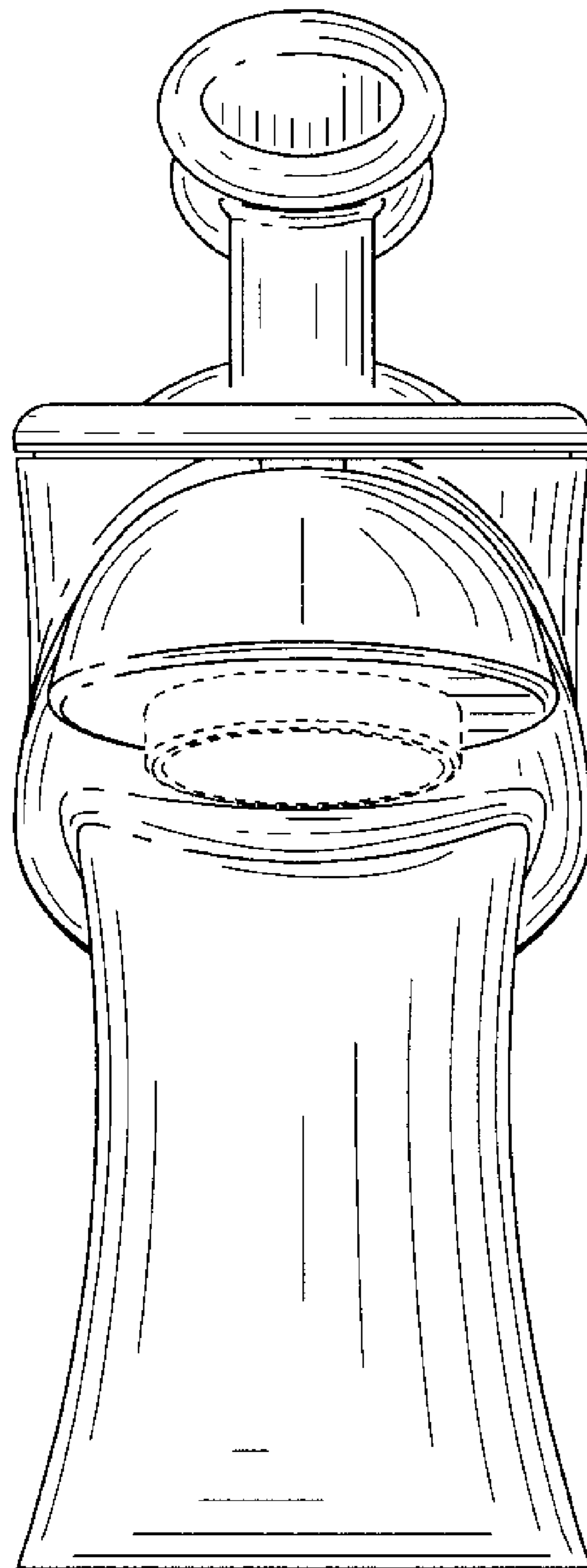




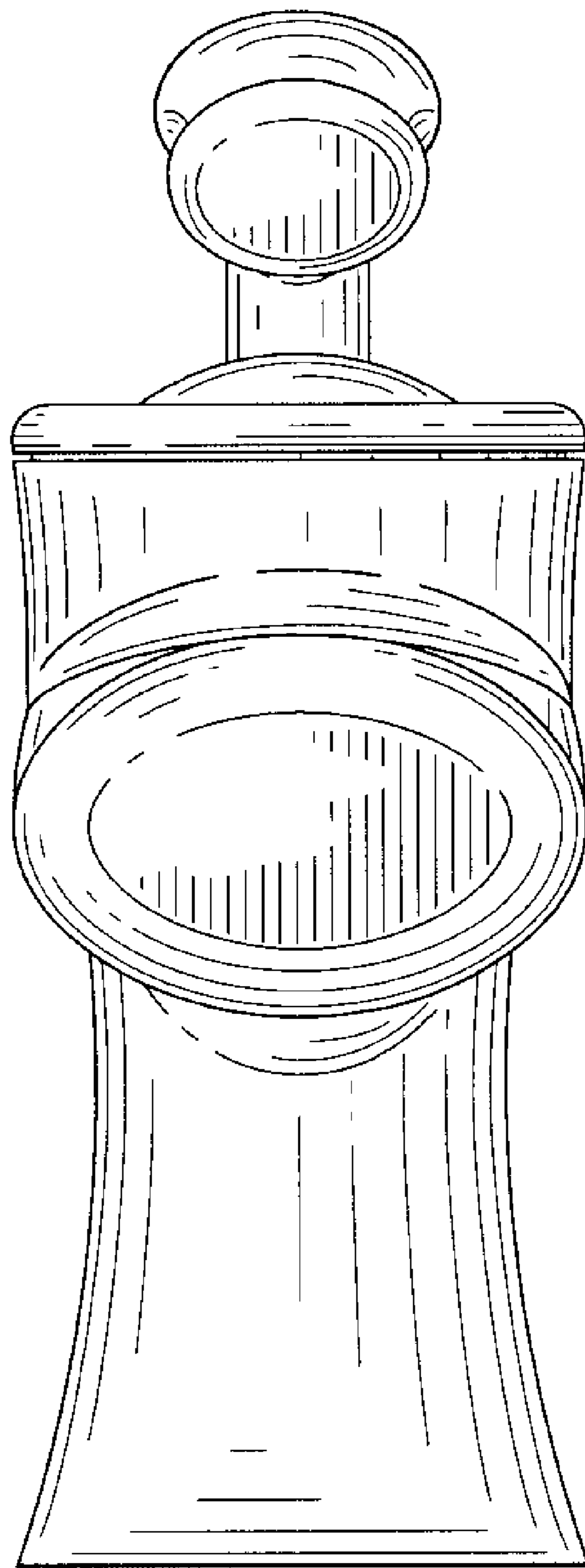

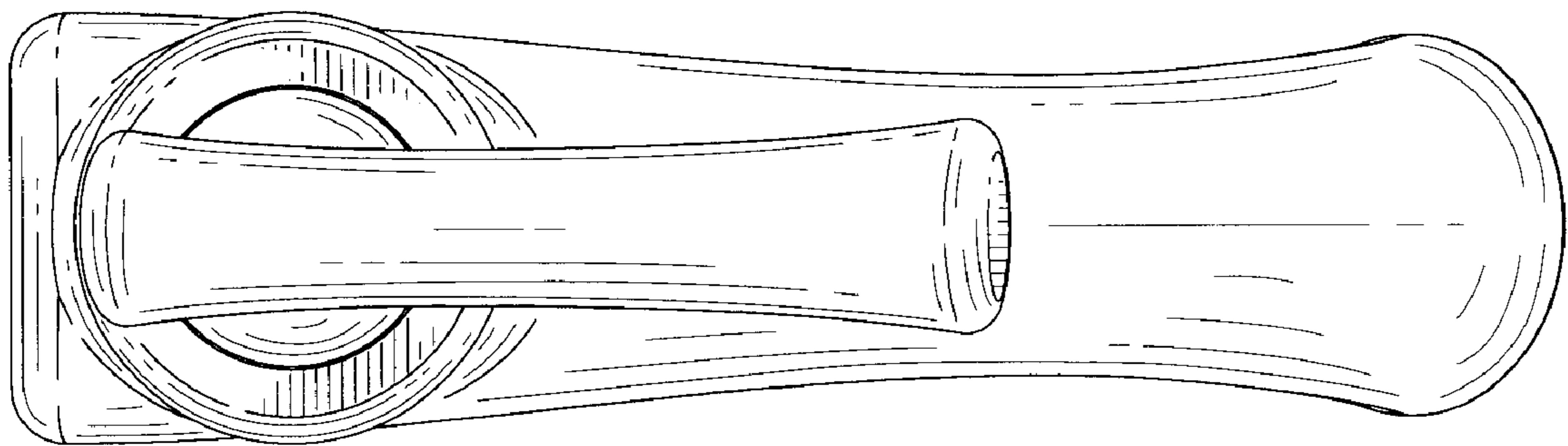
