(57) **CLAIM**

The ornamental design for a drainage apparatus with pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a drainage apparatus with pattern showing the new and ornamental design.

FIG. 2 is a bottom perspective view of the drainage apparatus with pattern of FIG. 1.

FIG. 5 is a back view of the drainage apparatus with pattern of FIG. 1.

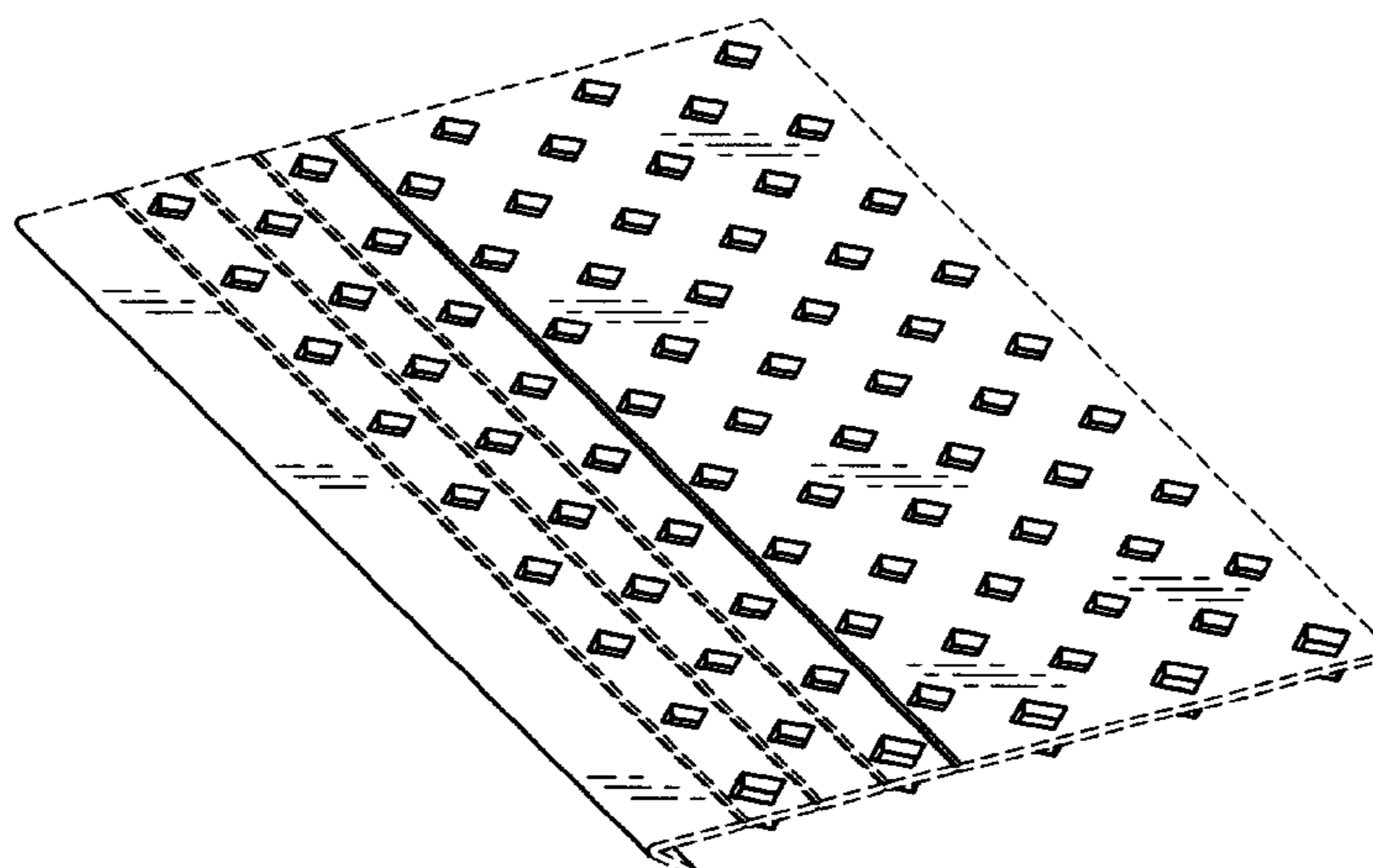
FIG. 6 is a front view of the drainage apparatus with pattern of FIG. 1.

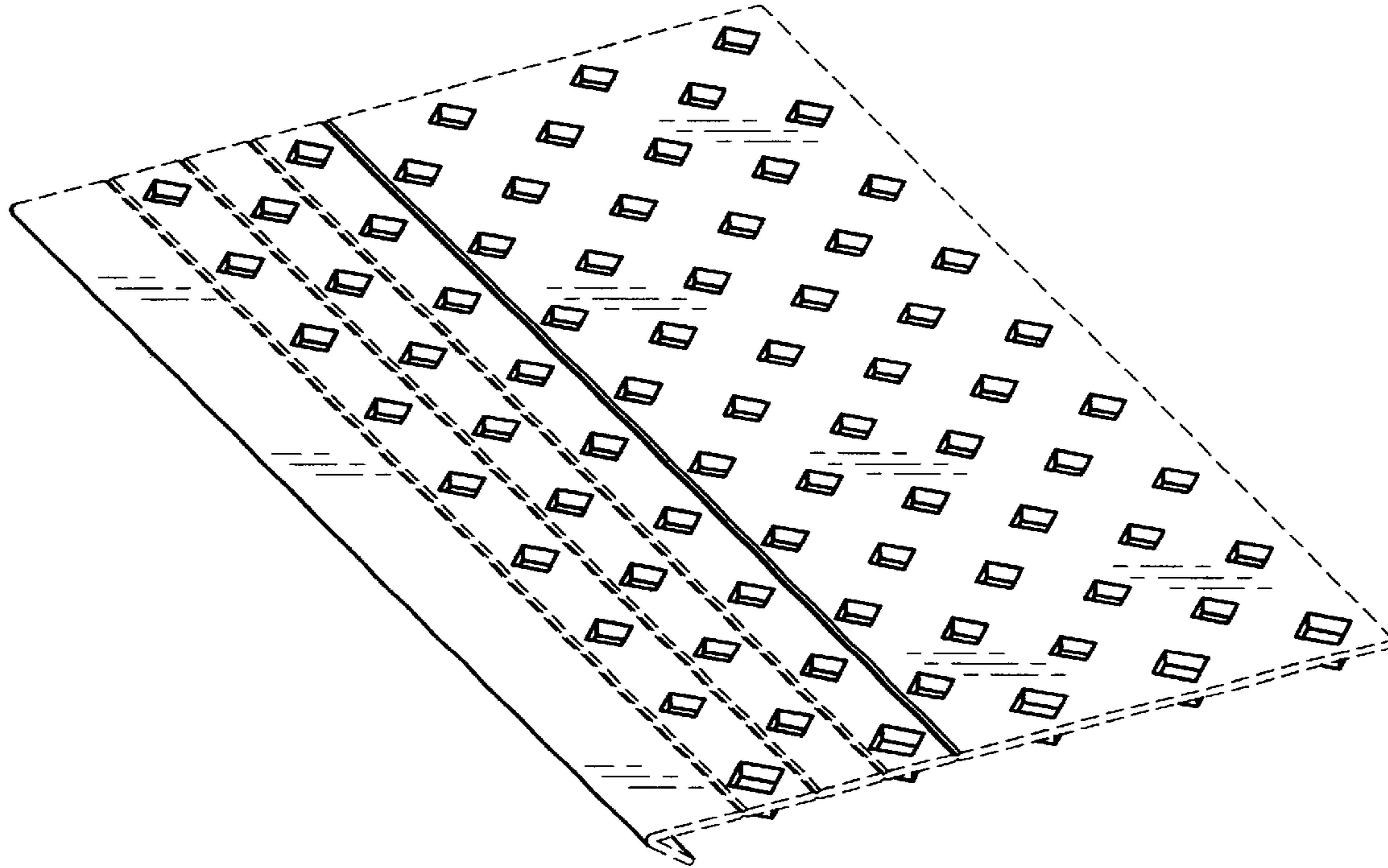

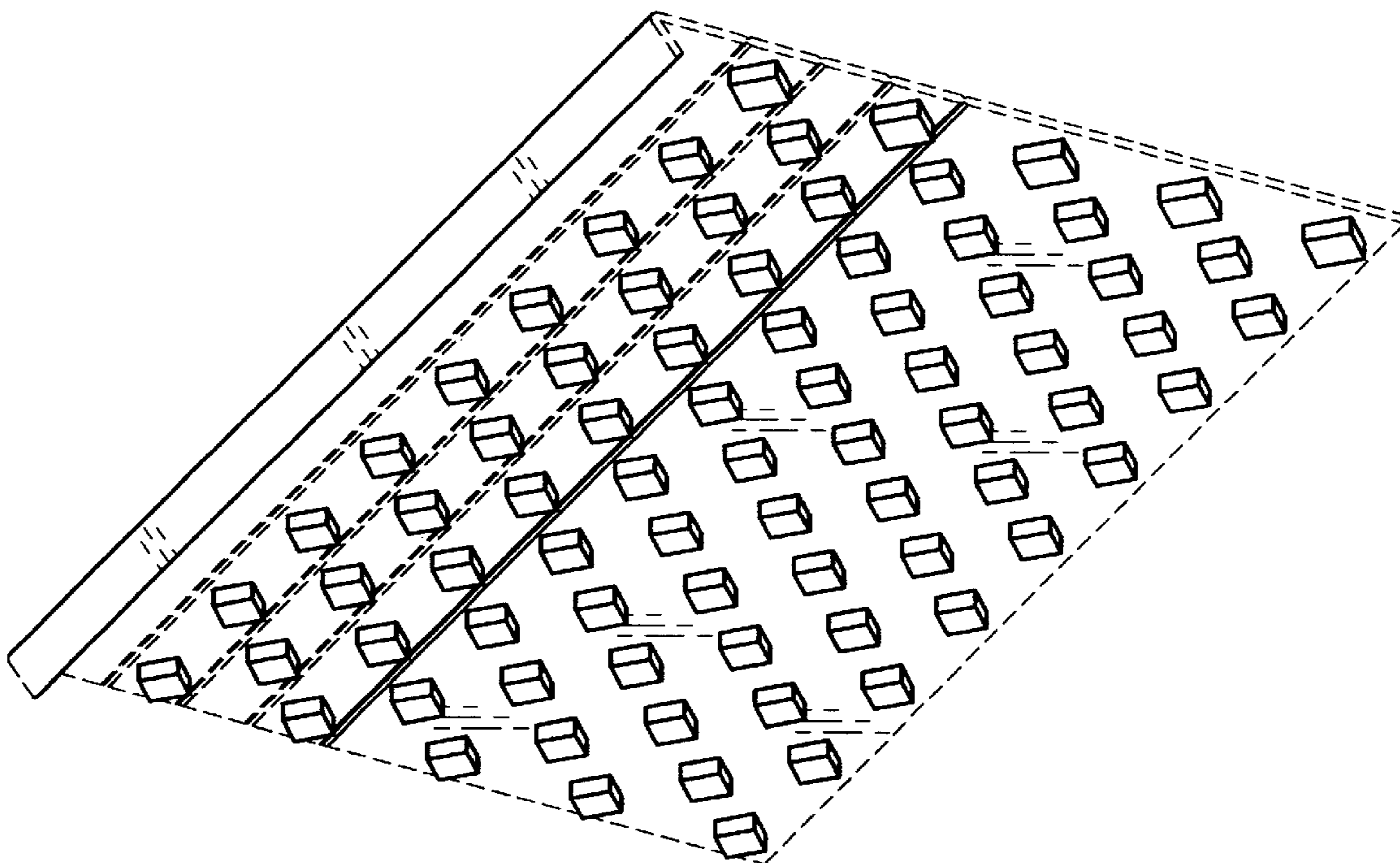

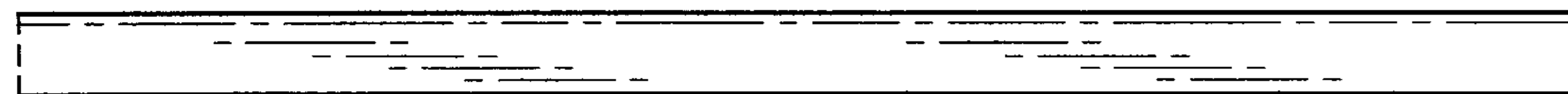

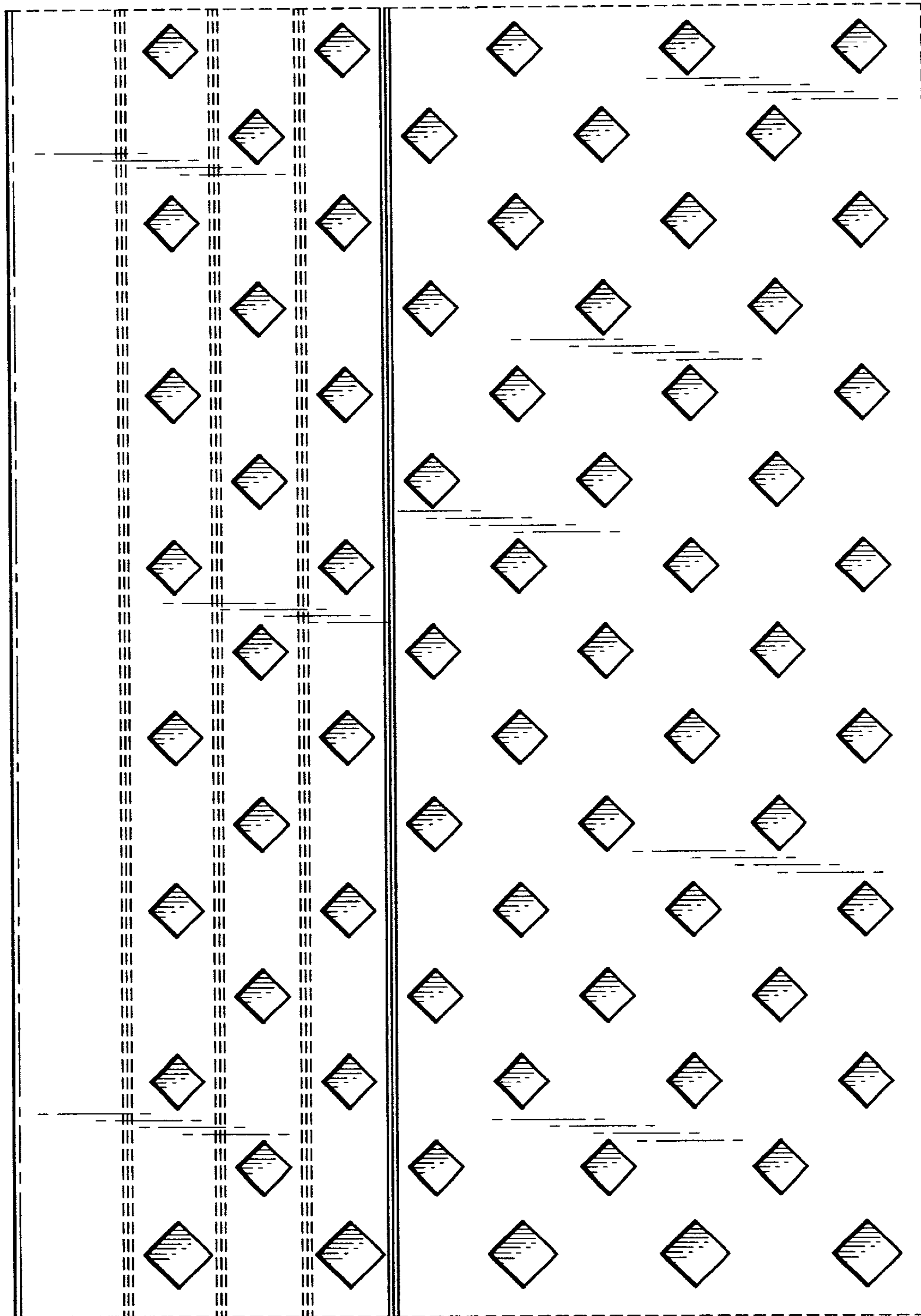
