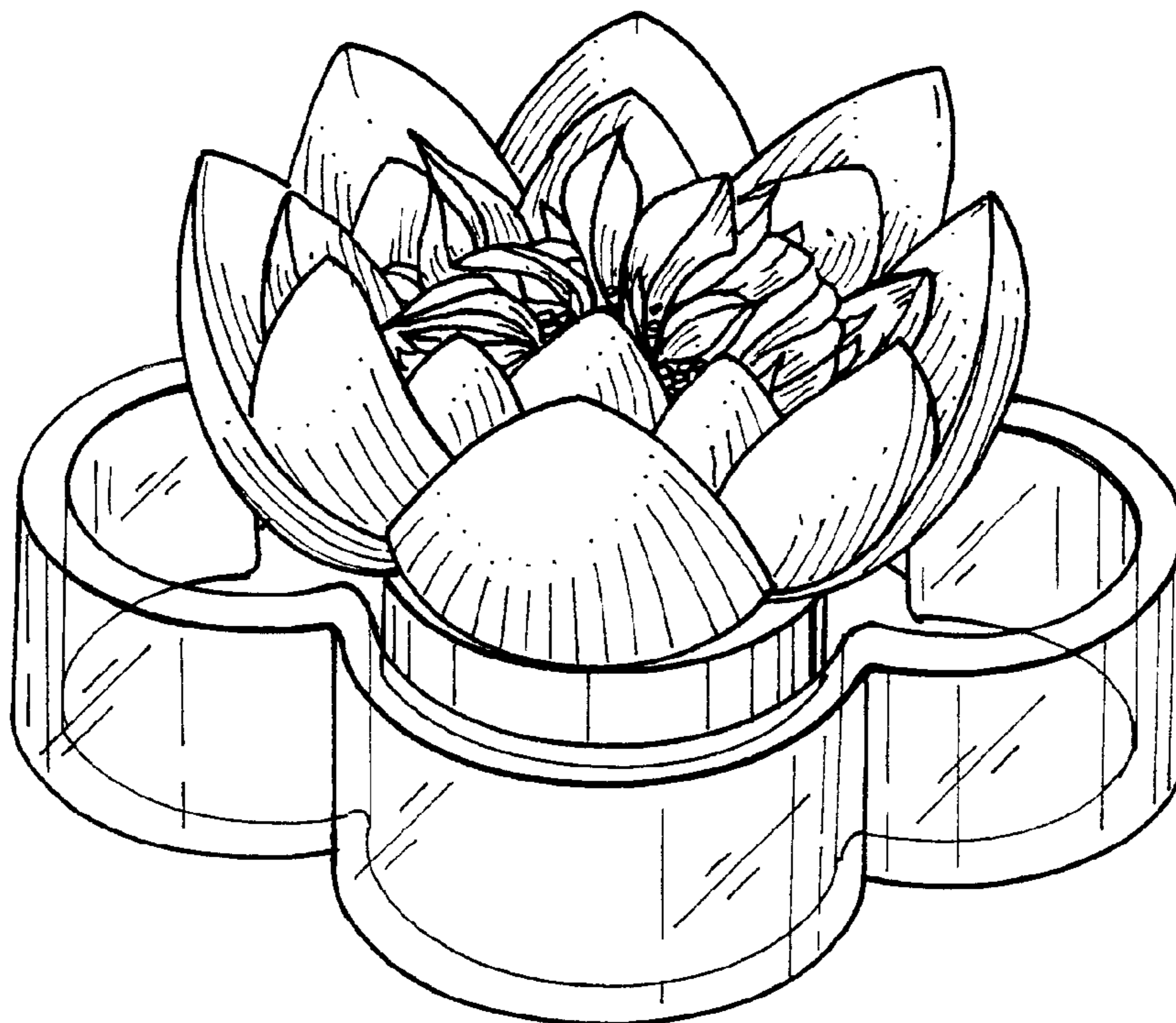

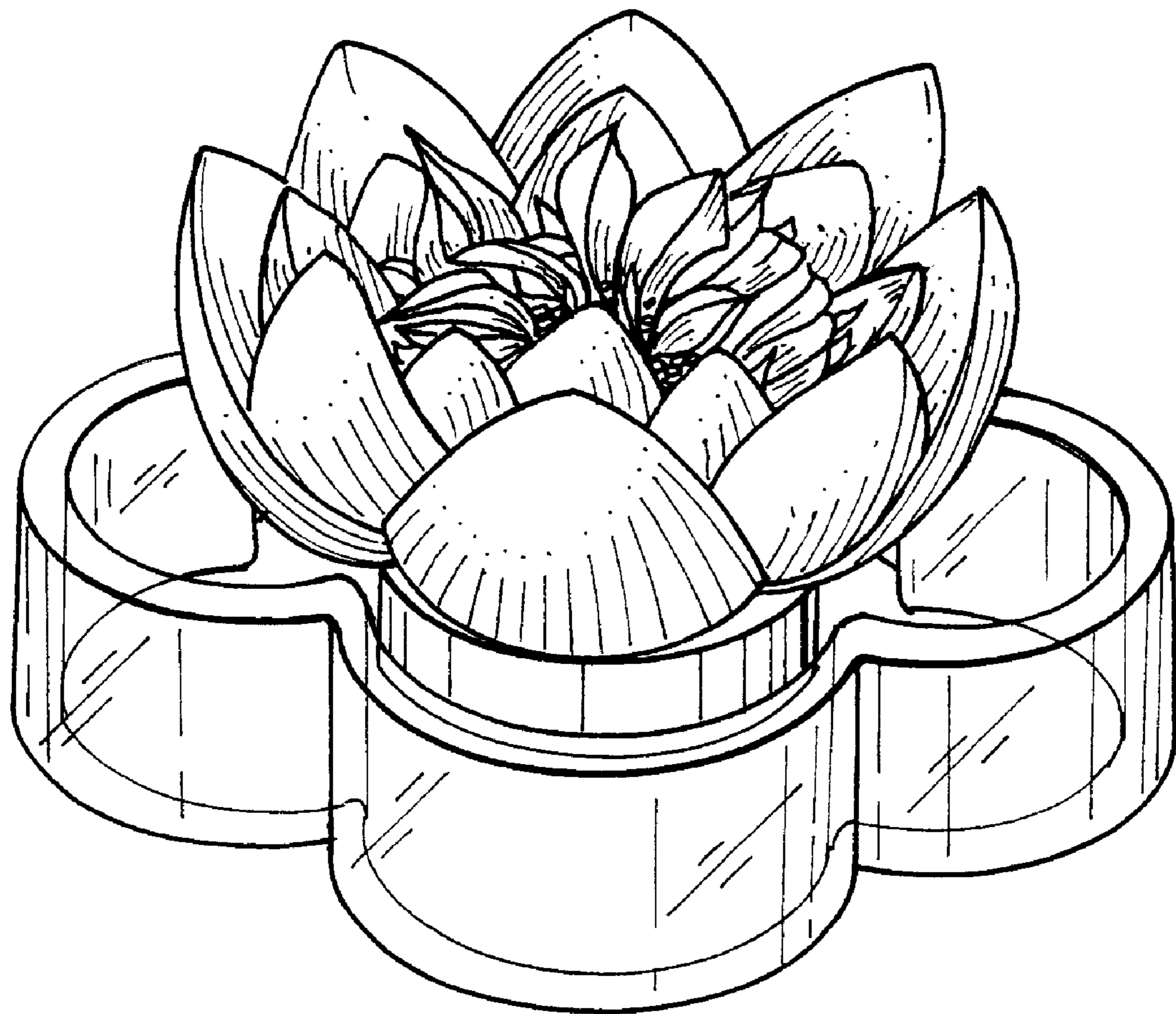
The ornamental design for an air freshener device, as shown and described.

**DESCRIPTION**

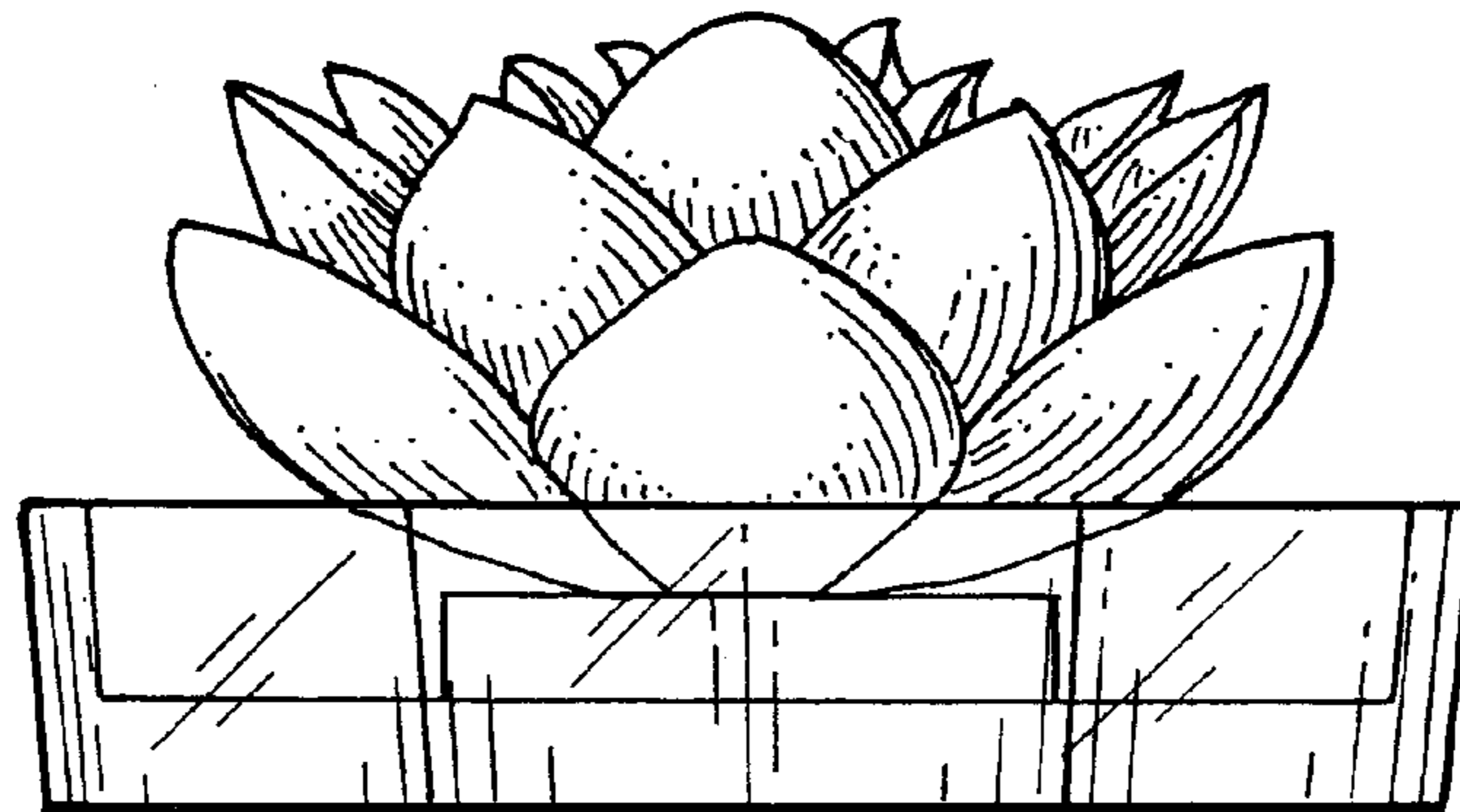

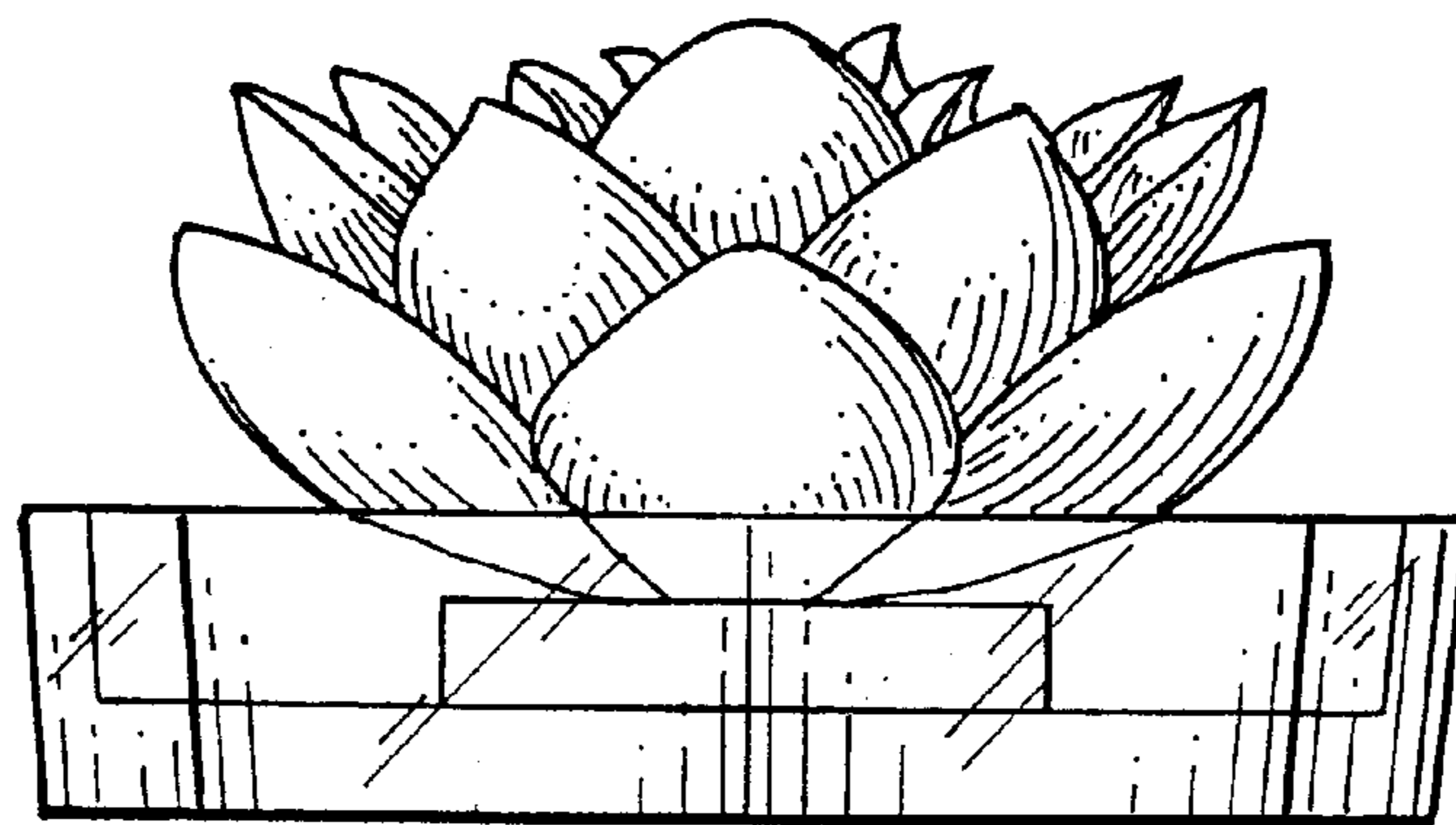




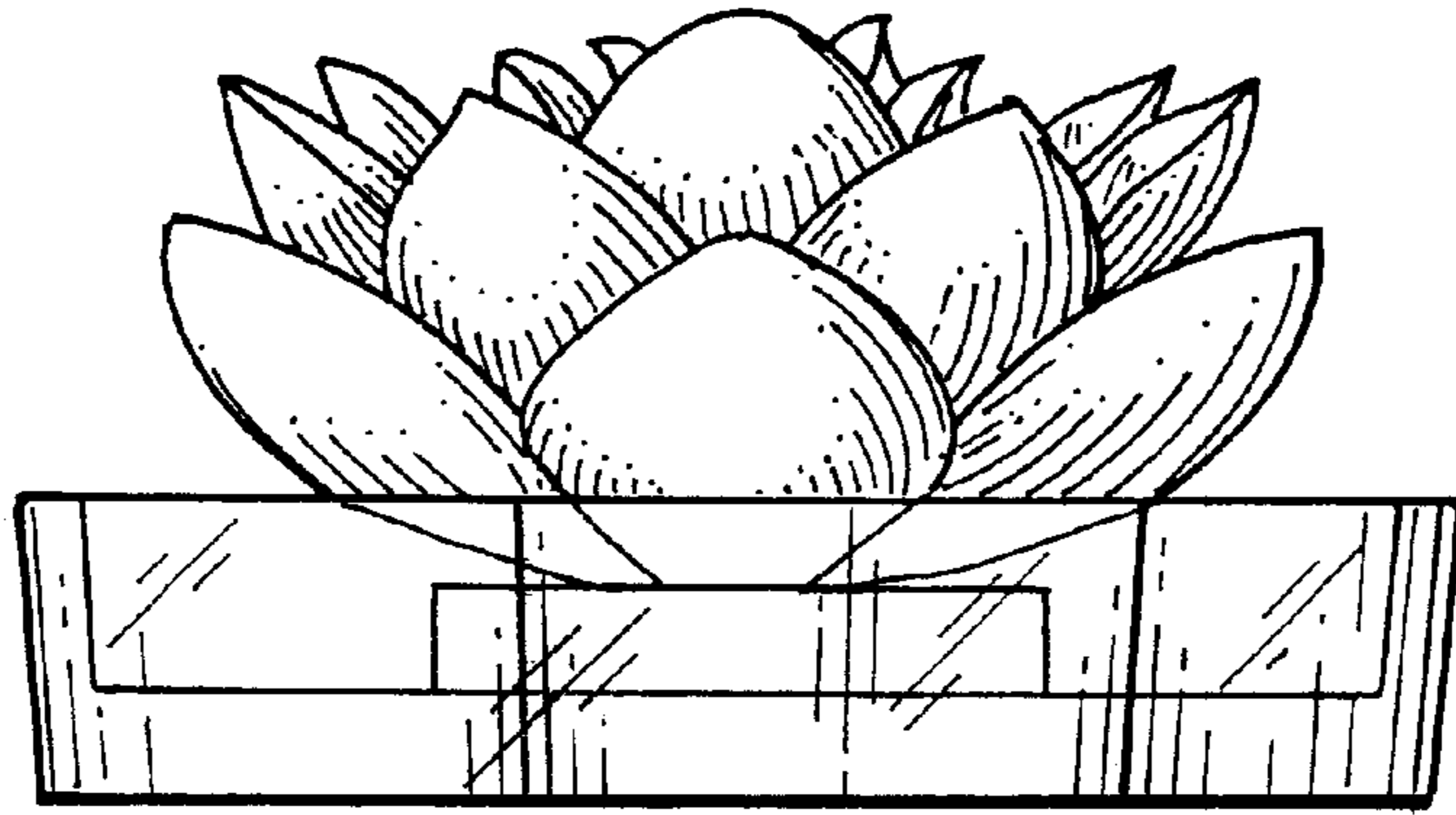

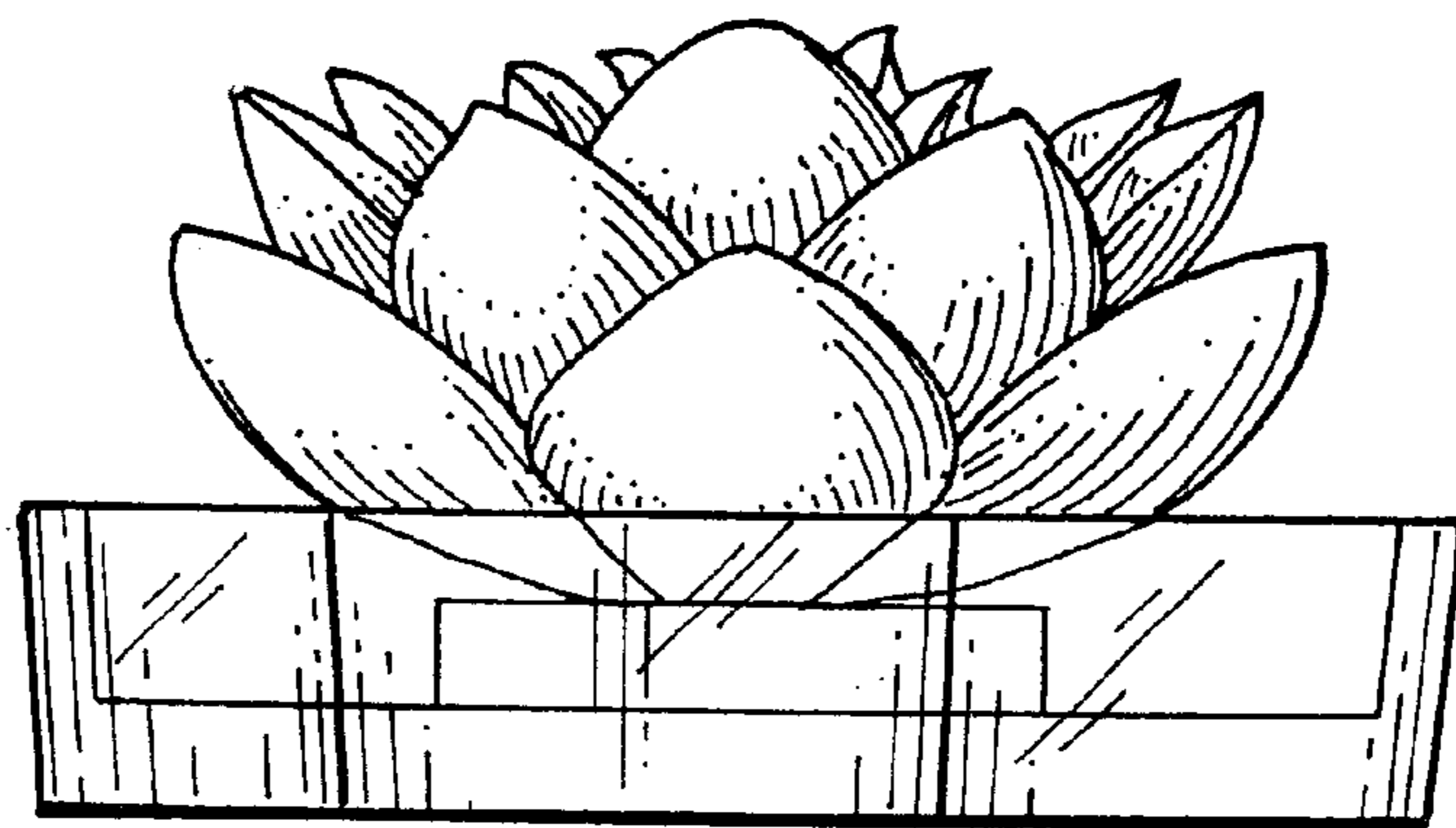

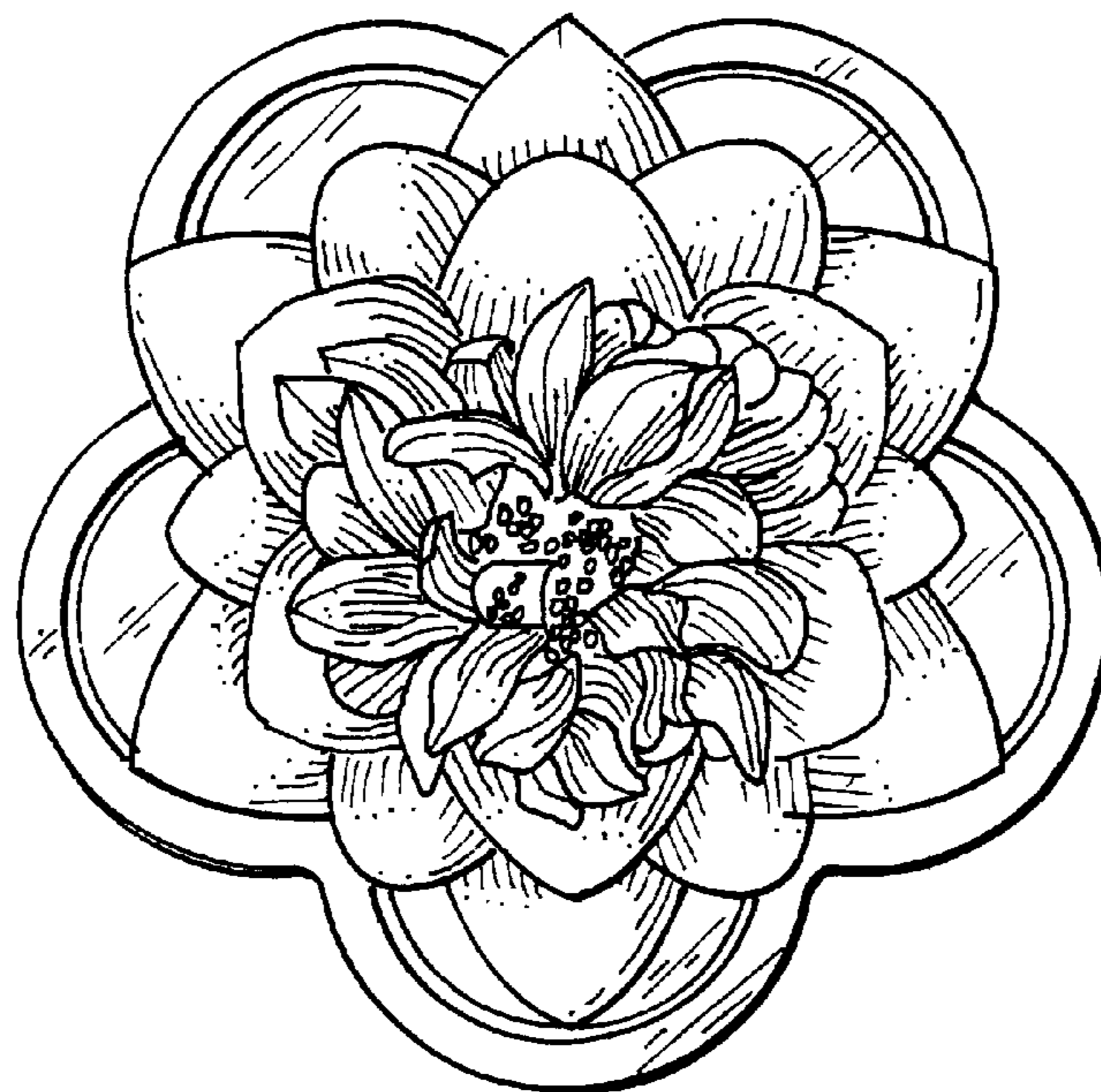

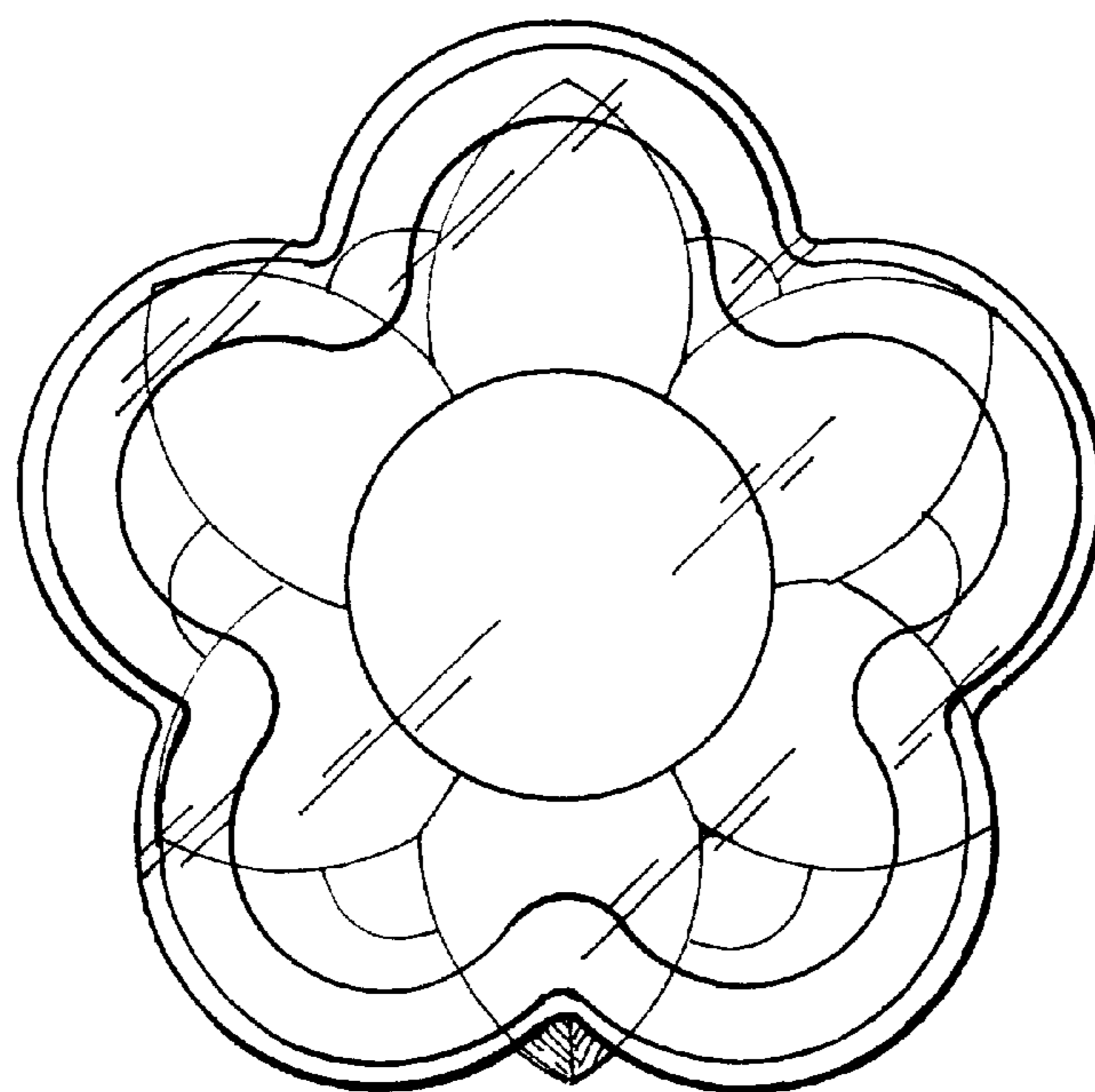
