(57) **CLAIM**

The ornamental design for a container for fly fishing tackle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for fly fishing tackle showing our new design;

FIG. 2 is a front elevational view of the container for fly fishing tackle illustrated in FIG. 1;

FIG. 3 is a left-side elevational view of the container for fly fishing tackle illustrated in FIGS. 1 and 2;

FIG. 4 is a right-side elevational view of the container for fly fishing tackle illustrated in FIGS. 1–3;

FIG. 5 is a top plan view of the container for fly fishing tackle illustrated in FIGS. 1–4;

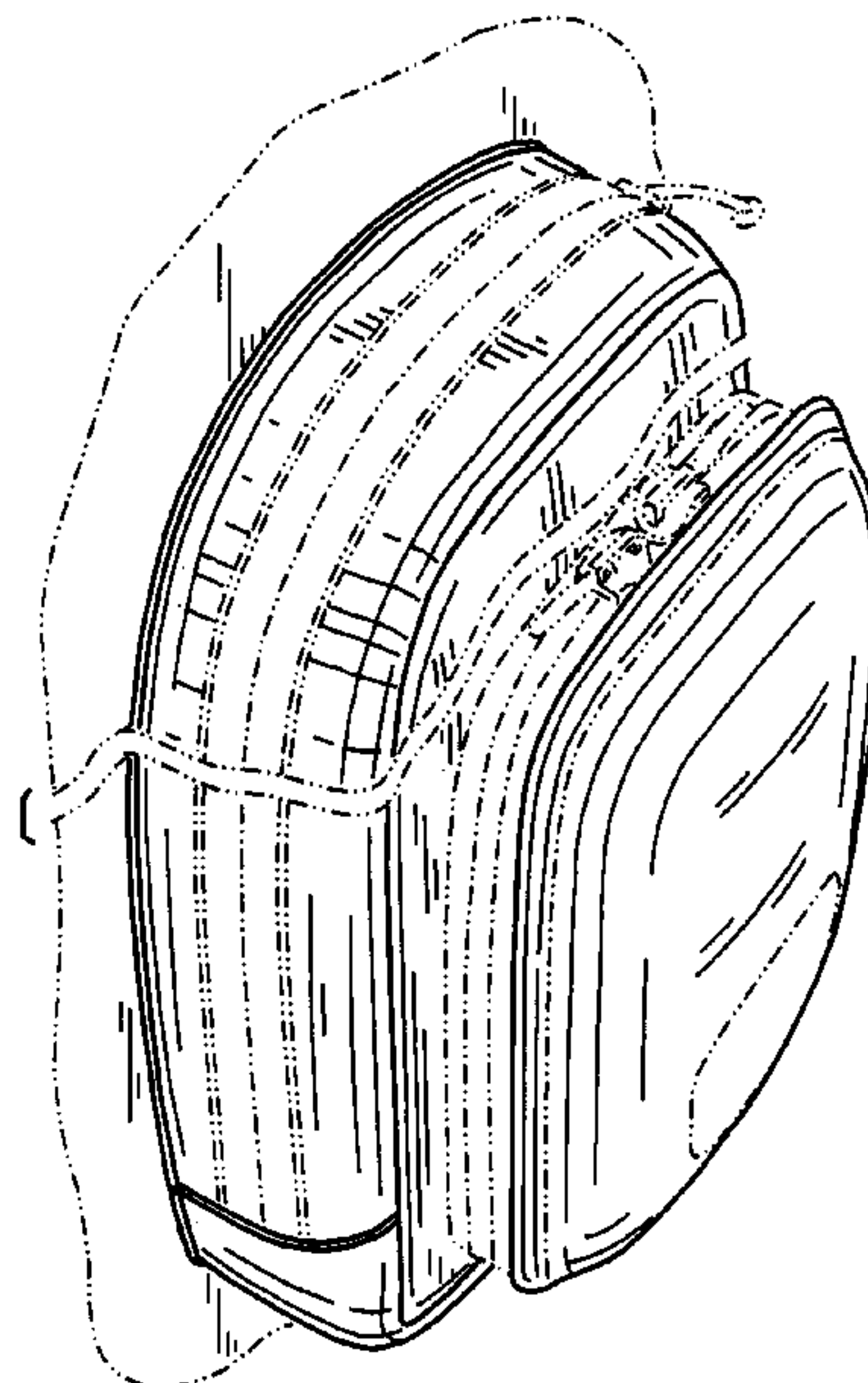
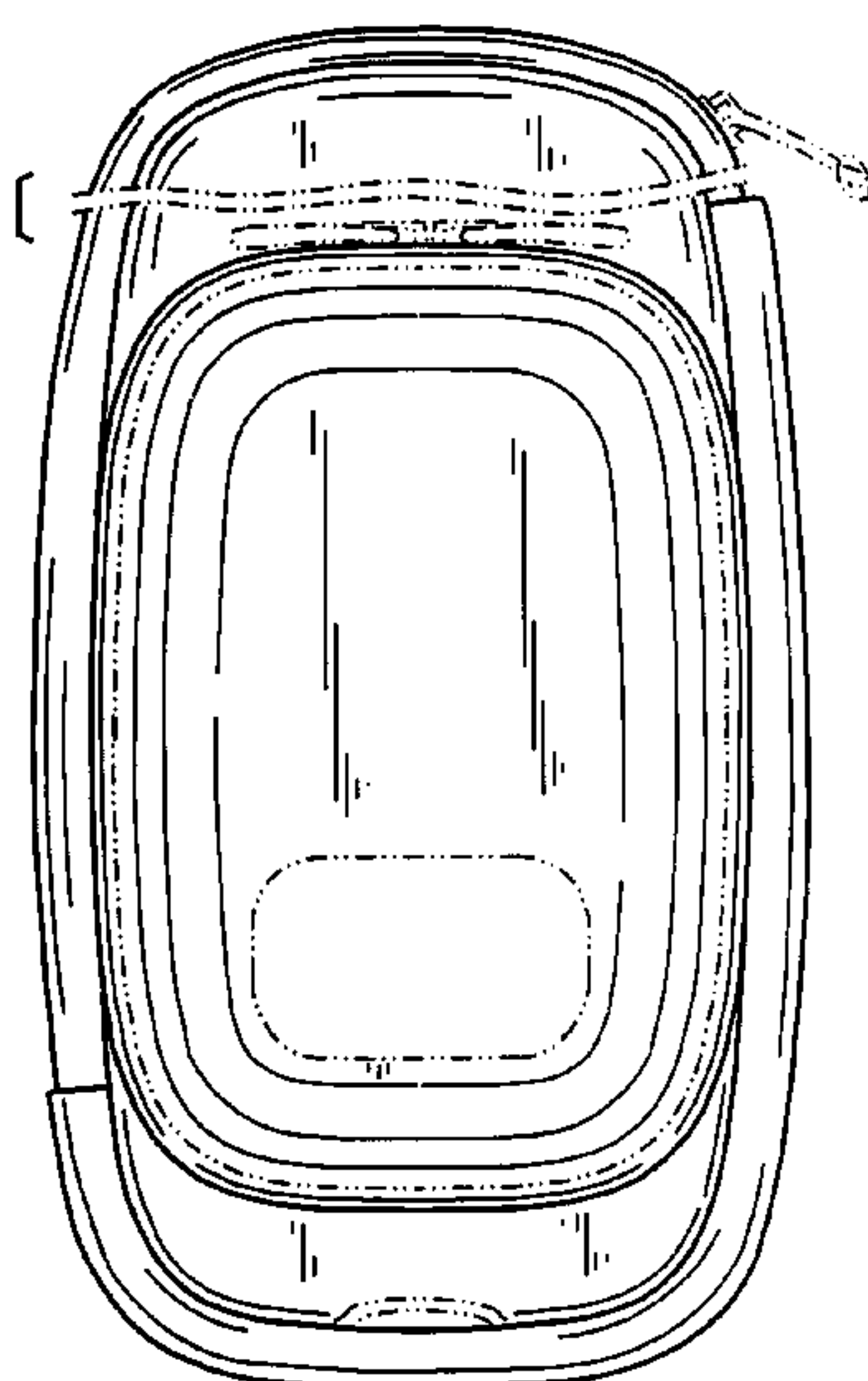
FIG. 6 is a bottom plan view of the container for fly fishing tackle illustrated in FIGS. 1–5;

FIG. 7 is a rear elevational view of the container for fly fishing tackle illustrated in FIGS. 1–6;

FIG. 8 is a perspective view of another embodiment of a container for fly fishing tackle showing our new design; and, FIG. 9 is a front elevational view of the container for fly fishing tackle of FIG. 8, the left-side elevational view, the right-side elevational view, the top plan view, the bottom plan view, and the rear elevational view, corresponding to those of FIGS. 3, 4, 5, 6 and 7, respectively.

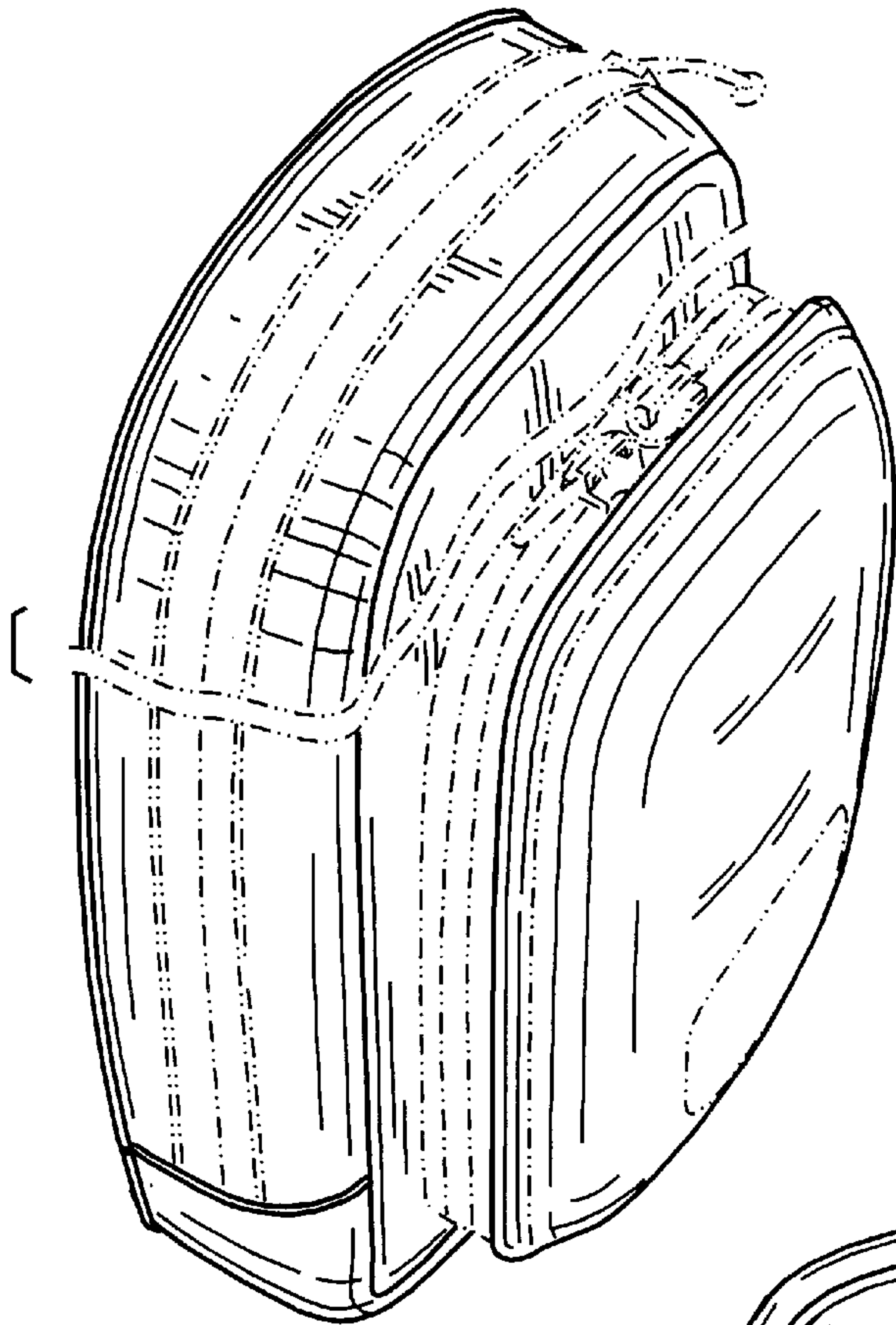

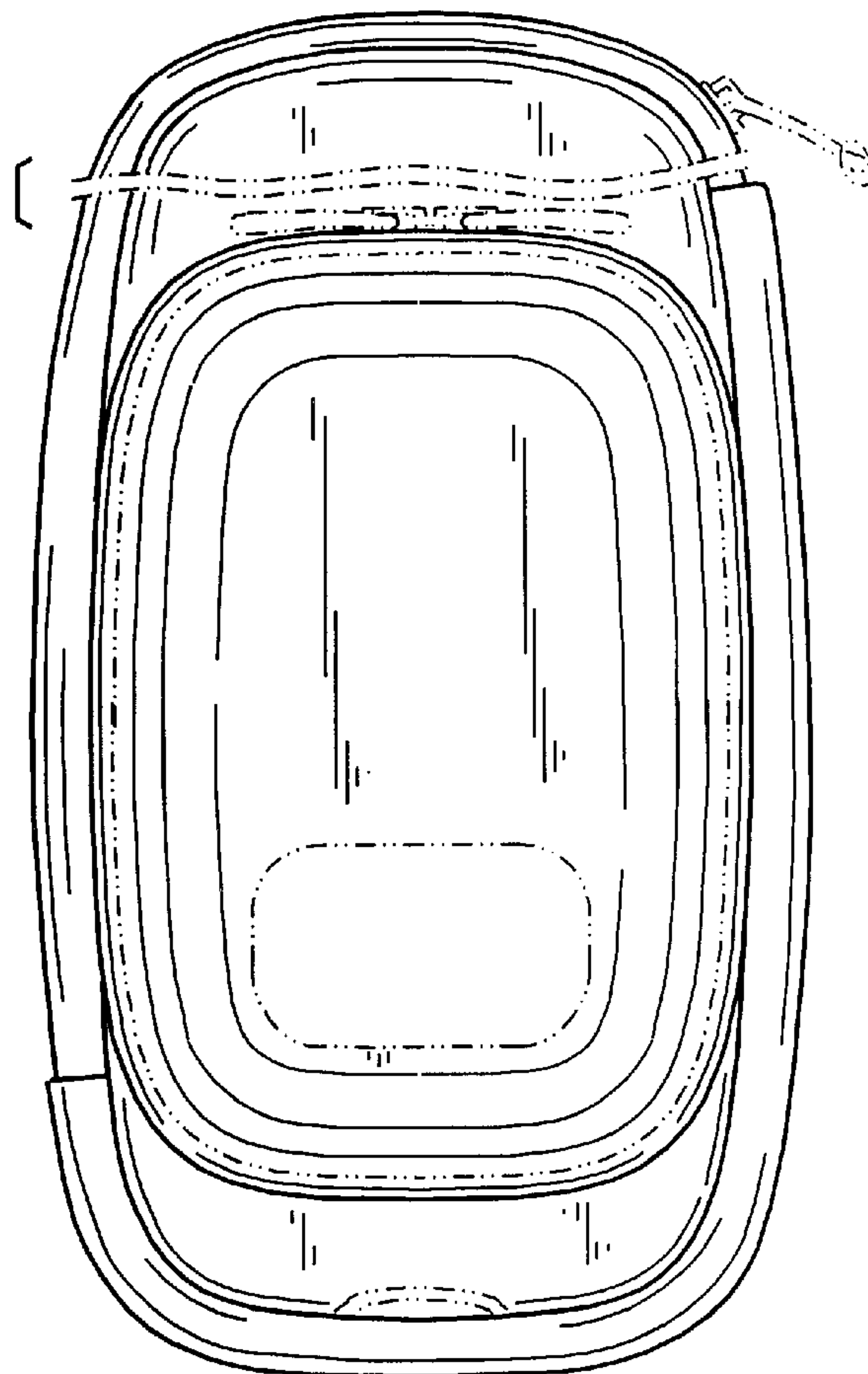

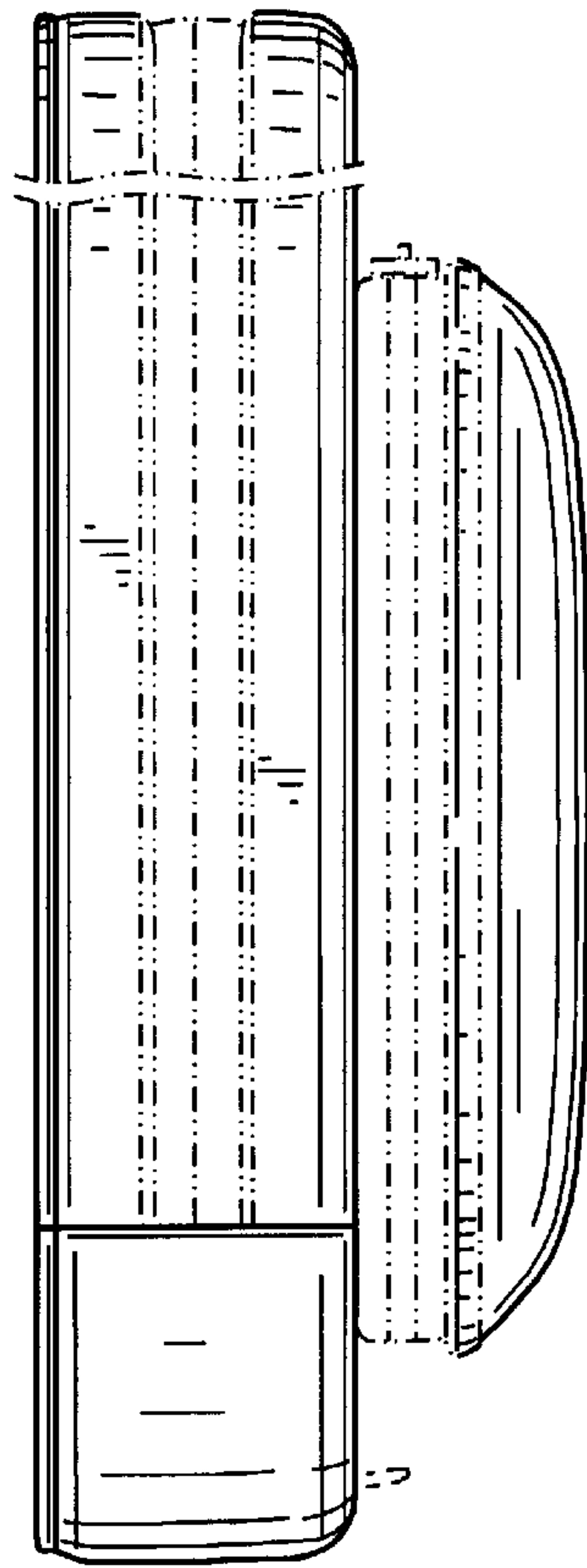

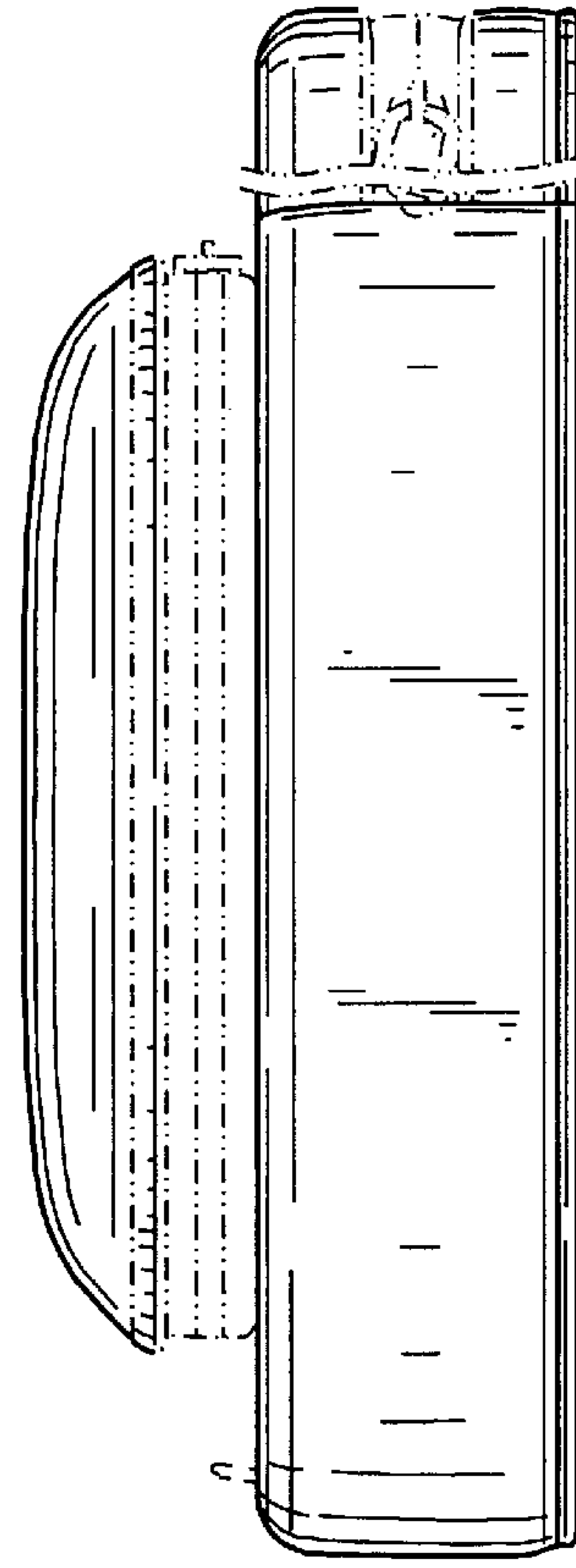

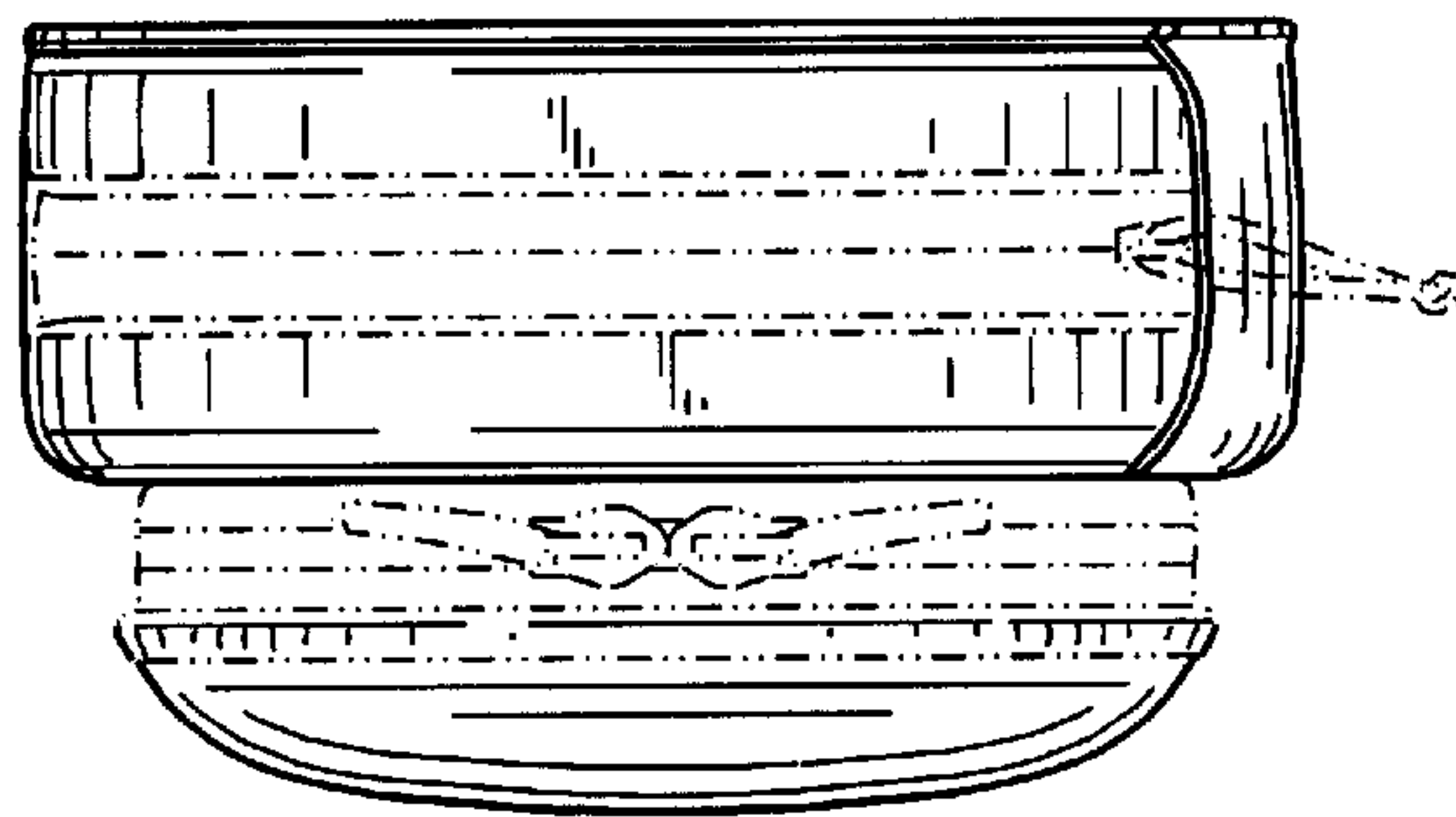

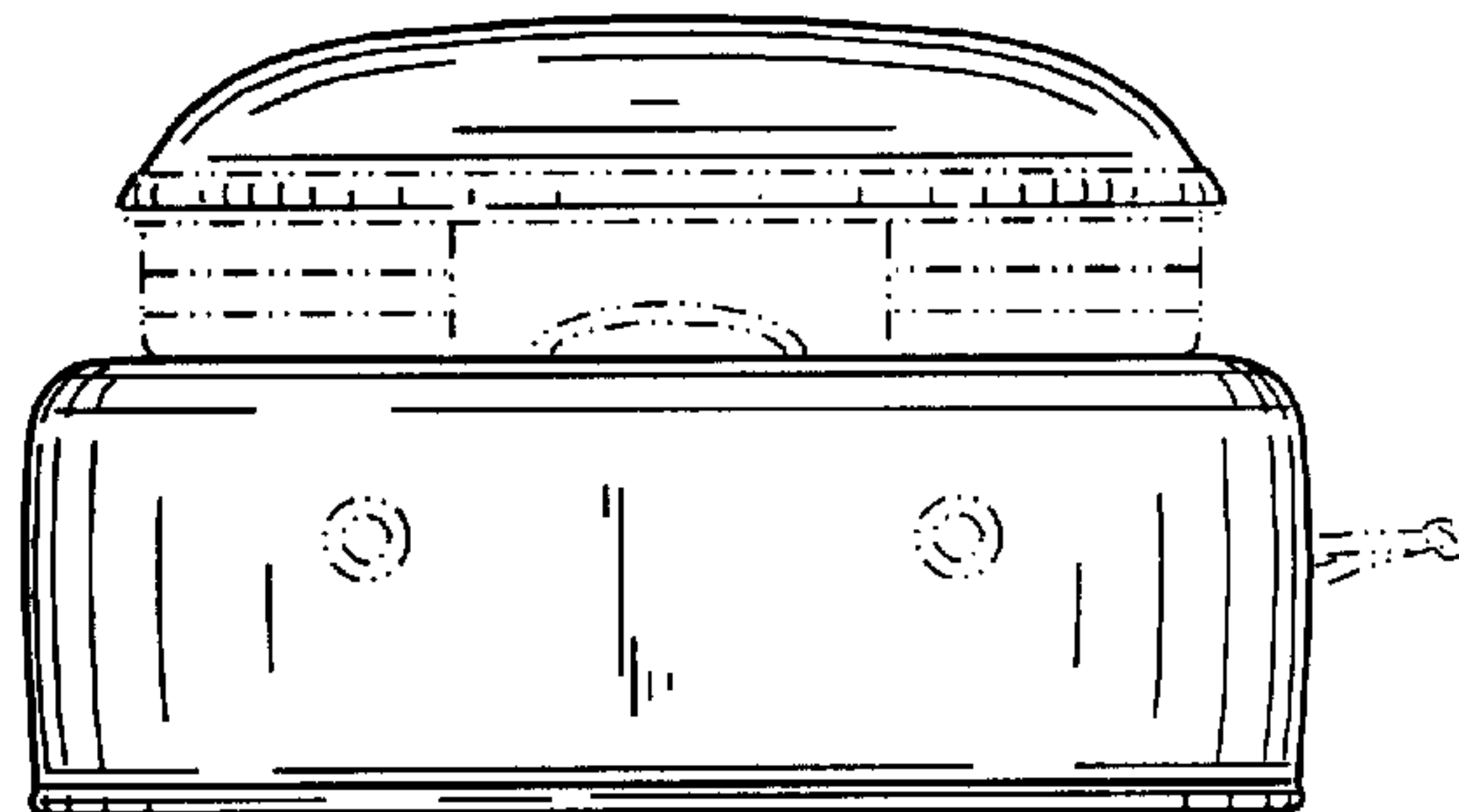

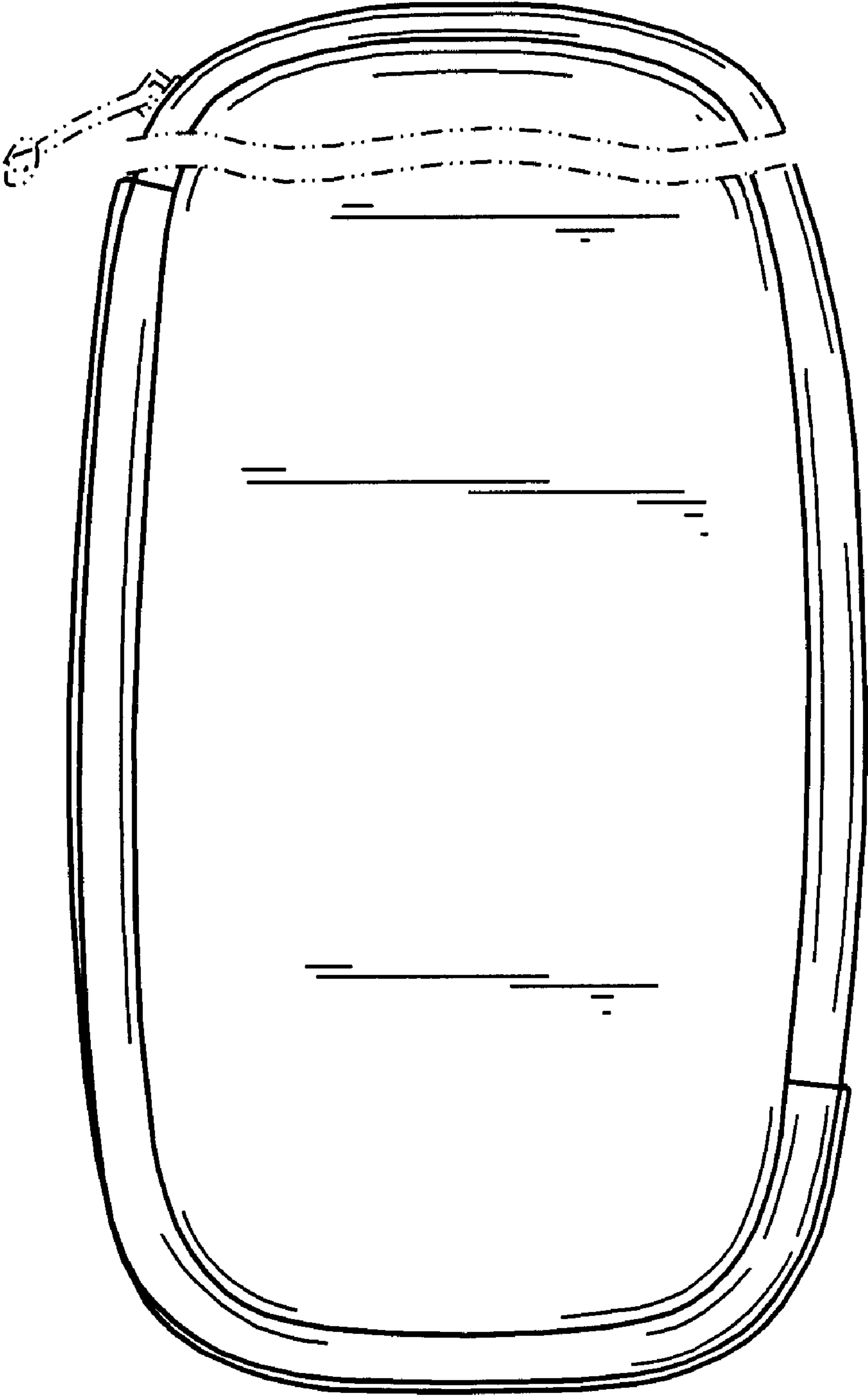

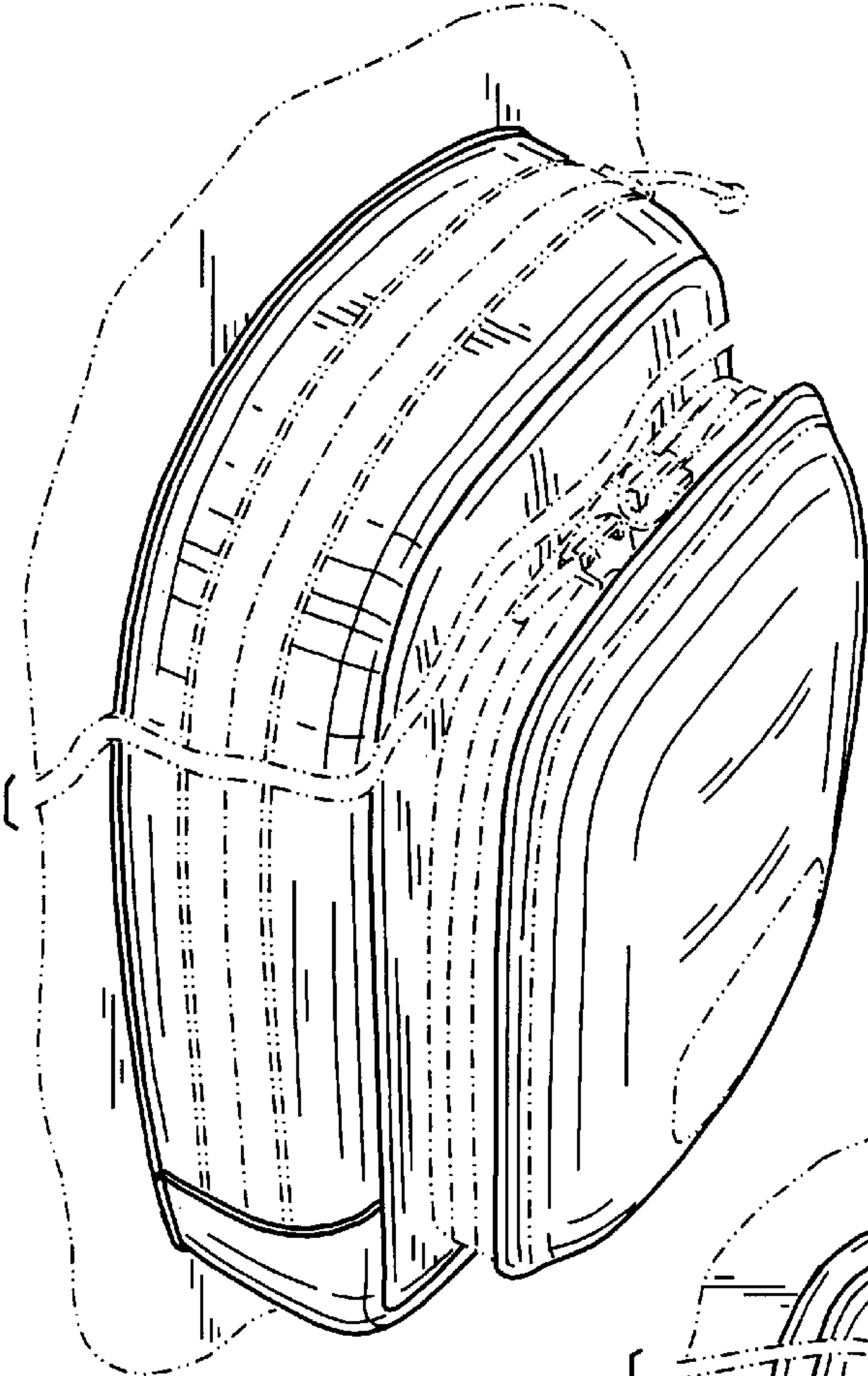

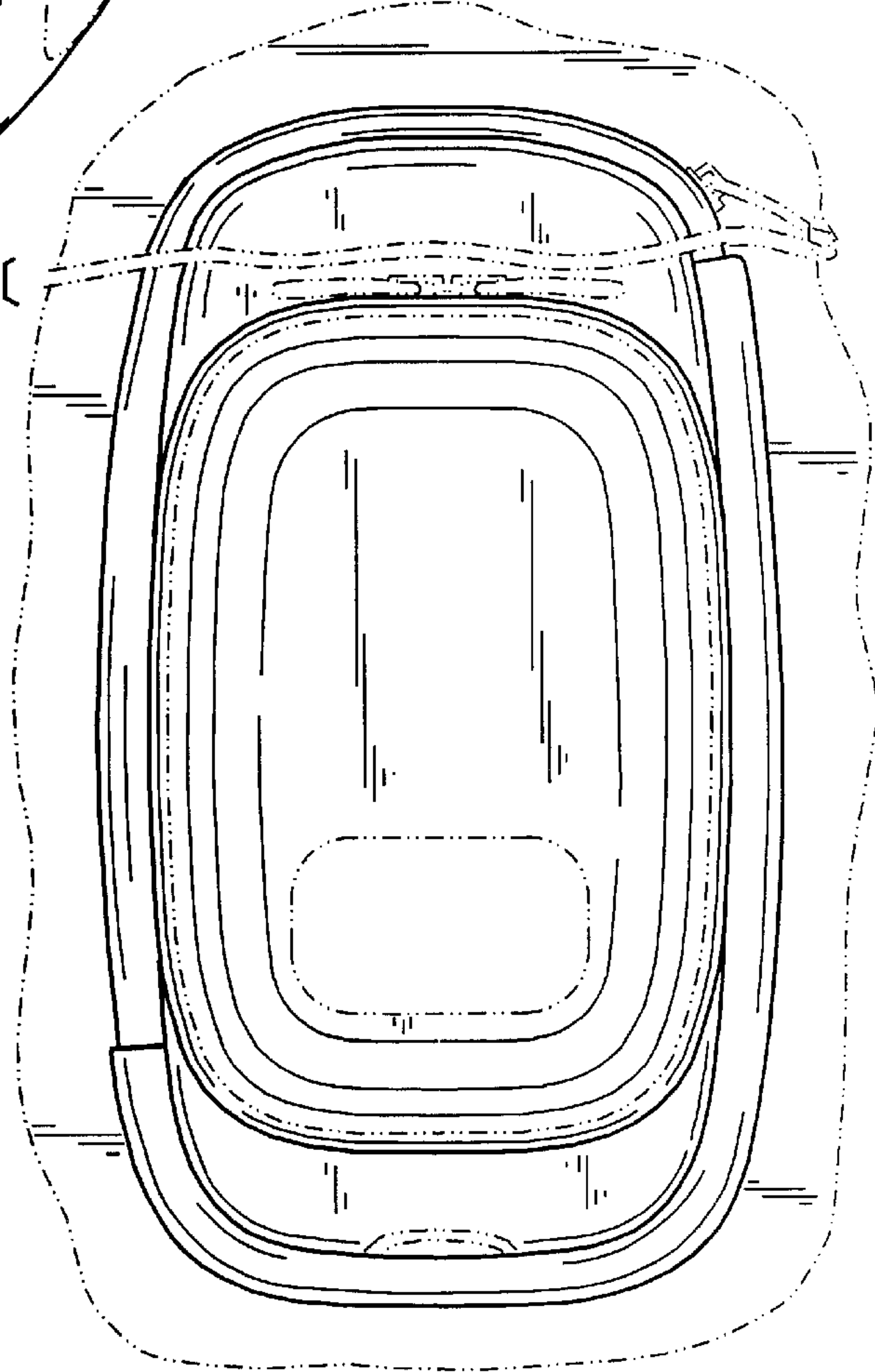
